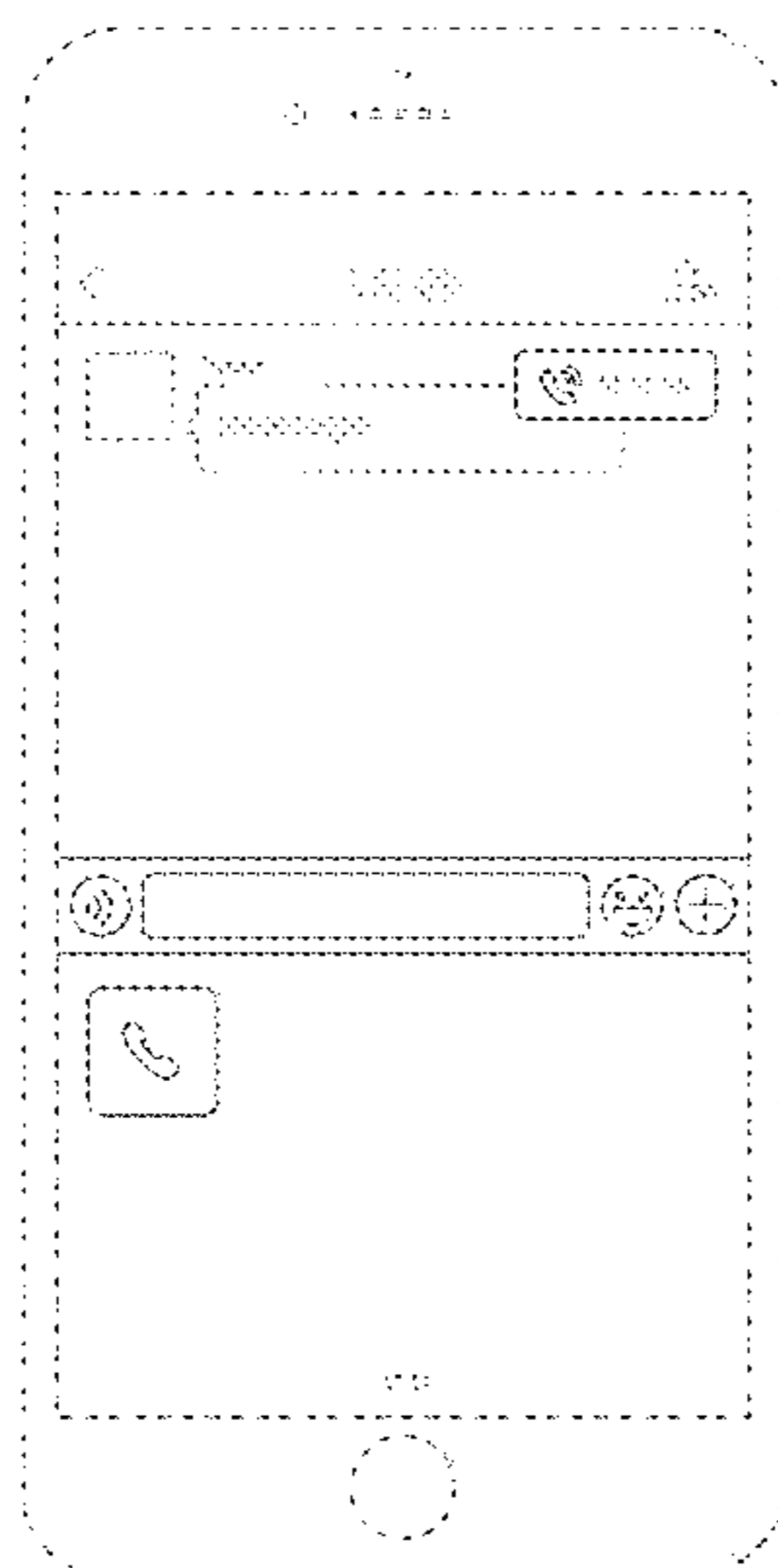
(57) **CLAIM**

The ornamental design for a portion of a display screen with graphical user interface, as shown and described.

**DESCRIPTION**

The FIGURE is a front view of a portion of a display screen with graphical user interface showing our new design. The broken lines showing portions of an electronic device and portions of the display screen illustrate environmental structure and the article of manufacture, respectively. The remaining broken lines, including all dotted line text and numerals, illustrate portions of the graphical user interface. None of the broken lines form part of the claimed design.
