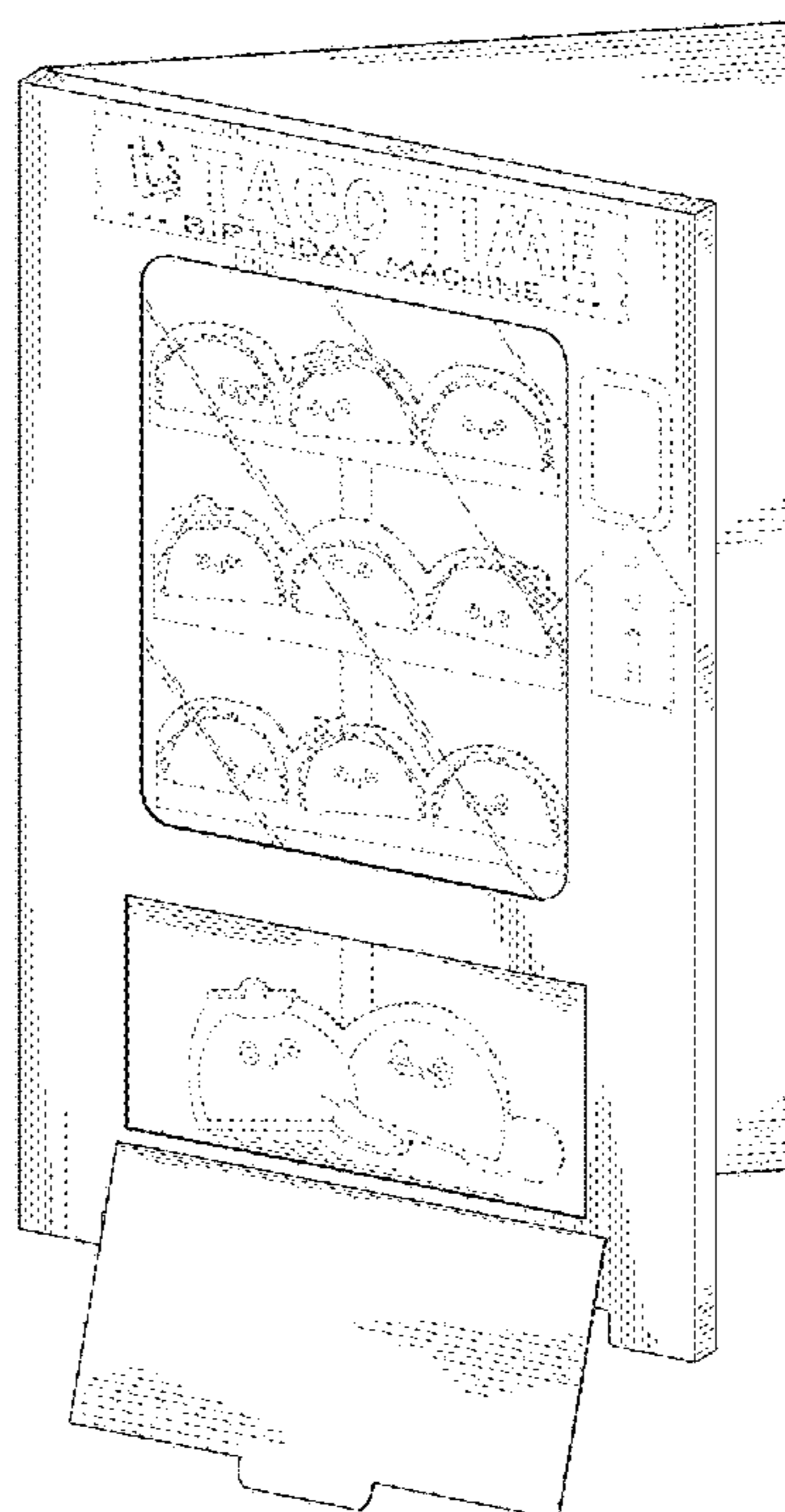
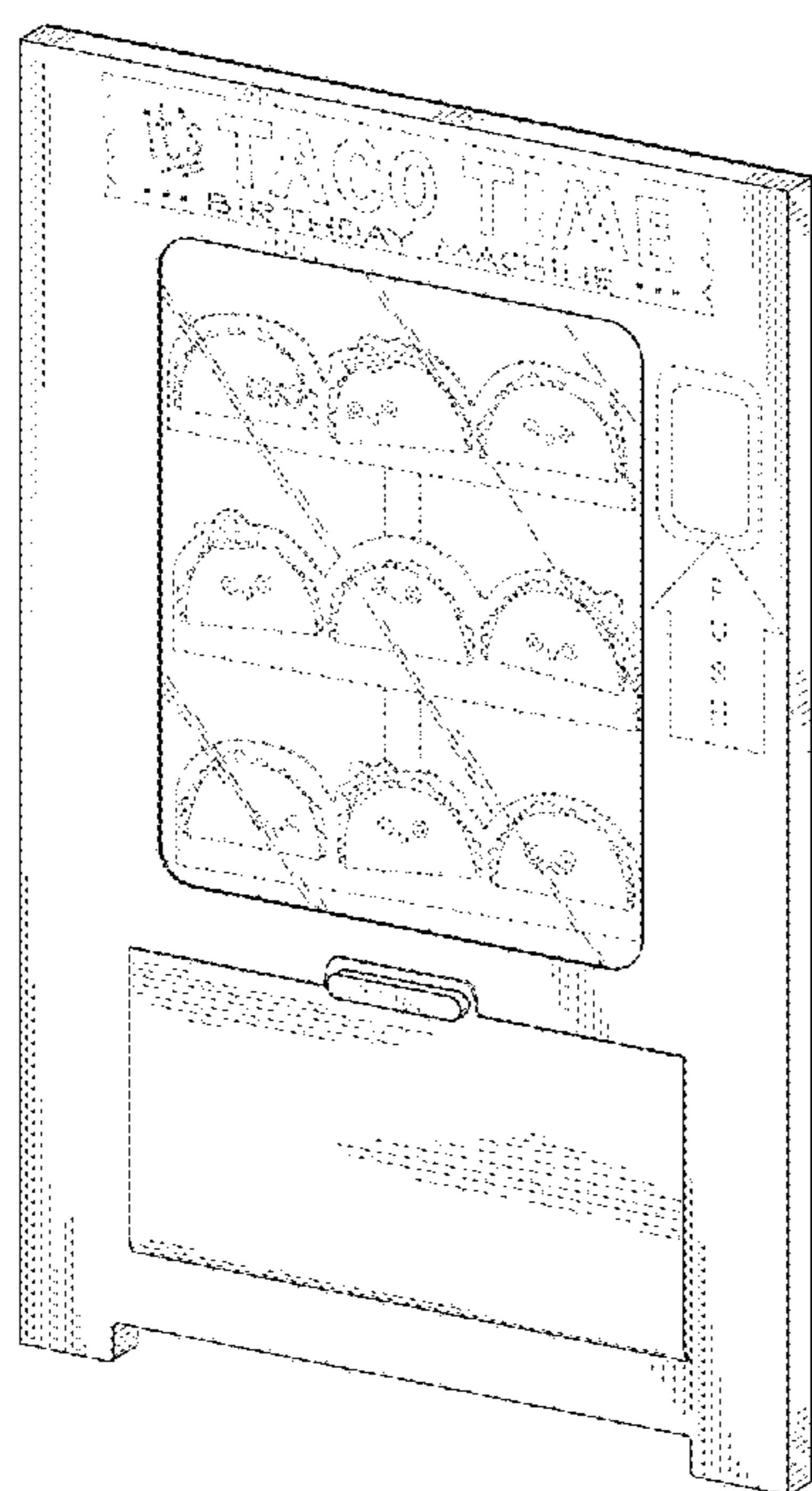
(57) **CLAIM**

The ornamental design for a vending machine greeting card,
as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the greeting card of the present invention, in a closed position, with closed front flap. FIG. 2 is a front view of the greeting card of FIG. 1. FIG. 3 is a rear view of the greeting card of FIG. 1. FIG. 4 is a top down view of the greeting card of FIG. 1. FIG. 5 is a bottom up view of the greeting card of FIG. 1. FIG. 6 is a left side view of the greeting card of FIG. 1. FIG. 7 is a right side view of the greeting card of FIG. 1; and, FIG. 8 is a perspective view of the greeting card of FIG. 1, in a partially open position, with open front flap. The broken line showing of portions of the vending machine greeting card is included for the purpose of illustrating environmental structure and forms no part of the claimed design.

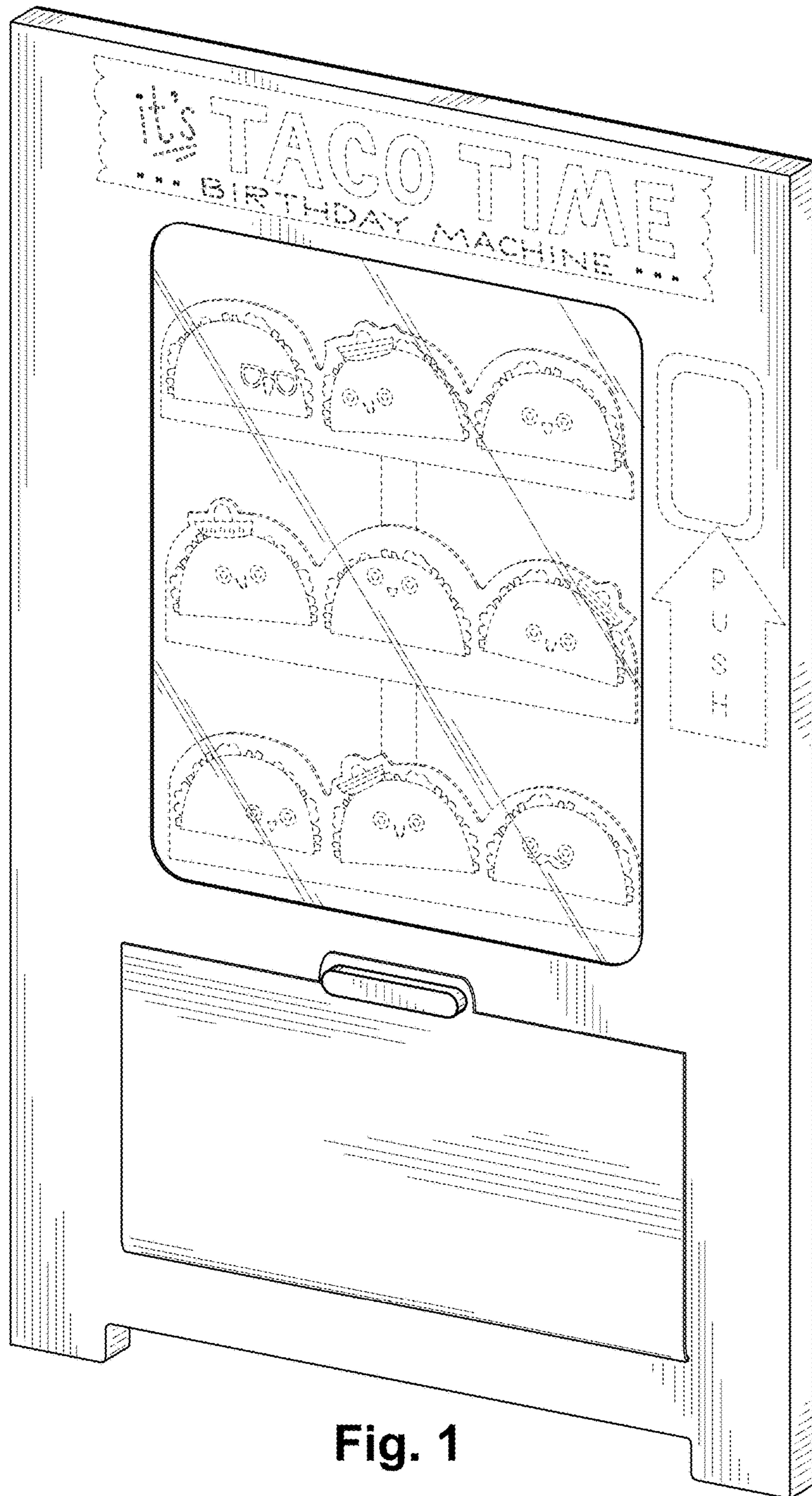

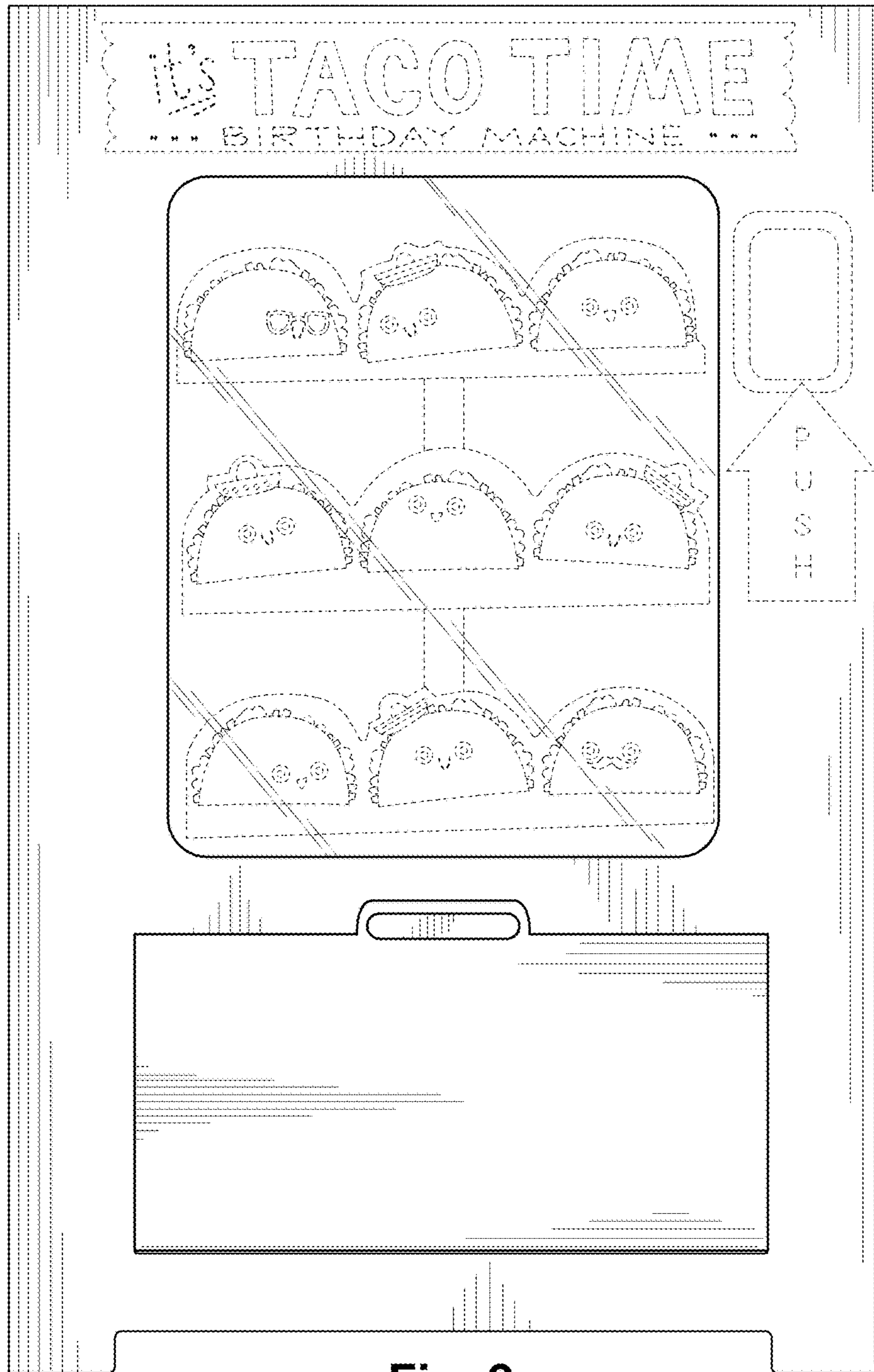

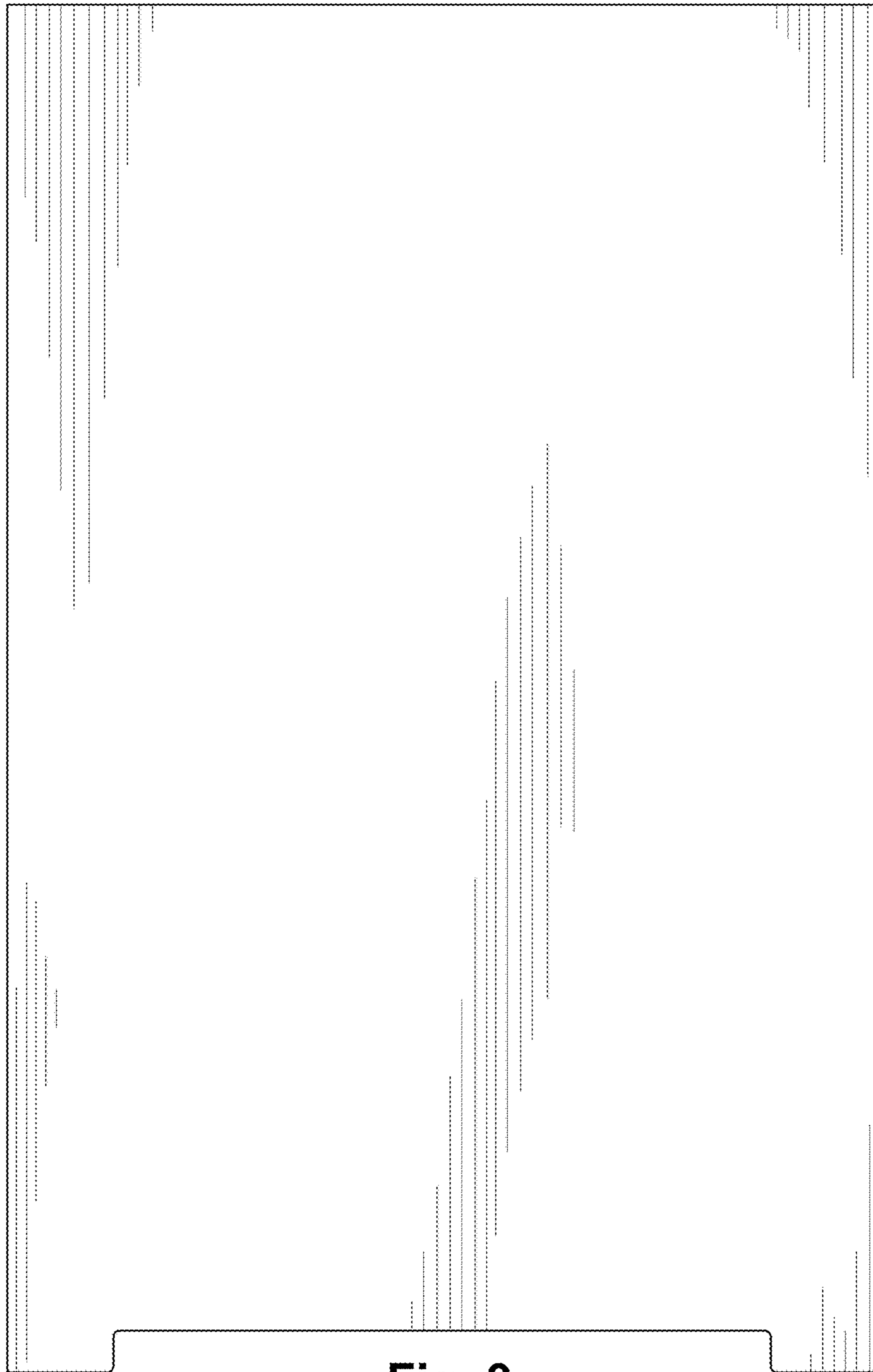

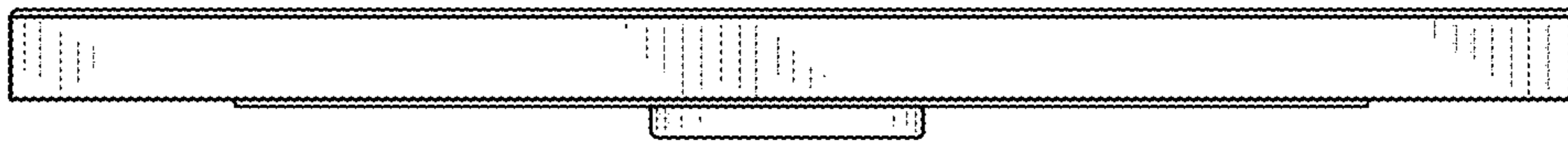

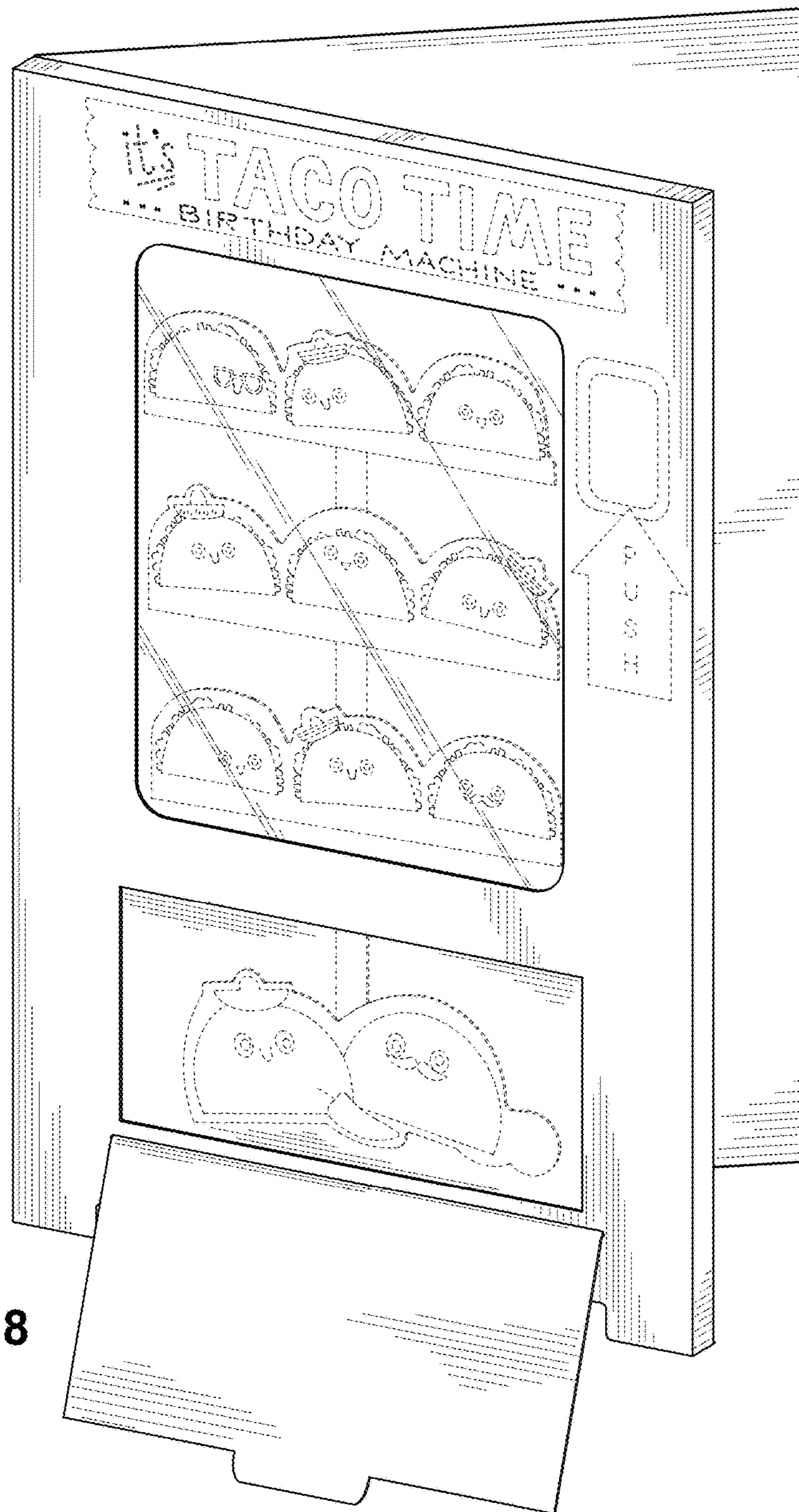
