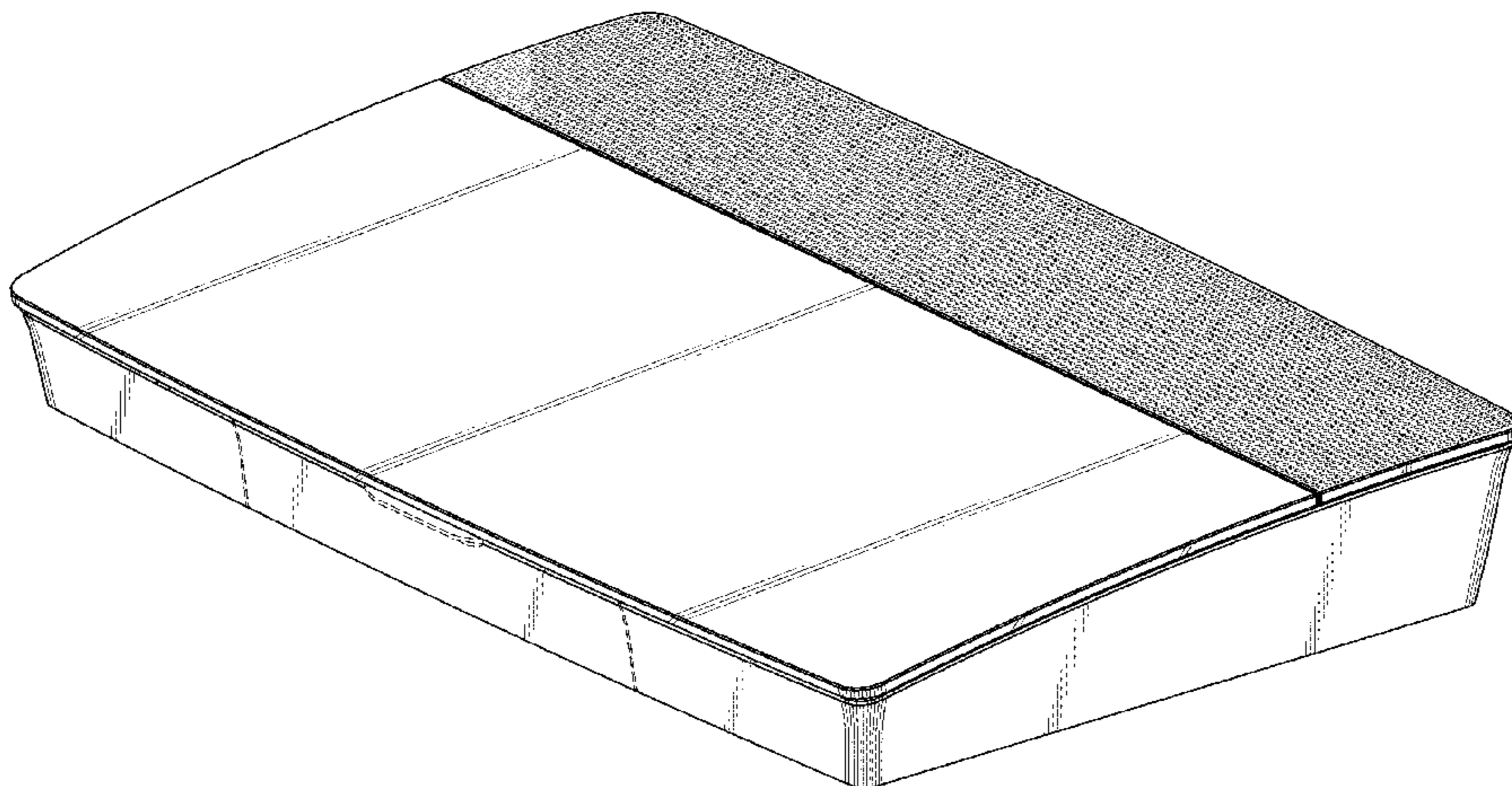
The ornamental design for a control console, substantially as

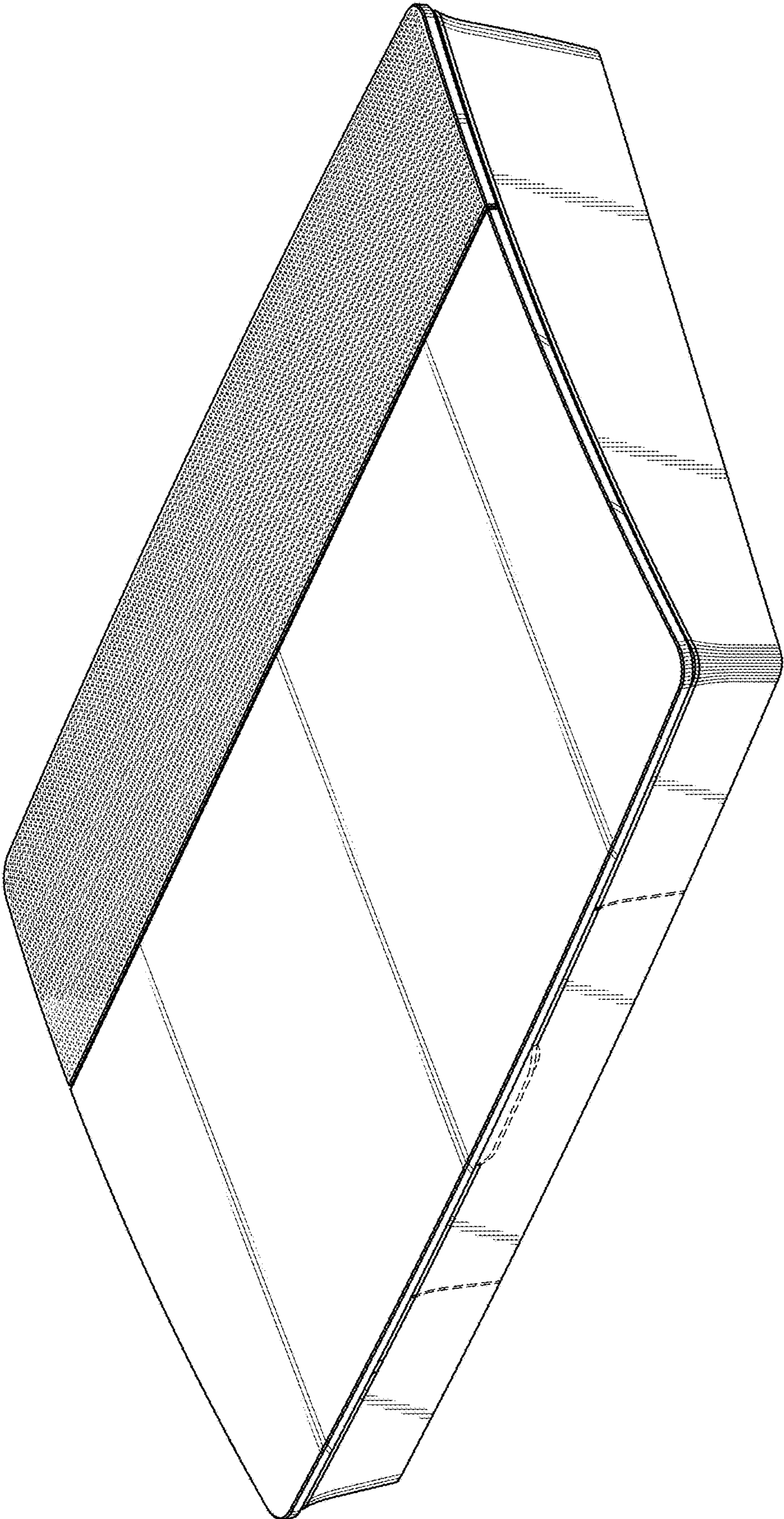

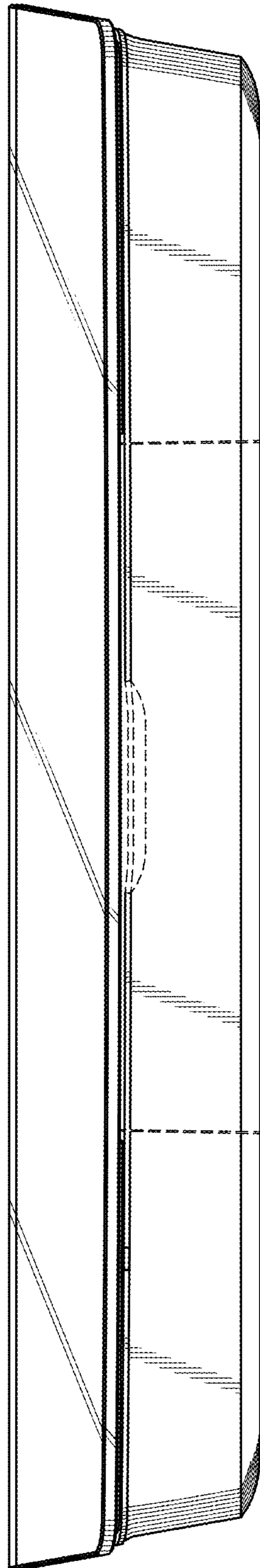

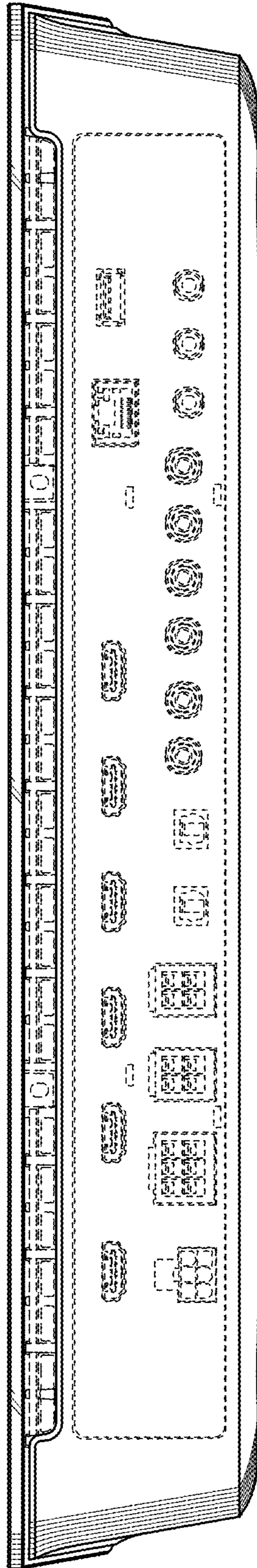

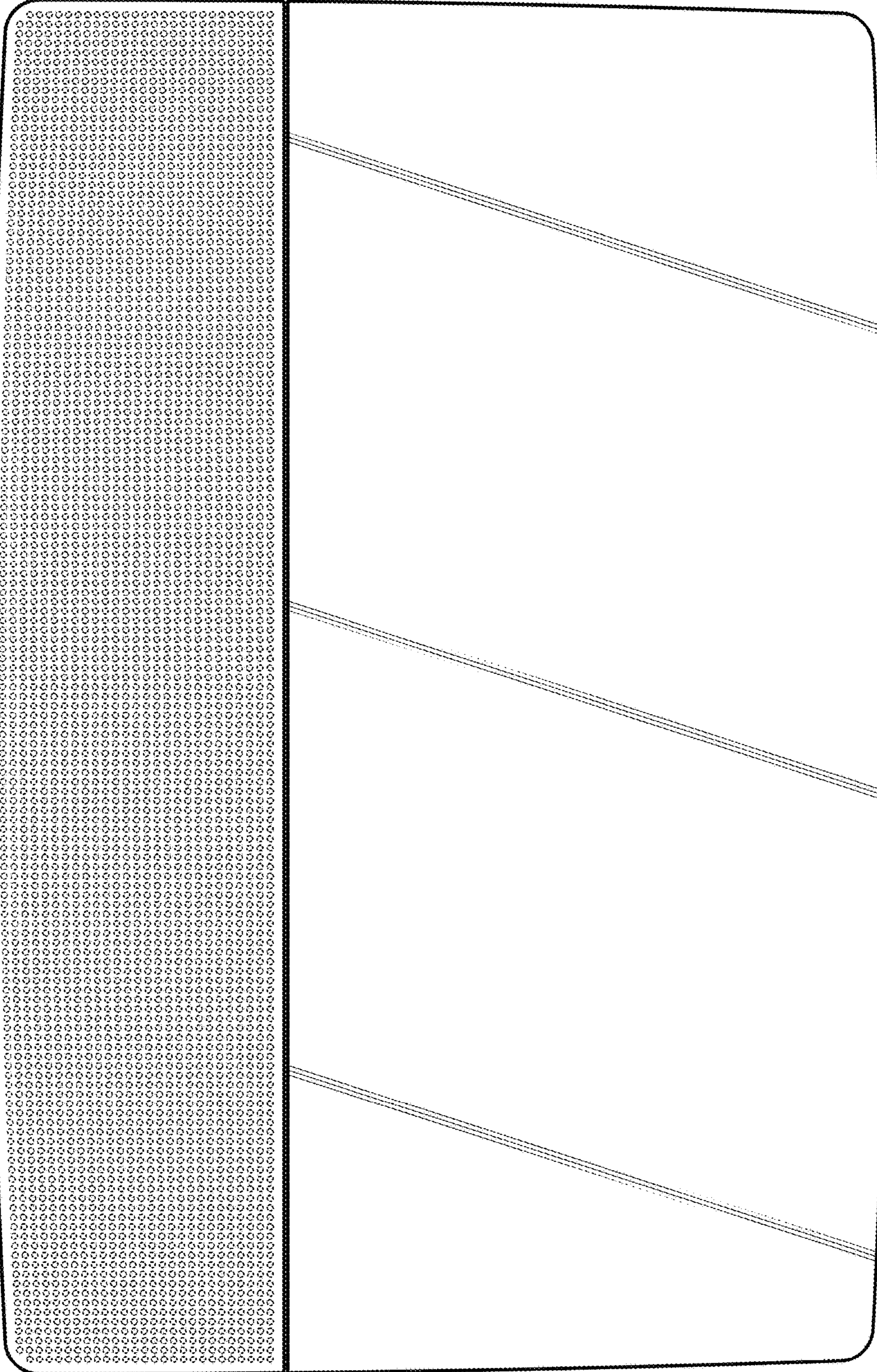

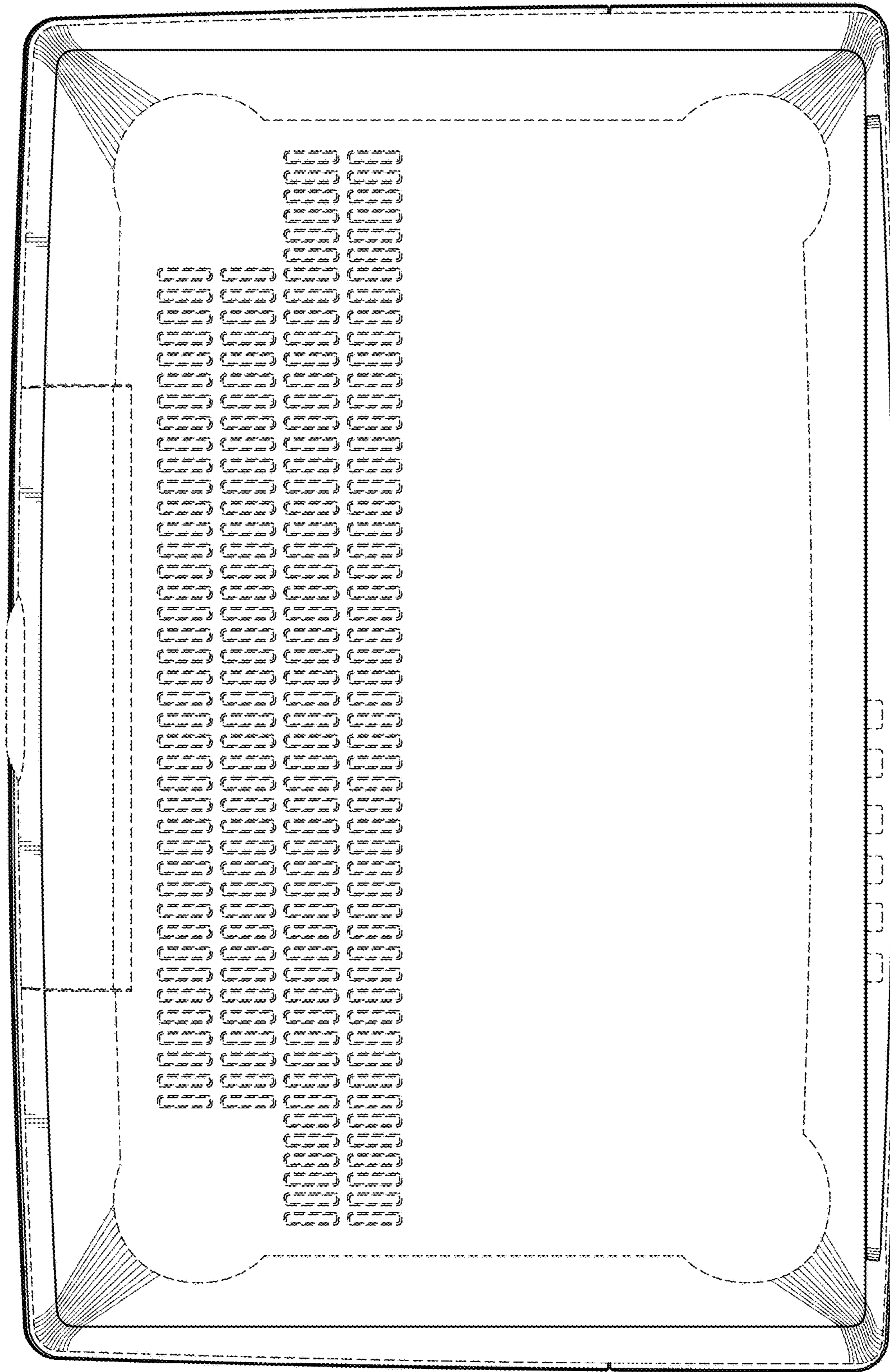

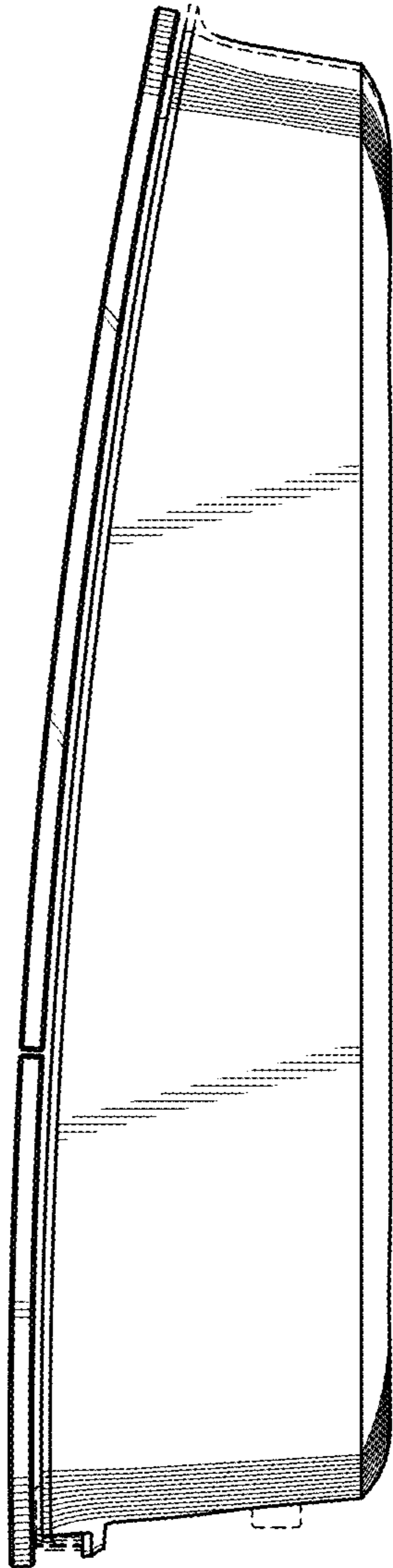

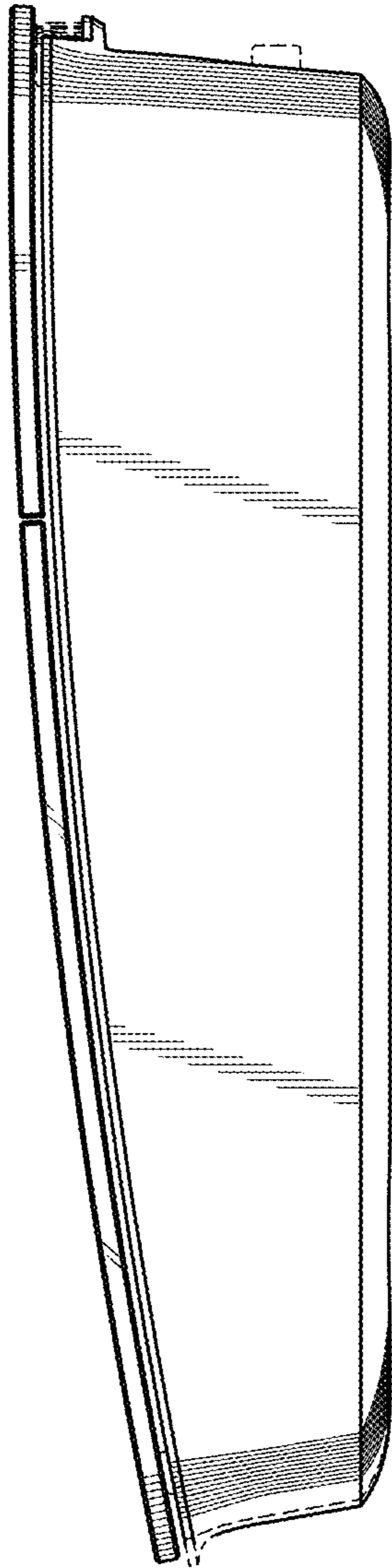
