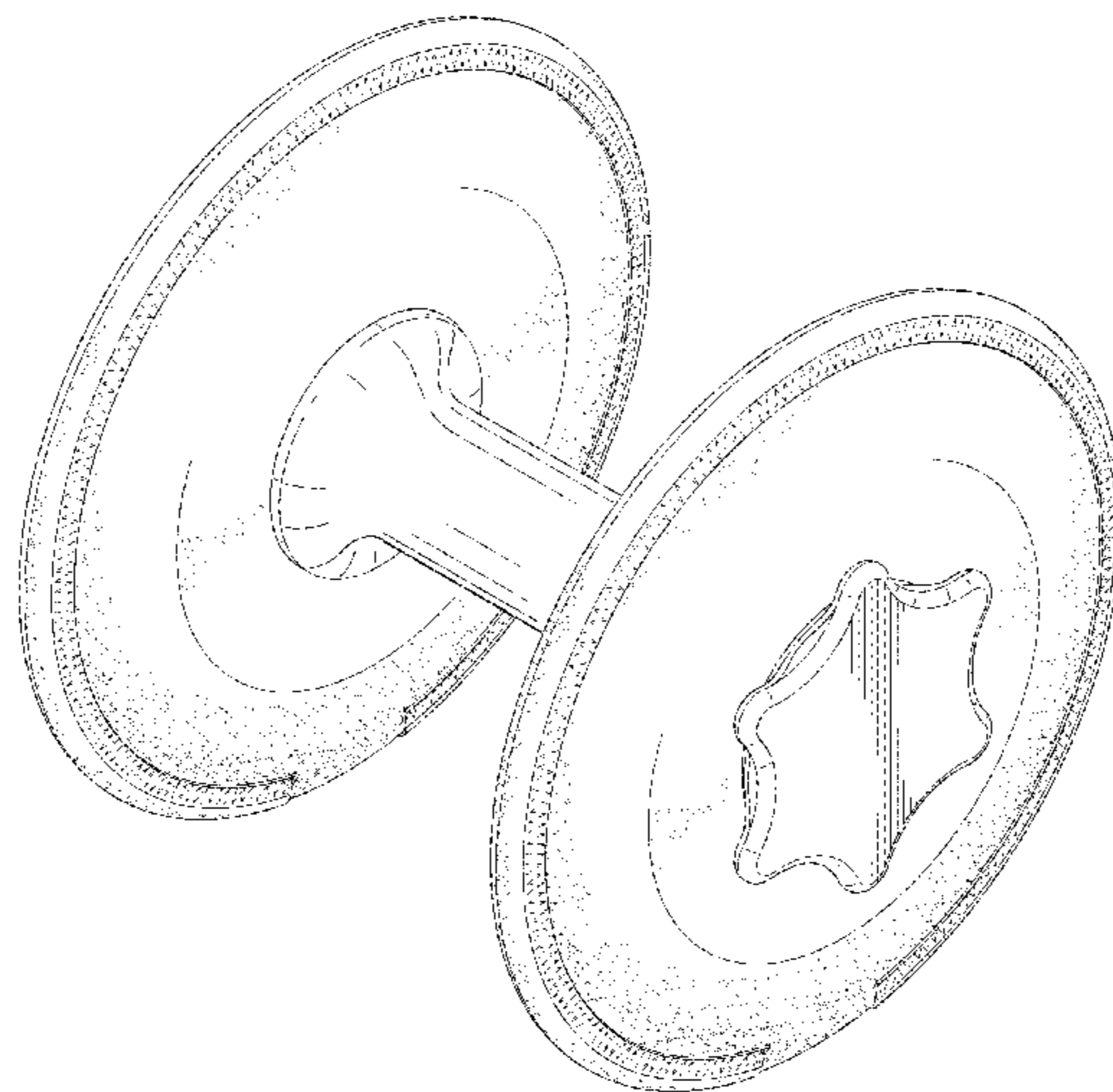
(57) **CLAIM**

The ornamental design for a weighted soft plate fitness dumbbell, as shown and described.

**DESCRIPTION**

FIG. 1 is an isometric view of the weighted soft plate fitness dumbbell, according to the first embodiment;  
FIG. 2 is a side view of the weighted soft plate fitness dumbbell, according to the first embodiment;  
FIG. 3 is a top view of the weighted soft plate fitness dumbbell, according to the first embodiment;  
FIG. 4 is an isometric view of the weighted soft plate fitness dumbbell, according to the second embodiment;  
FIG. 5 is a side view of the weighted soft plate fitness dumbbell, according to the second embodiment; and,  
FIG. 6 is a top view of the weighted soft plate fitness dumbbell, according to the second embodiment.

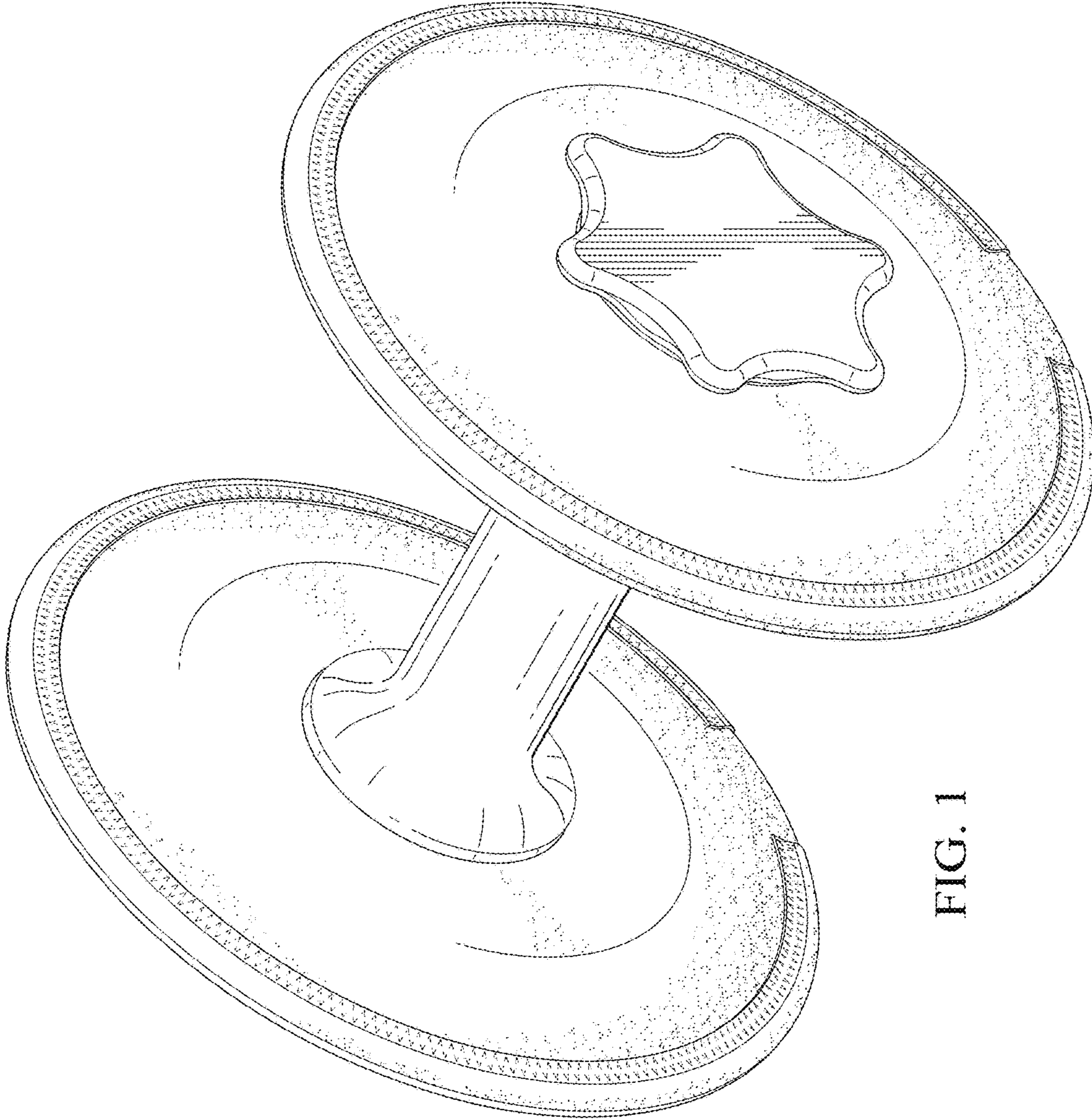

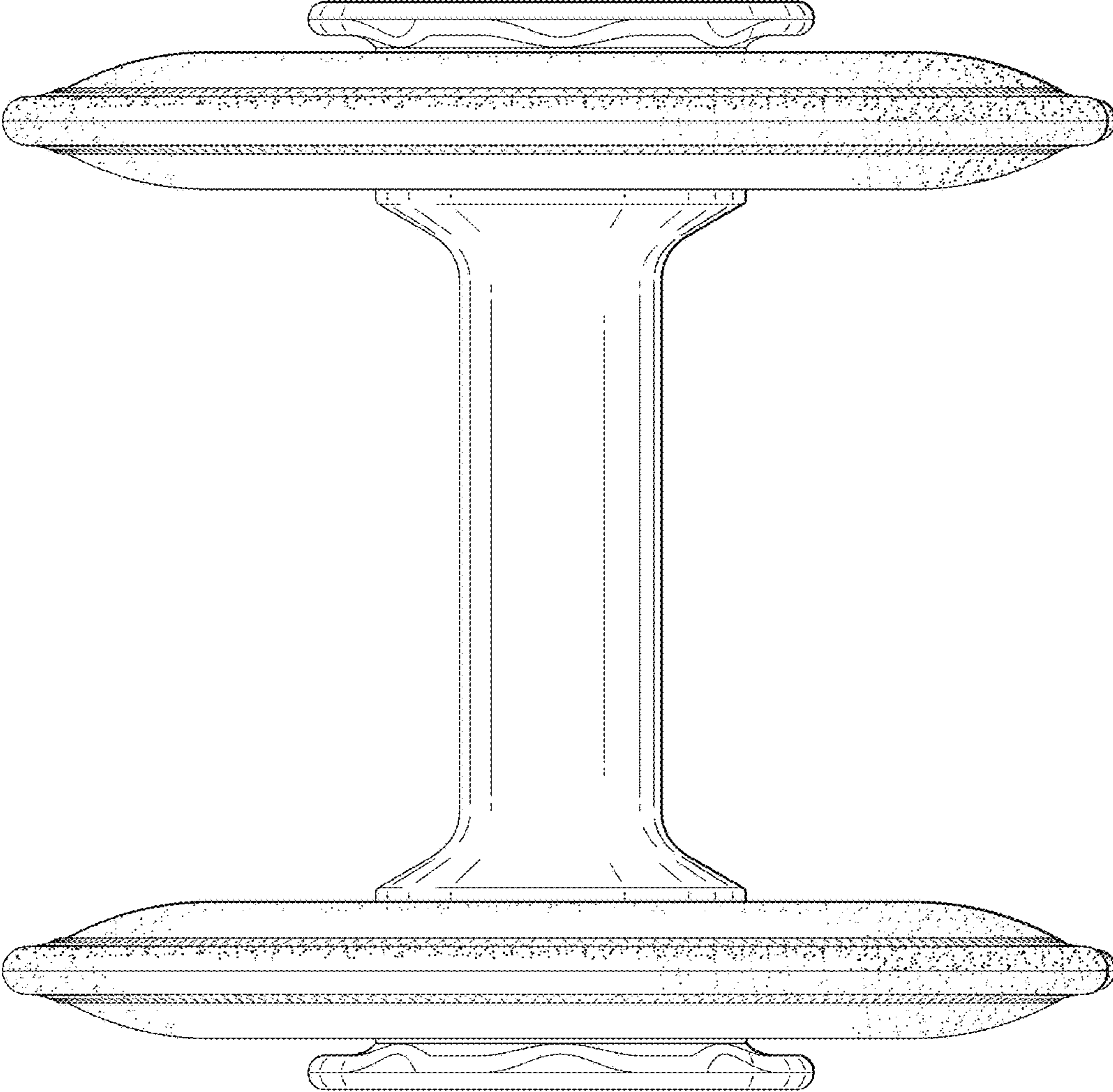

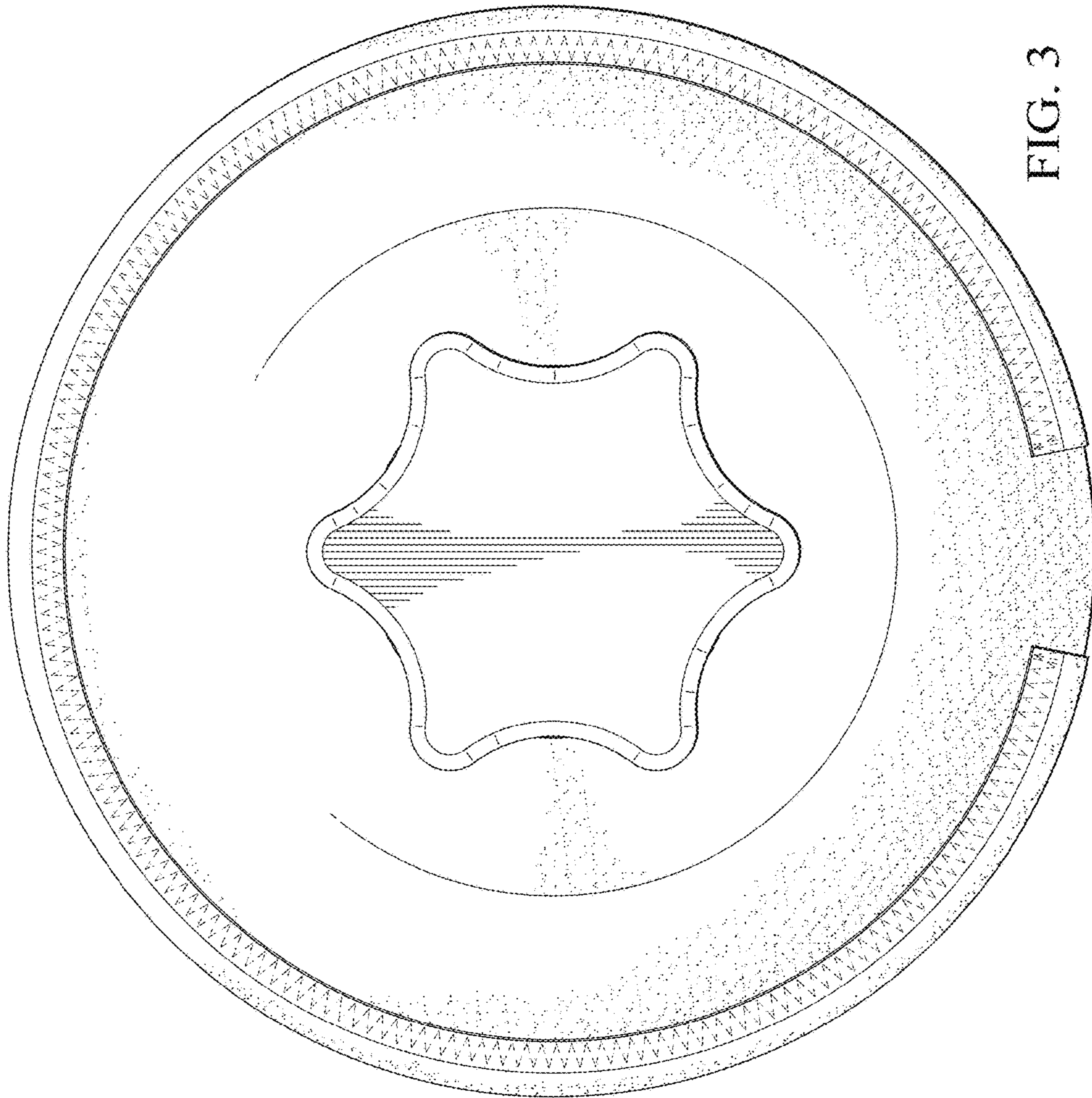

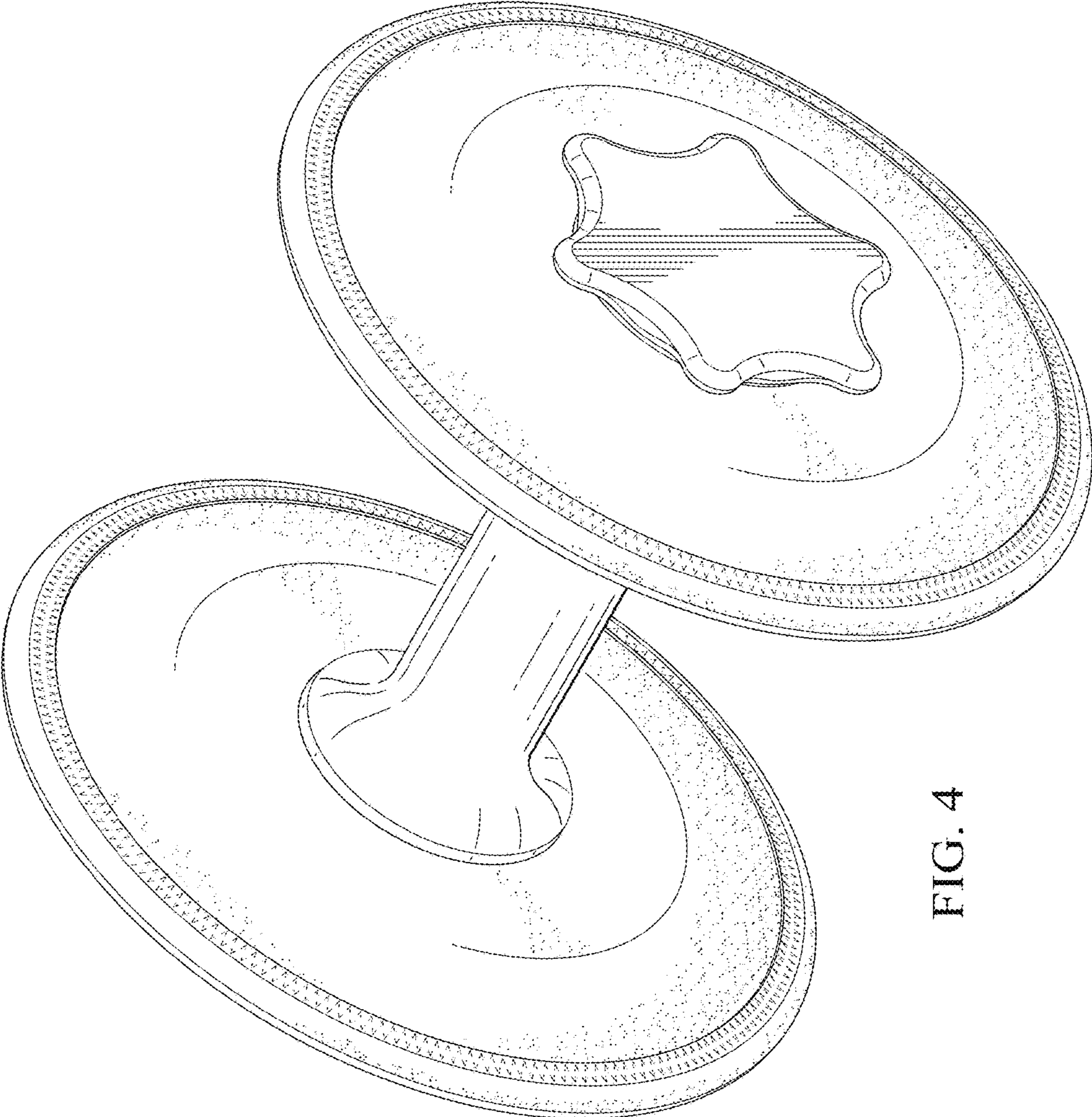

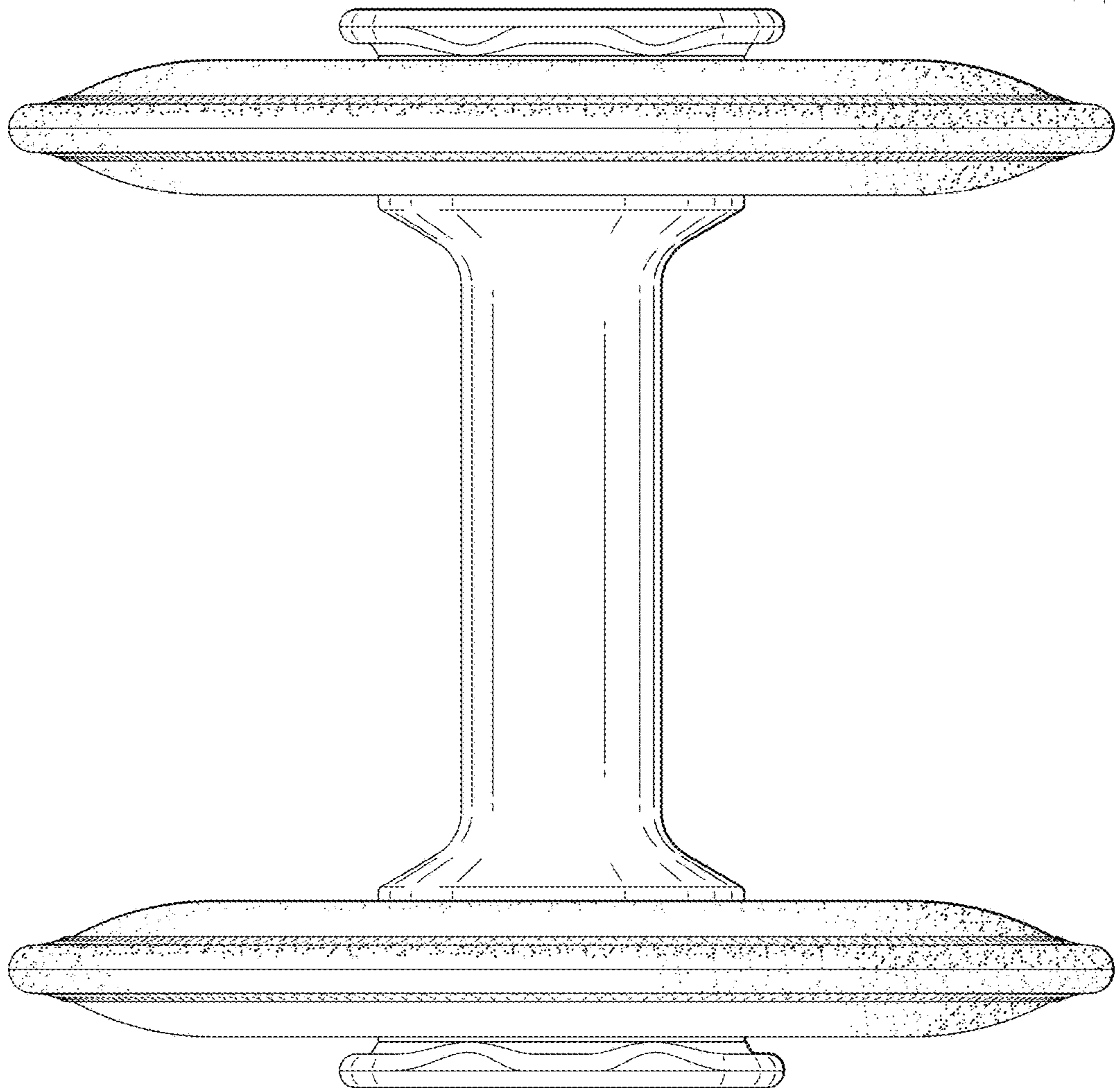

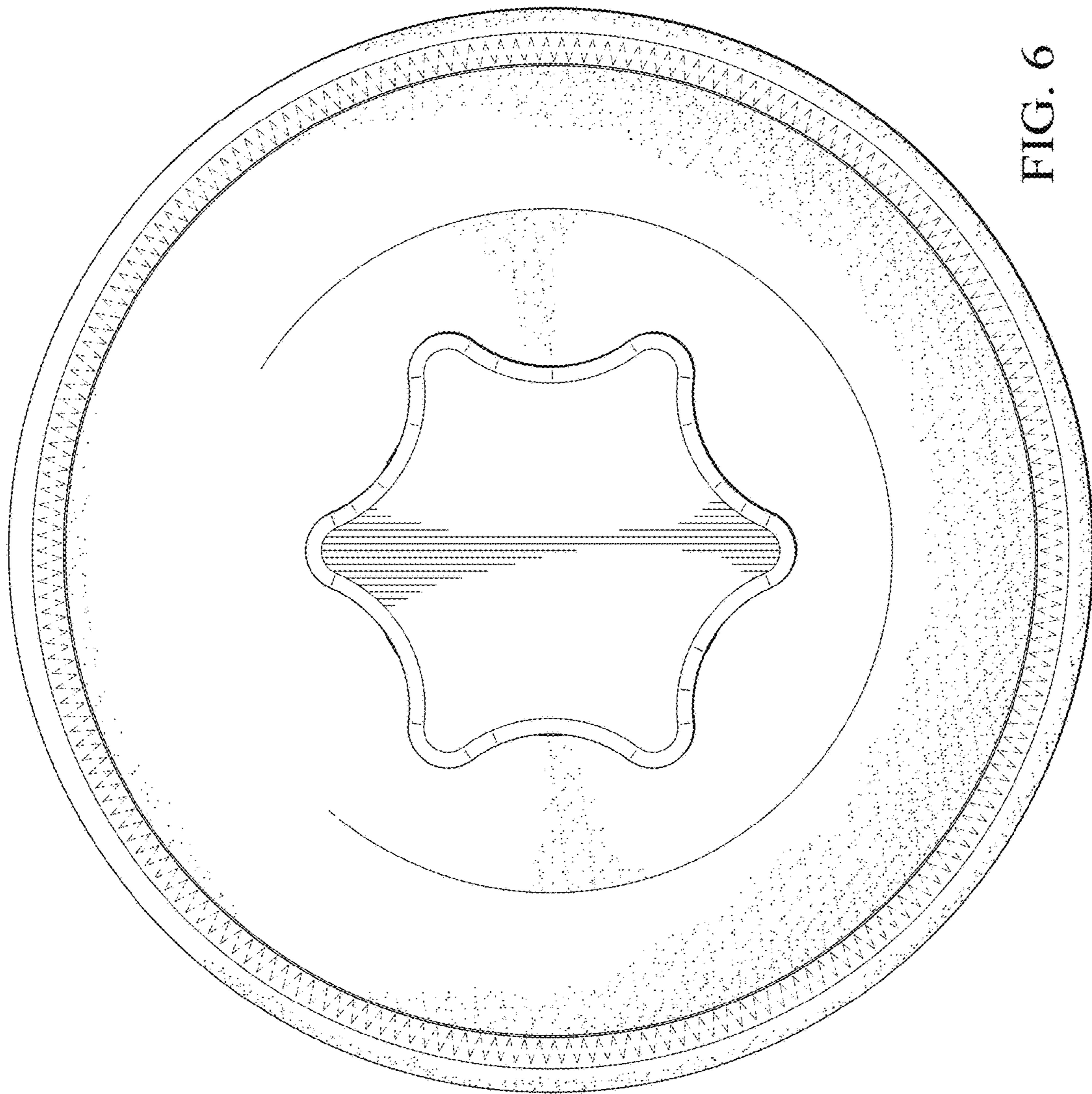
