The ornamental design for an applicator, as shown and described.

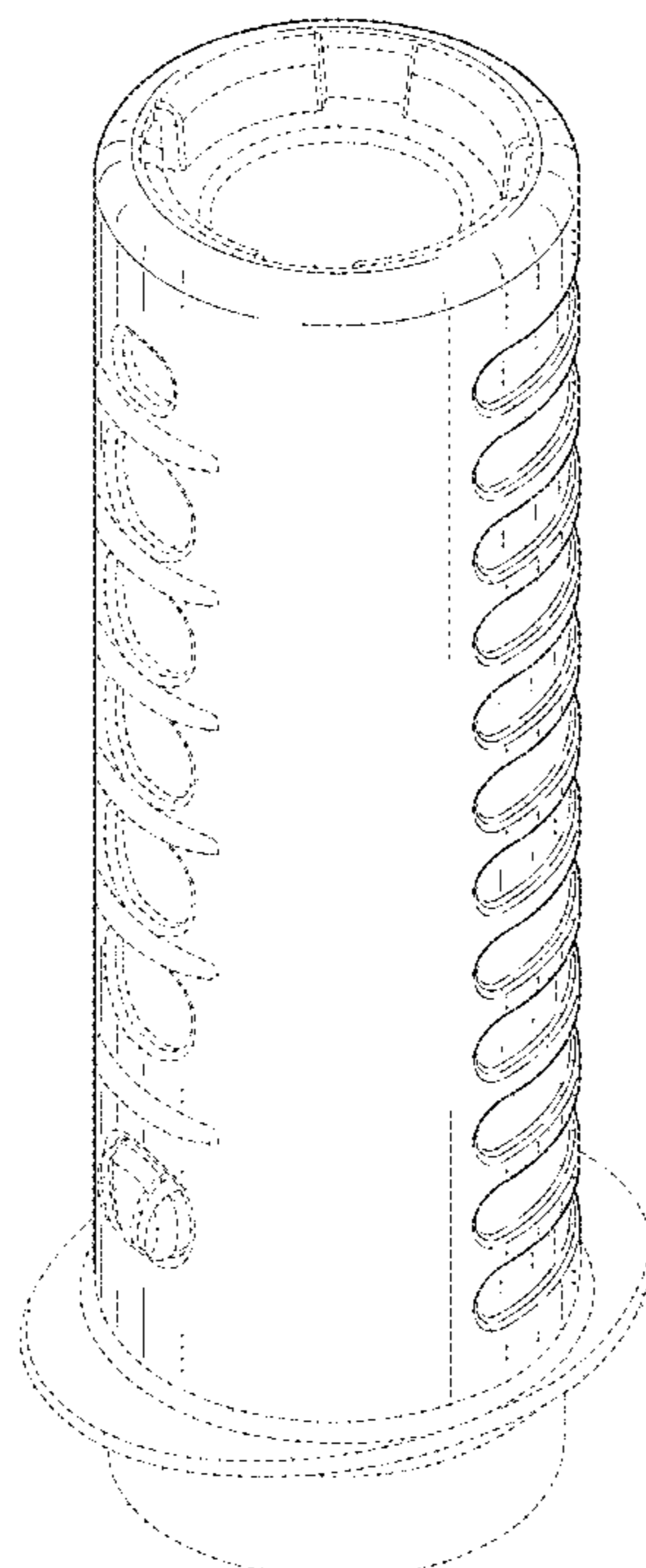
DESCRIPTION

FIG. 1 is a top, front, right perspective view of an applicator showing our new design;

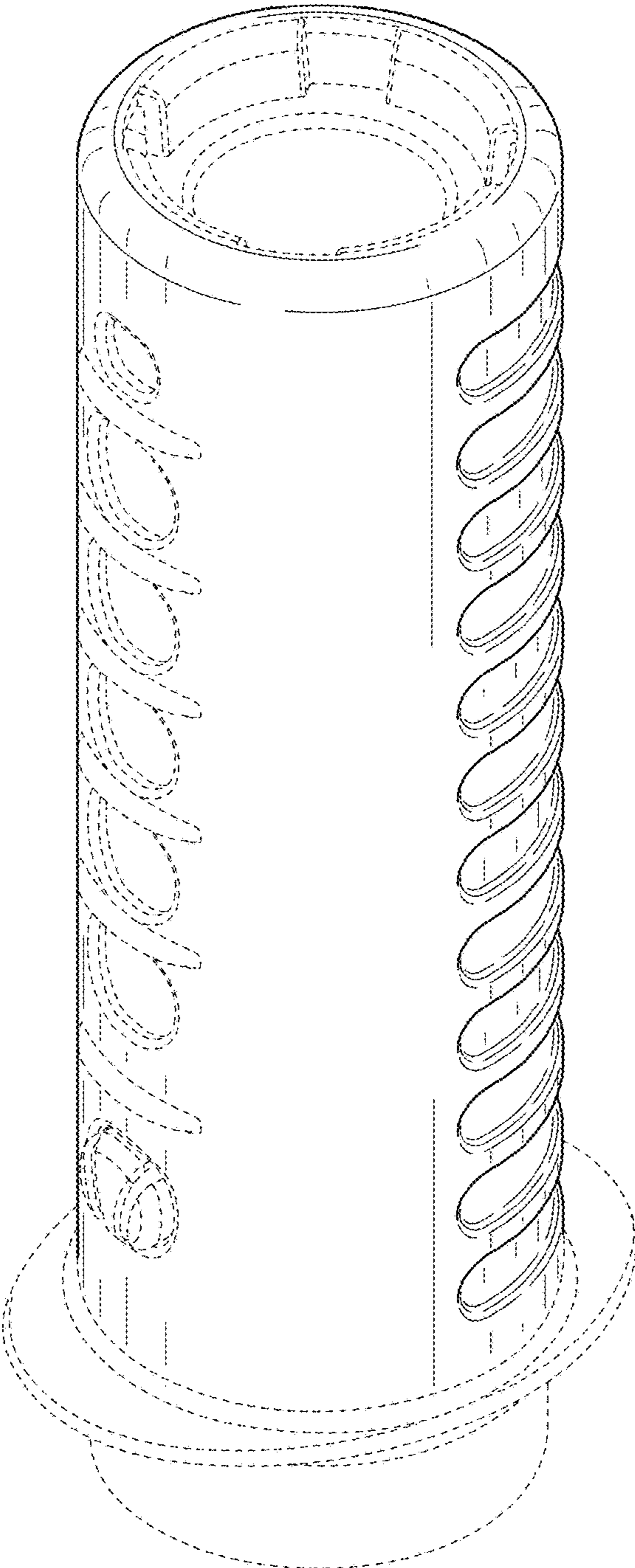

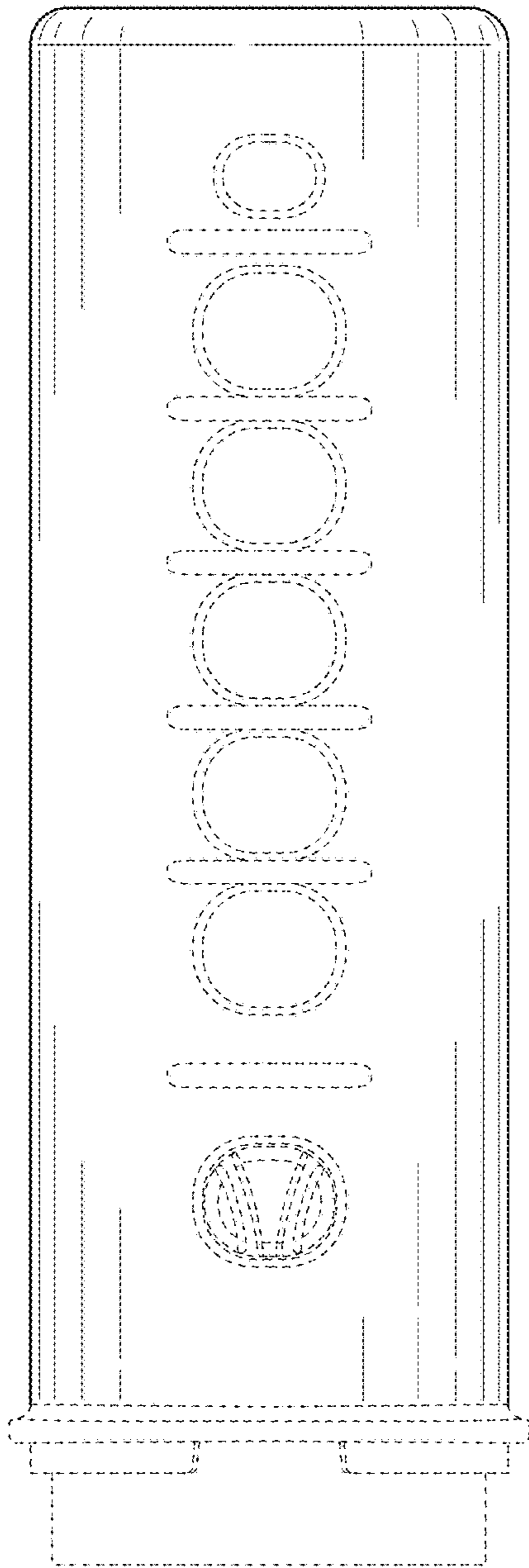

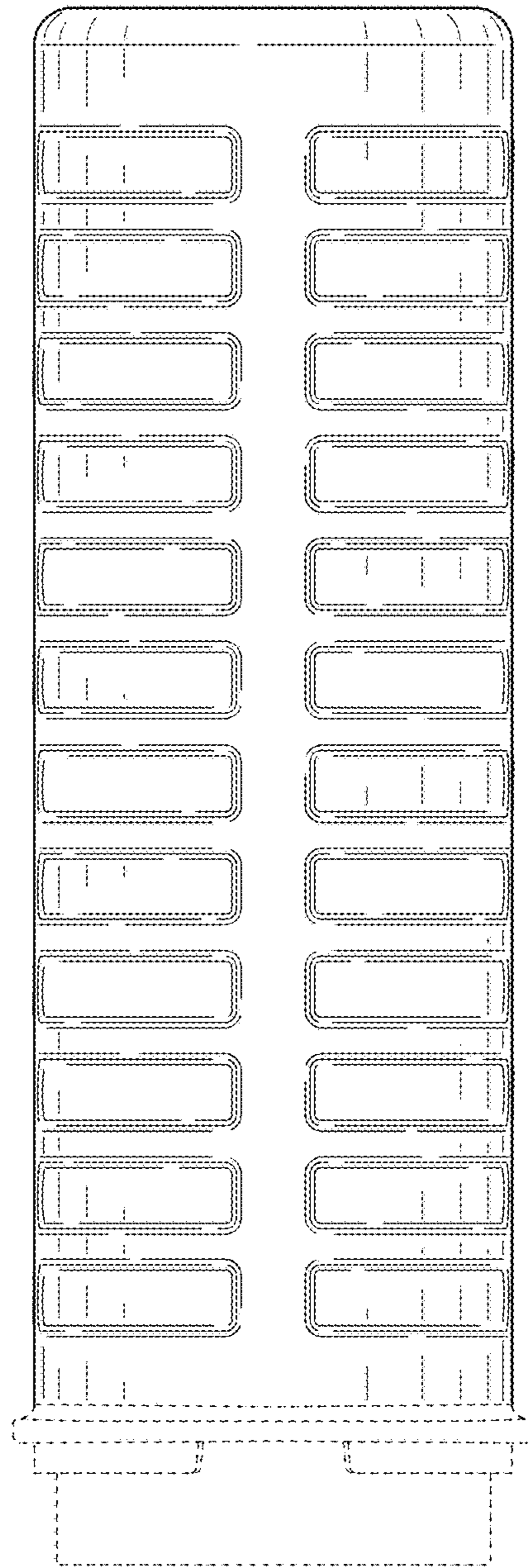

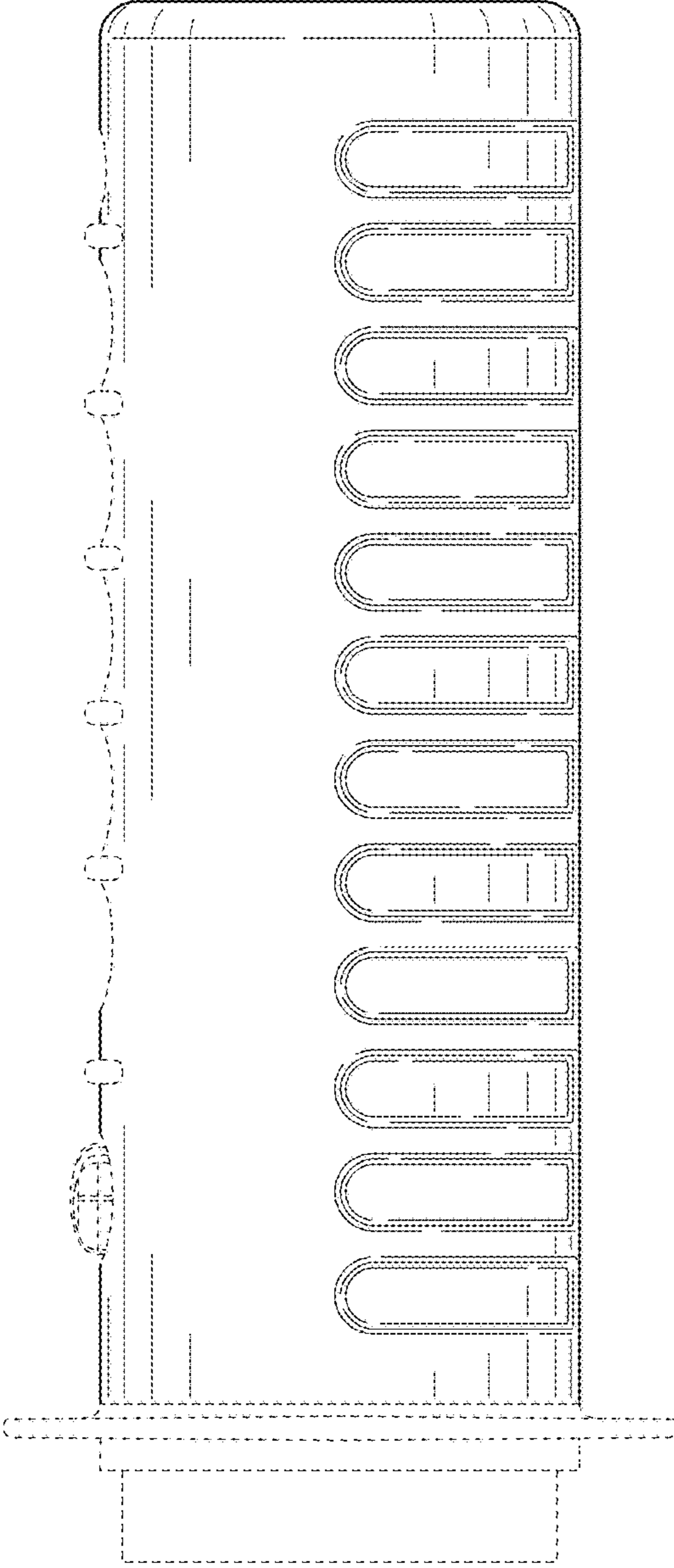

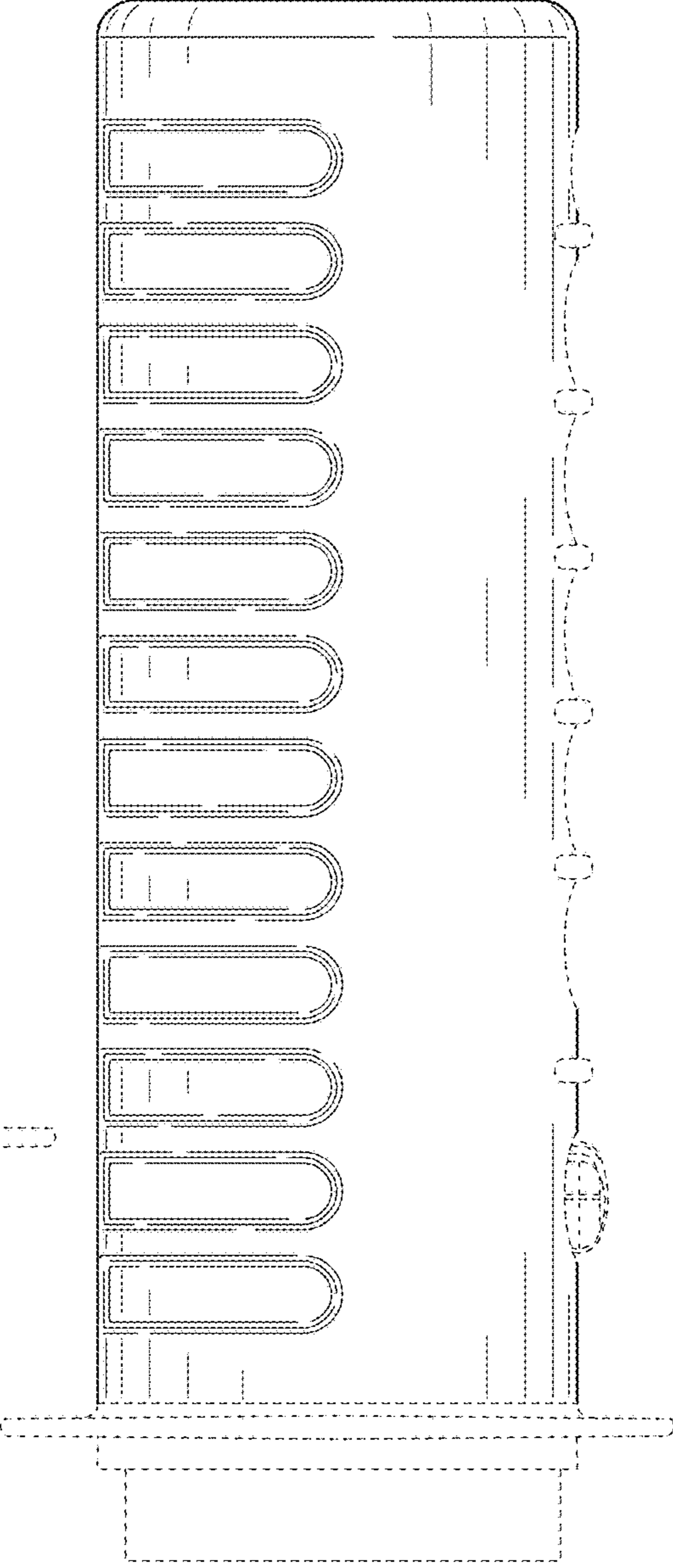

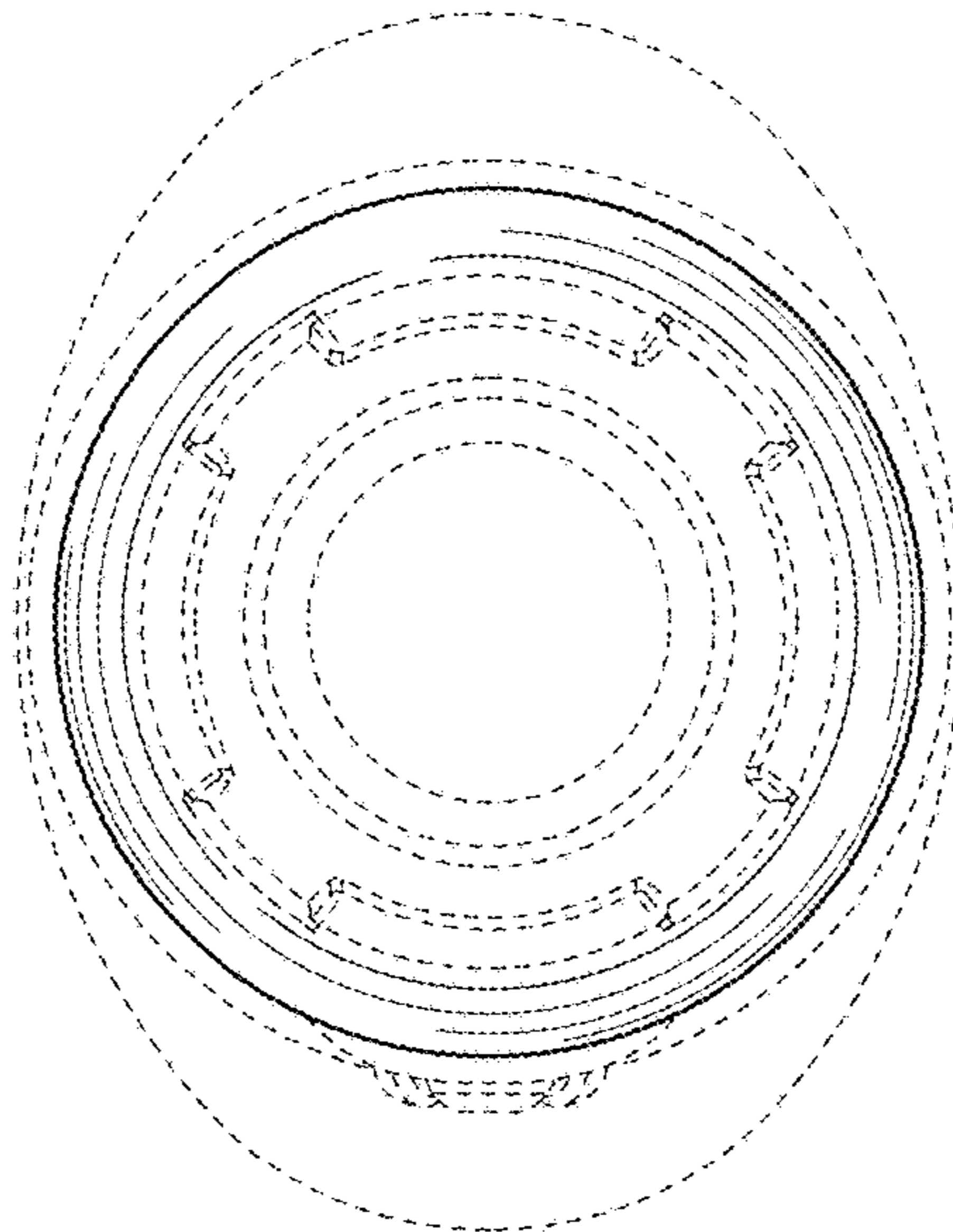

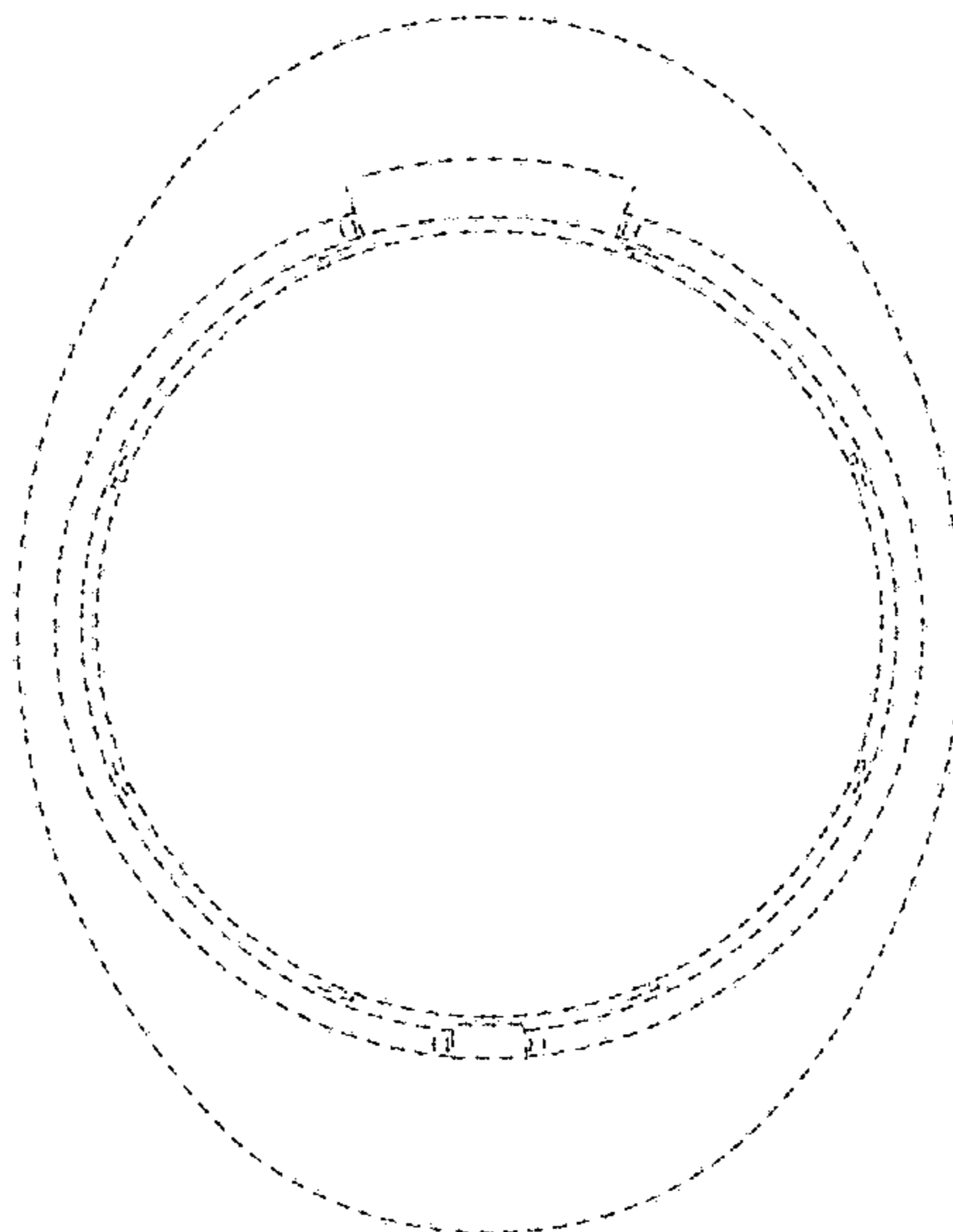
