DESCRIPTION

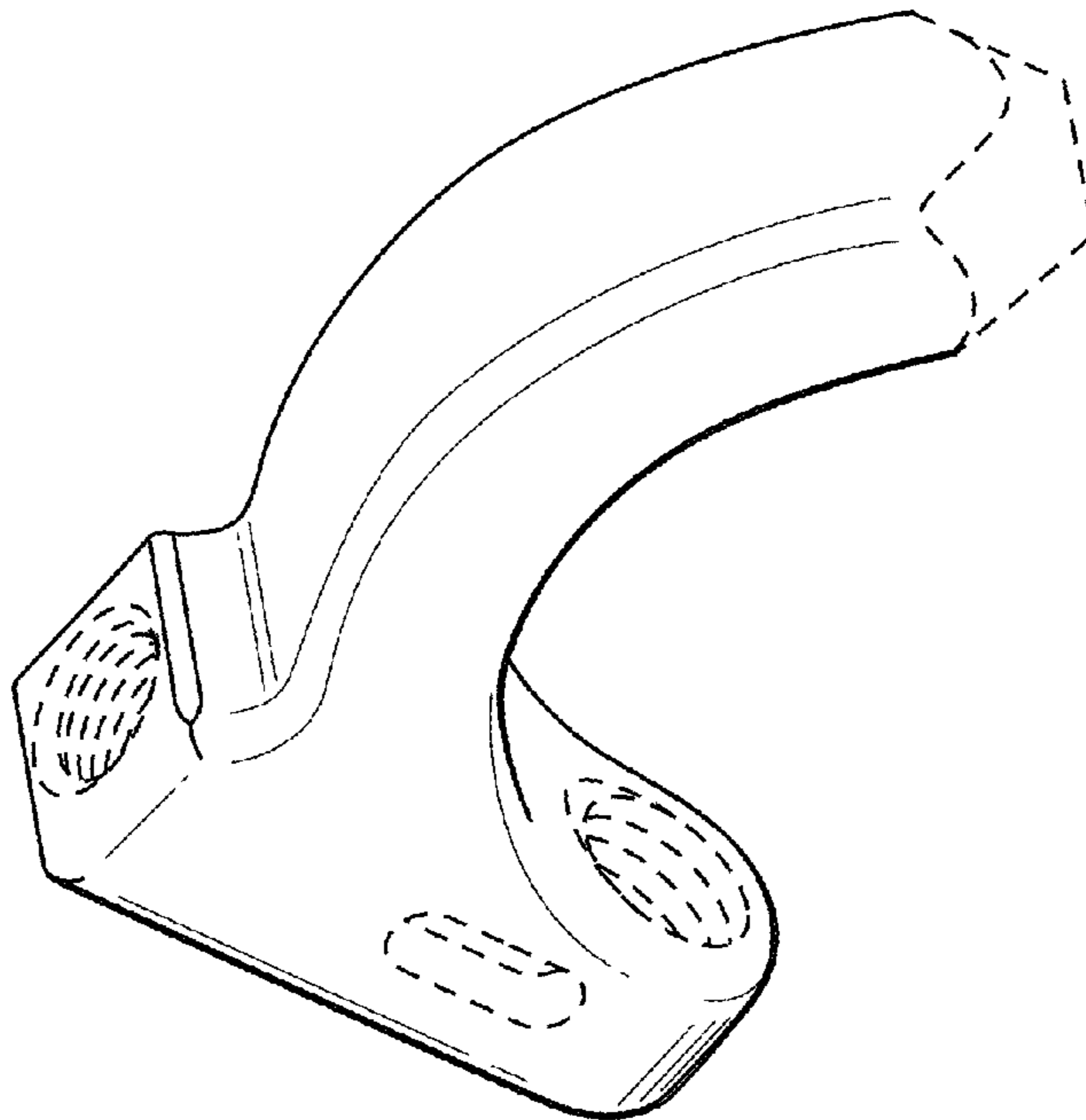
FIG. 1 is a rear perspective view of an anterior hip extractor in accordance with the new design;

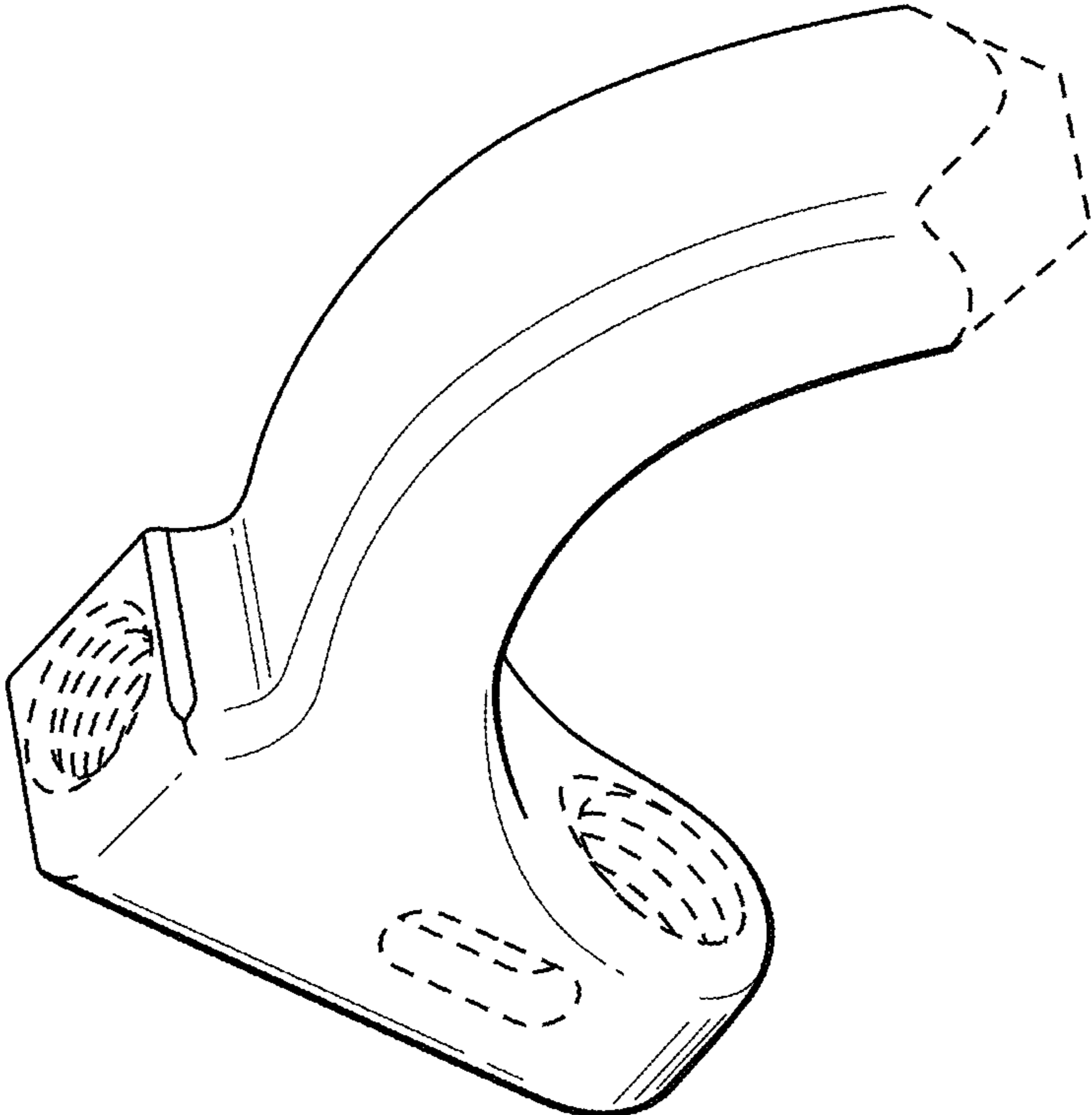

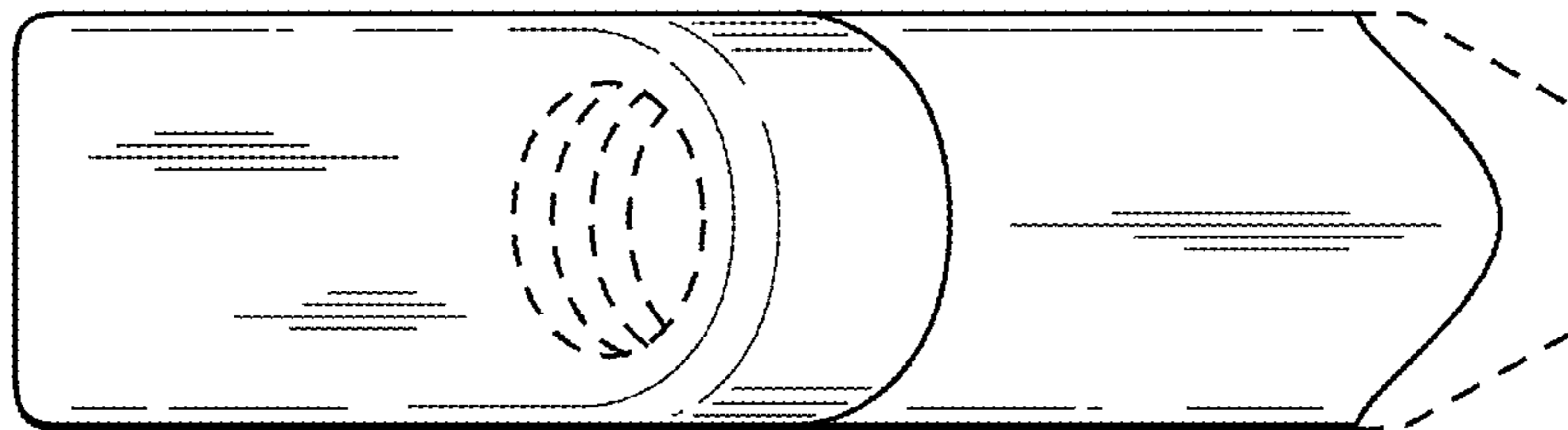

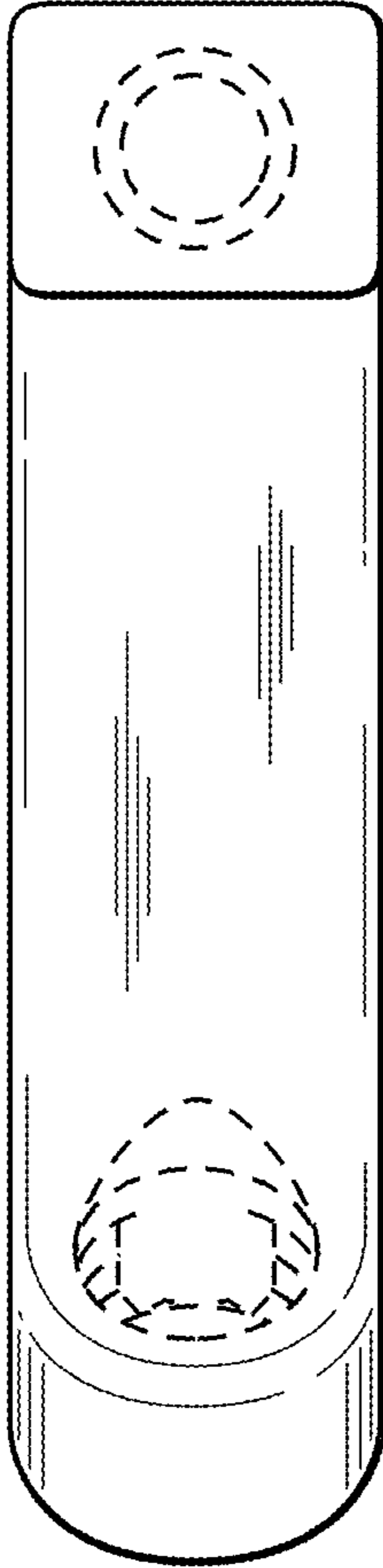

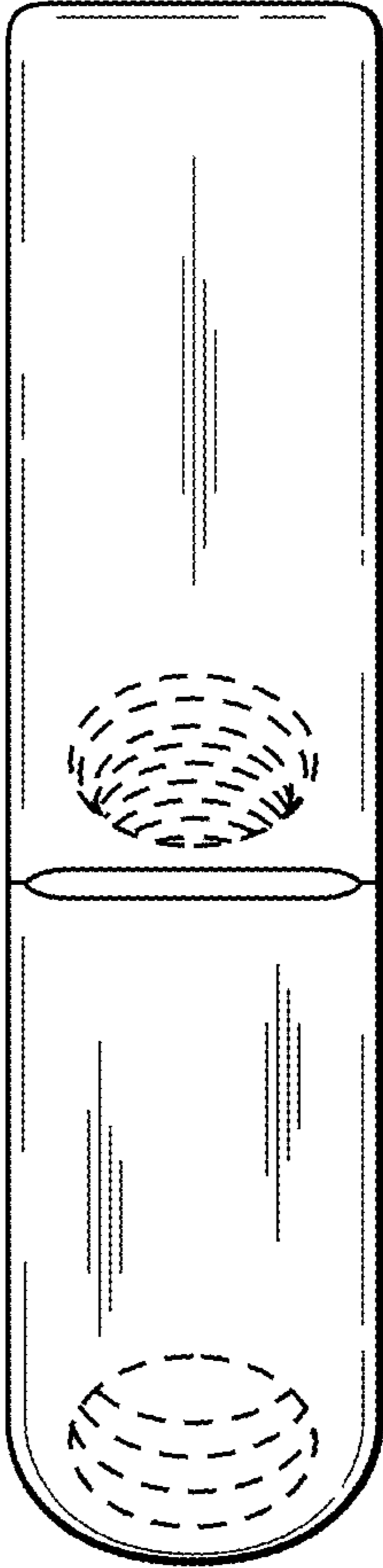

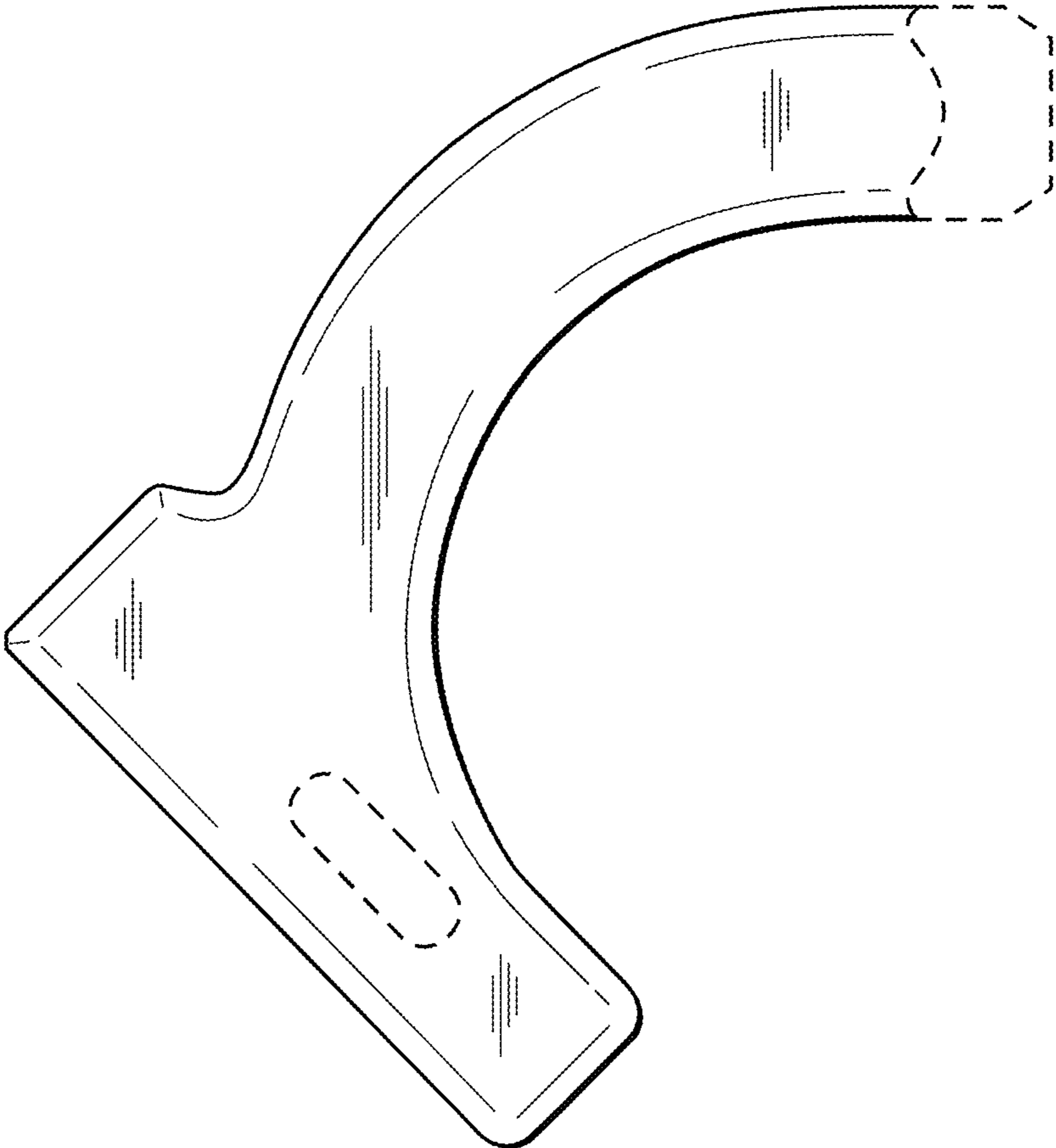

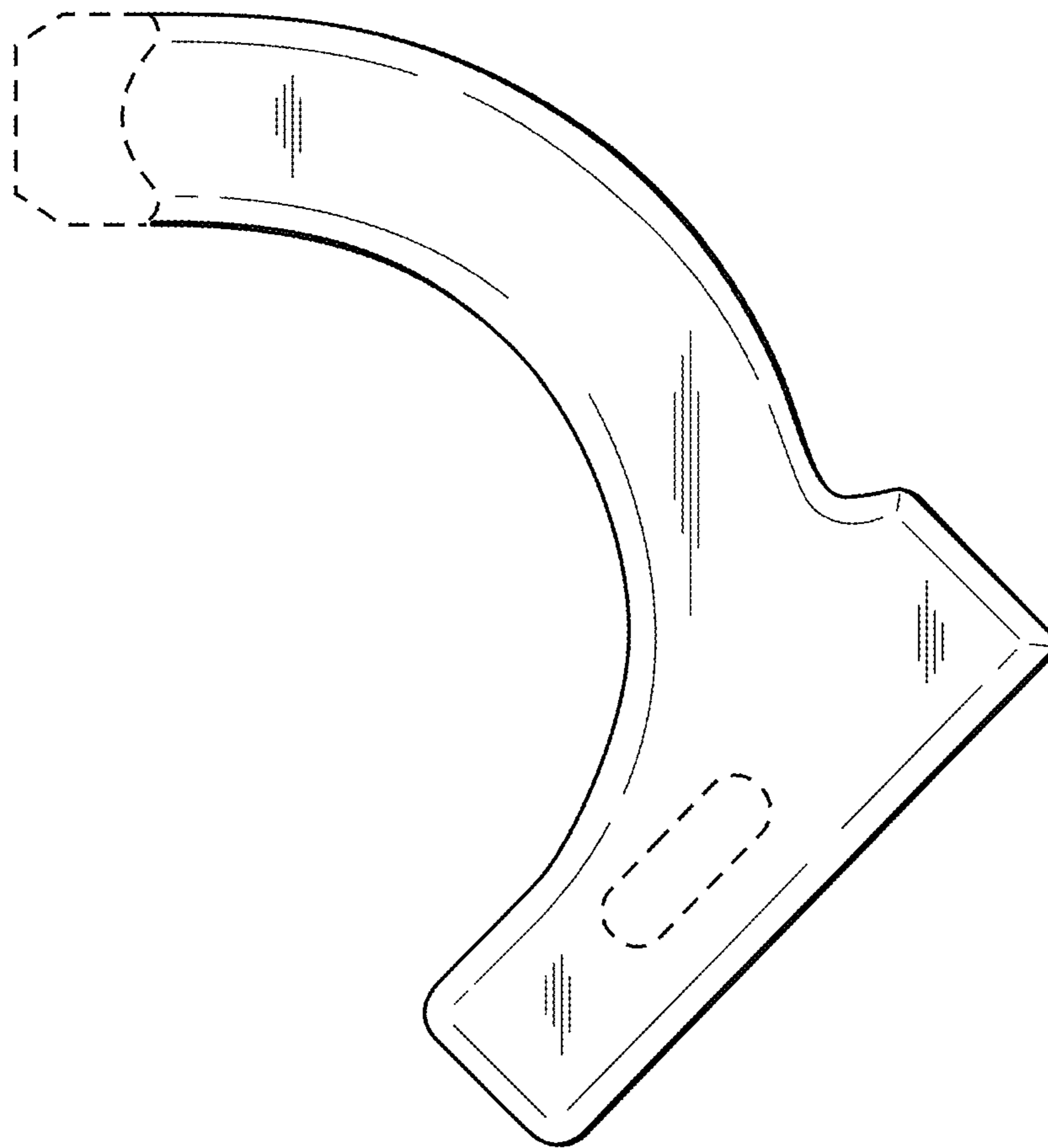

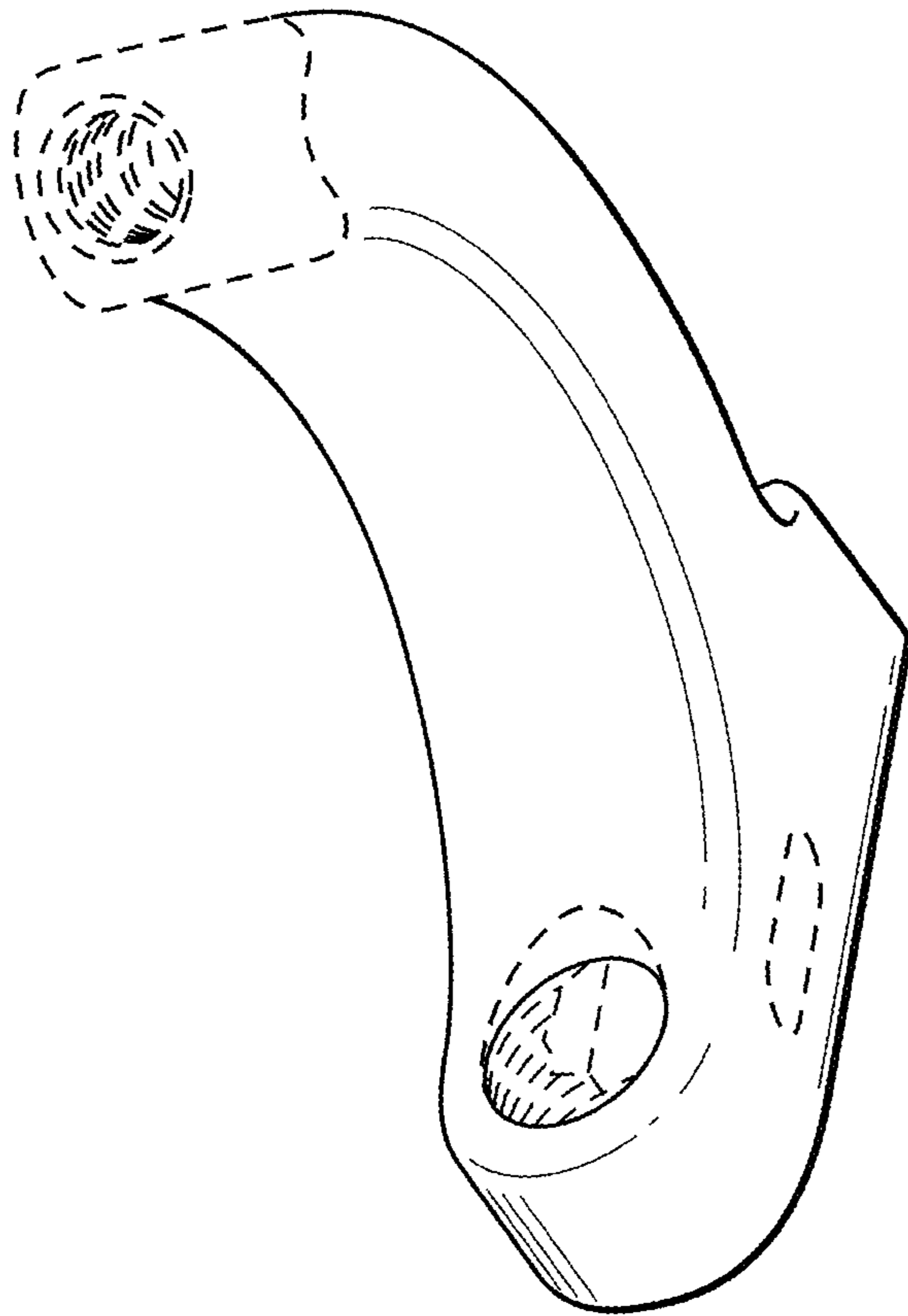
