(57) **CLAIM**

The ornamental design for a box for dental instruments and parts set, as shown and described.

**DESCRIPTION**

FIG. 1 is a top perspective view of the closed box element of a box for dental instruments and parts set showing our new design;

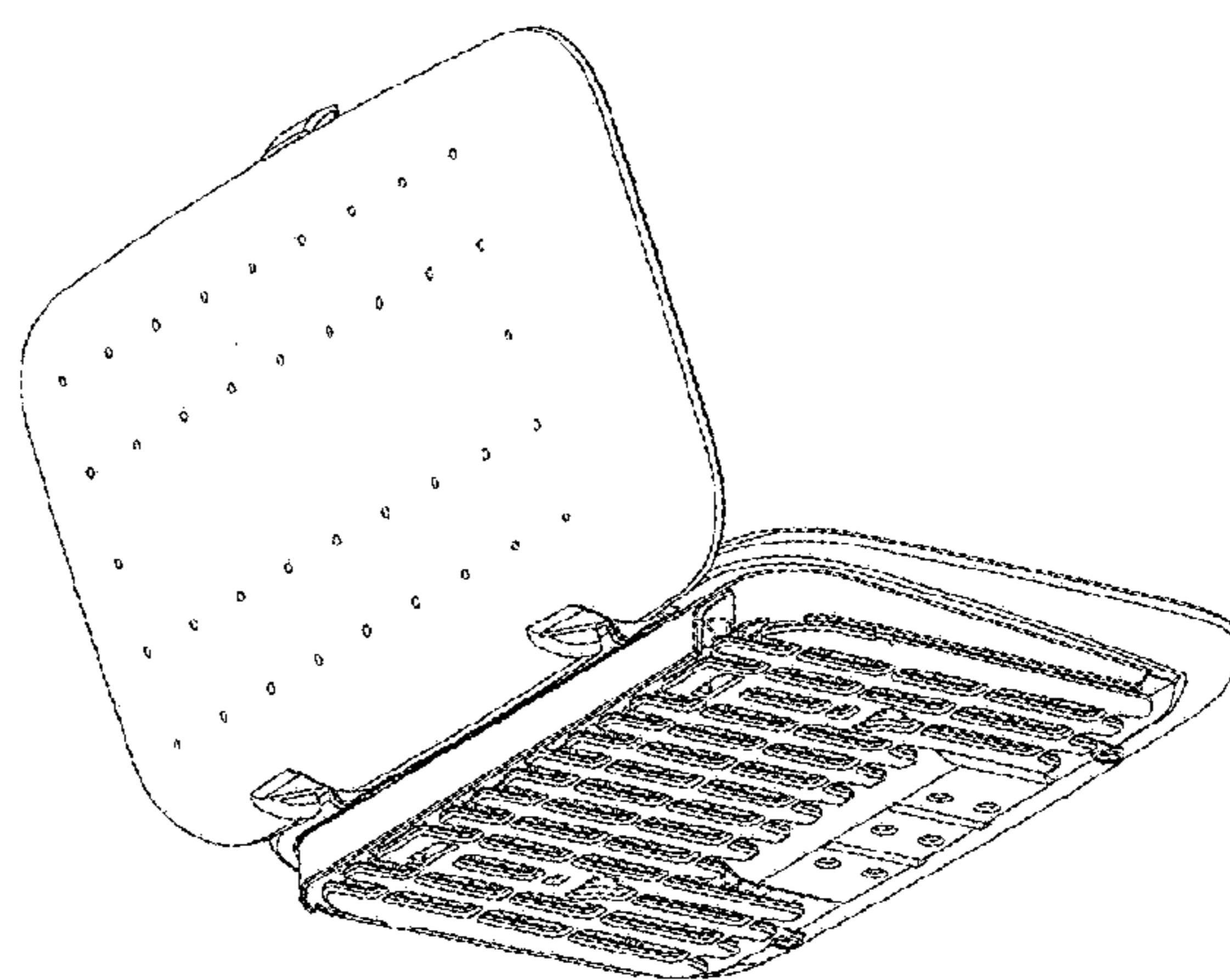
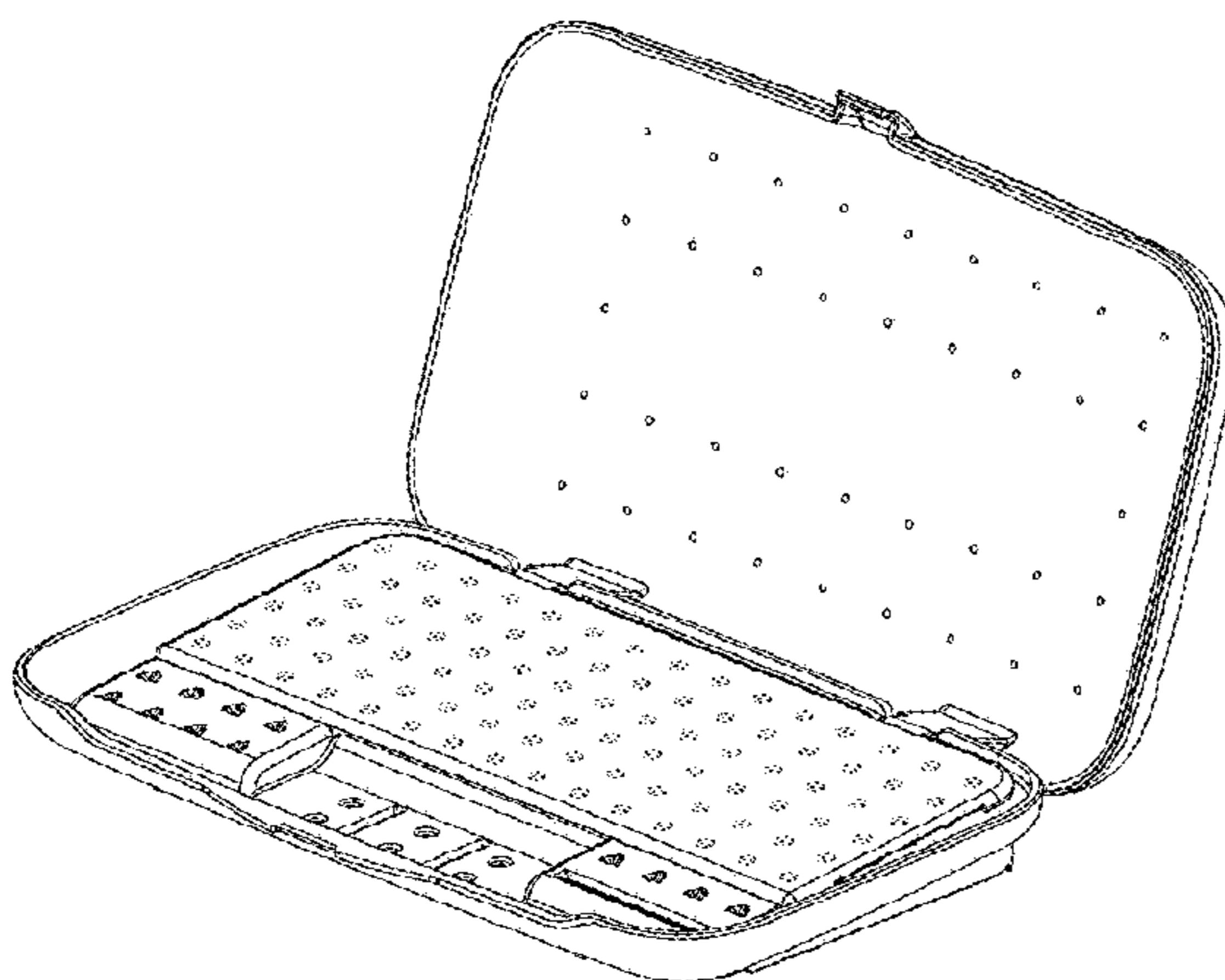


FIG. 30 is a bottom plan view thereof;

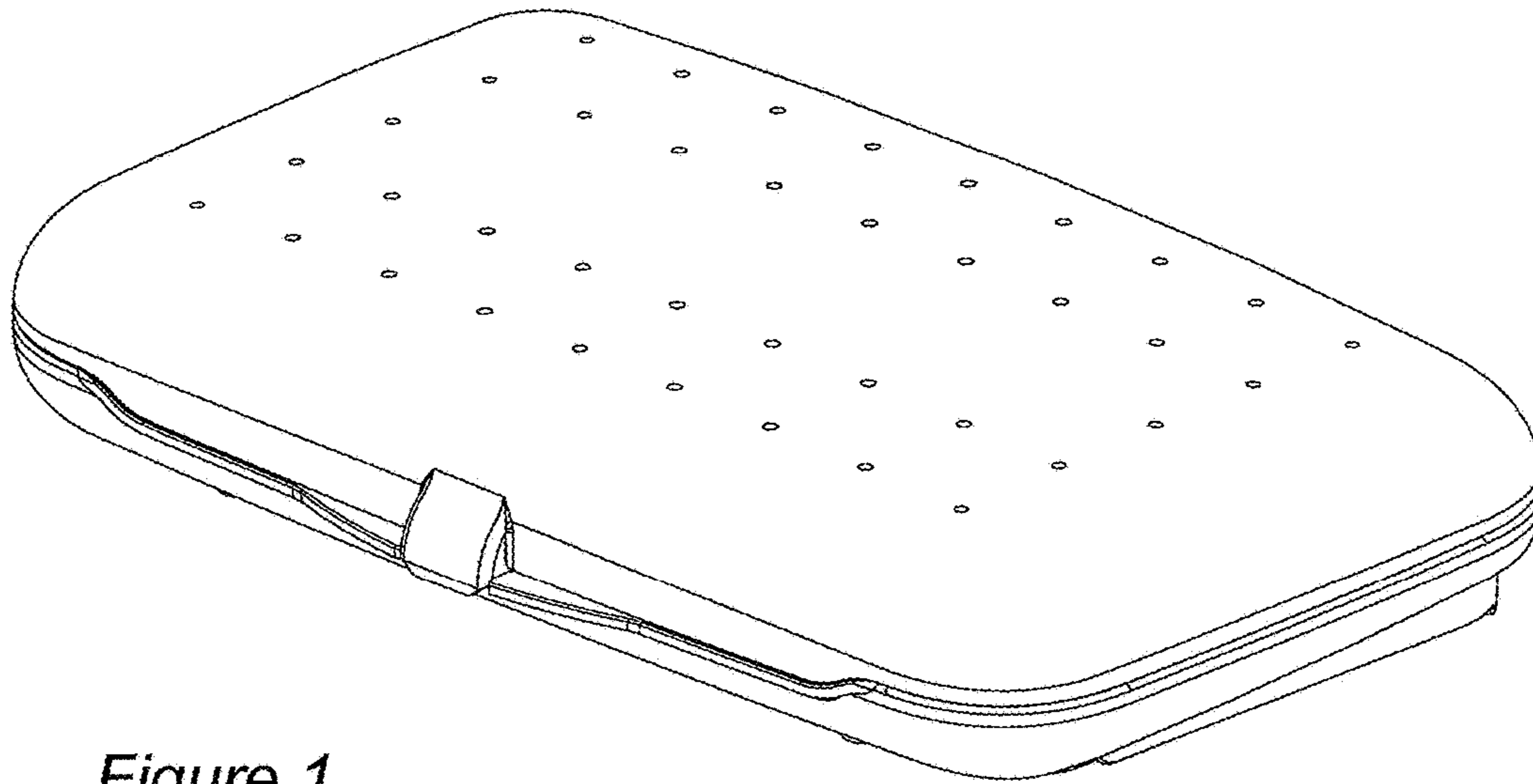

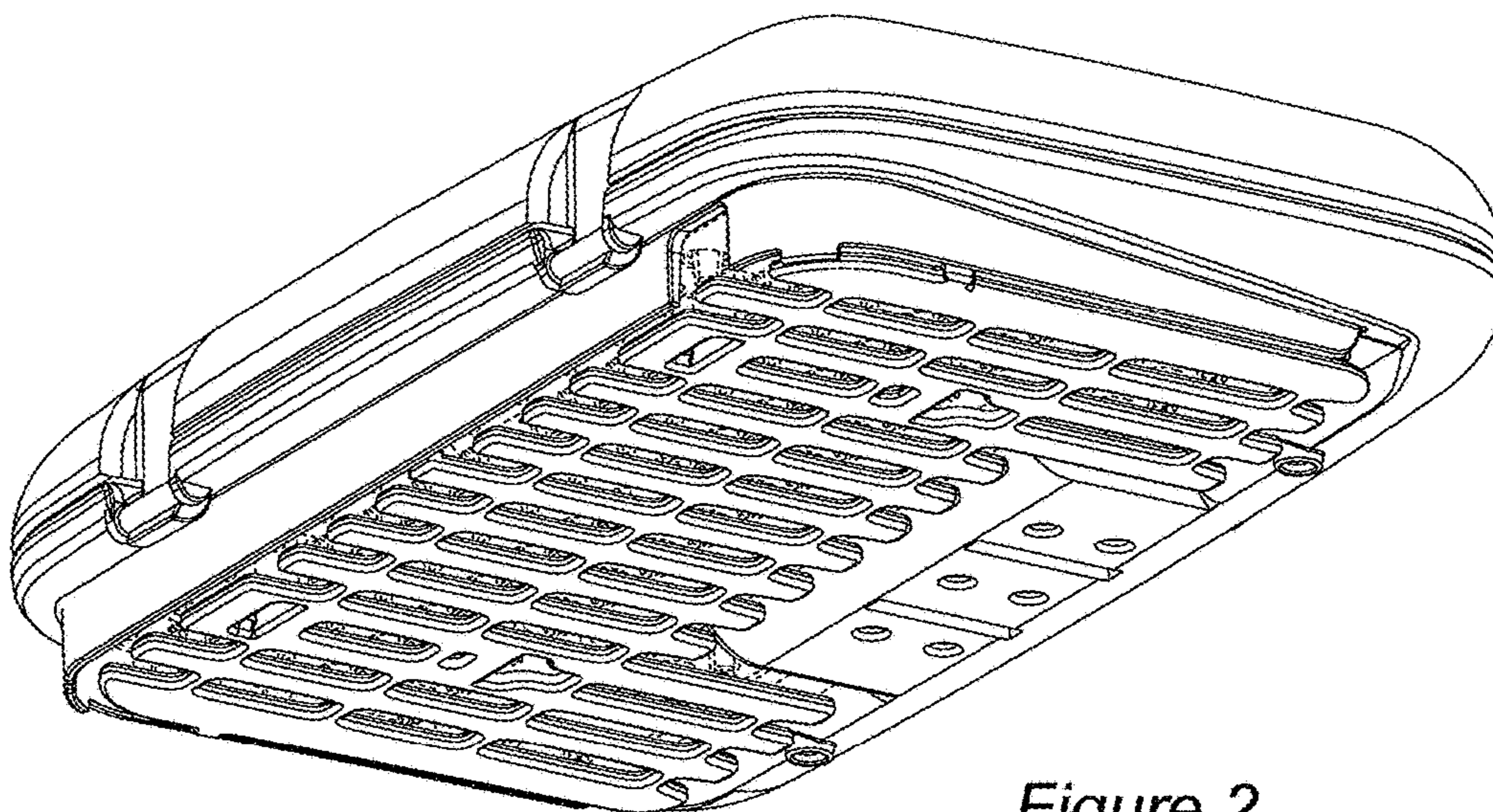

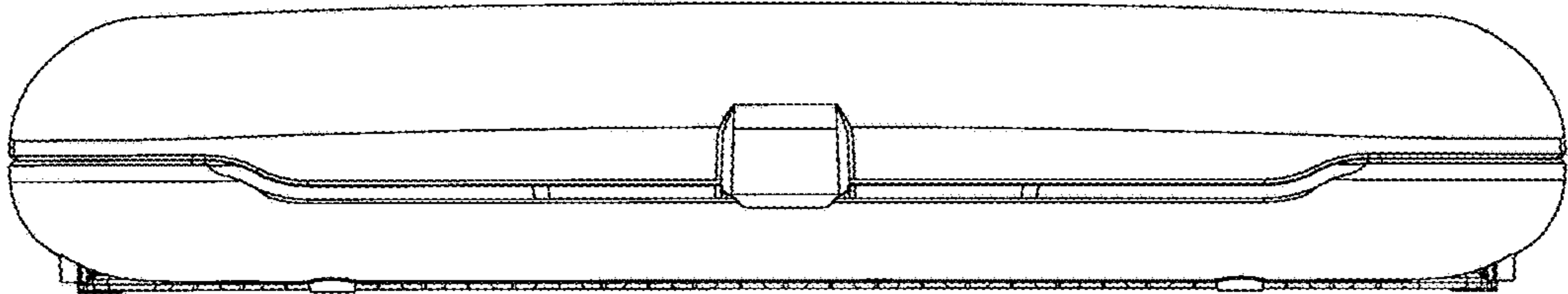

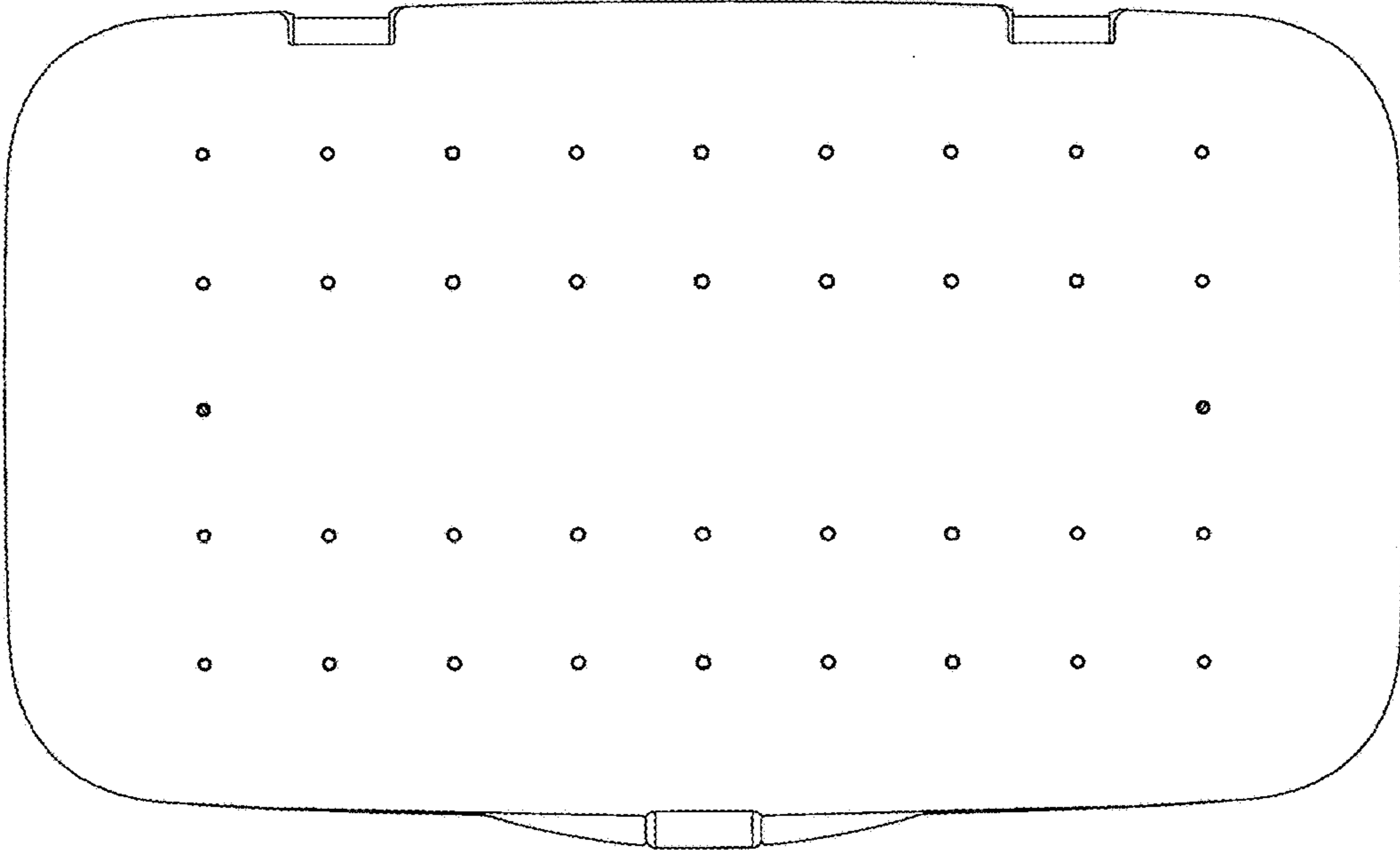
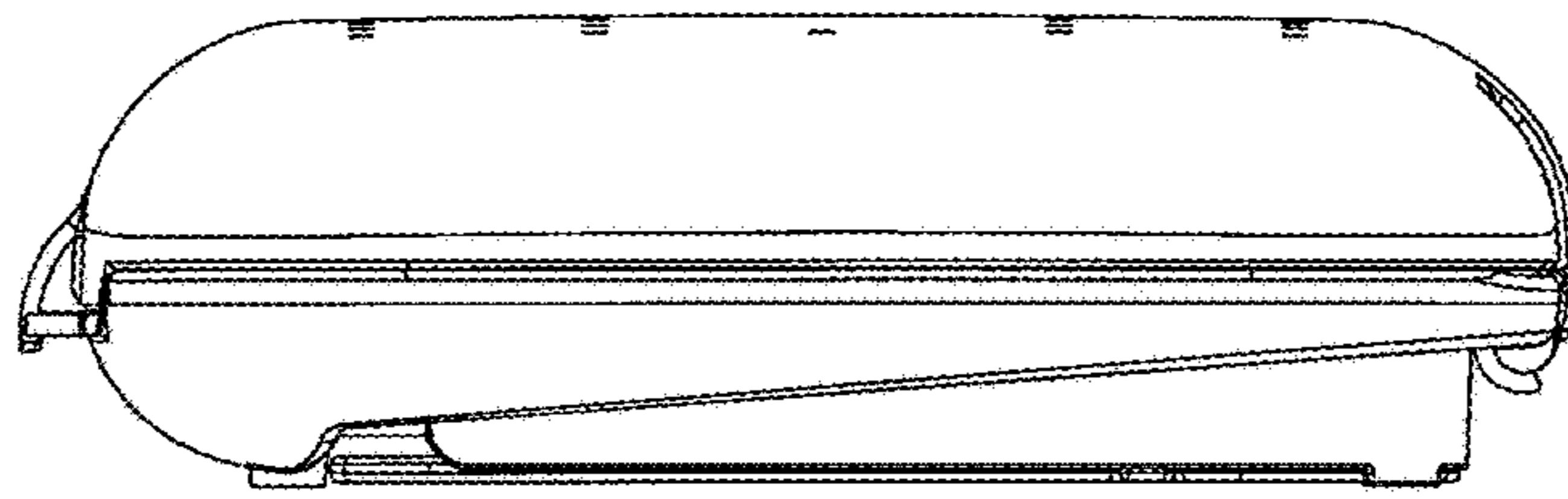
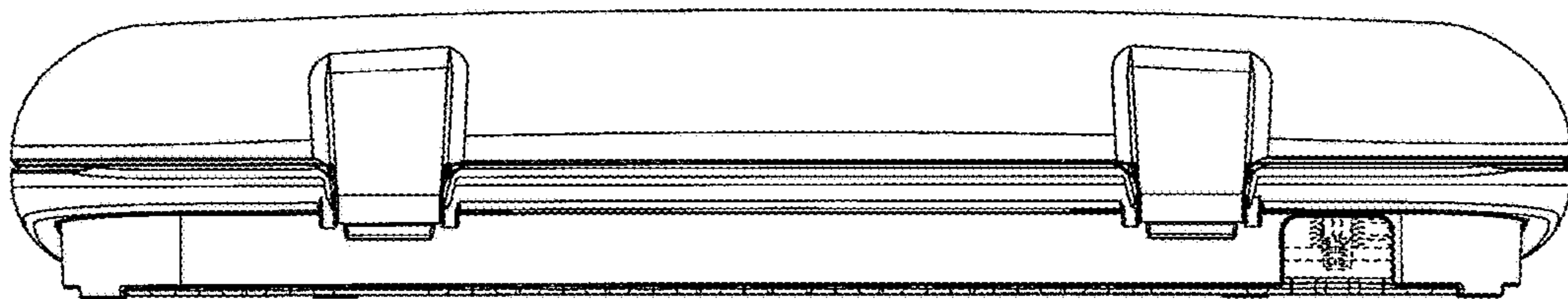

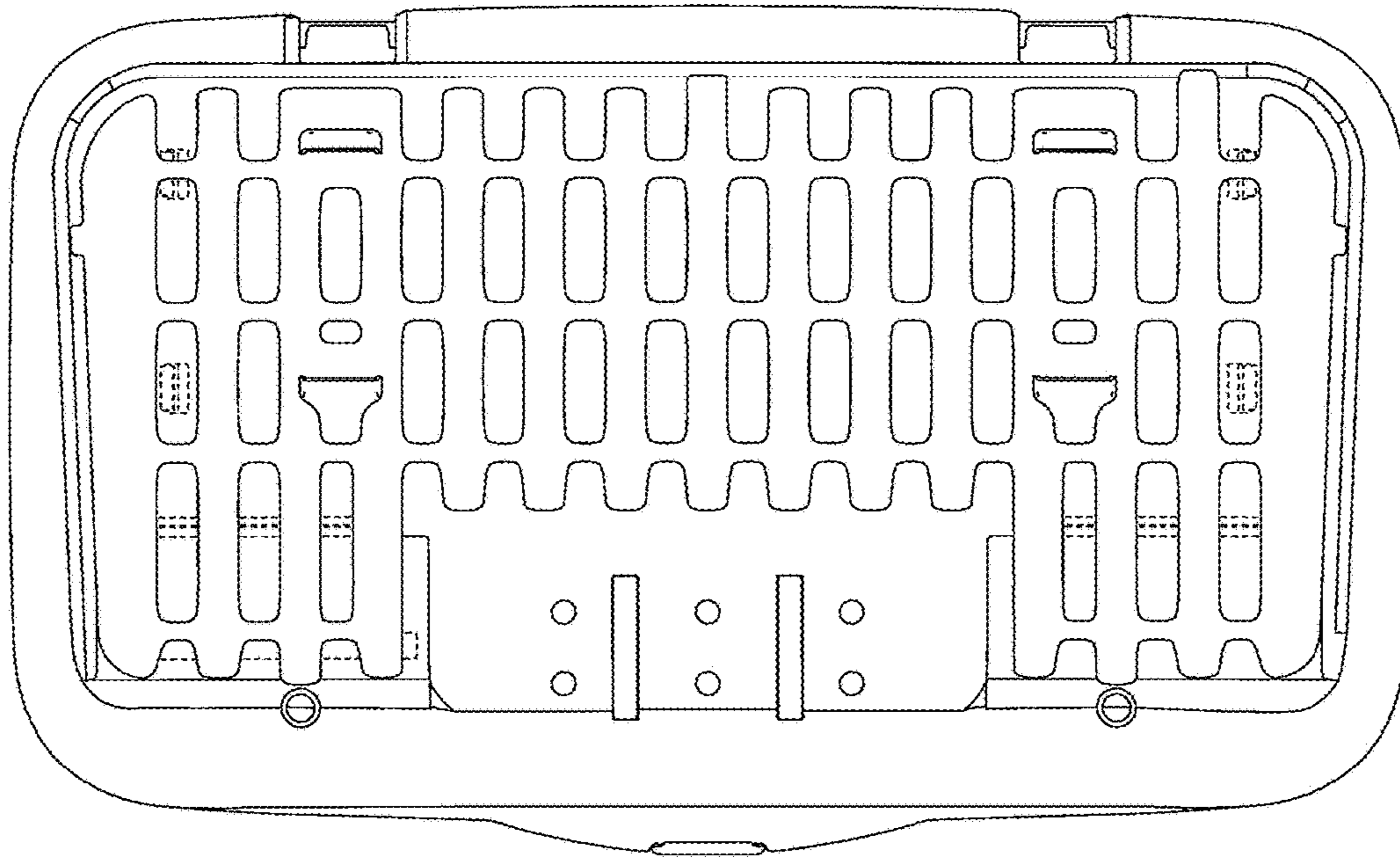

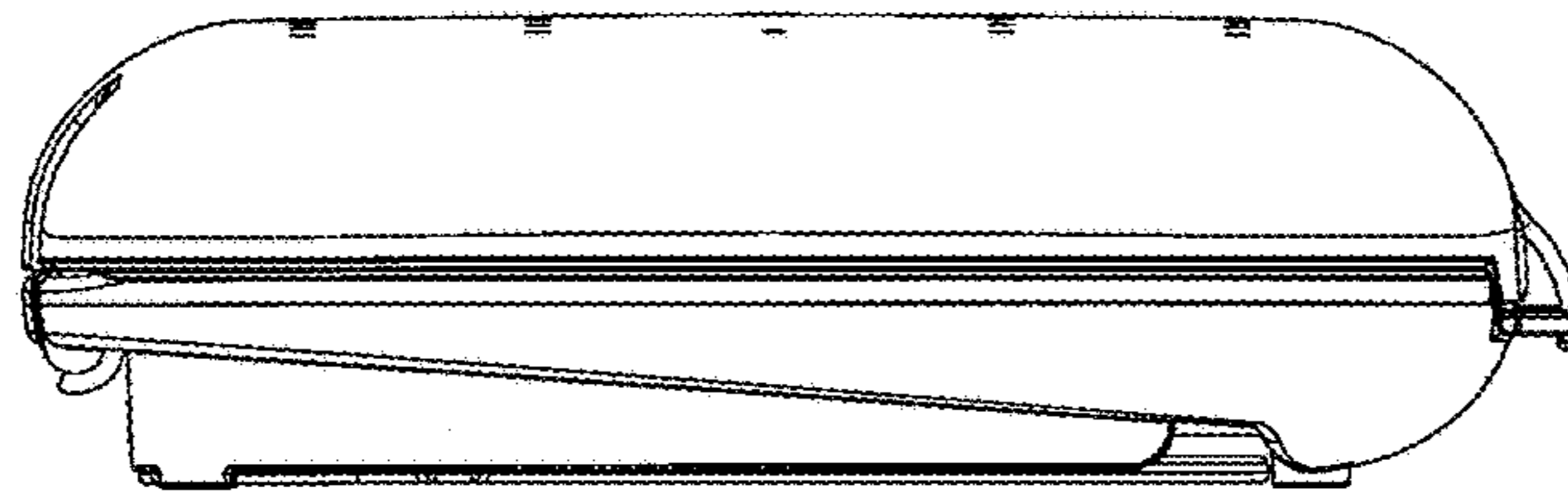

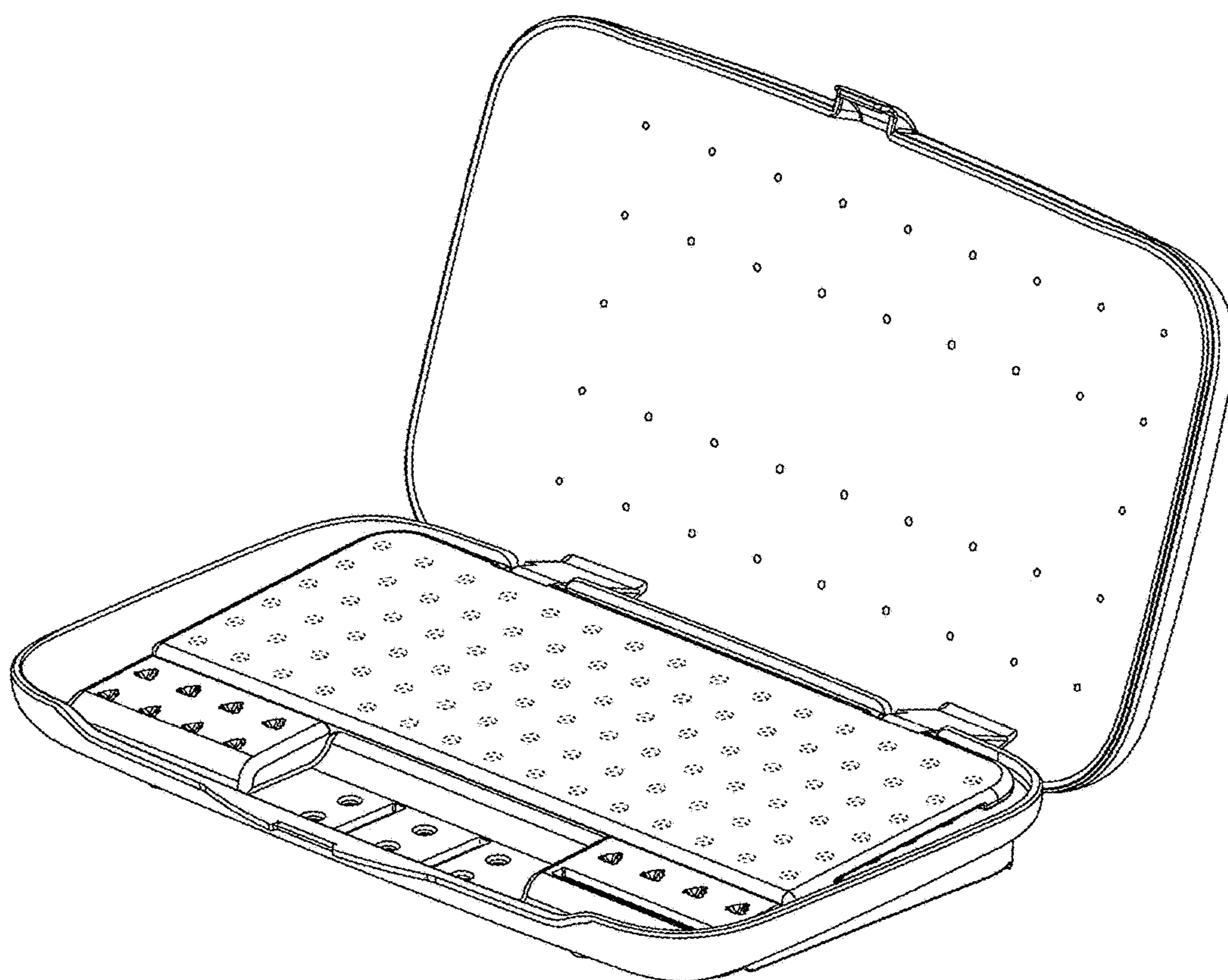

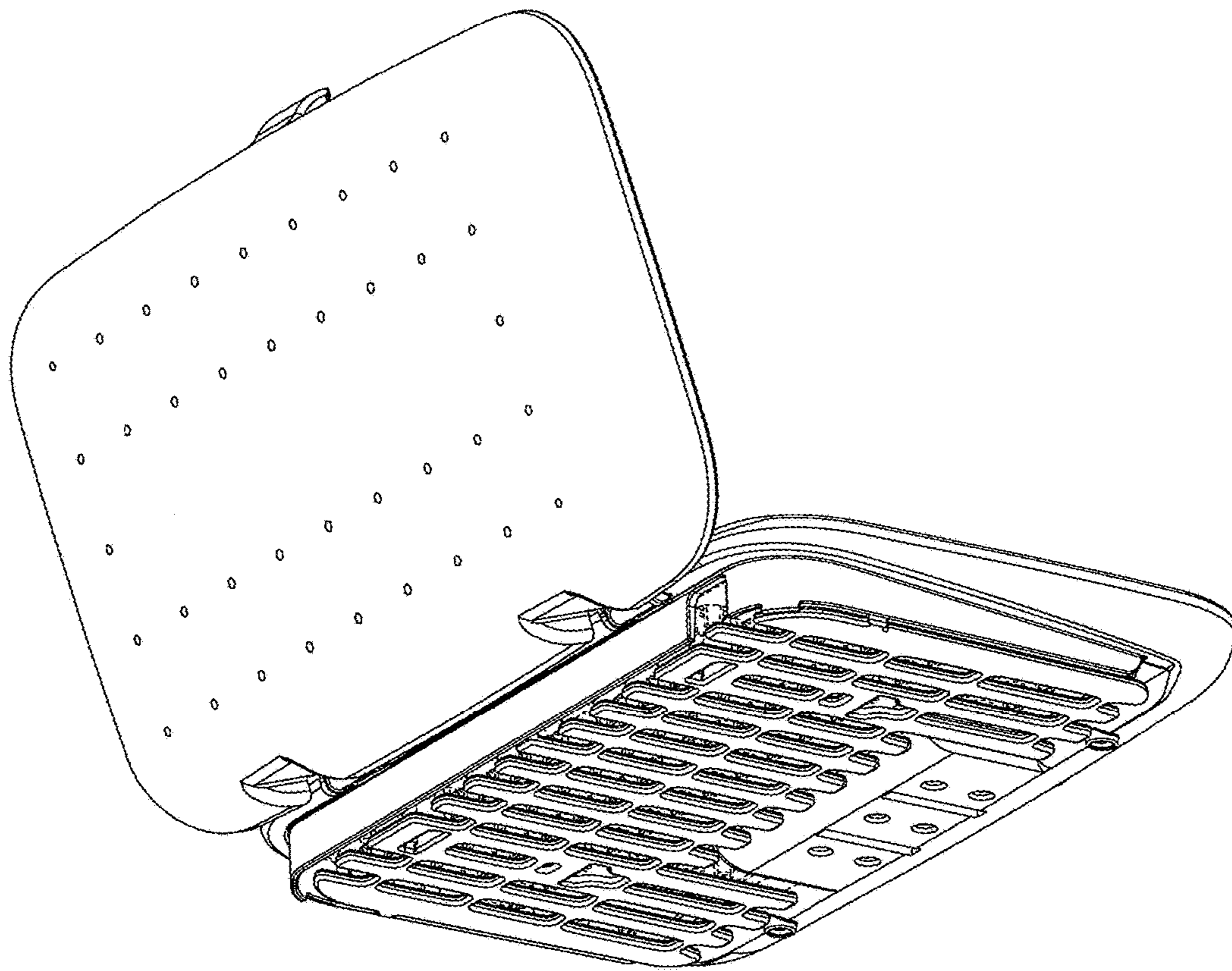

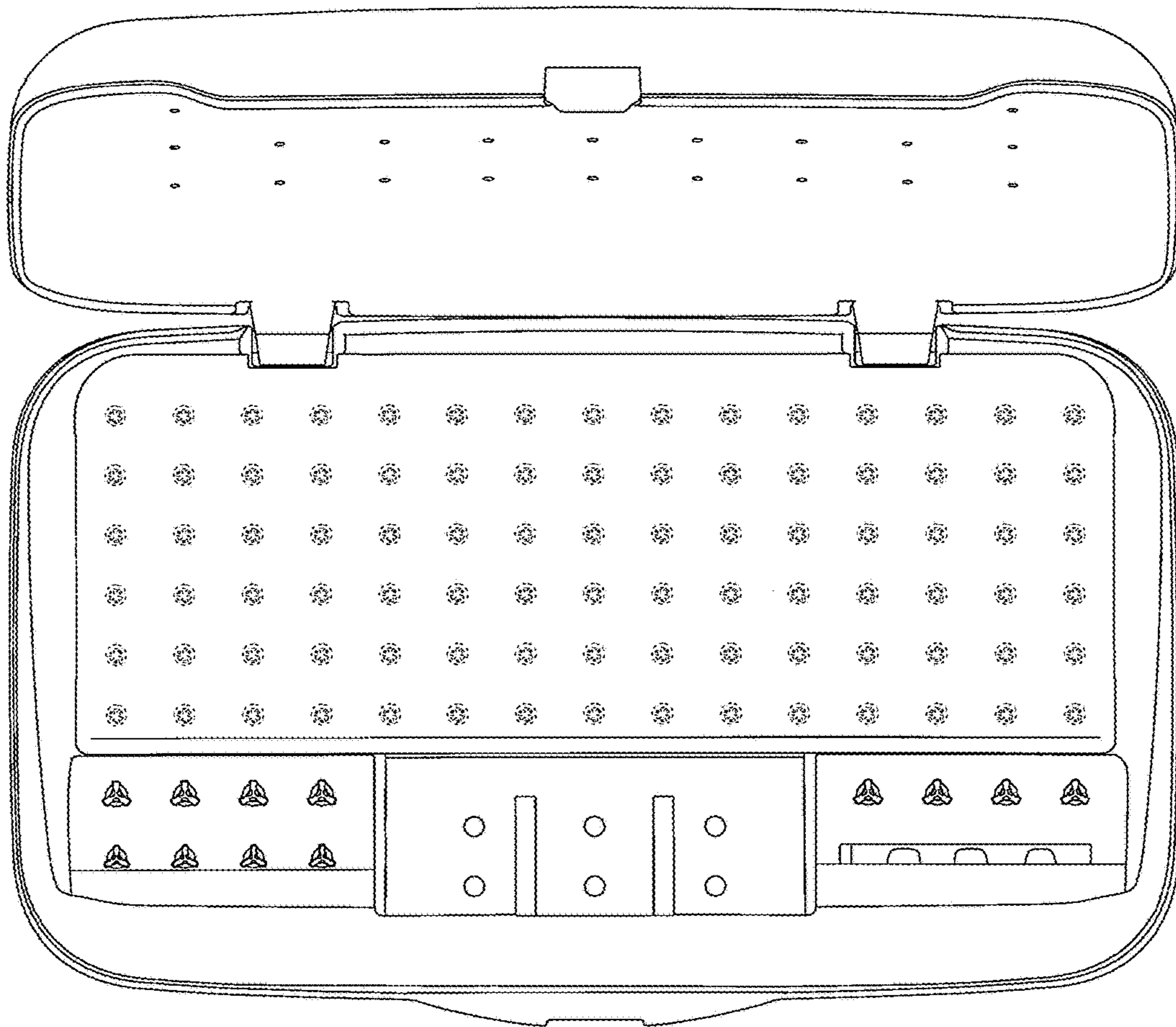

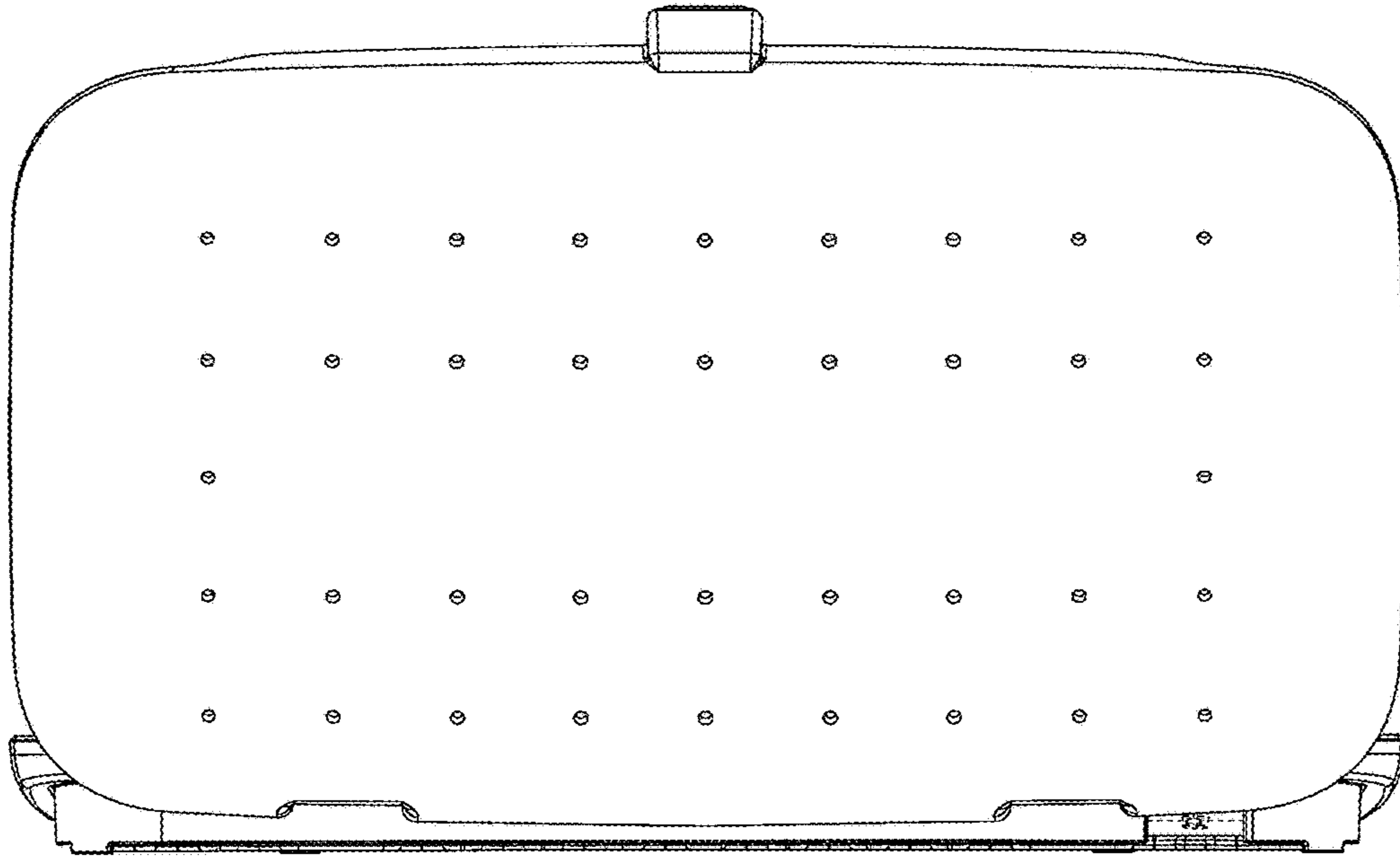

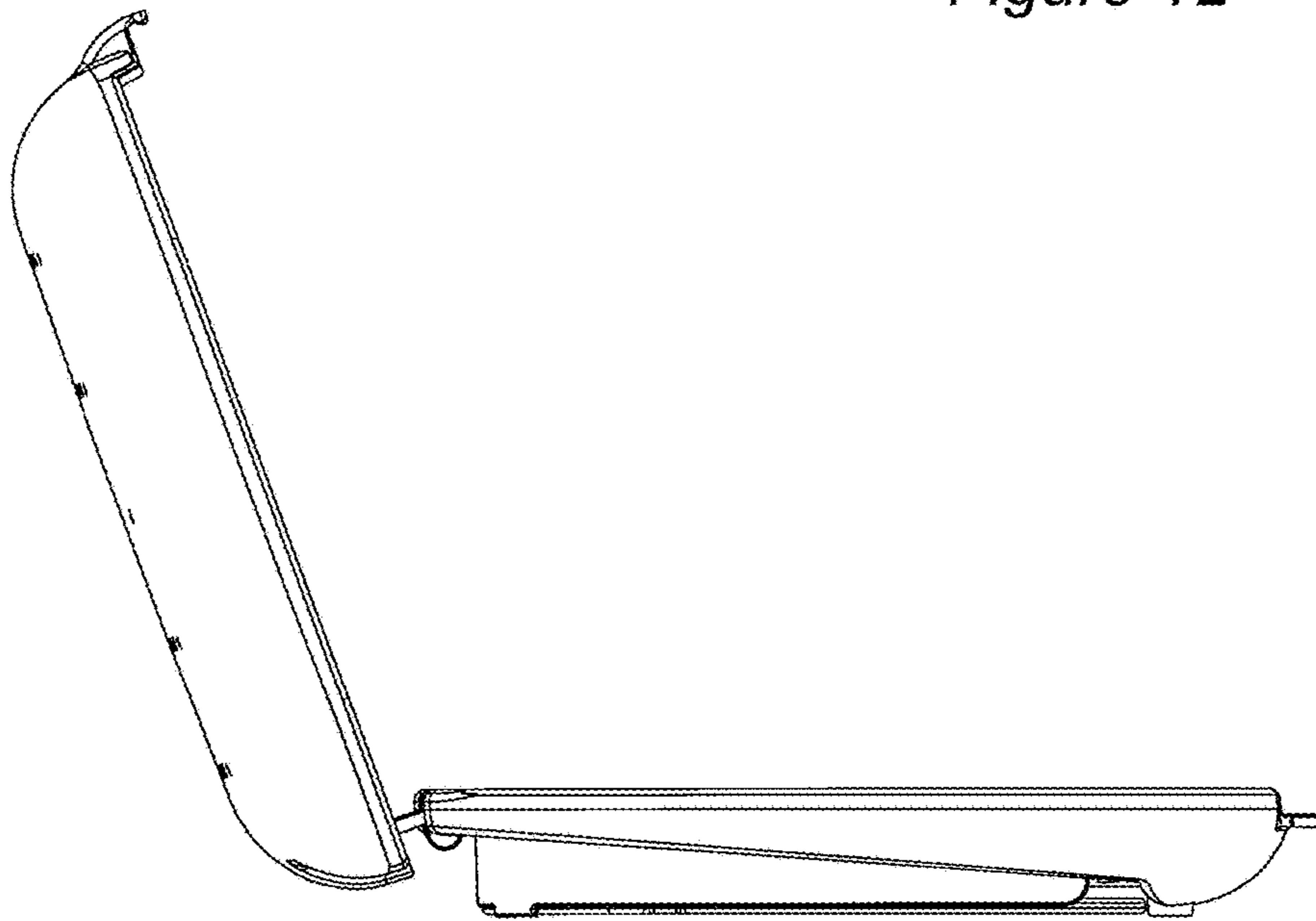

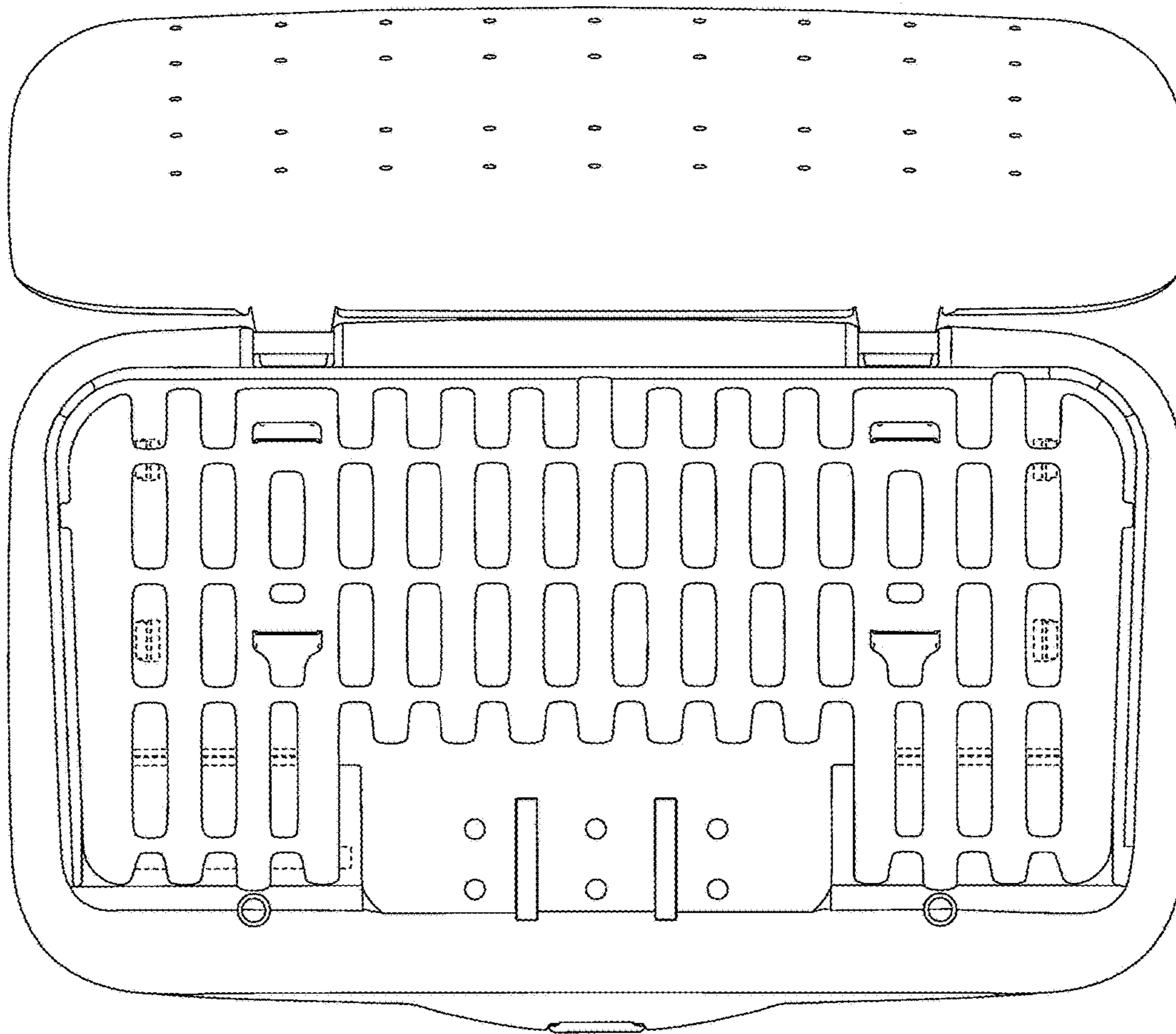

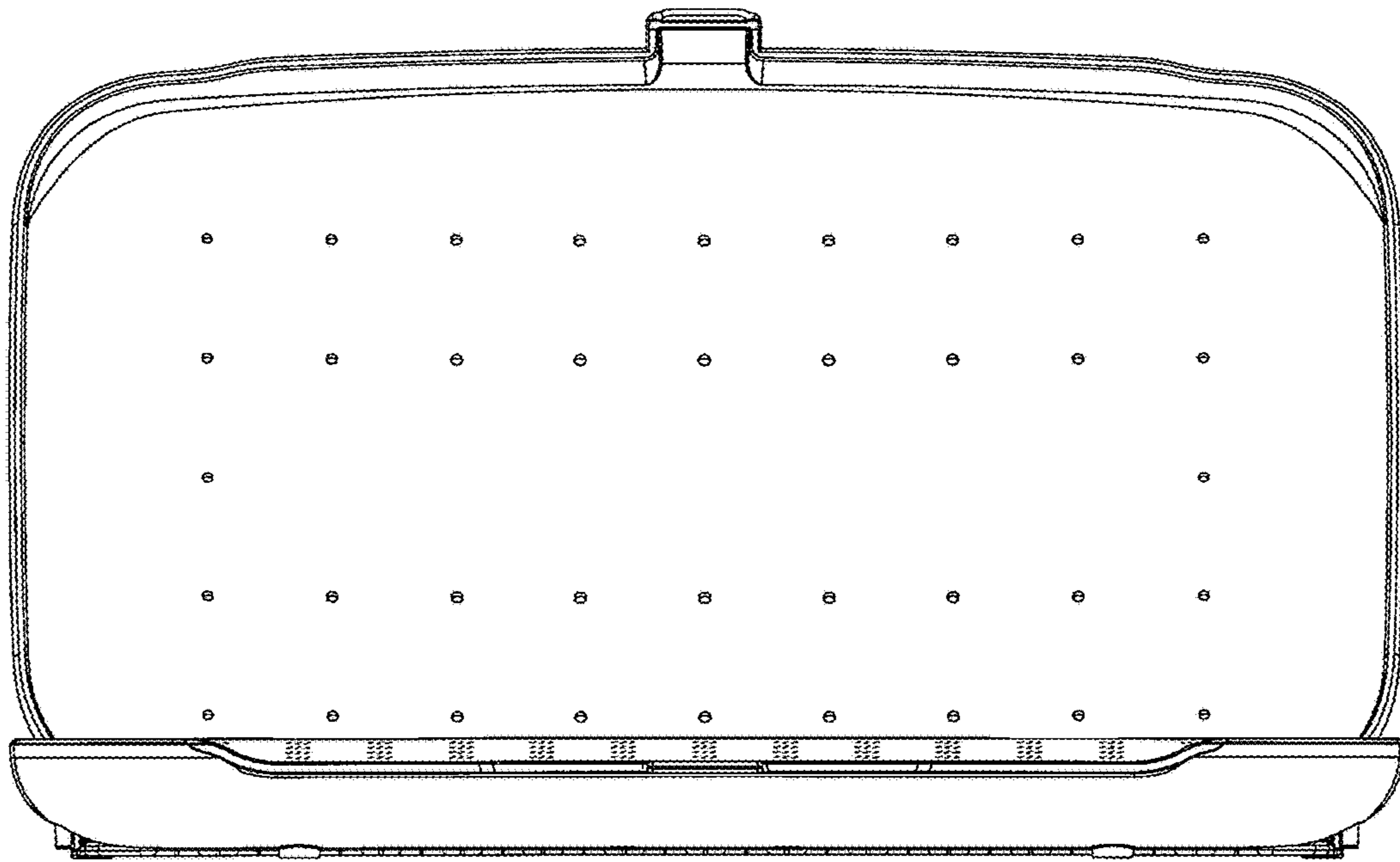

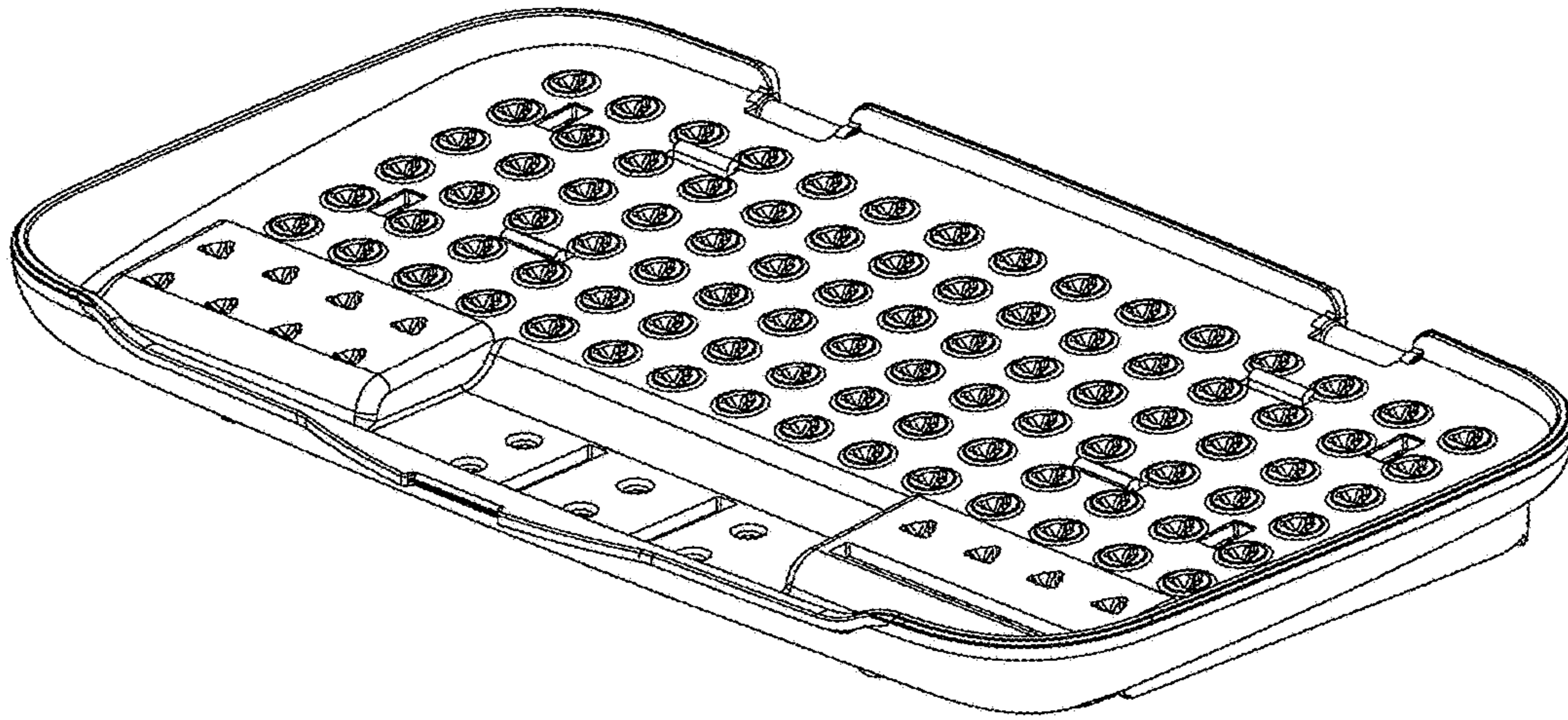

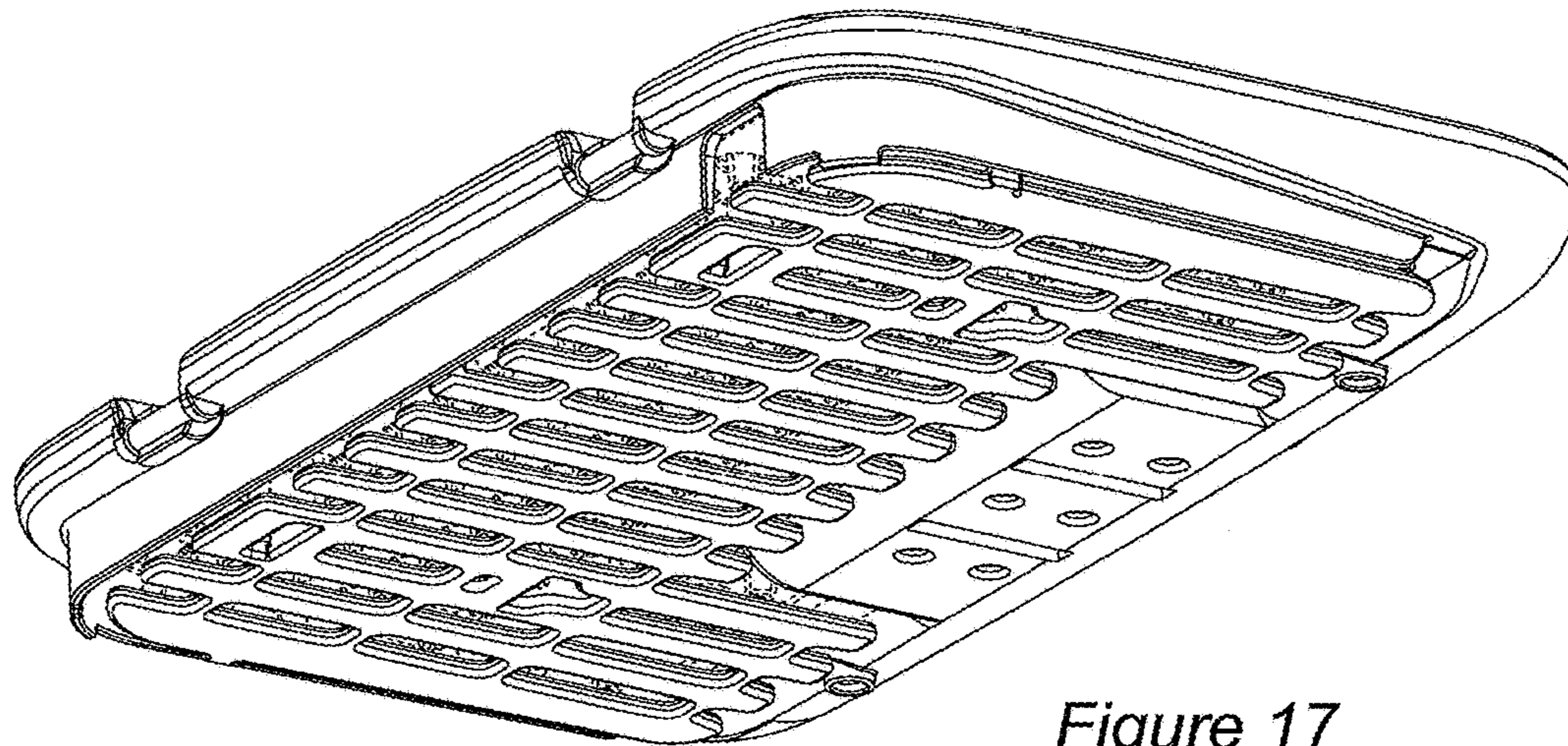

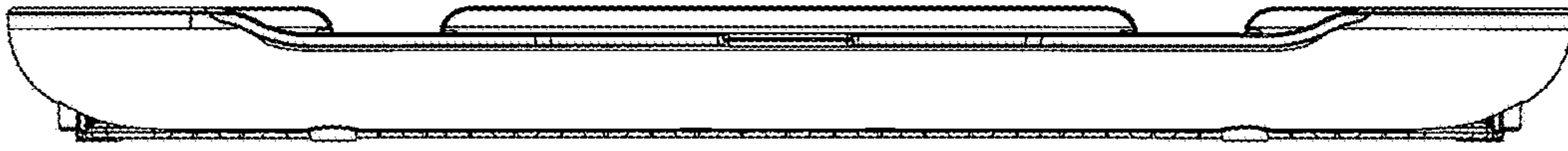

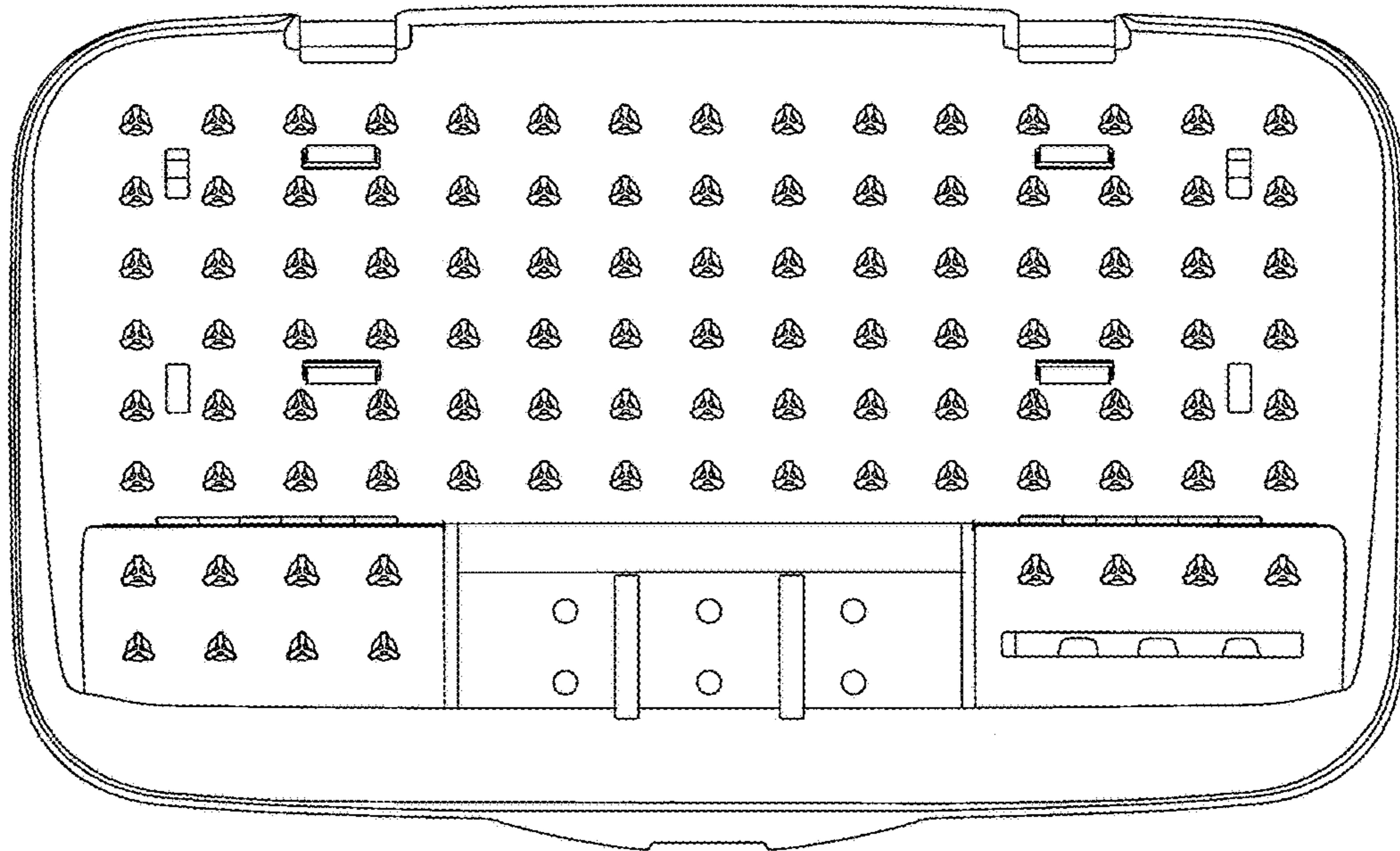

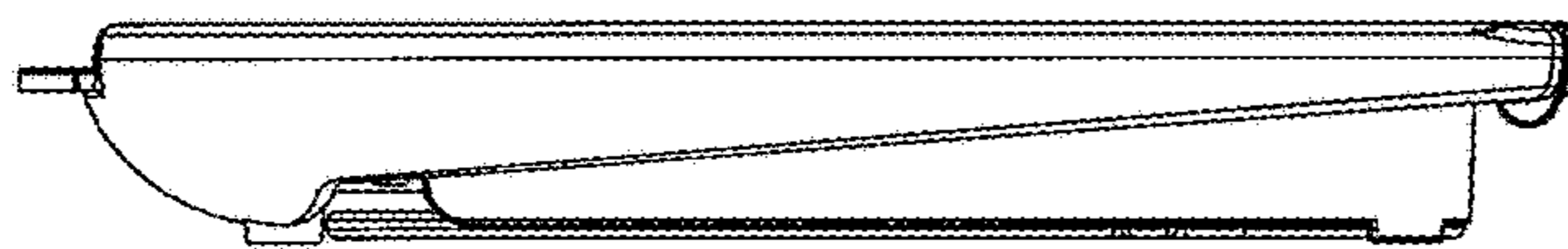

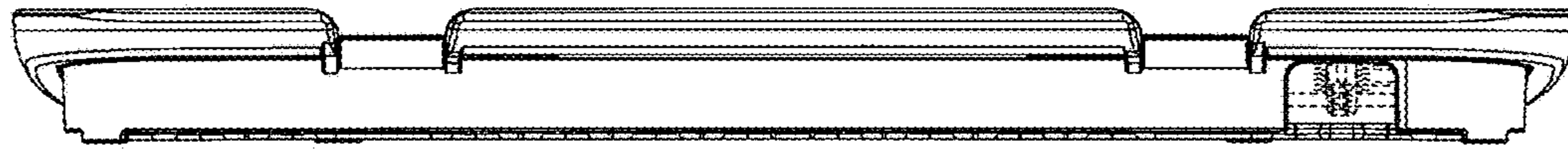

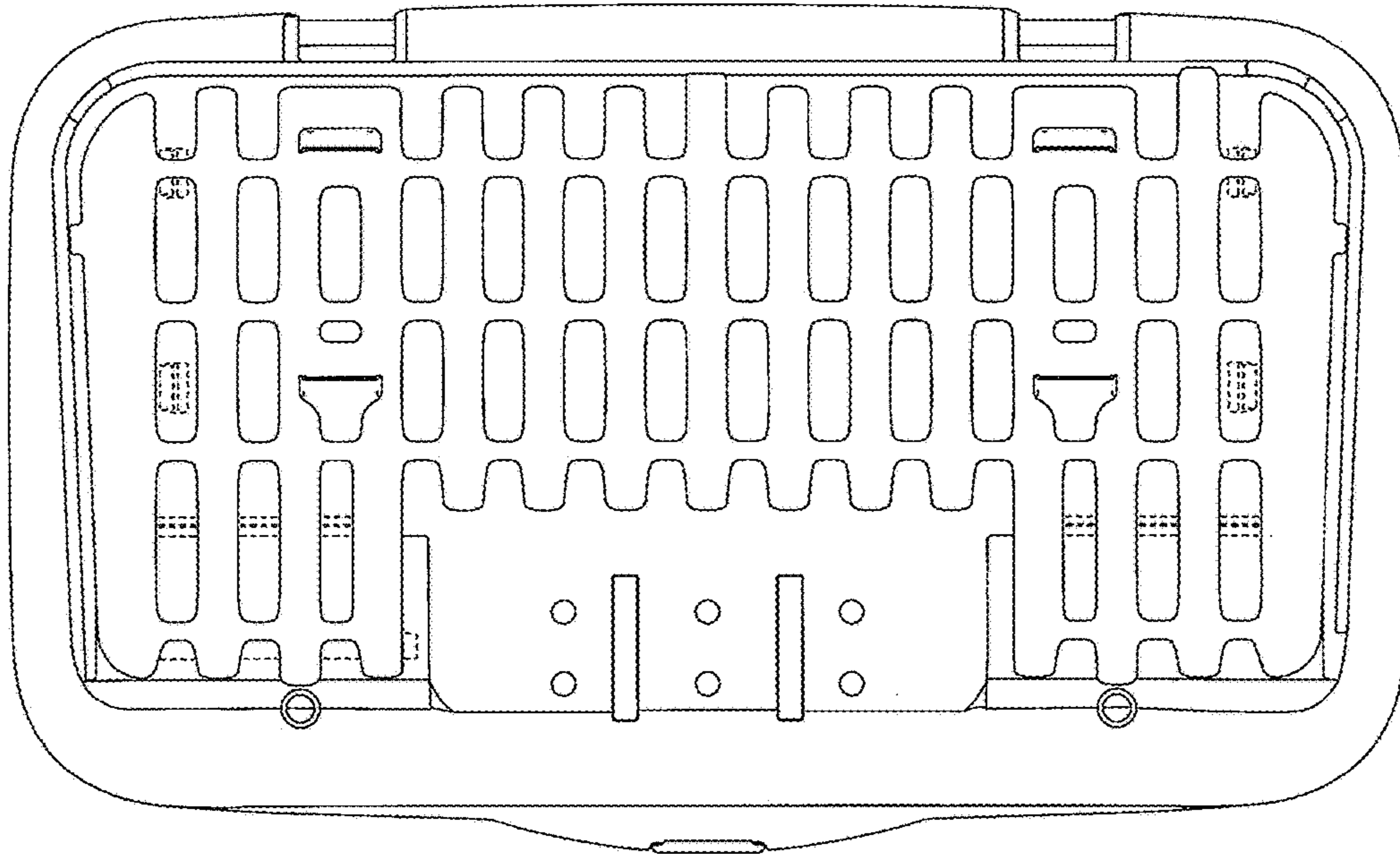

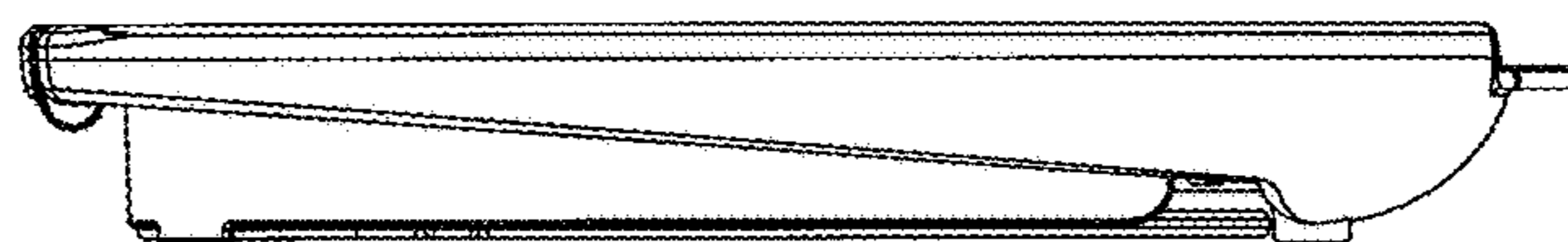

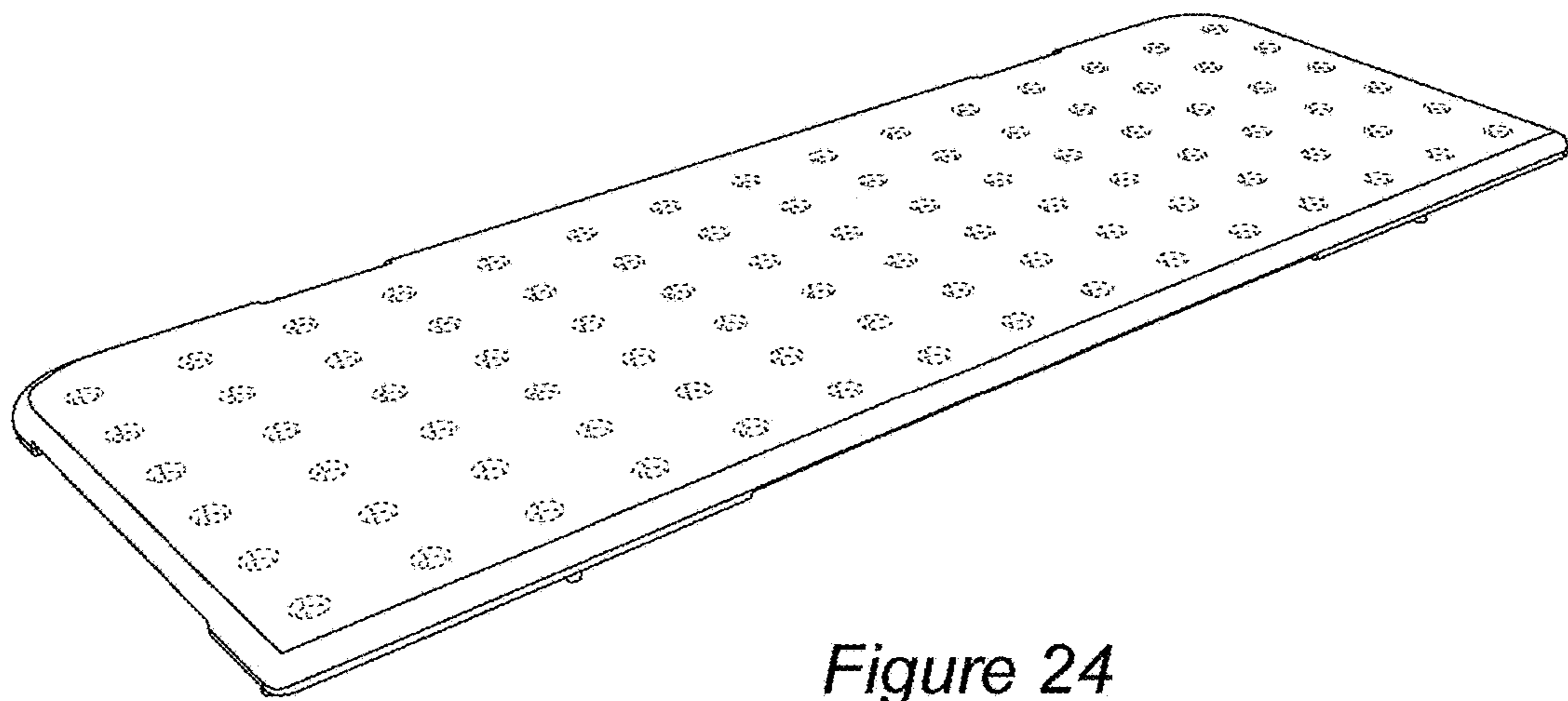

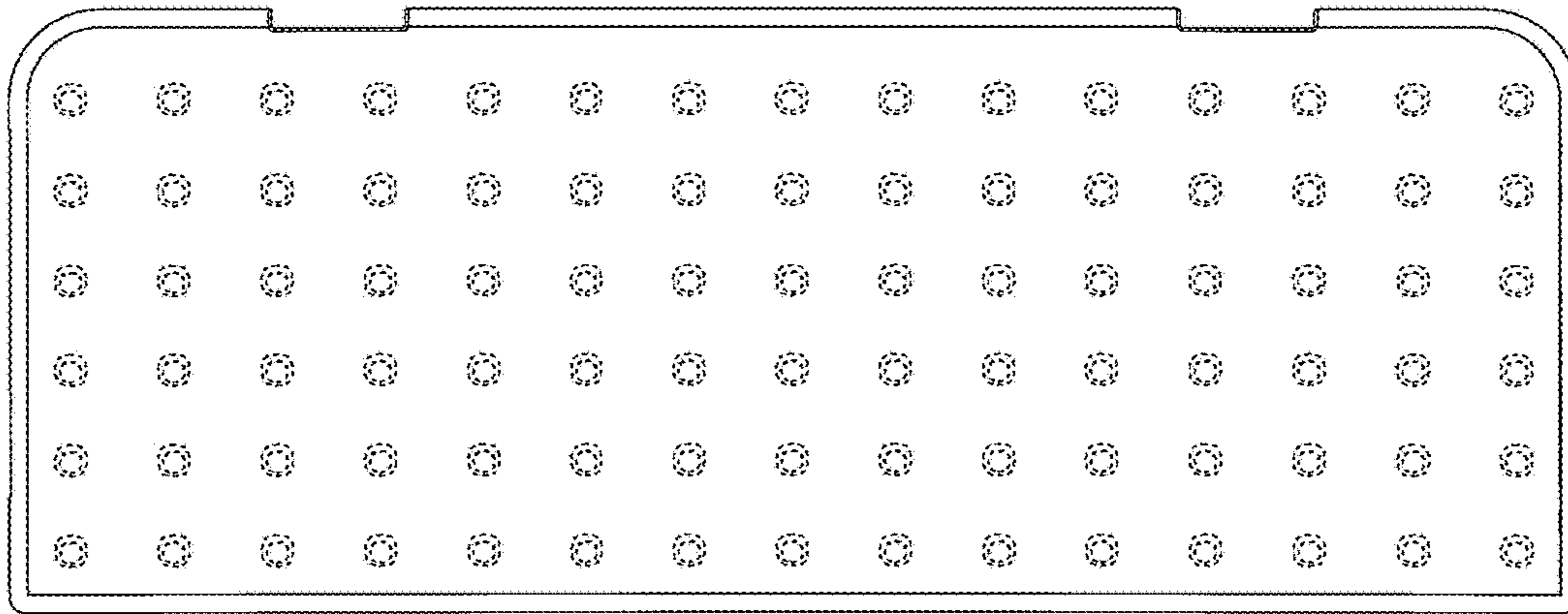

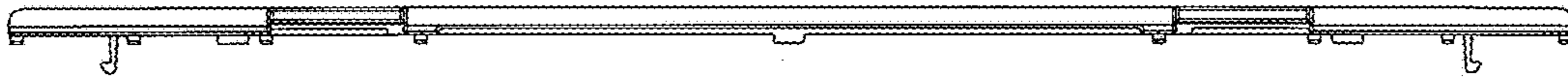

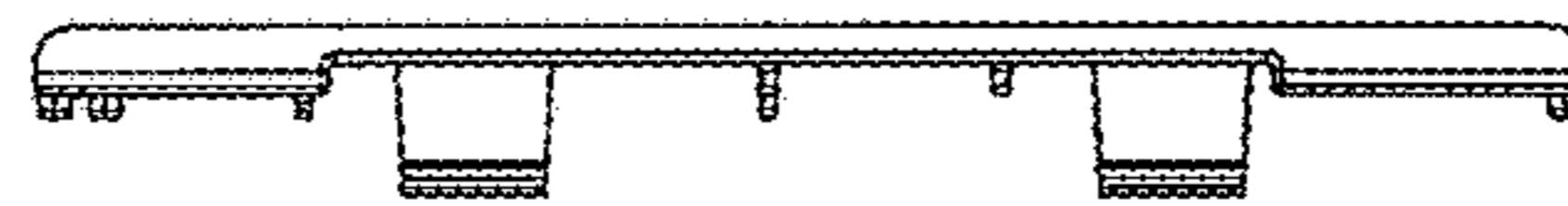

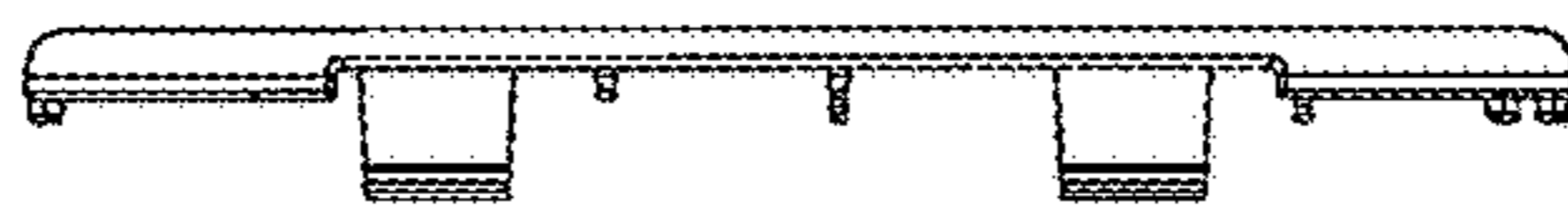

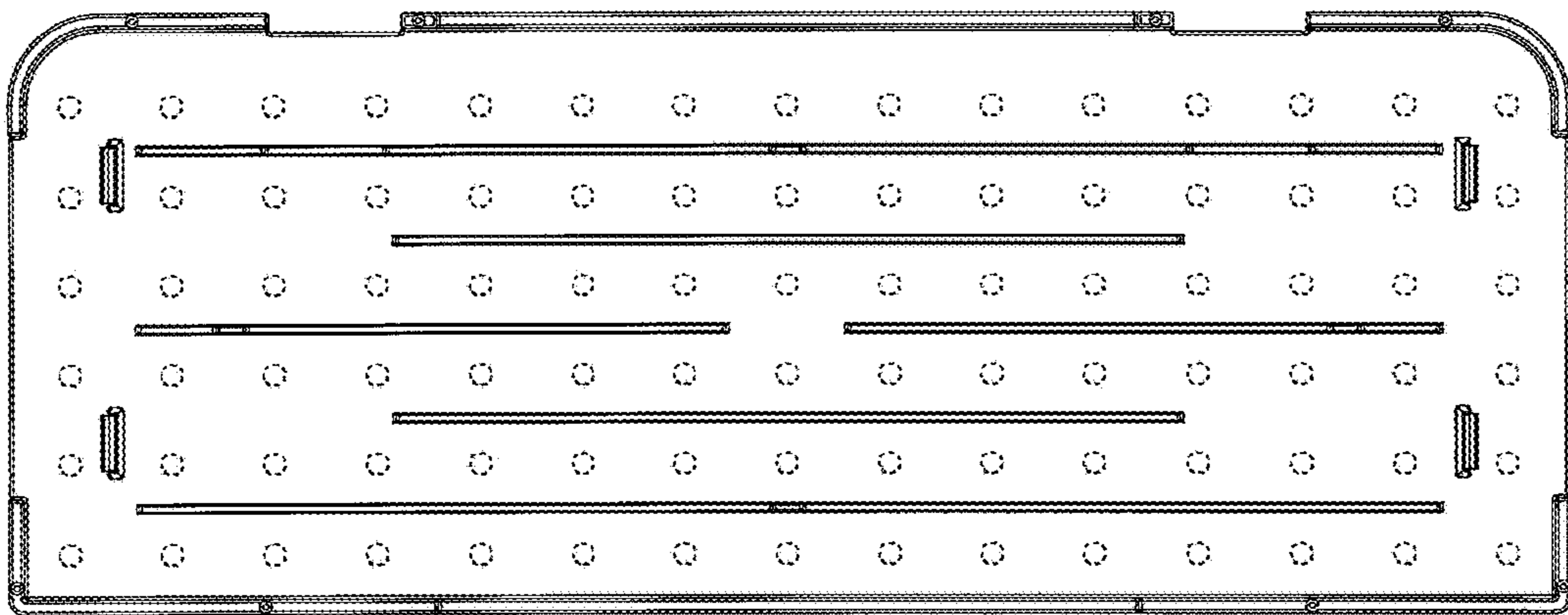

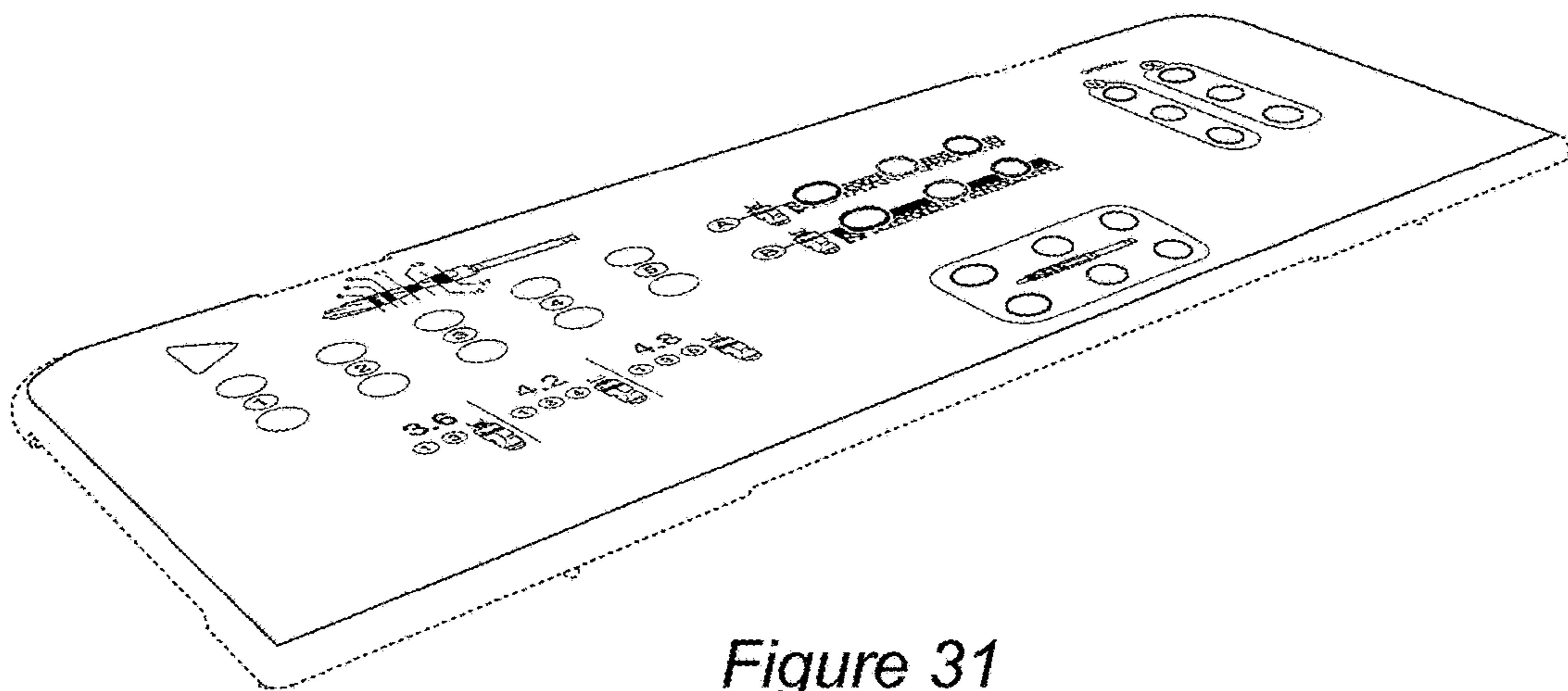

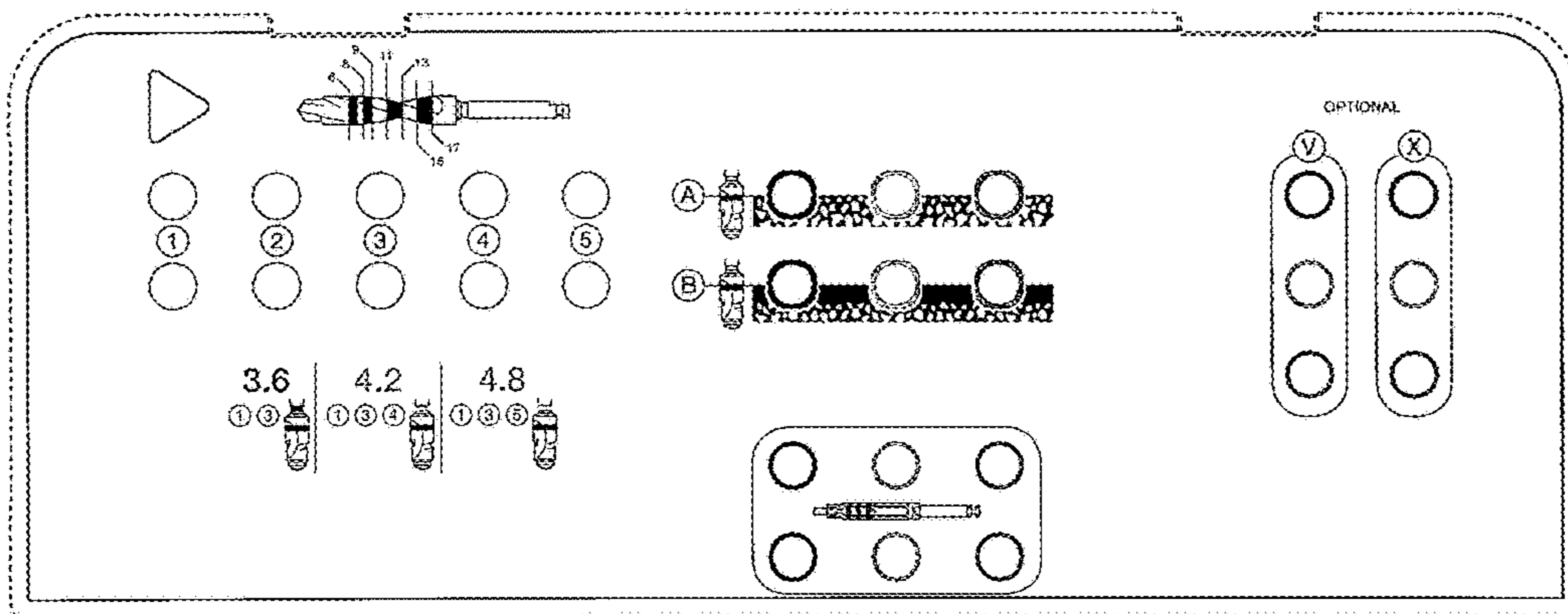

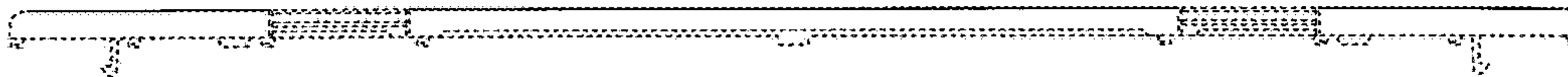

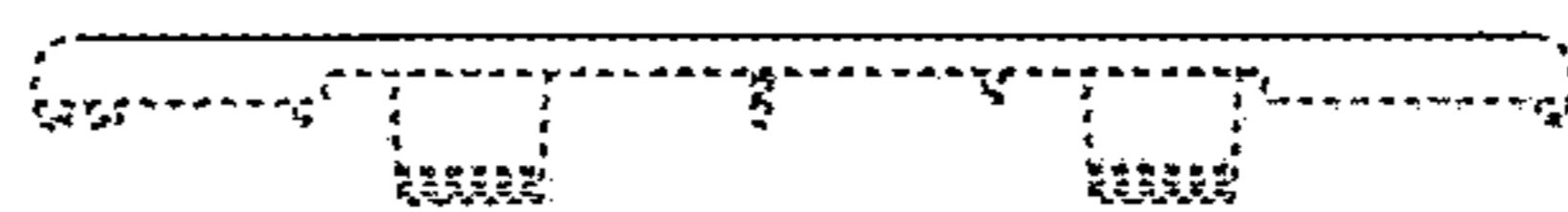

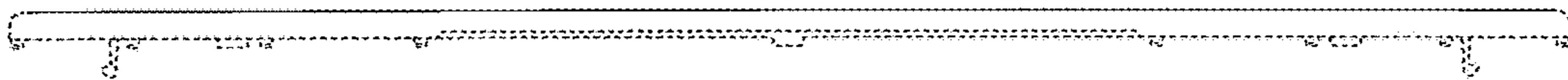

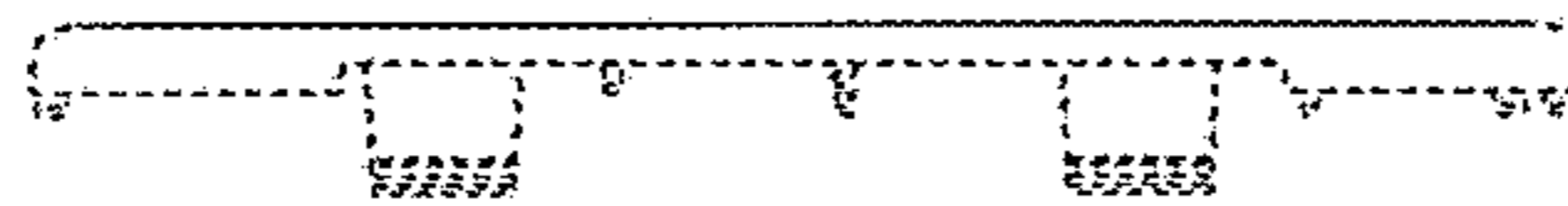

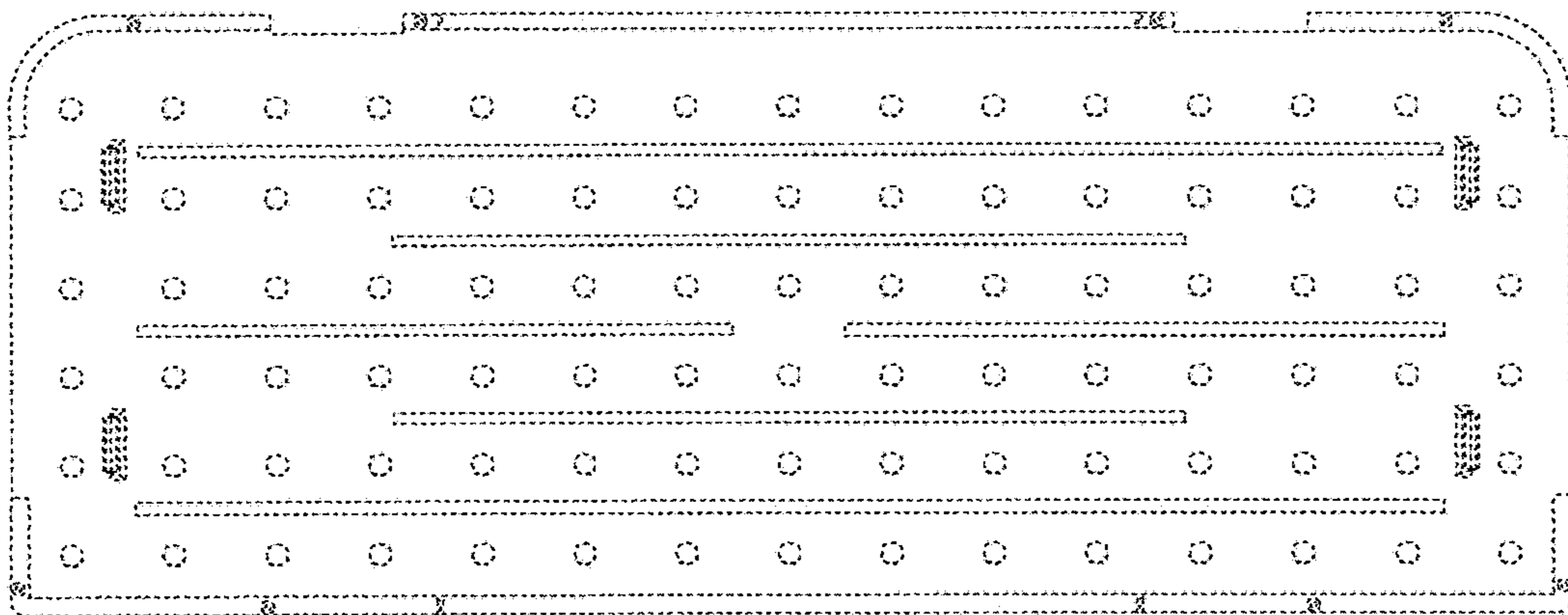

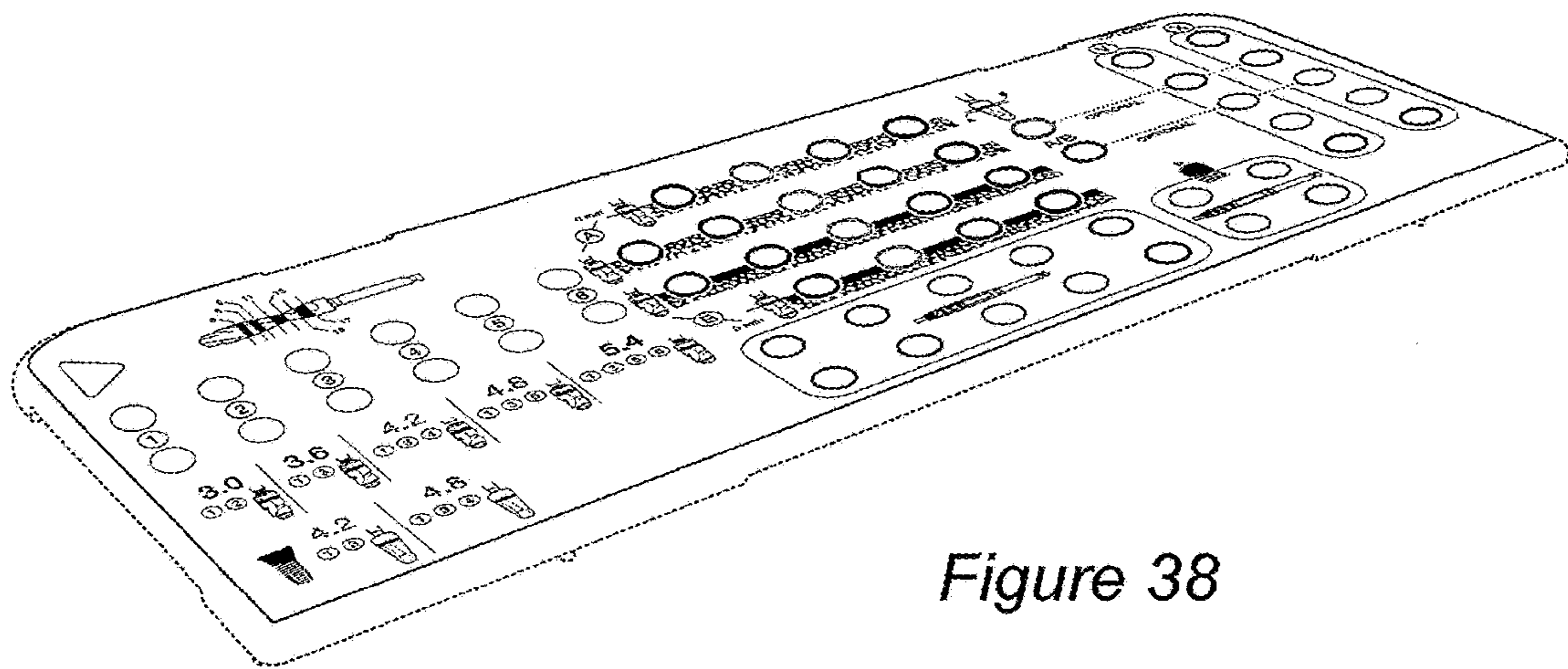

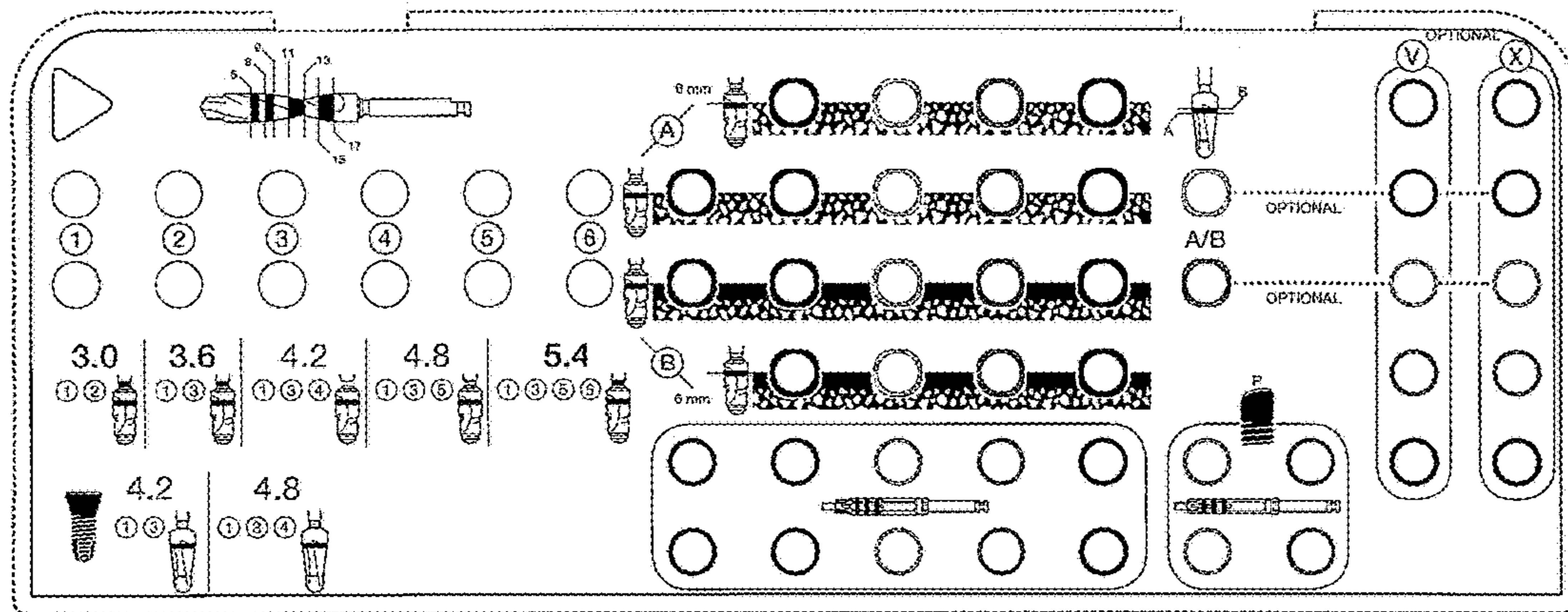

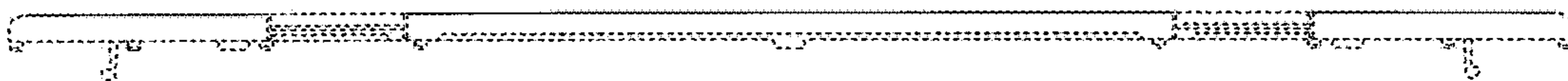

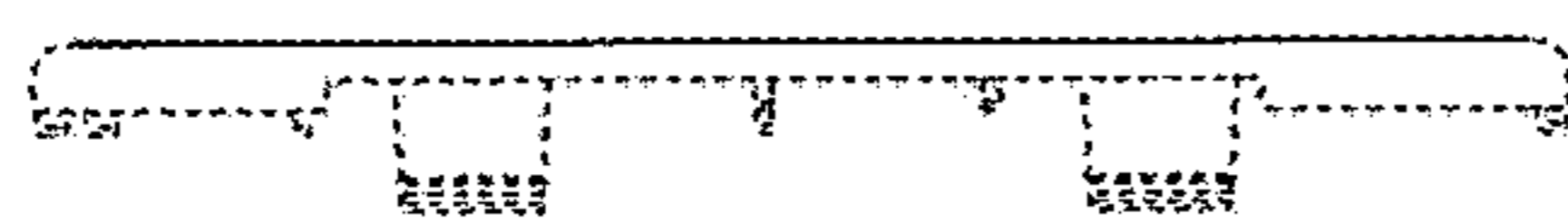

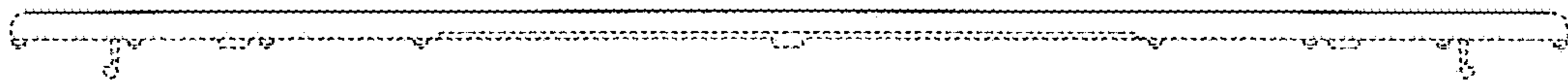

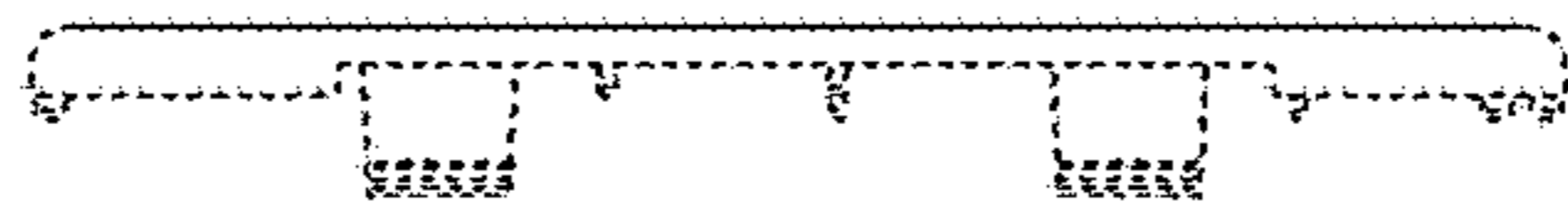

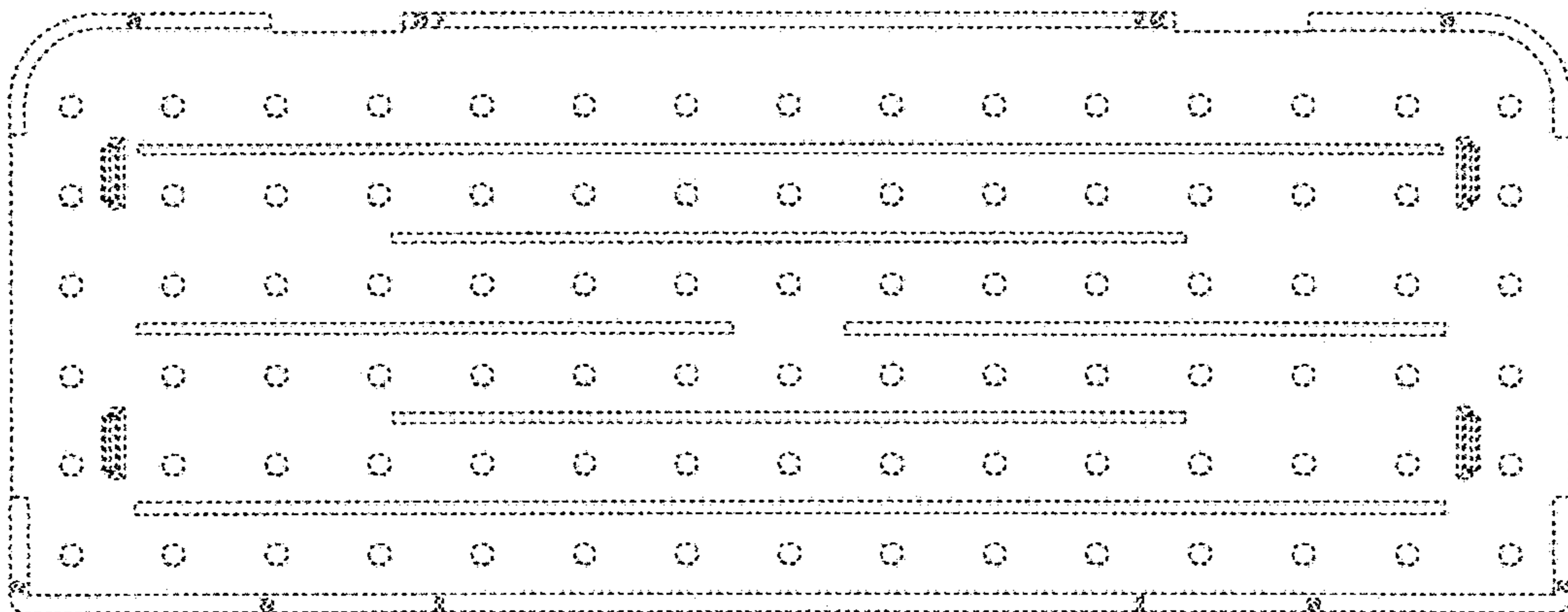

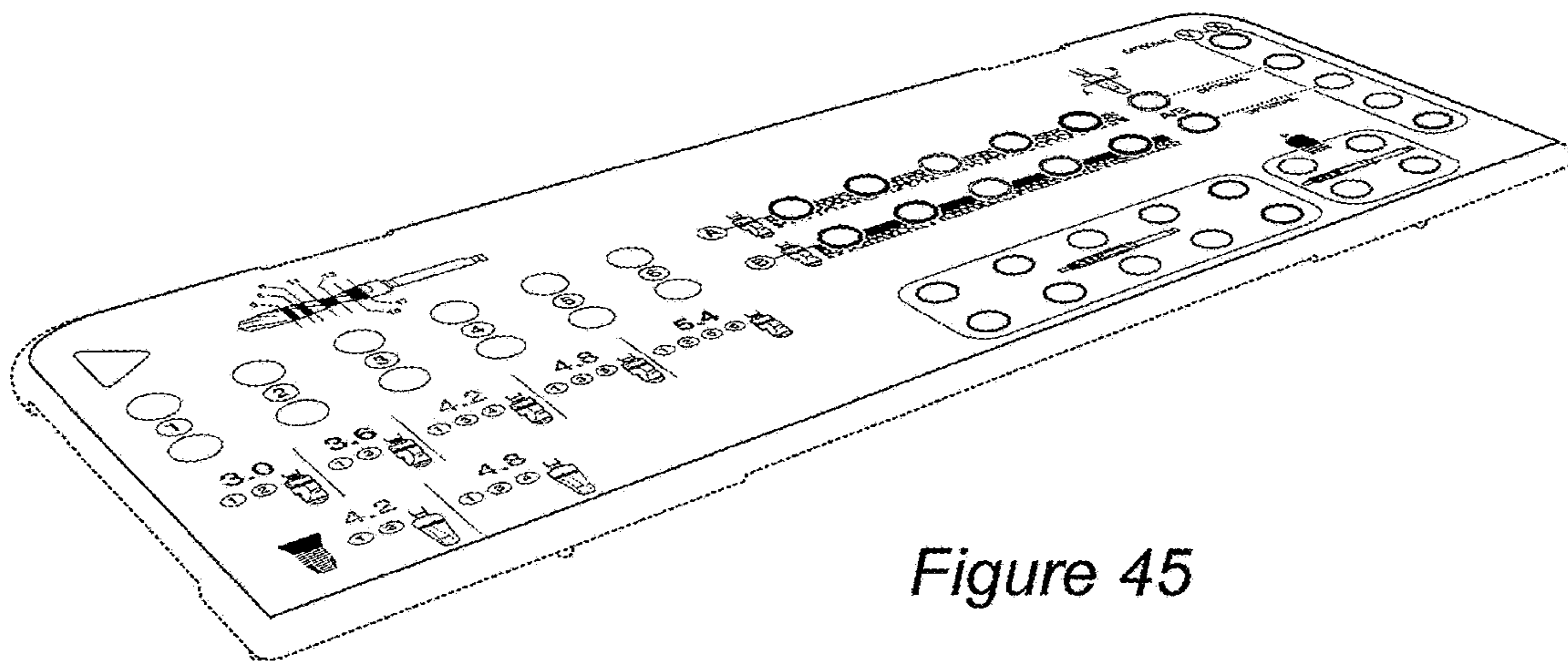

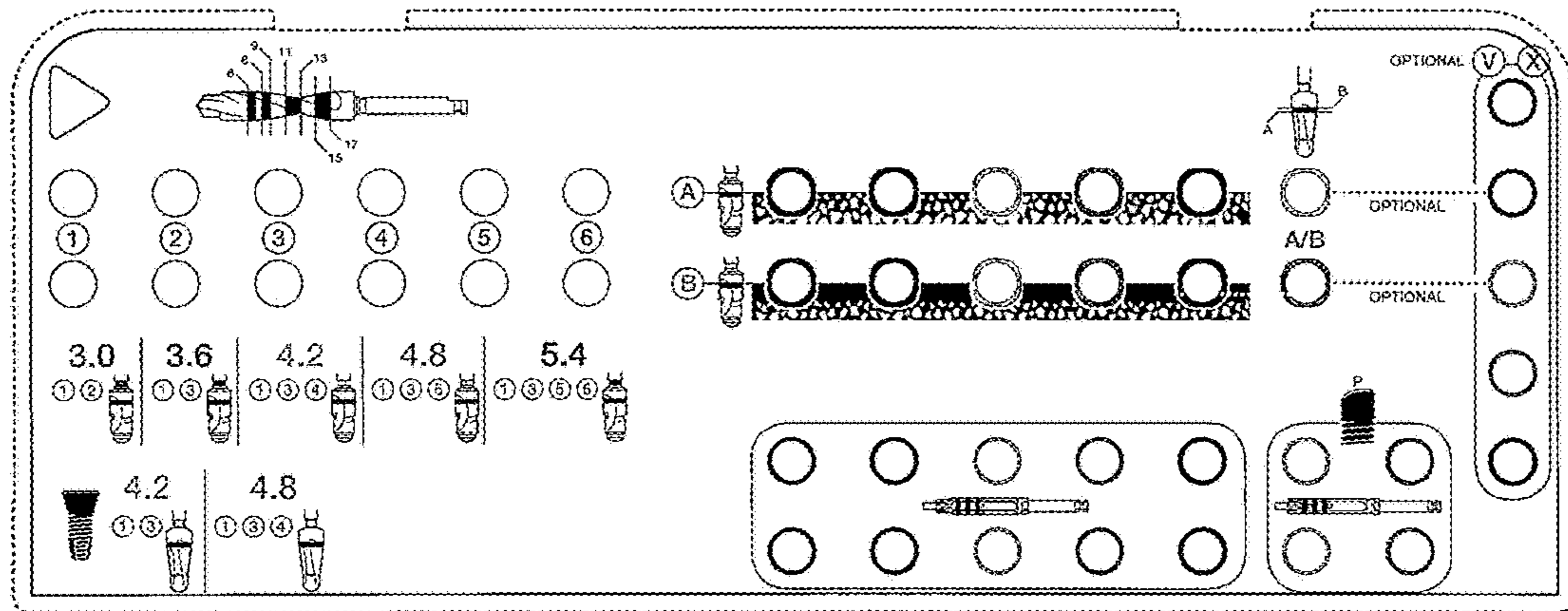

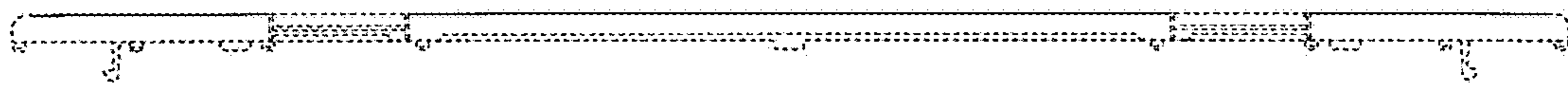

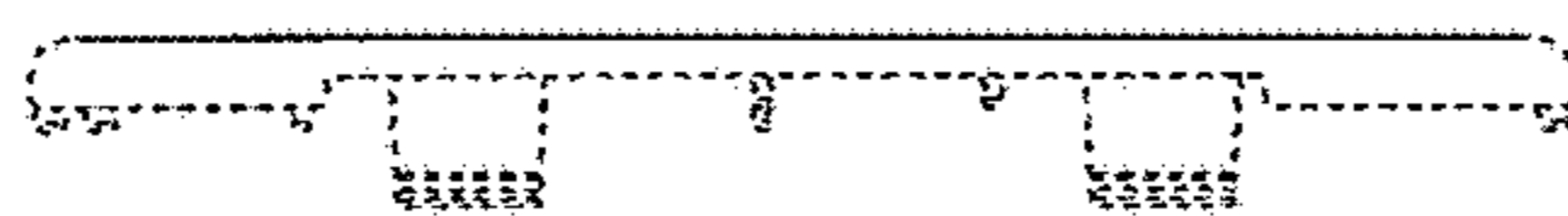

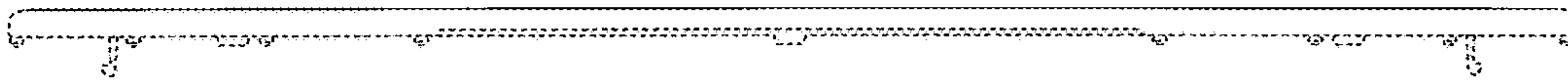

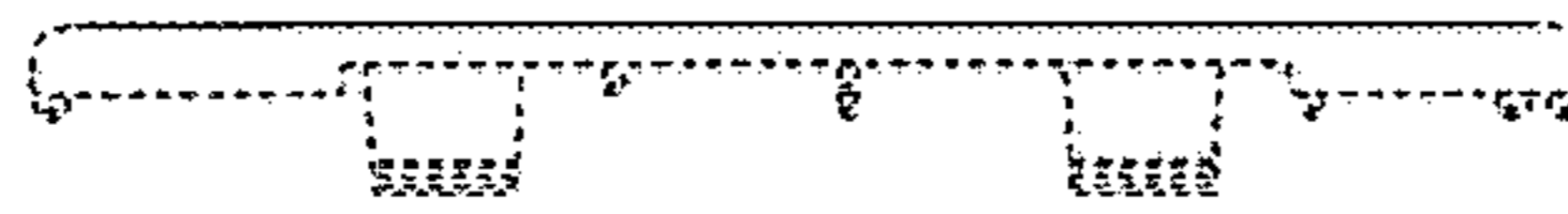

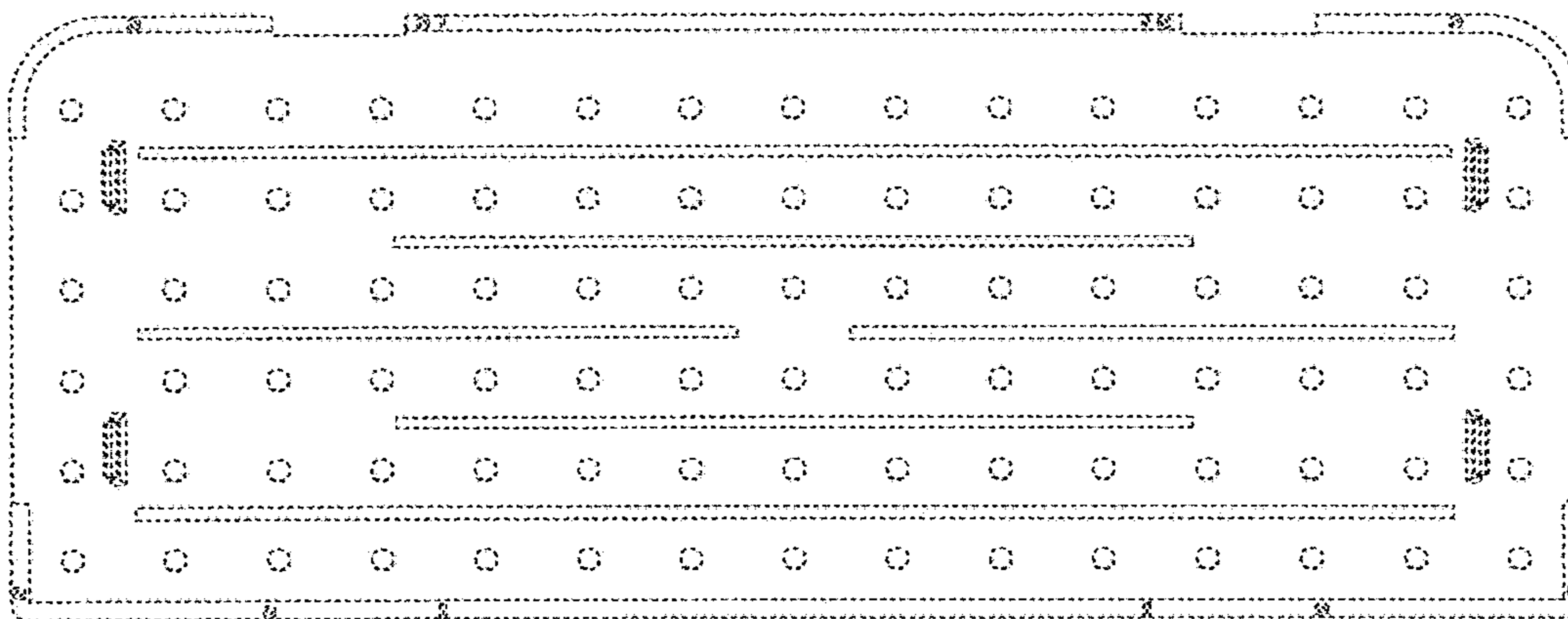

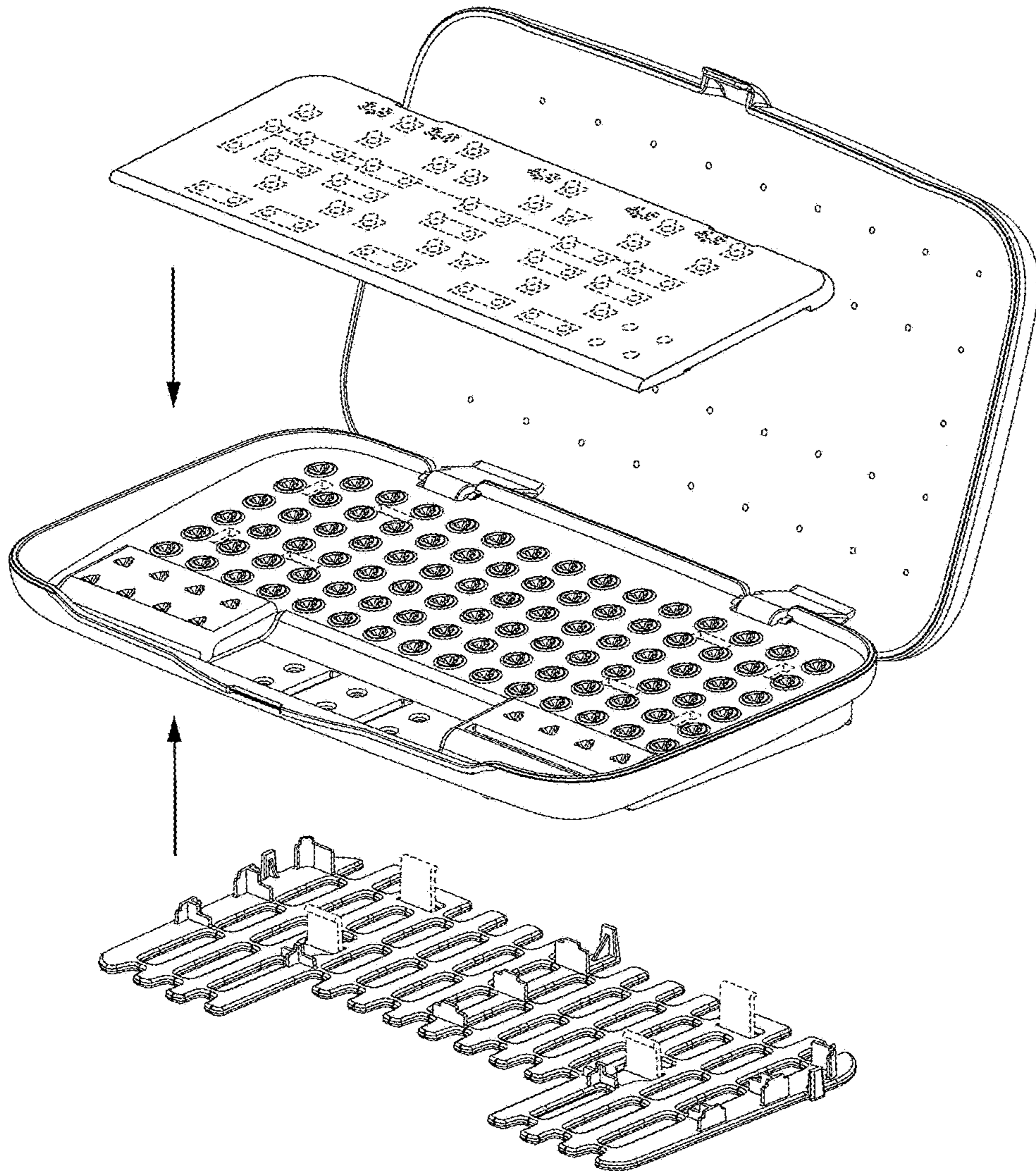
