(57) **CLAIM**

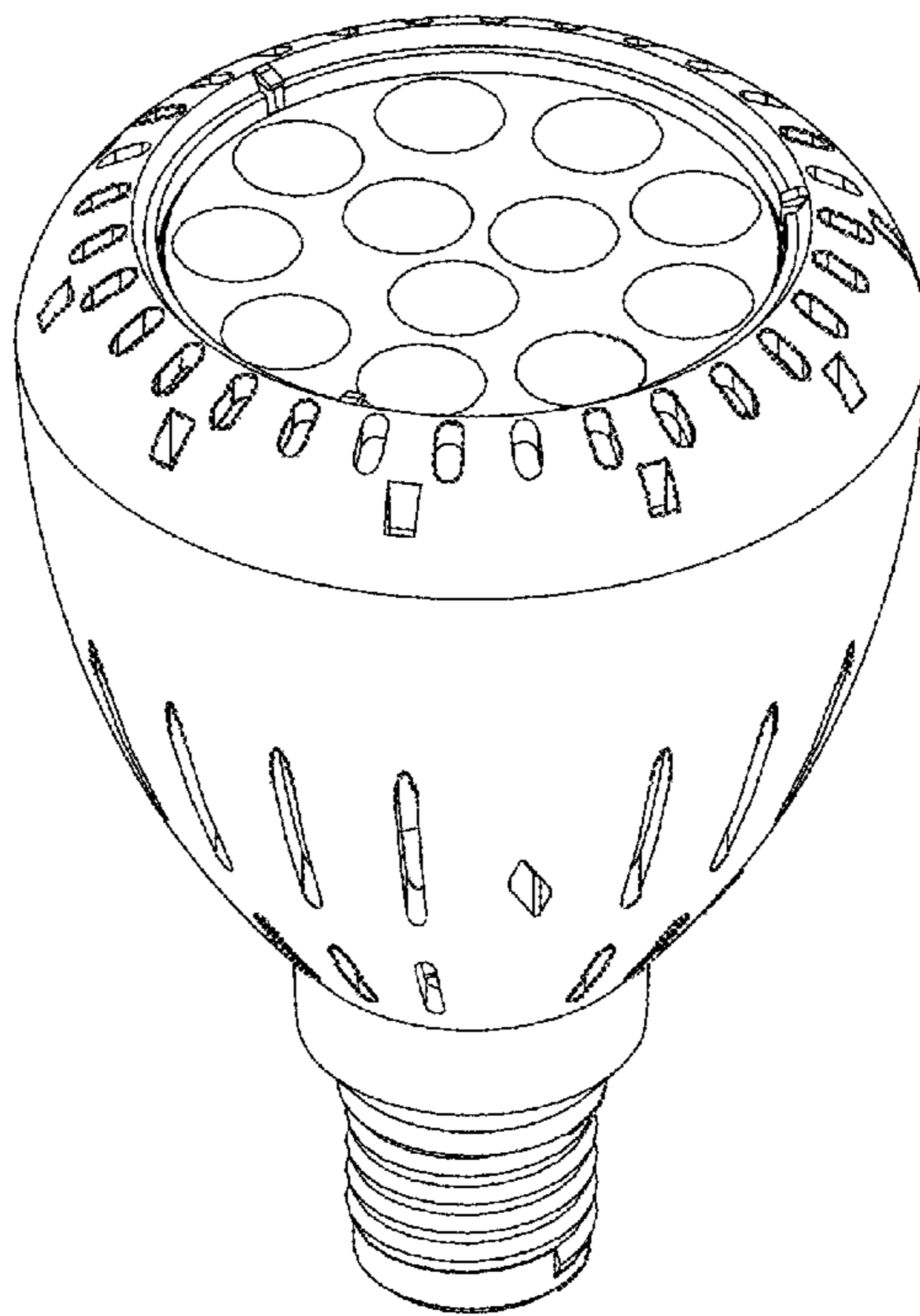
We claim a unique ornamental design for the external design for a light bulb, as shown and described.

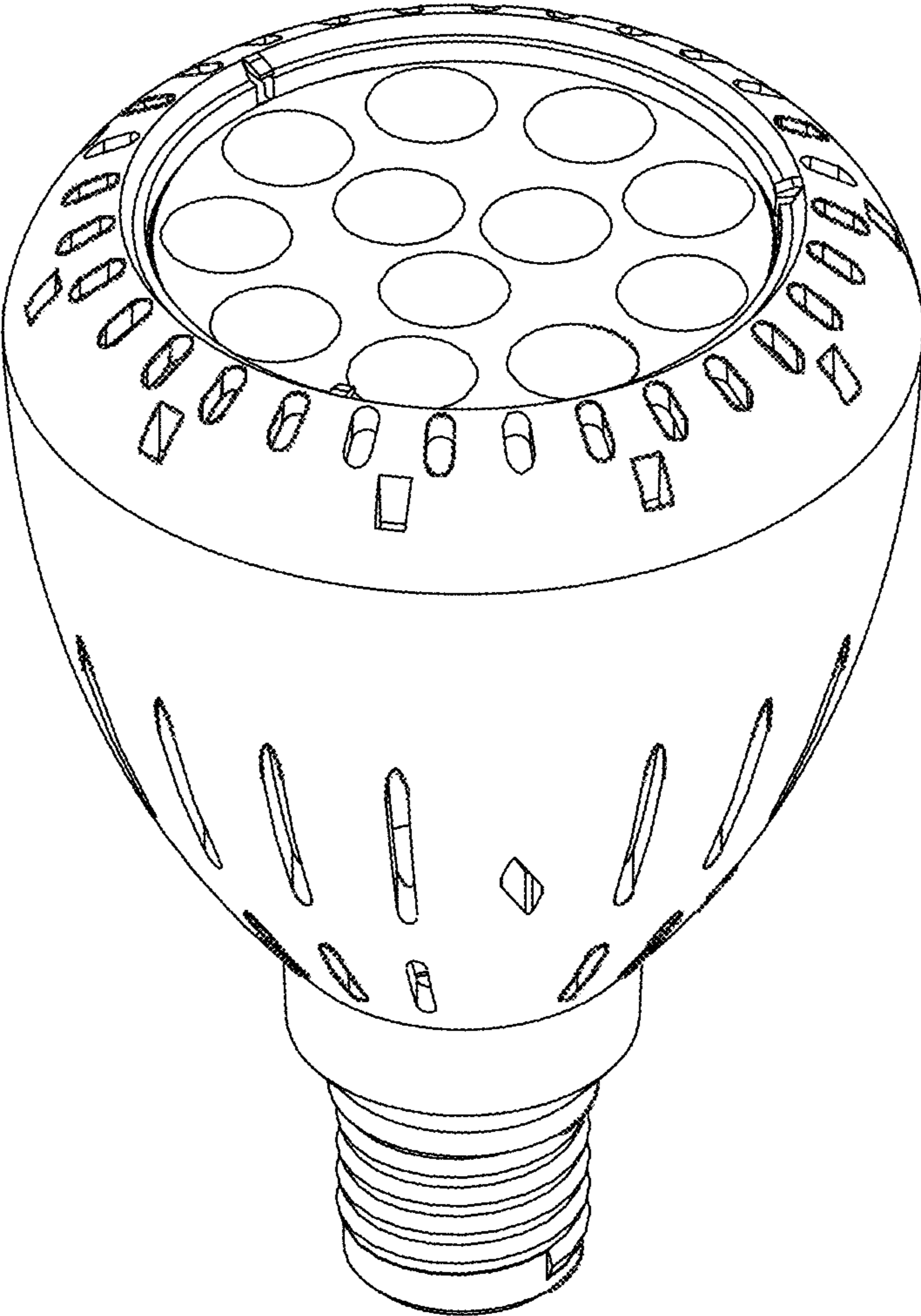

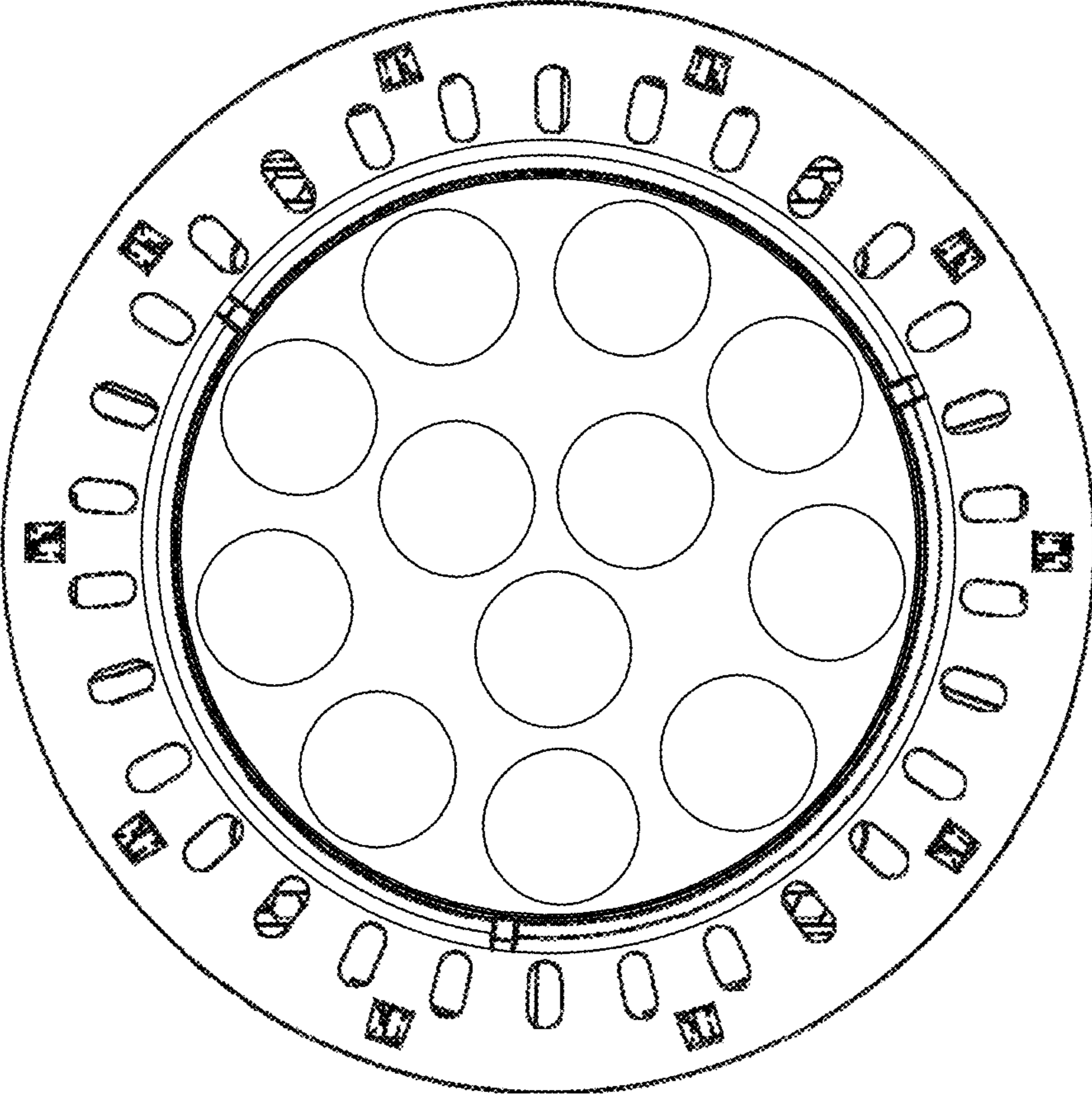

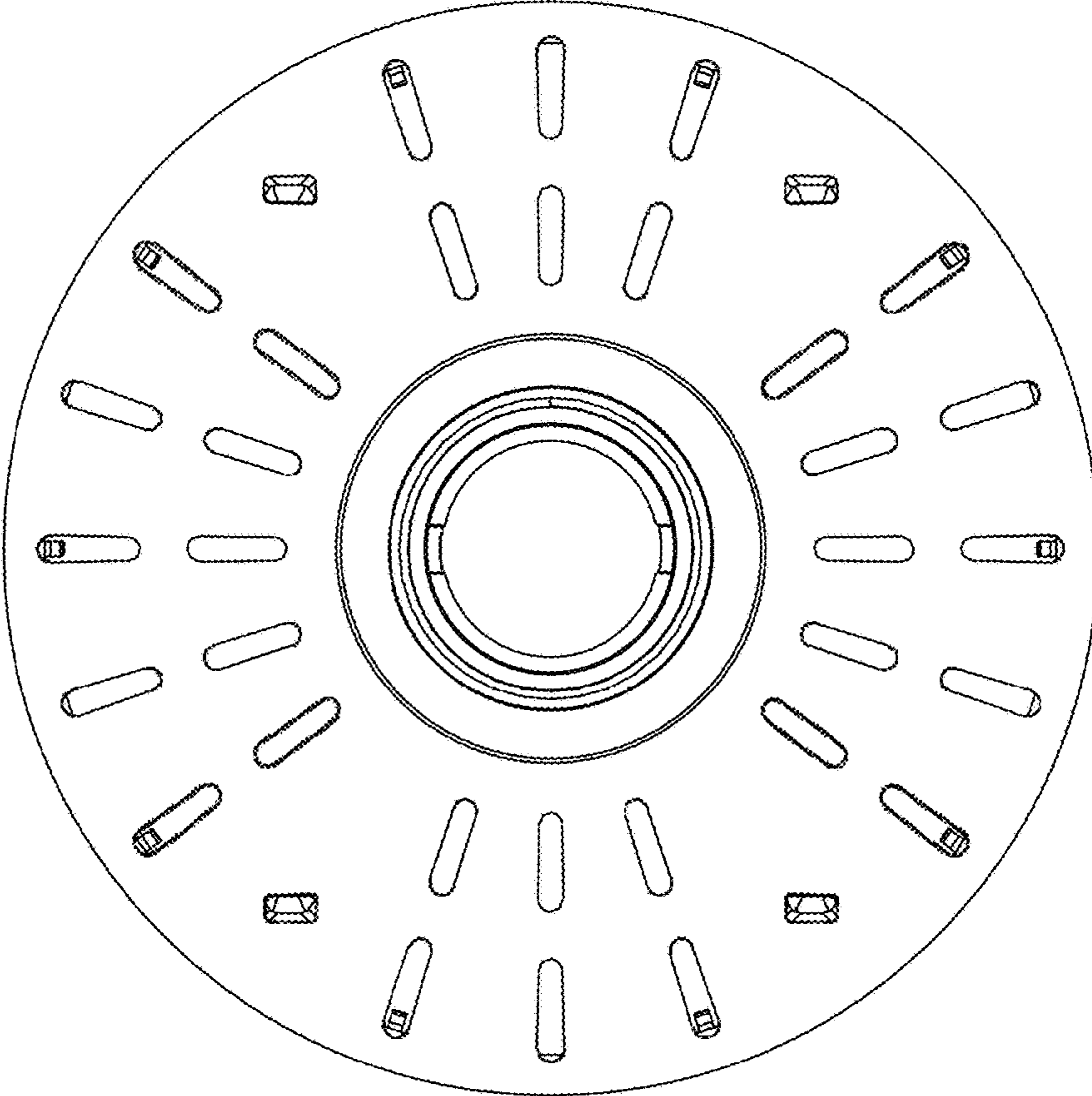

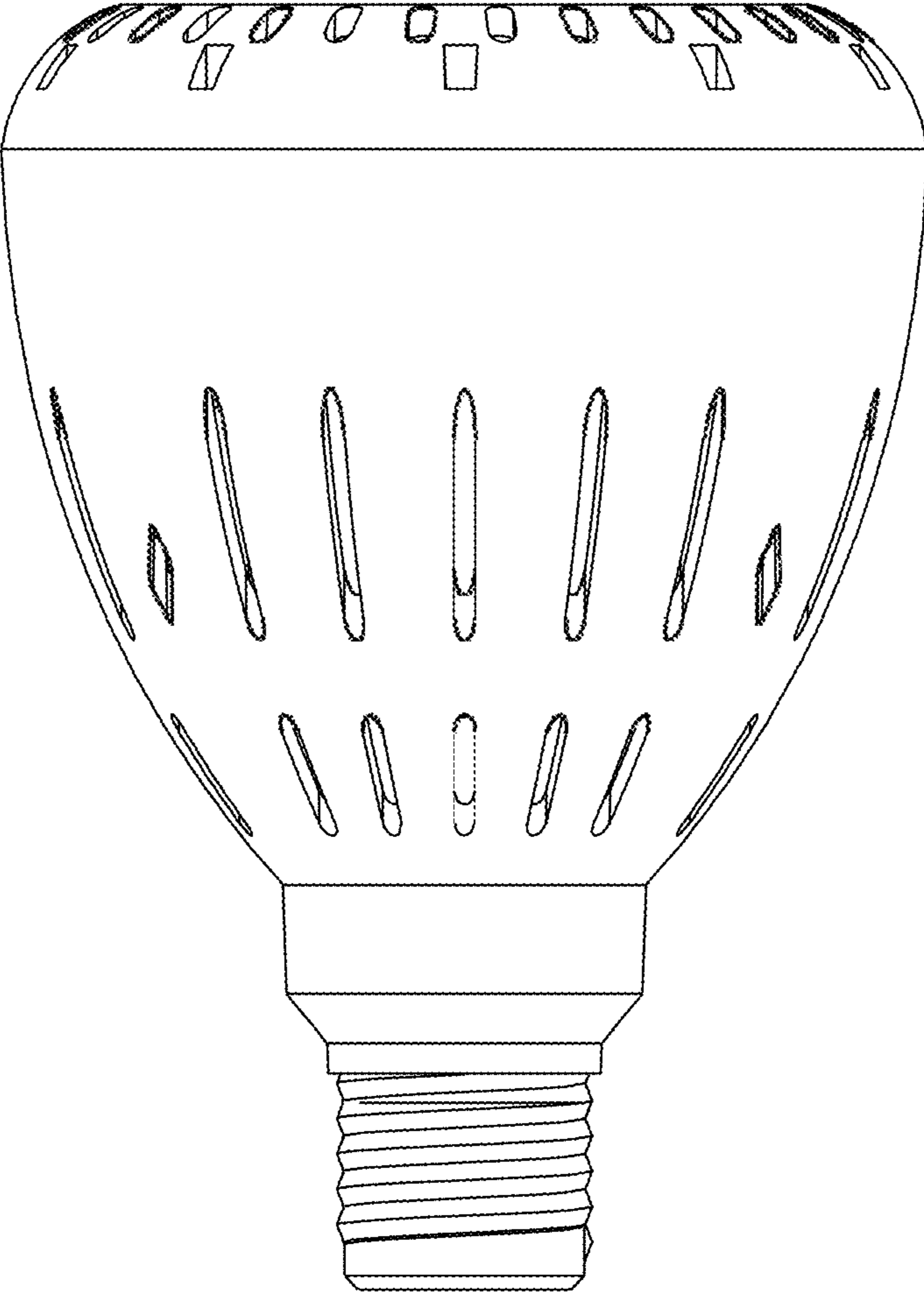
