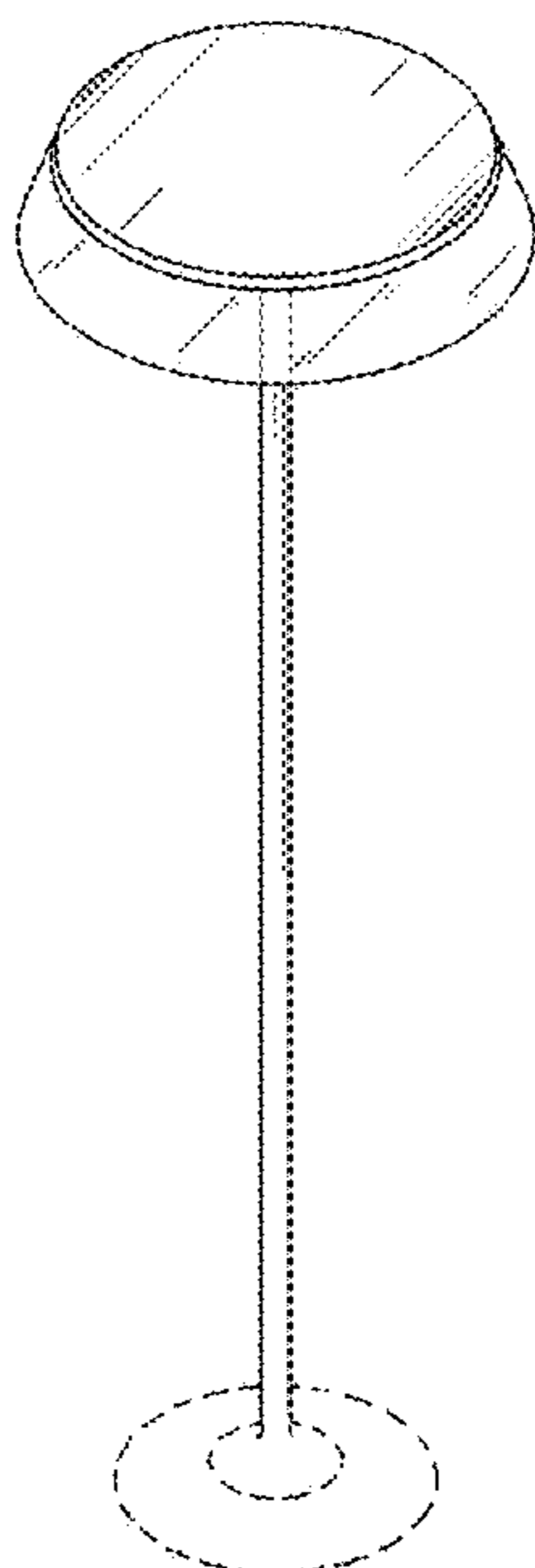

**DESCRIPTION**

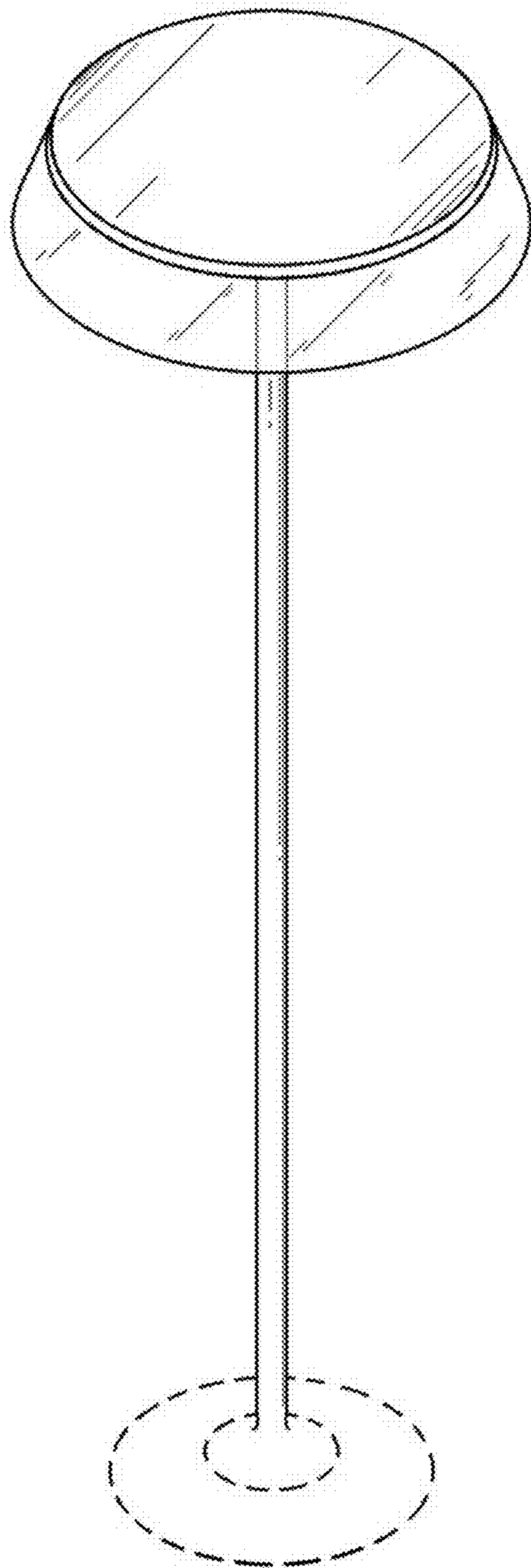
1. Floor lamp

The model regards a floor lamp with a base, a supporting rod vertically protruding from the base, a large lighting cap and a transparent shade supported by the cap.

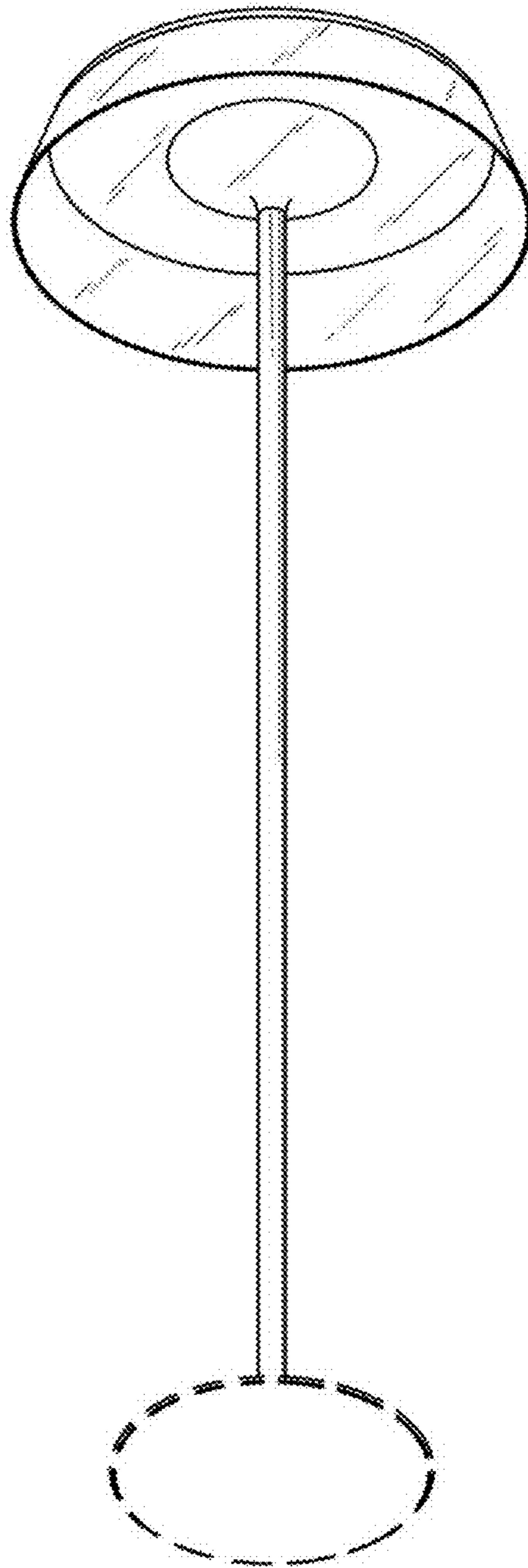

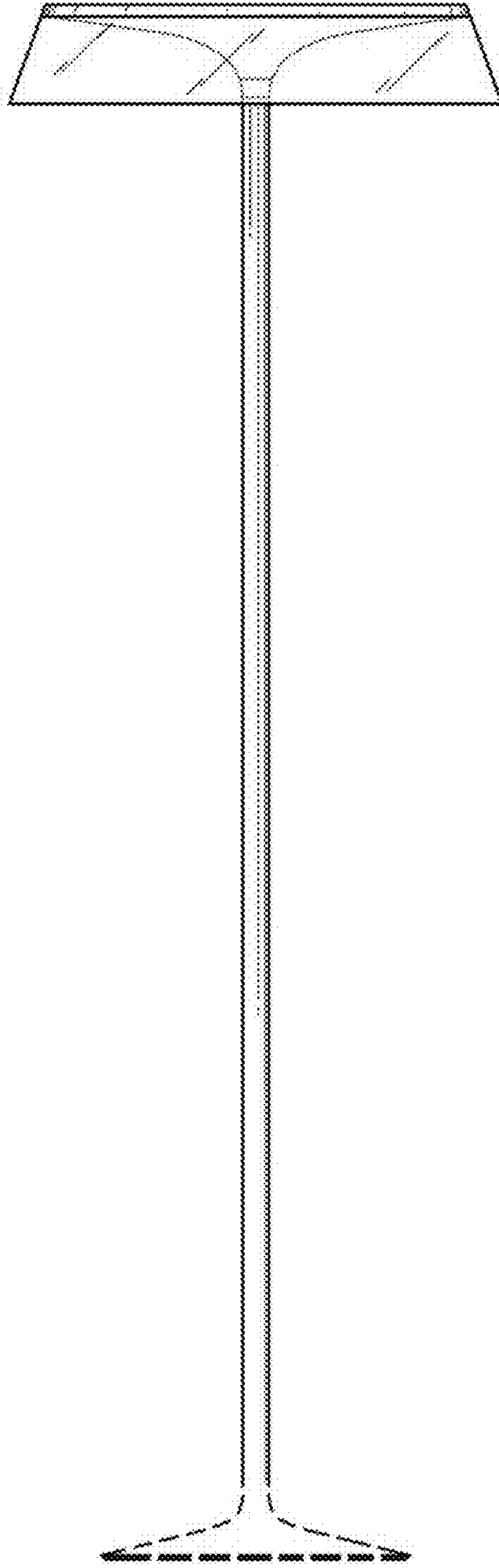

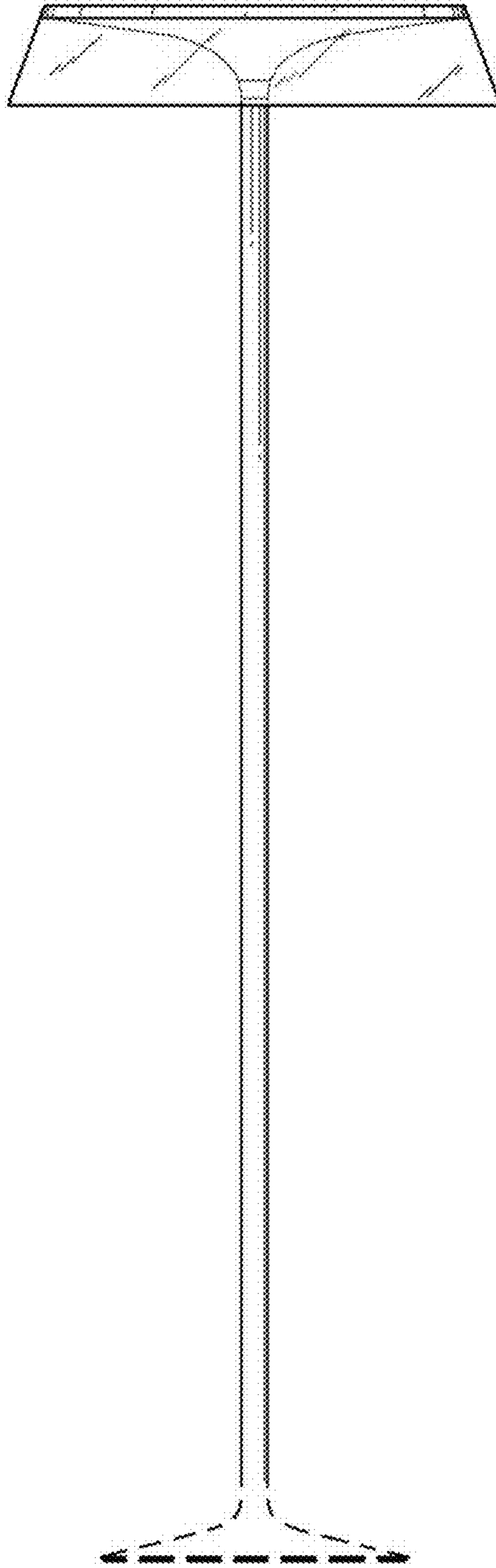

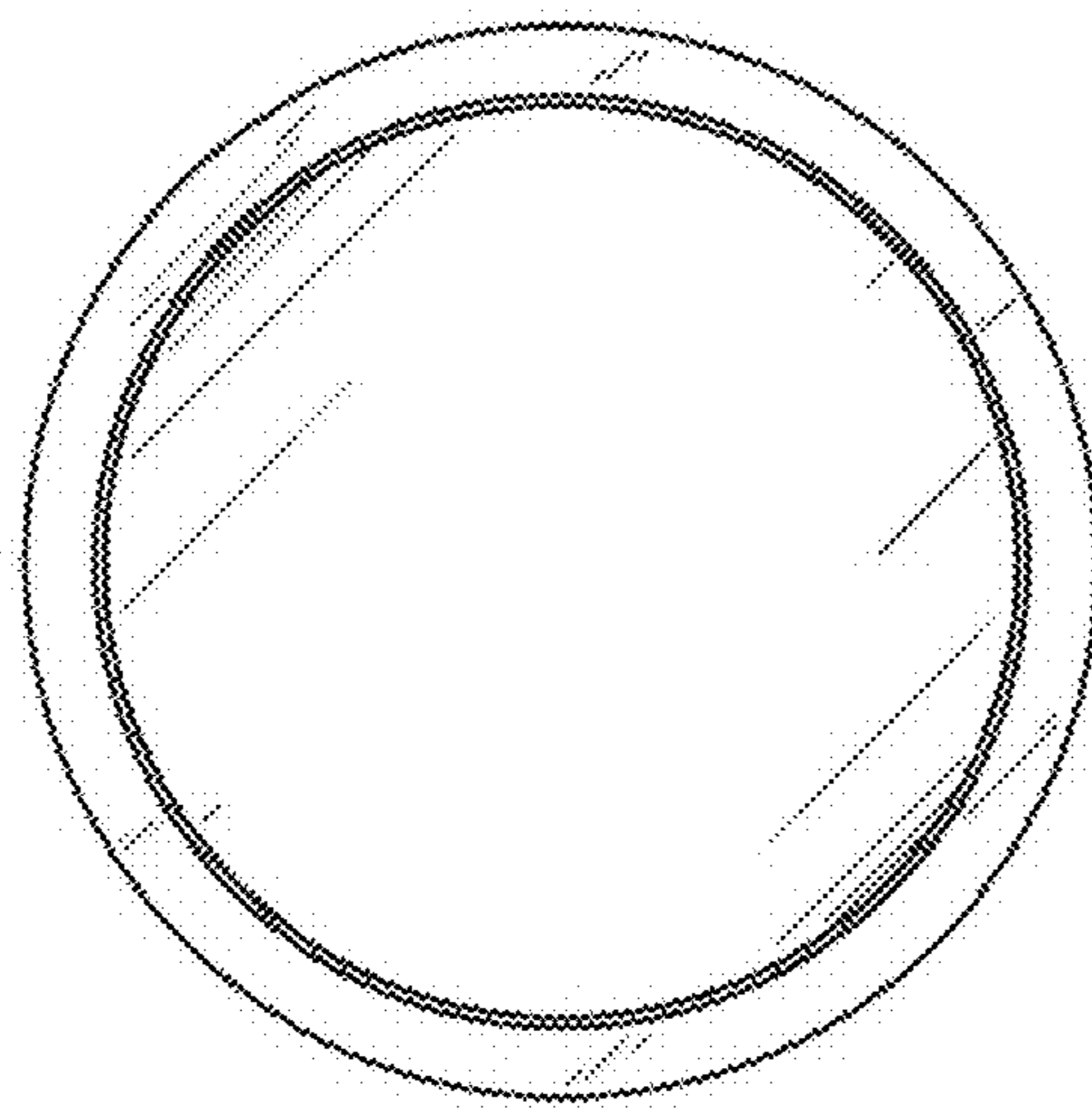

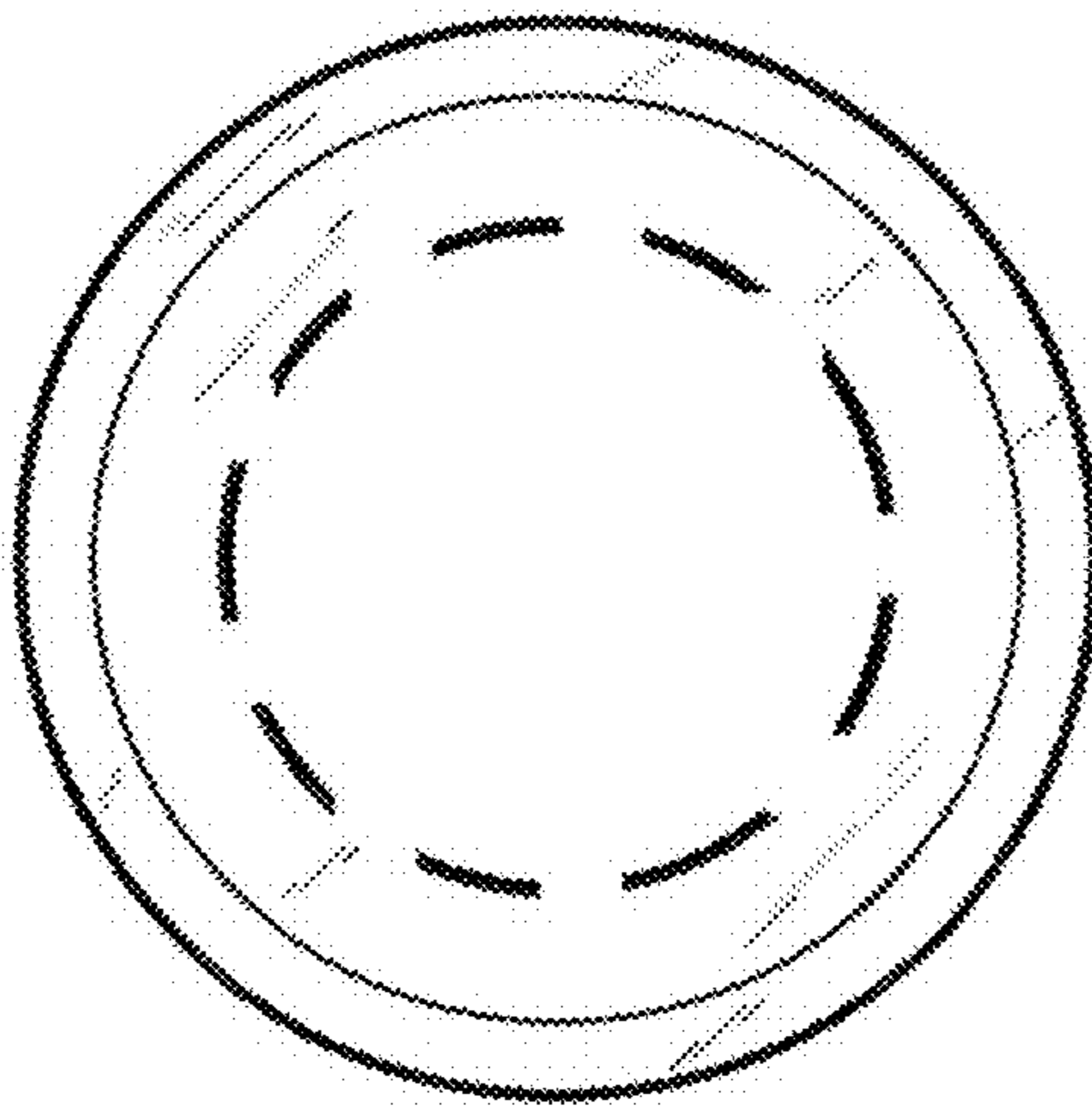
