1.2 : Top

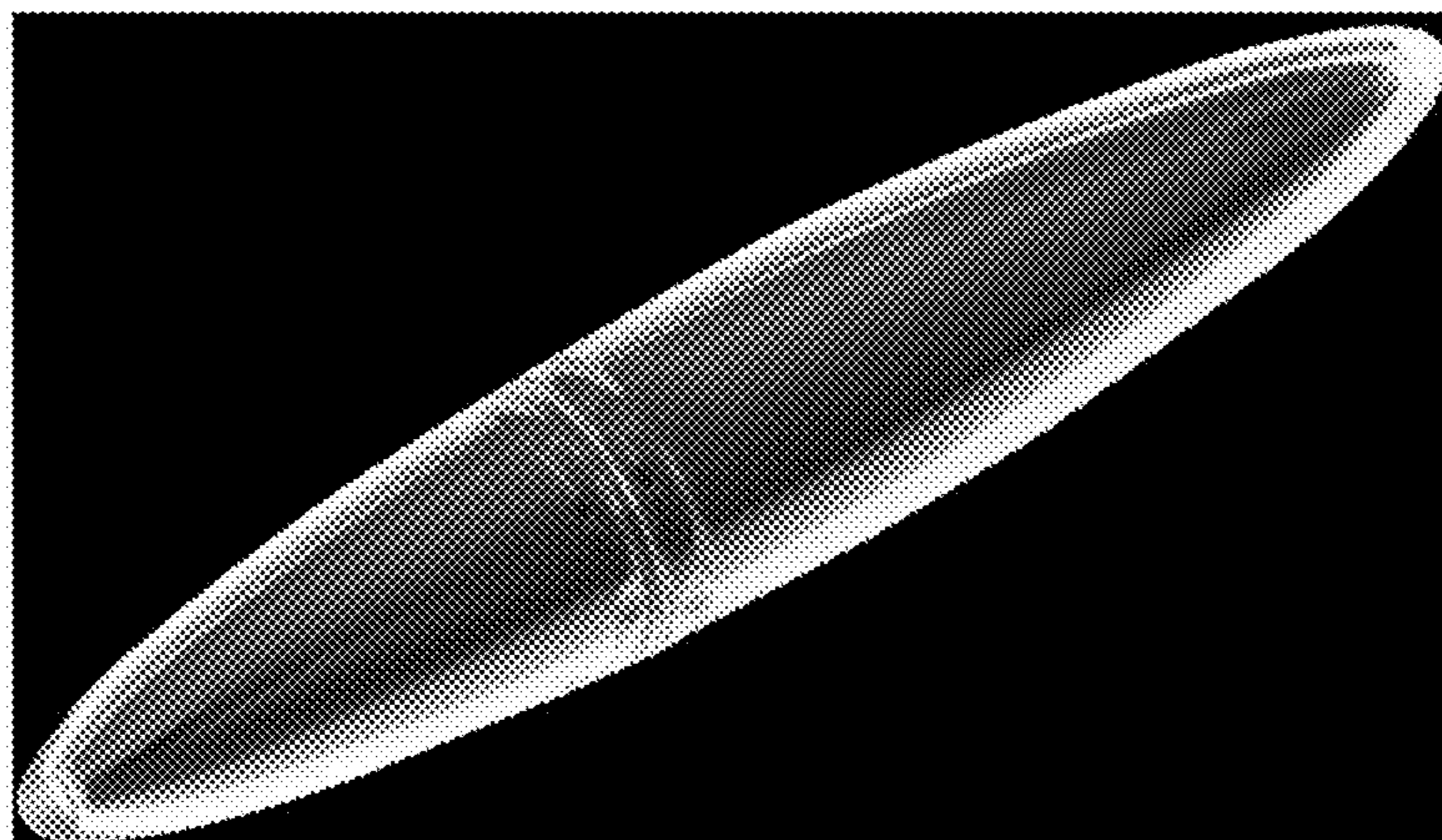
1.3 : Right

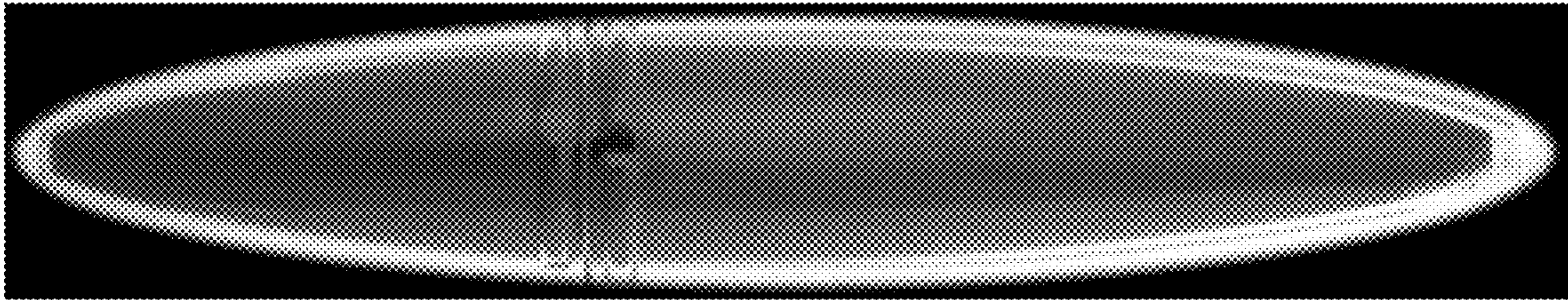

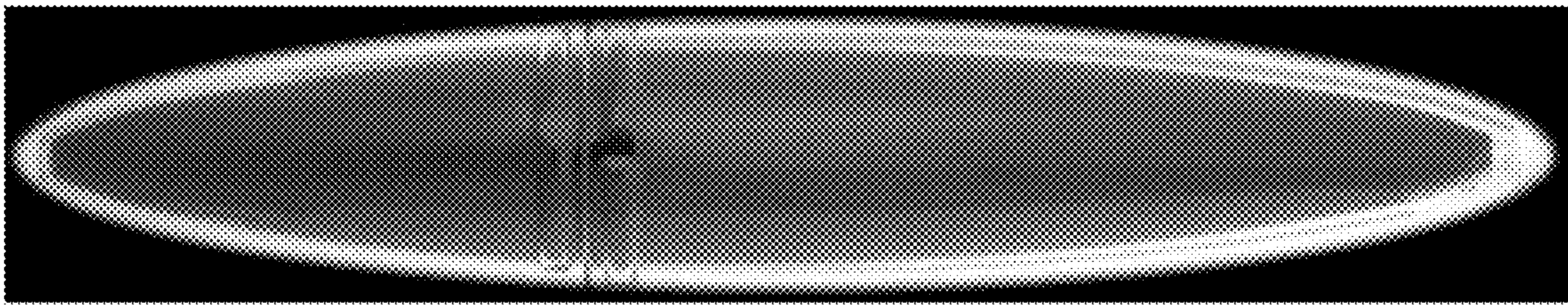

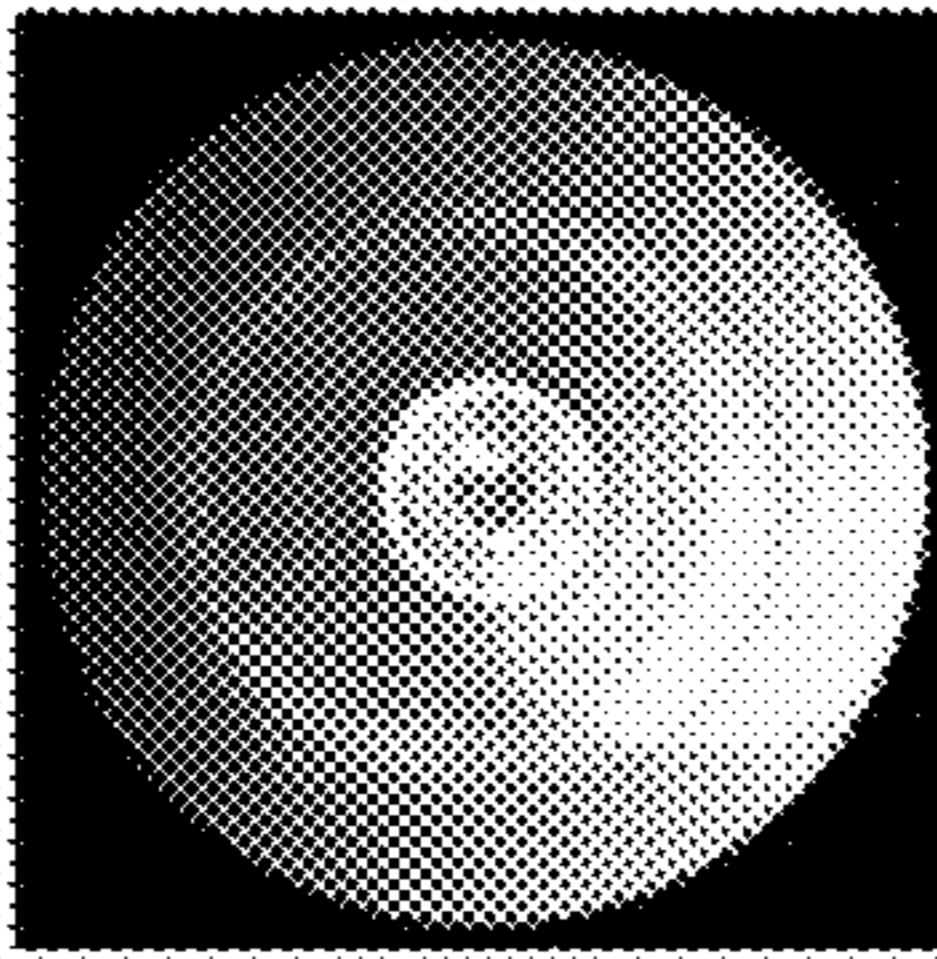

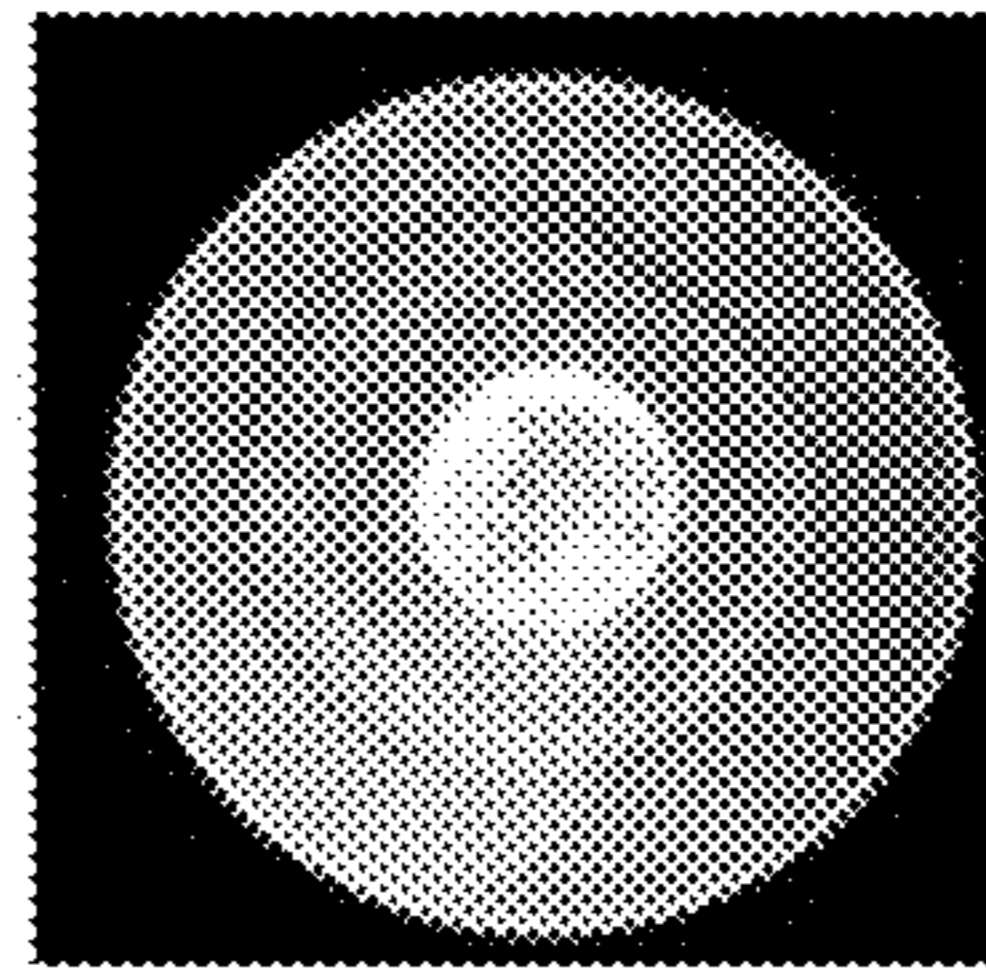
