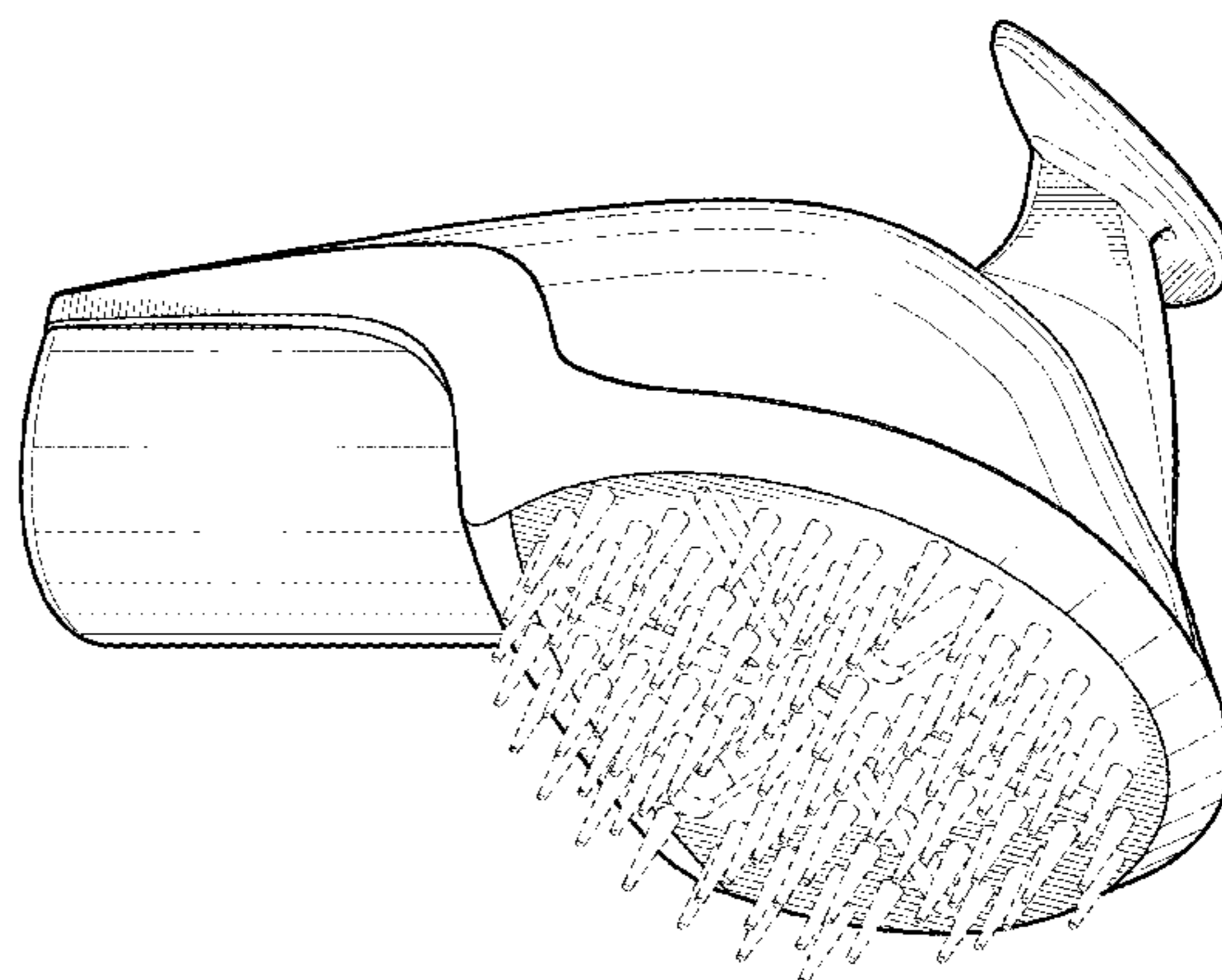
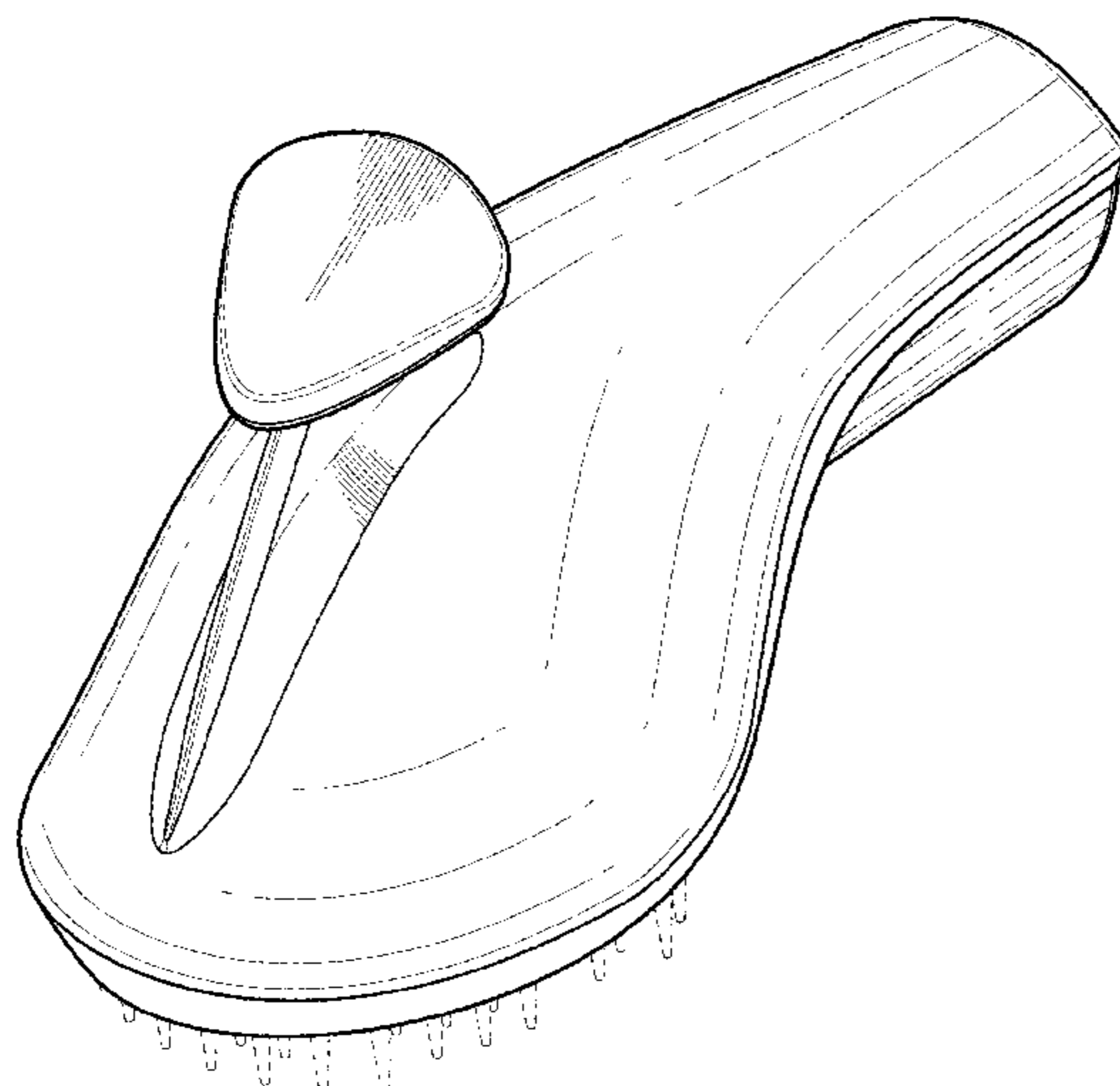
(57) **CLAIM**

The ornamental design for a pet grooming device, as shown and described.

DESCRIPTION

FIG. 1 is a top, front perspective view of a pet grooming device showing our new design;
FIG. 2 is a bottom, front perspective view thereof;
FIG. 3 is a right side elevational view thereof;
FIG. 4 is a left side elevational view thereof;
FIG. 5 is a top plan view thereof;
FIG. 6 is a bottom plan view thereof;
FIG. 7 is a front elevational view thereof; and,
FIG. 8 is a rear elevational view thereof.
The broken line showing of brush bristles, openings on the bottom of the device and an opening at the rear of the device in FIGS. 1-4 and 6-8 depicts portions of the pet grooming device that form no part of the claimed design but that are shown for purposes of illustration.

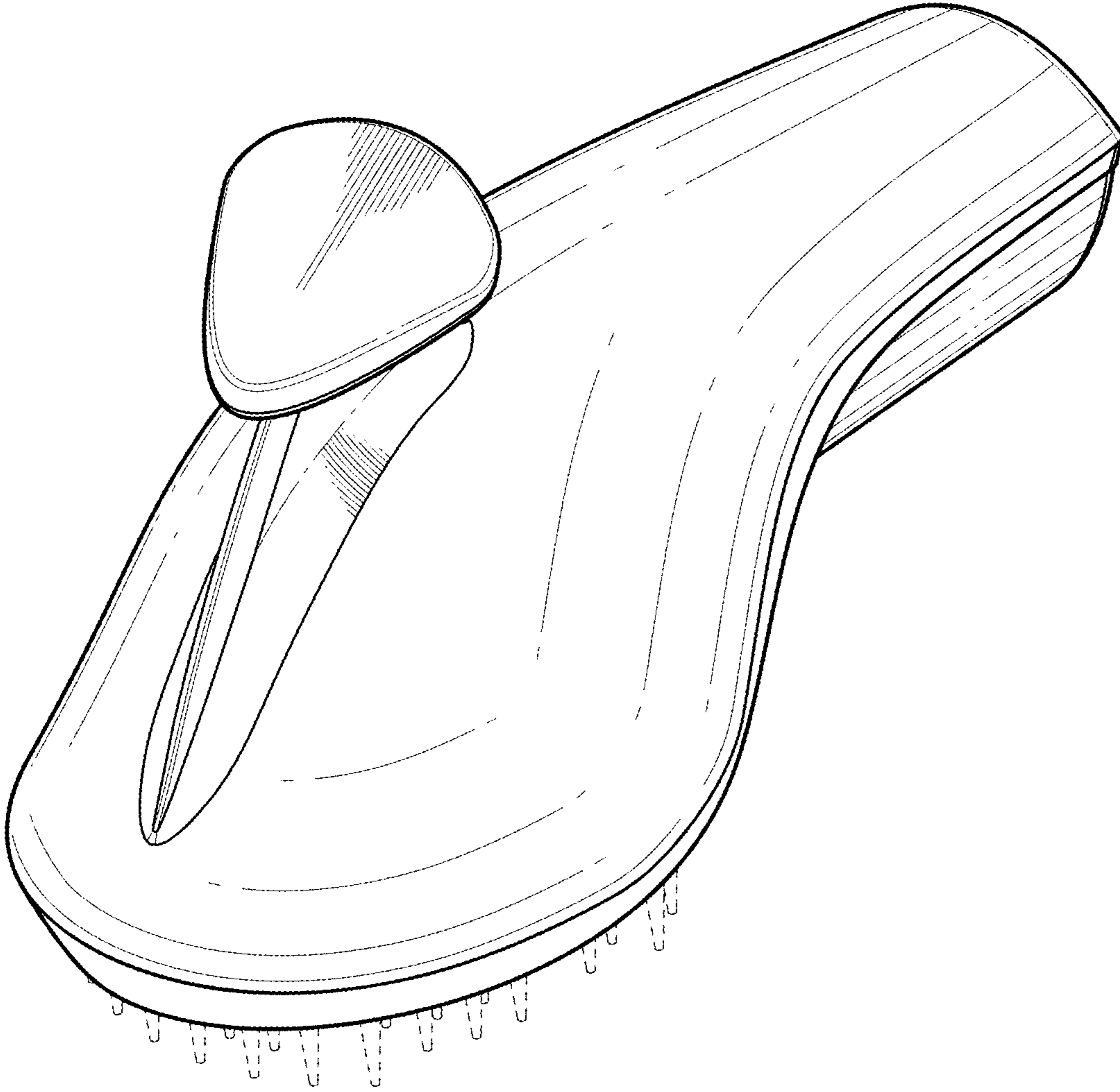

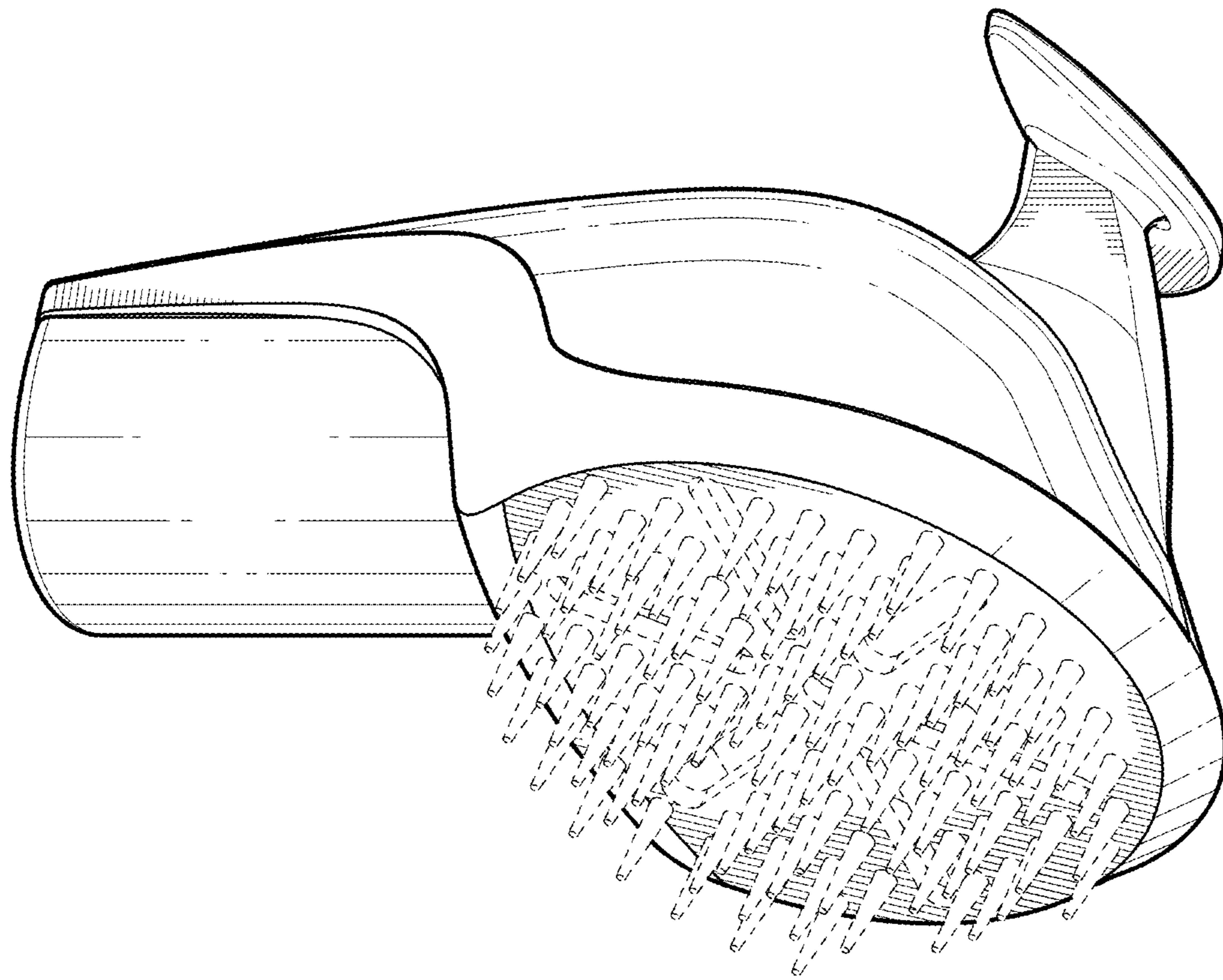

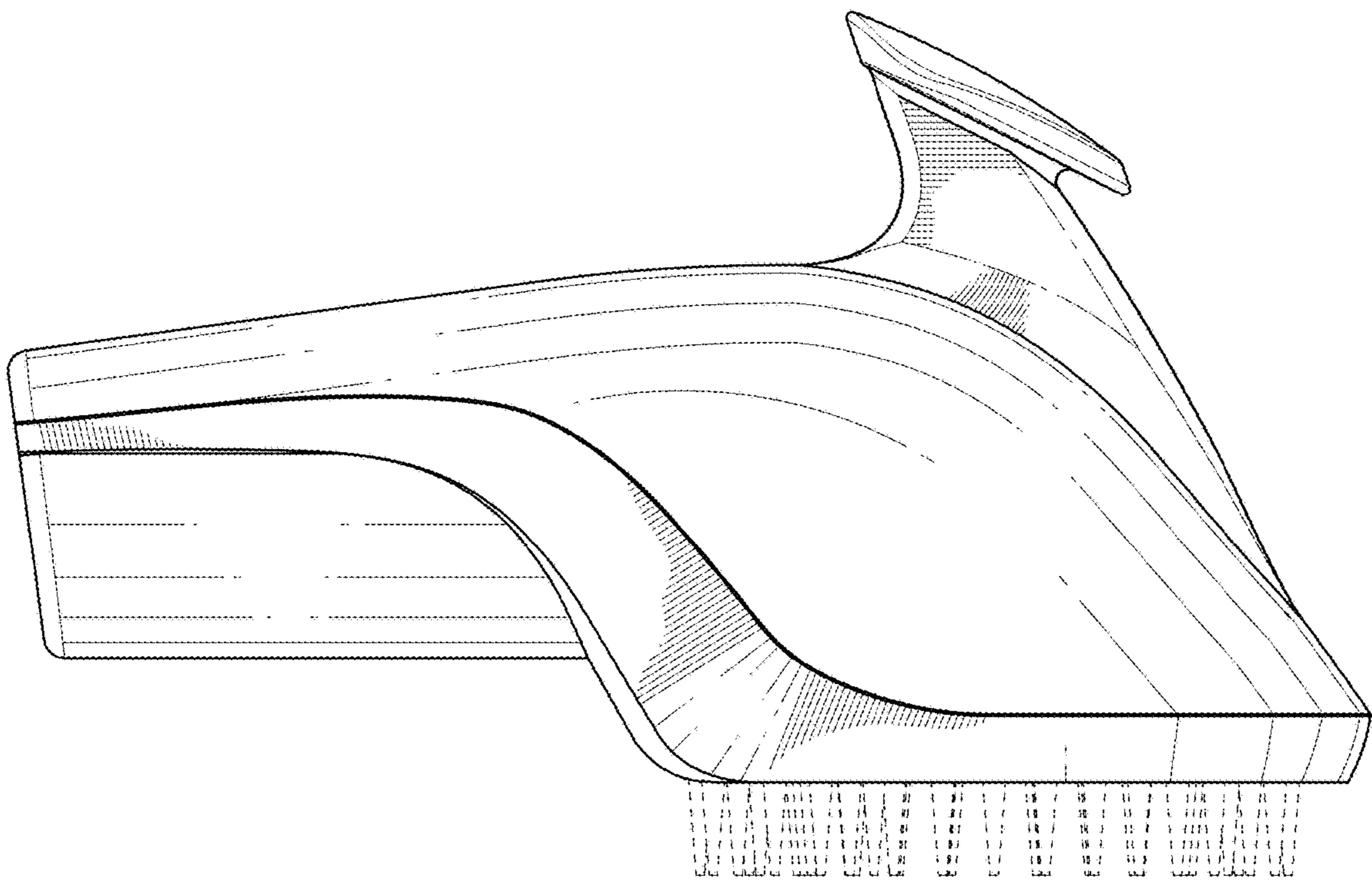

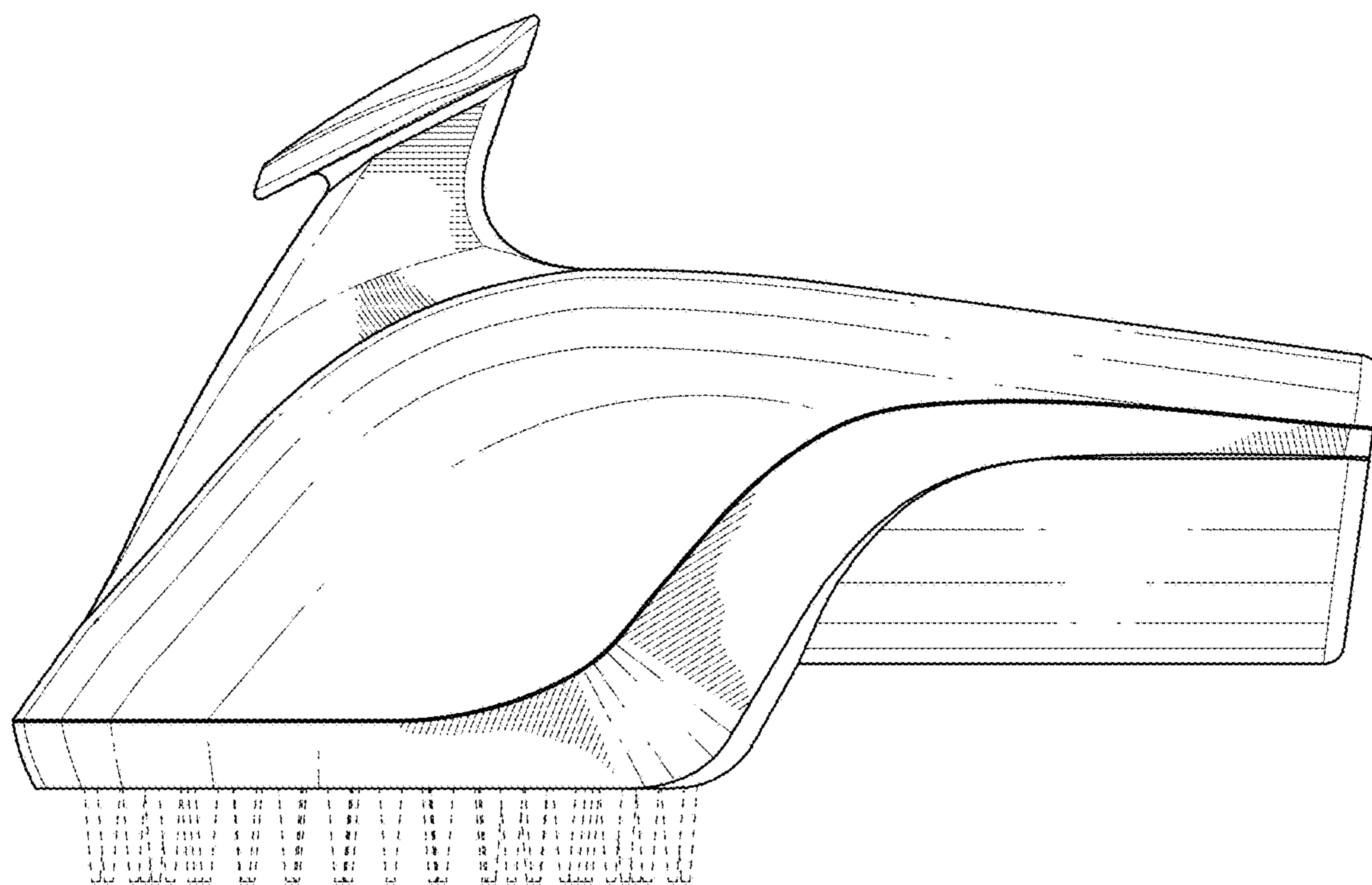

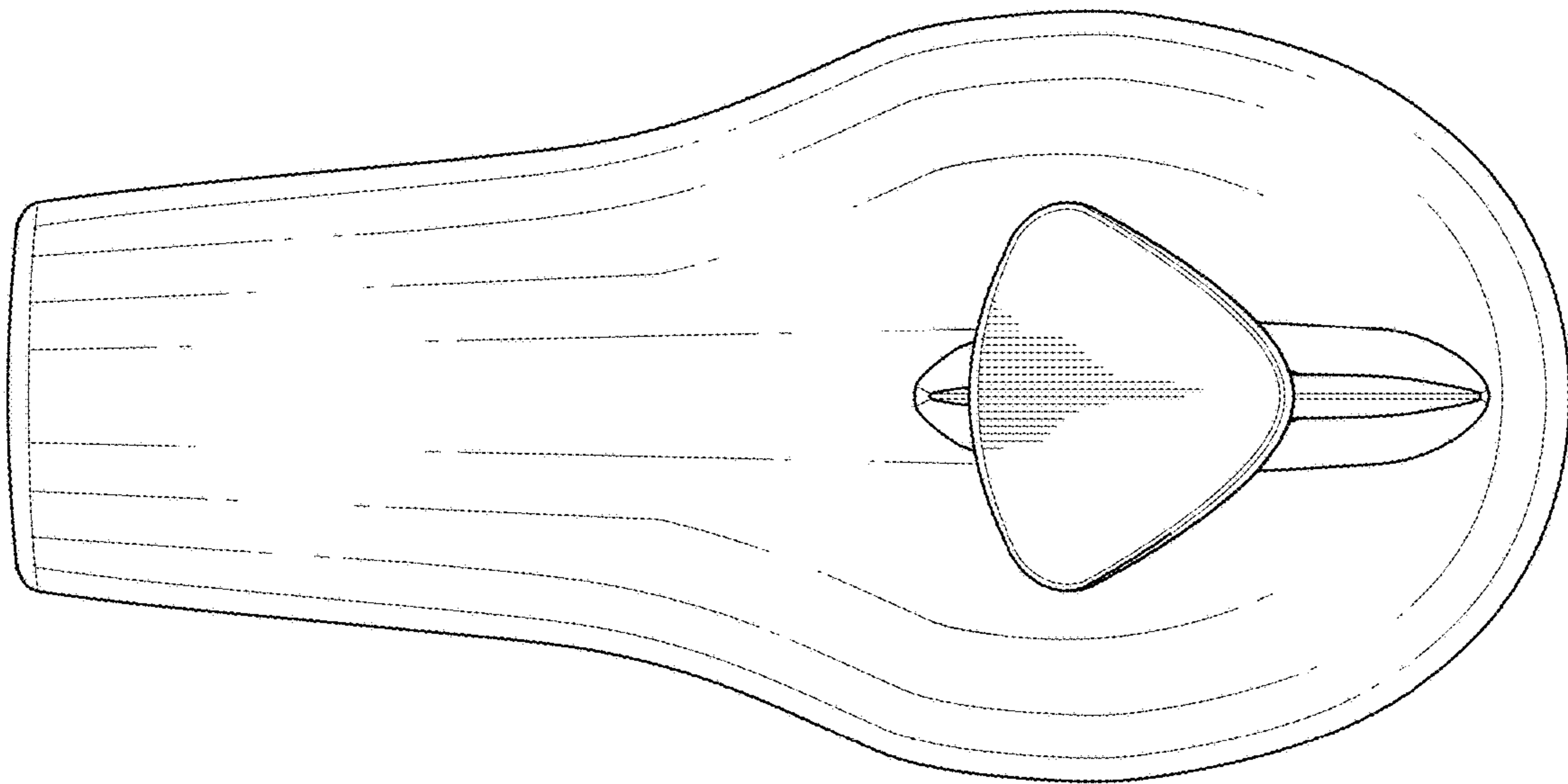

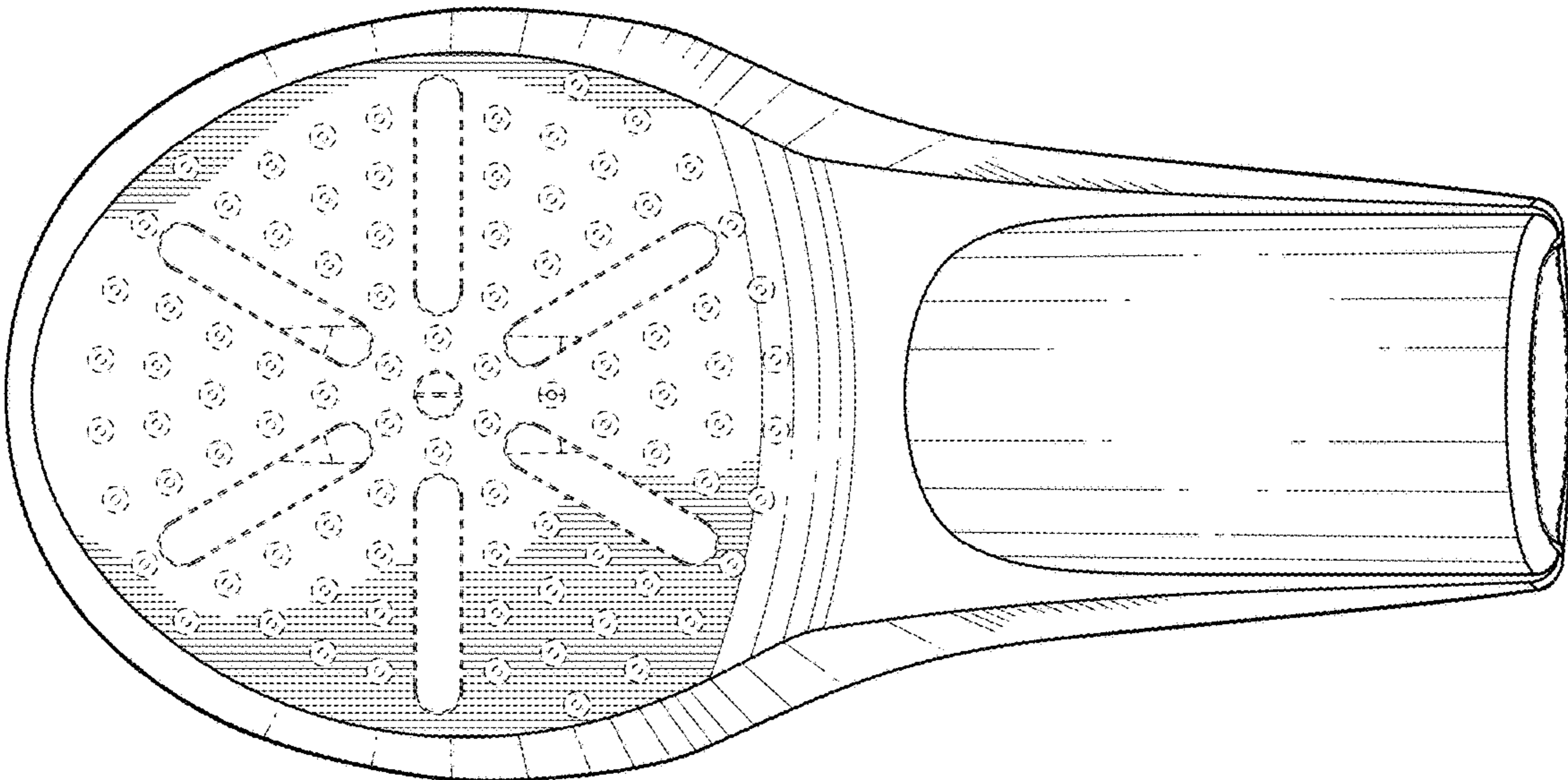

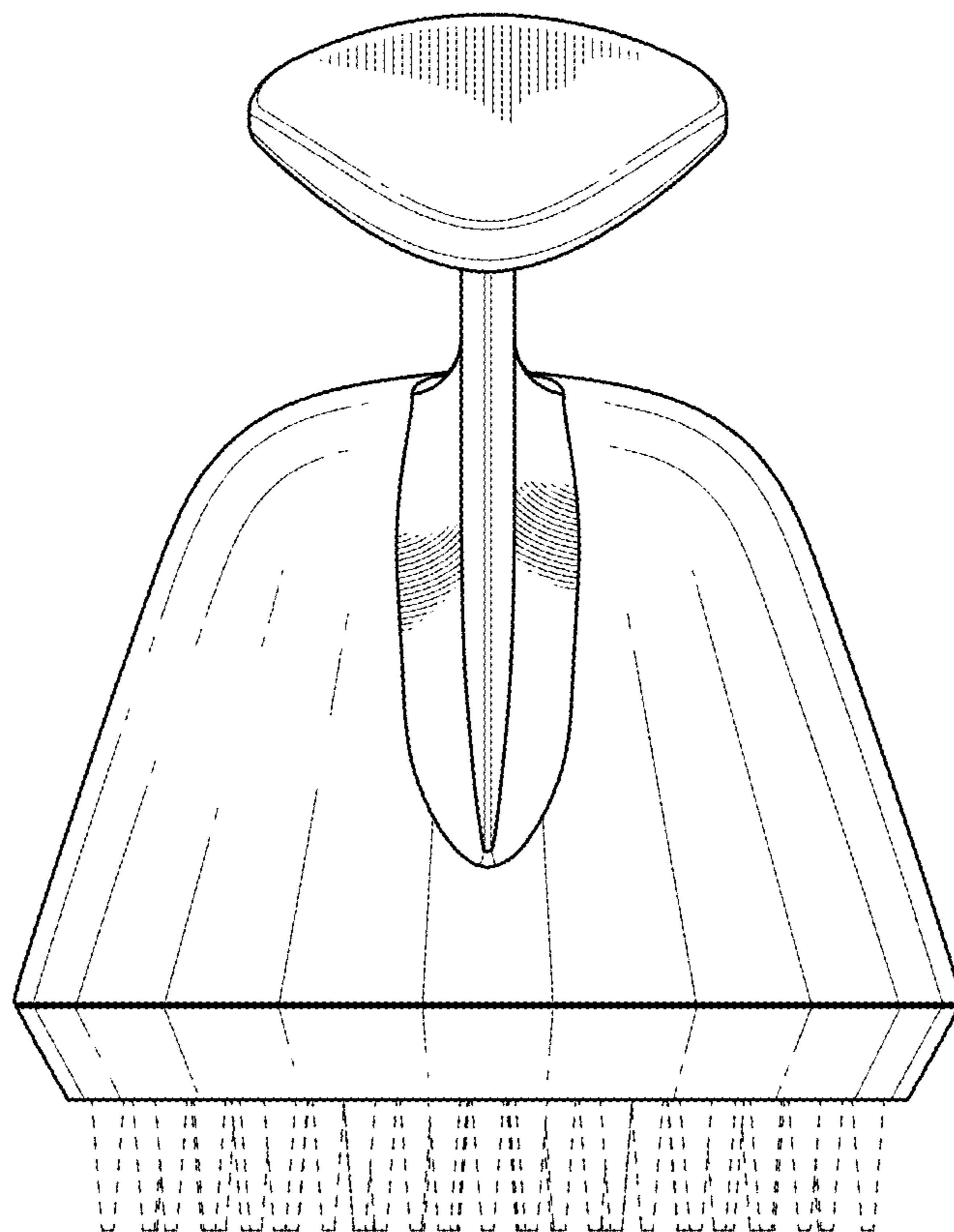

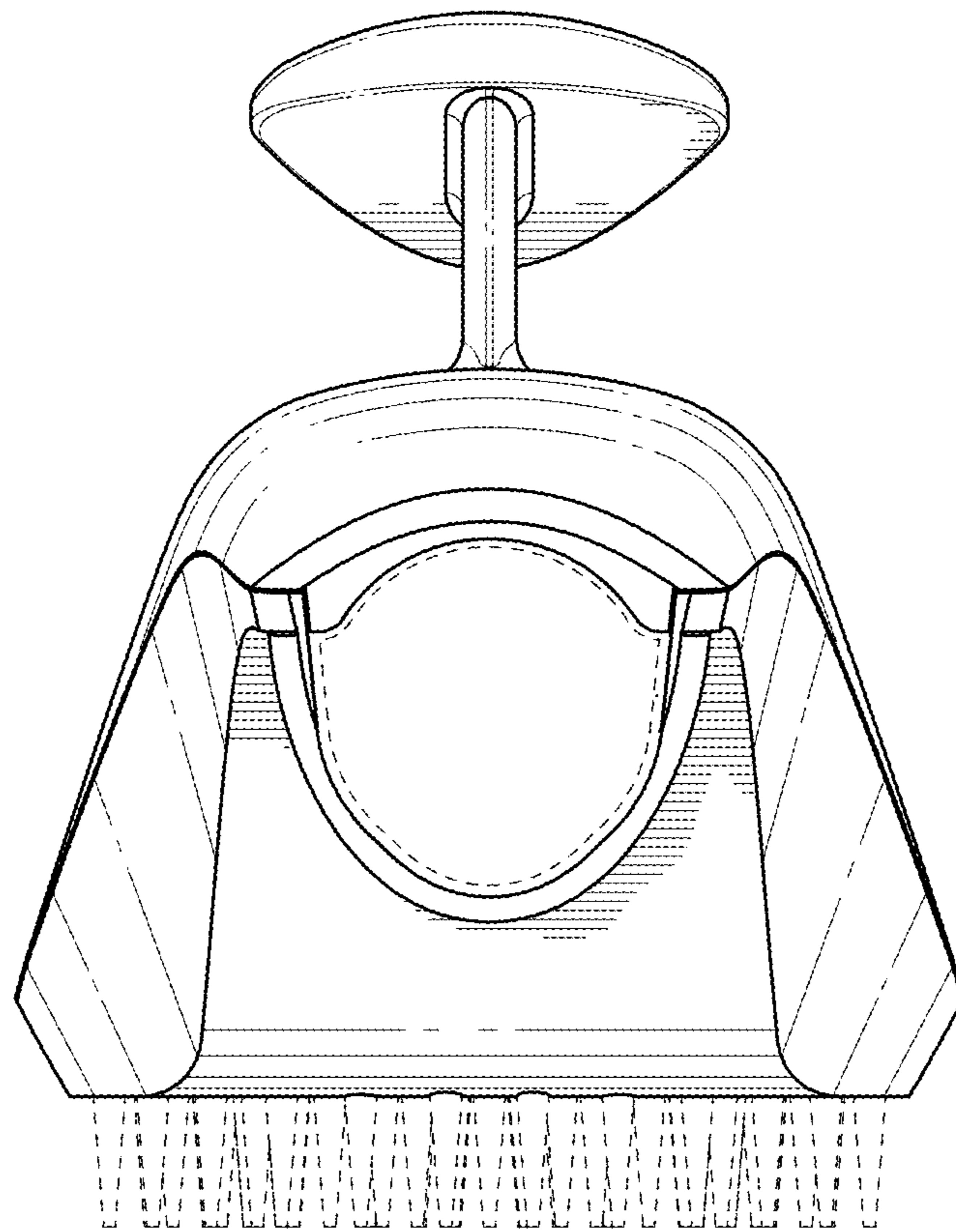
