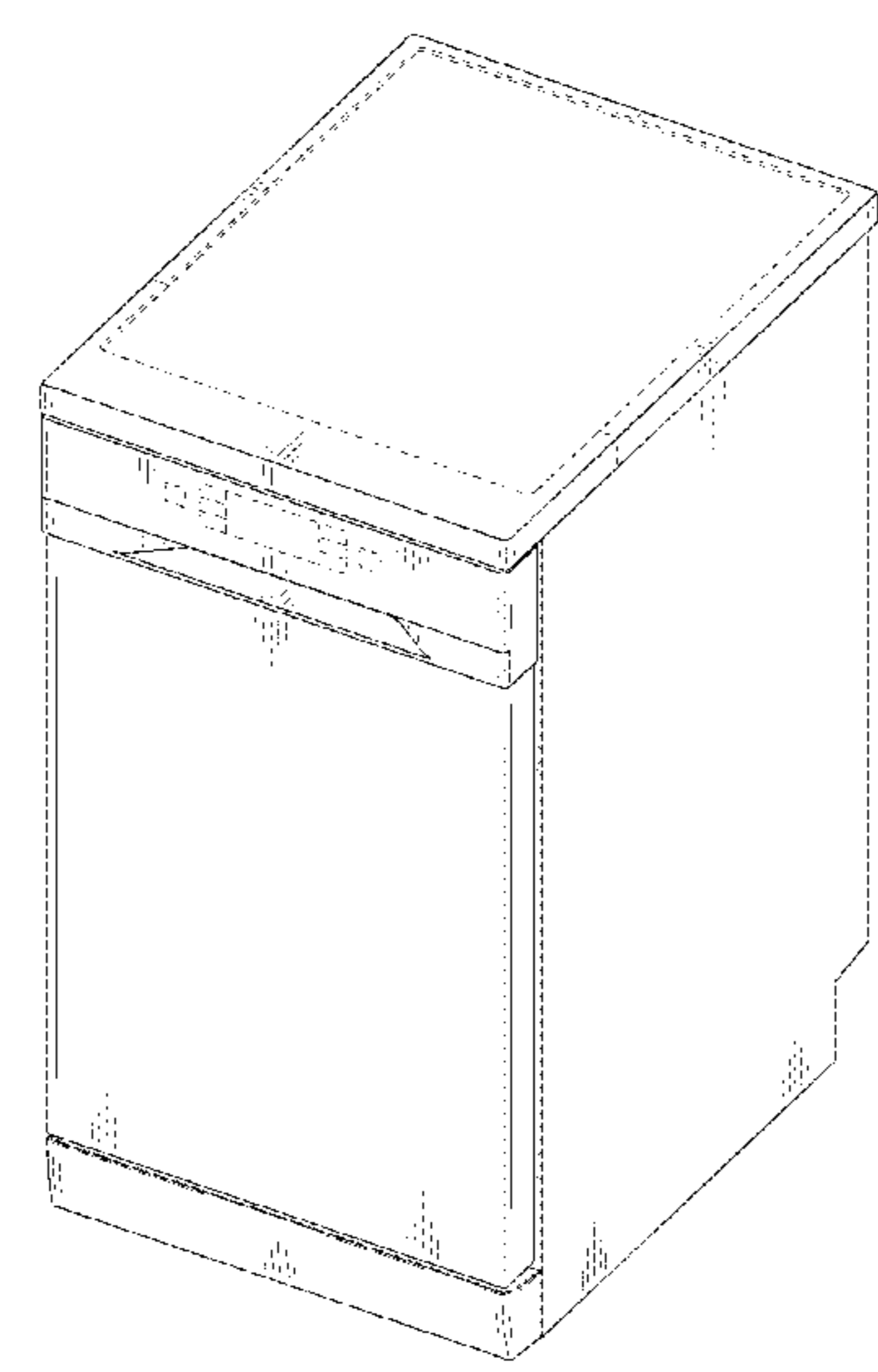

DESCRIPTION

FIG. 1 is a front perspective view of a dishwasher showing our new design;
FIG. 2 is a front elevation view thereof;
FIG. 3 is a rear elevation view thereof;
FIG. 4 is a left-side elevation view thereof;
FIG. 5 is a right-side elevation view thereof;
FIG. 6 is a top plan view thereof; and,
FIG. 7 is a bottom plan view thereof.
The dashed broken lines in the figures depict portions of the dishwasher that form no part of the claimed design.

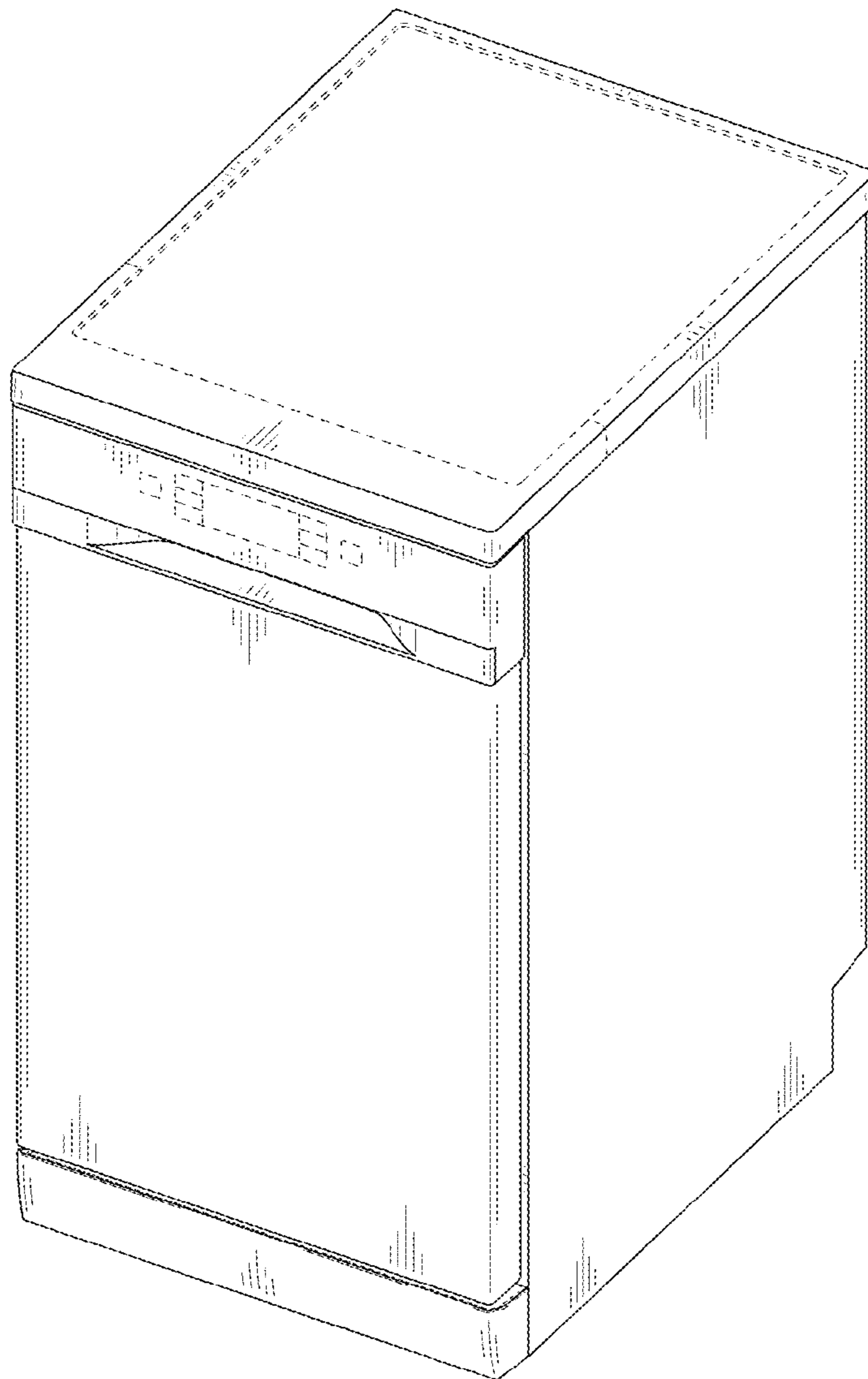

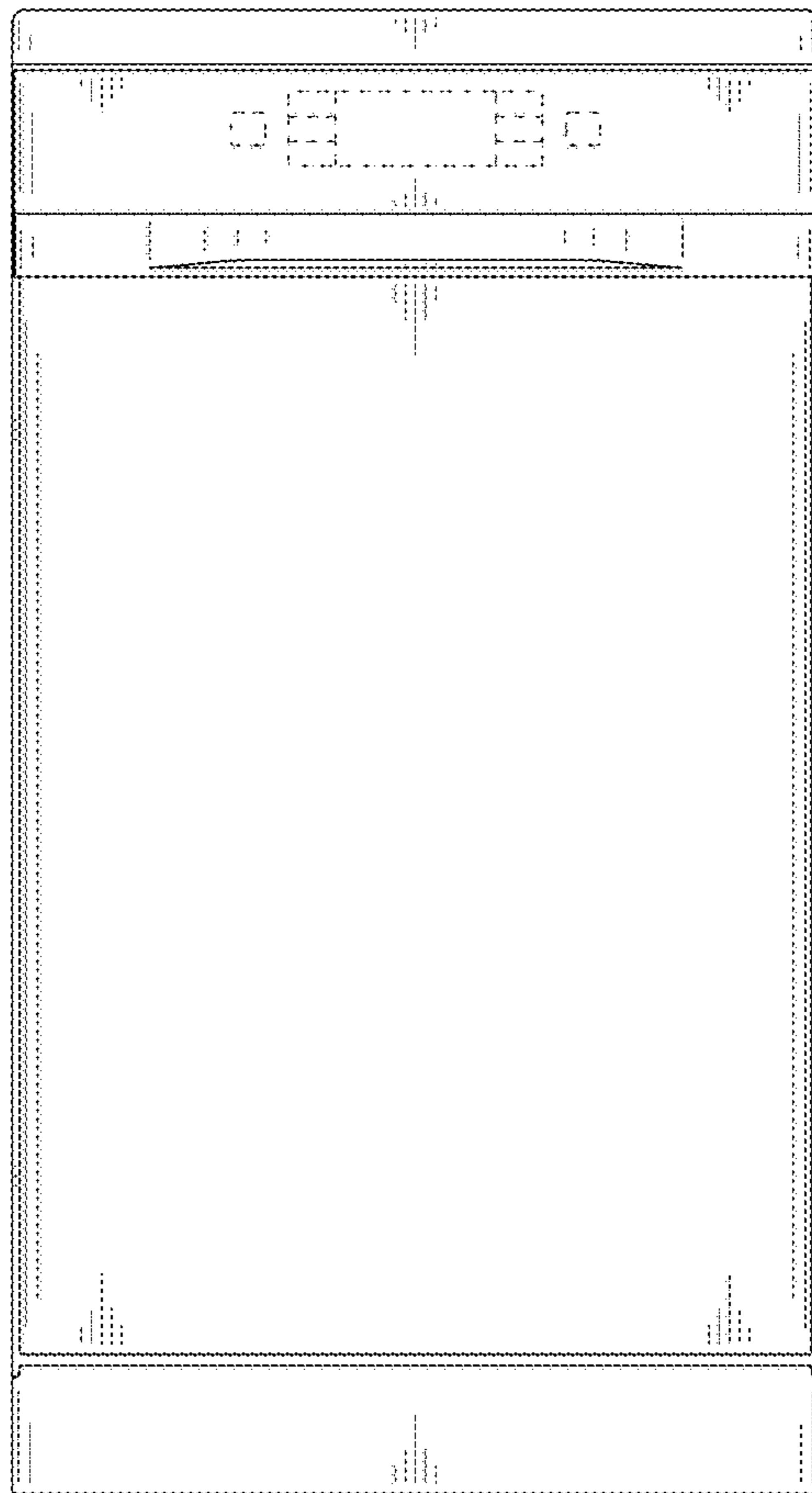

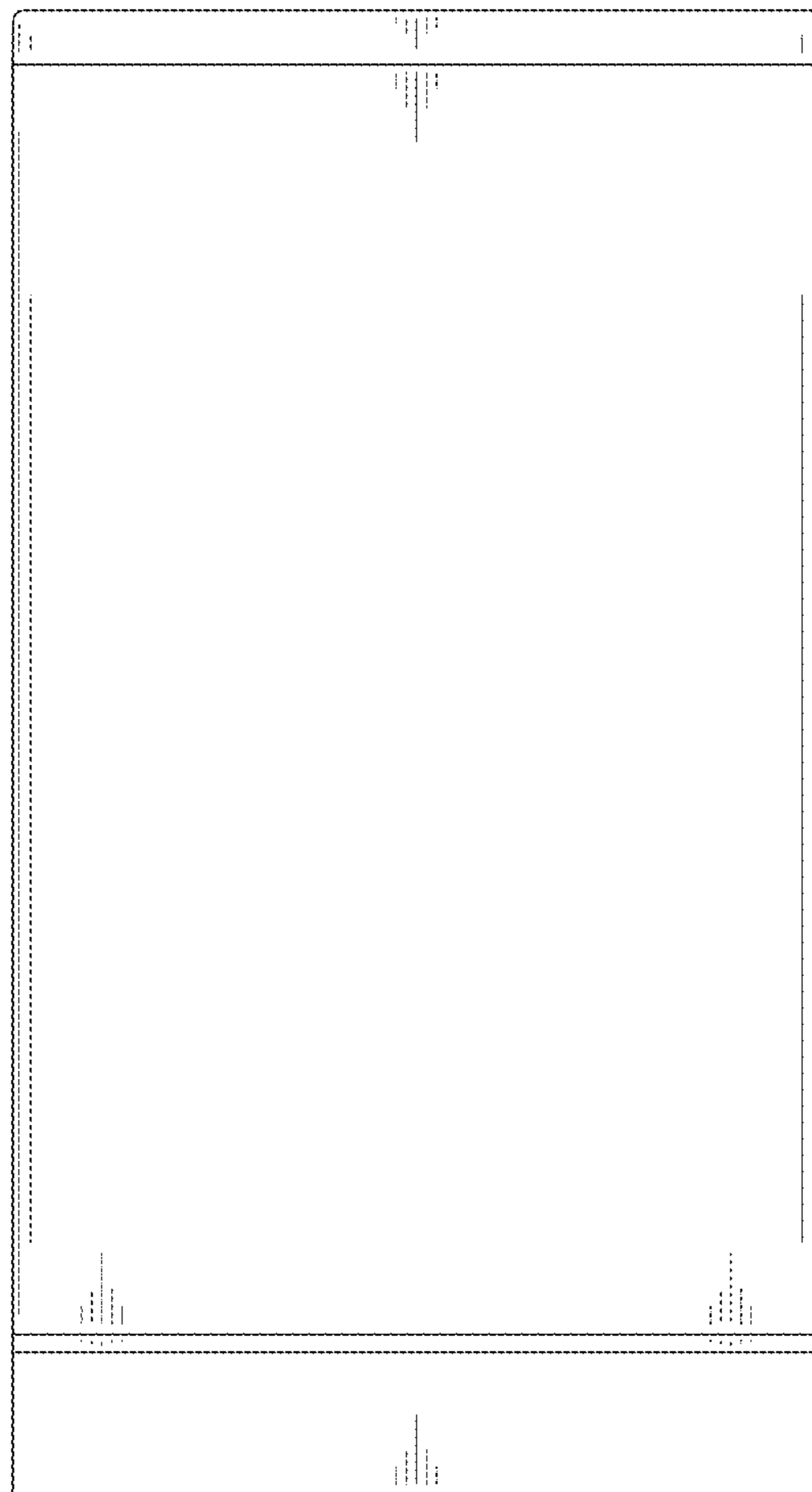

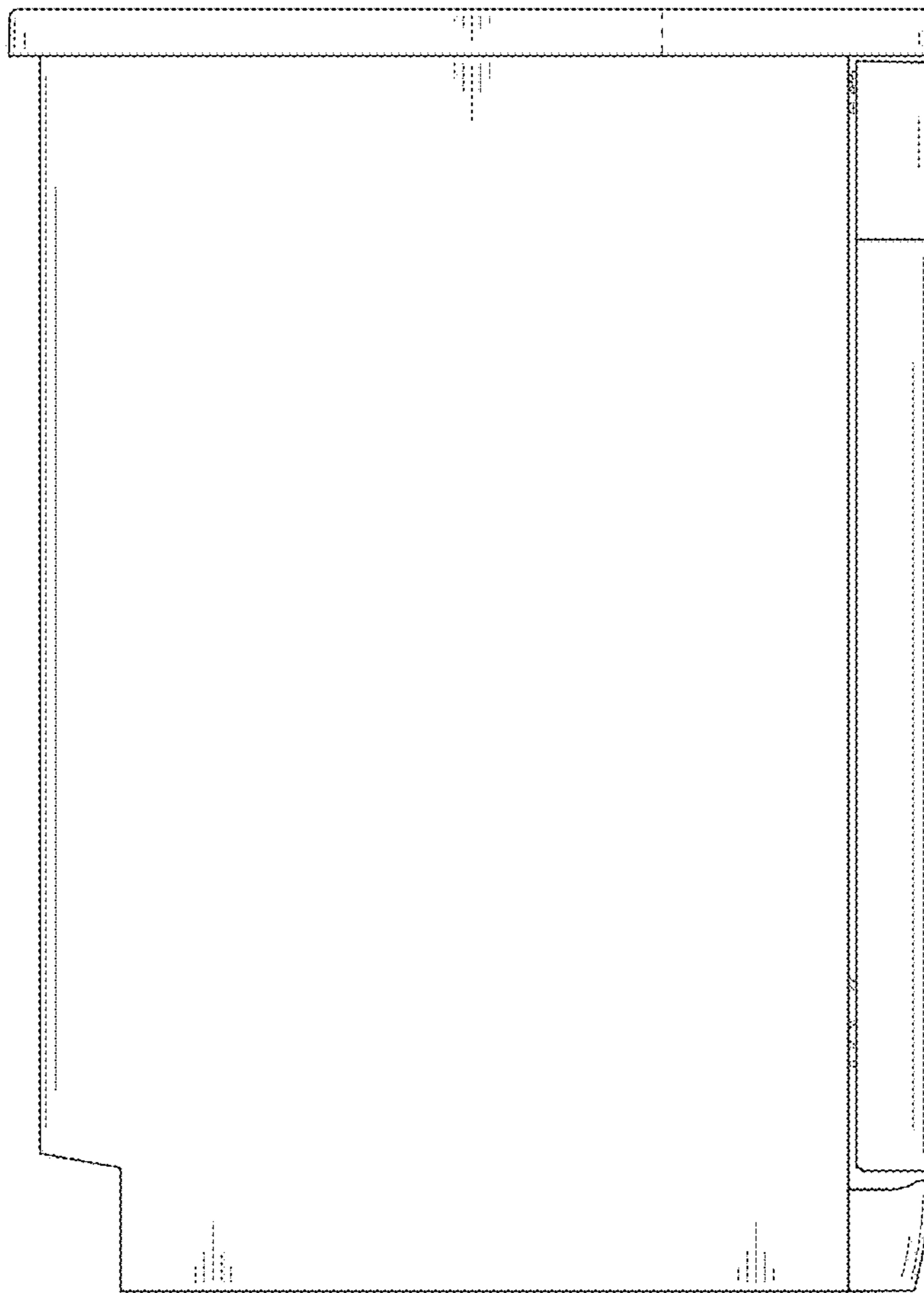

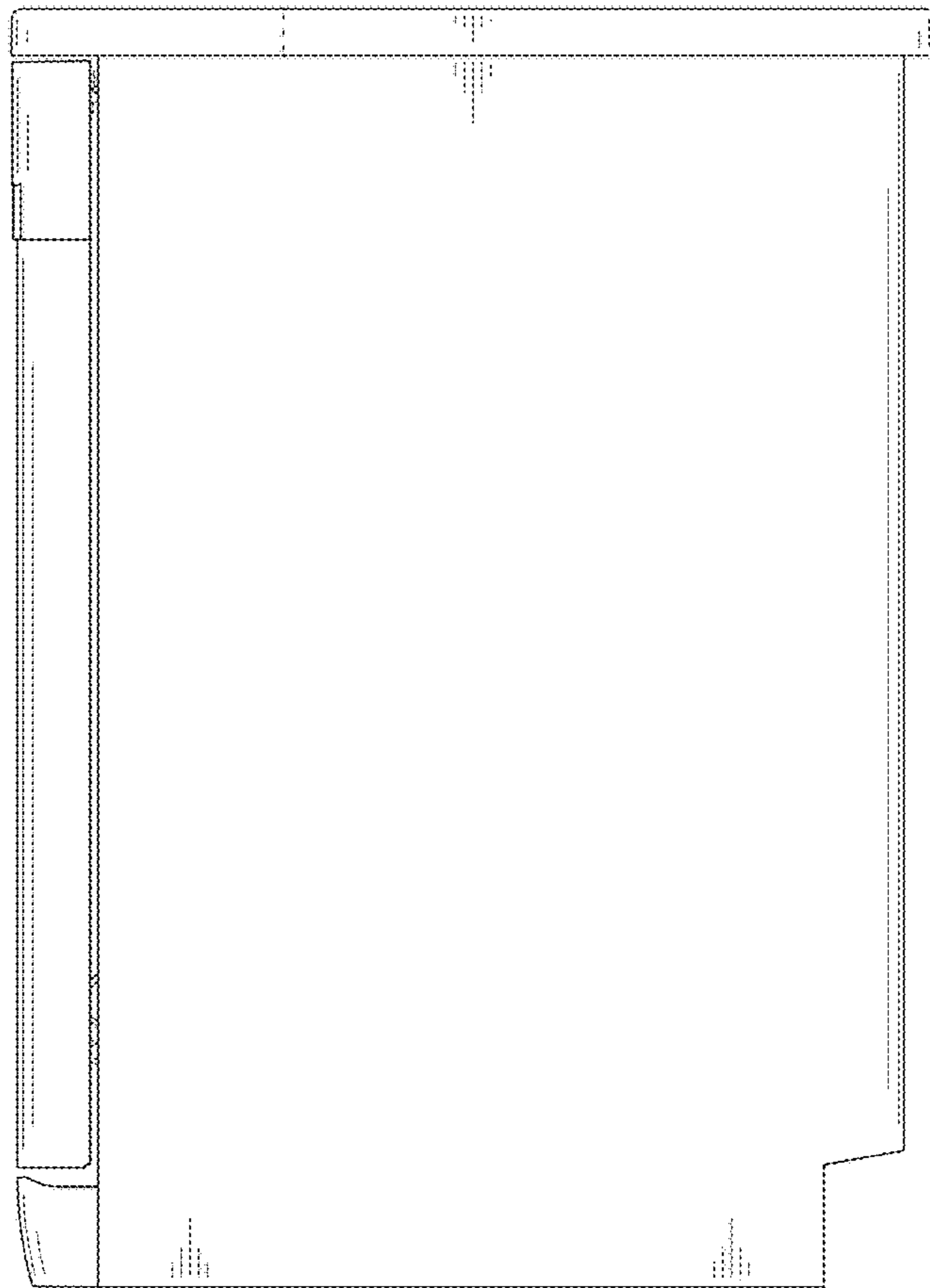

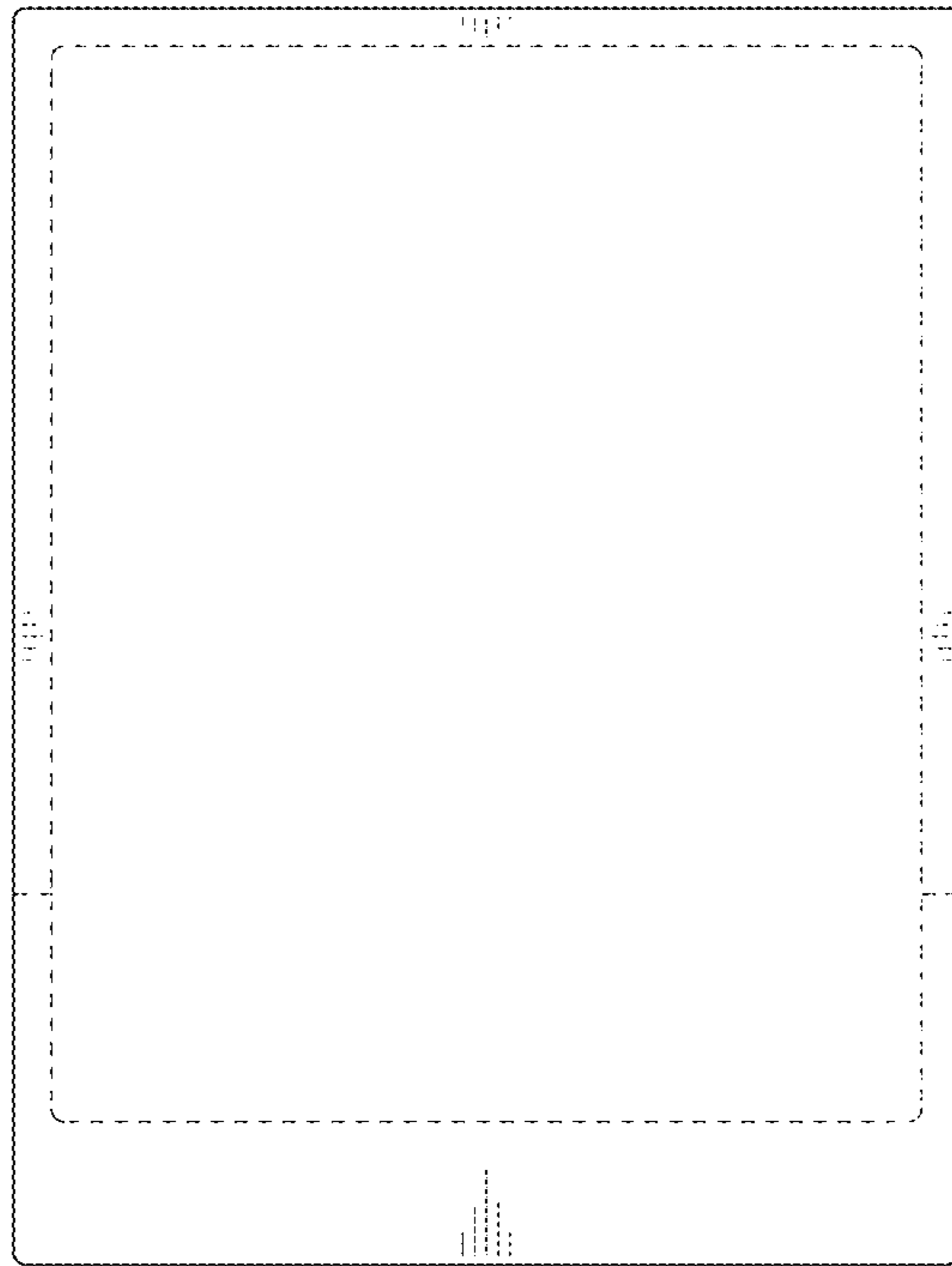
