(57) **CLAIM**

We claim the ornamental design for a glove, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of a glove showing the new design;

FIG. 2 is a front view showing the design of FIG. 1;

FIG. 3 is a back view showing the design of FIG. 1;

FIG. 4 is a side view showing the design of FIG. 1;

FIG. 5 is an opposite side view showing the design of FIG. 1;

FIG. 6 is a top view showing the design of FIG. 1;

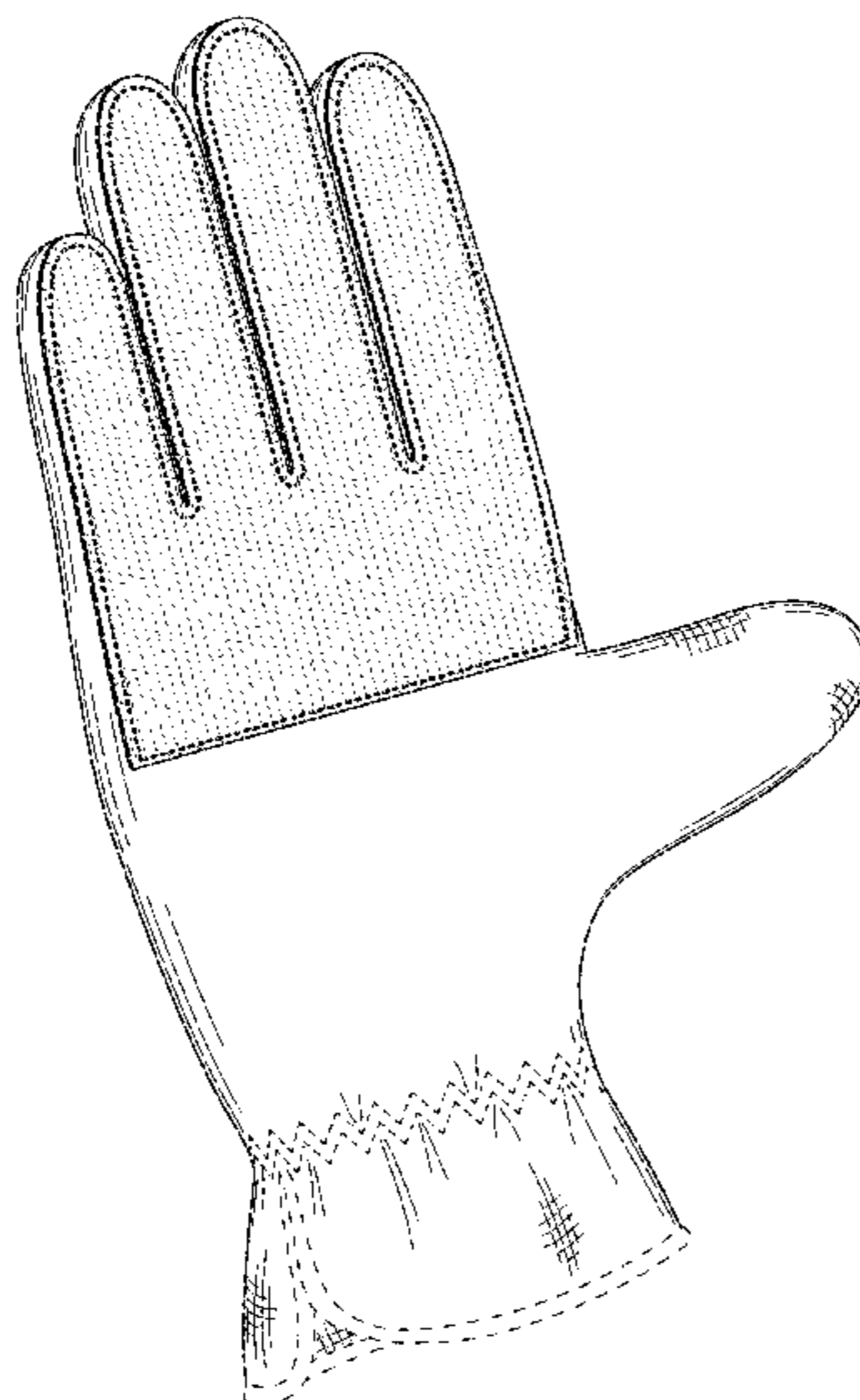
FIG. 7 is bottom view showing the design of FIG. 1;

FIG. 8 is an in-use, perspective view showing the design of FIG. 1 in a first environment of use; and,

FIG. 9 is an in-use, perspective view showing the design of FIG. 1 in a second environment of use.

The appearance of the interior surface of a glove, a portion not illustrated in the drawing disclosure, is unclaimed. The broken lines appearing on the glove illustrate stitching and form no part of the claimed design. The additional broken lines in FIGS. 8 and 9 illustrate environmental structure, namely a wearer's forearm, sandpaper sheet (FIG. 8) or sandpaper disc (FIG. 9), and an object for sanding, and form no part of the claimed design,

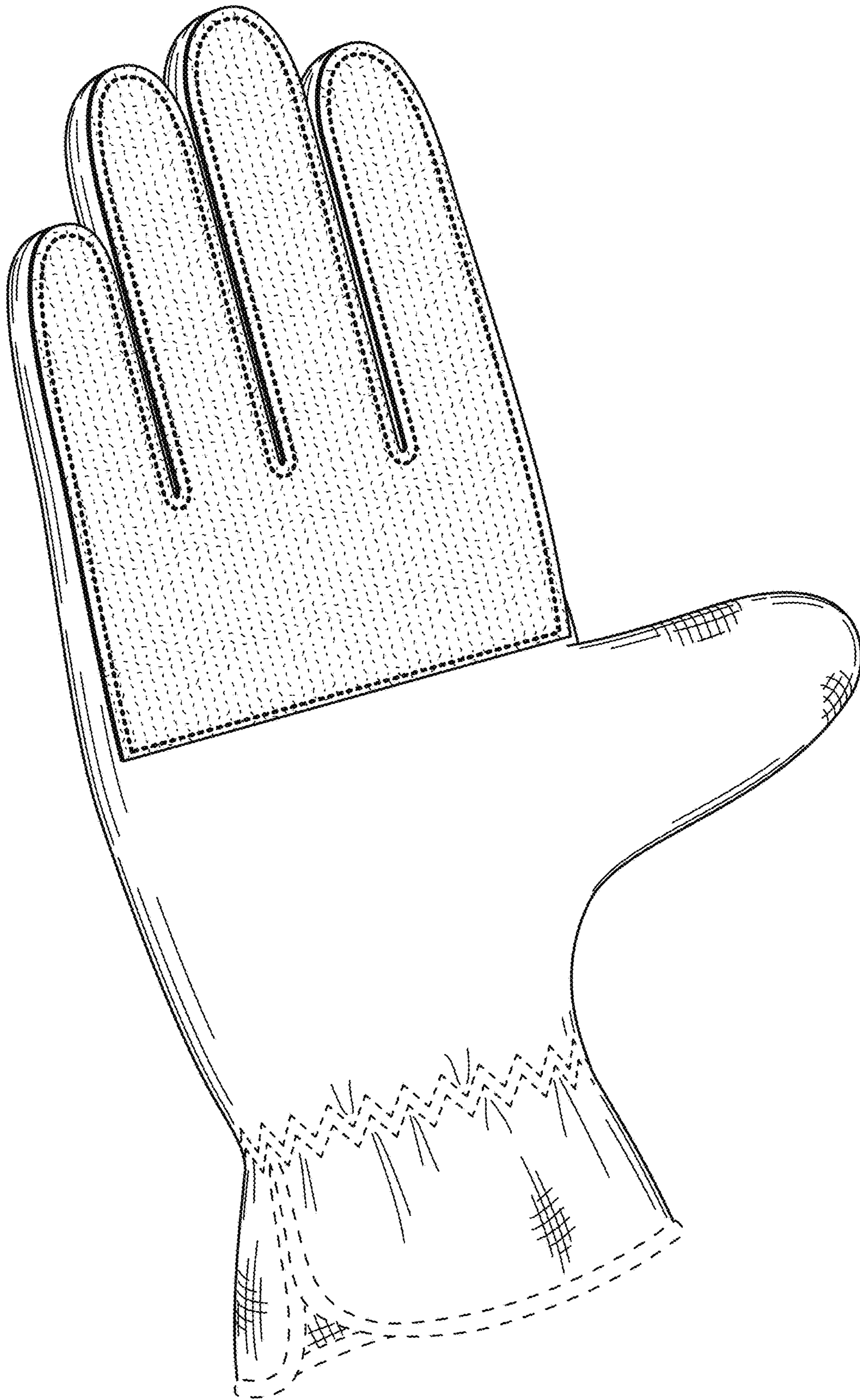

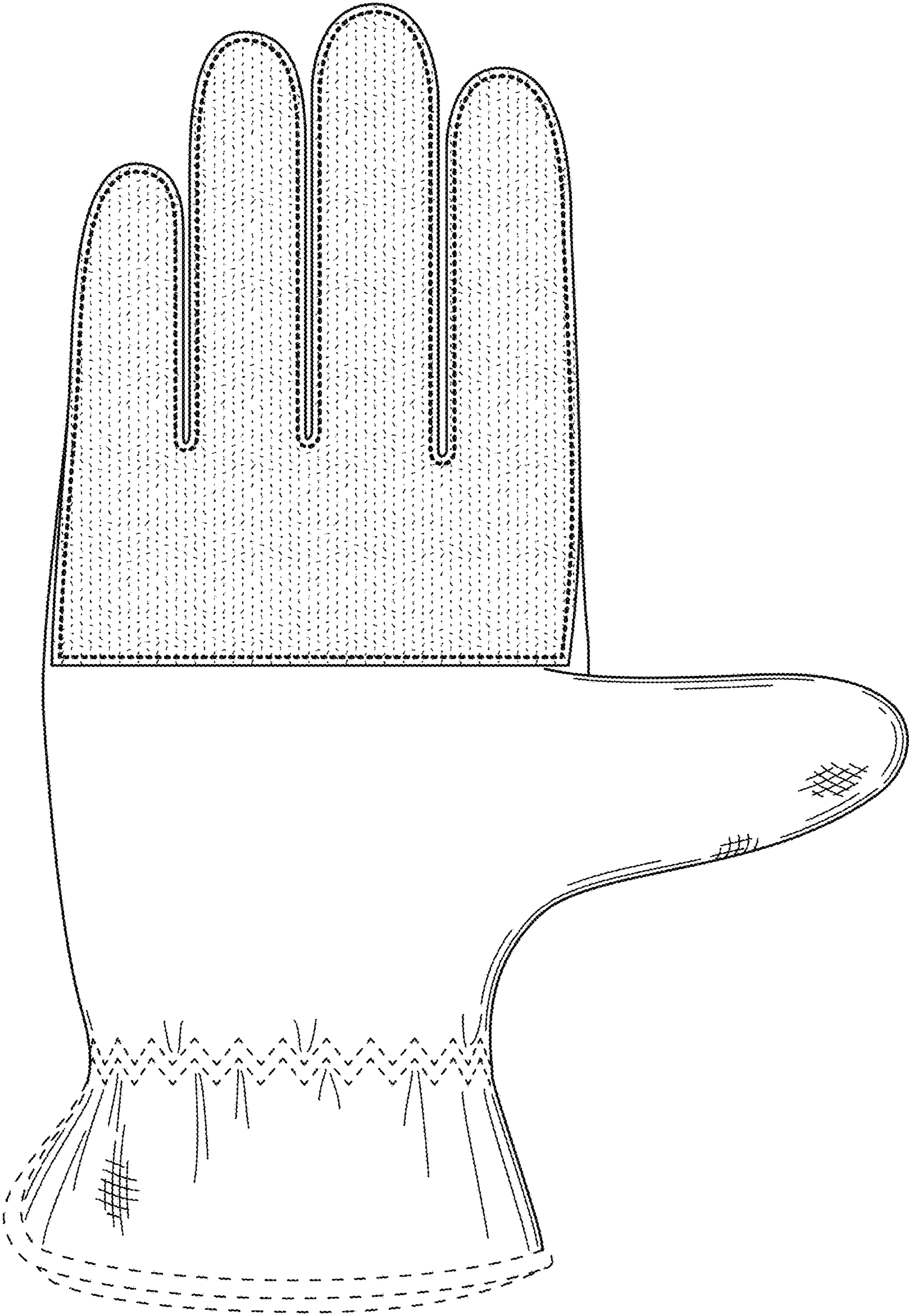

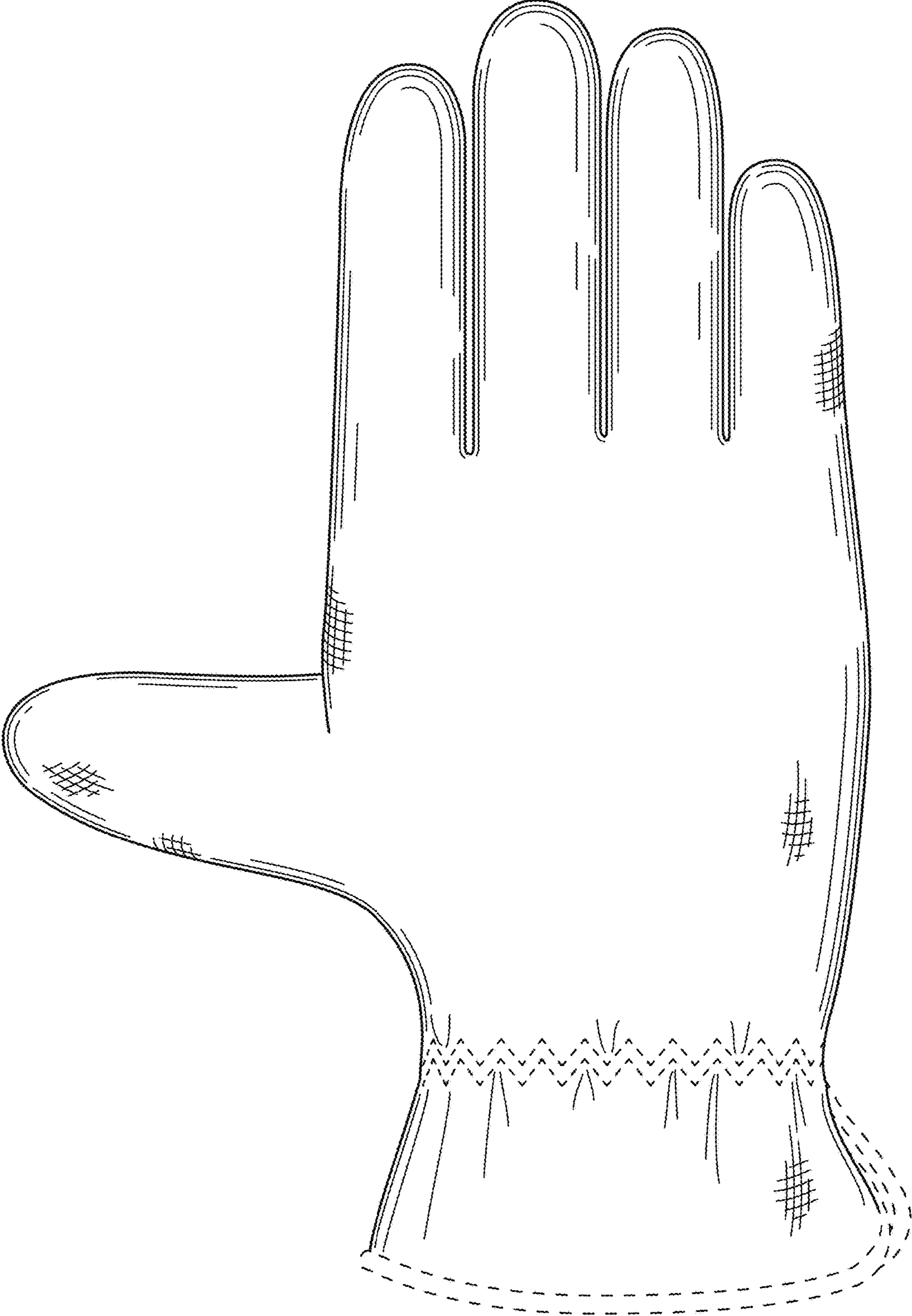

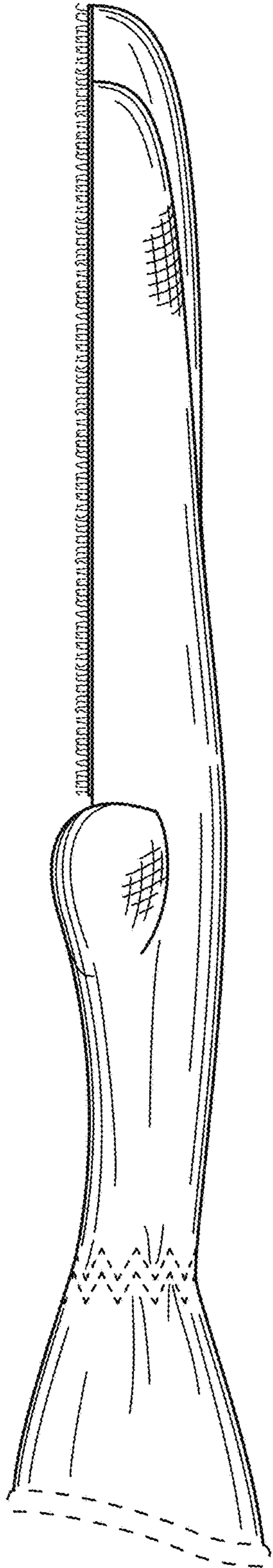

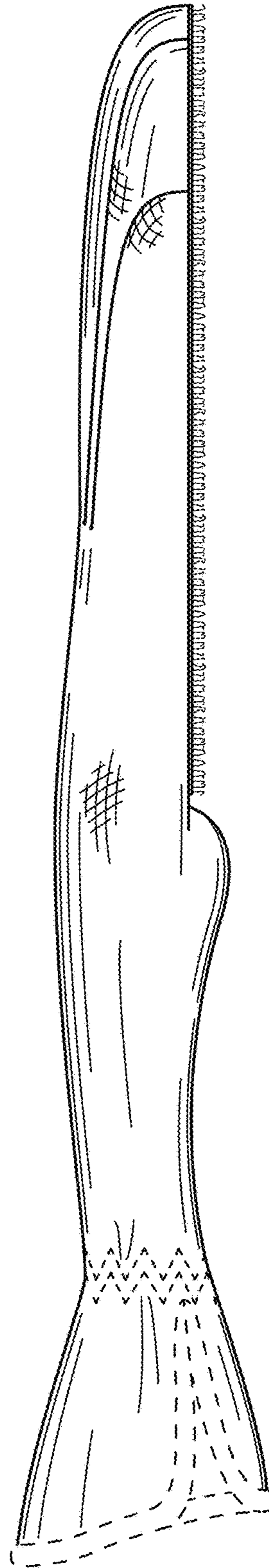

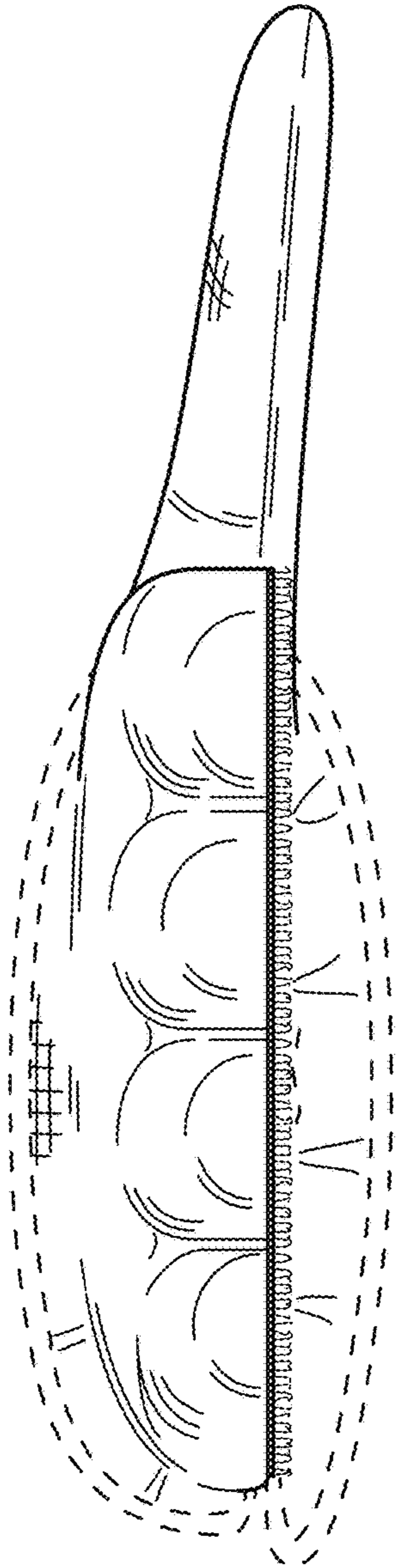

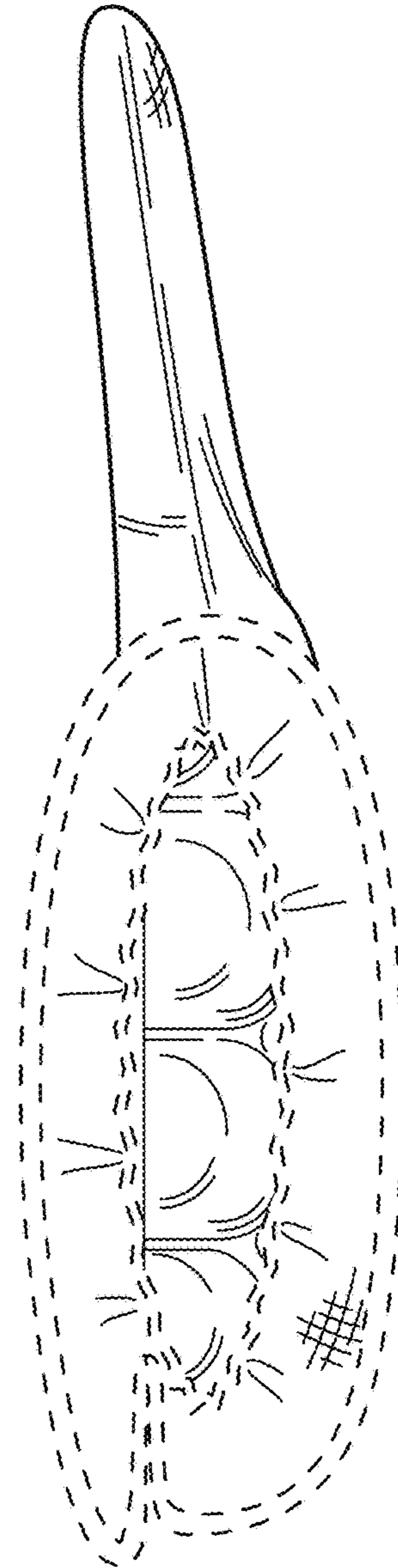

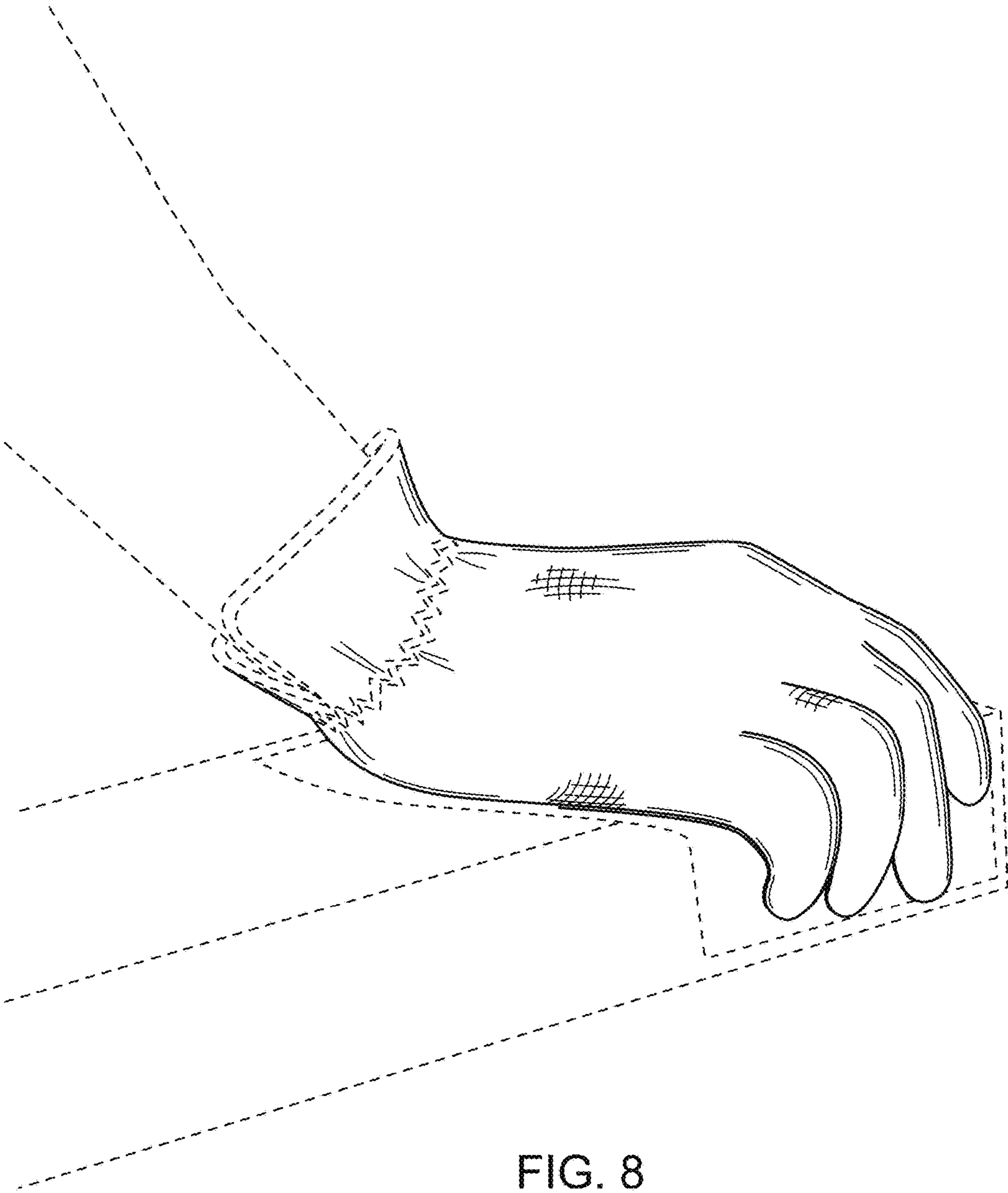

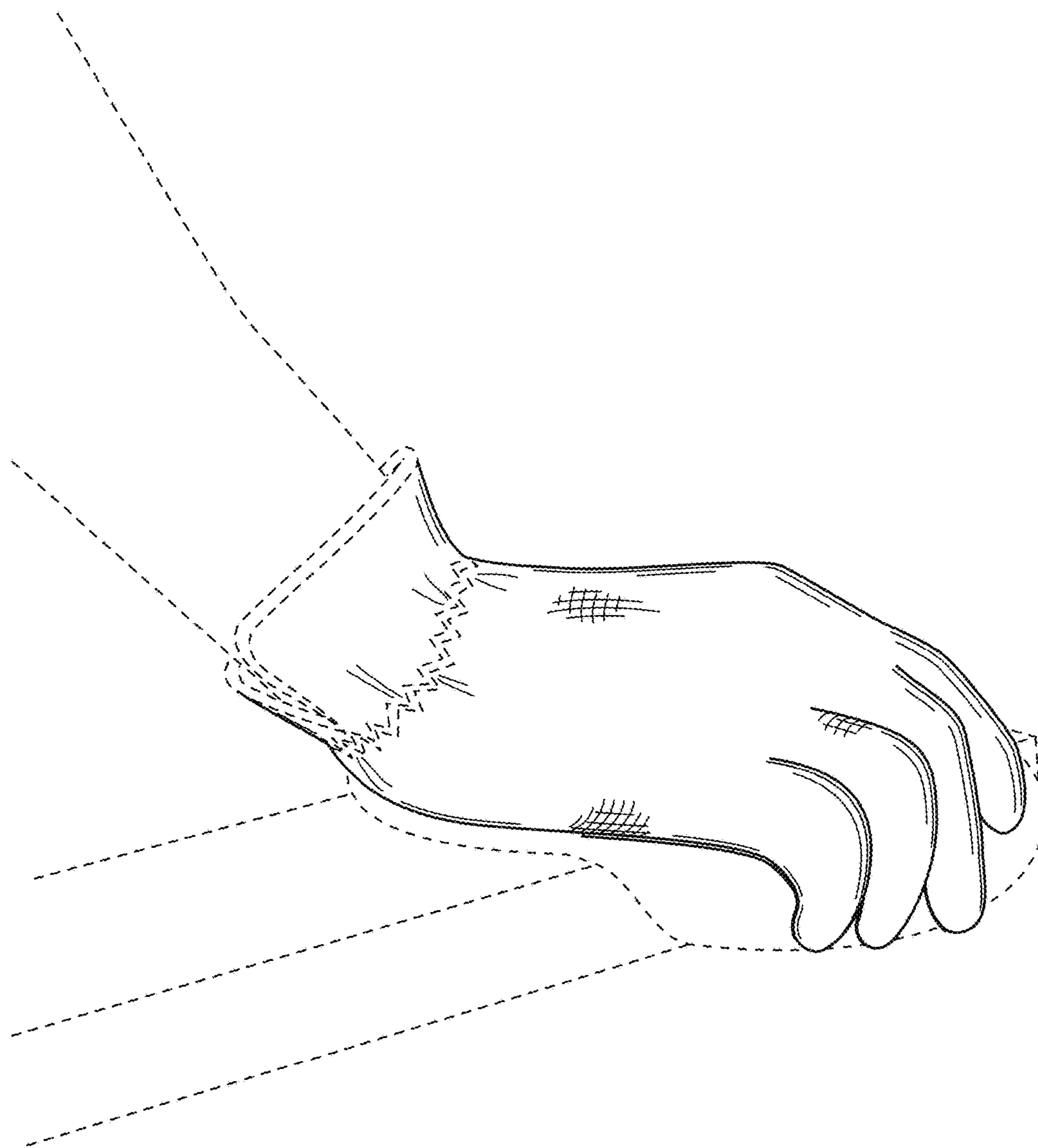
