(57) **CLAIM**

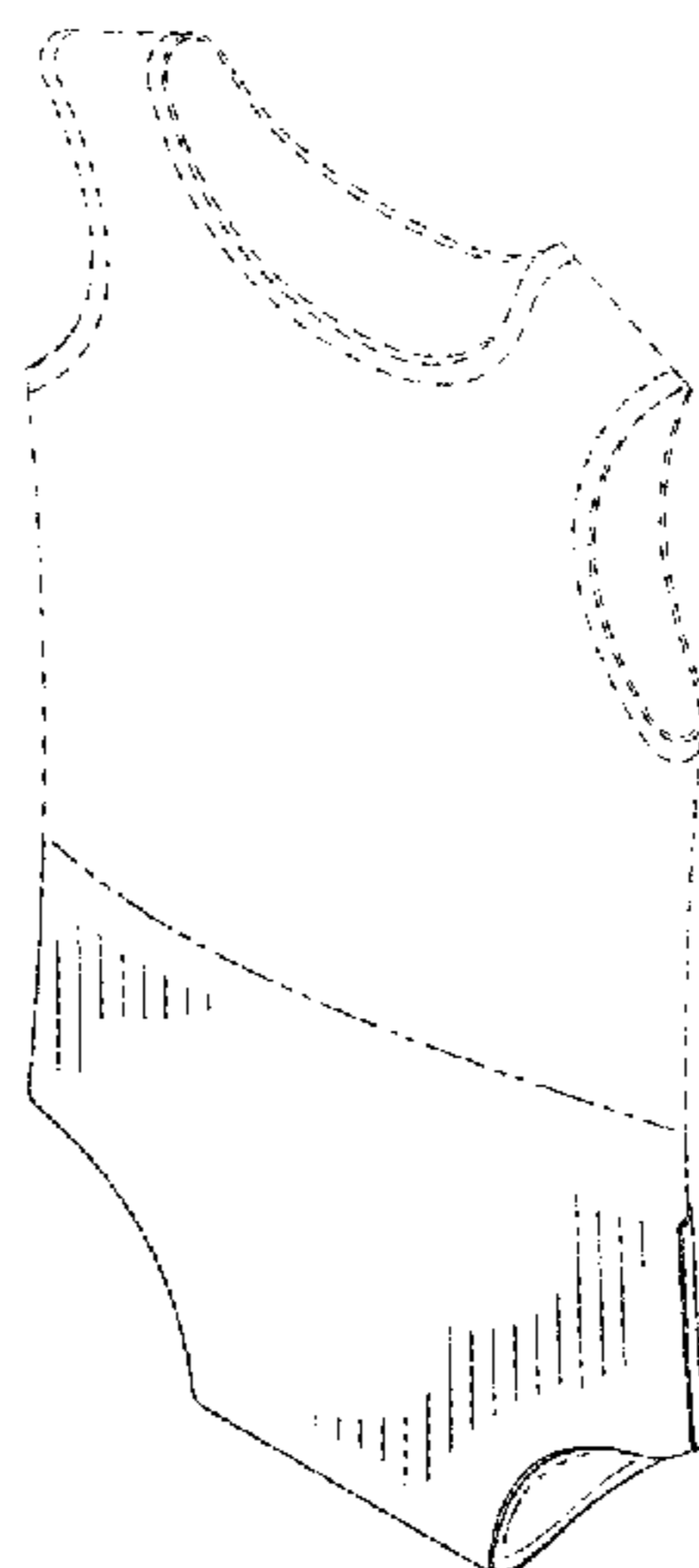
The ornamental design for a toddler onesie, as shown and described.

DESCRIPTION

FIG. 1 is a top front perspective view of a toddler onesie; FIG. 2 is a front elevation view thereof; FIG. 3 is a rear elevation view thereof; FIG. 4 is a left side elevation view thereof, the right side elevation view being a mirror image thereof; FIG. 5 is a top plan view thereof; FIG. 6 is a bottom plan view thereof; and, FIG. 7 is a top rear perspective view thereof, shown in an open configuration.
The broken lines of even length shown in the drawings illustrate portions of the toddler onesie that form no part of the claimed design, while the broken lines of uneven length define the bounds of the claimed design.

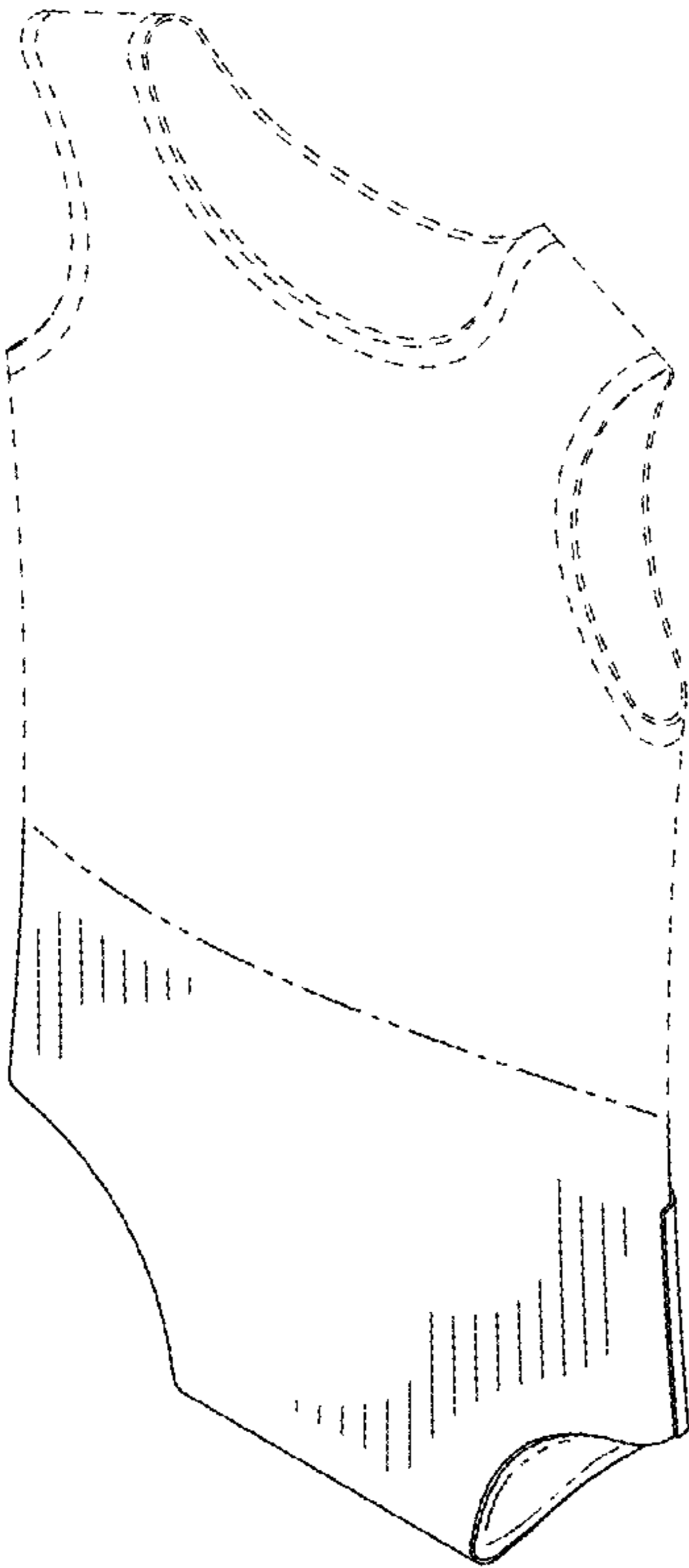

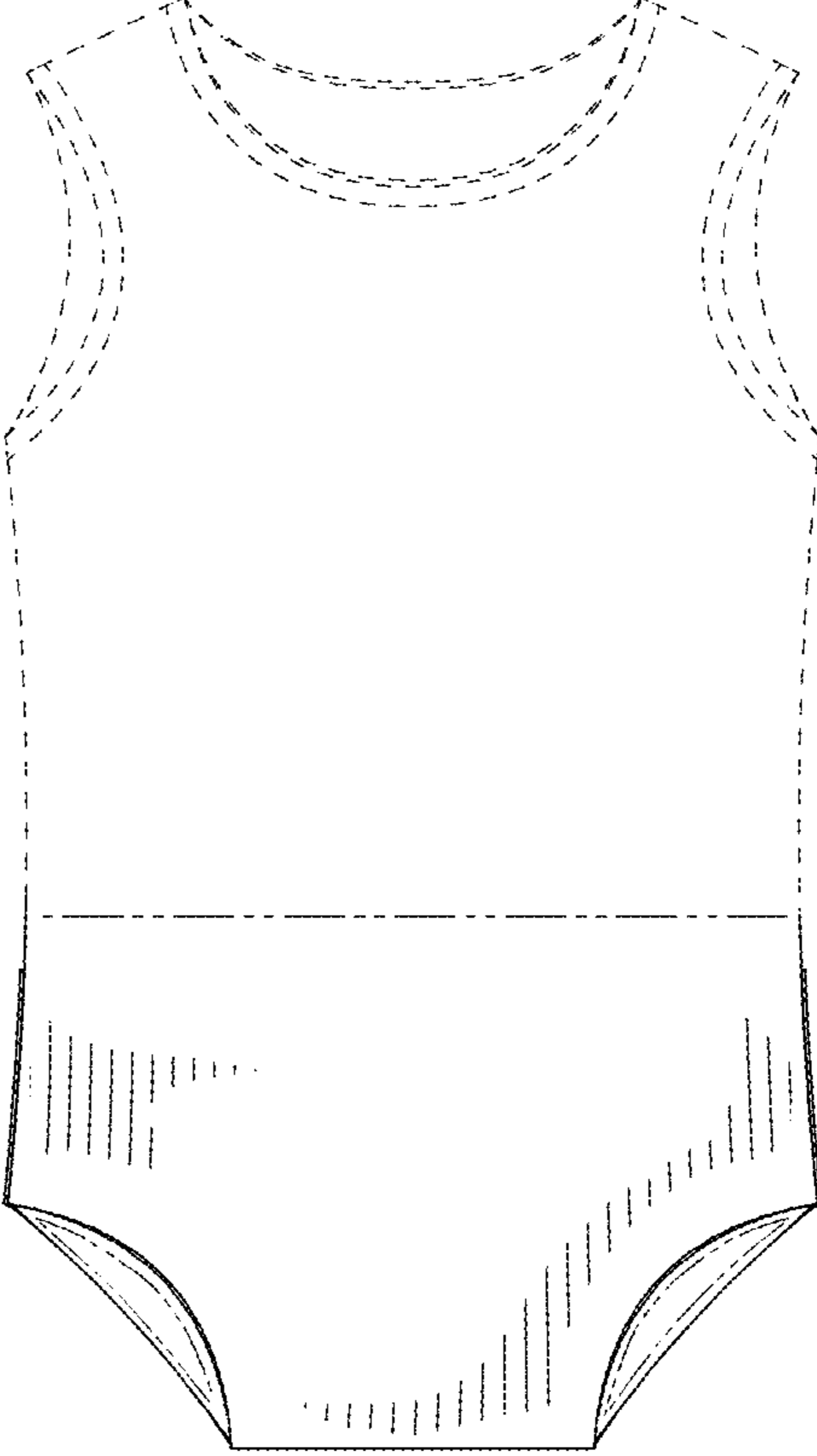

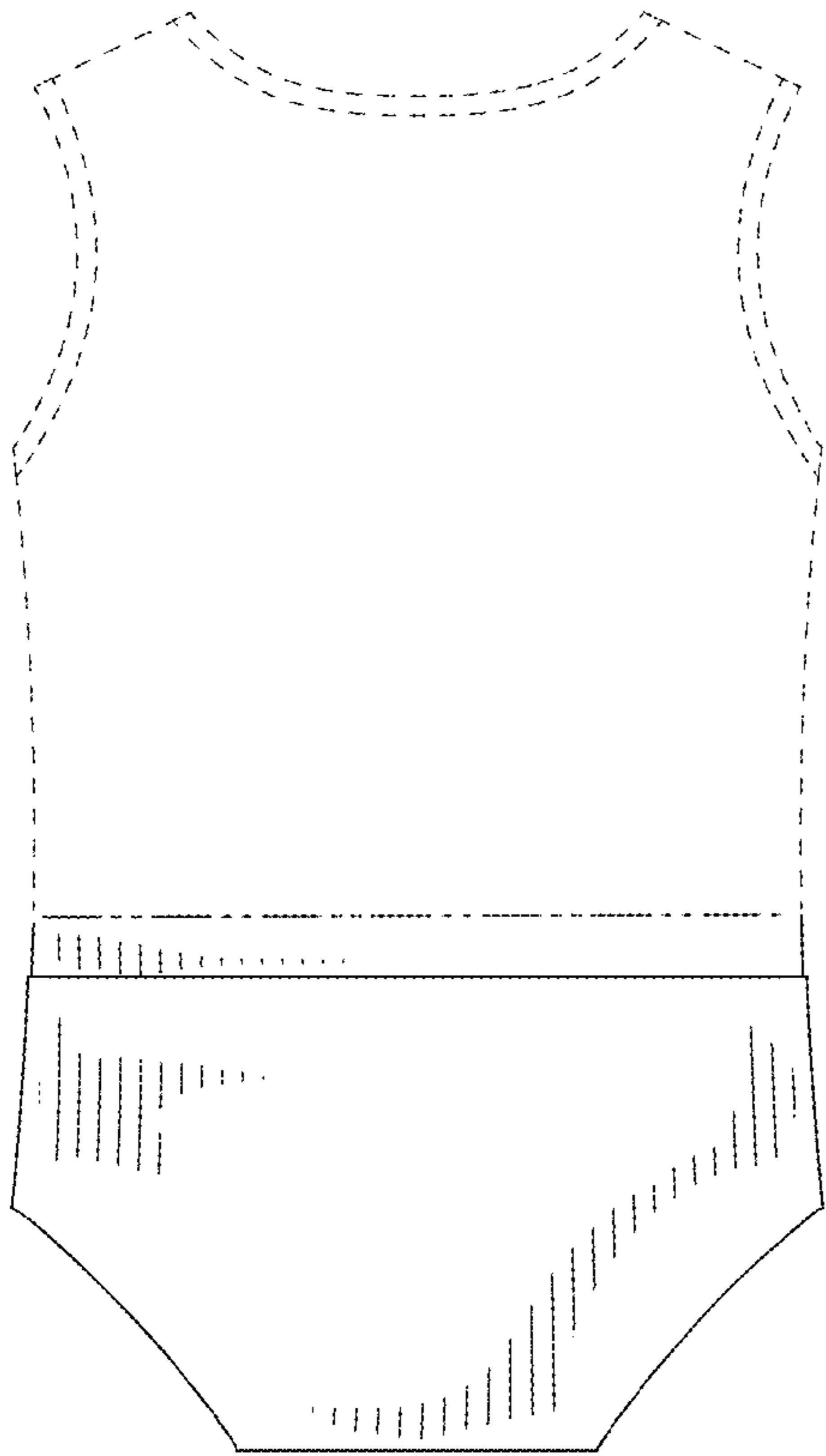

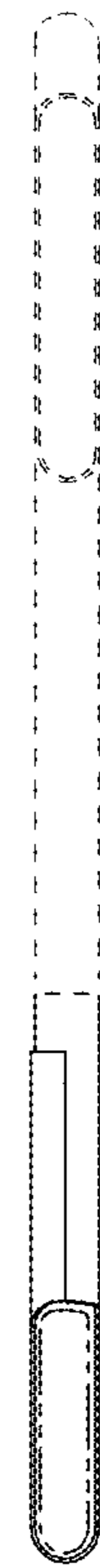

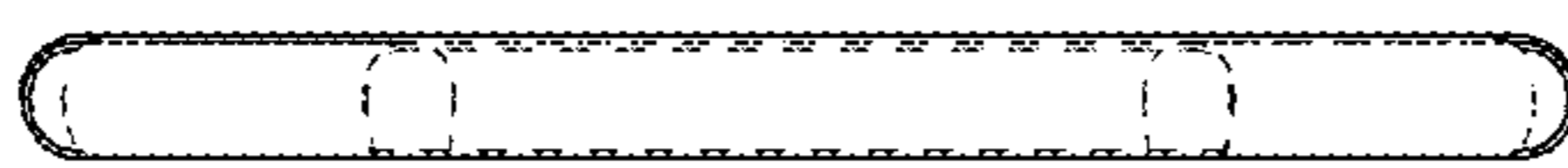

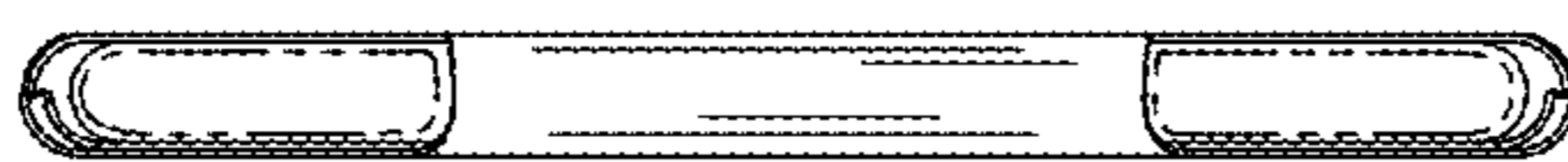

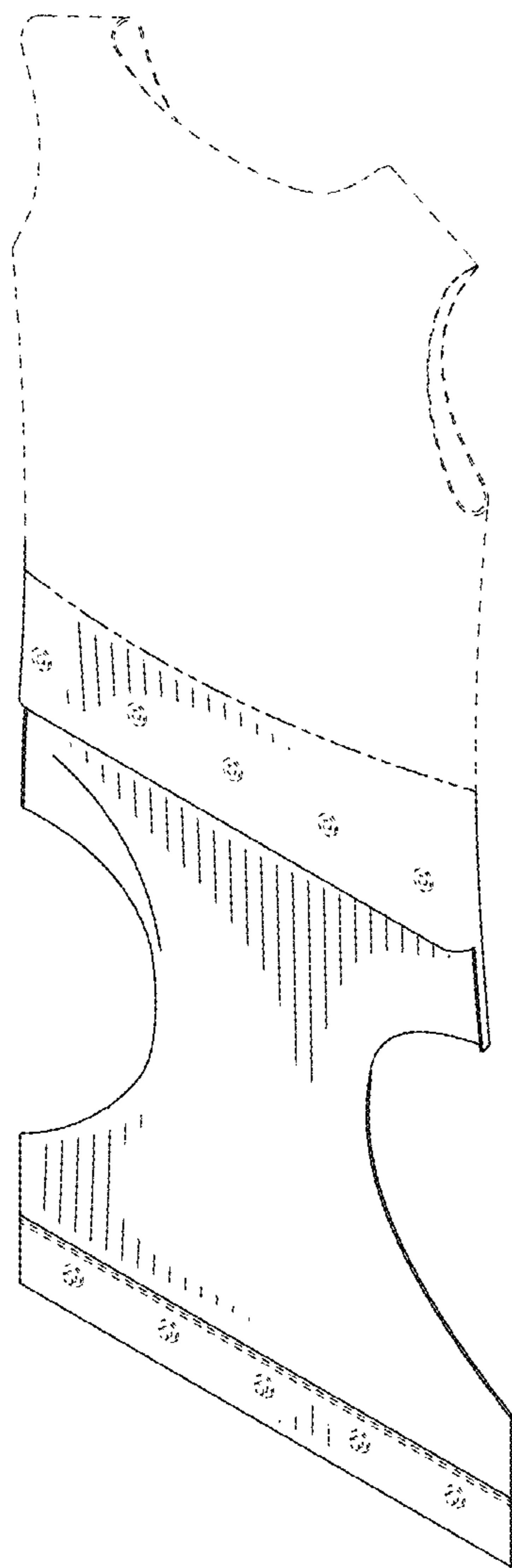
