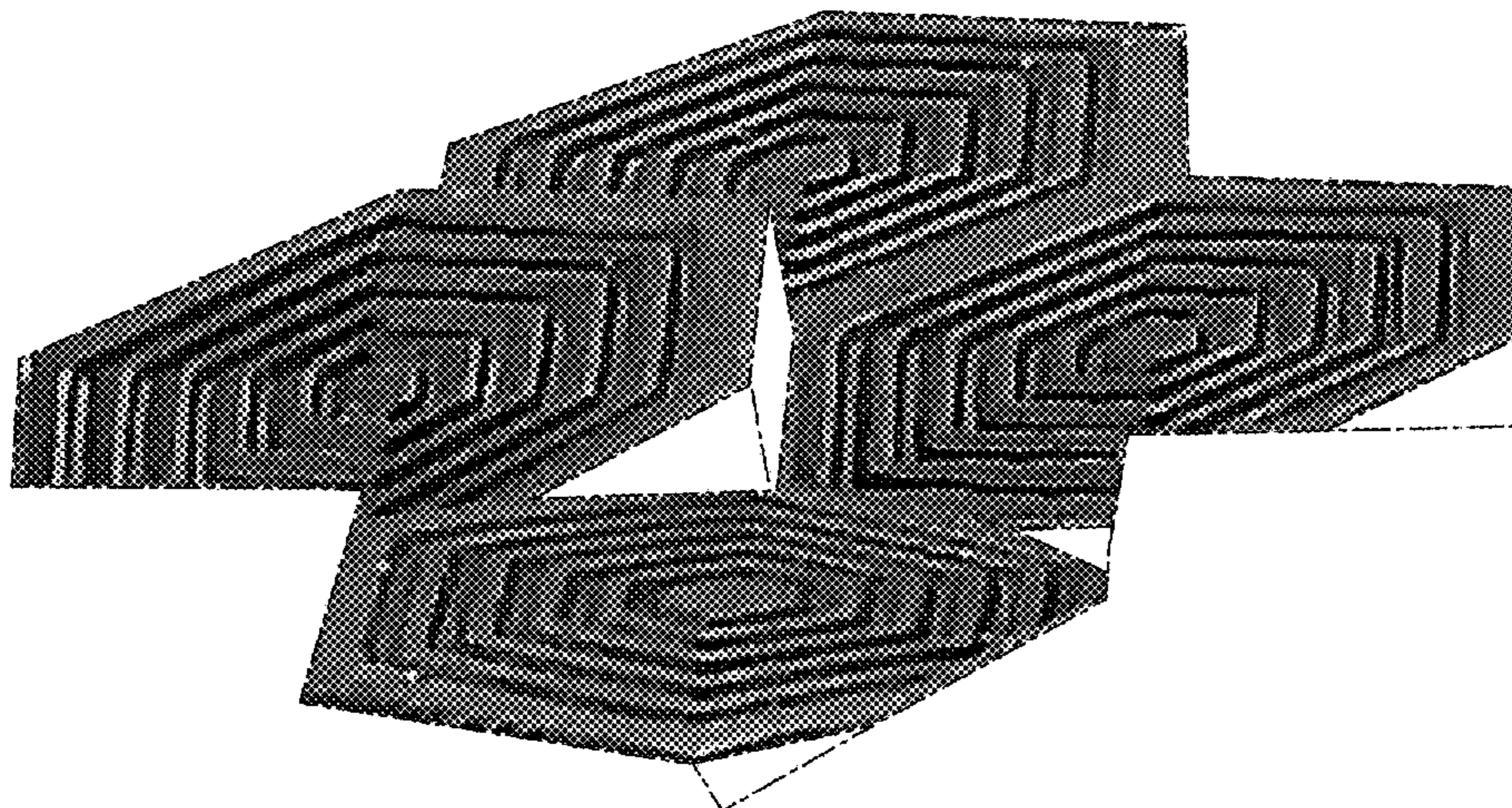
(57) **CLAIM**

The ornamental design for a shoe outsole, as shown and described.

**DESCRIPTION**

FIG. 1 is a photographic front perspective view of a shoe outsole showing my new design;  
FIG. 2 is a photographic bottom view thereof;  
FIG. 3 is a second photographic front perspective view thereof;  
FIG. 4 is an enlarged partial view of FIG. 1 thereof;  
FIG. 5 is an enlarged partial view of FIG. 2 thereof; and,  
FIG. 6 is an enlarged partial view of FIG. 3.  
The photographic area is claimed. The broken lines immediately adjacent to the photographic area represent the bounds of the claimed design and form no part thereof. The broken lines showing the remainder of the shoe are for environmental purposes only and form no part of the claimed design.

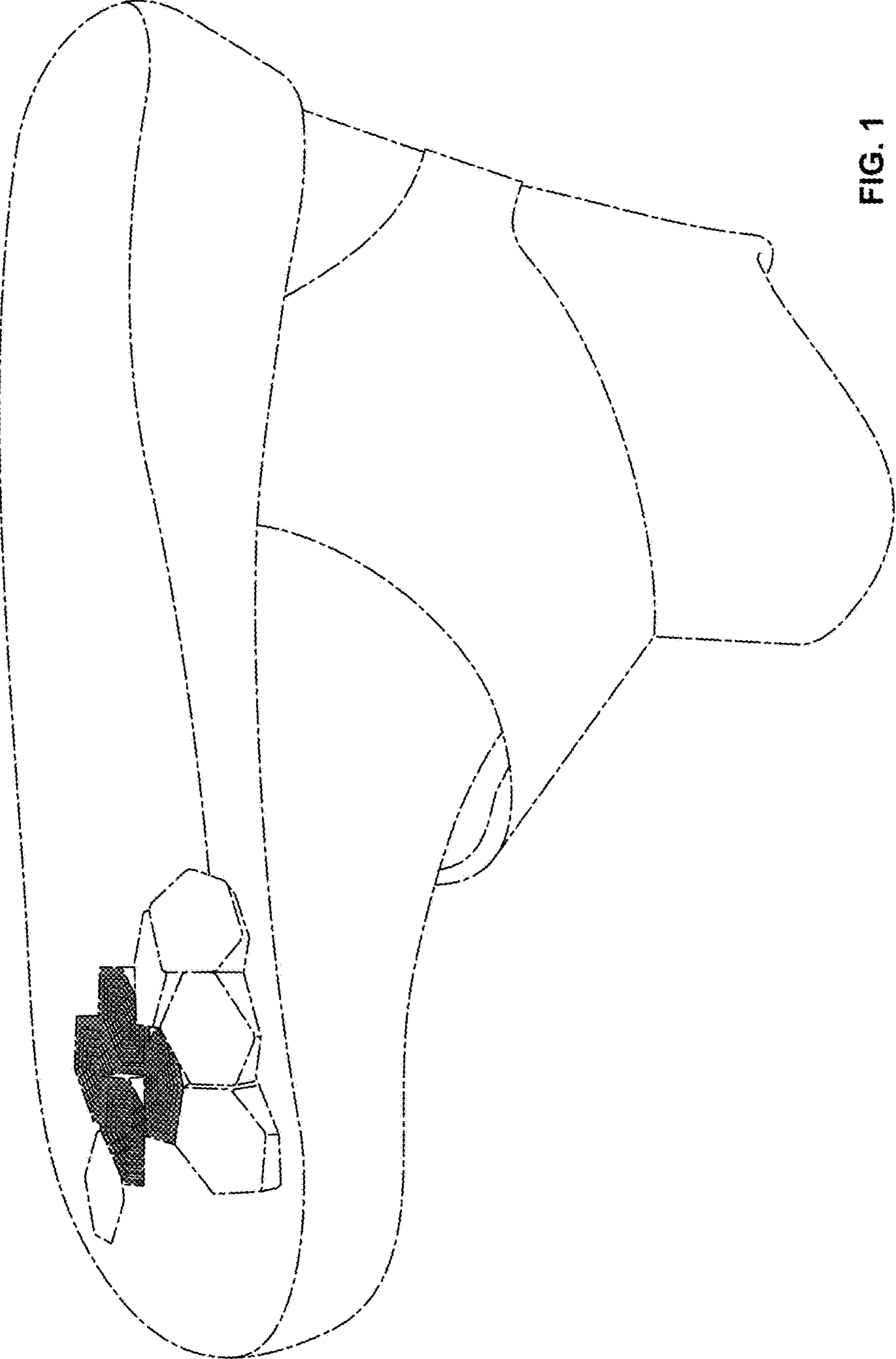

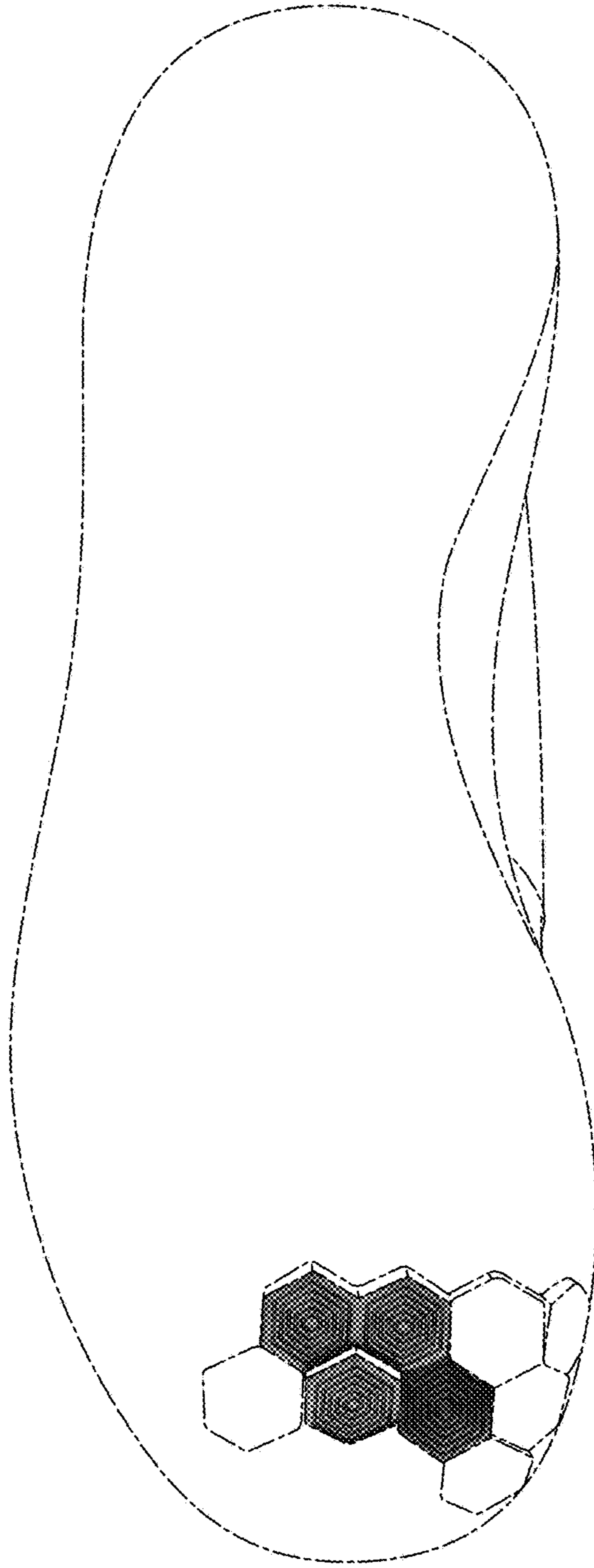

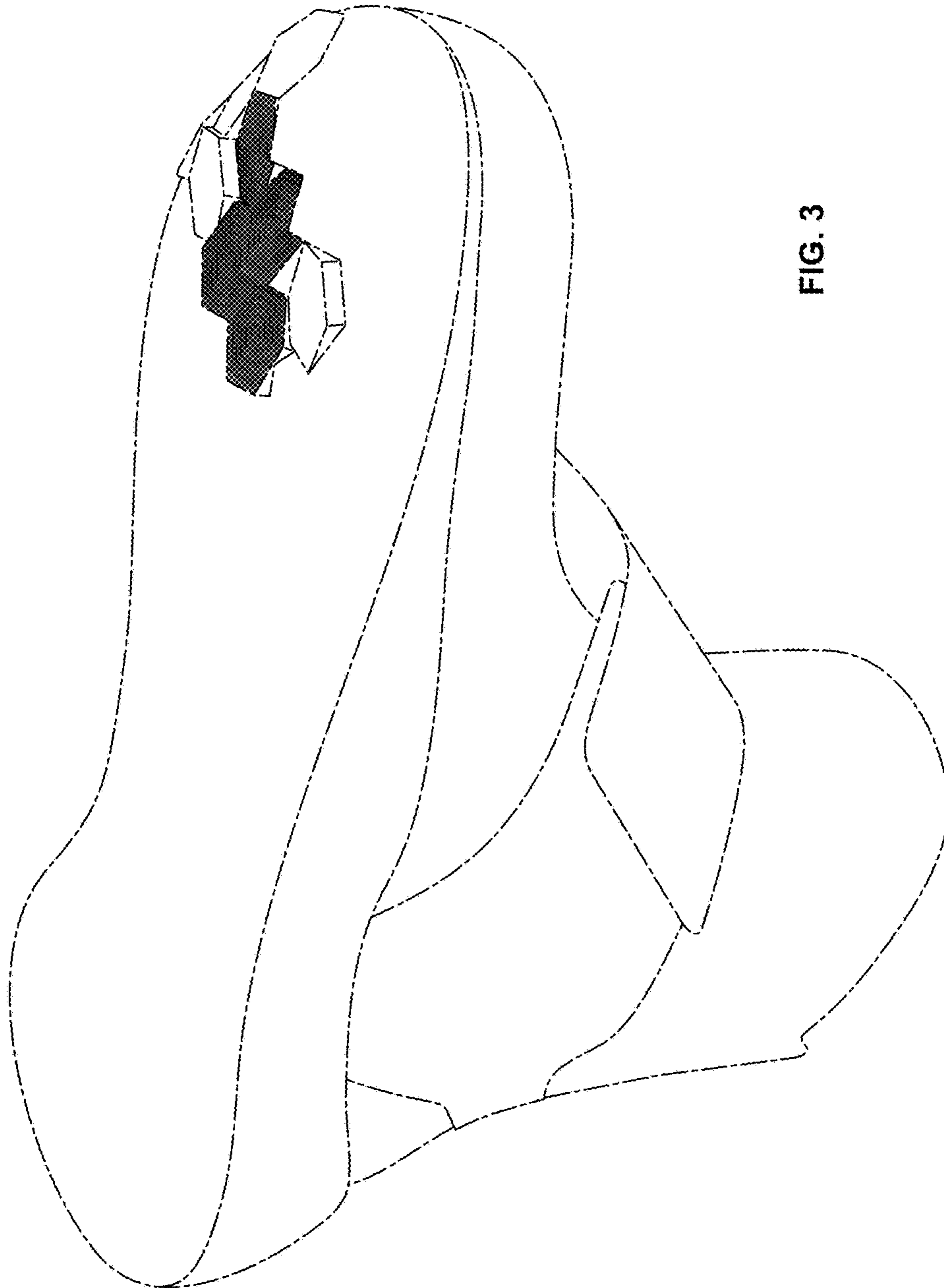

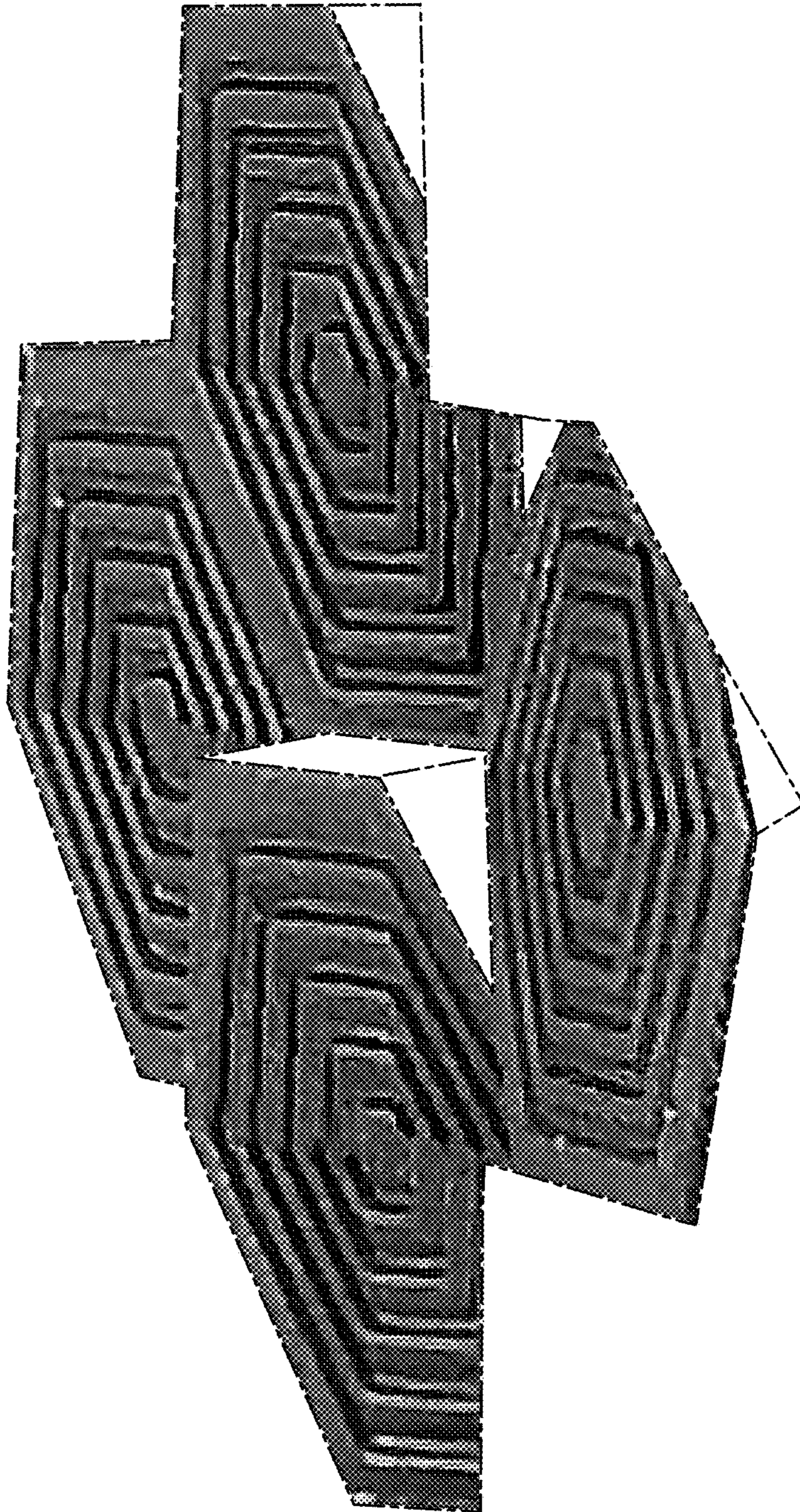

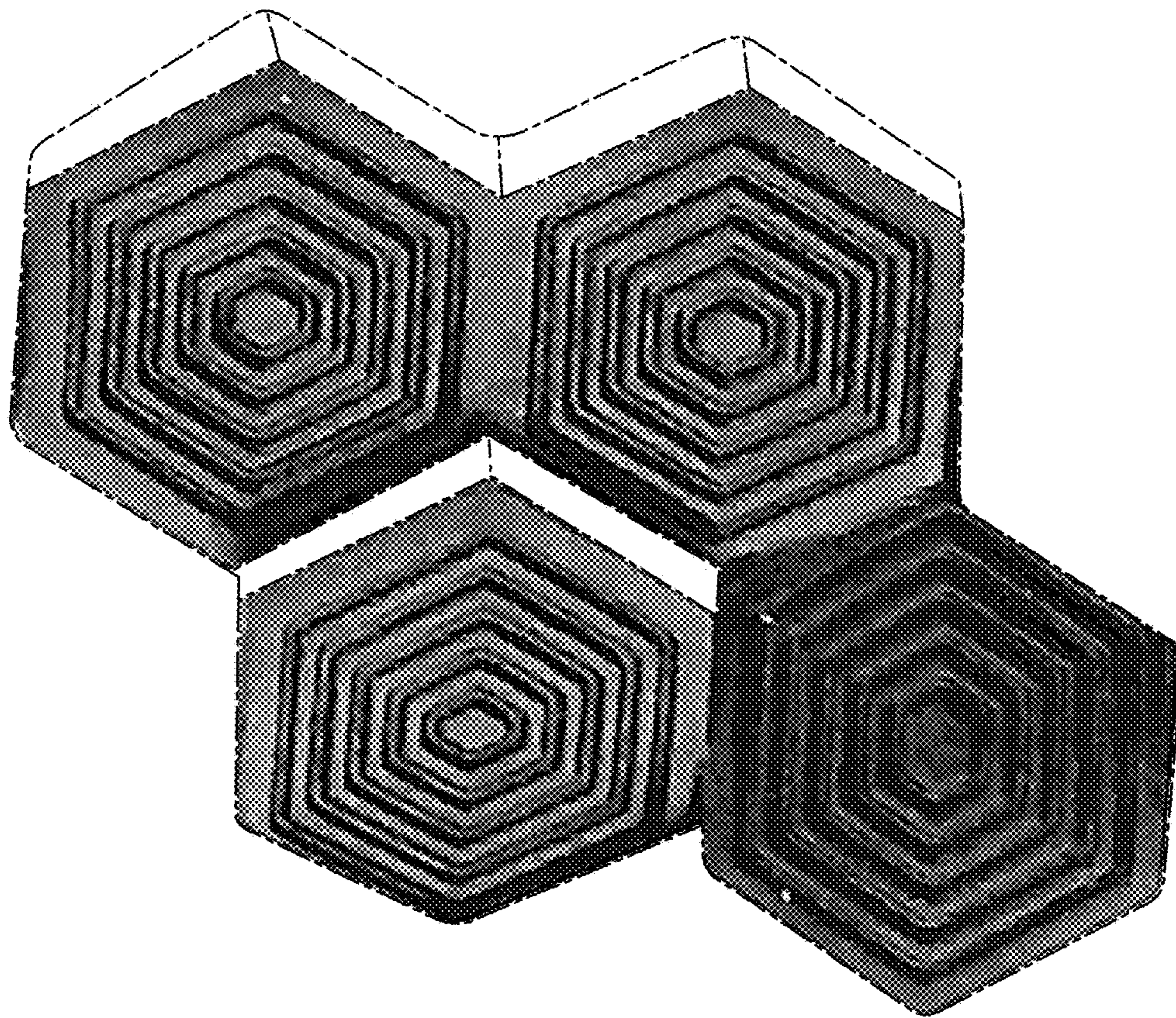

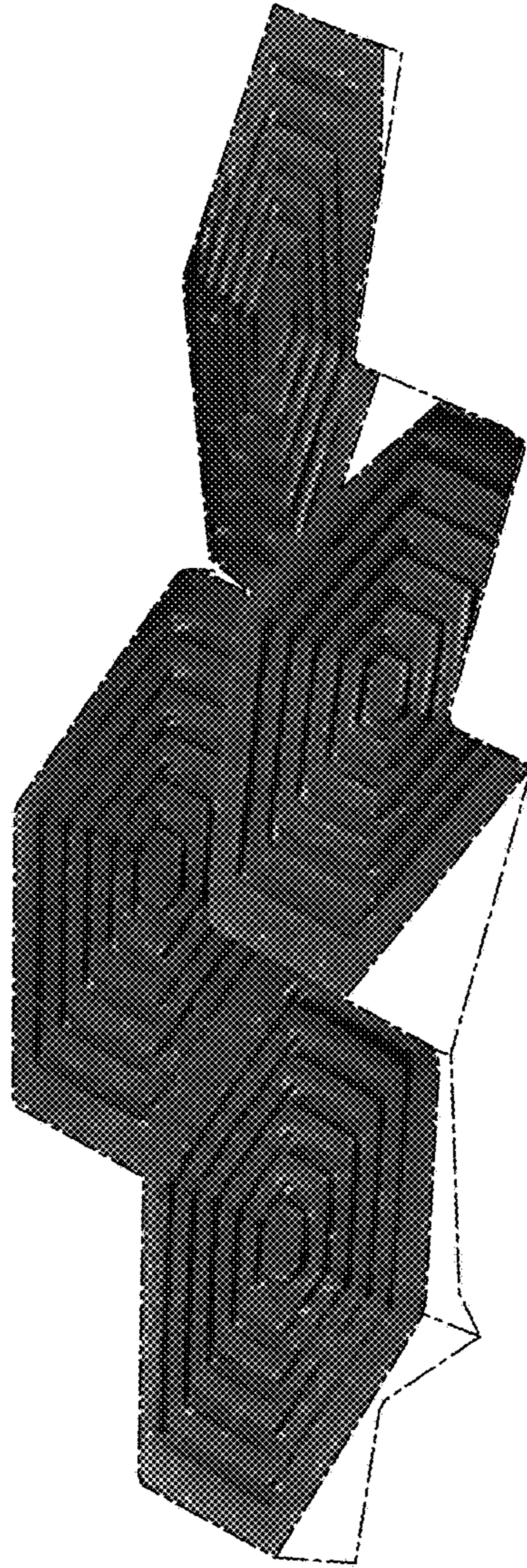
