(57) **CLAIM**

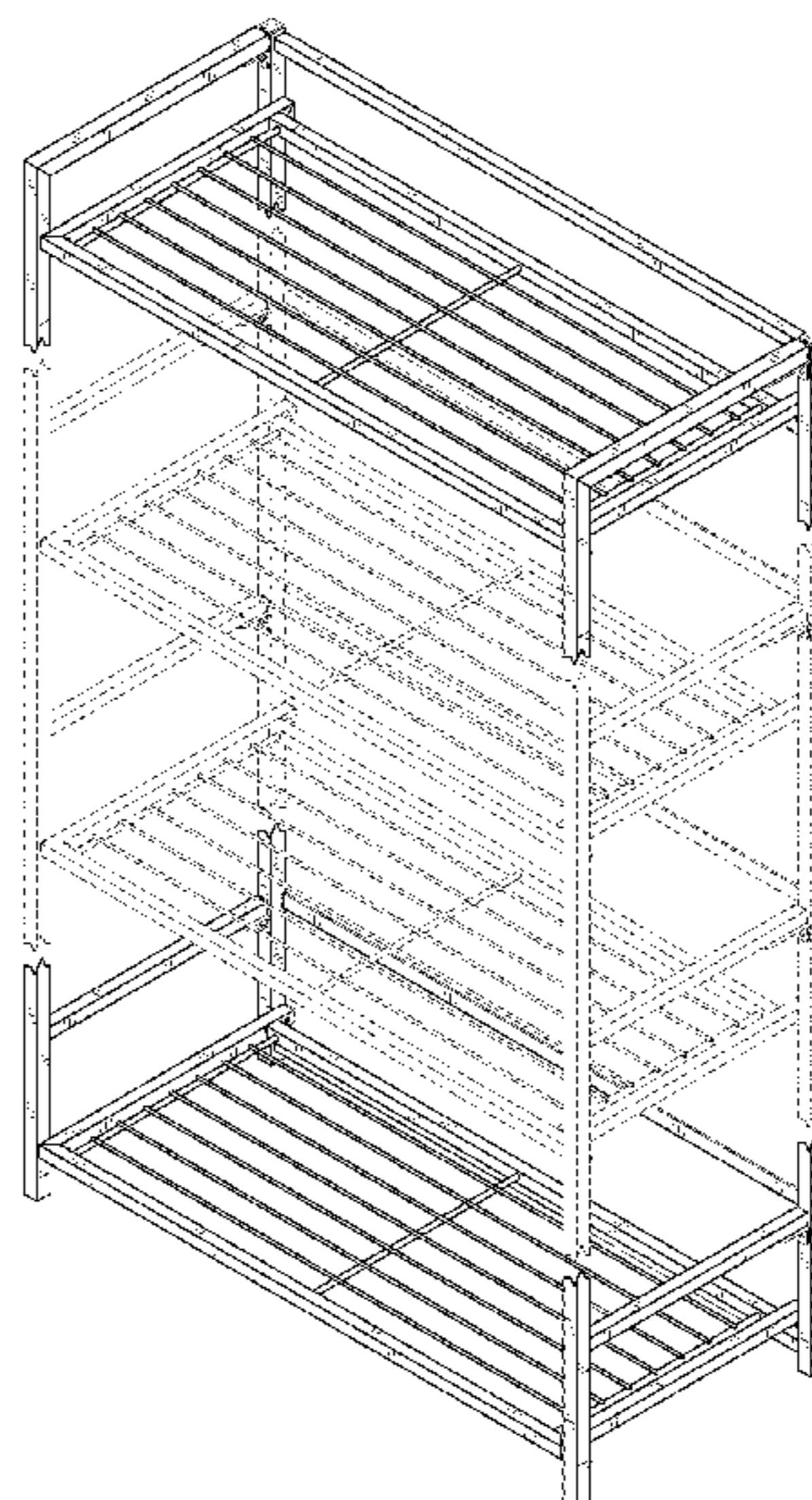
The ornamental design for a shelving unit, as shown and described.

**DESCRIPTION**

FIG. 1 is a front isometric view of a first embodiment of a shelving unit;

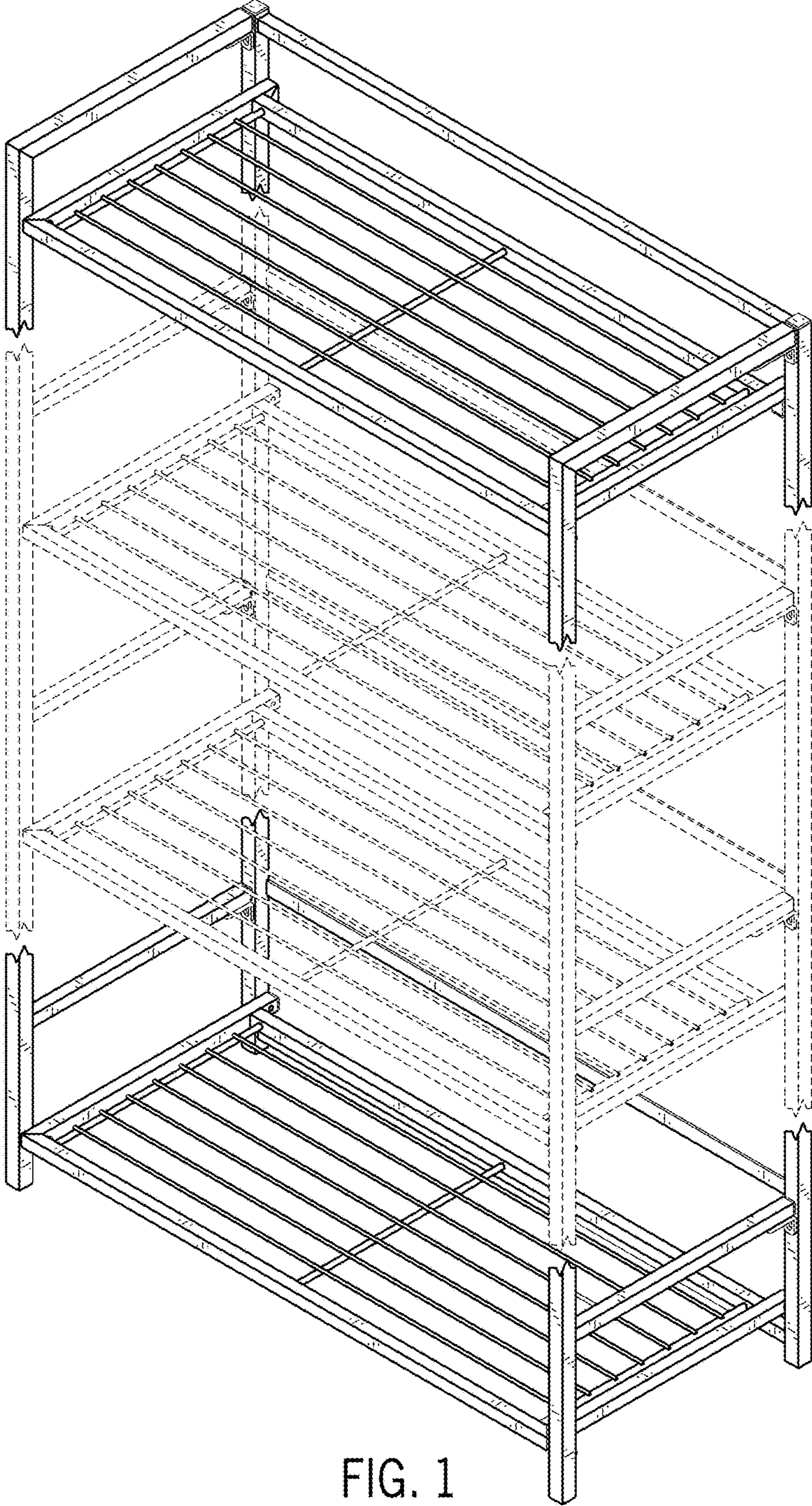

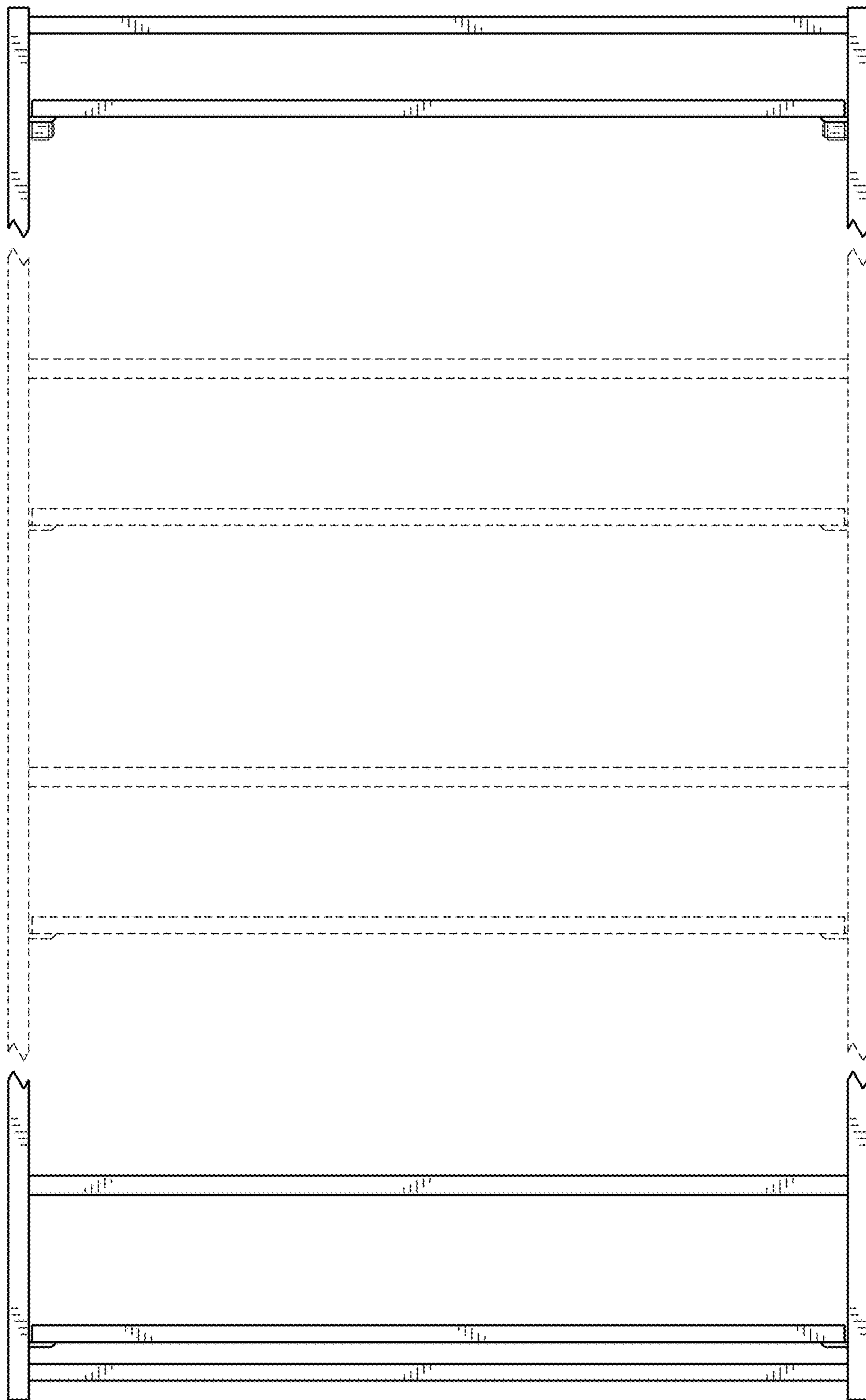

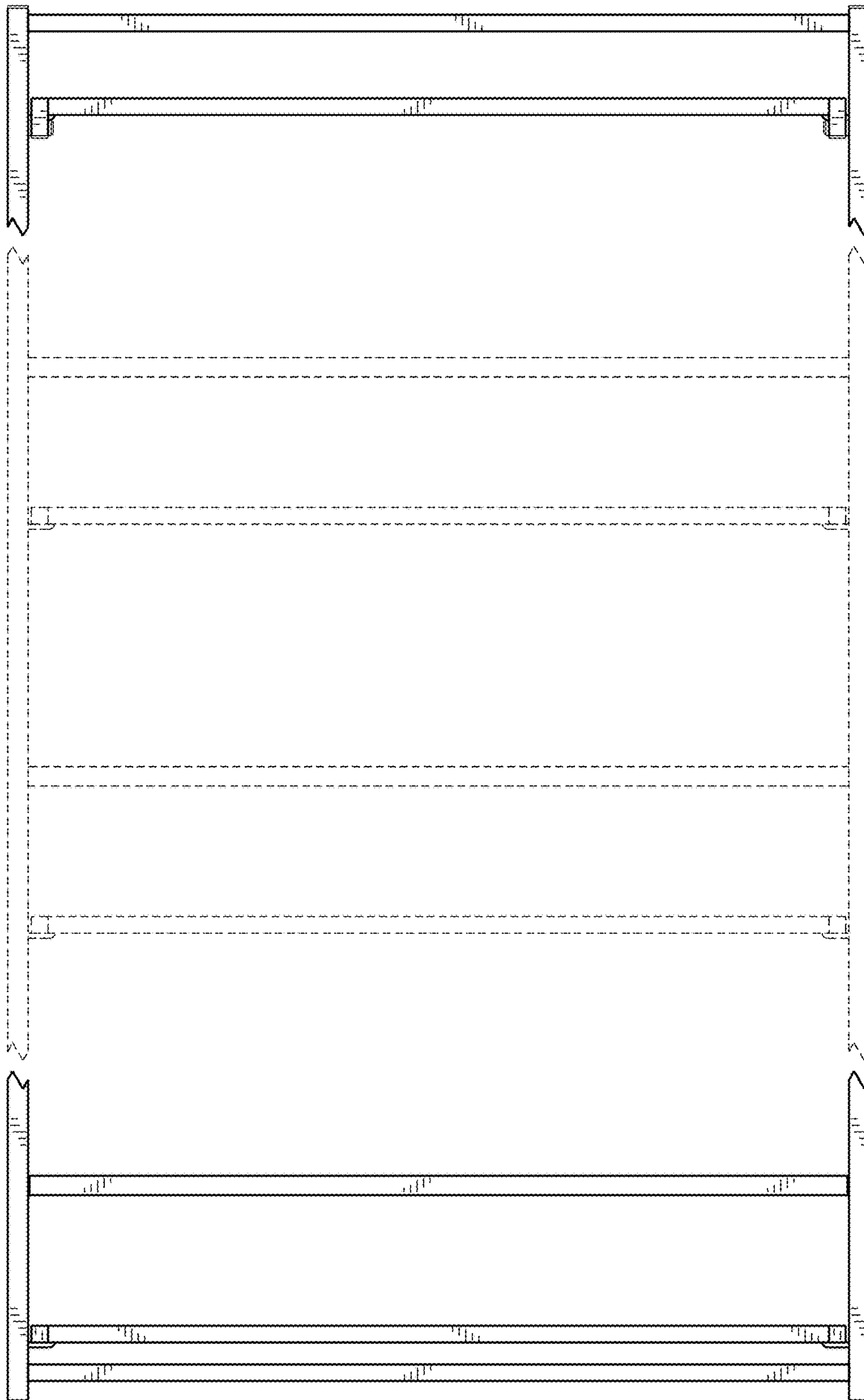

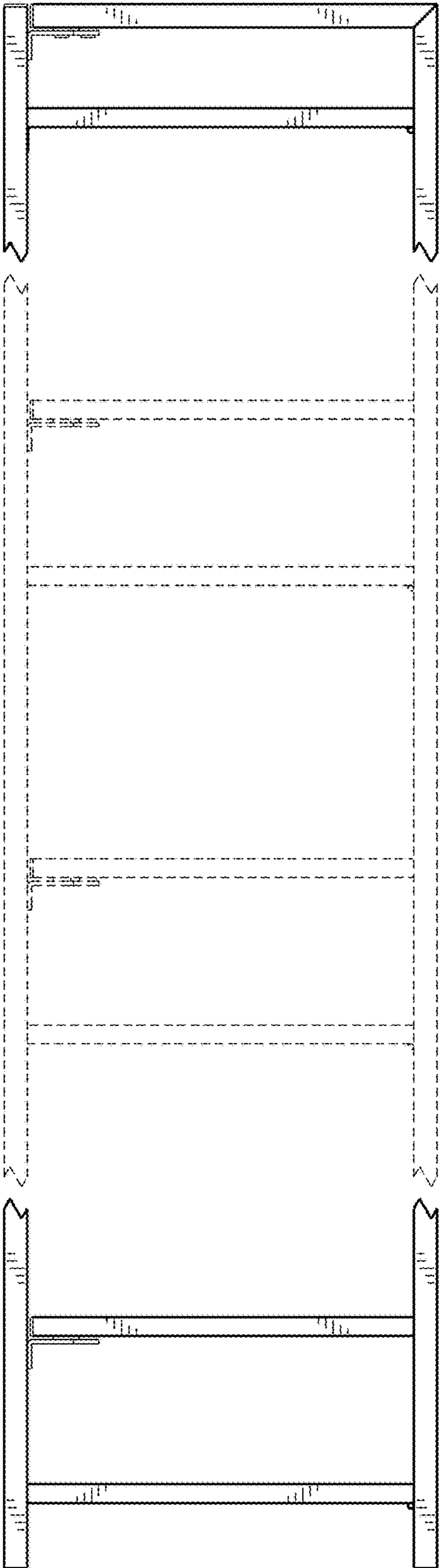

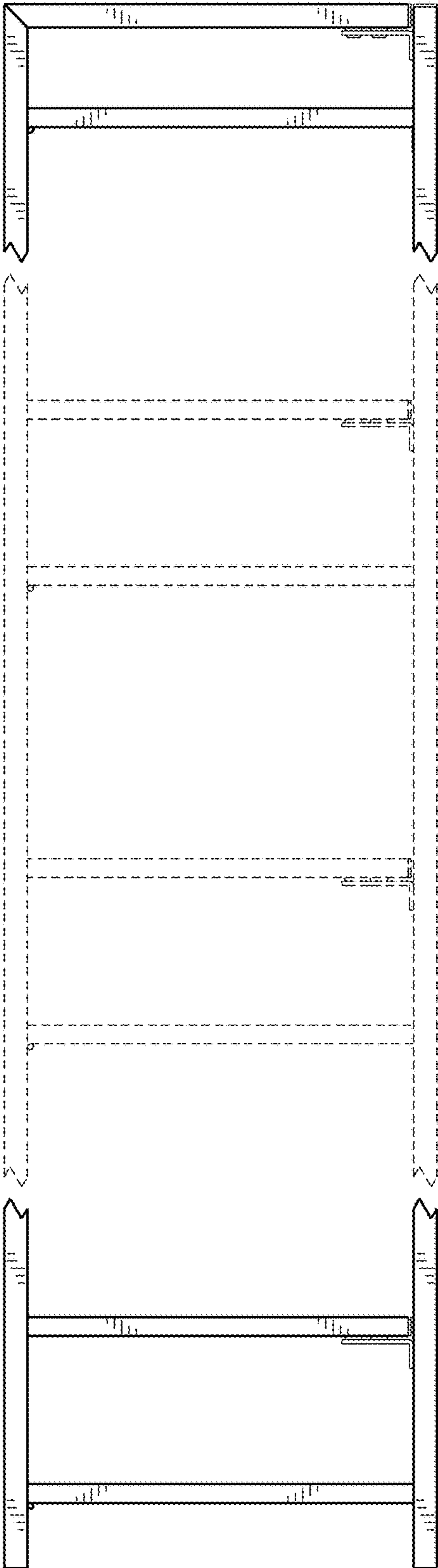

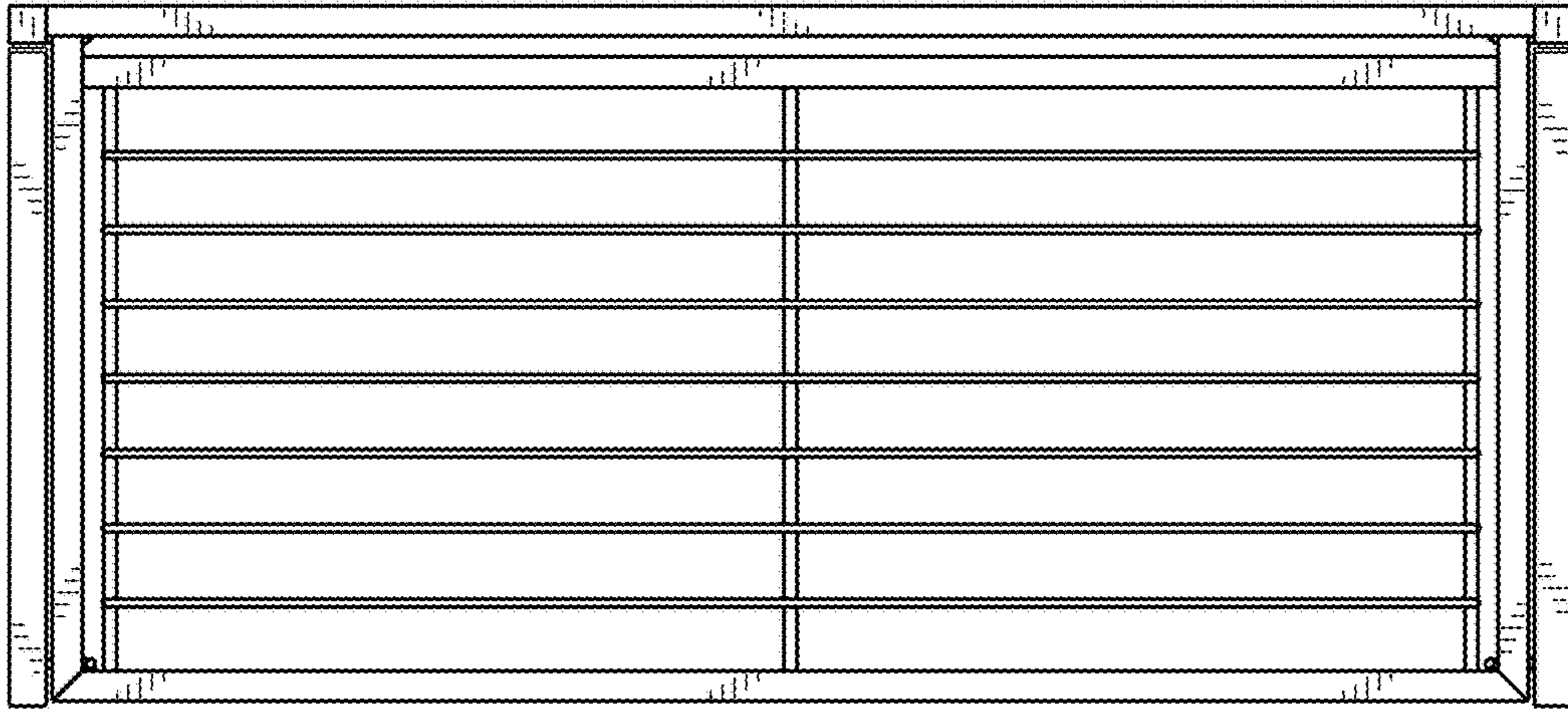

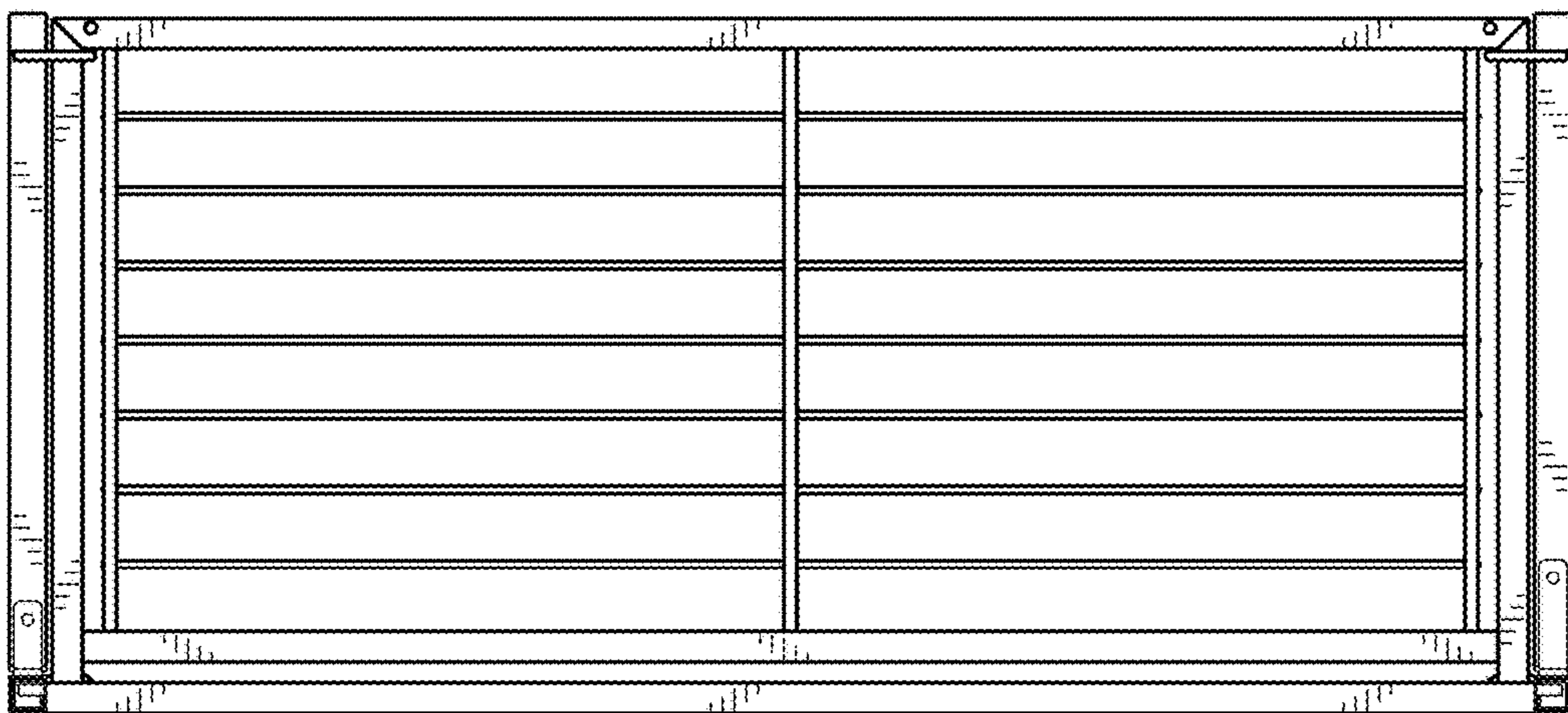

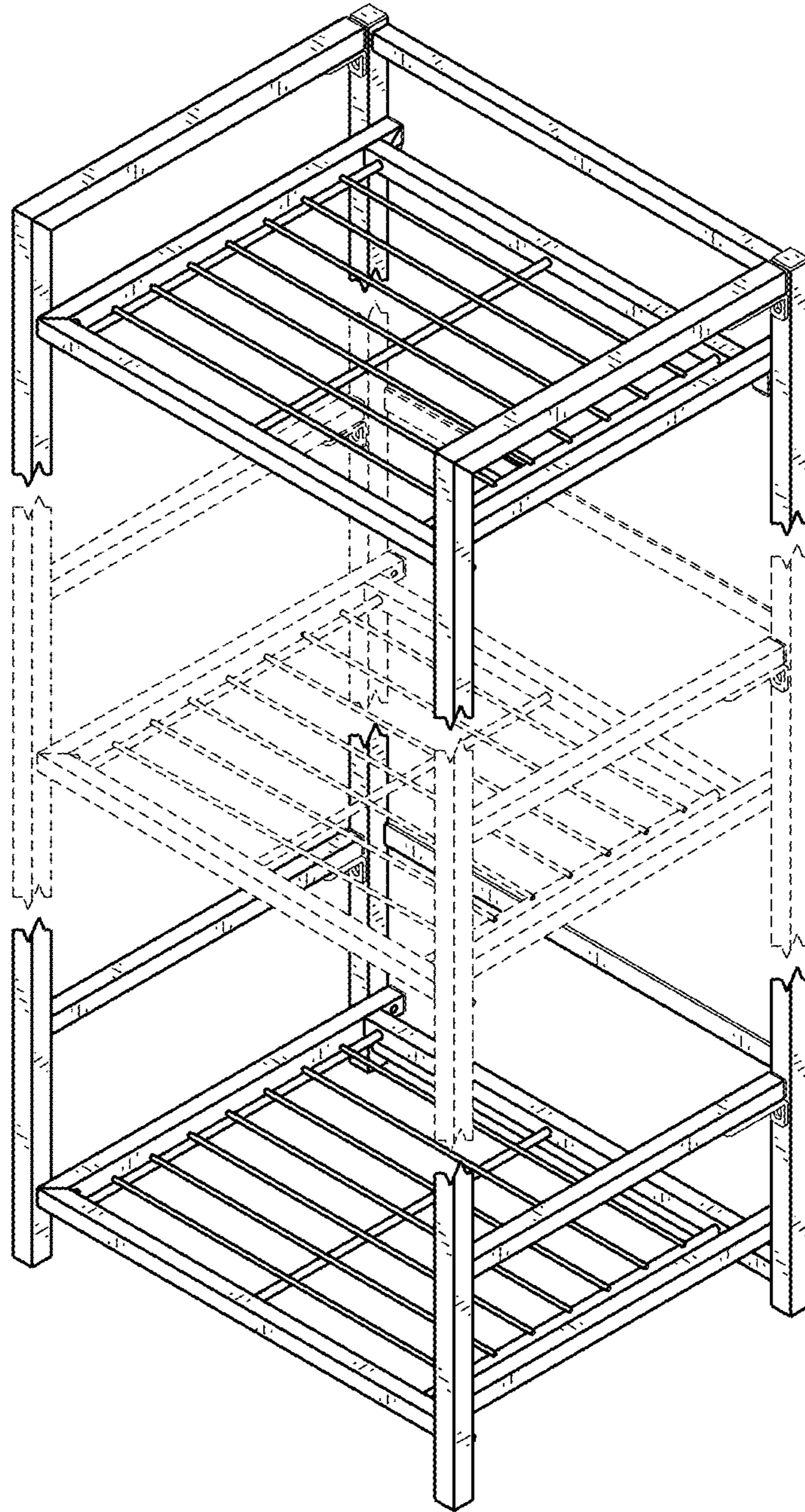

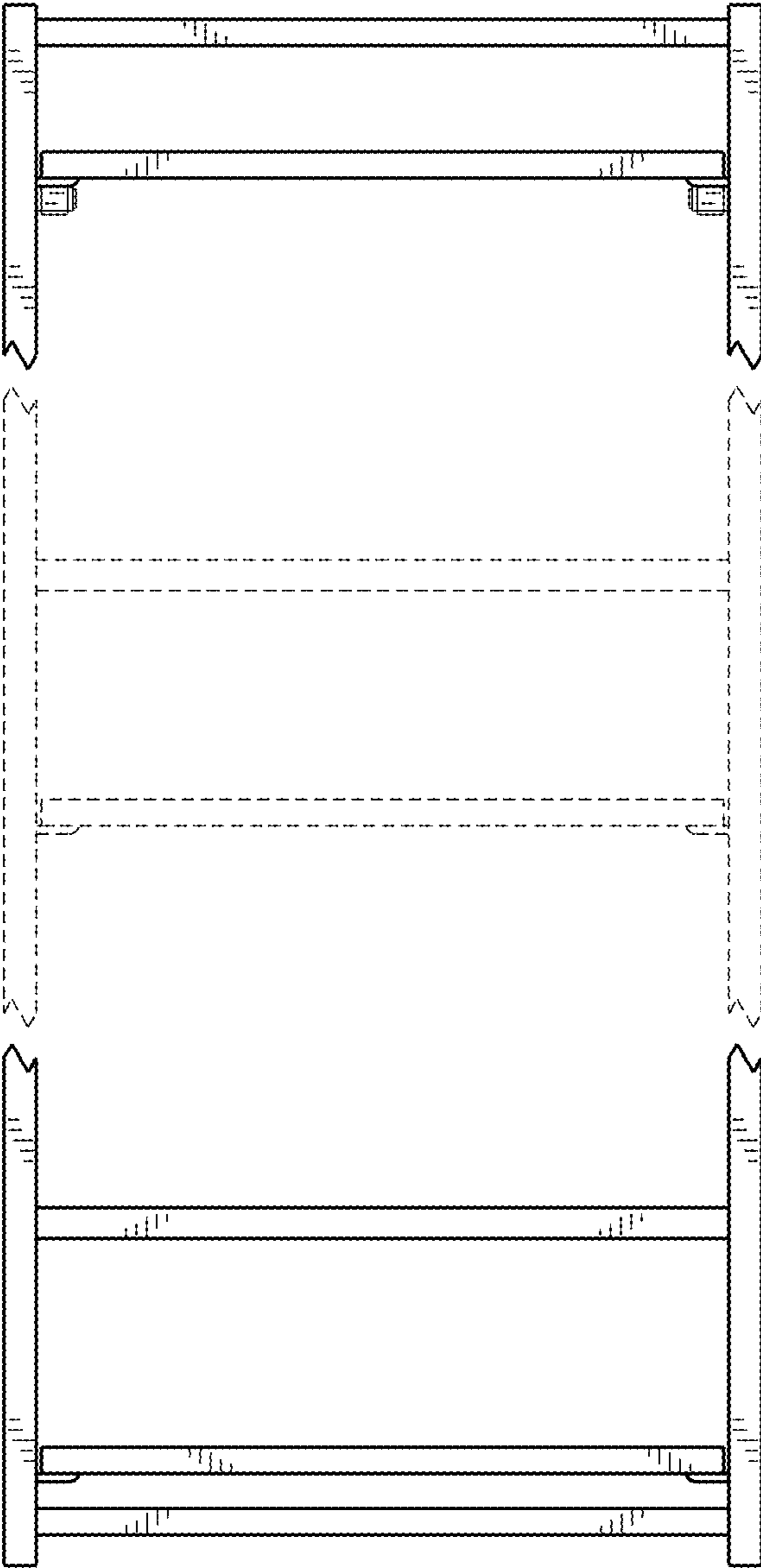

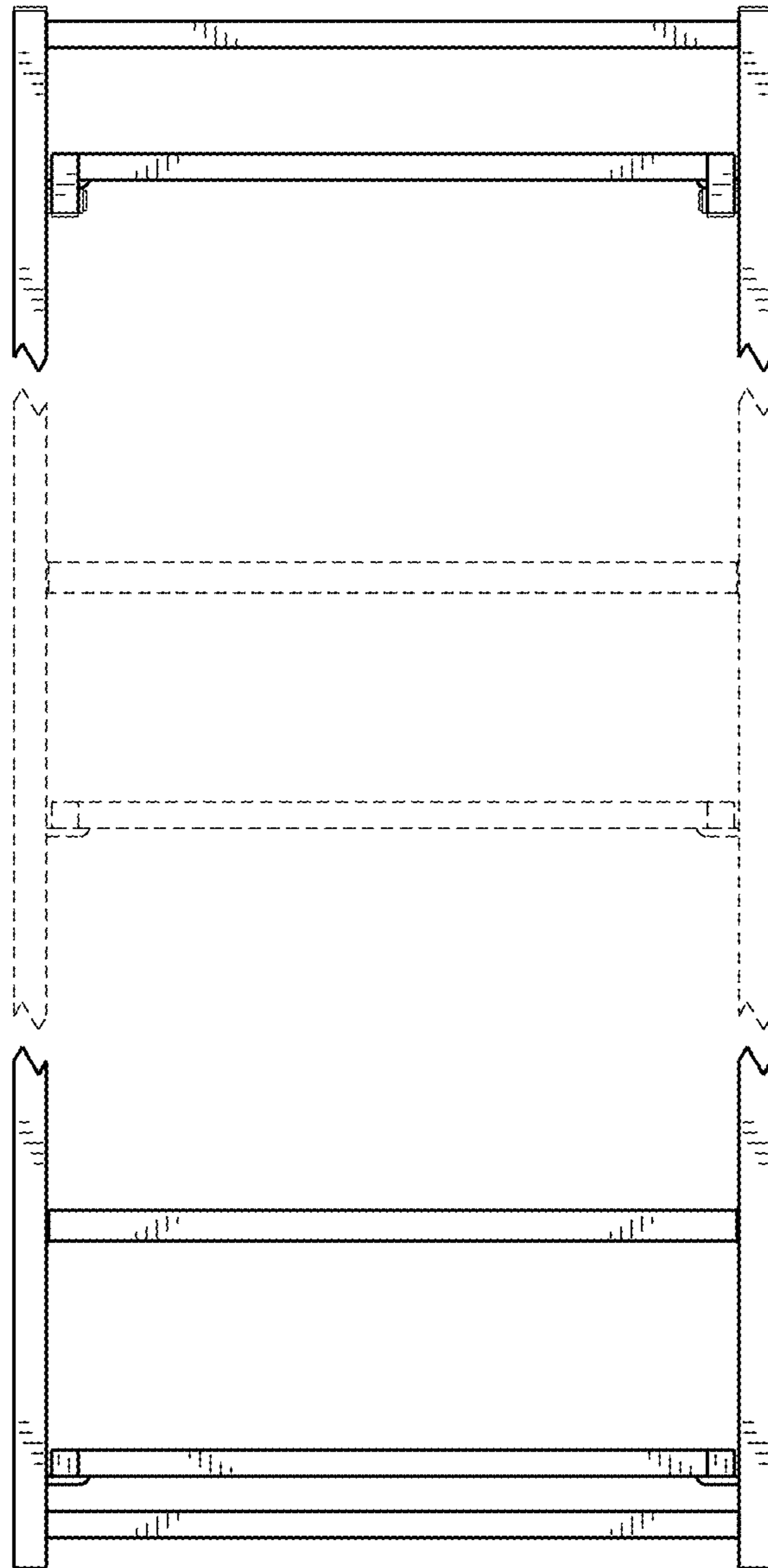

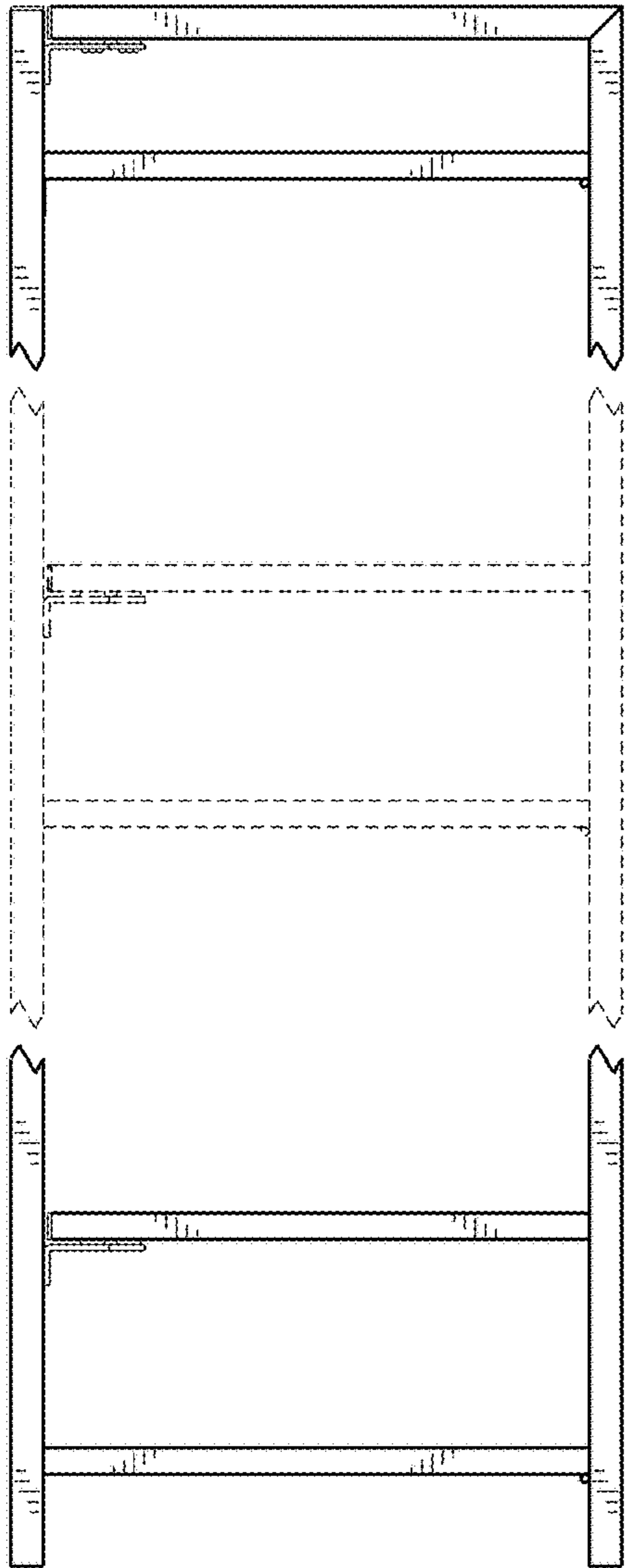

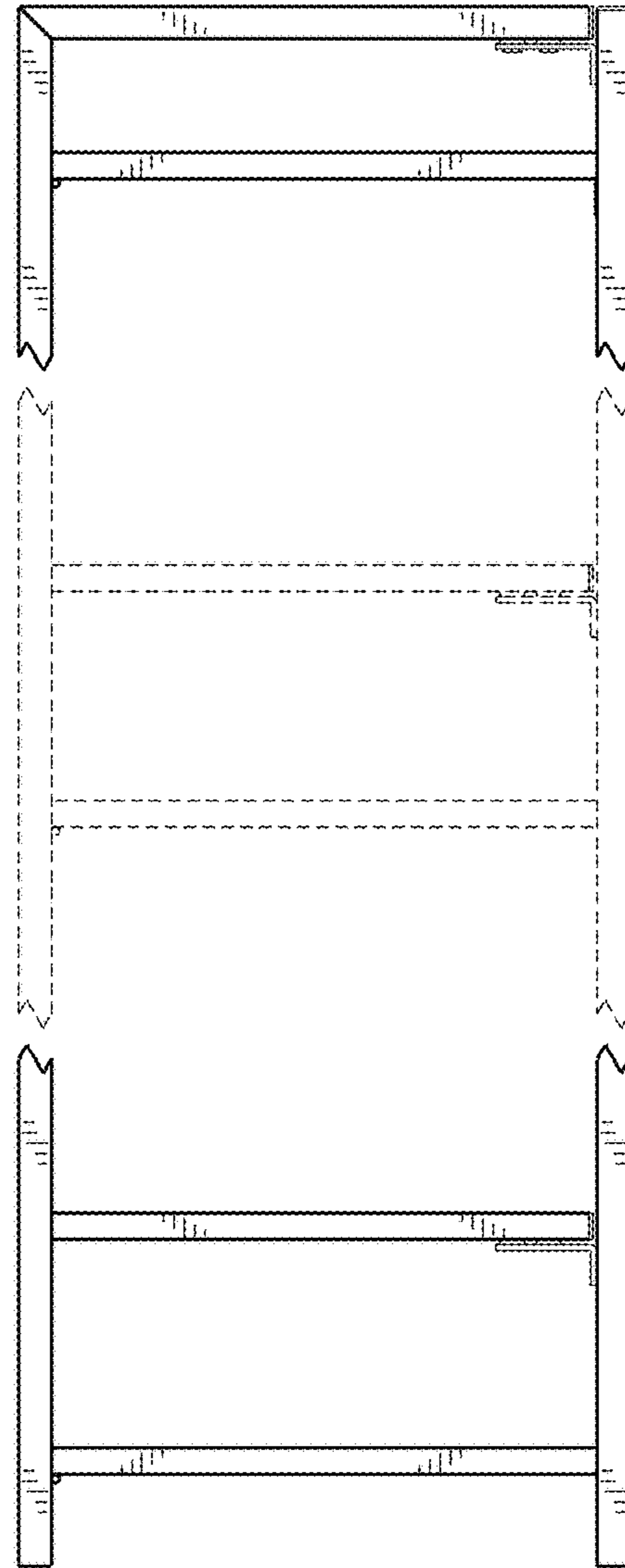

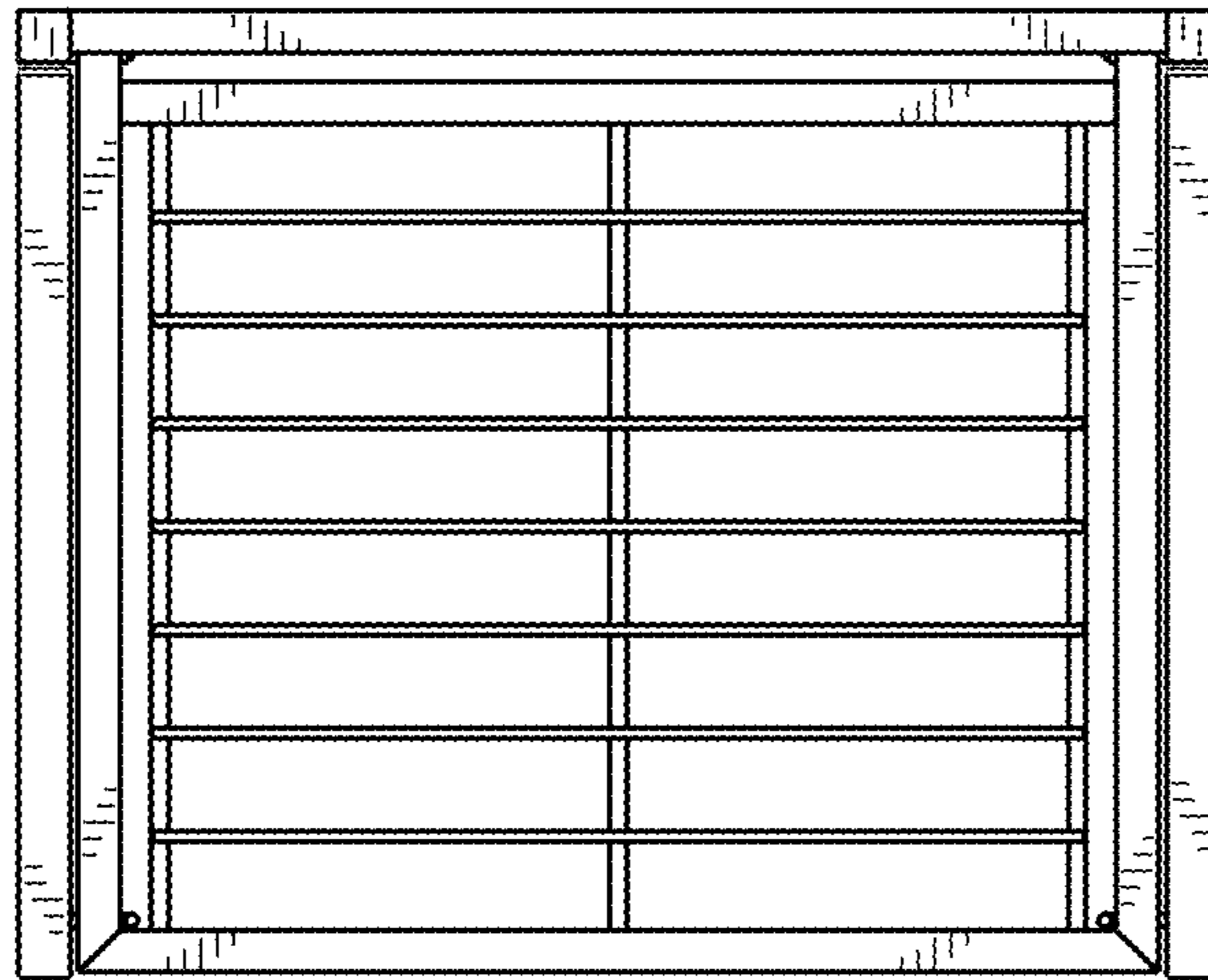

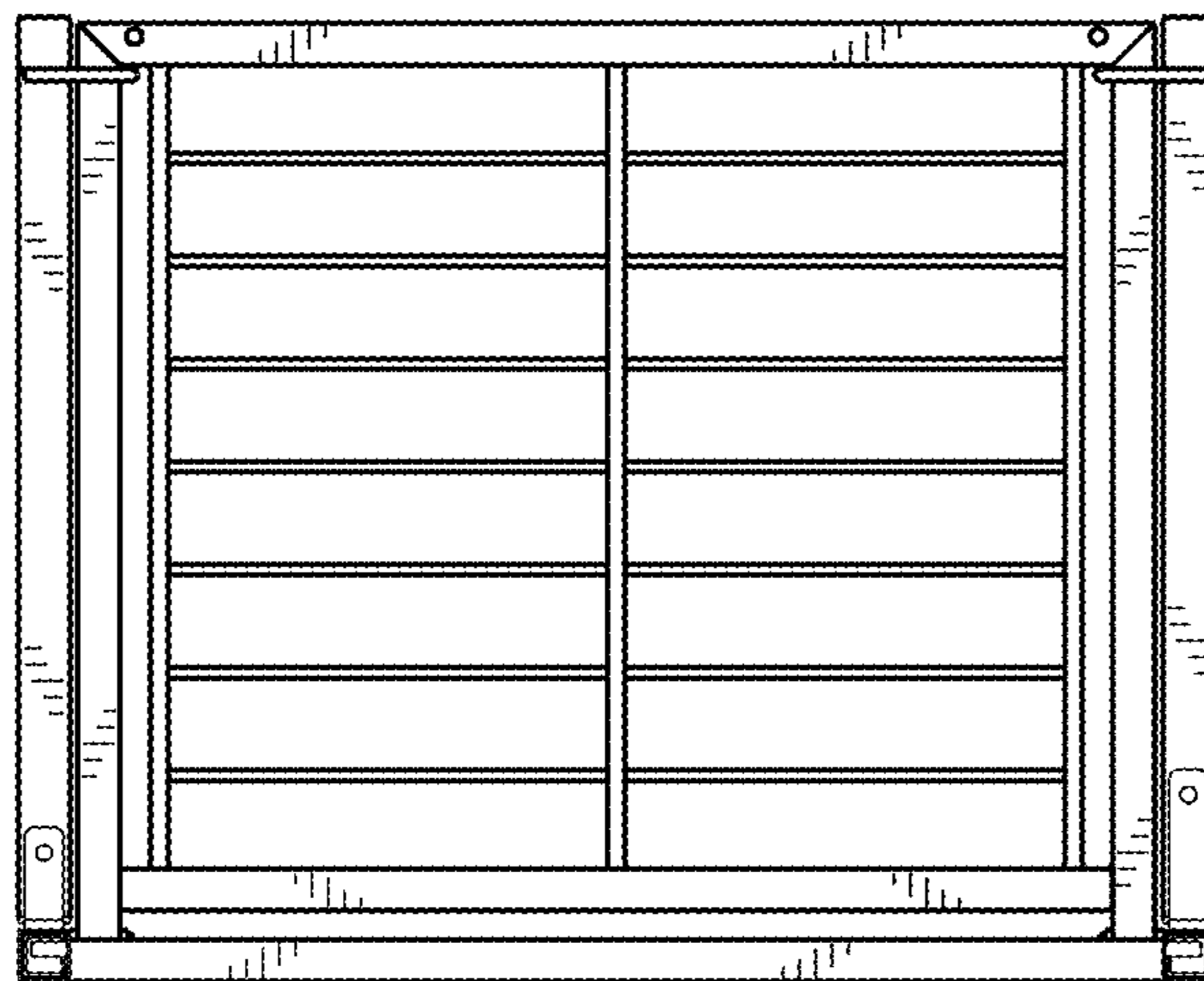
