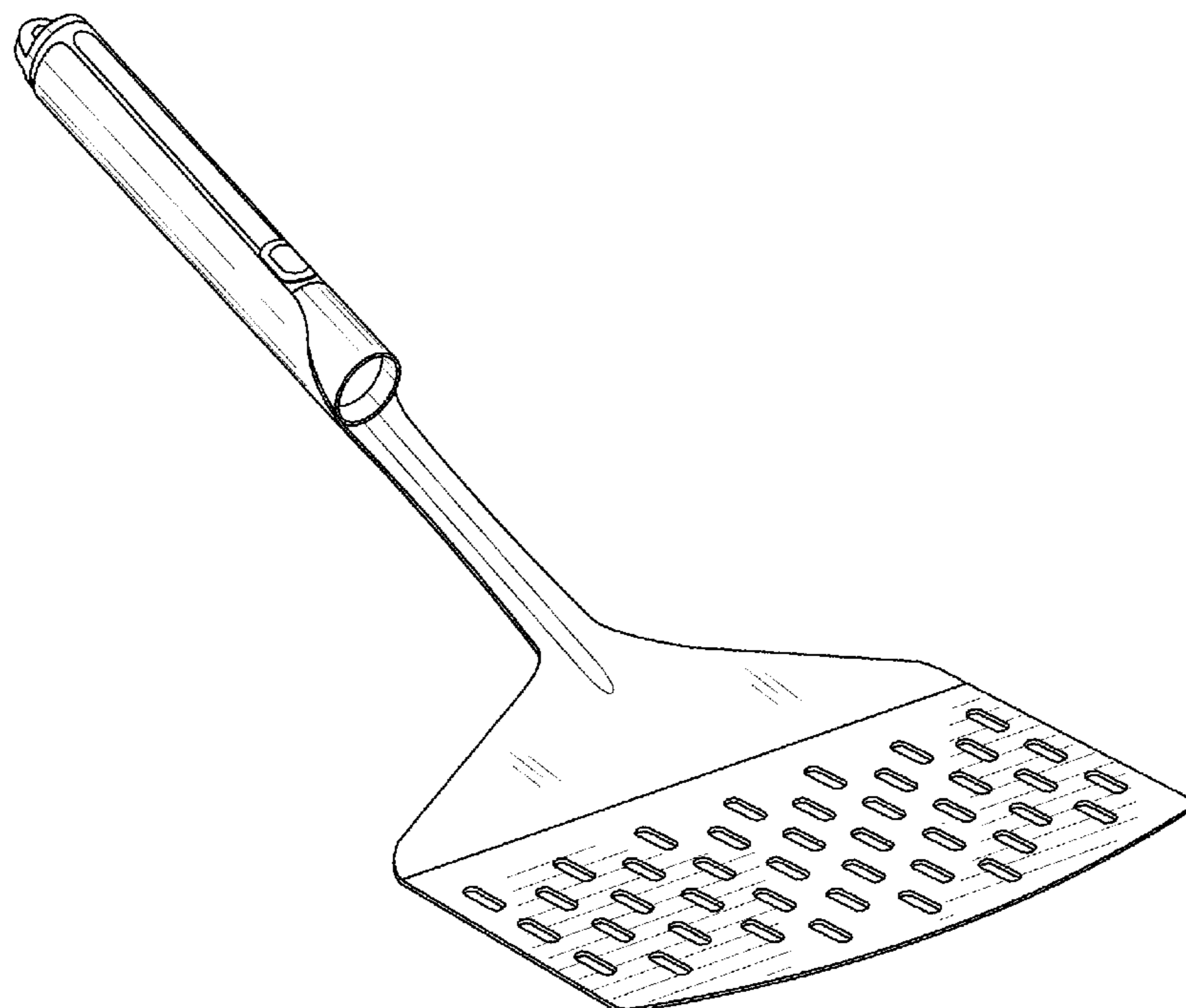
CLAIM

- (57) An ornamental design for a spatula, as shown and described.

DESCRIPTION

FIG. 1 is a top, front isometric view of a spatula showing our new design.
 FIGS. 2 and 3 are top and bottom views, respectively, of the embodiment of FIG. 1.

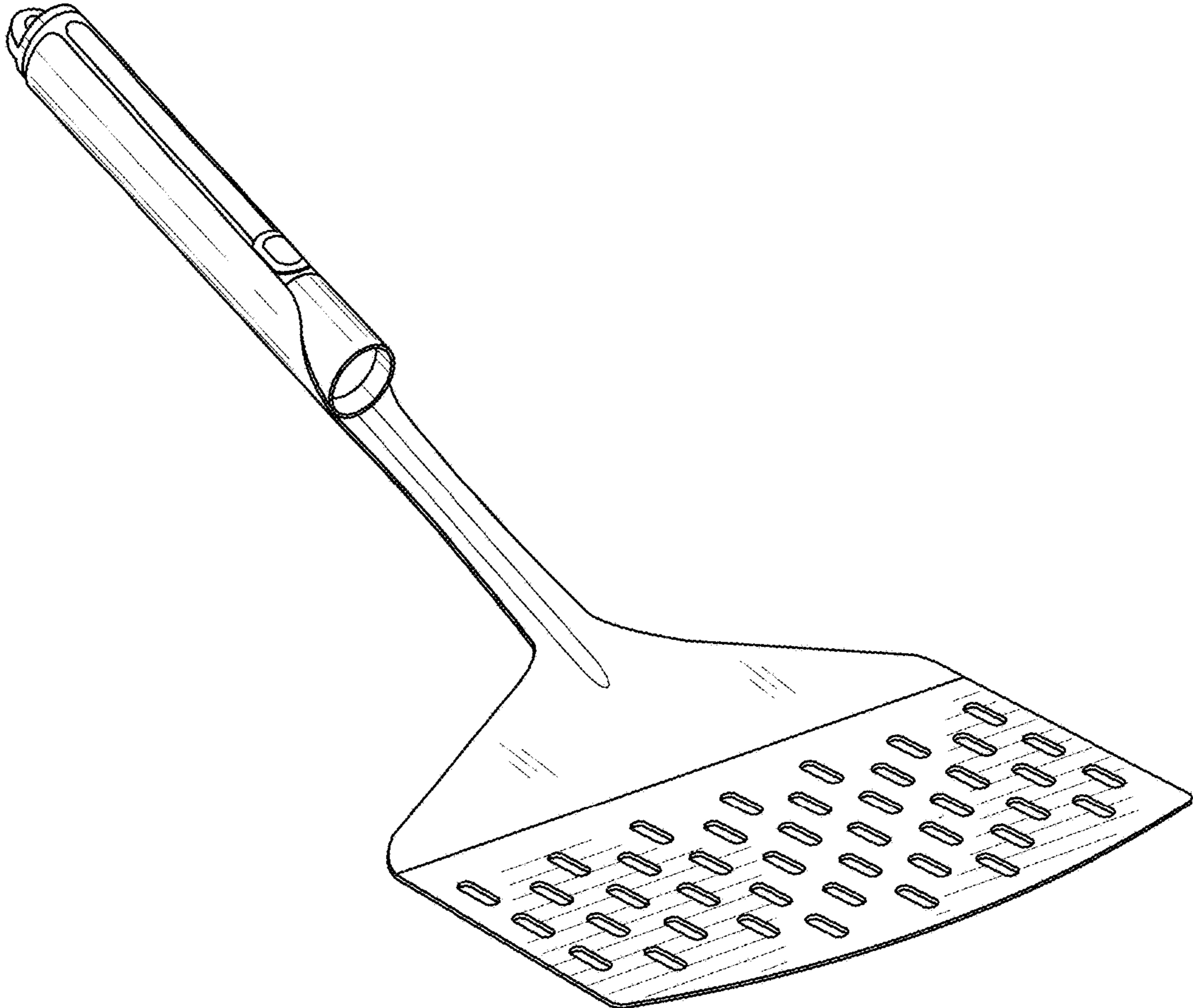

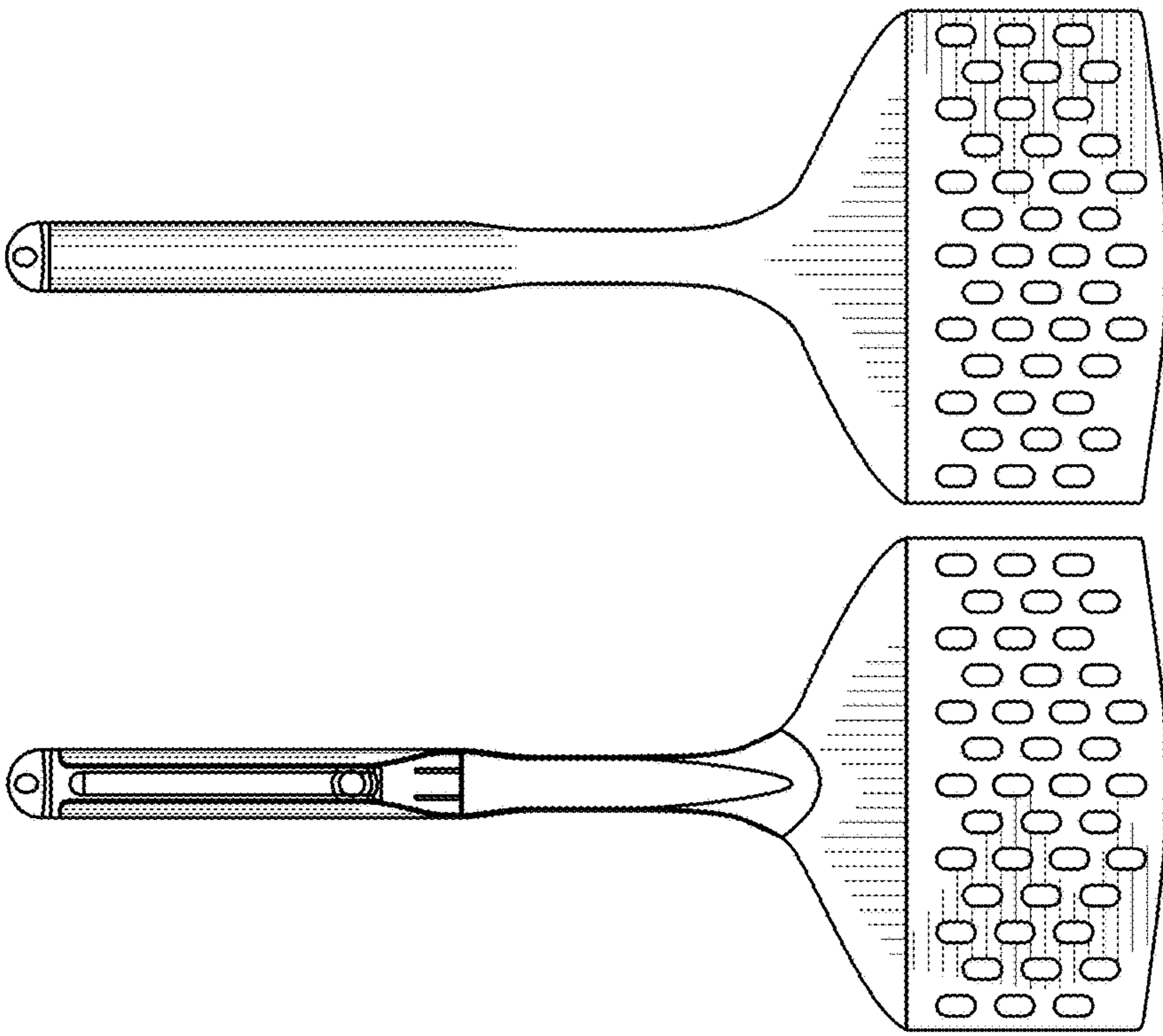

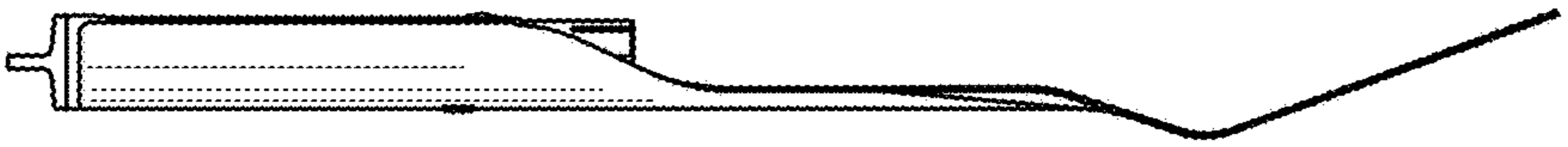

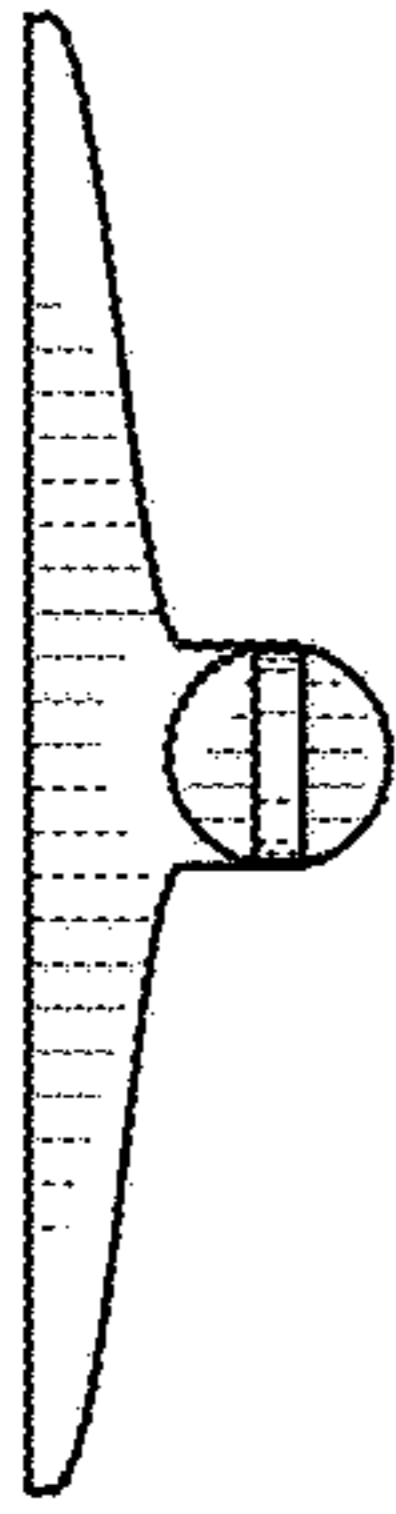

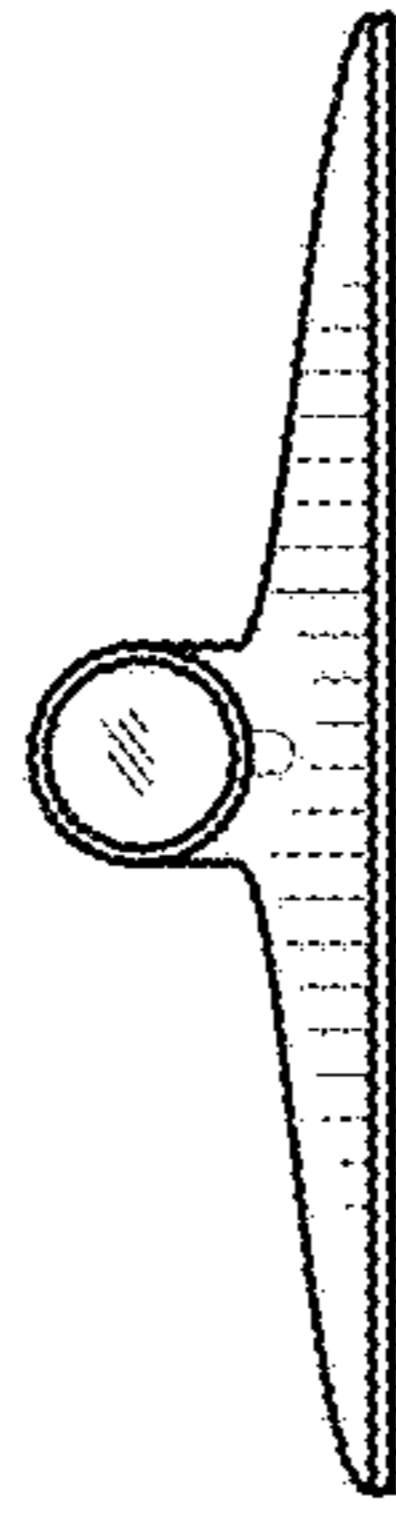
