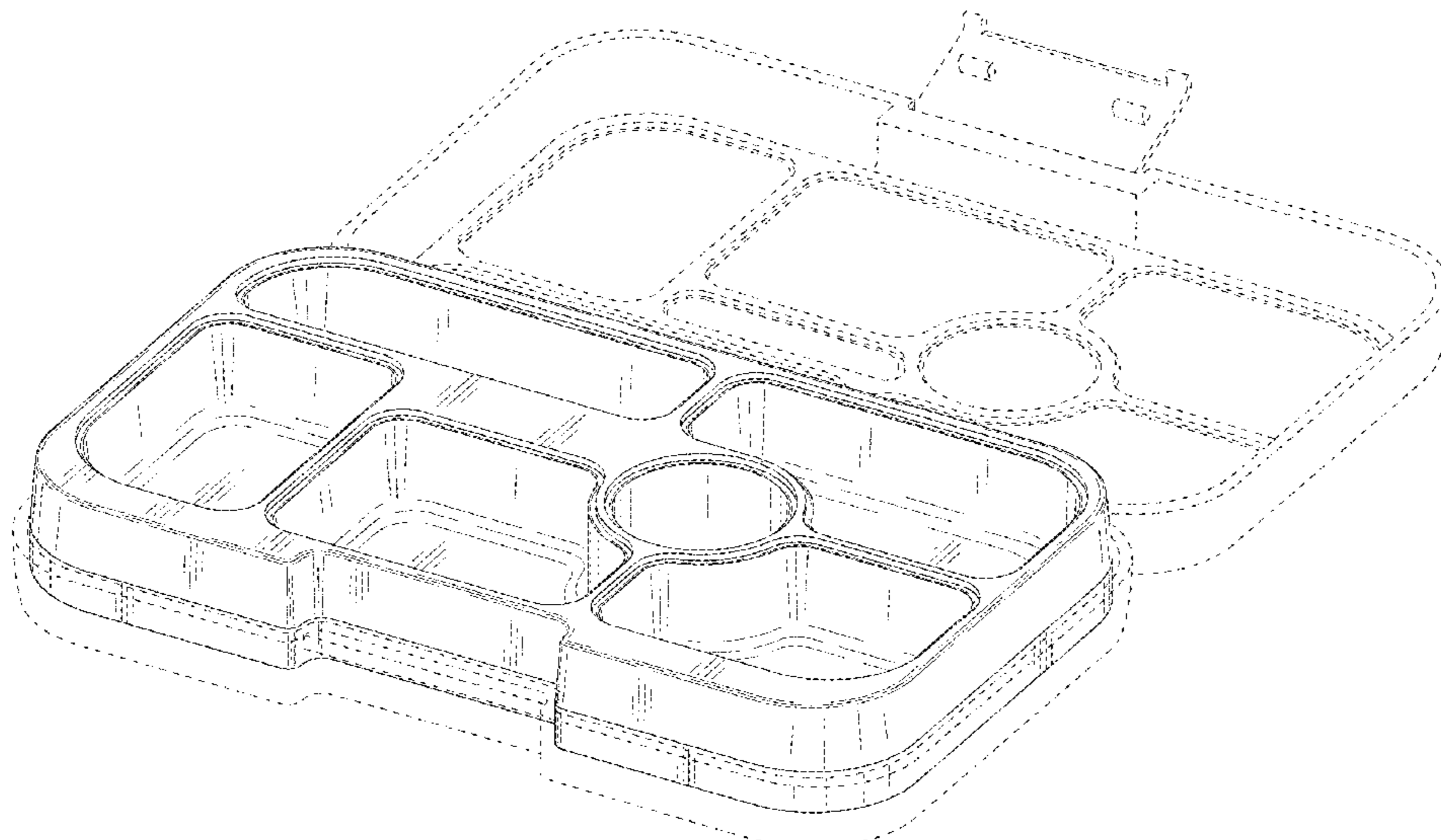
The ornamental design for a food storage box insert, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of the food storage box insert. FIG. 2 is a right side view of the food storage box insert. FIG. 3 is a left side view of the food storage box insert. FIG. 4 is a front view of the food storage box insert. FIG. 5 is a back view of the food storage box insert. FIG. 6 is a top view of the food storage box insert. FIG. 7 is bottom view of the food storage box insert. FIG. 8 is a perspective view illustrating an exemplary food storage box for use with the food storage box insert; and, FIG. 9 is a perspective view of a bottom of the food storage box insert.

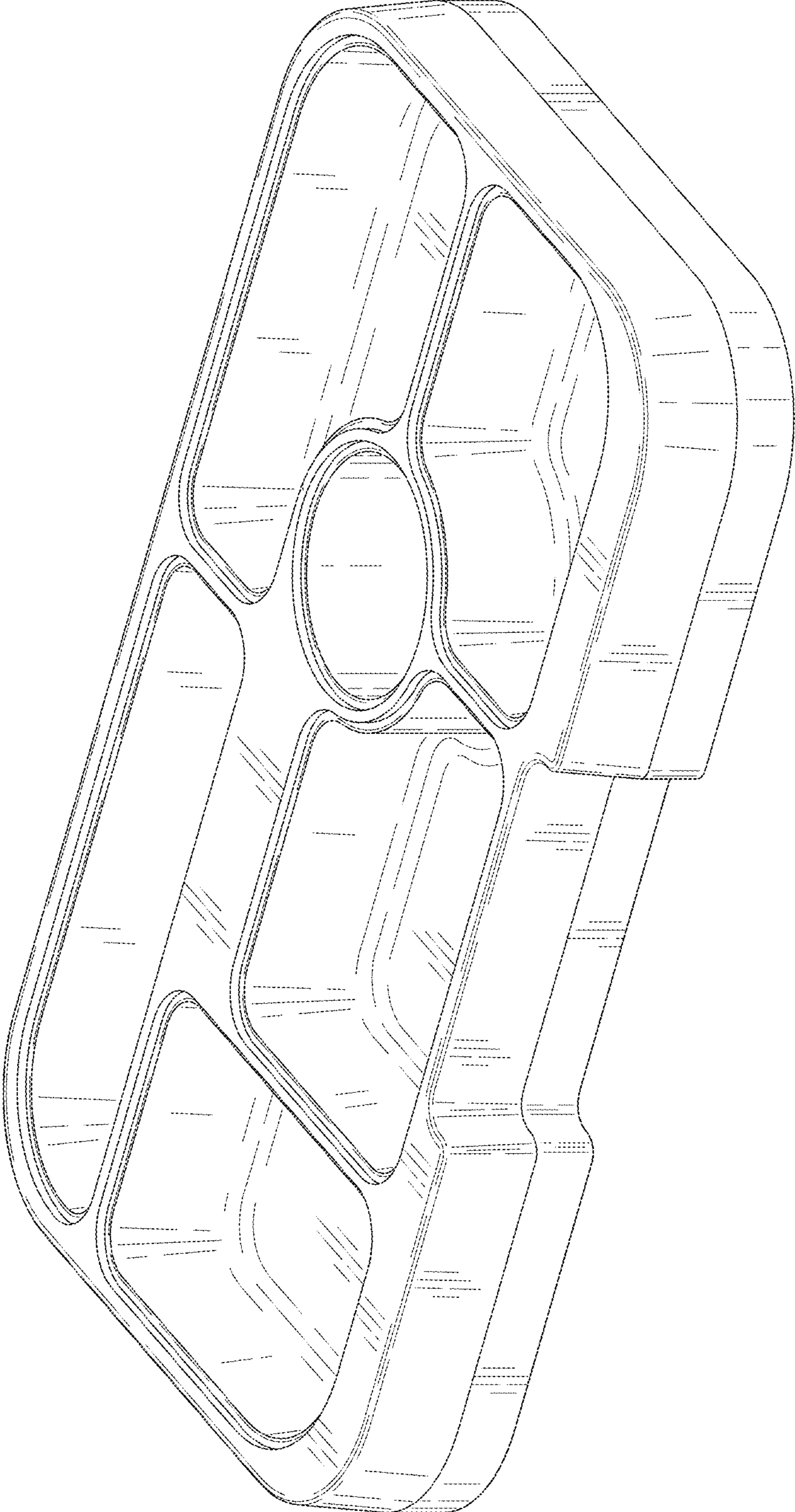

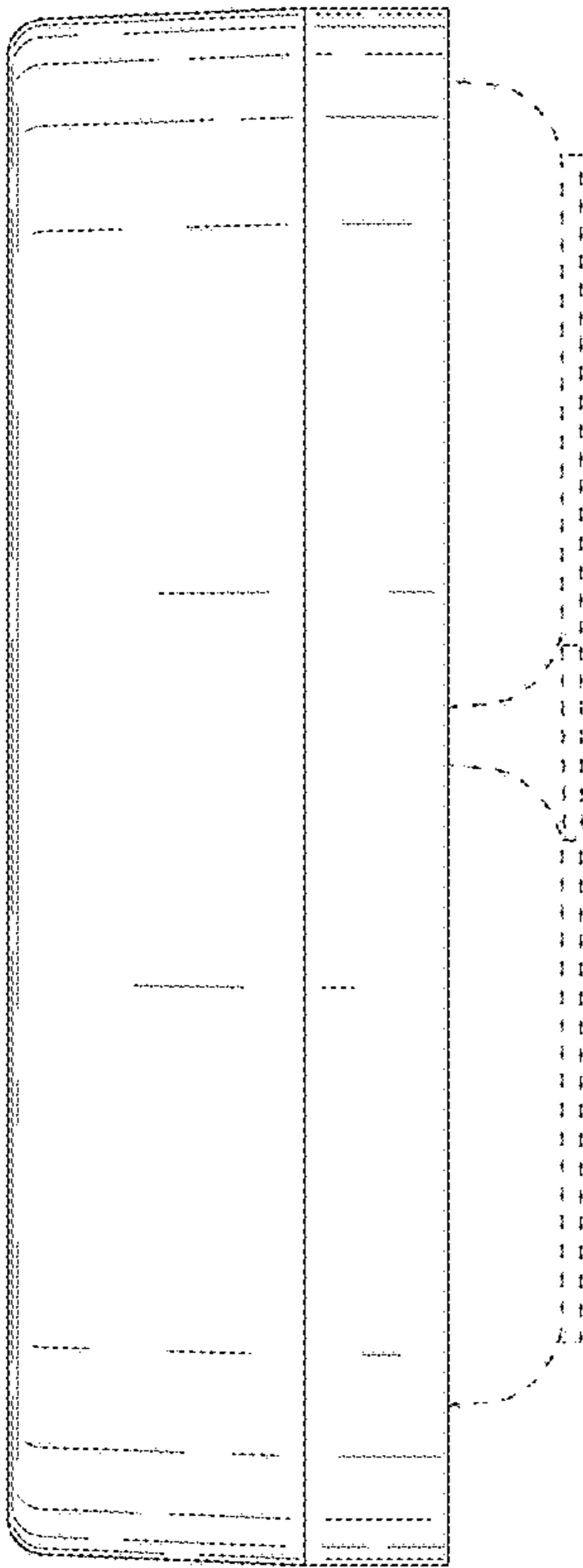
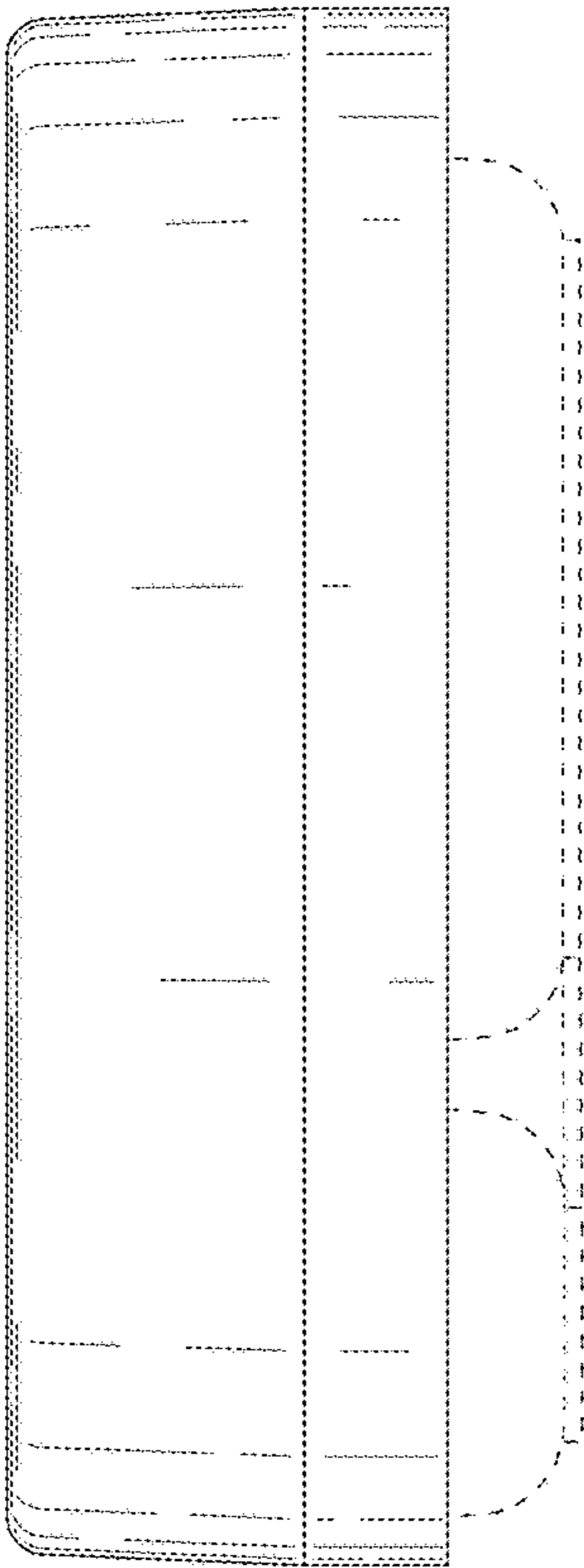
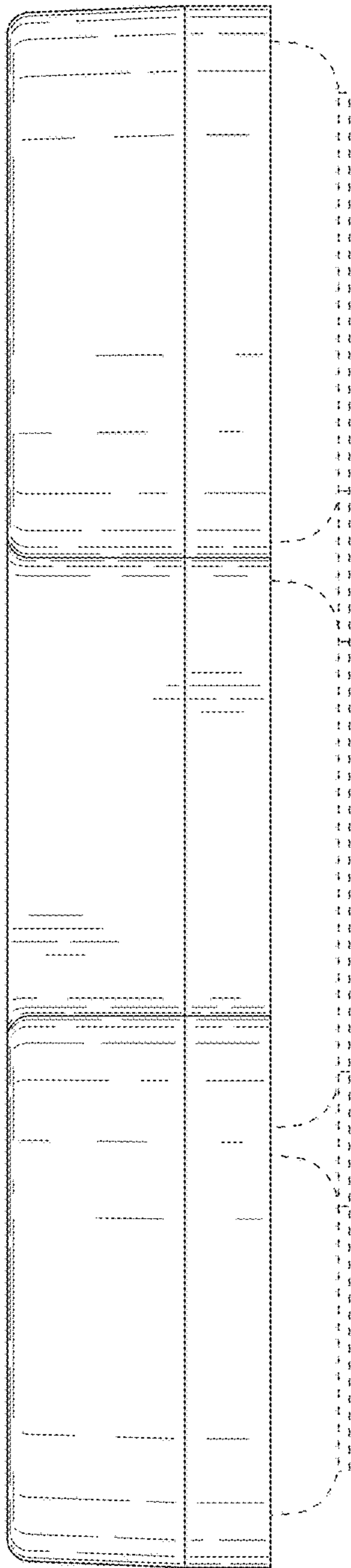


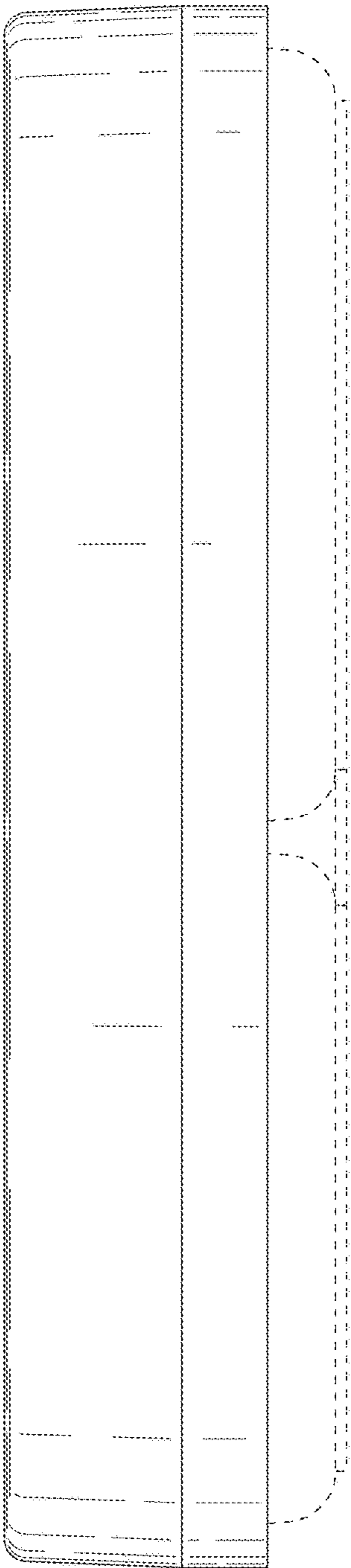

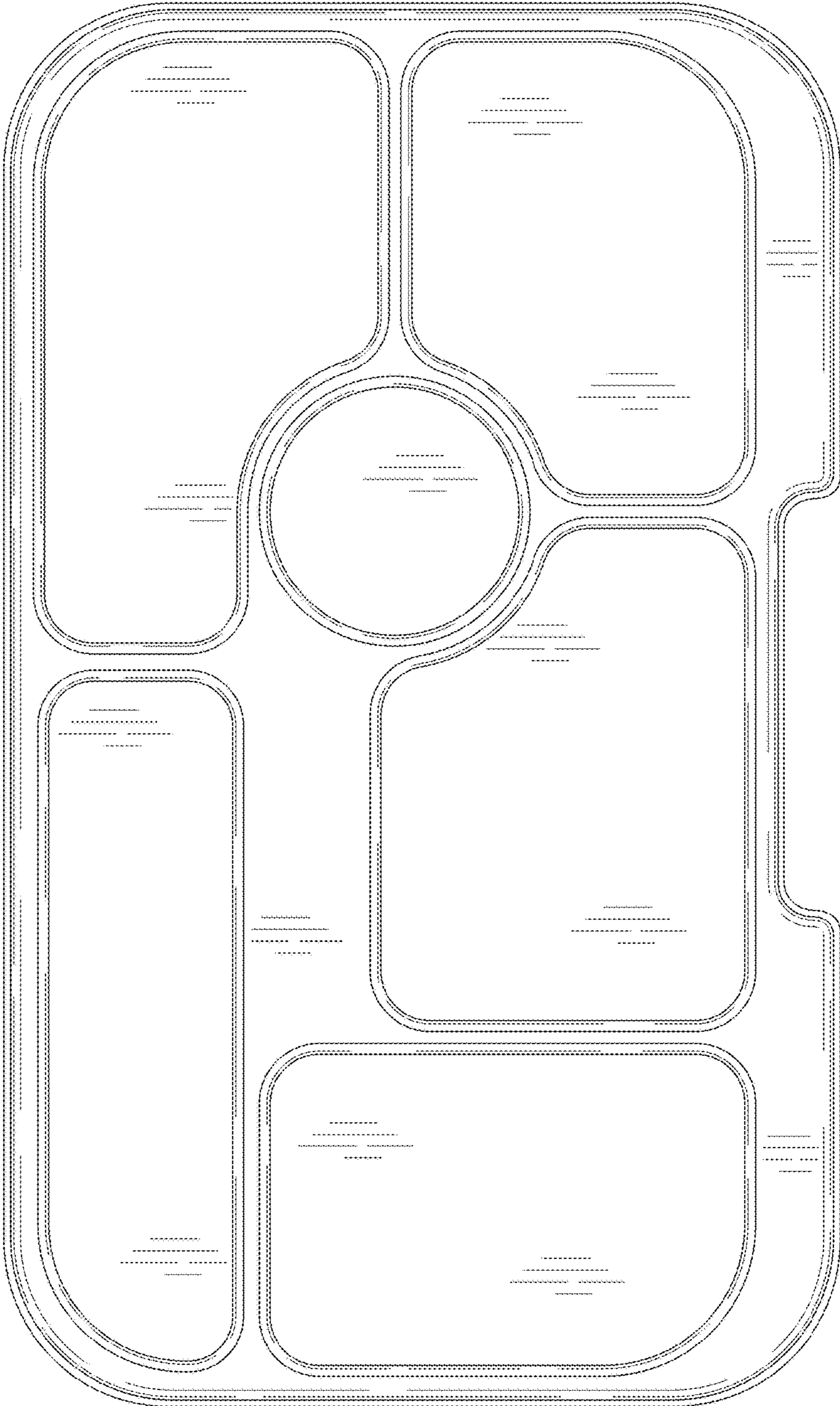

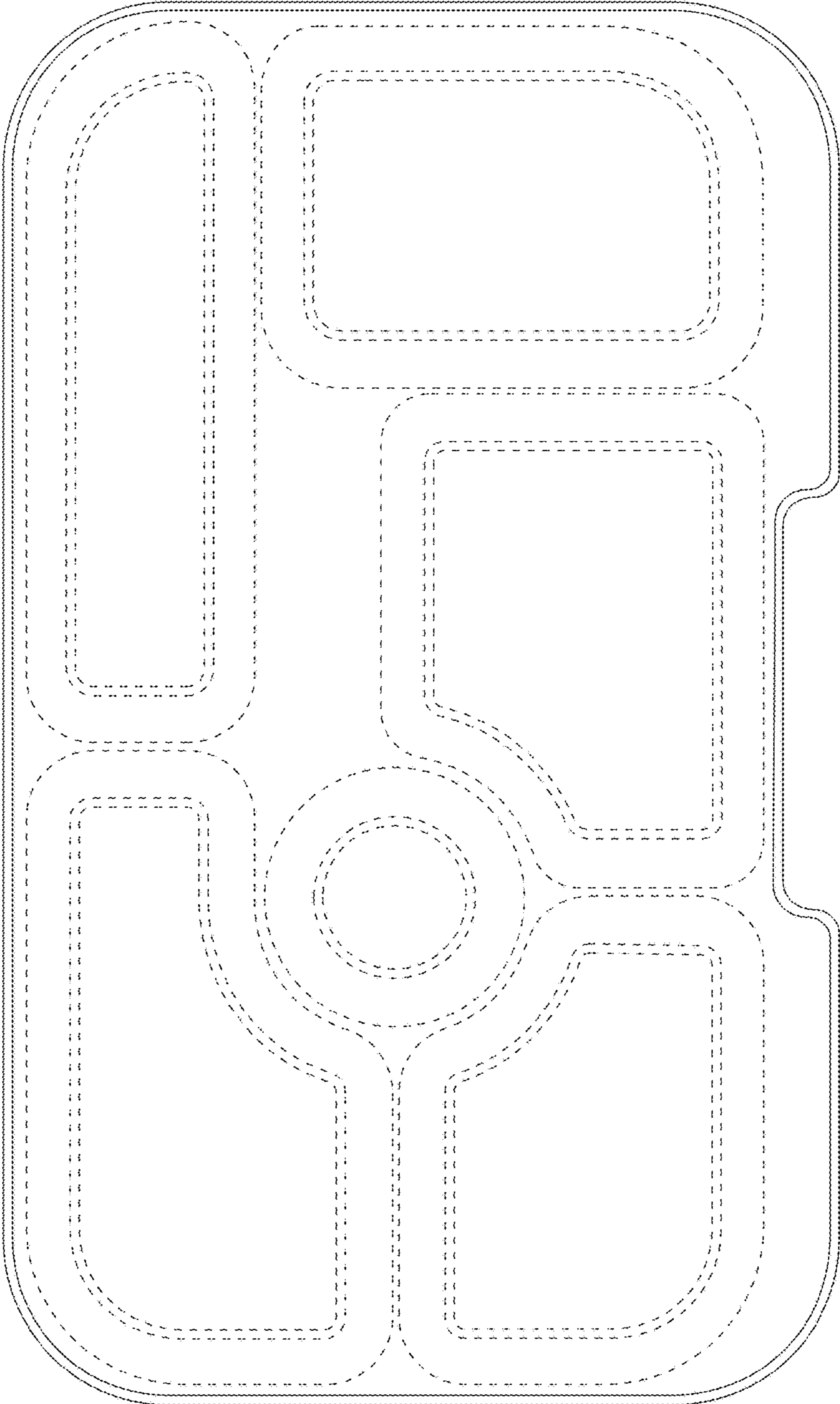
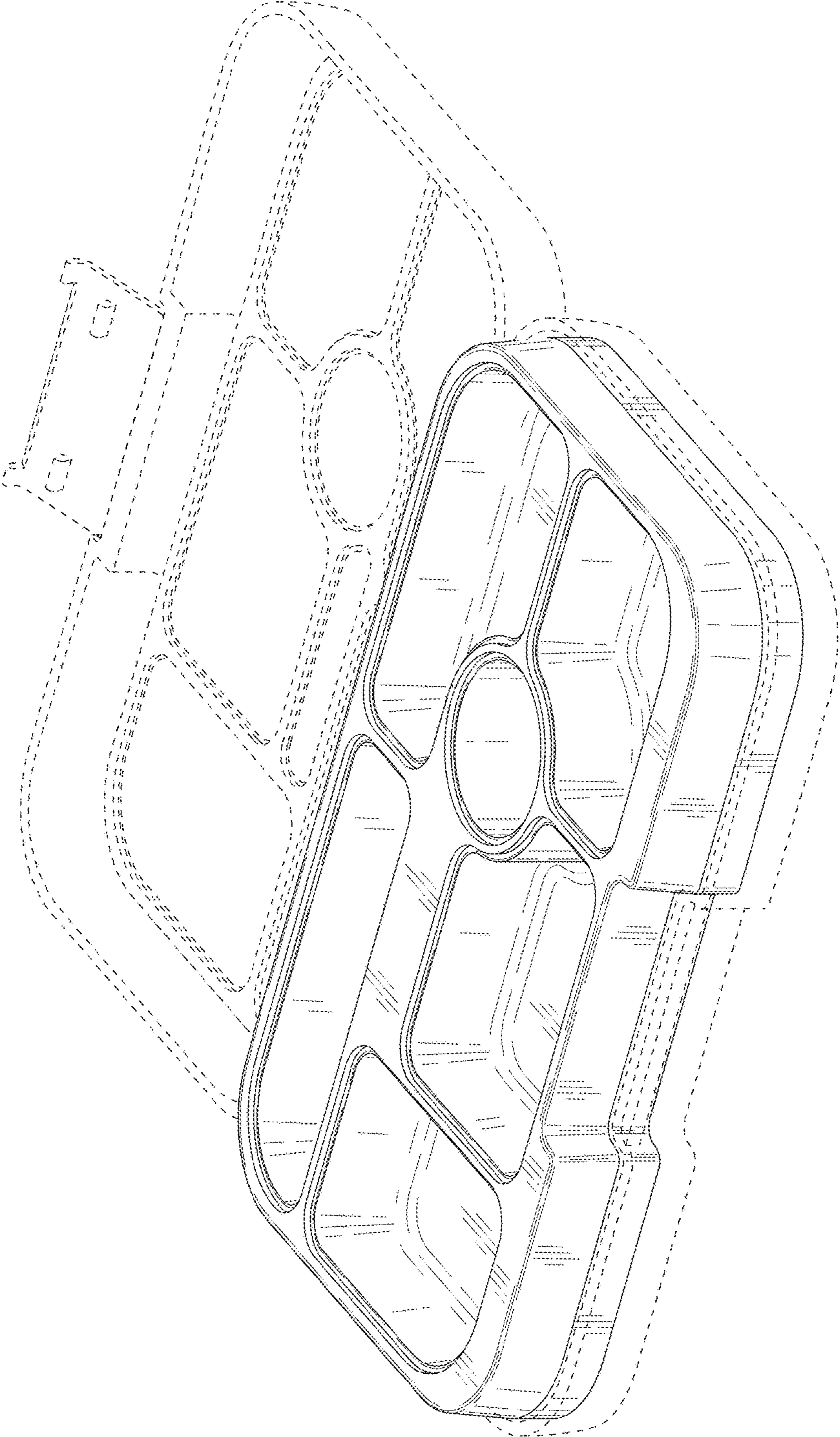
