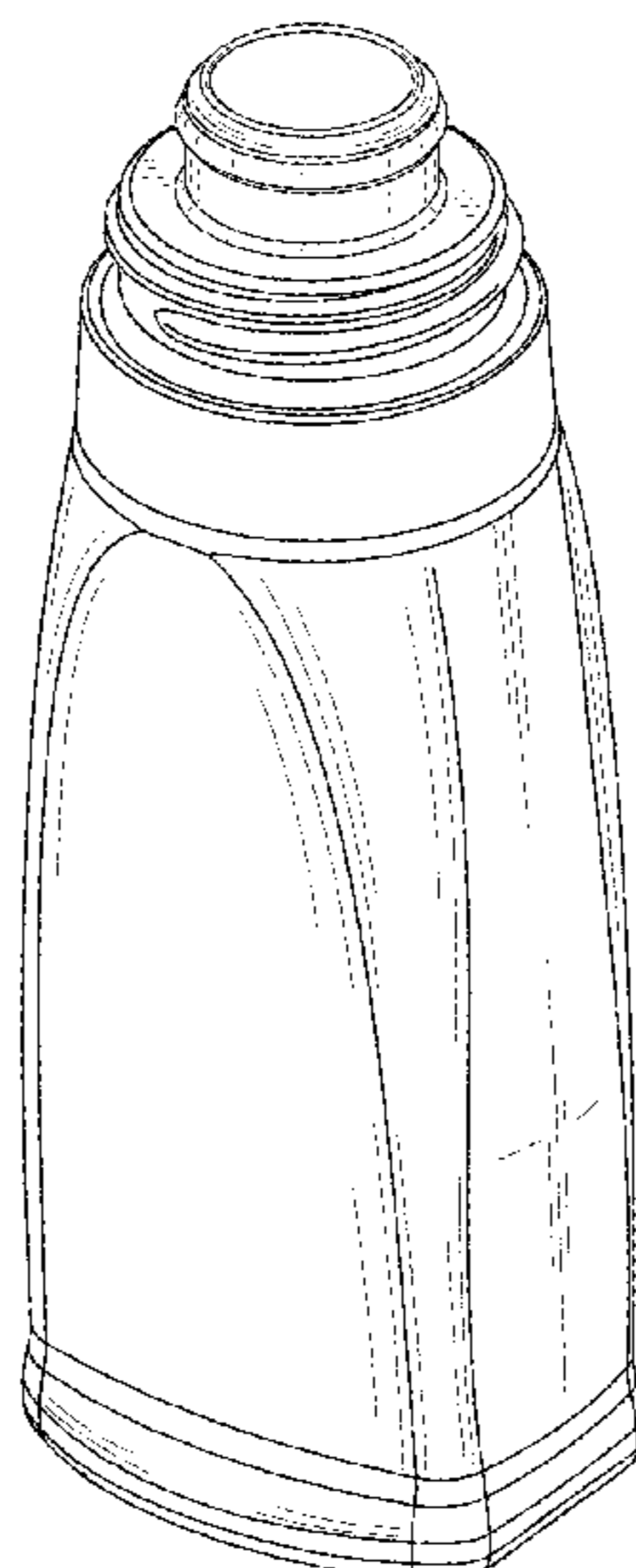

DESCRIPTION

FIG. 1 is a front perspective view of a bottle showing our new design;
FIG. 2 is a front view thereof, the rear view being a mirror image;
FIG. 3 is a right side view thereof; the left side view being a mirror image;
FIG. 4 is a top view thereof; and,
FIG. 5 is a bottom view thereof.
In the drawings, the broken lines showing portions of a bottle depict environment and form no part of the claim.

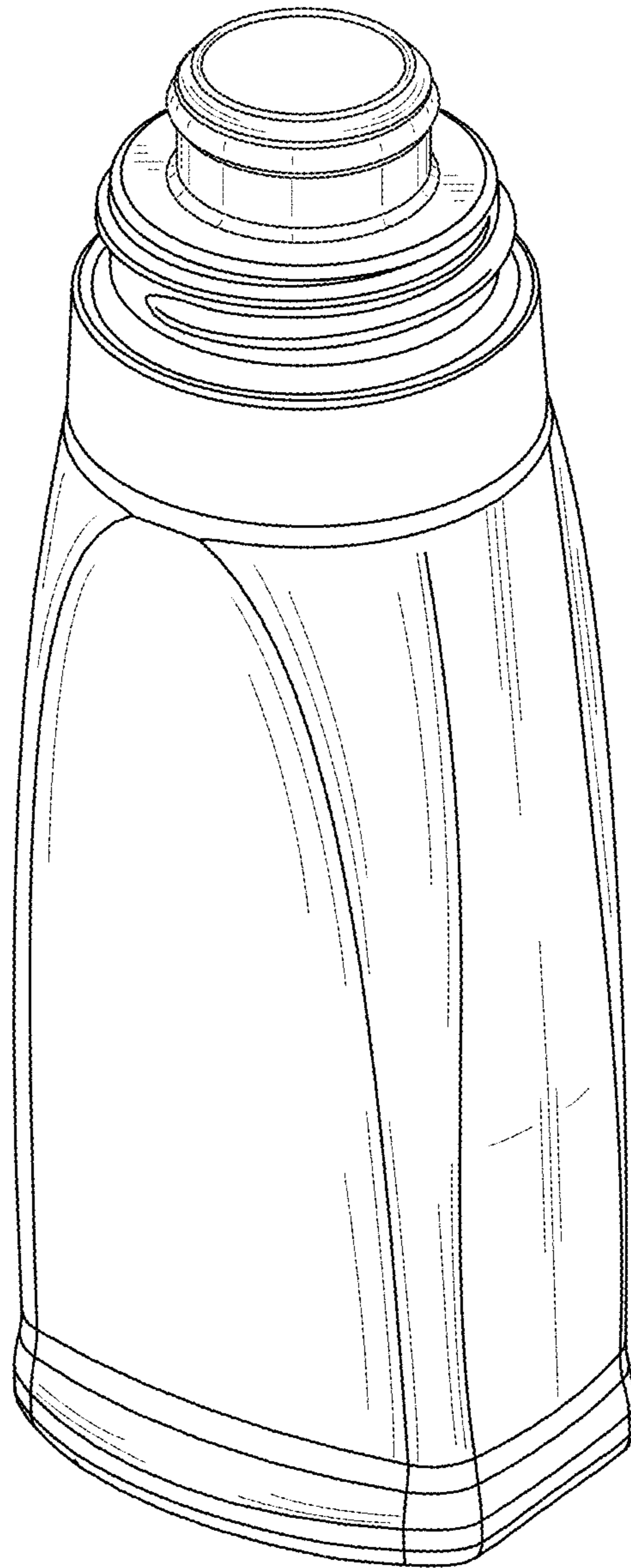

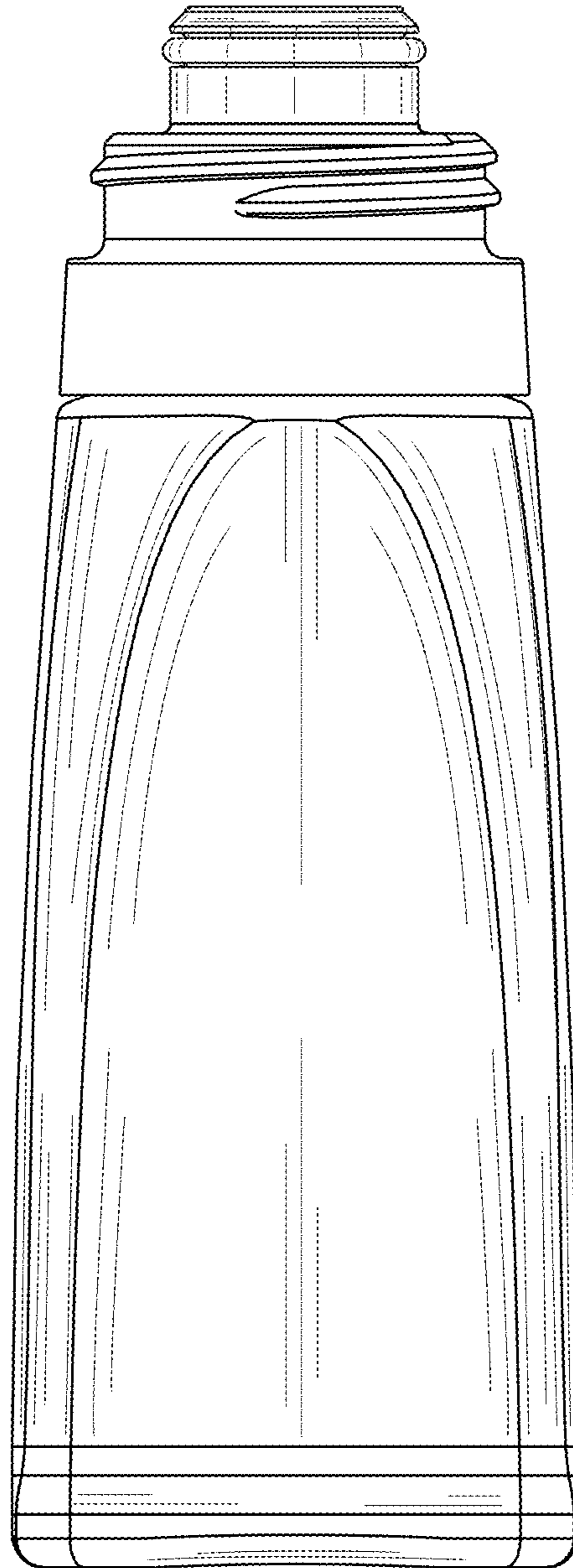

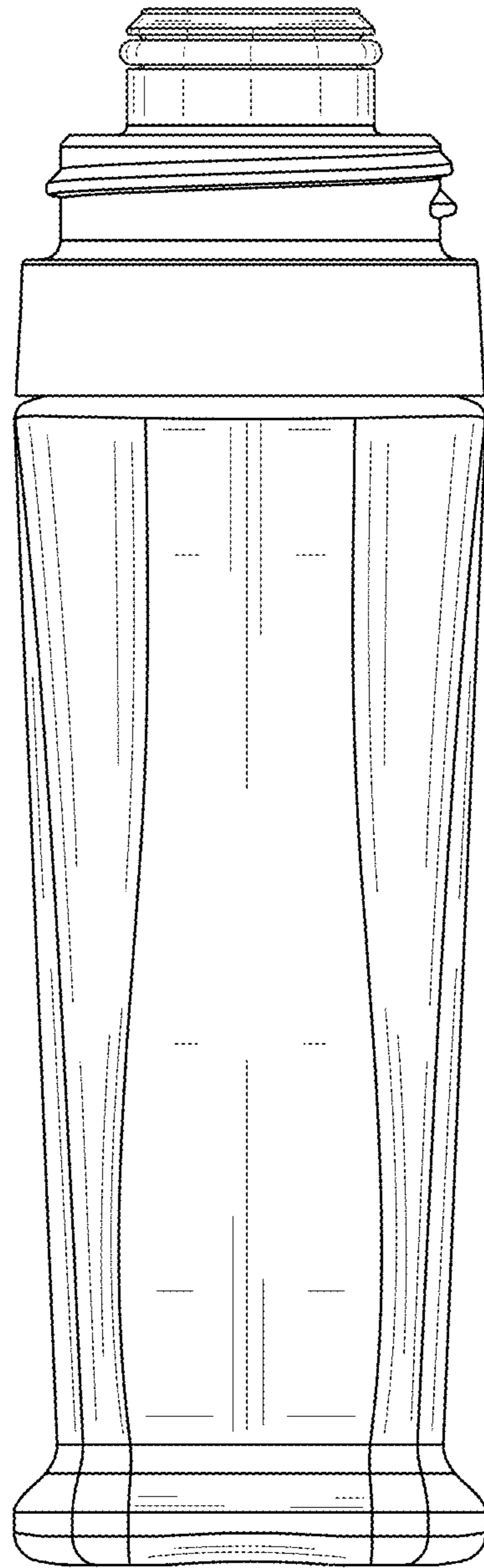

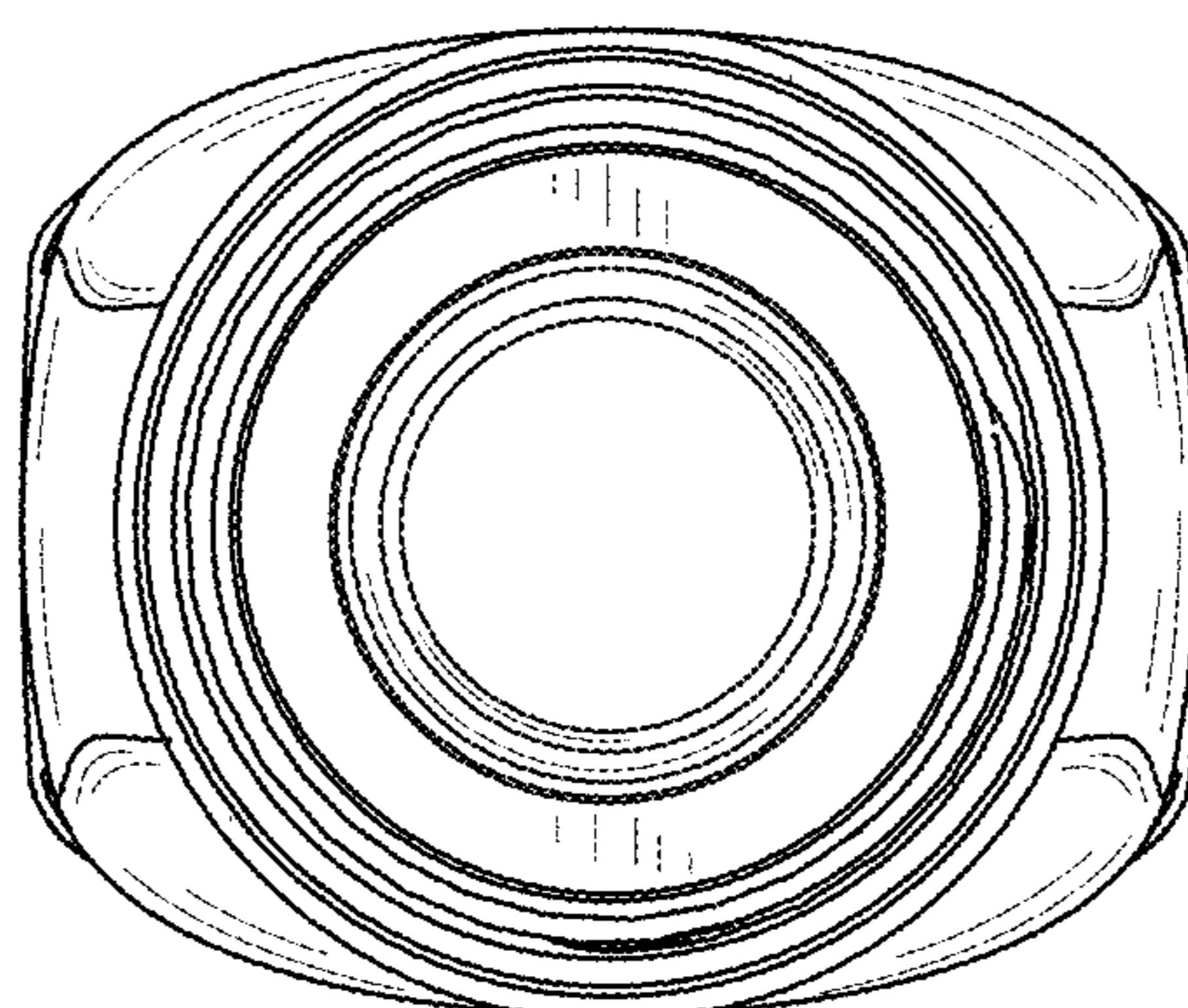

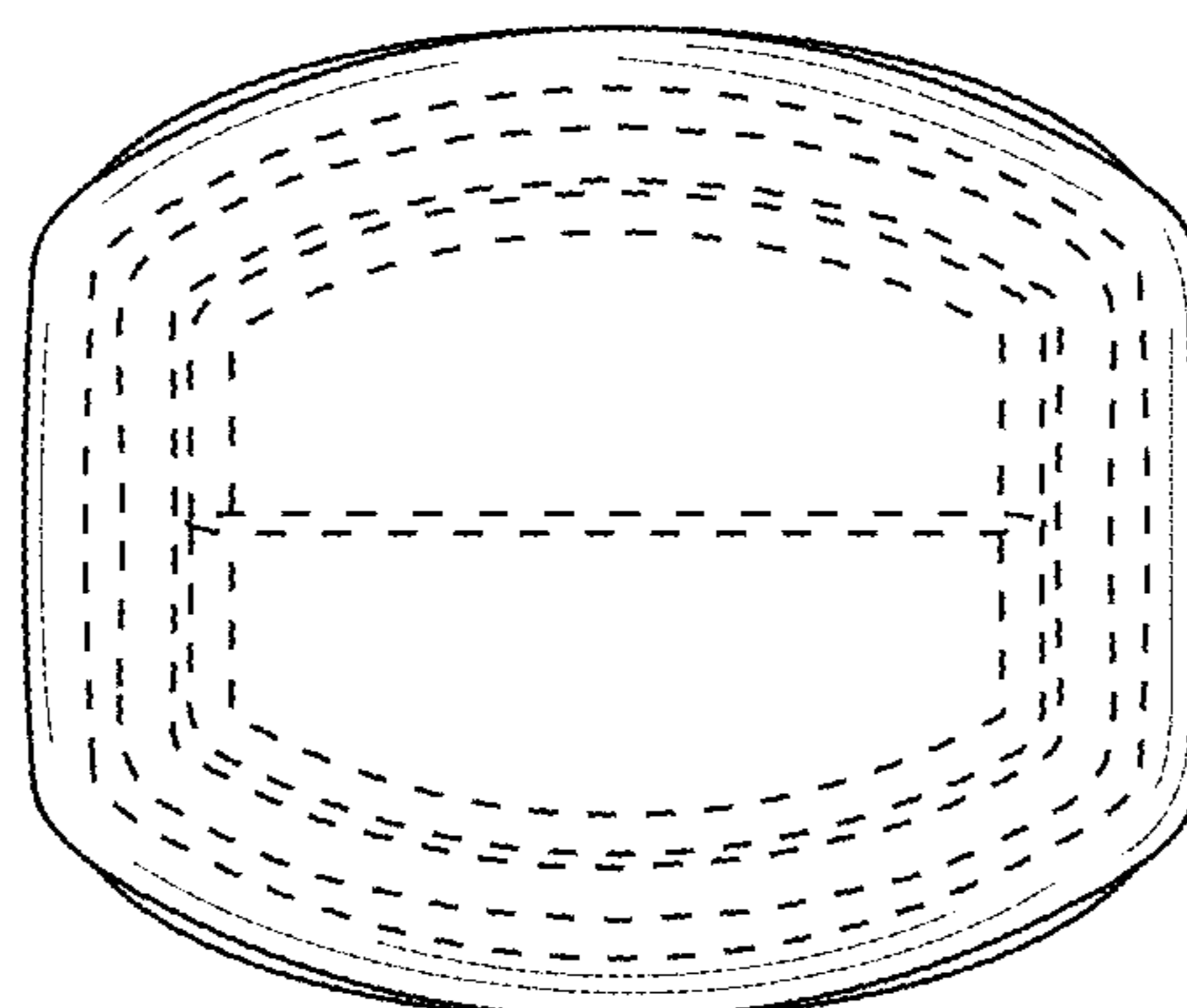
