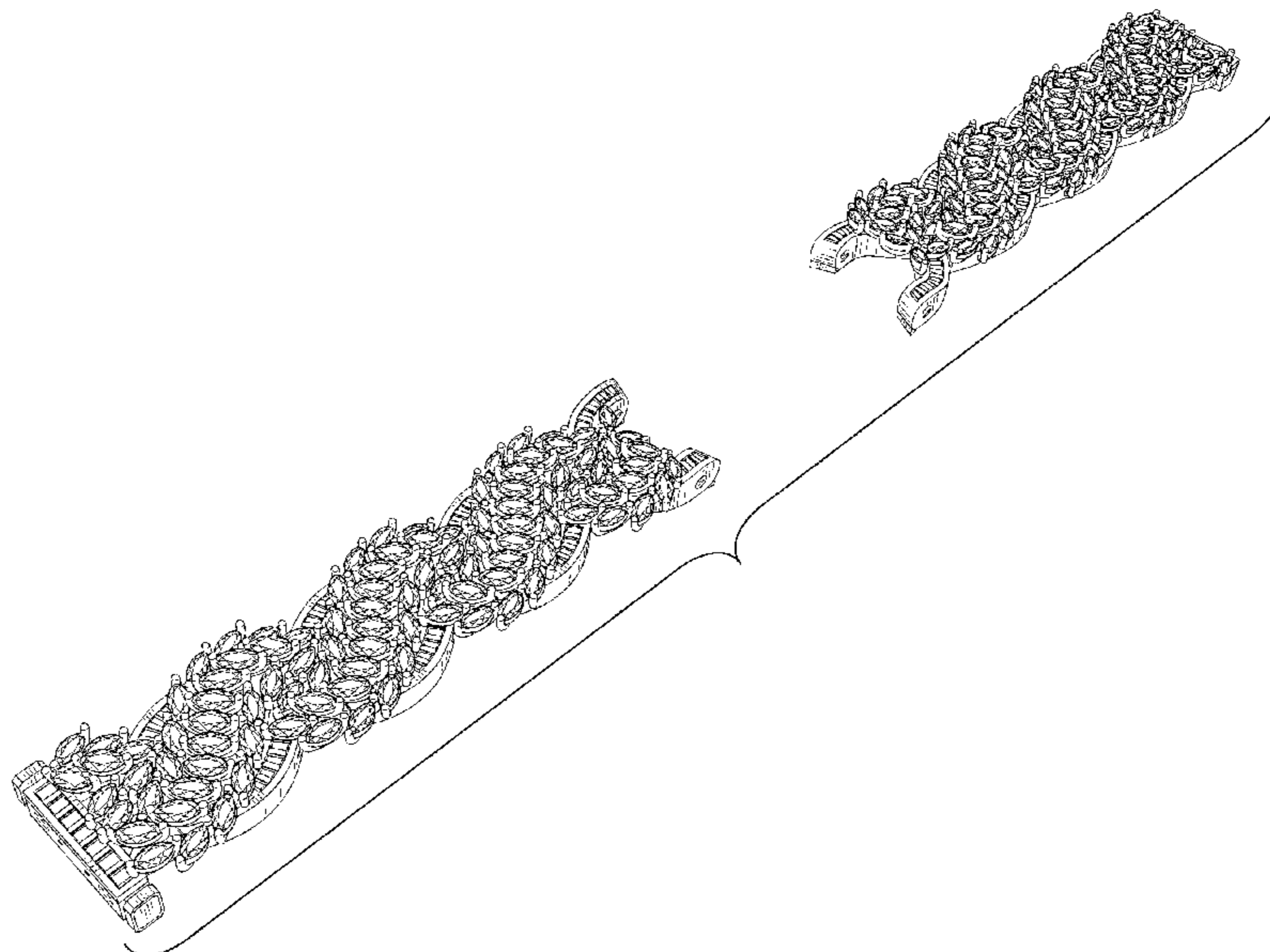
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a front right perspective view of a bracelet showing my new design;
FIG. 2 is an enlarged front view thereof;
FIG. 3 is an enlarged rear view thereof;
FIG. 4 is a left side view thereof;
FIG. 5 is a right side view thereof;
FIG. 6 is a top plan view thereof;

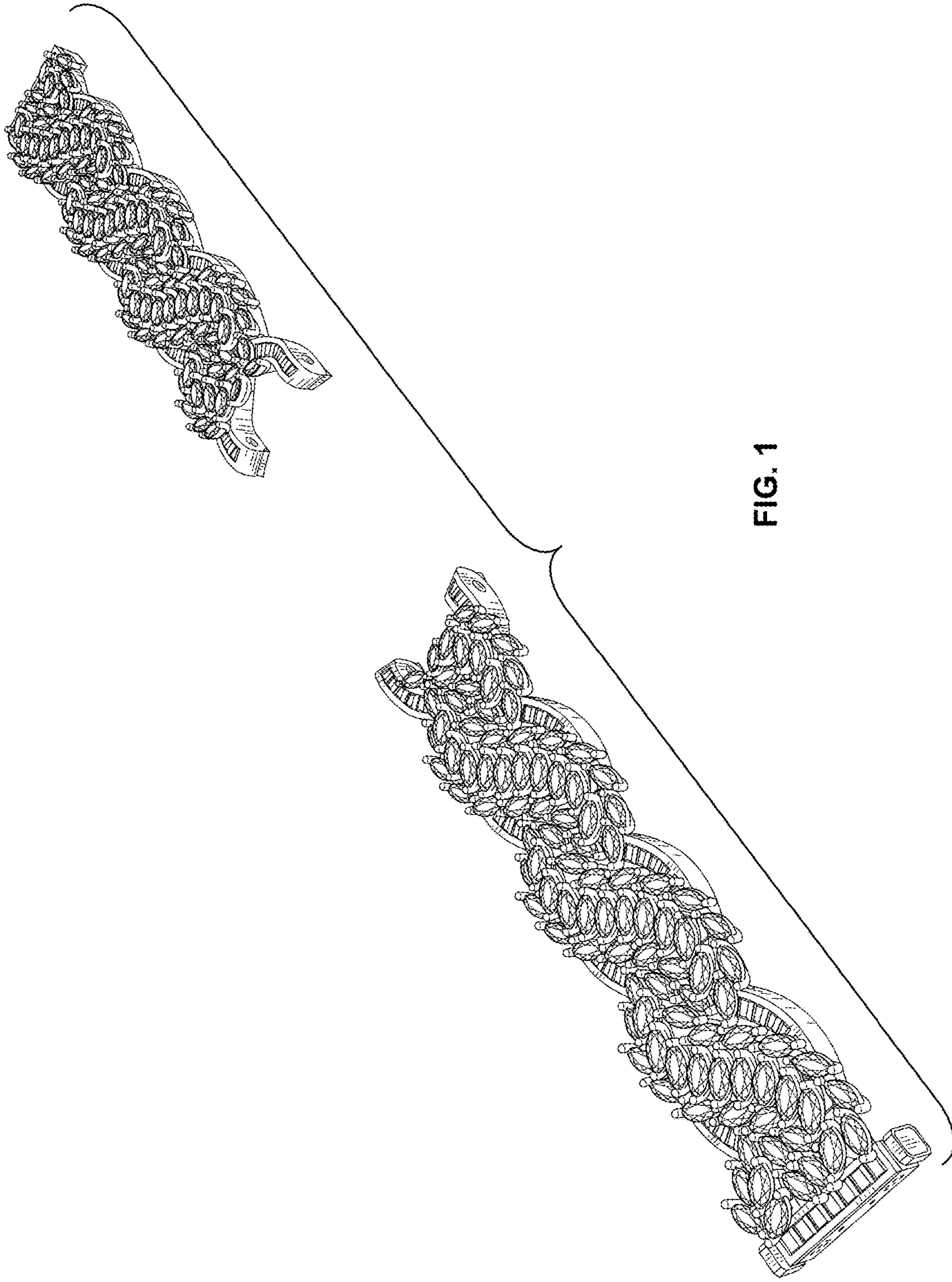

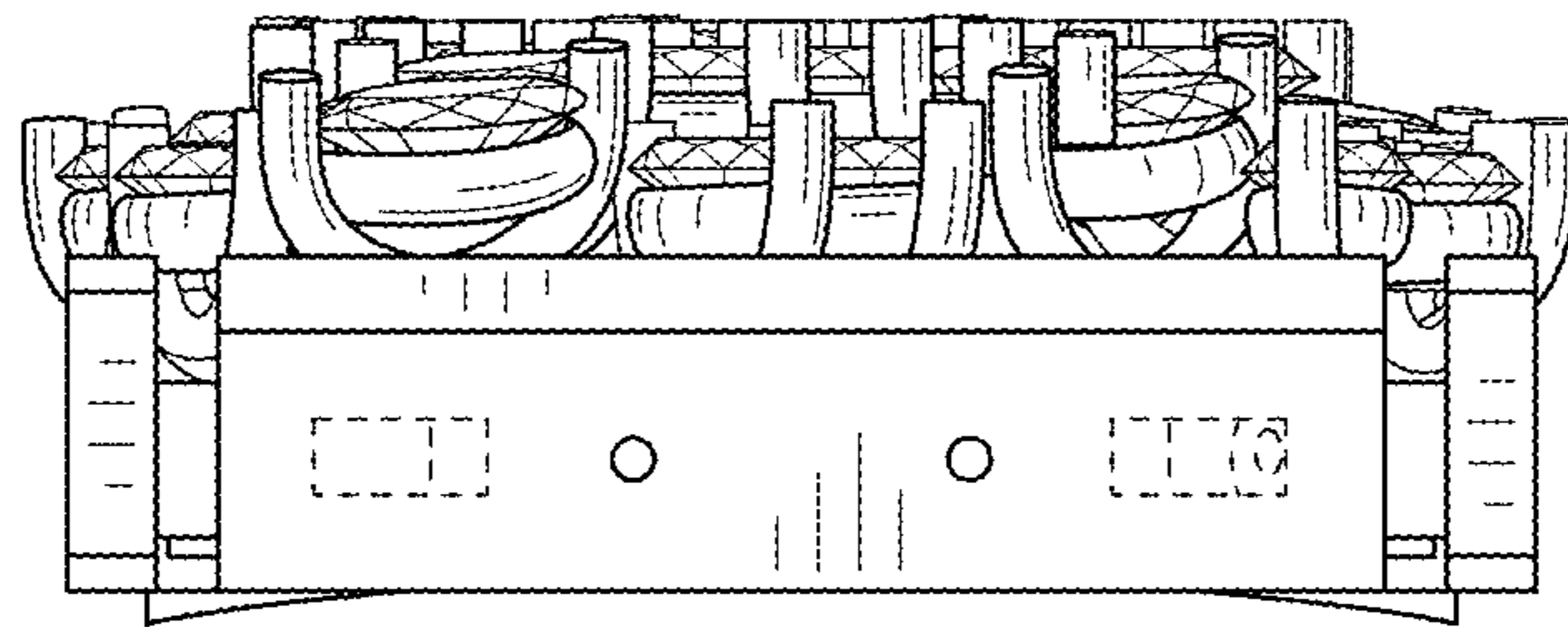

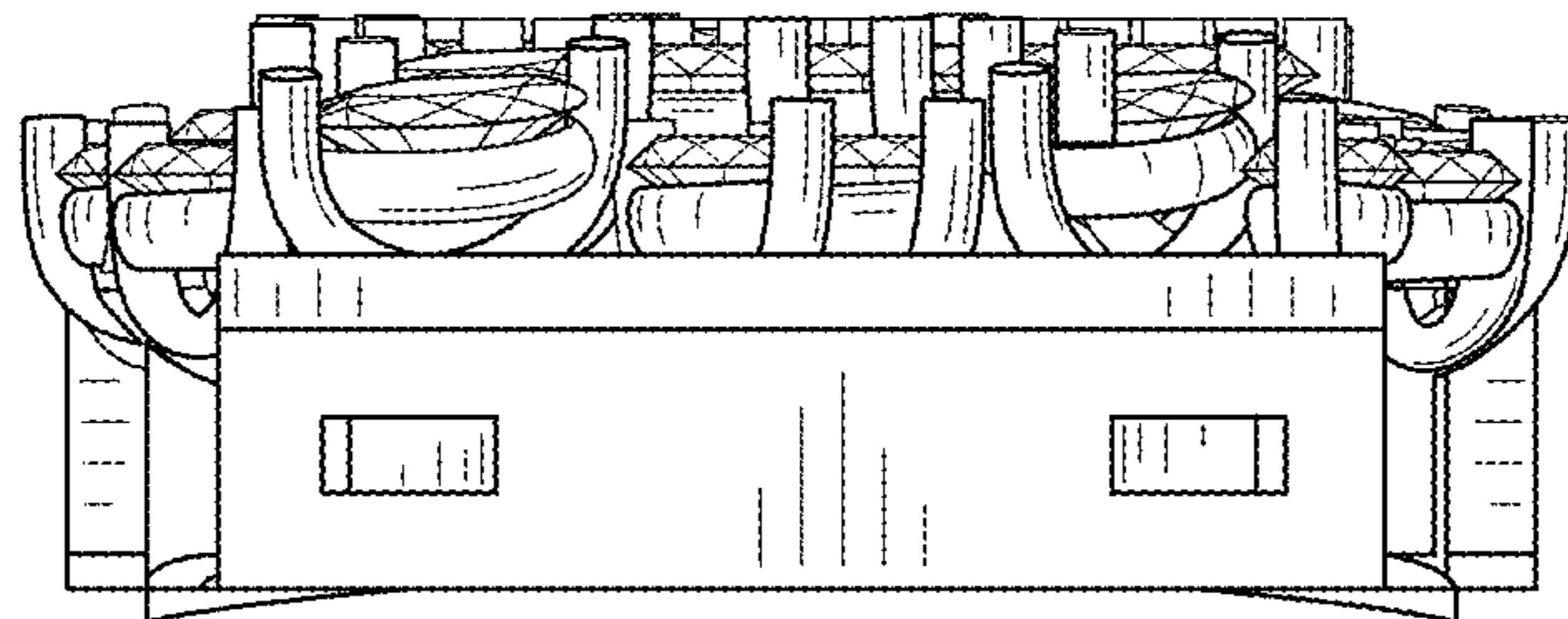

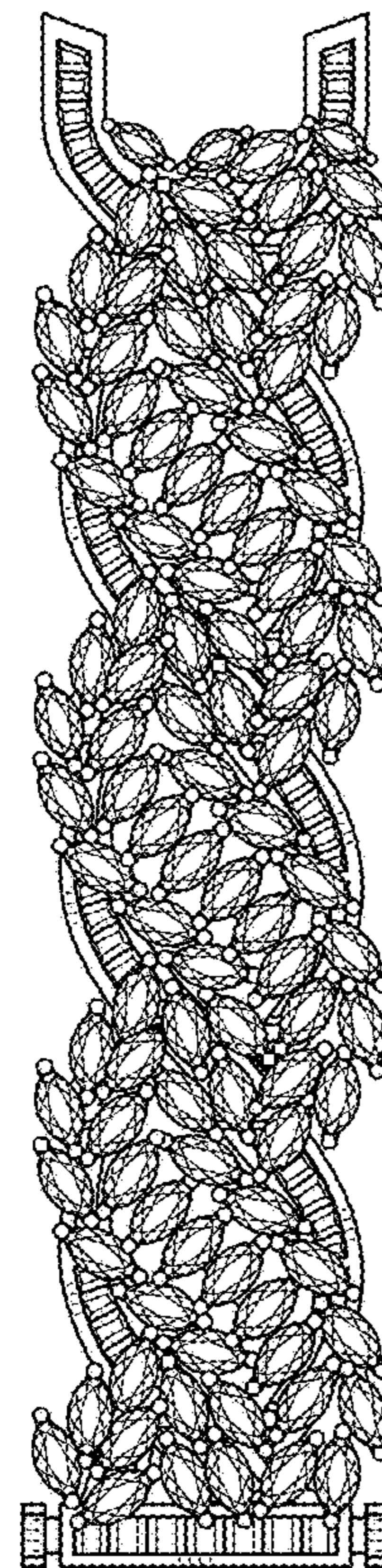
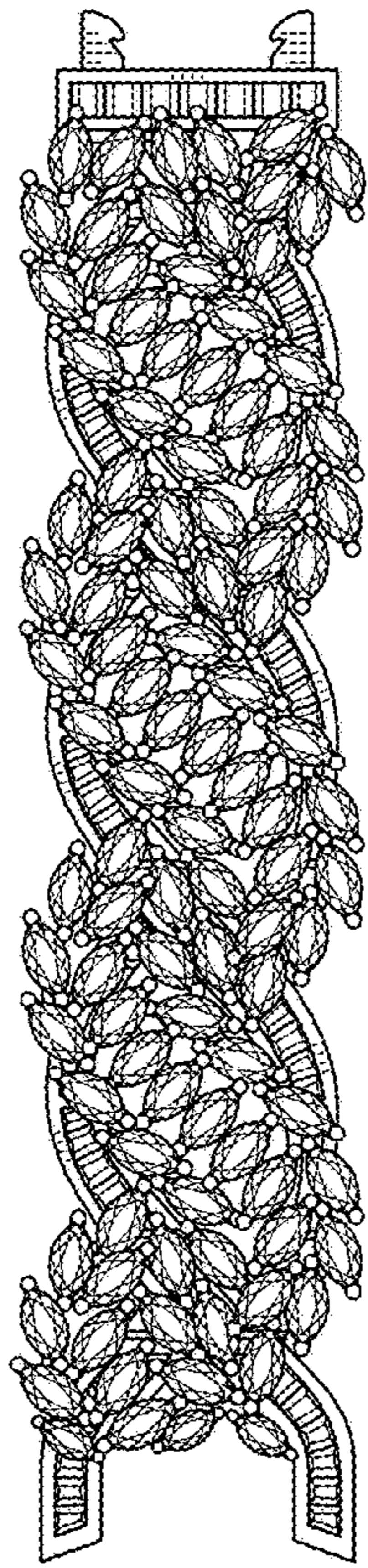

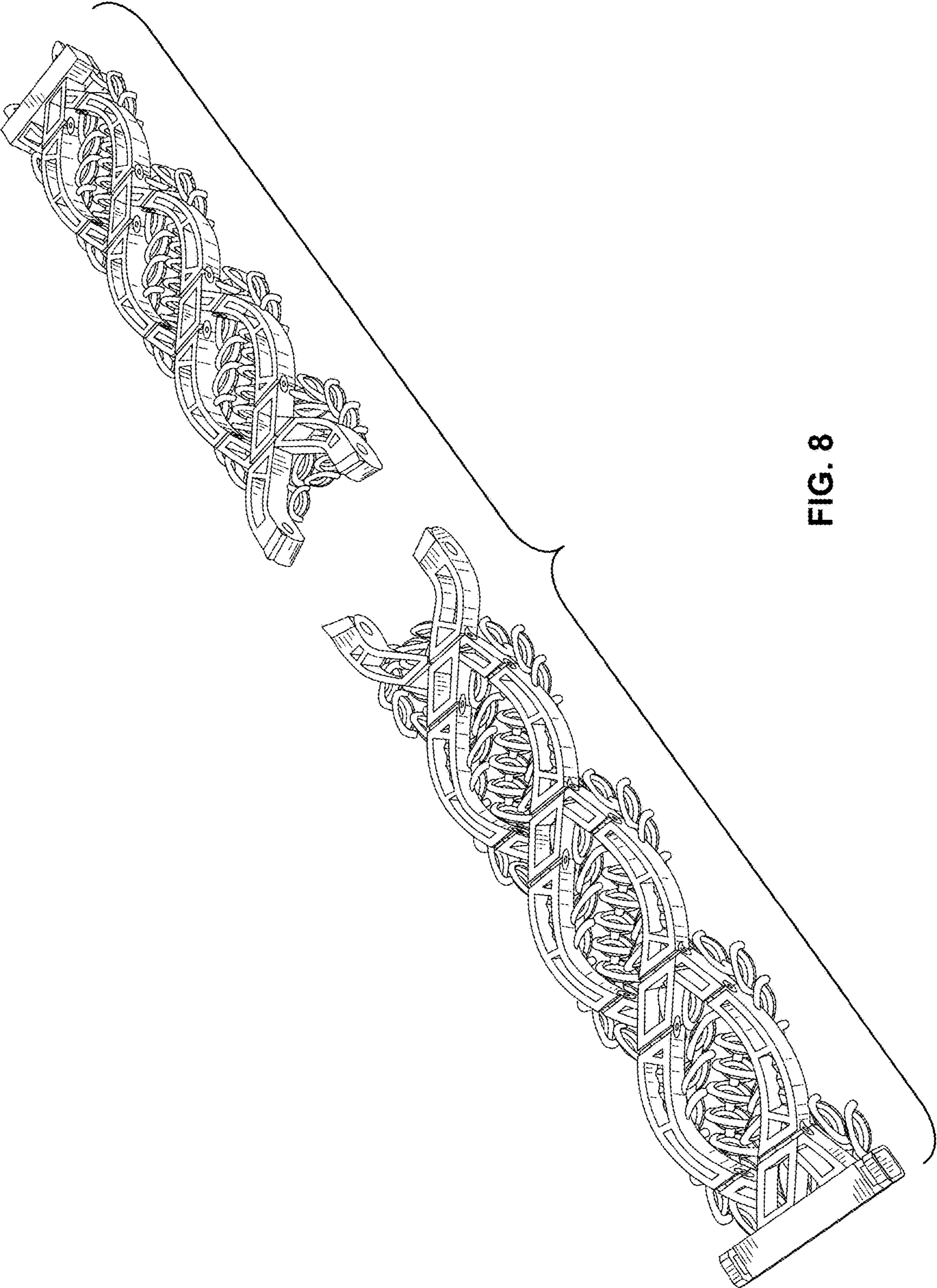
