FIG. 10 is a detailed view of mesh shown in FIG. 6 of the plant container.

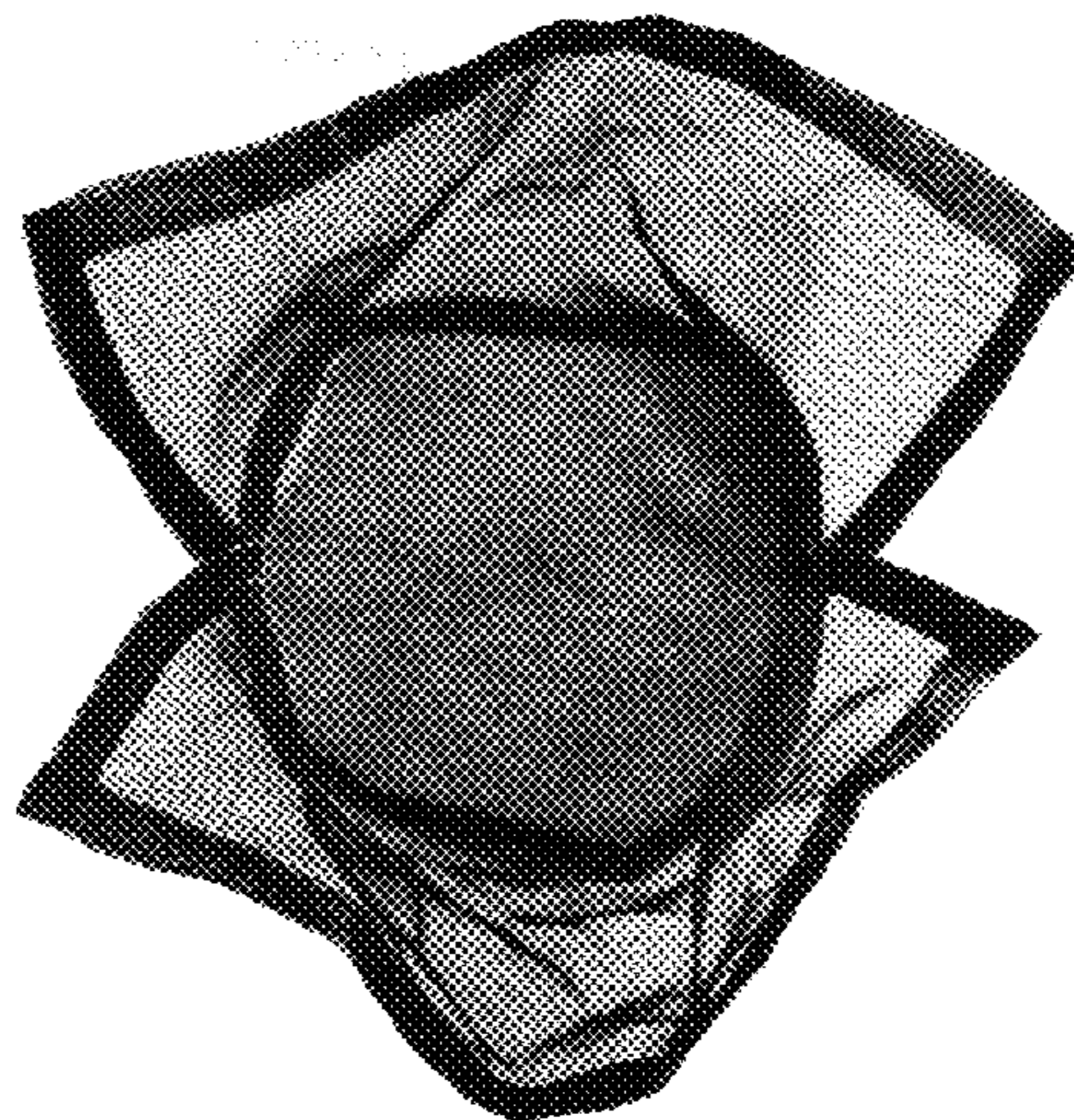
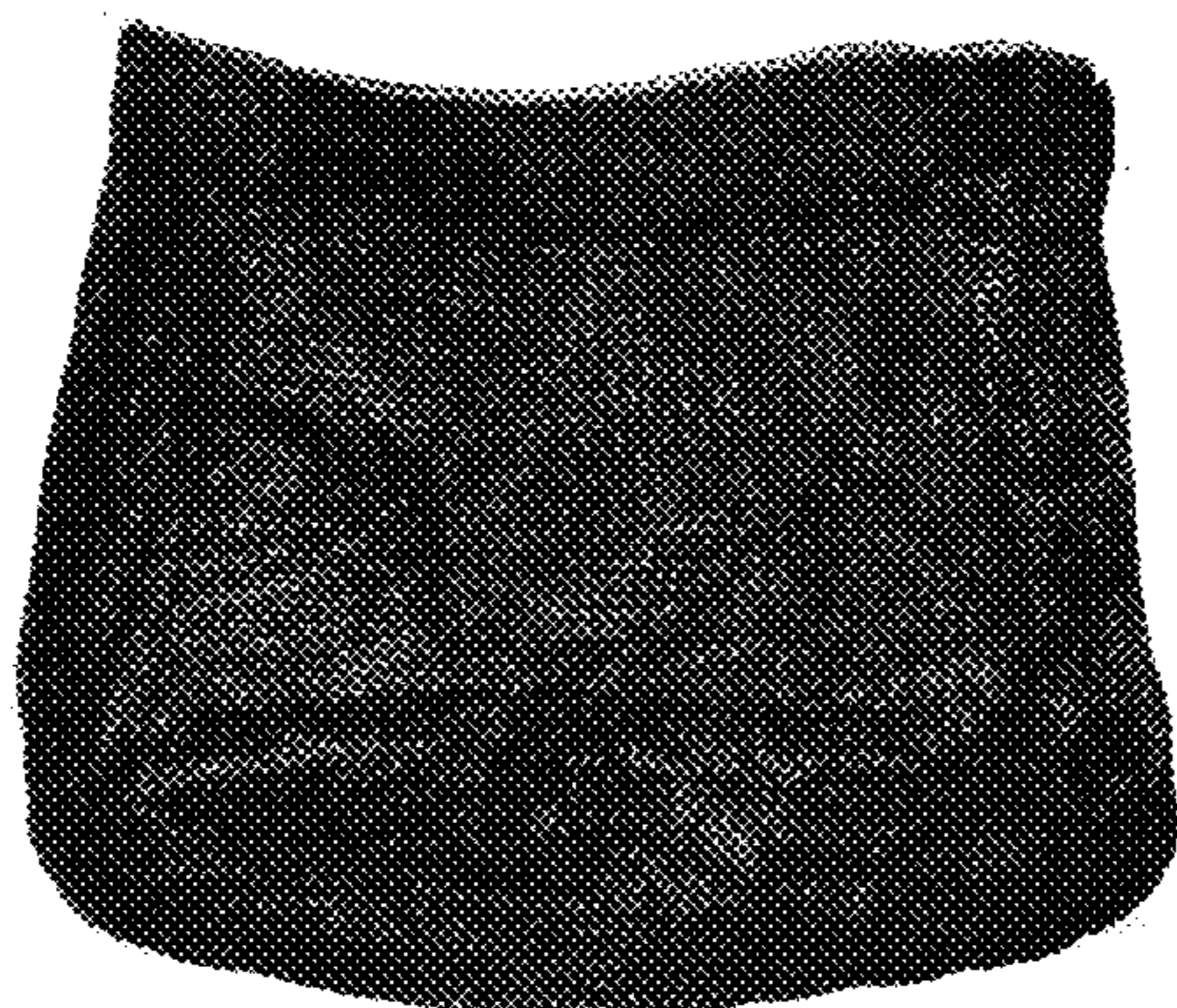

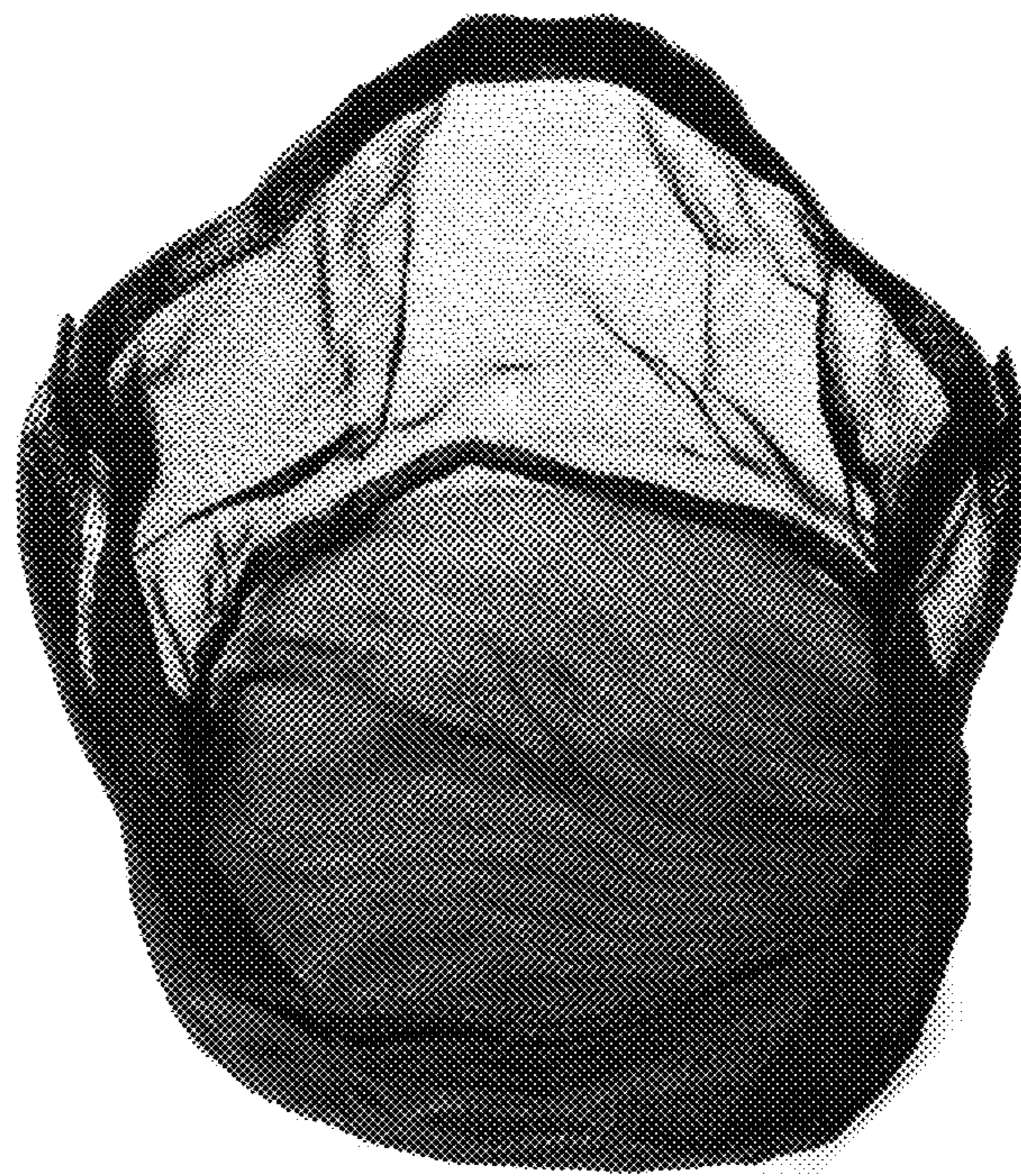

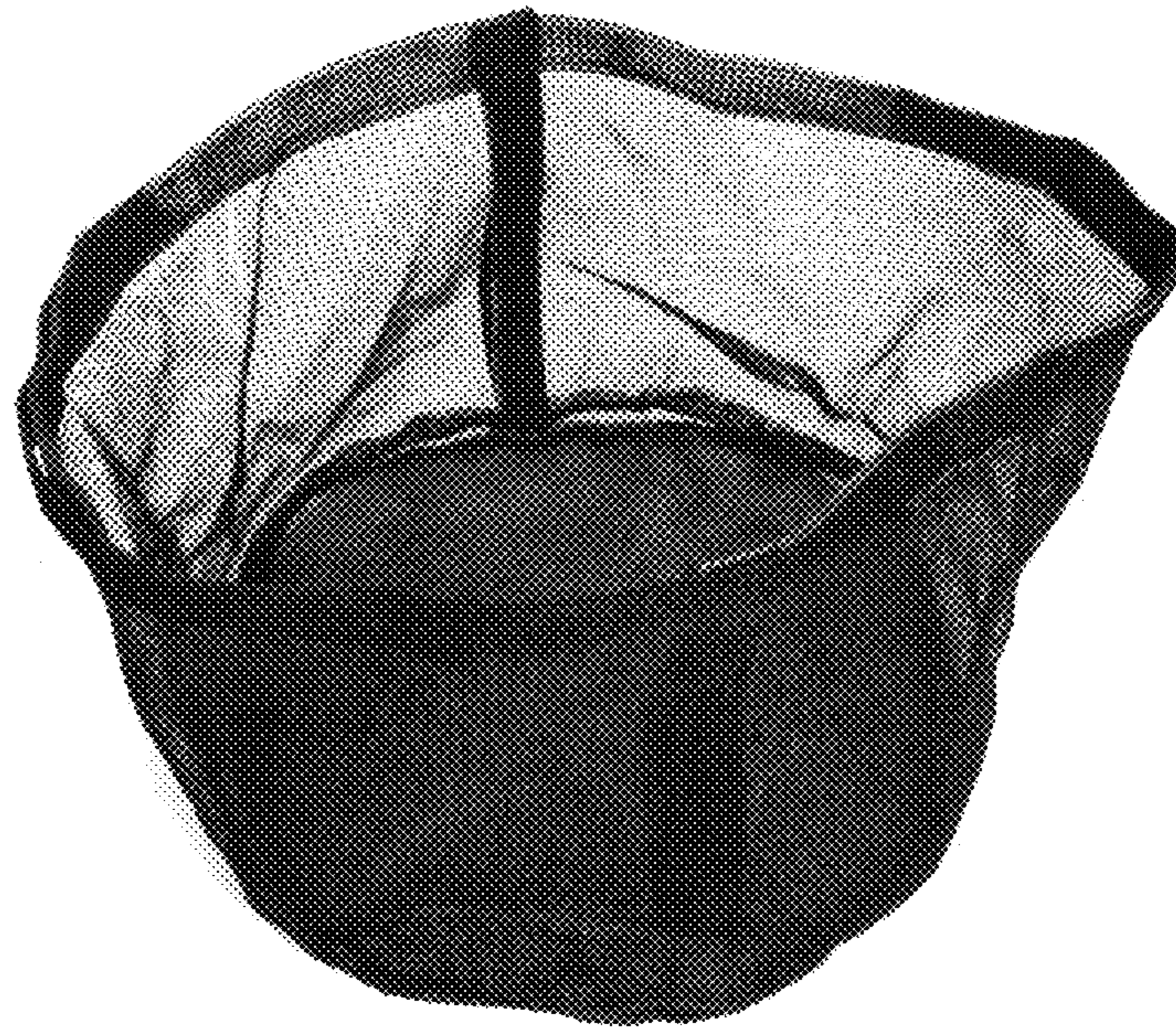

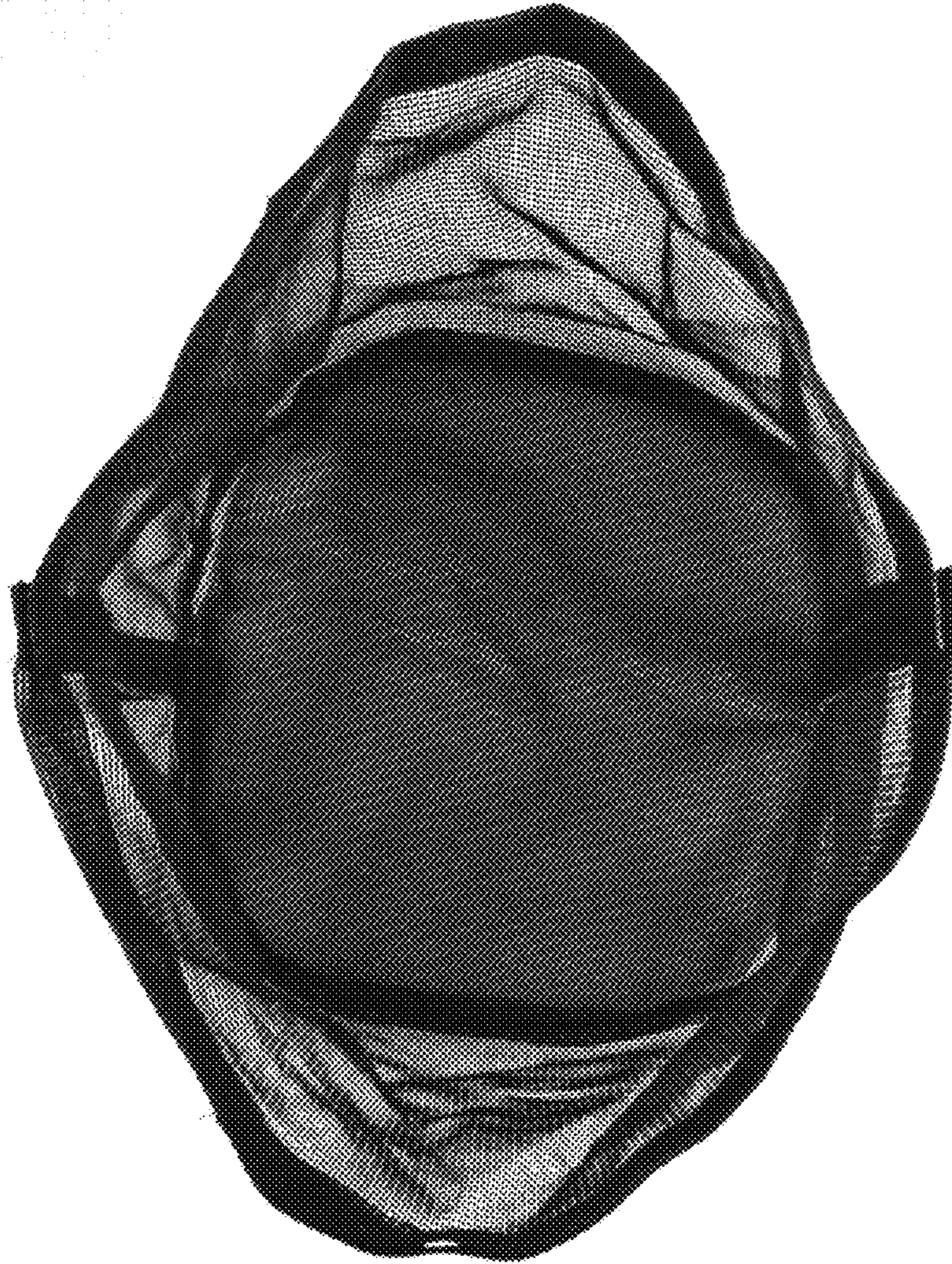

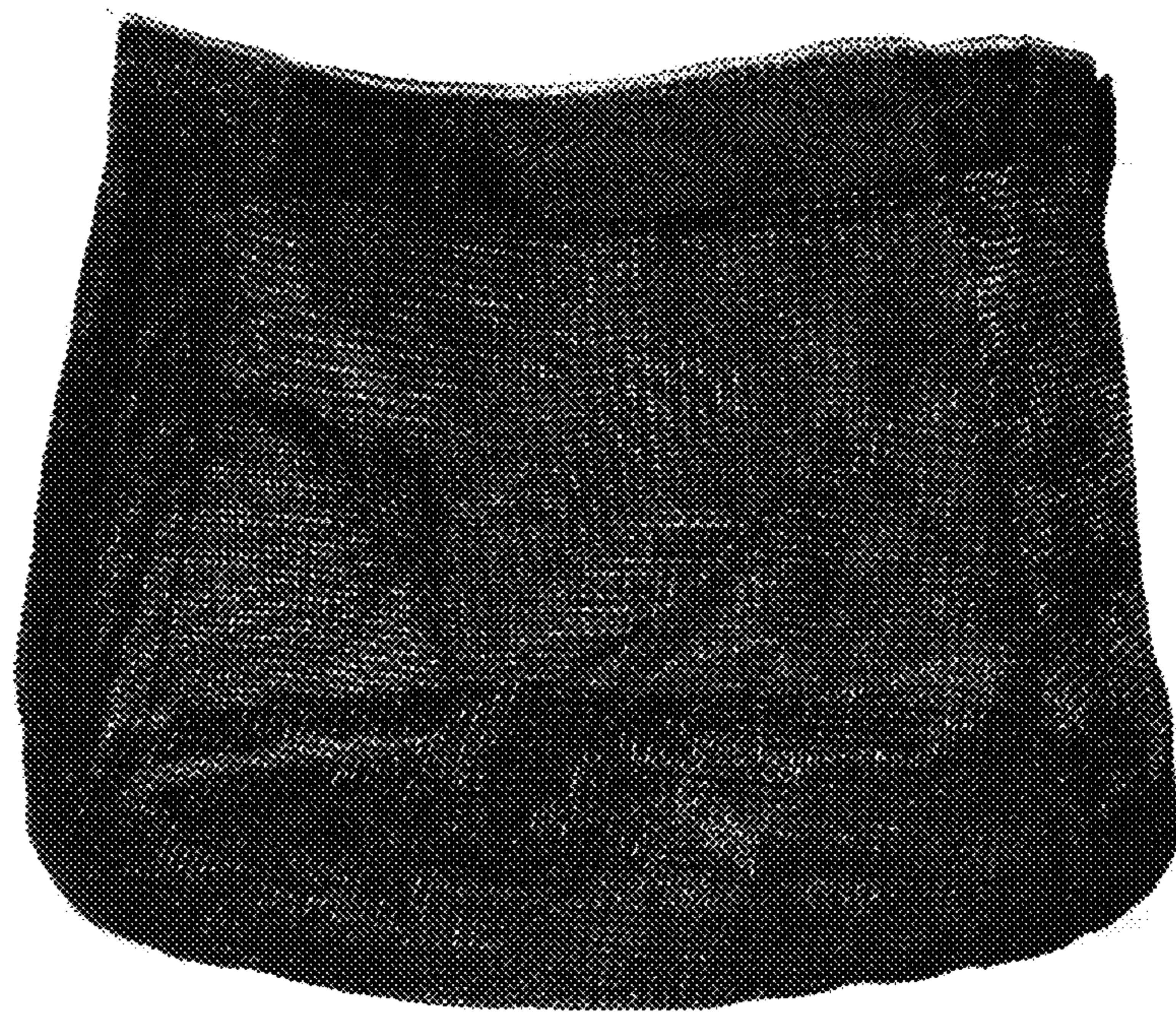

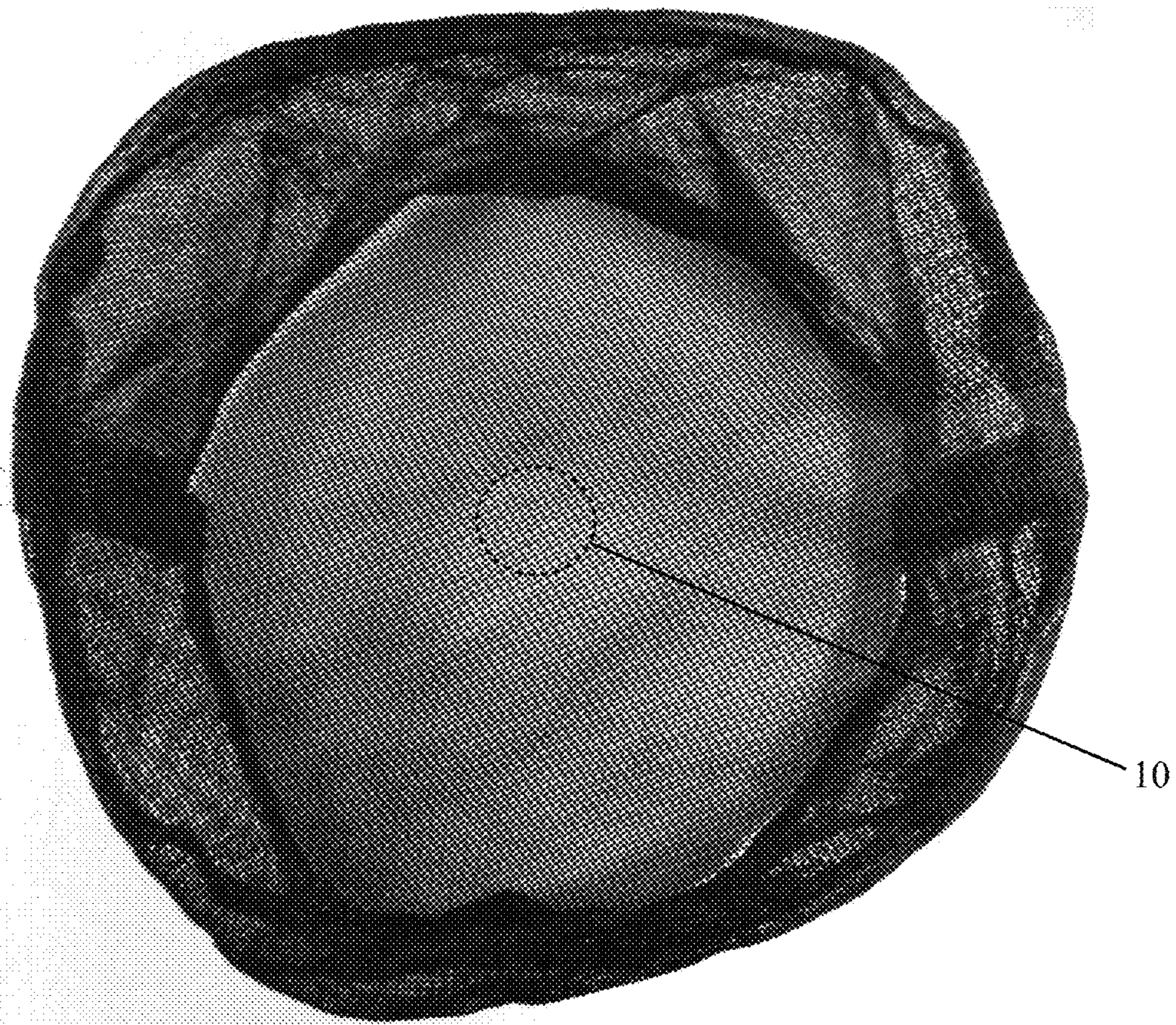

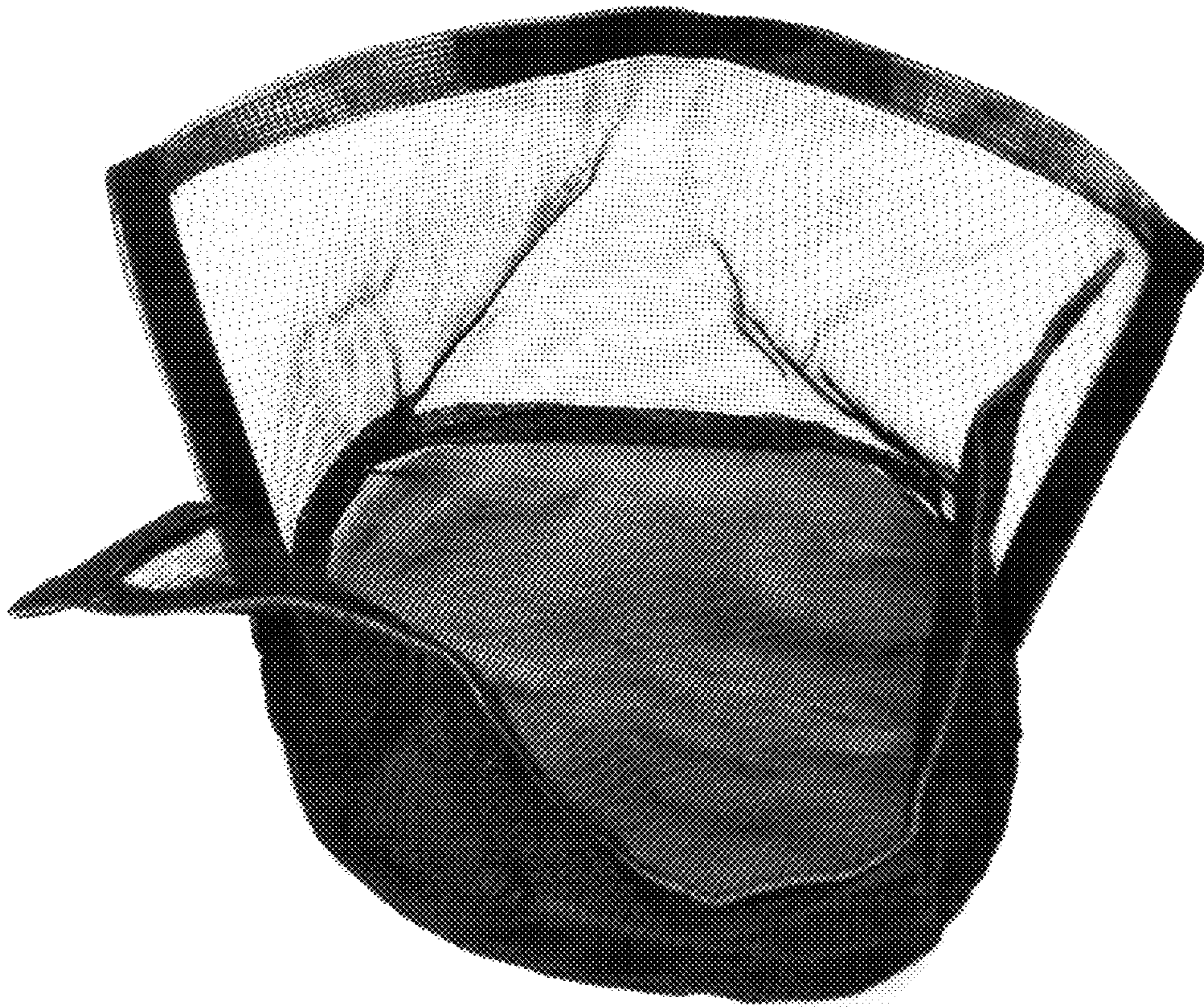

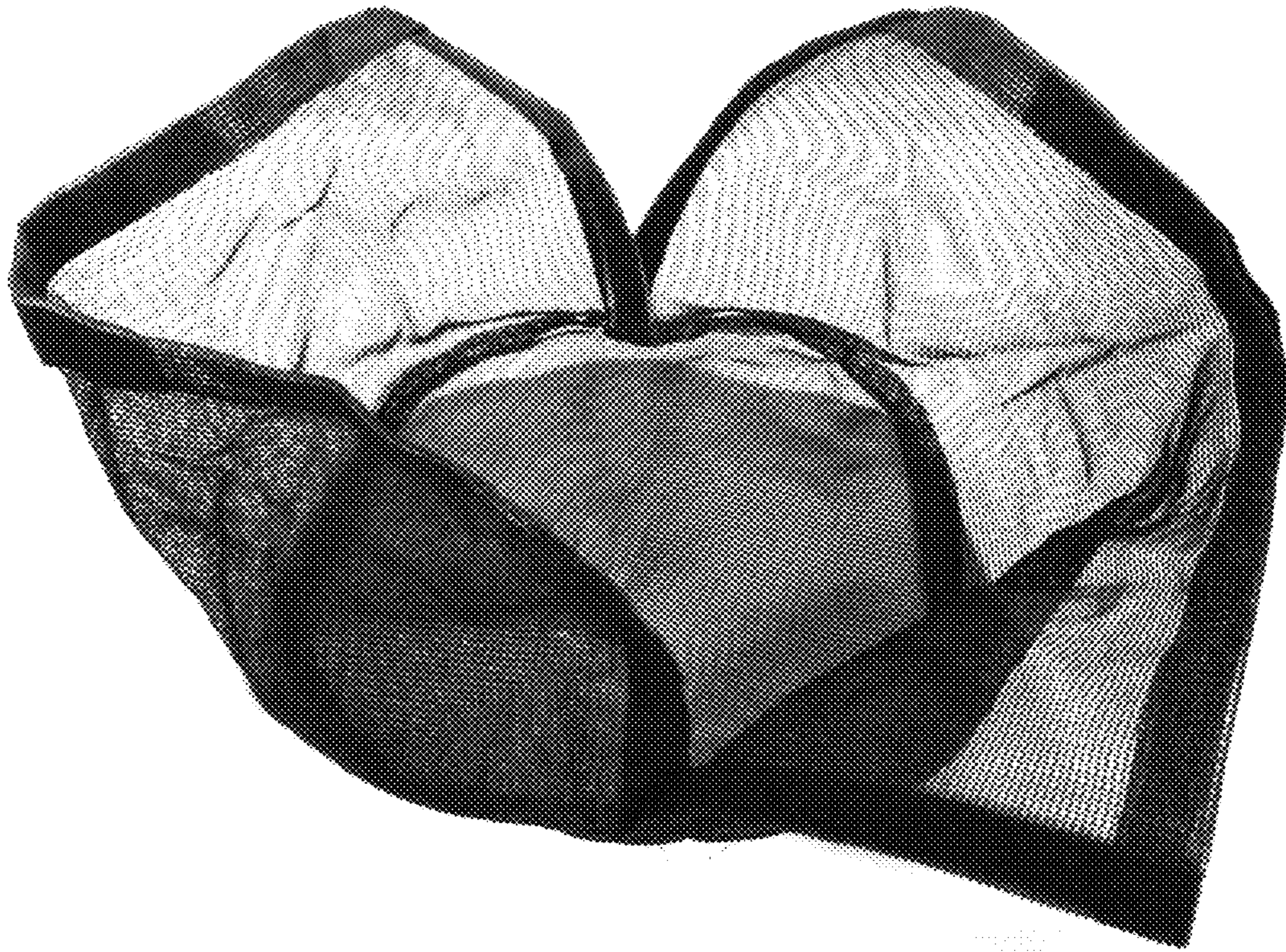

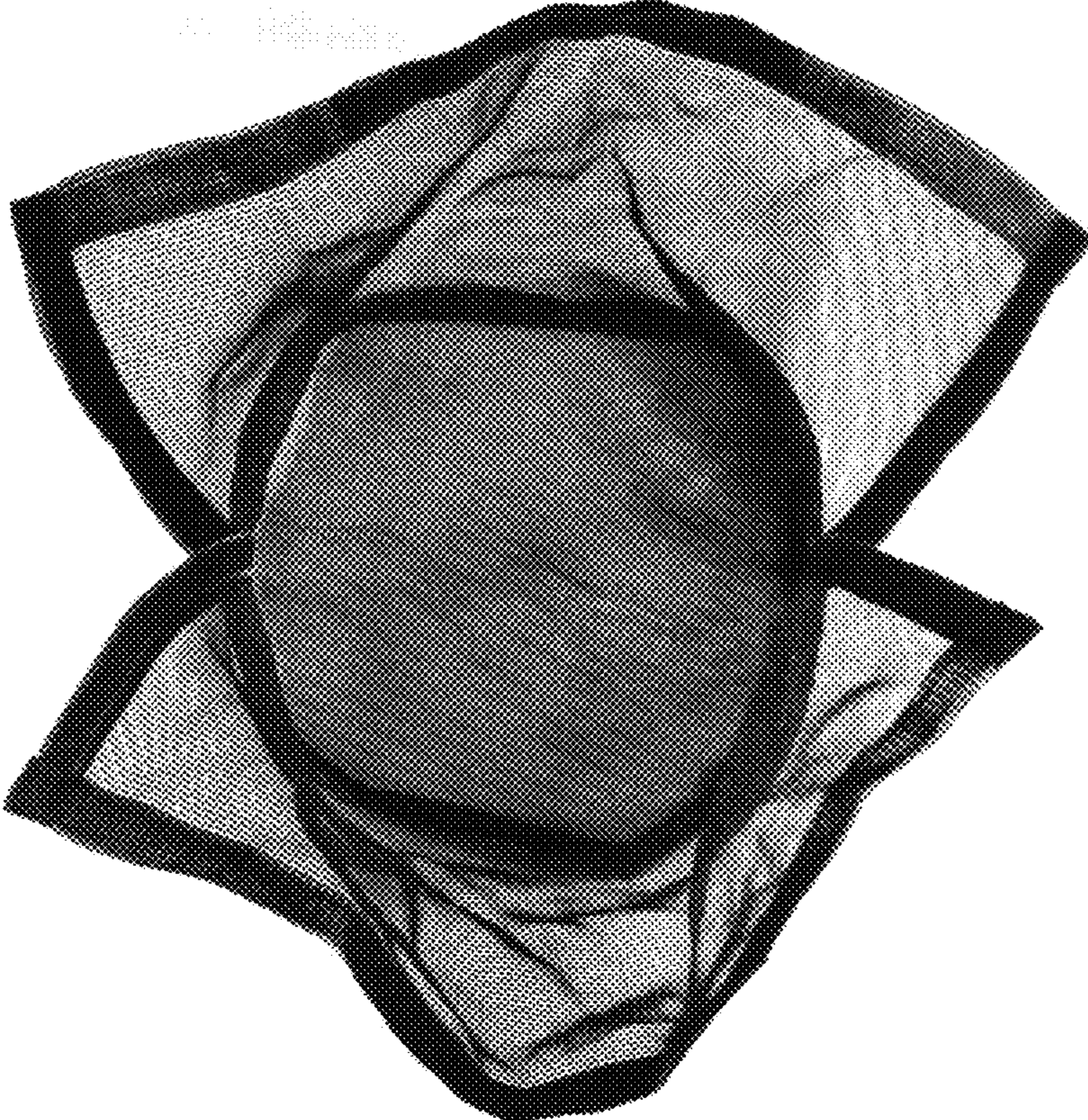

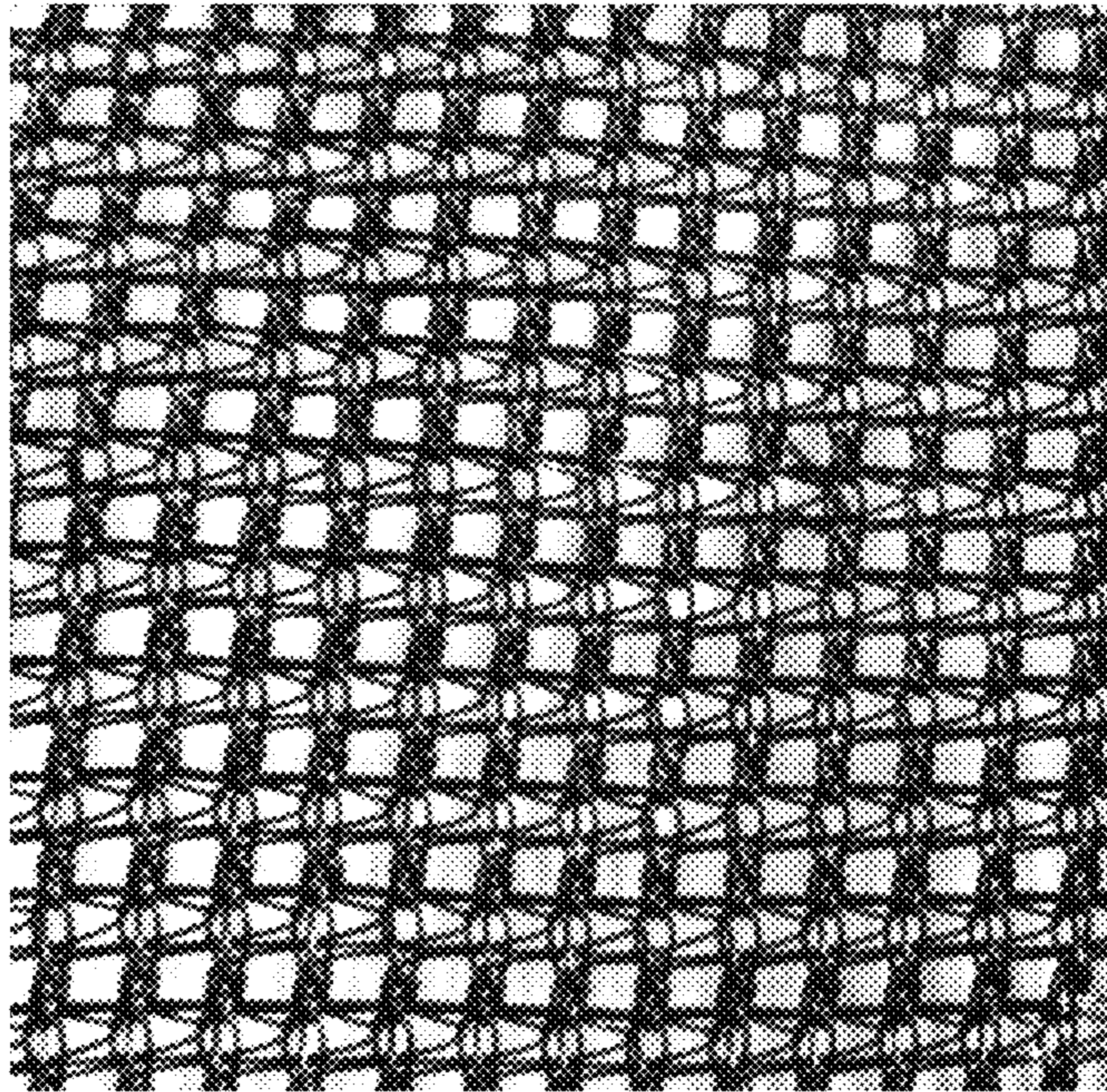
