I claim the ornamental design for a passenger car, as shown and described.

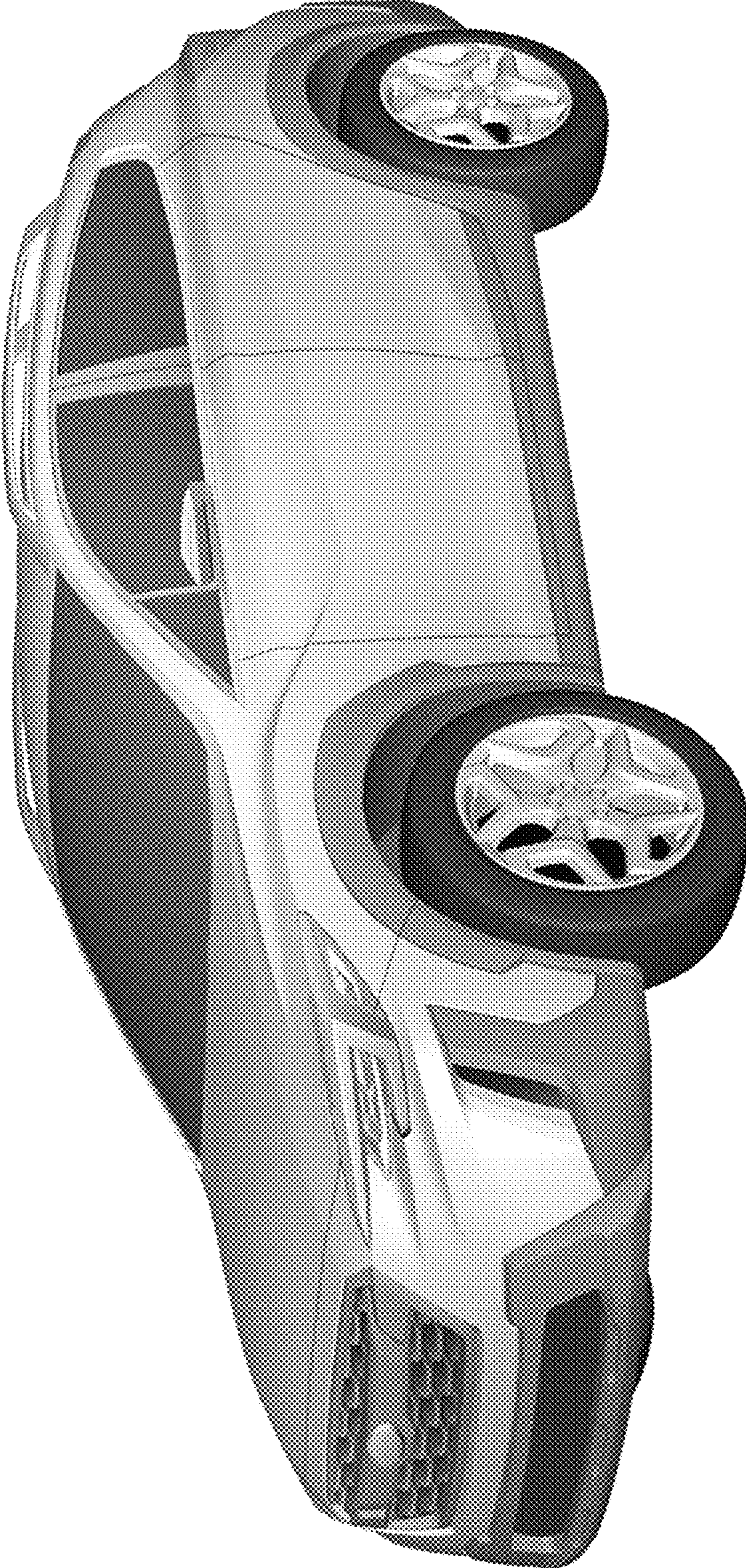

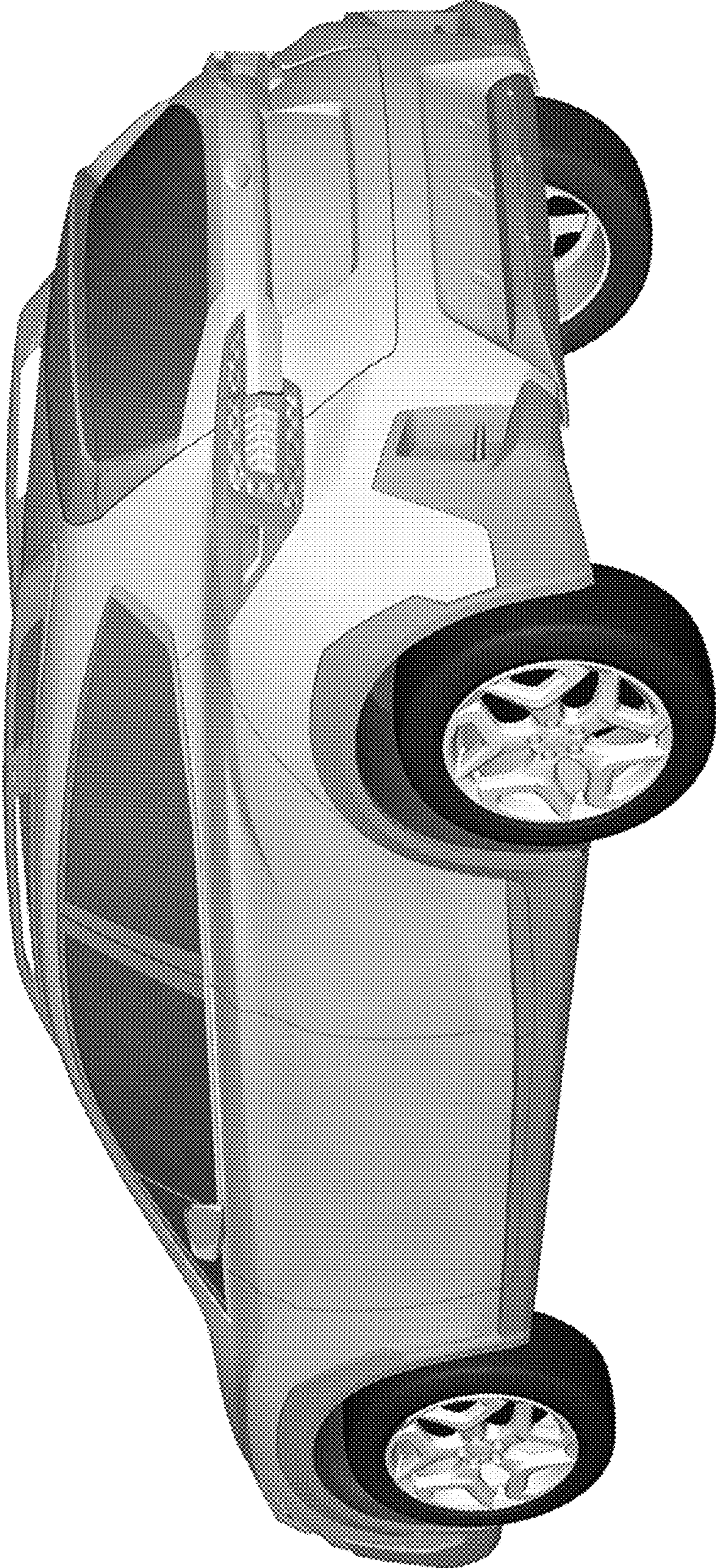

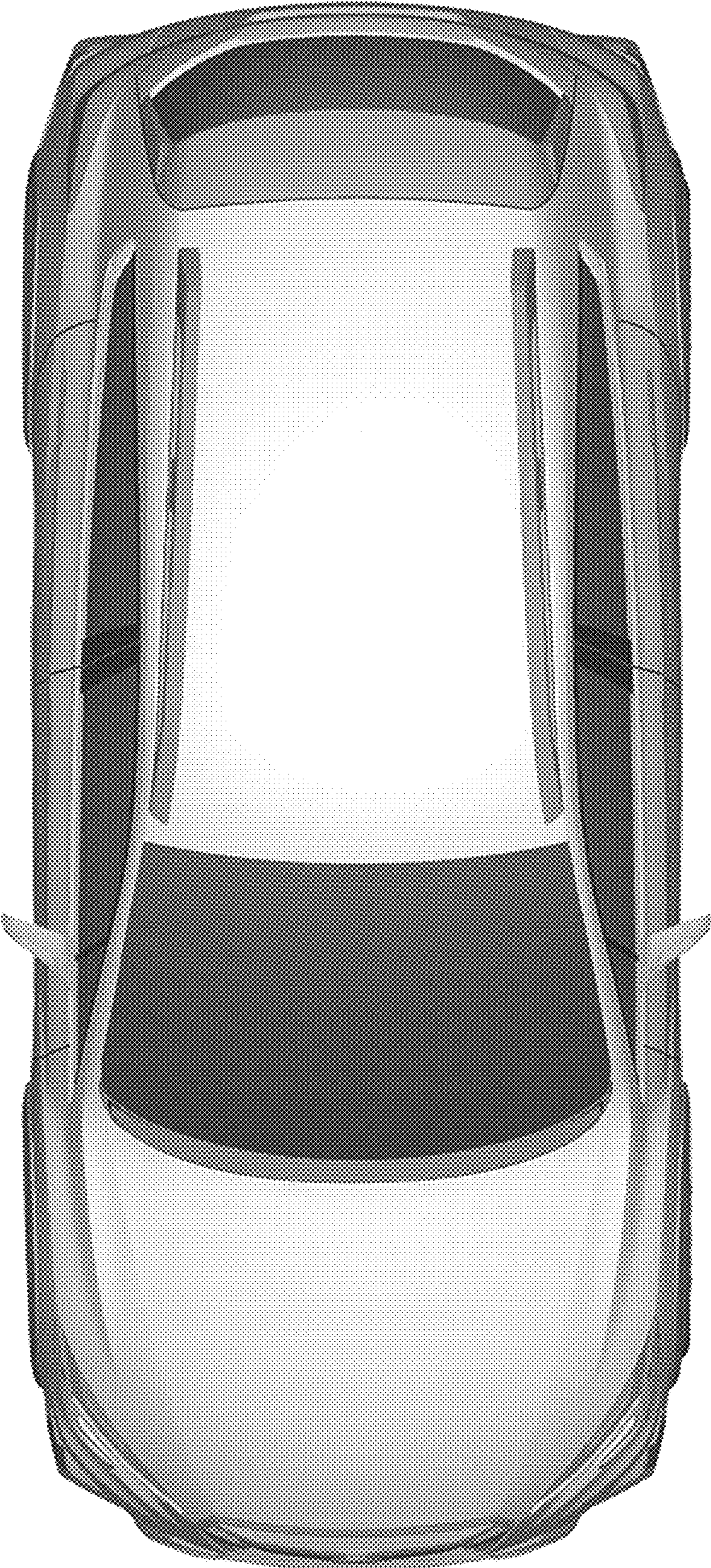

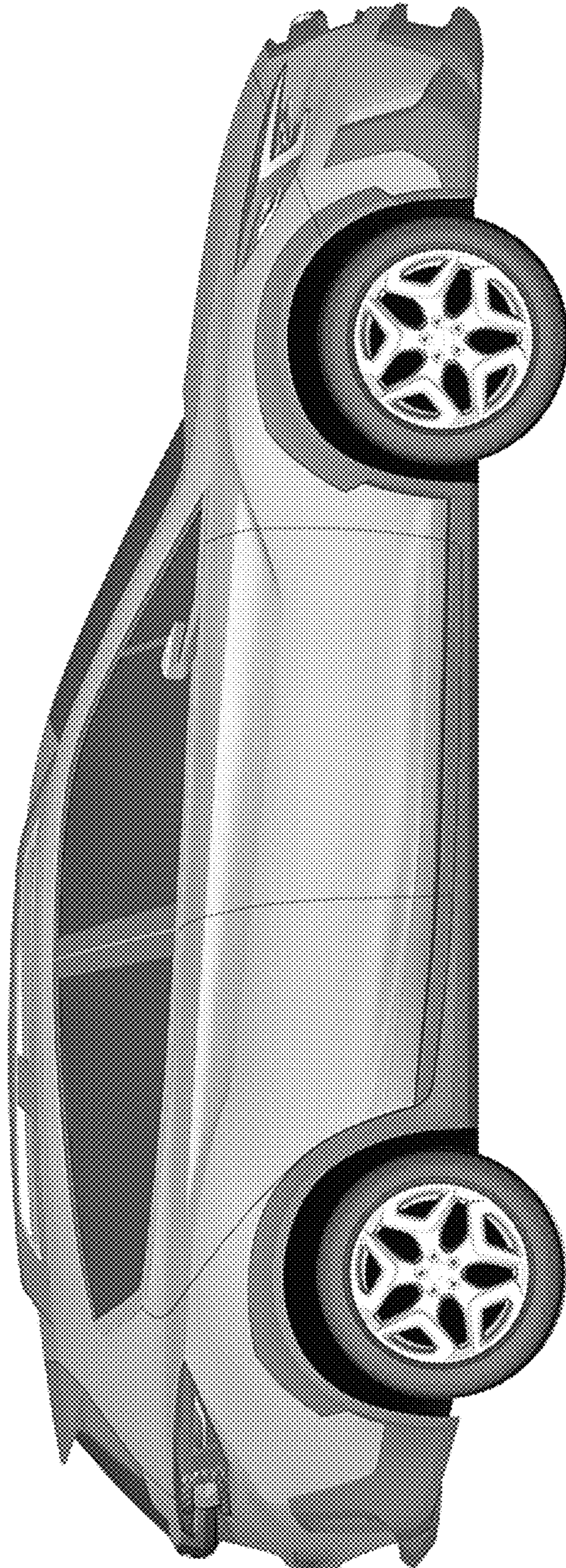
