(57) **CLAIM**

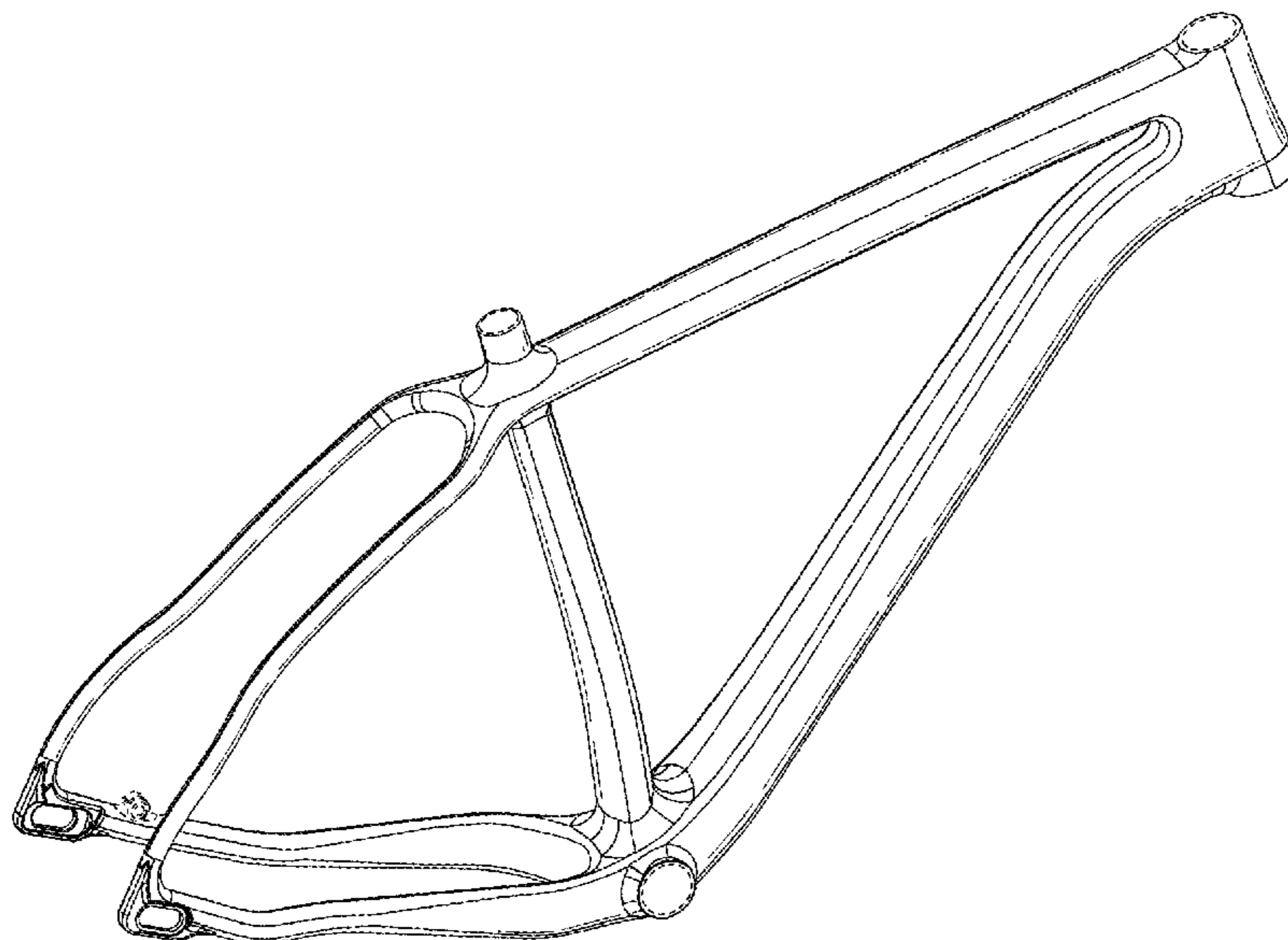
The ornamental design for a bicycle frame, substantially as shown and described.

**DESCRIPTION**

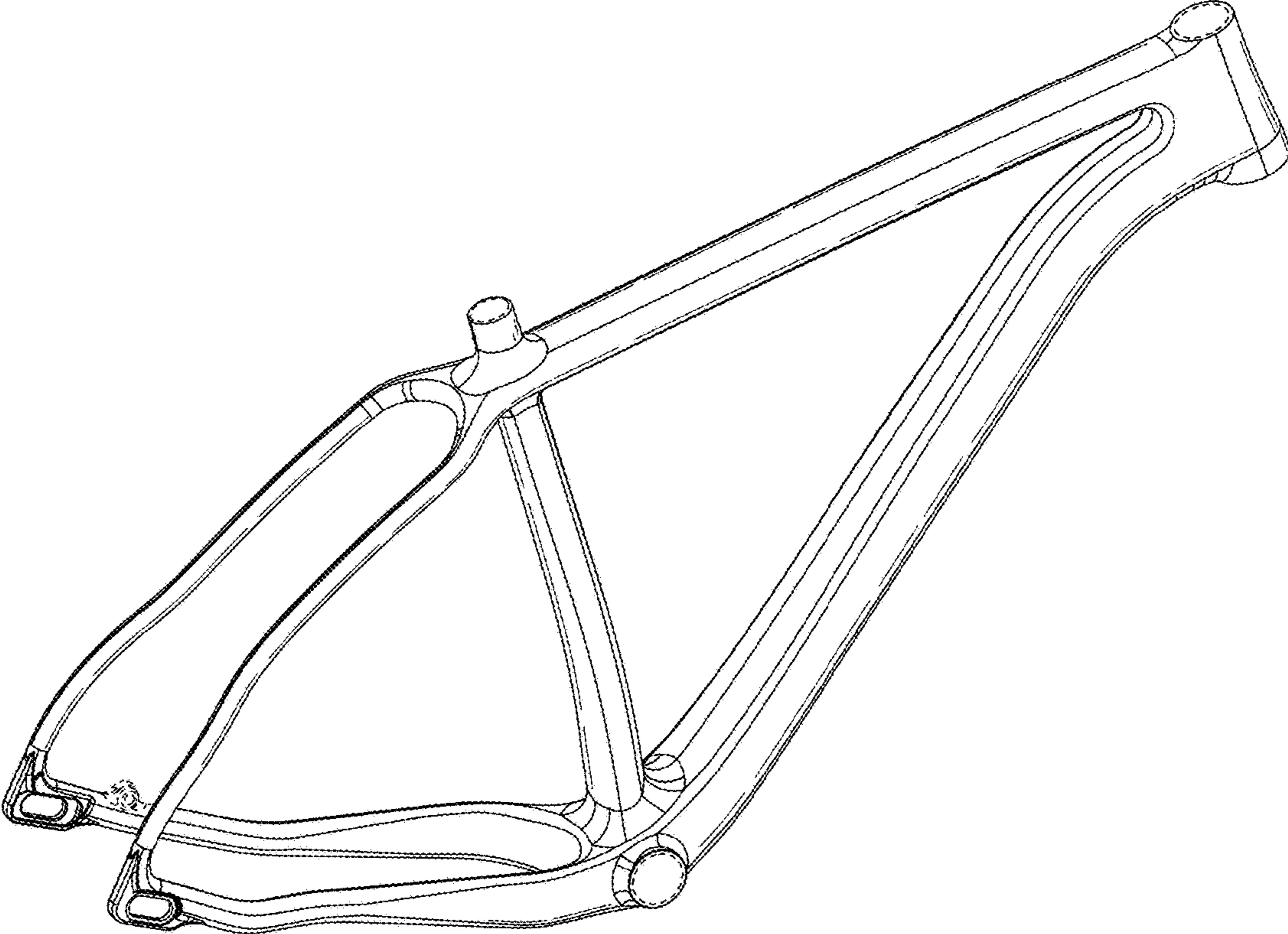

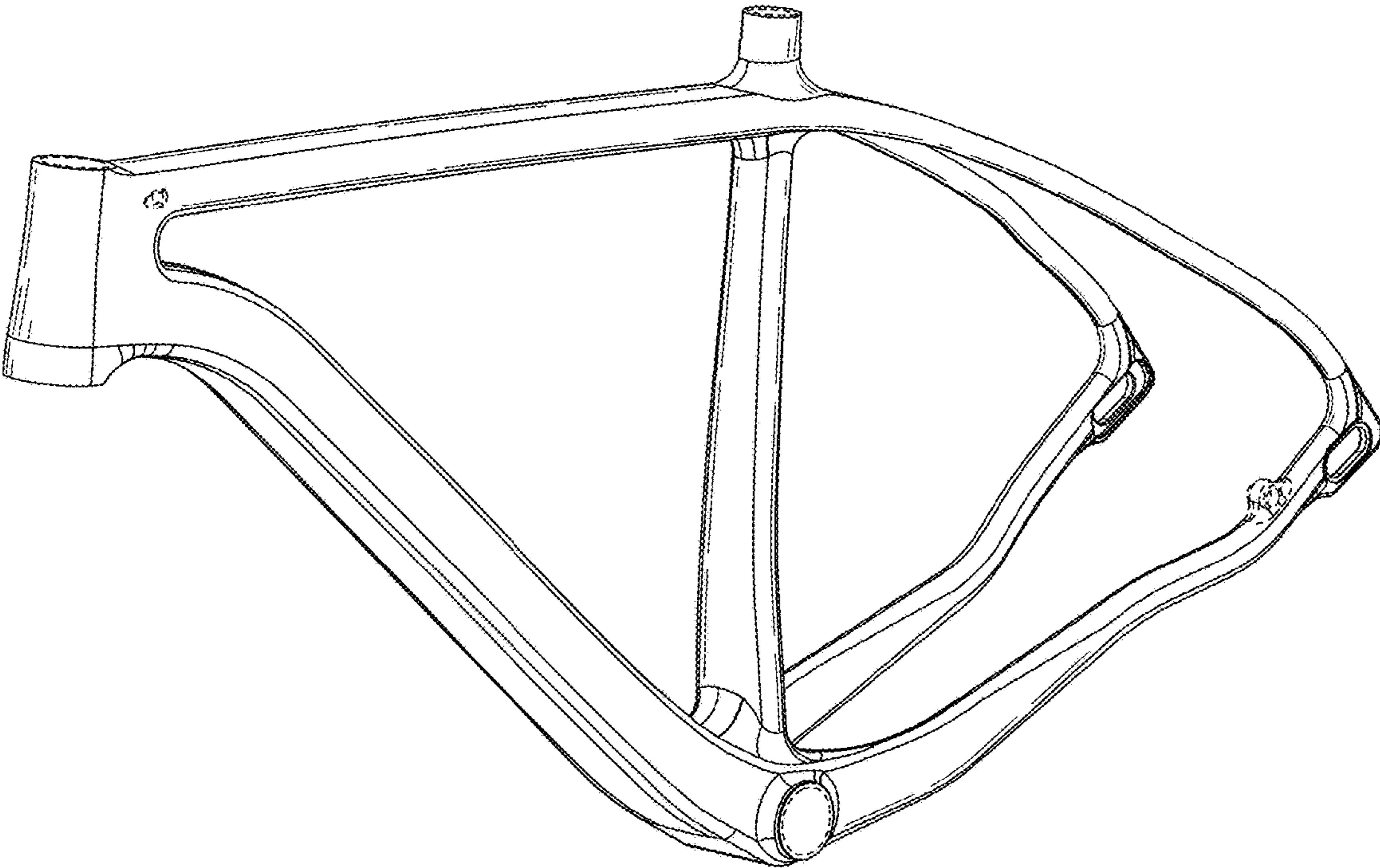

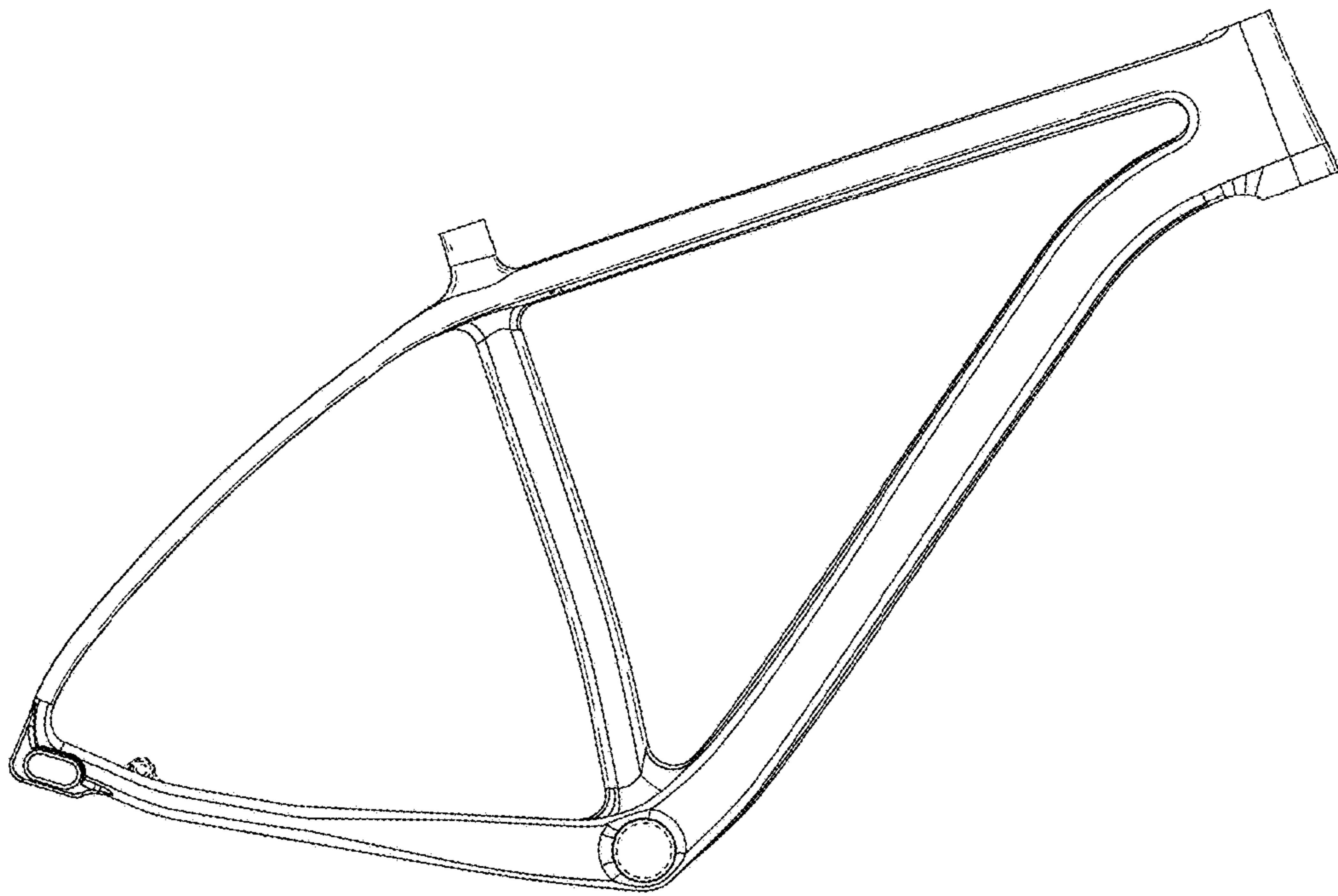

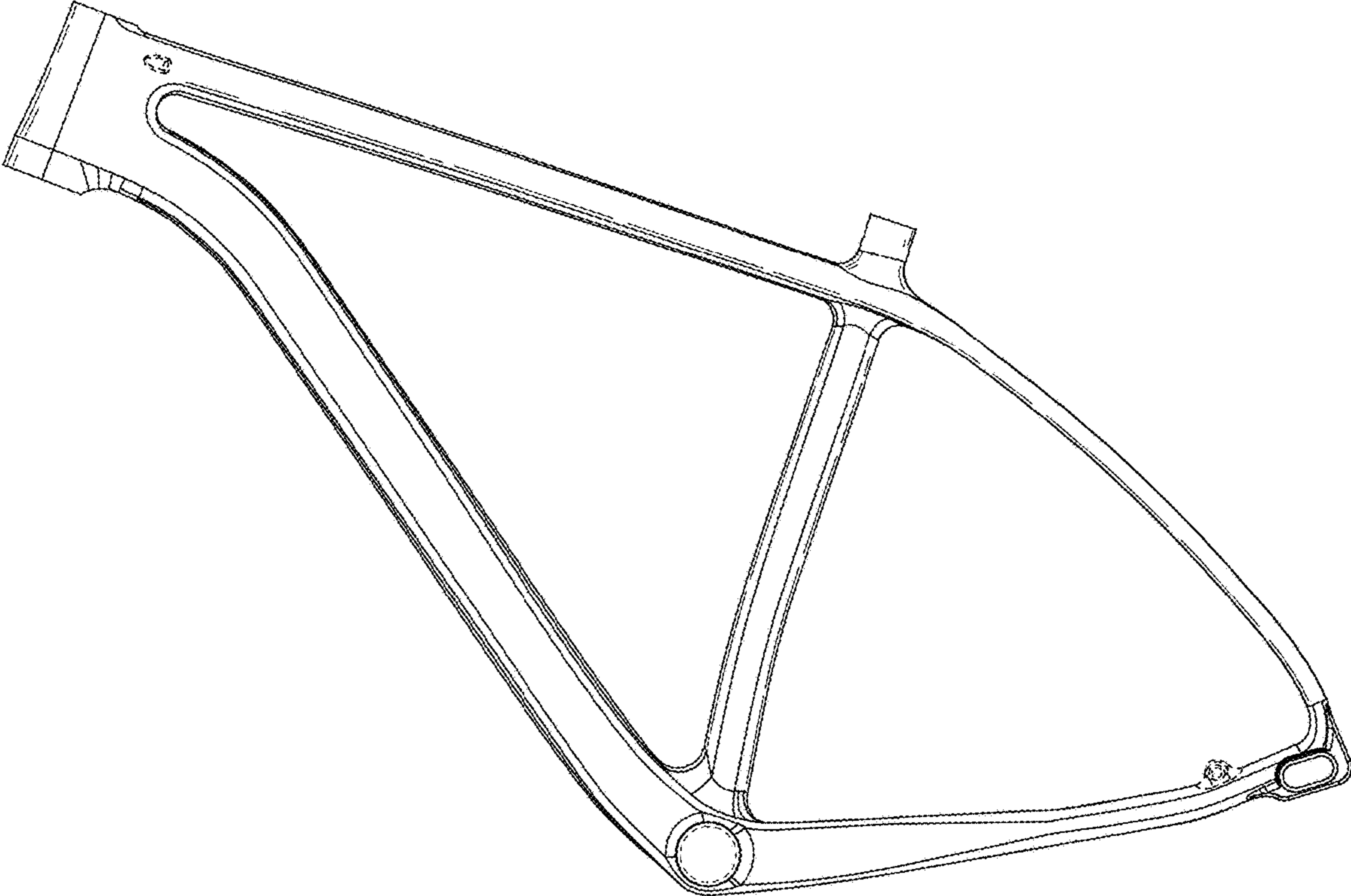

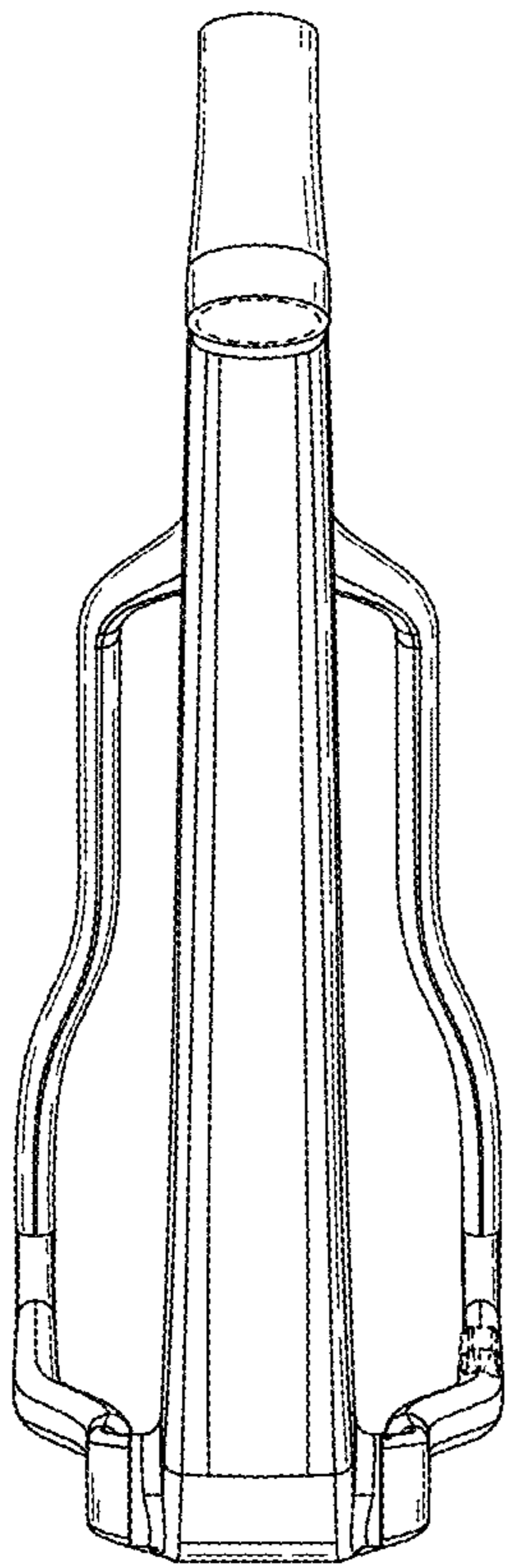

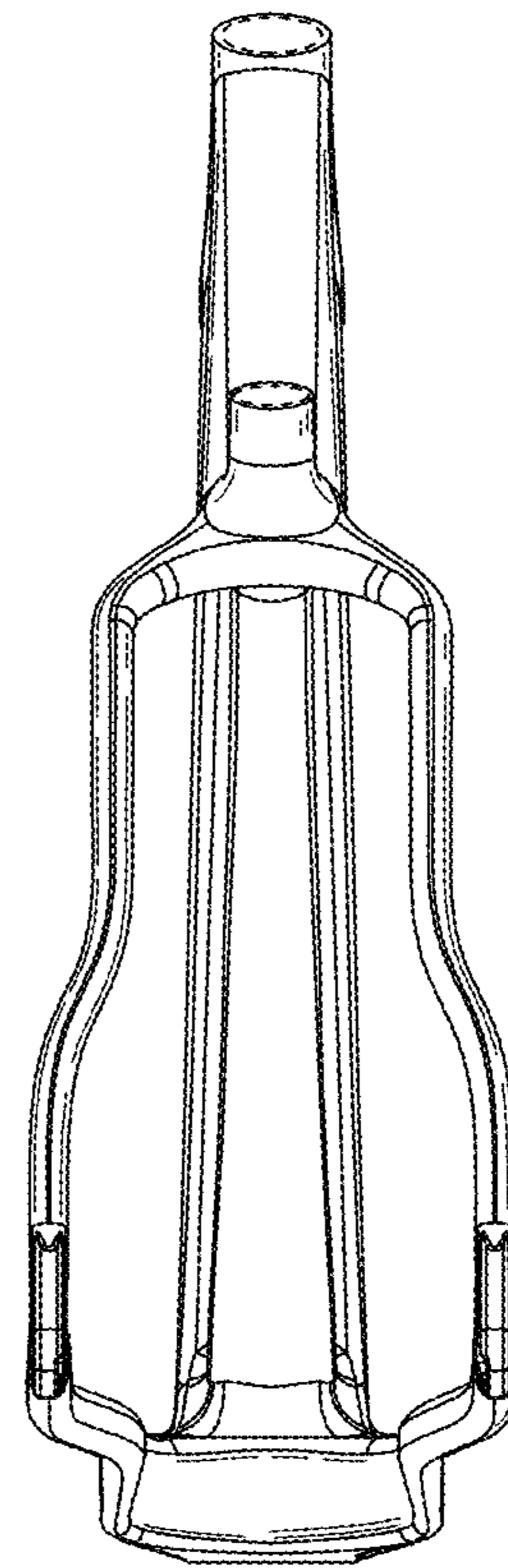

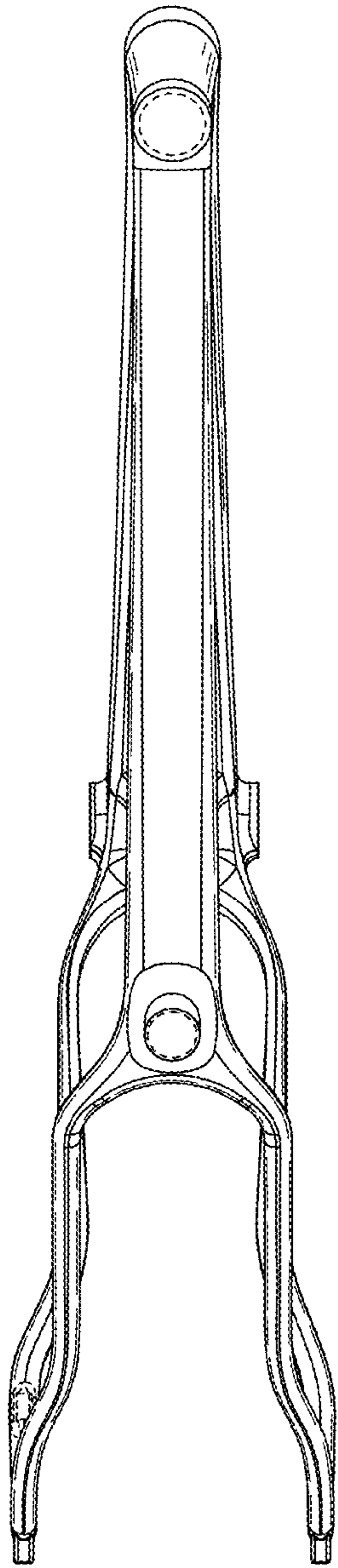

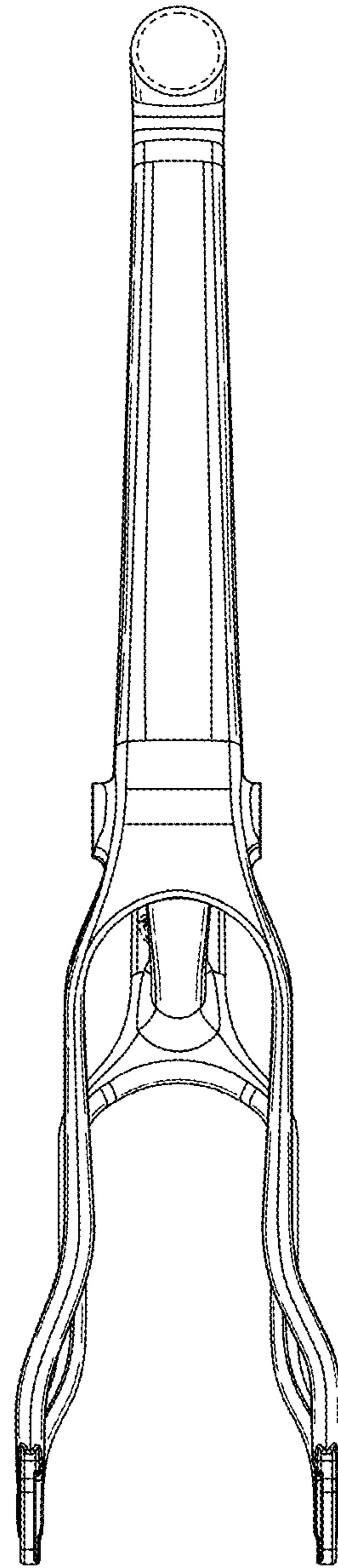
