(57) **CLAIM**

The ornamental design for a vehicle bonnet vent, as shown and described.

DESCRIPTION

FIG. 1 is a right front perspective view of a bonnet vent for a vehicle according to the present invention.

FIG. 2 is a left rear perspective view of the bonnet vent shown in FIG. 1.

FIG. 3 is a right side view thereof.

FIG. 4 is a left side view thereof.

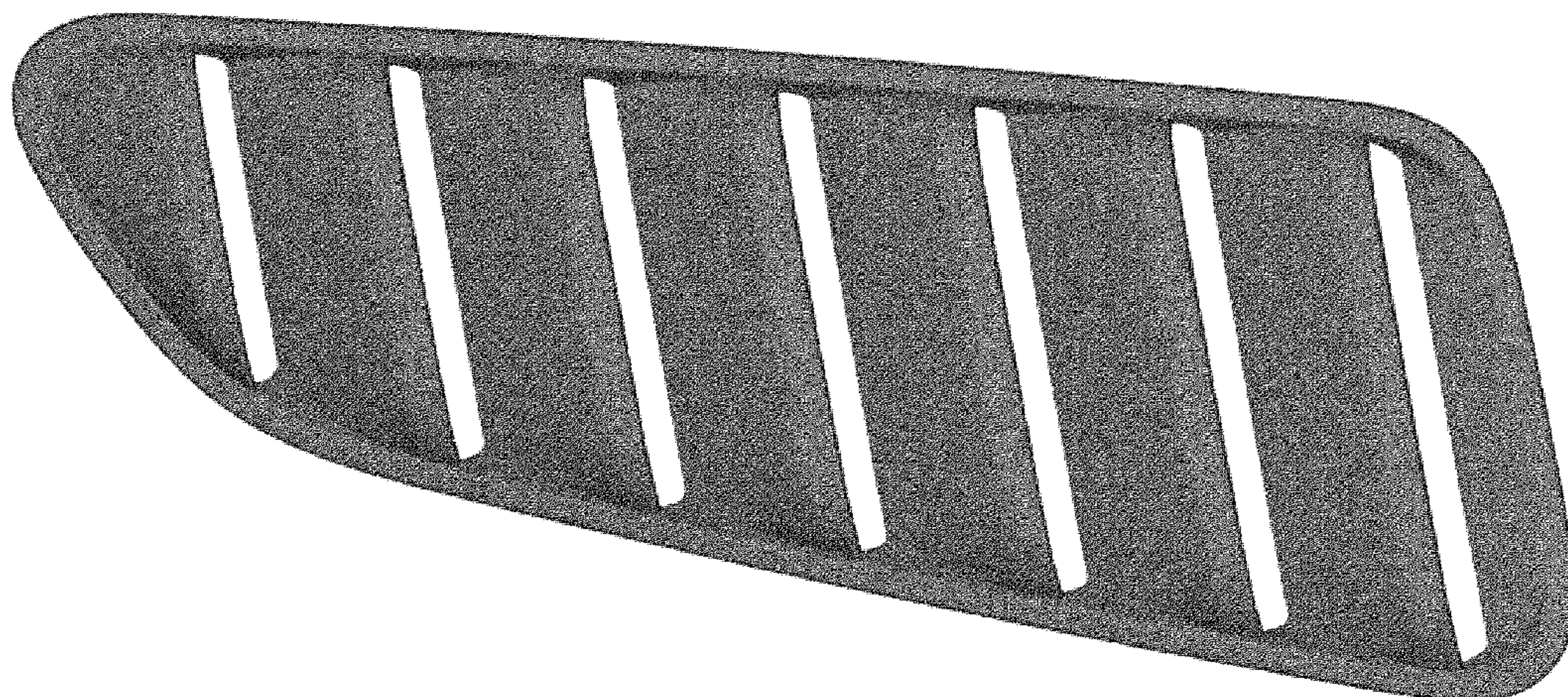
FIG. 5 is a front view thereof.

FIG. 6 is a rear view thereof.

FIG. 7 is a top view thereof; and,

FIG. 8 is a top view of the bonnet vent shown in FIG. 1, with the bonnet vent shown mounted on a vehicle that is depicted in de-emphasized and halftone portions so as to illustrate the structural environment that surrounds the bonnet vent. These portions form no part of the claimed invention. More particularly, in FIG. 8, the bonnet vent of the present invention is shown within the broken lines, and any elements shown outside of the broken lines form no part of the claimed invention, but are instead included to show environmental aspects of the claimed invention.

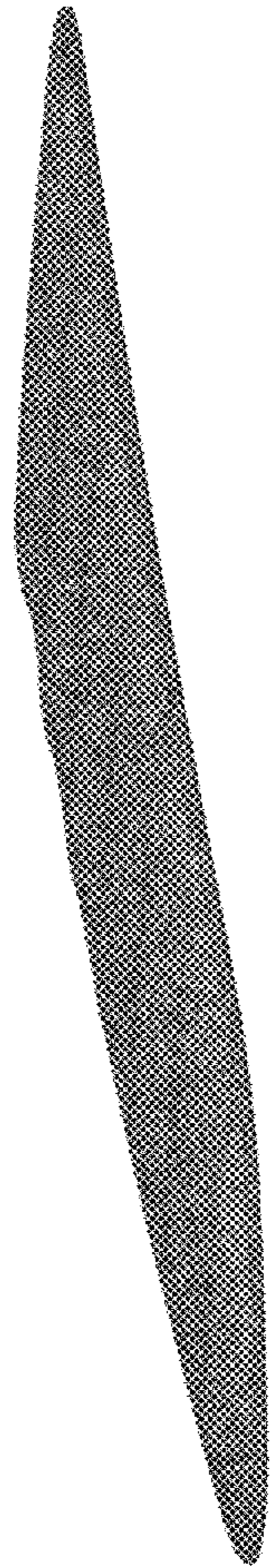

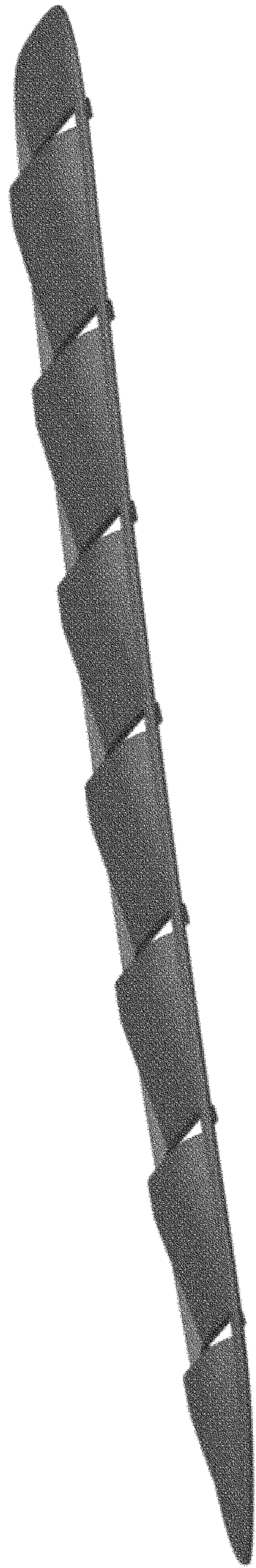

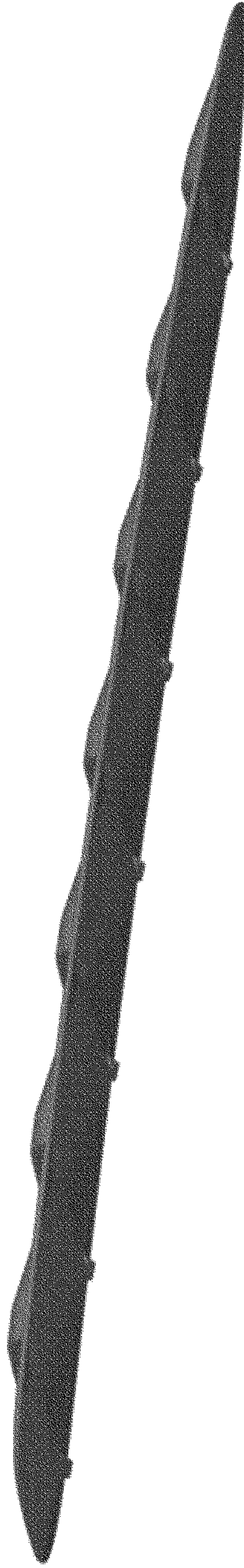

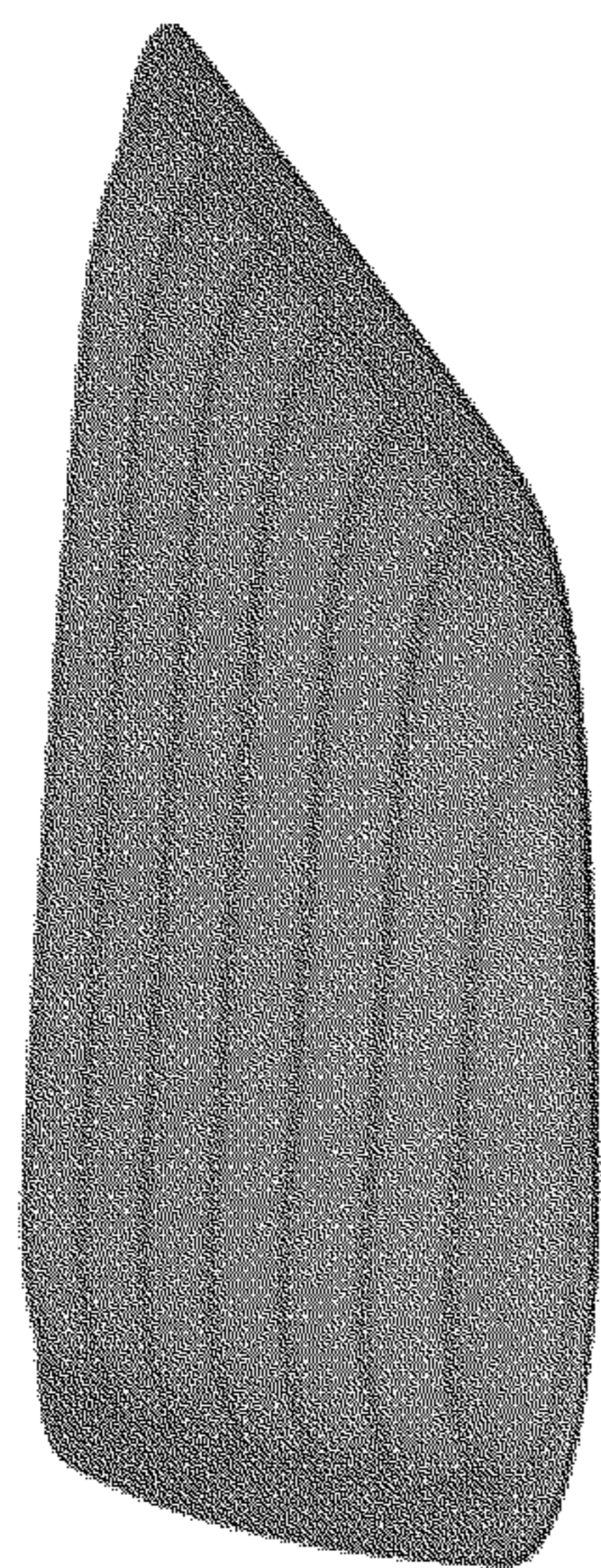

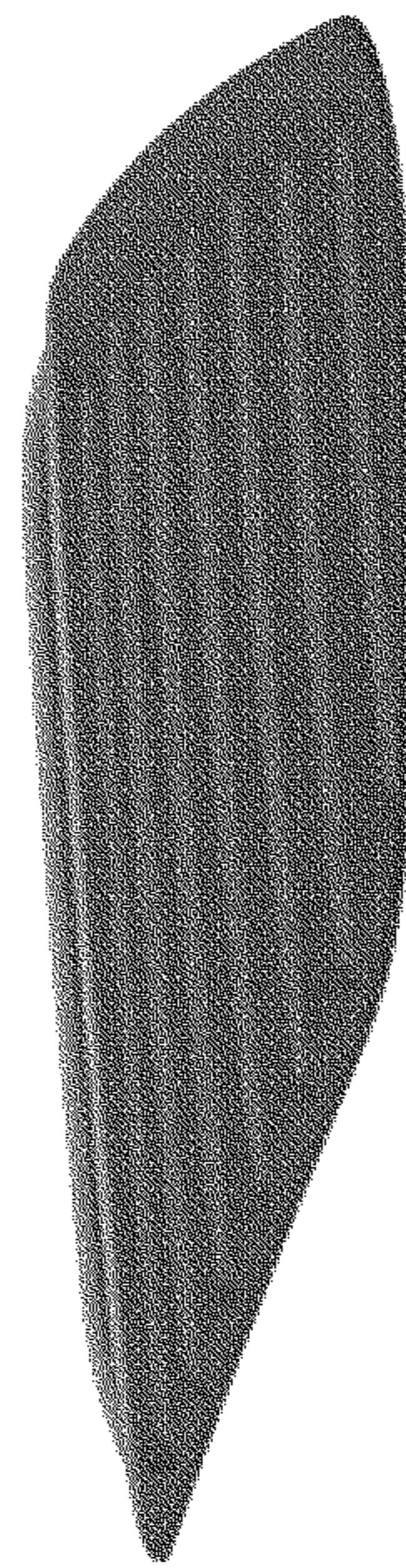

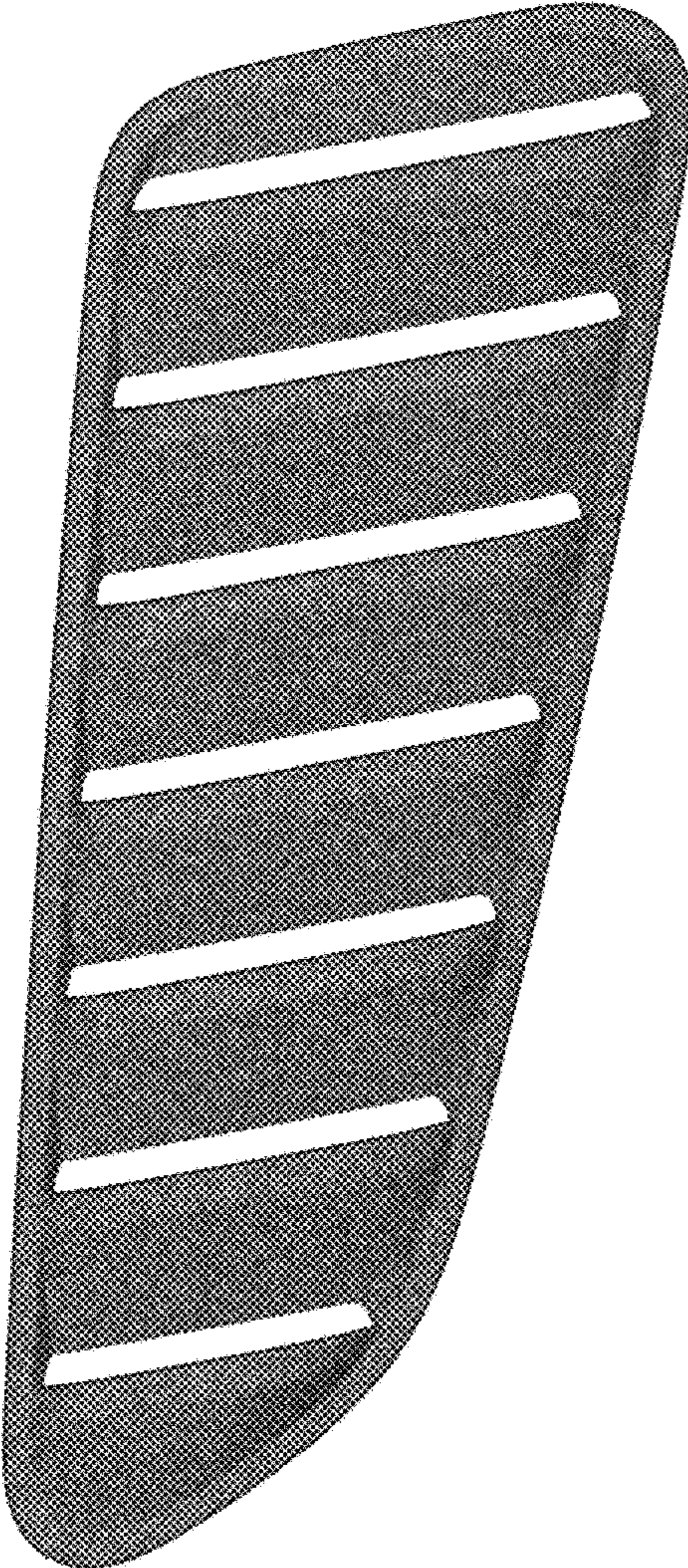

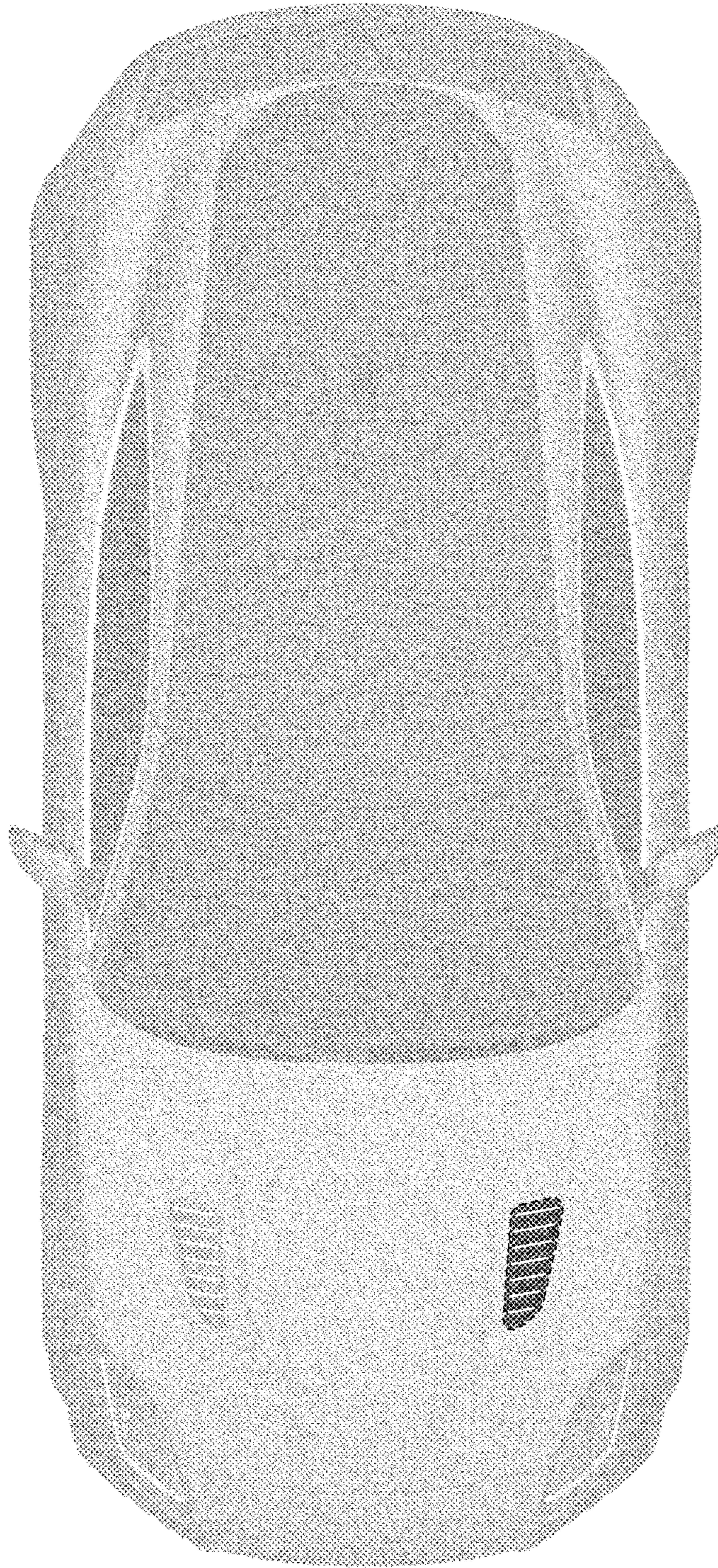
