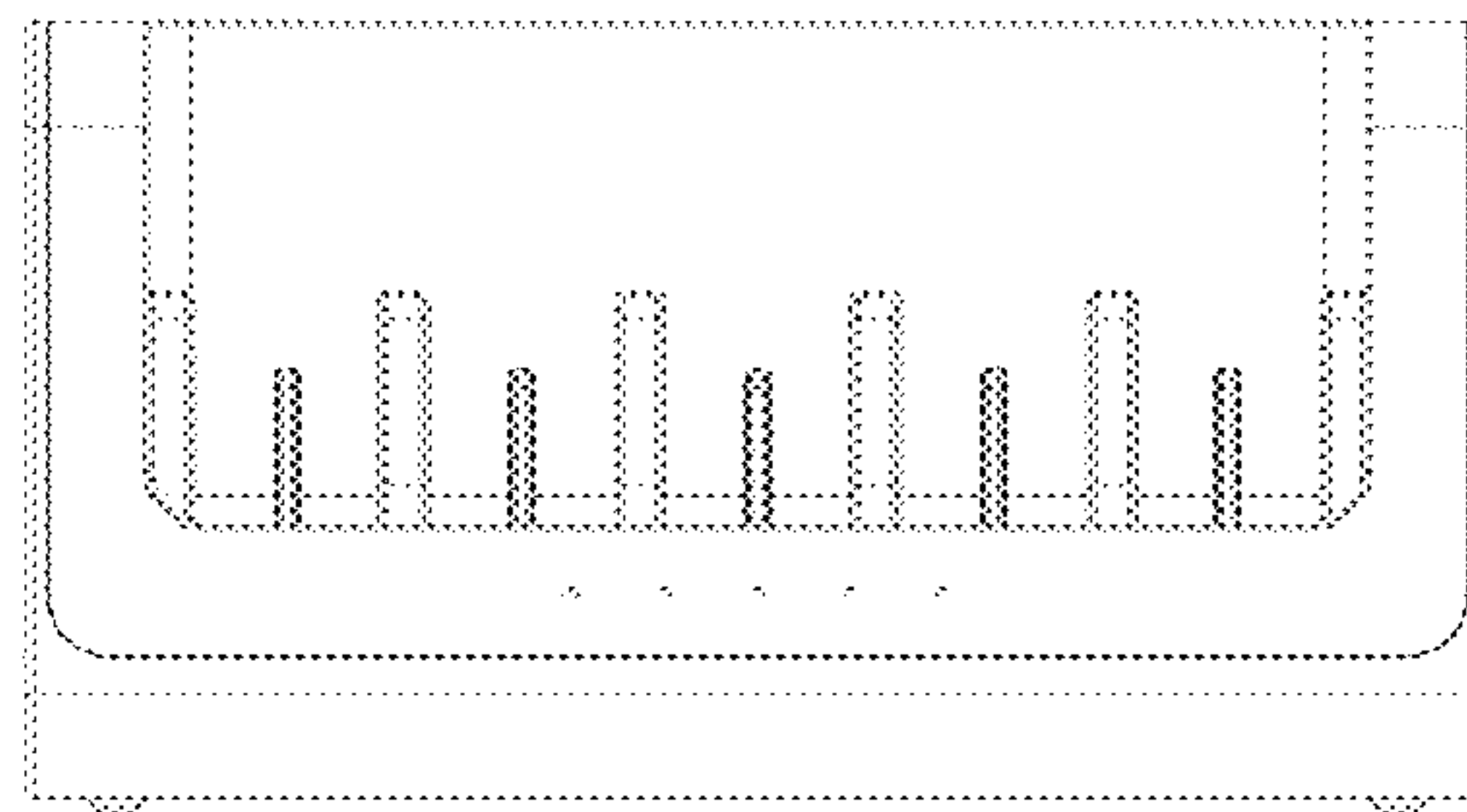
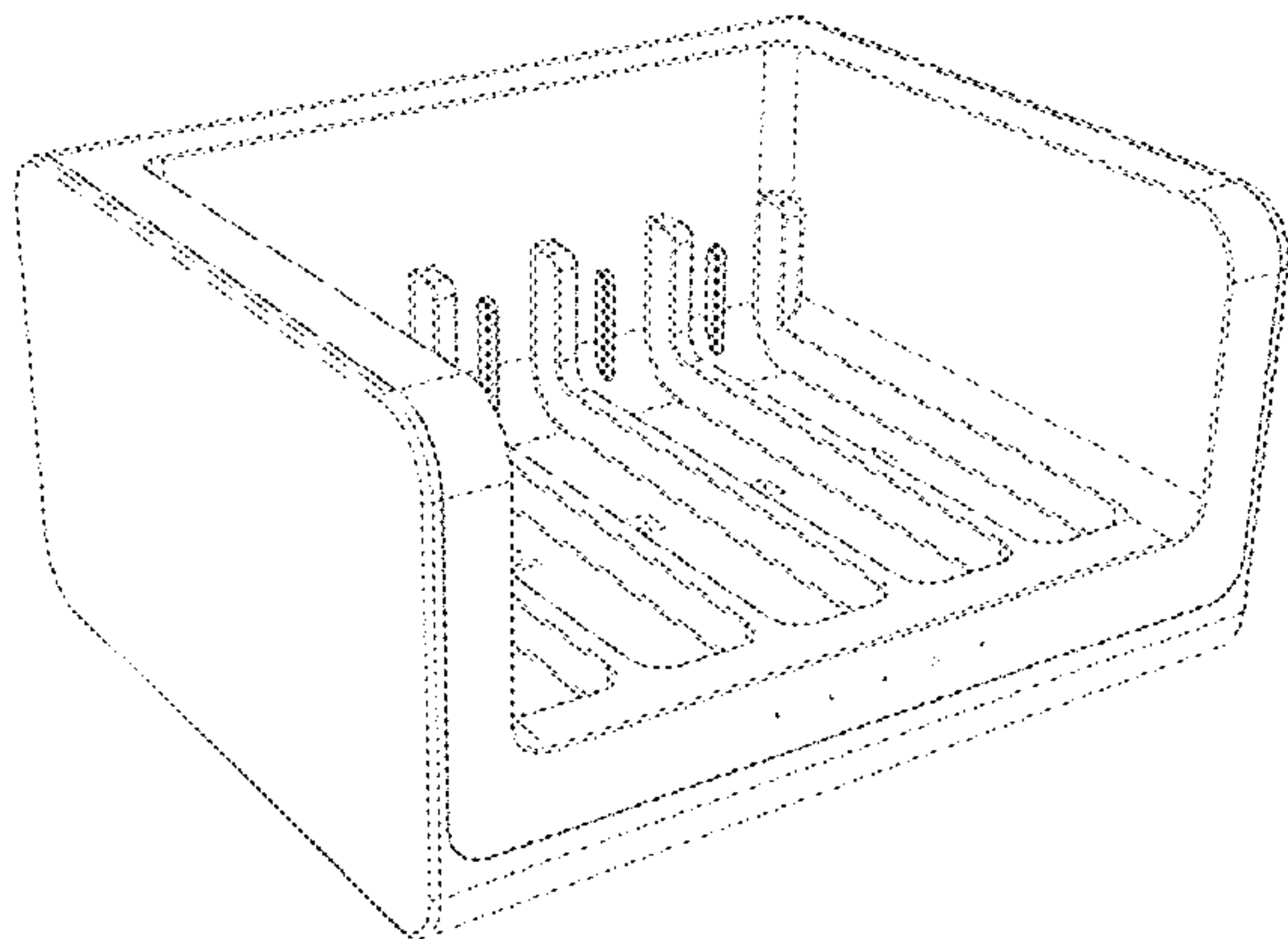
The ornamental design for a charging station for multi-media device, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a charging station for multi-media device in accordance with the present design; FIG. 2 is a front elevational view thereof; FIG. 3 is a rear elevational view thereof; FIG. 4 is a right side elevational view thereof; FIG. 5 is a left side elevational thereof; FIG. 6 is a top plan view thereof; FIG. 7 is a bottom plan view thereof; and, FIG. 8 is a front perspective view of the charging station for multi-media device in the environment of multiple multi-media devices.

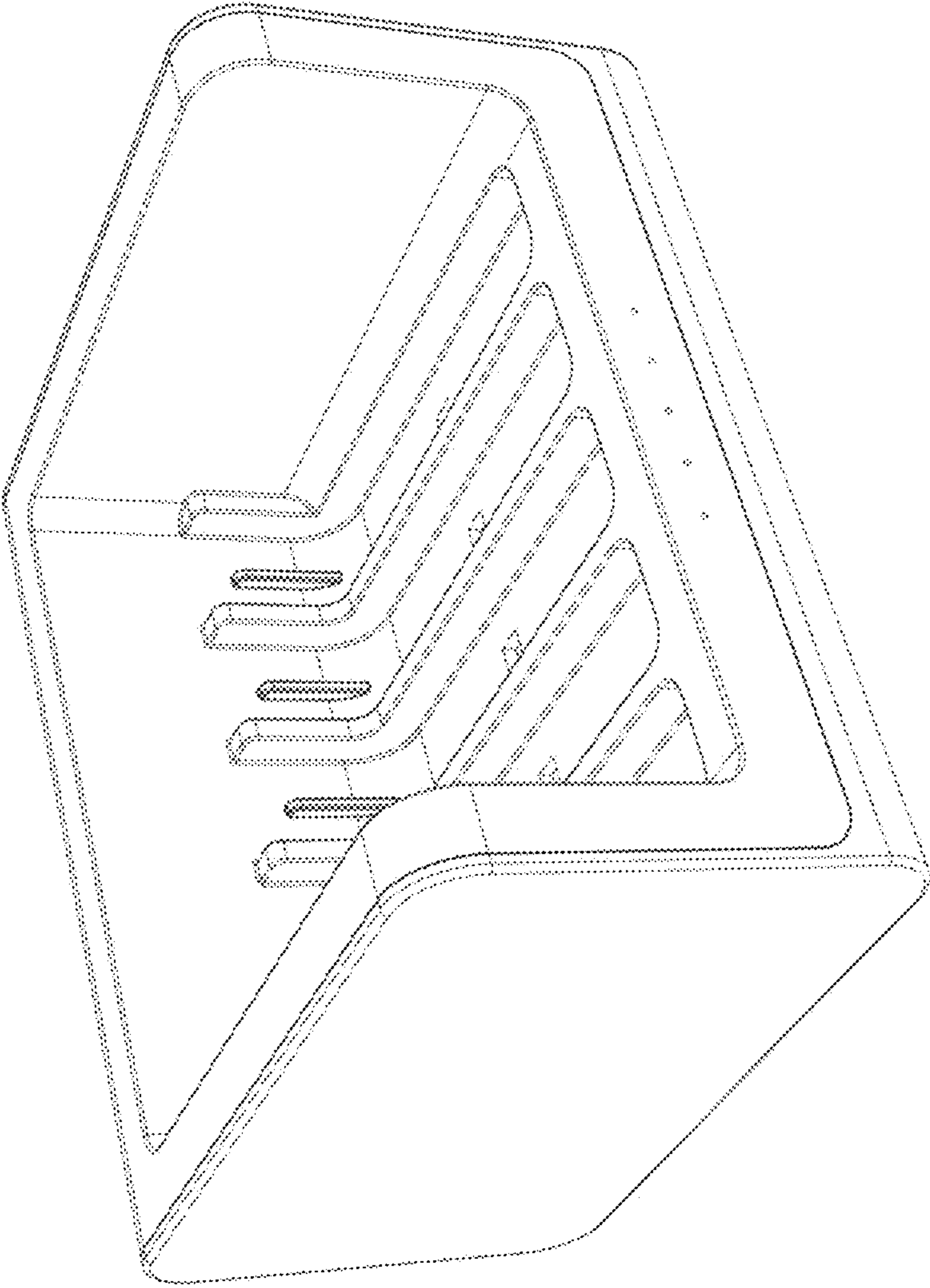

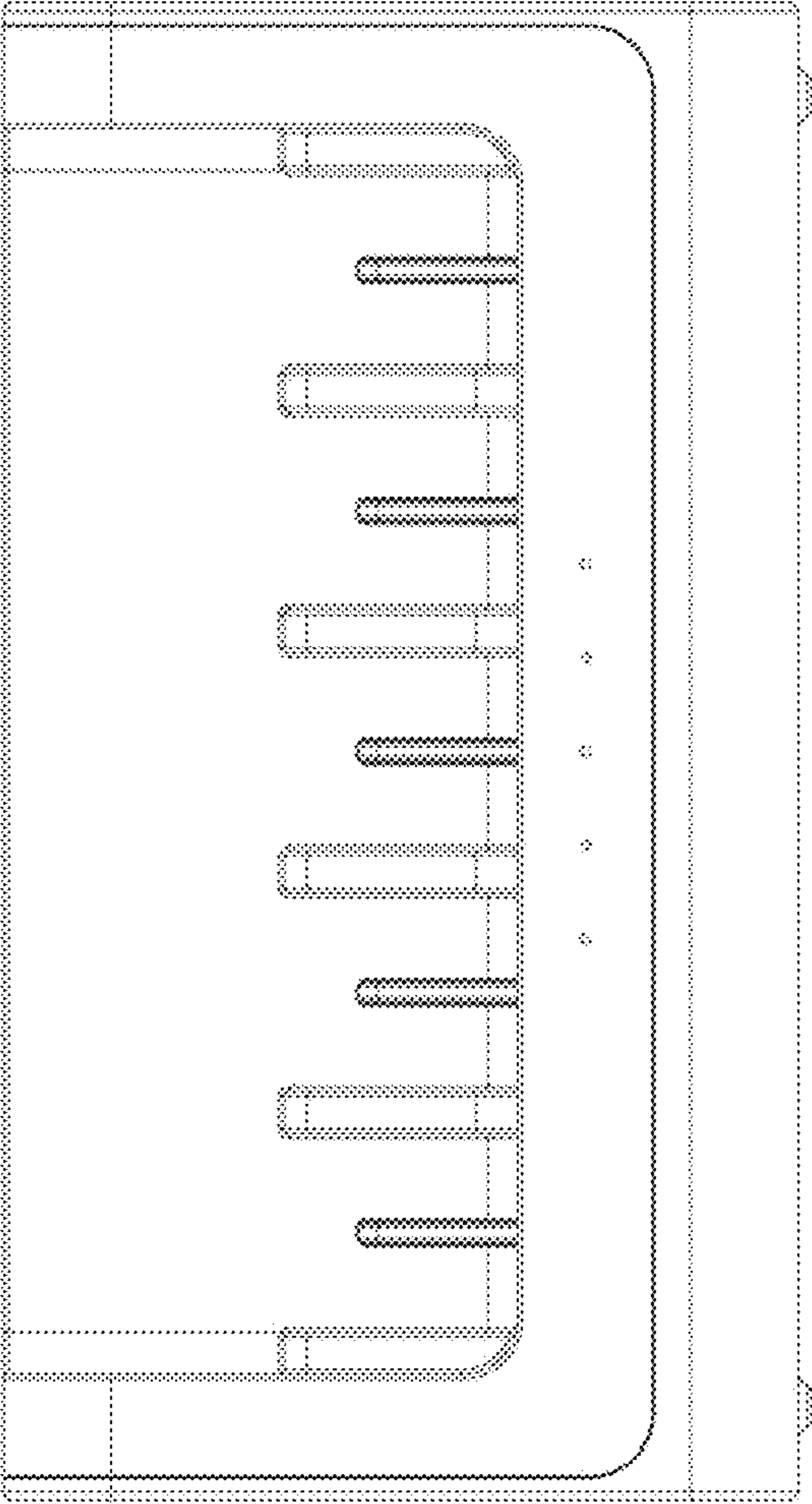

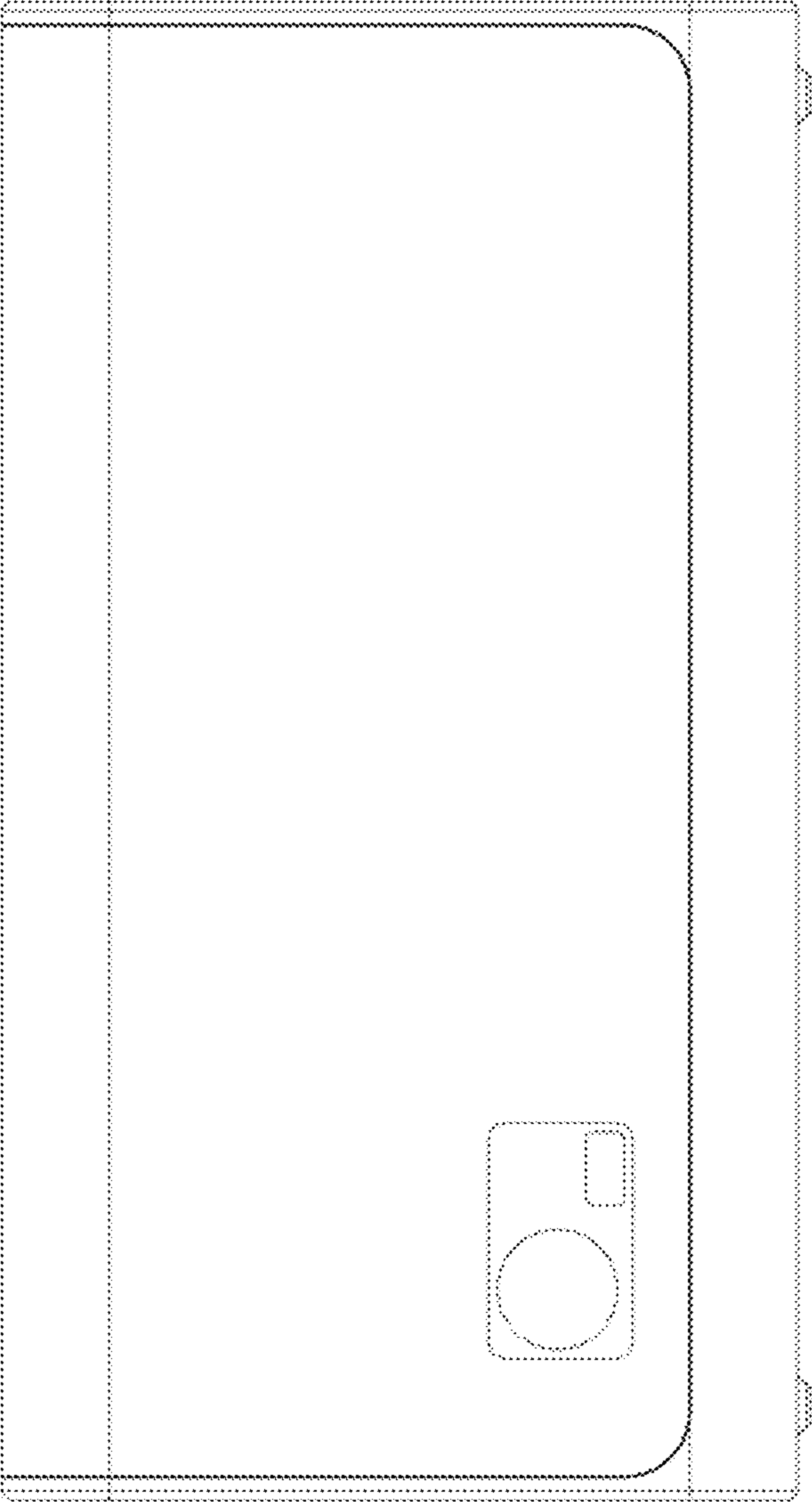

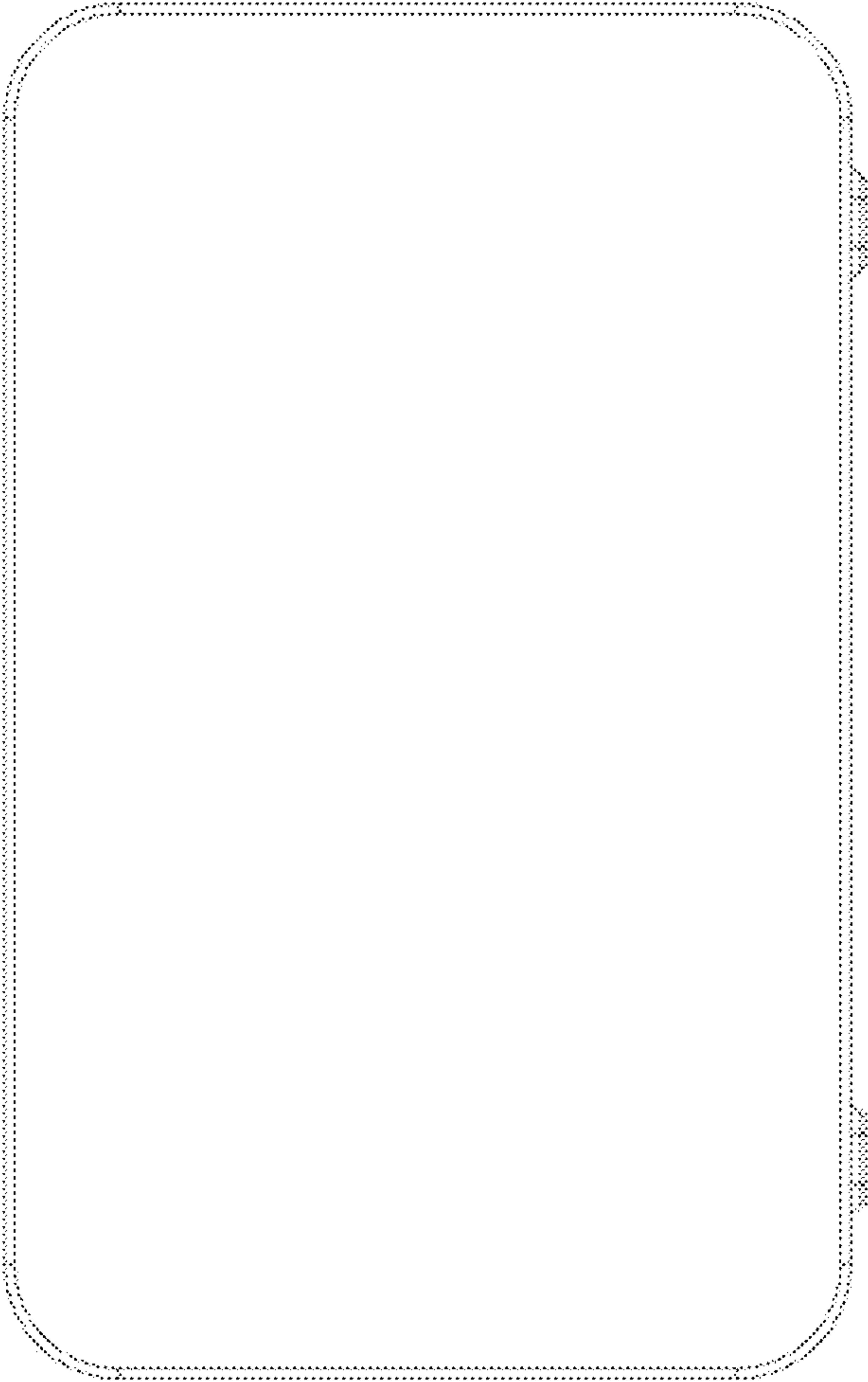

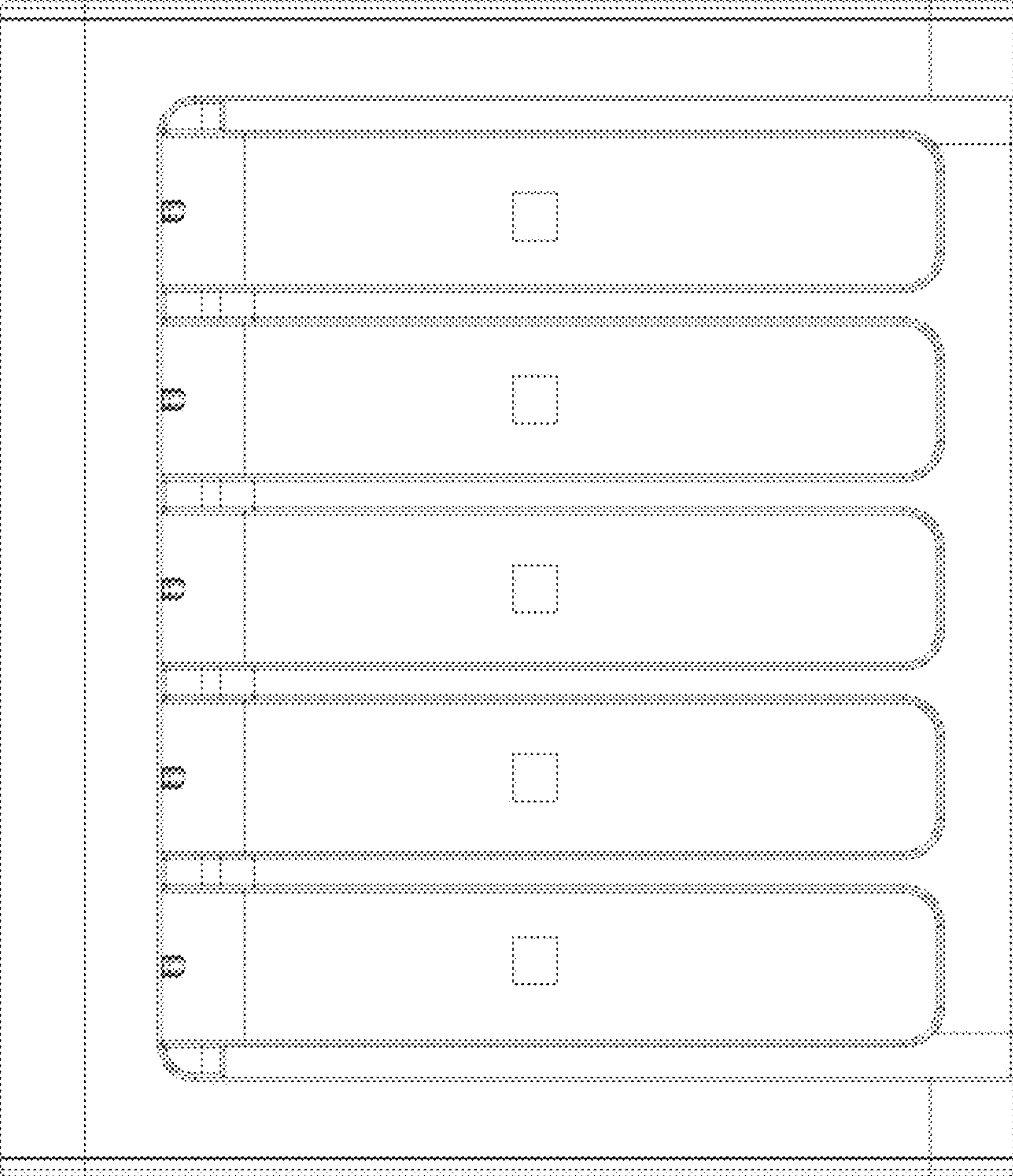

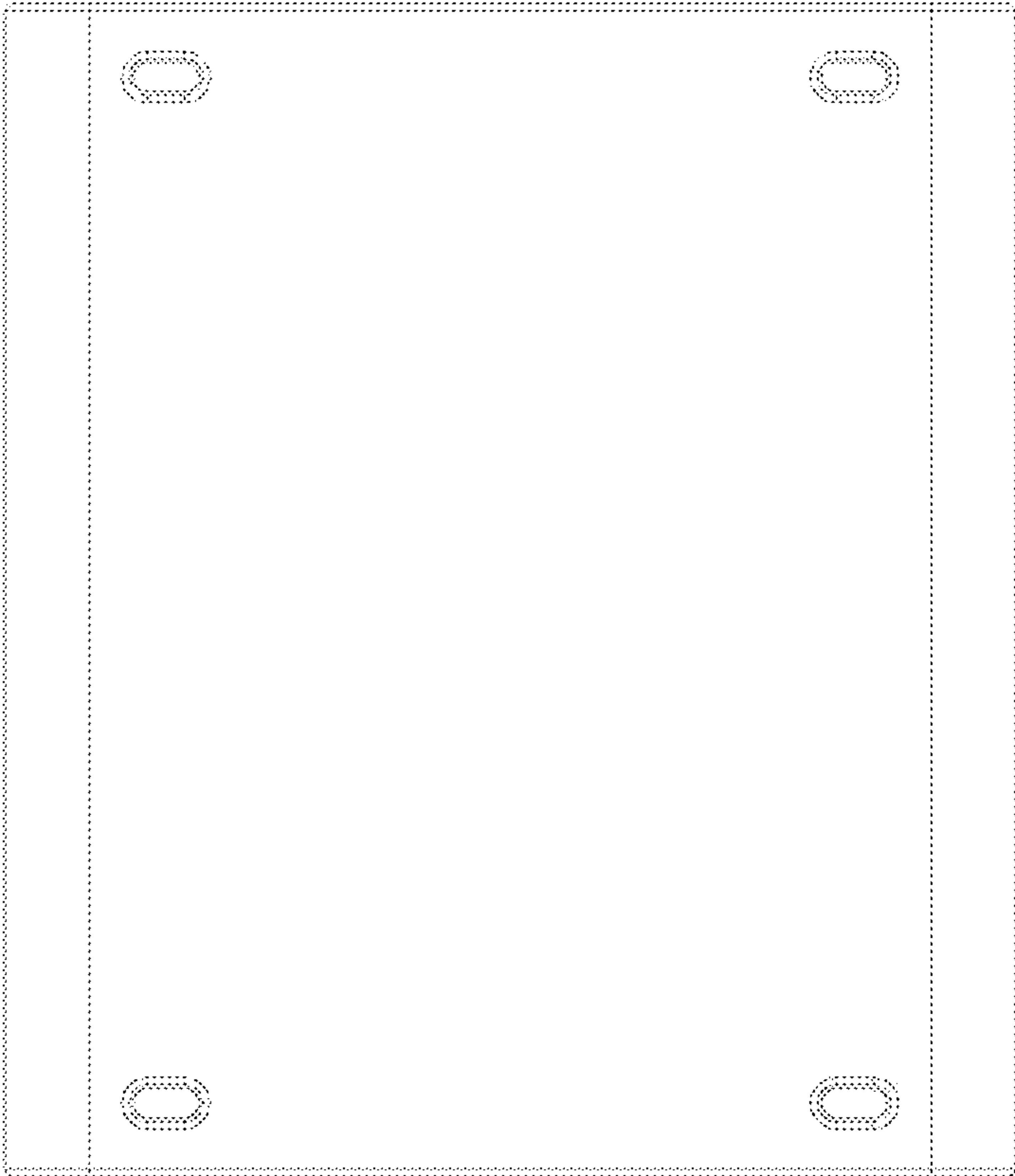

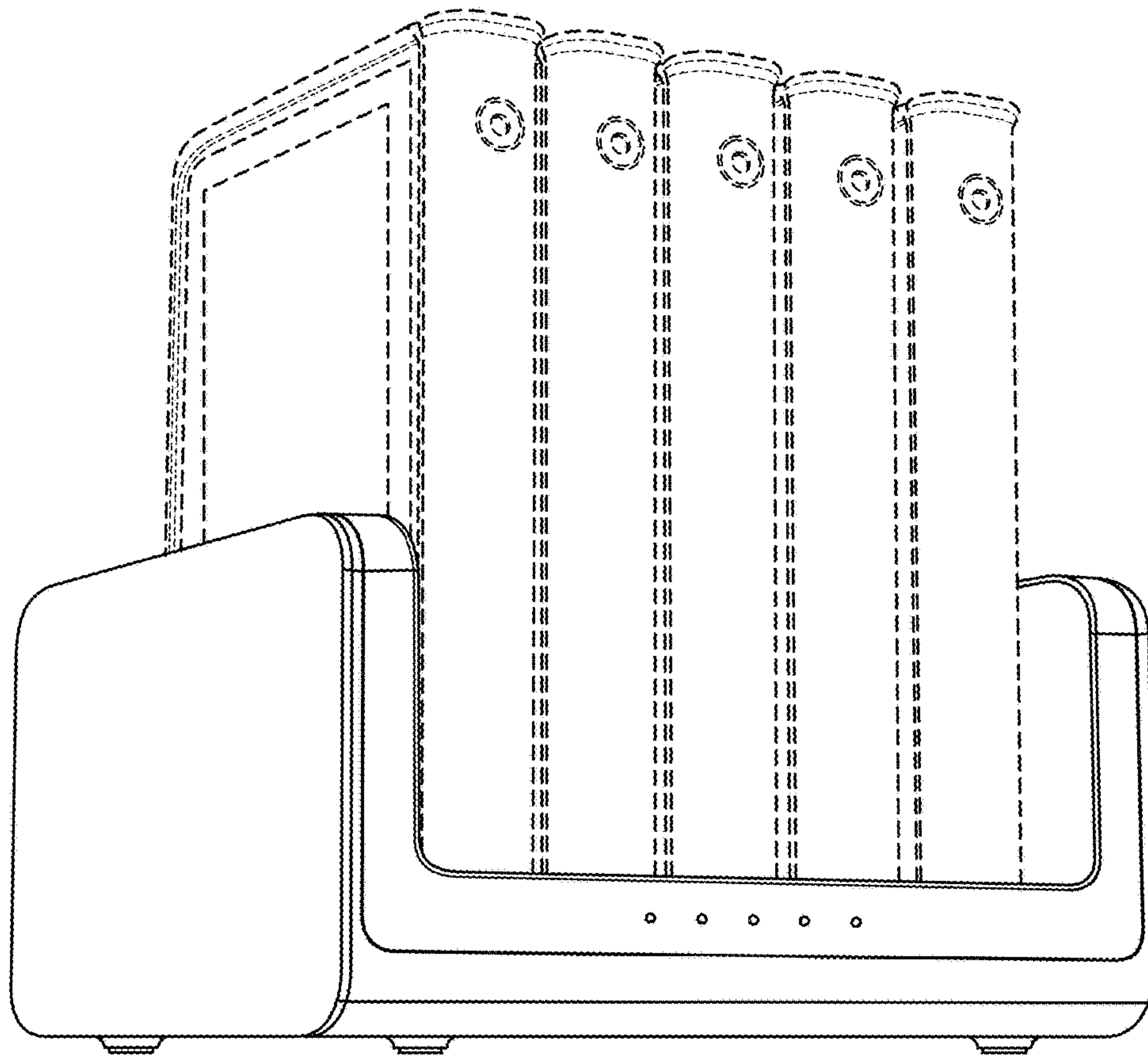
