We claim, the ornamental design for a display screen or portion thereof with graphical user interface, as shown and described.

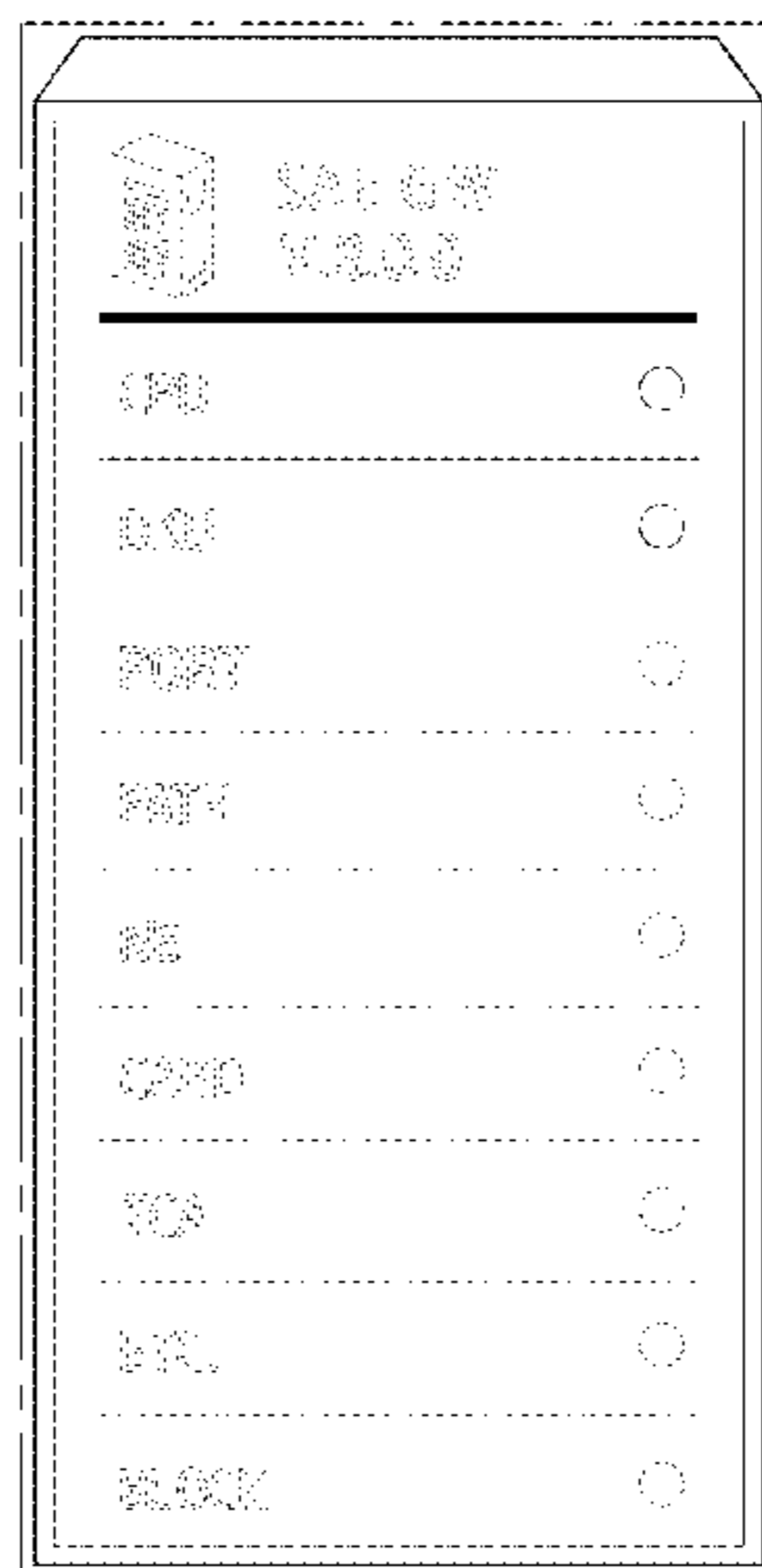
**DESCRIPTION**

FIG. 1 is a front view of a display screen or portion thereof with graphical user interface, showing our new design; and, FIG. 2 is an enlarged view of the encircled portion of FIG. 1.

The outermost broken lines illustrate a display screen or portion thereof and form no part of the claimed design. The remaining broken lines illustrate portions of the graphical user interface that form no part of claimed design.

The dot-dash broken lines encircling enlargement portions of the design form no part of the claimed design.

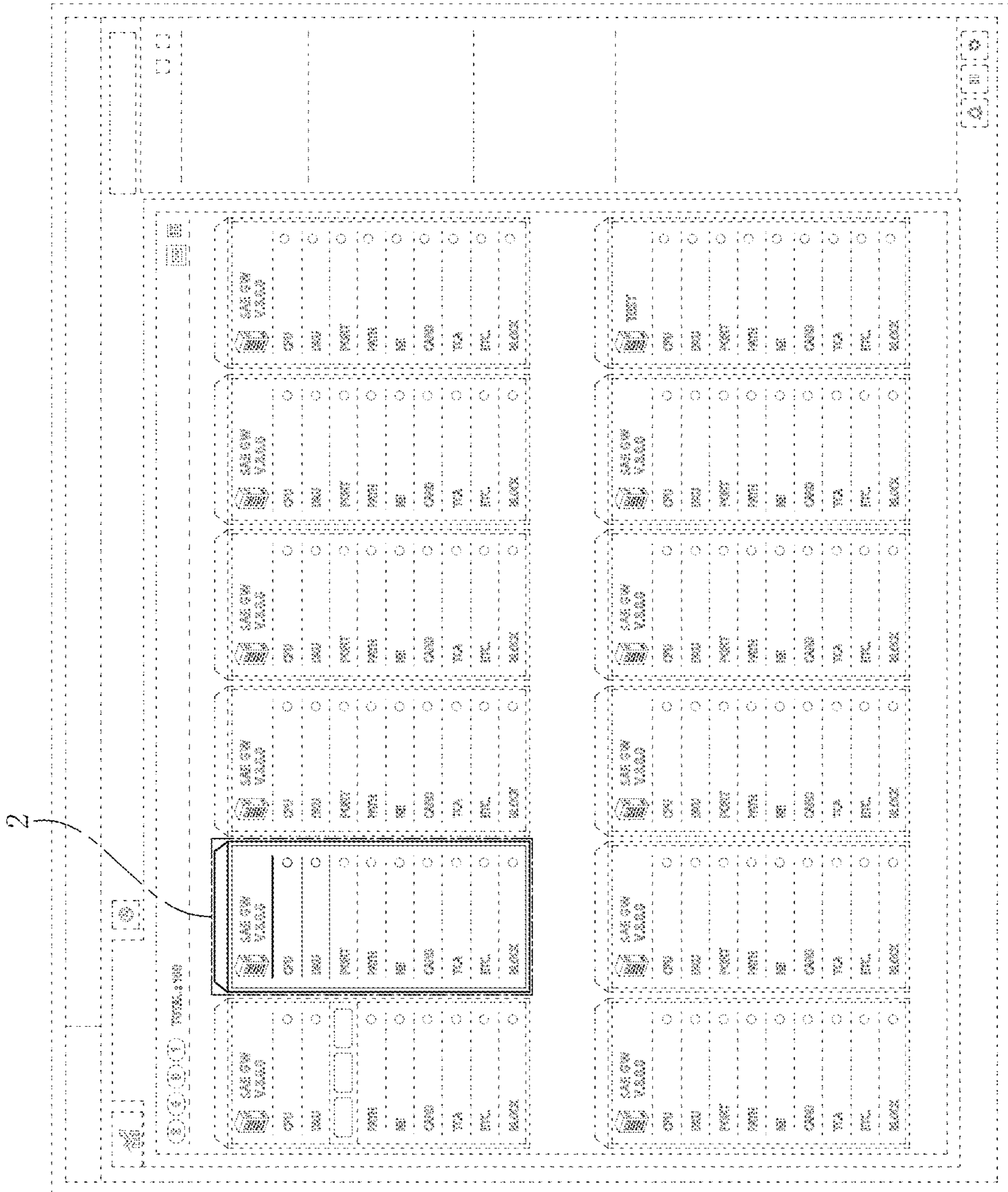
