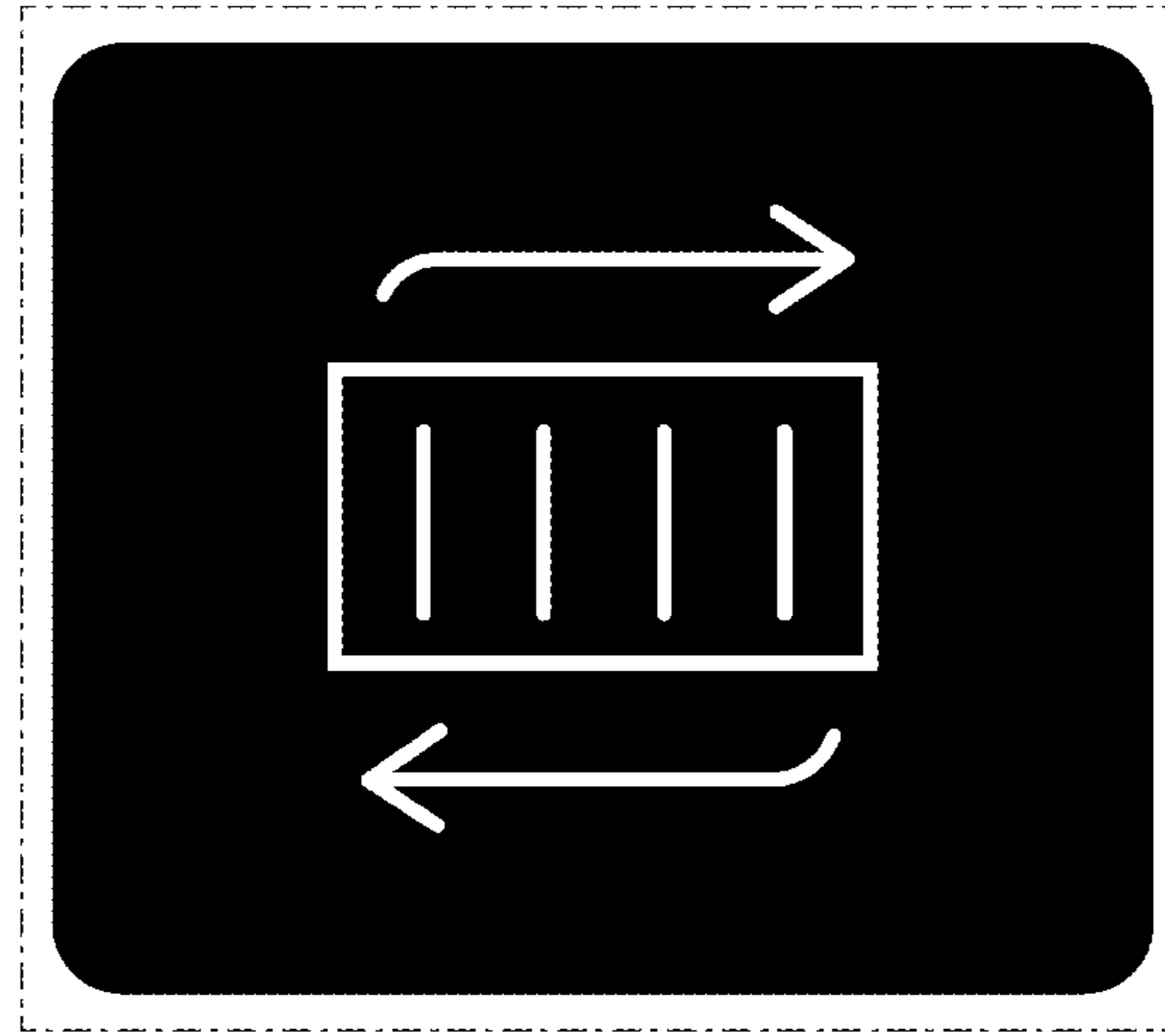
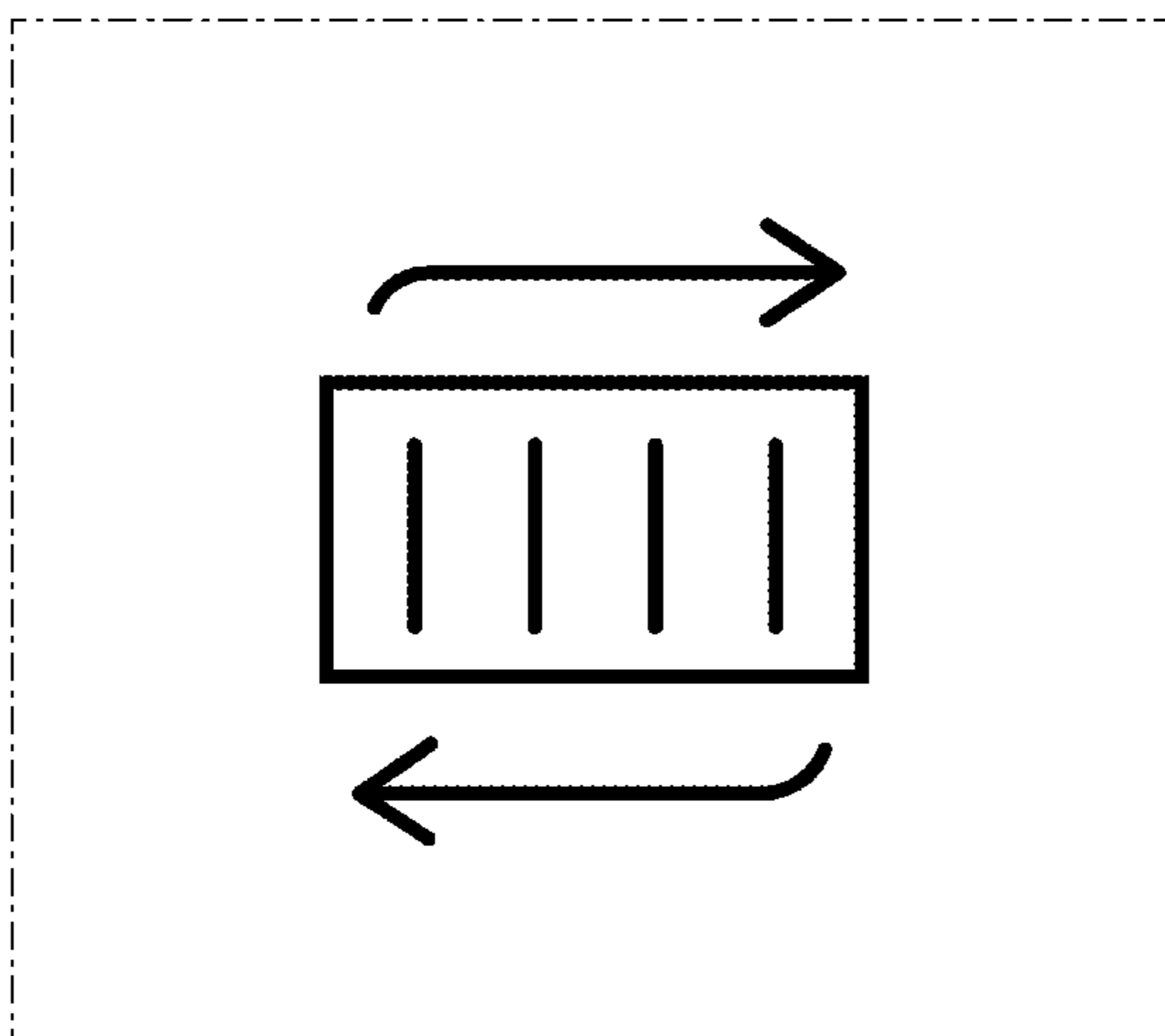
(57) **CLAIM**

The ornamental design for a display screen with animated icon, as shown and described.

**DESCRIPTION**

FIG. 1 is a front view of a first image of a display screen with animated icon showing the new design; and, FIG. 2 is a front view of a second image thereof. The appearance of the image transitions between the images shown in FIGS. 1 and 2. The process or period in which an image transitions to another image forms no part of the claimed design. The broken lines depict a display screen and form no part of the claimed design.

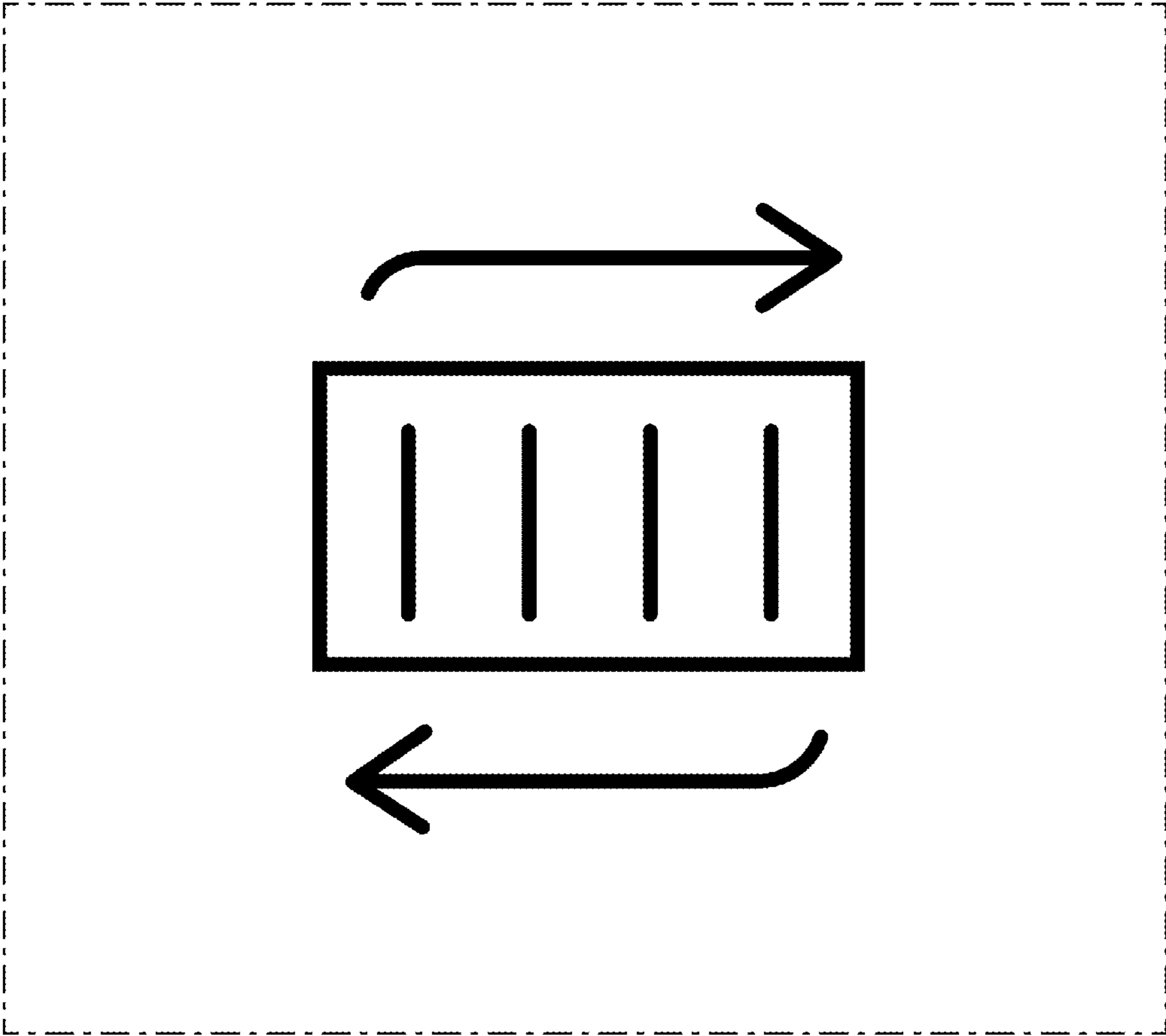

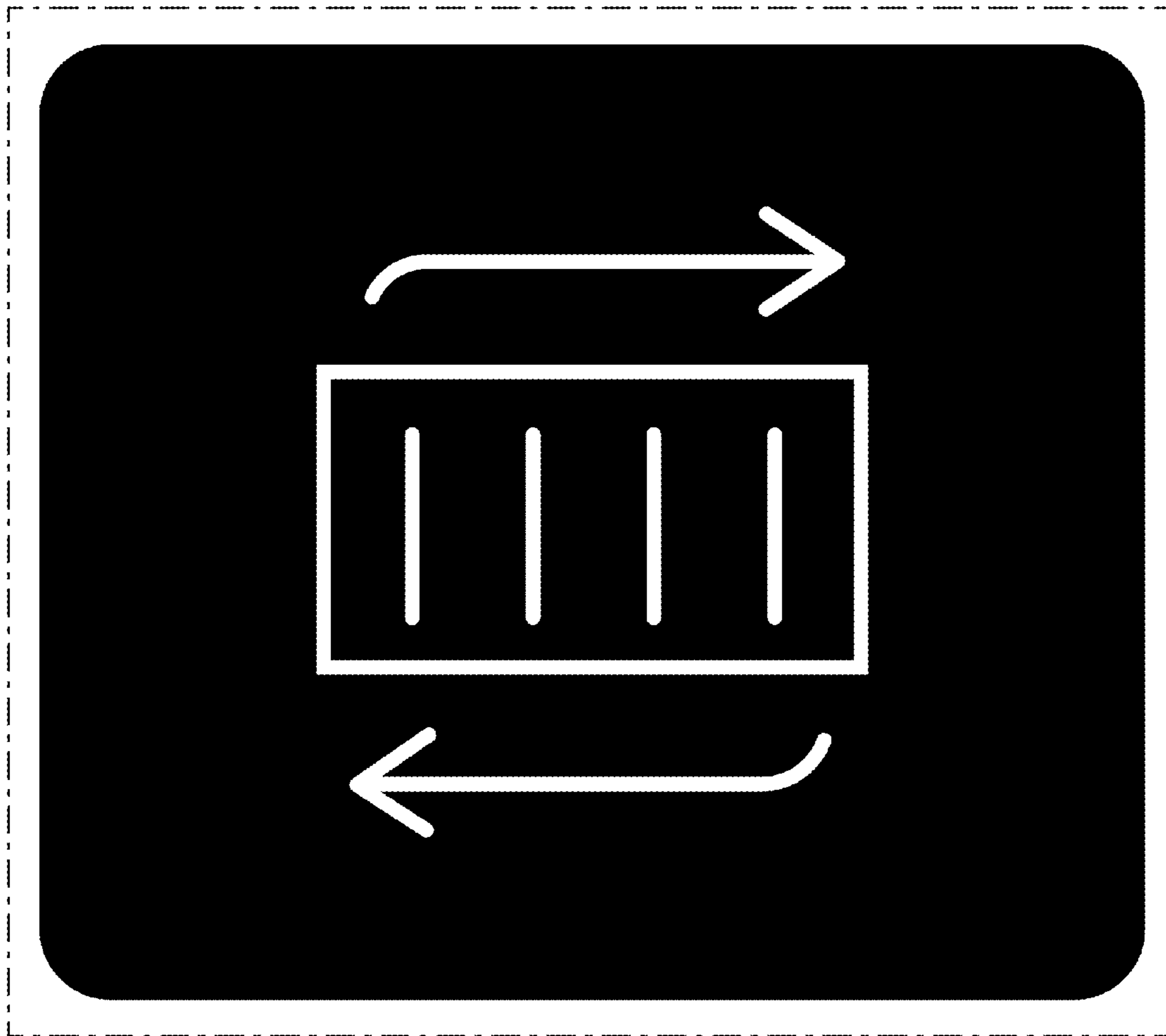
