DESCRIPTION

FIG. 1 is an isometric perspective view of a handle showing my new design;
FIG. 2 is a top view thereof;
FIG. 3 is a side view thereof;
FIG. 4 is a front view thereof;
FIG. 5 is a rear view thereof; and,
FIG. 6 is a perspective view thereof, showing a retention bracket in phantom.

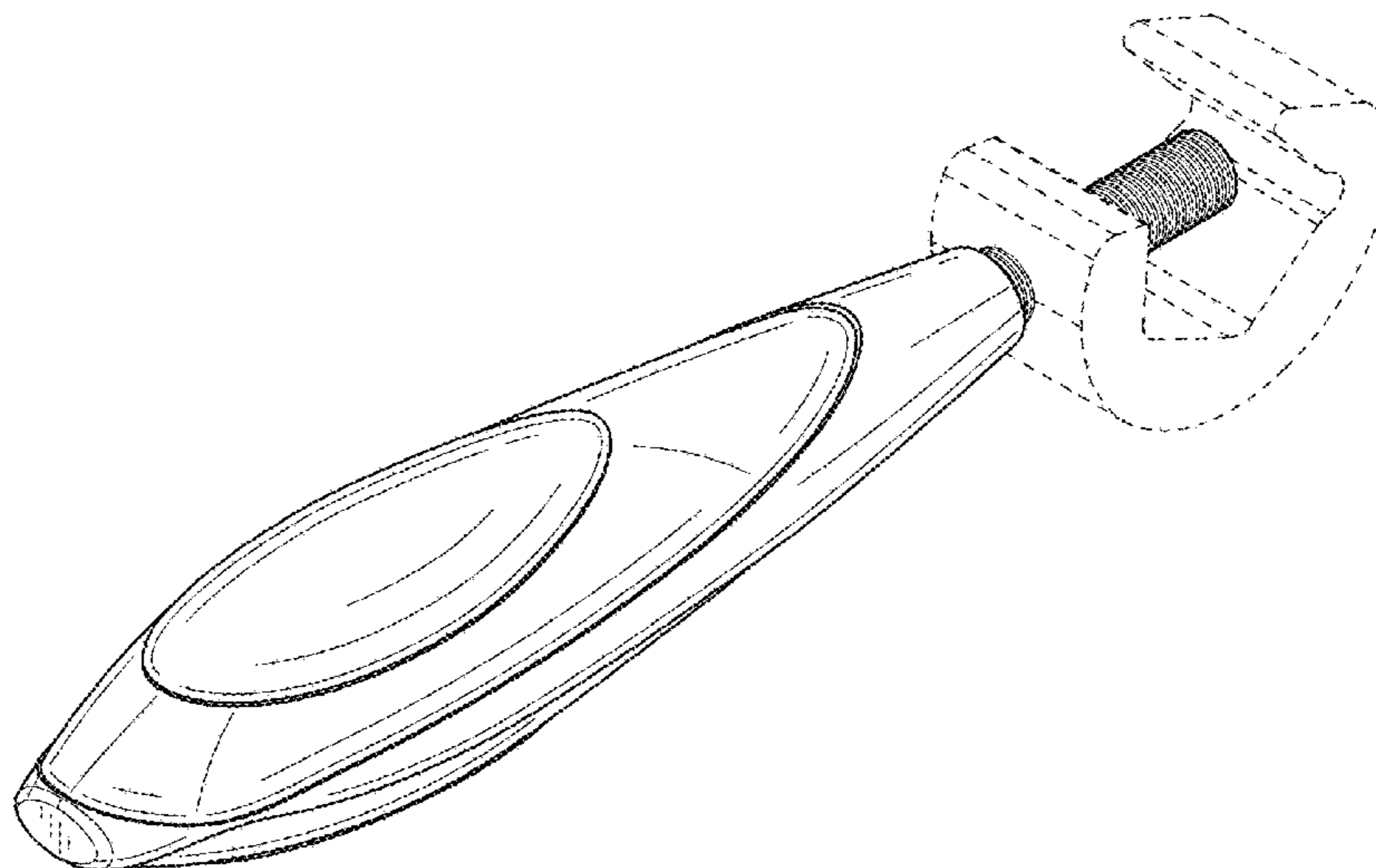

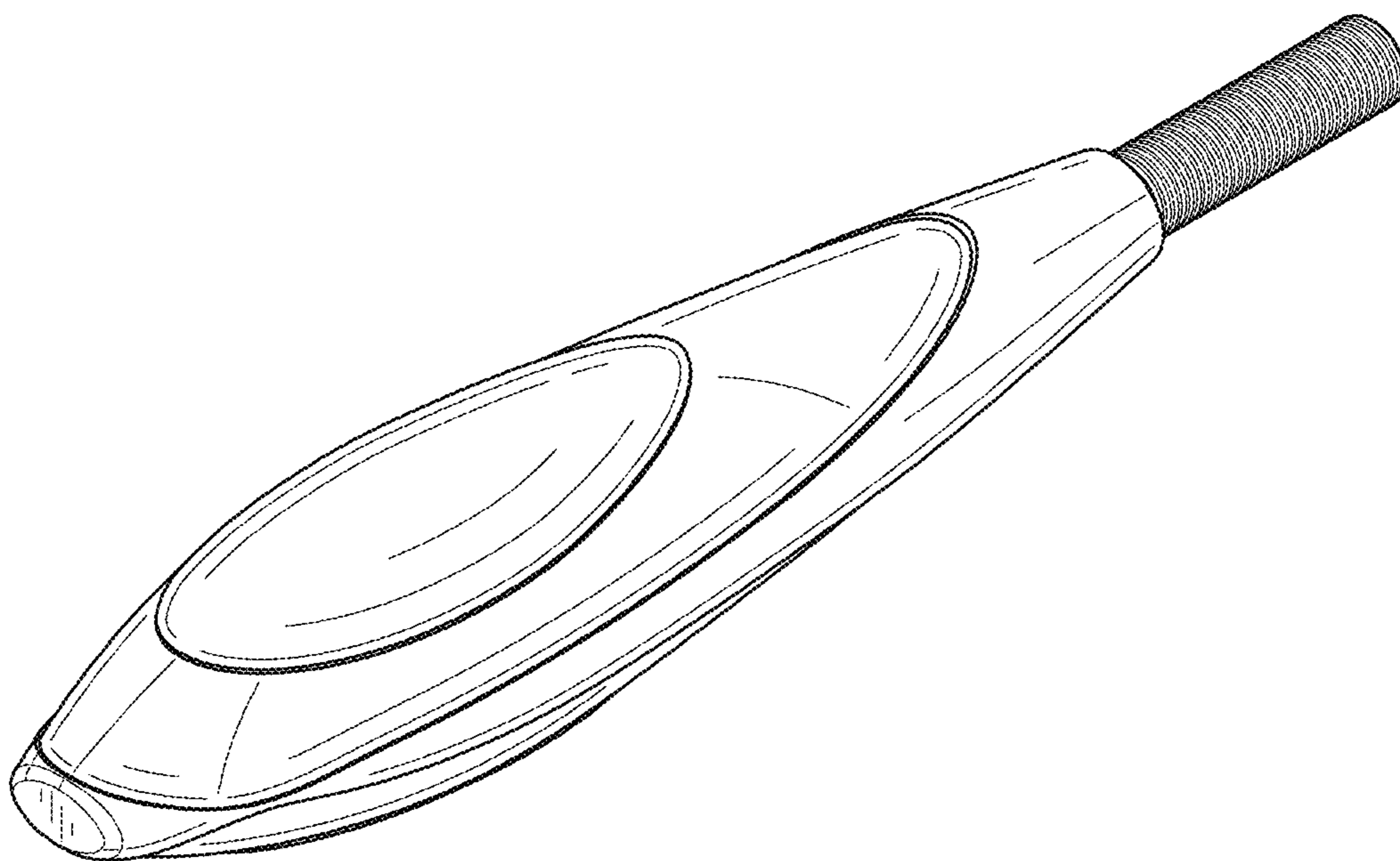

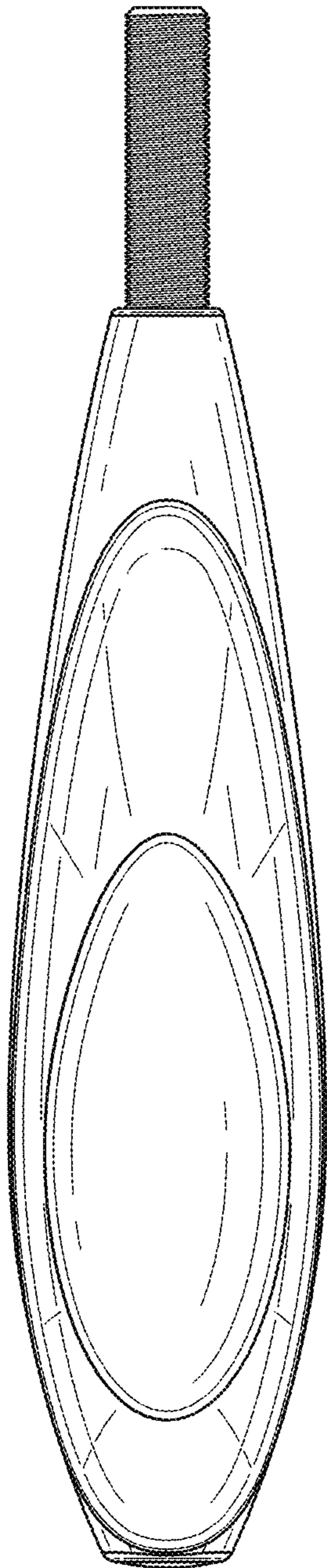

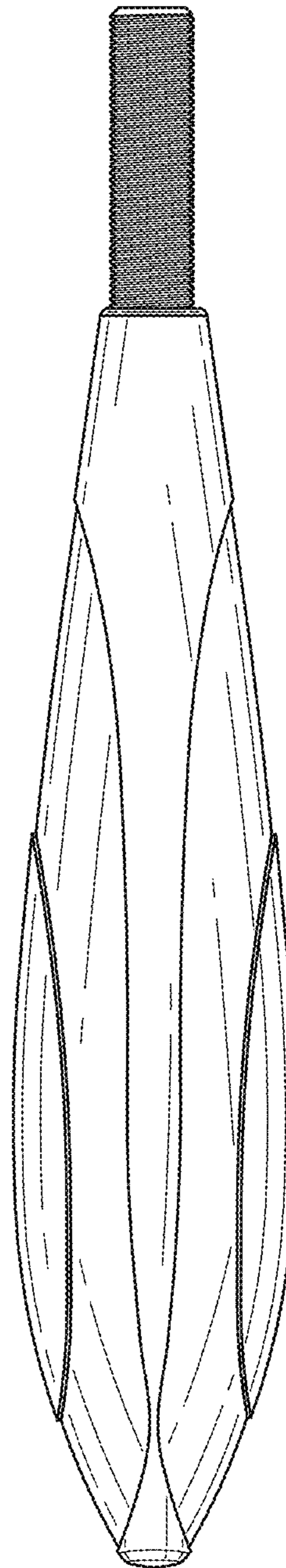

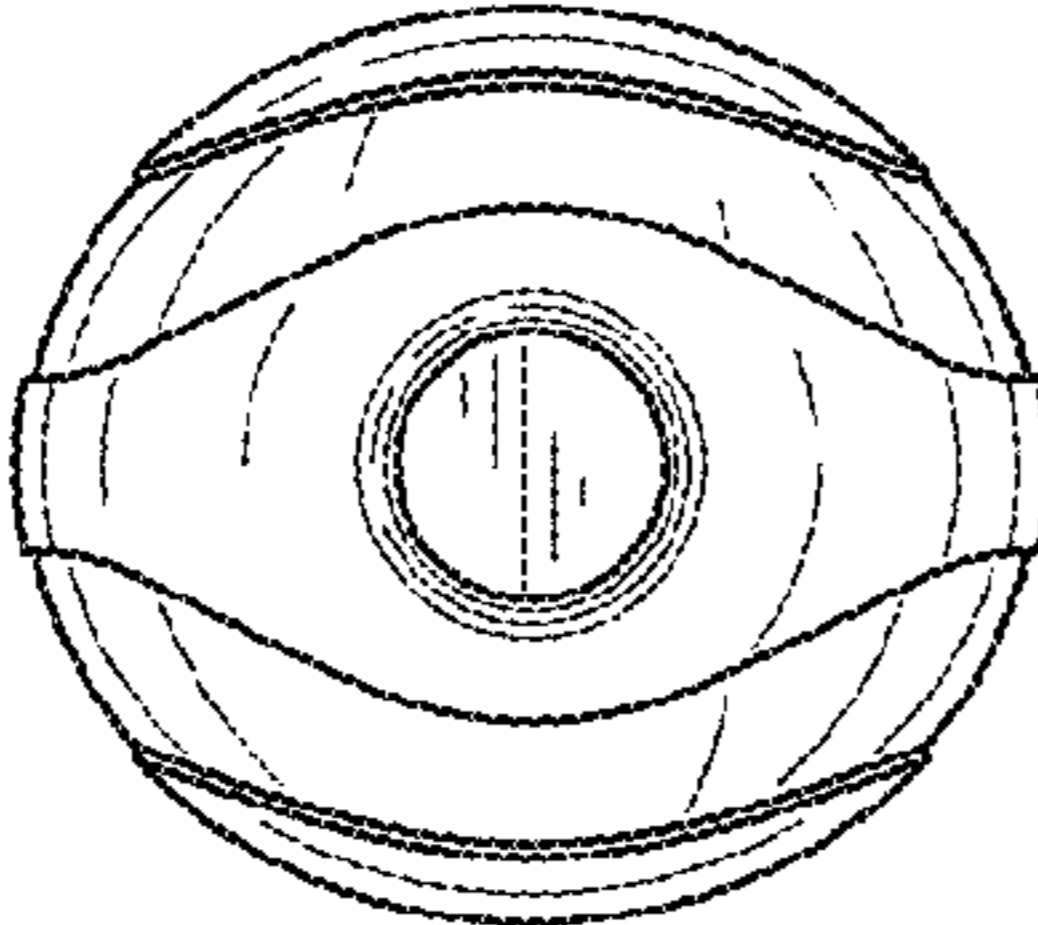

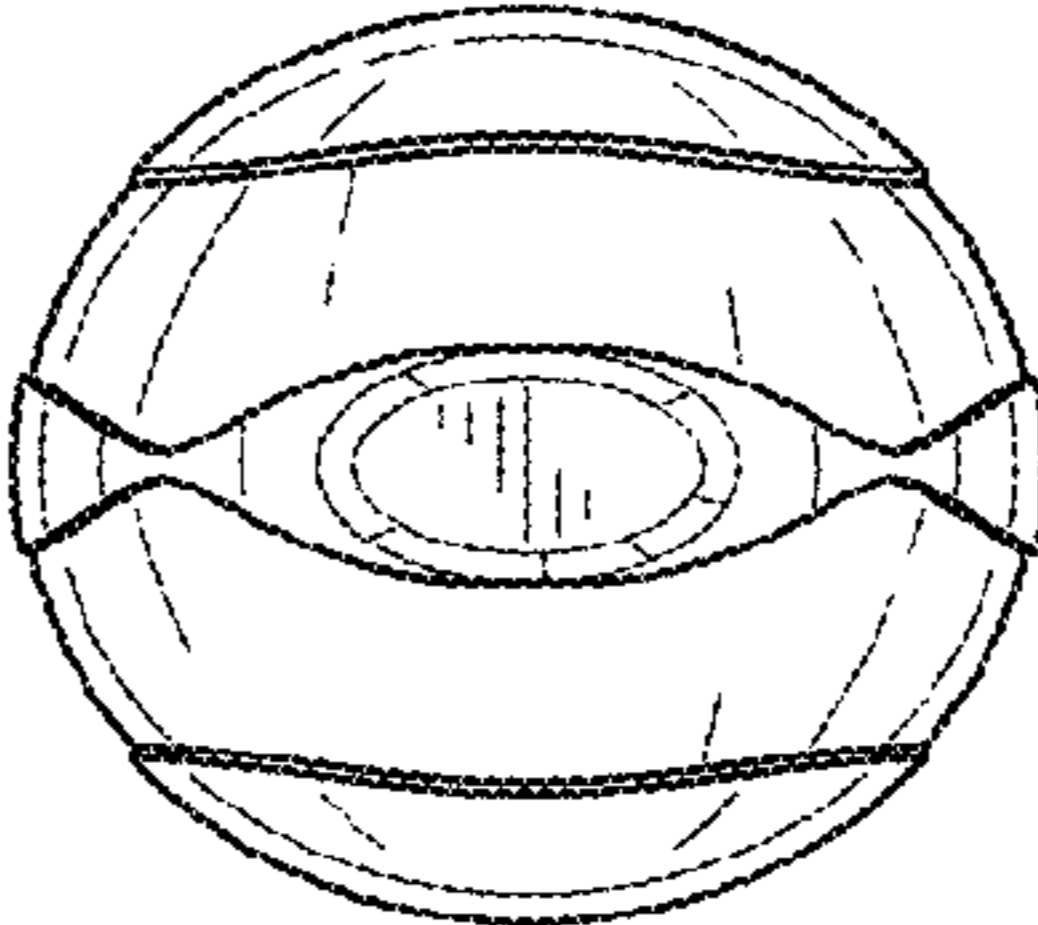
