(57) **CLAIM**

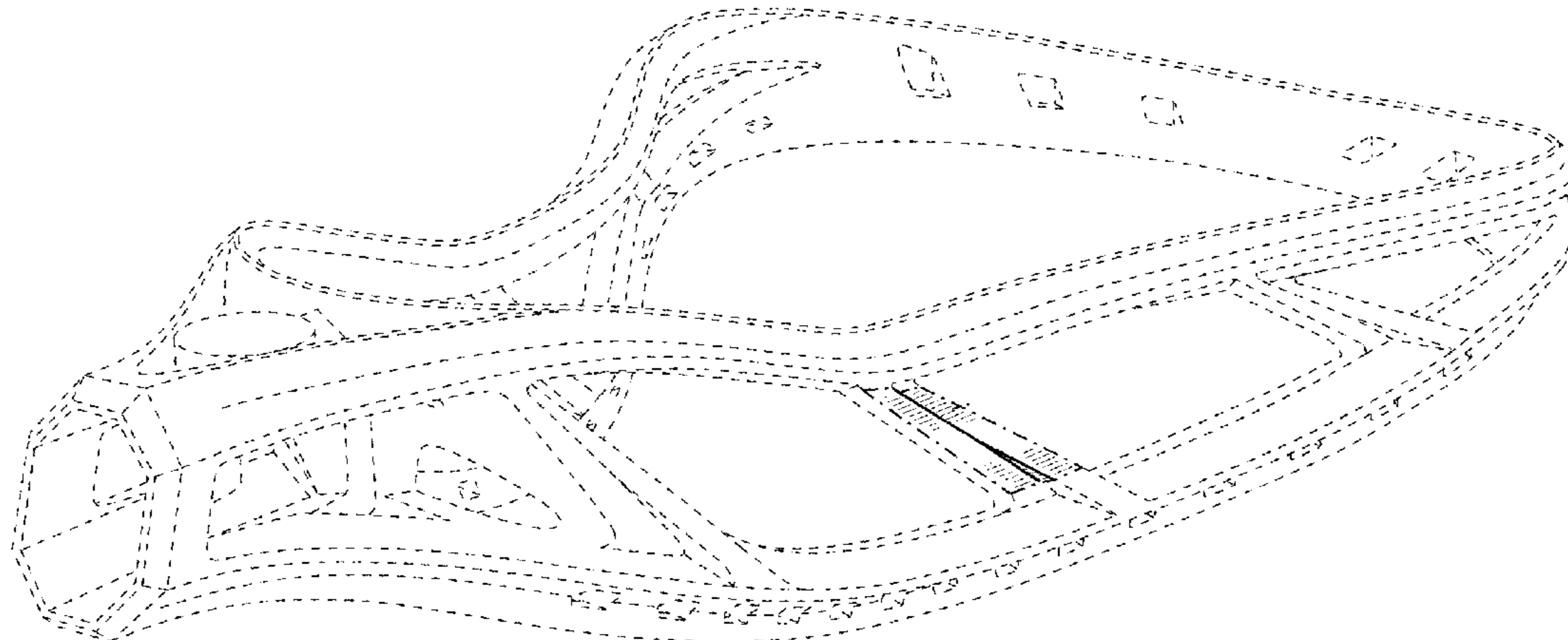
The ornamental design for a lacrosse head, as shown and described.

DESCRIPTION

FIG. 1 is a bottom, front, right side perspective view of a lacrosse head showing a first embodiment our new design; FIG. 2 is a front elevation view thereof; FIG. 3 is a right side elevation view thereof; FIG. 4 is a rear elevation view thereof; FIG. 5 is a top plan view thereof; FIG. 6 is a bottom plan view thereof; FIG. 7 is a fragmentary, top, right side perspective view of a portion thereof; FIG. 8 is a bottom, front, right side perspective view of a second embodiment thereof; FIG. 9 is a front elevation view of FIG. 8; FIG. 10 is a right side elevation view of FIG. 8; FIG. 11 is a rear elevation view of FIG. 8; FIG. 12 is a top plan view of FIG. 8; FIG. 13 is a bottom plan view of FIG. 8; FIG. 14 is a fragmentary, top, right side perspective view of a portion of FIG. 8; FIG. 15 is a bottom, front, right side perspective view of a third embodiment thereof; FIG. 16 is a front elevation view of FIG. 15; FIG. 17 is a right side elevation view of FIG. 15; FIG. 18 is a rear elevation view of FIG. 15; FIG. 19 is a top plan view of FIG. 15; FIG. 20 is a bottom plan view of FIG. 15; and, FIG. 21 is a fragmentary, top, right side perspective view of a portion of FIG. 15.

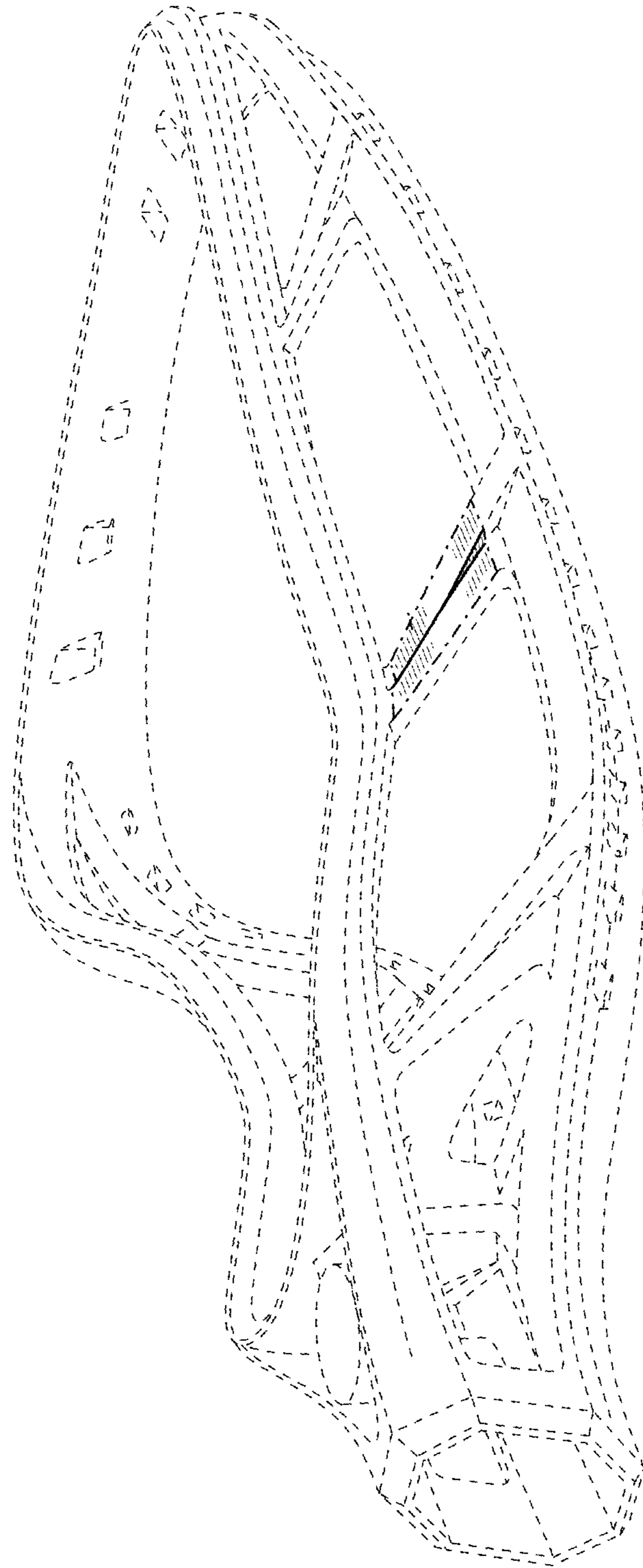

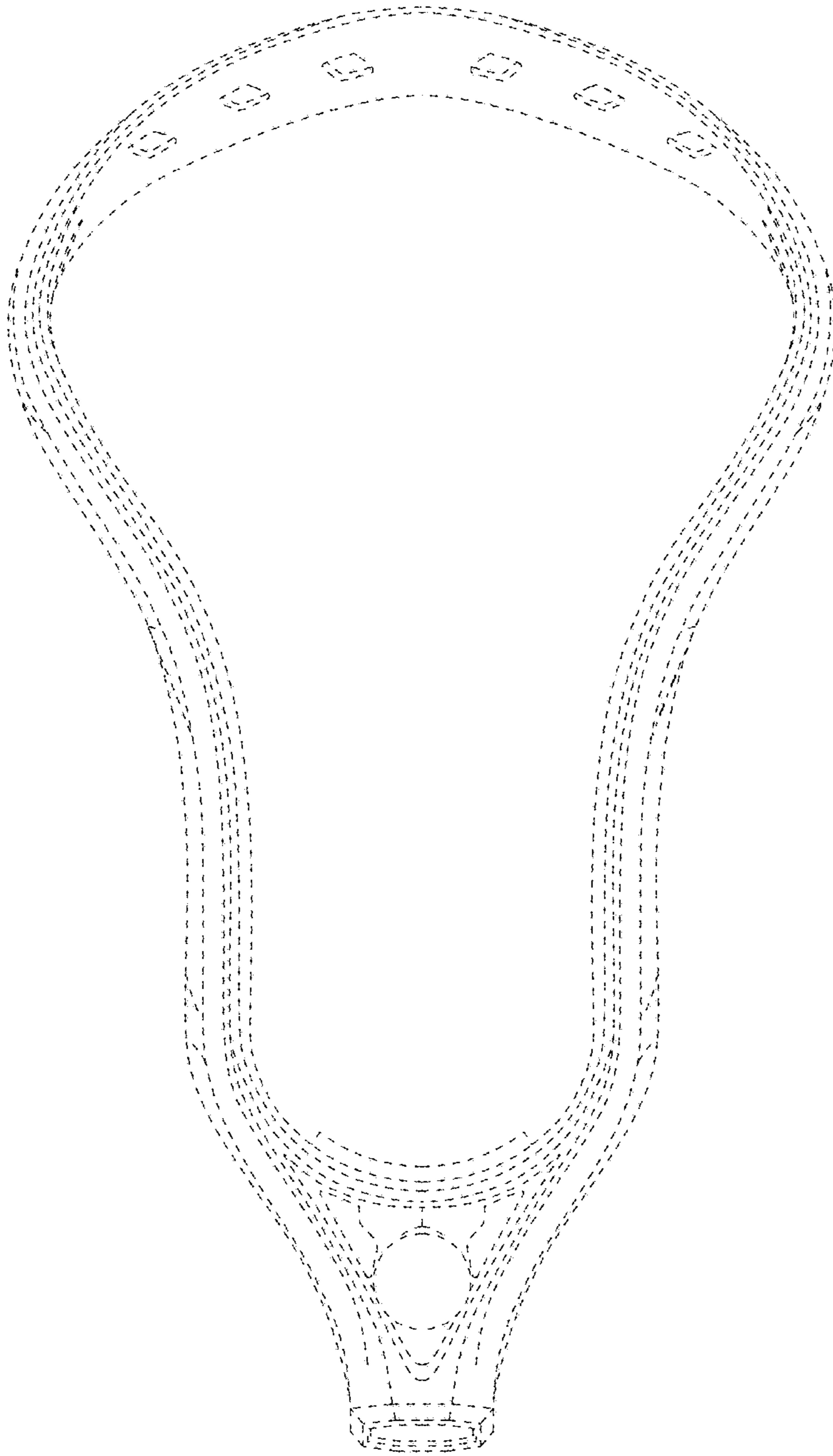

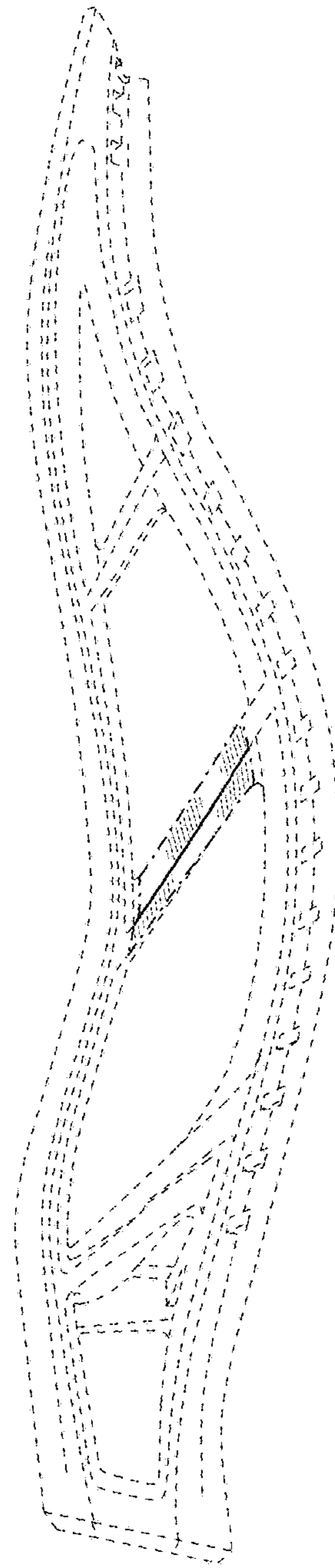

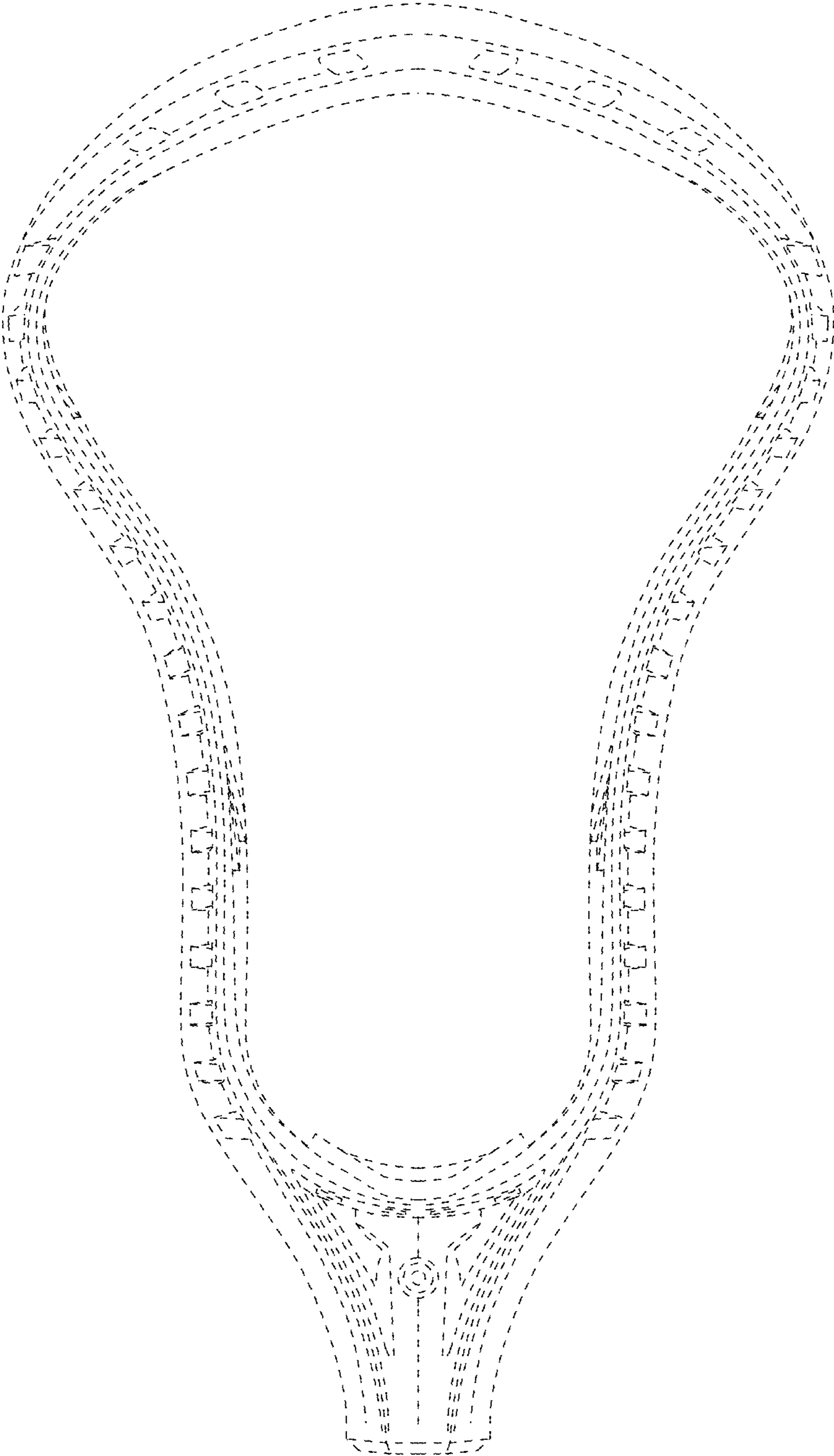

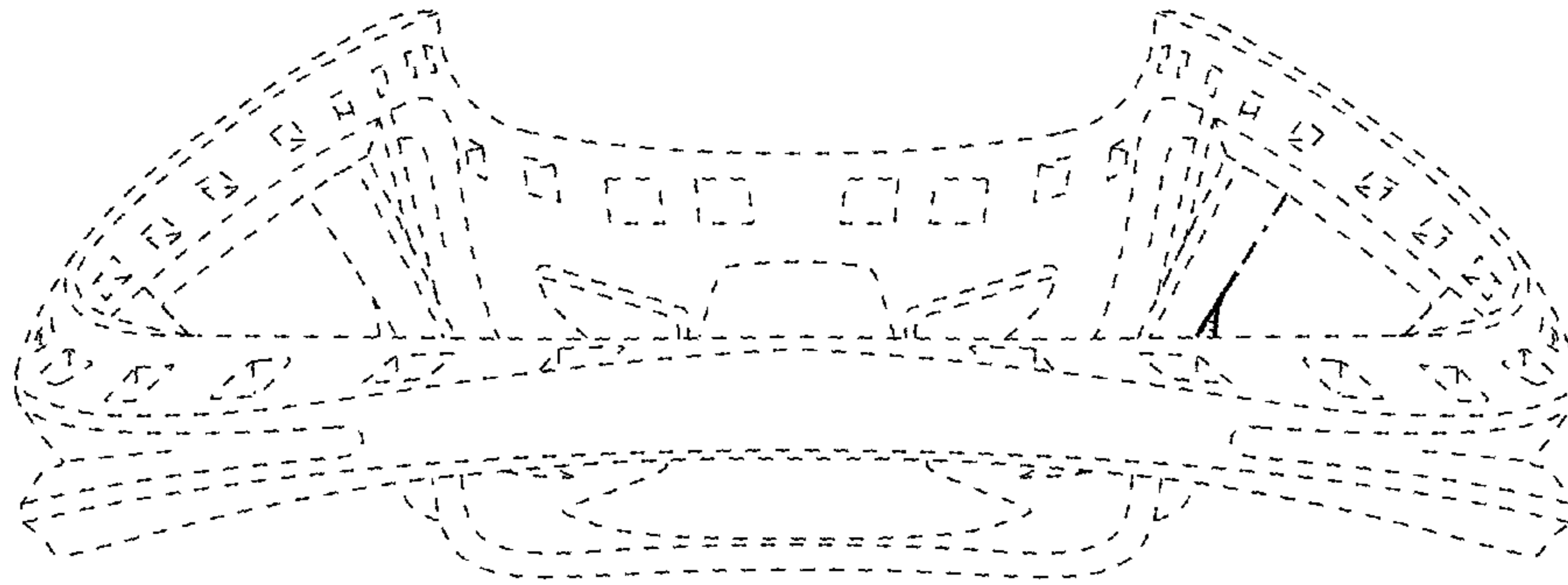

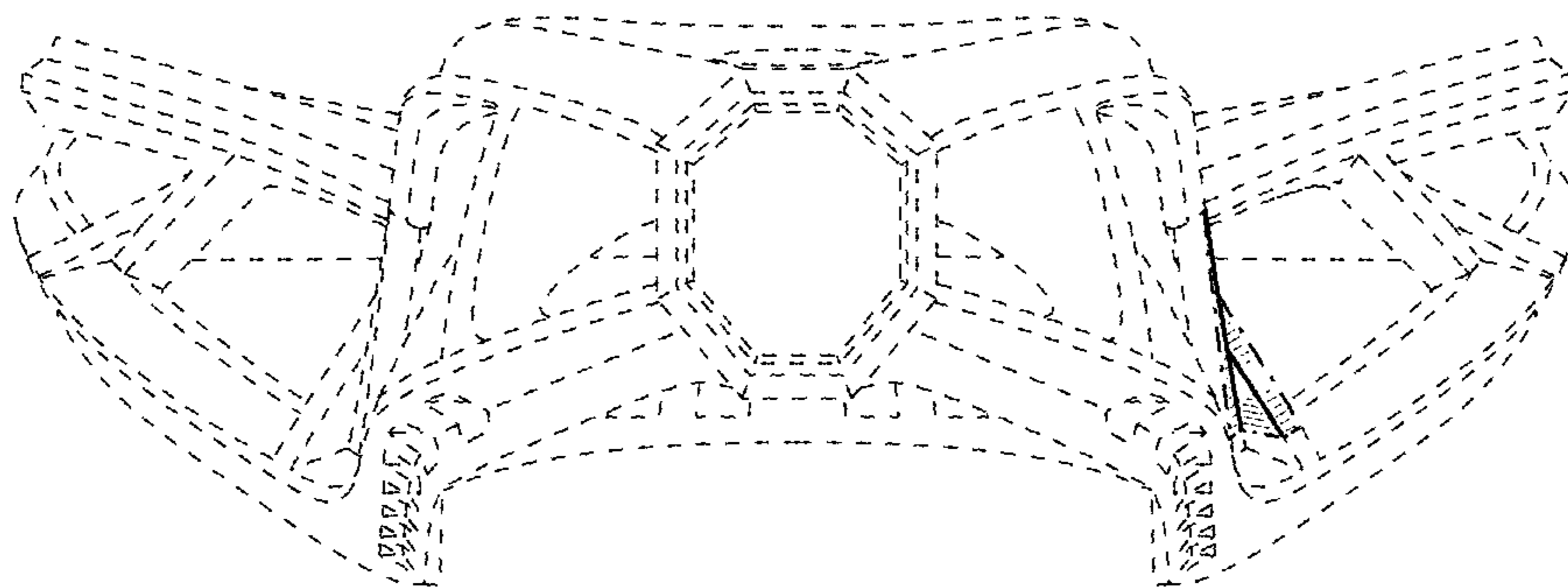

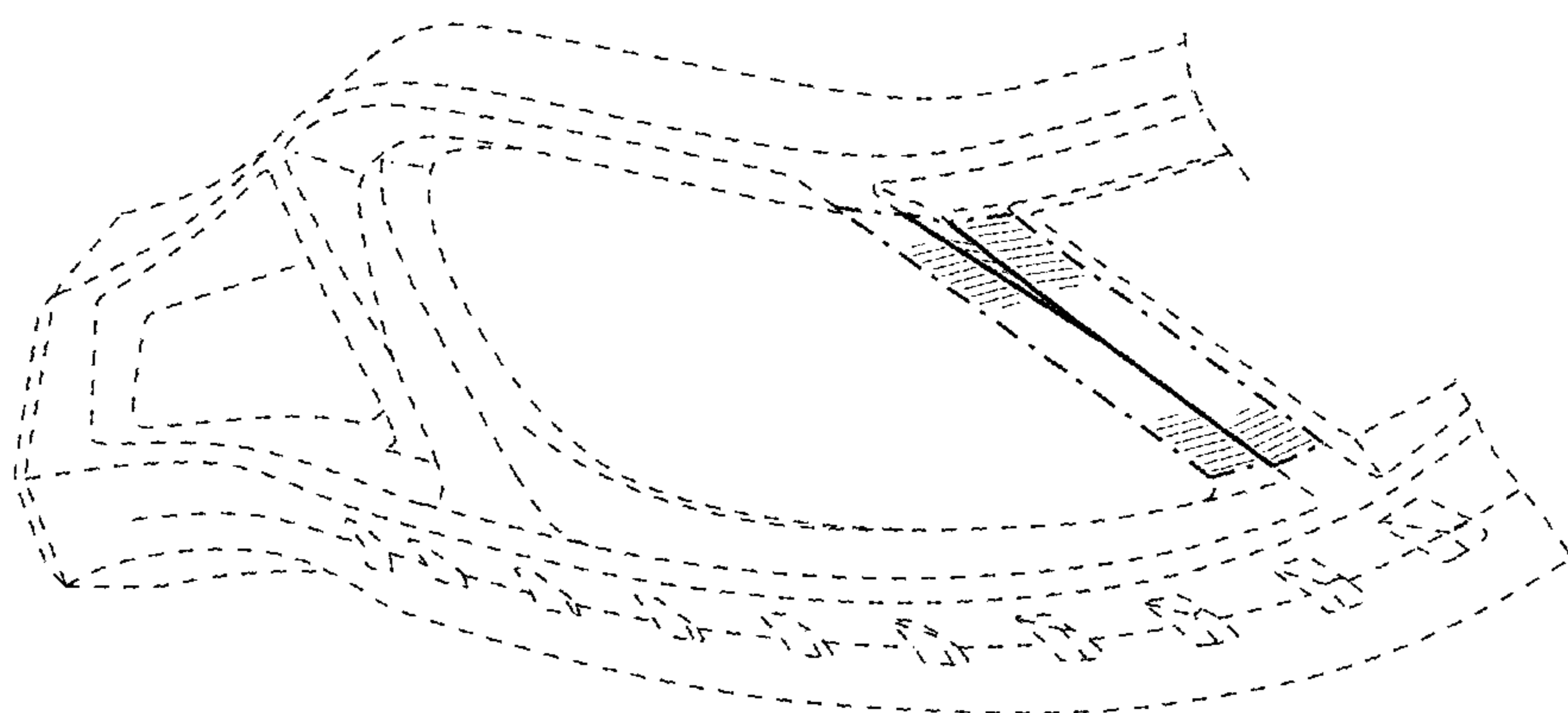

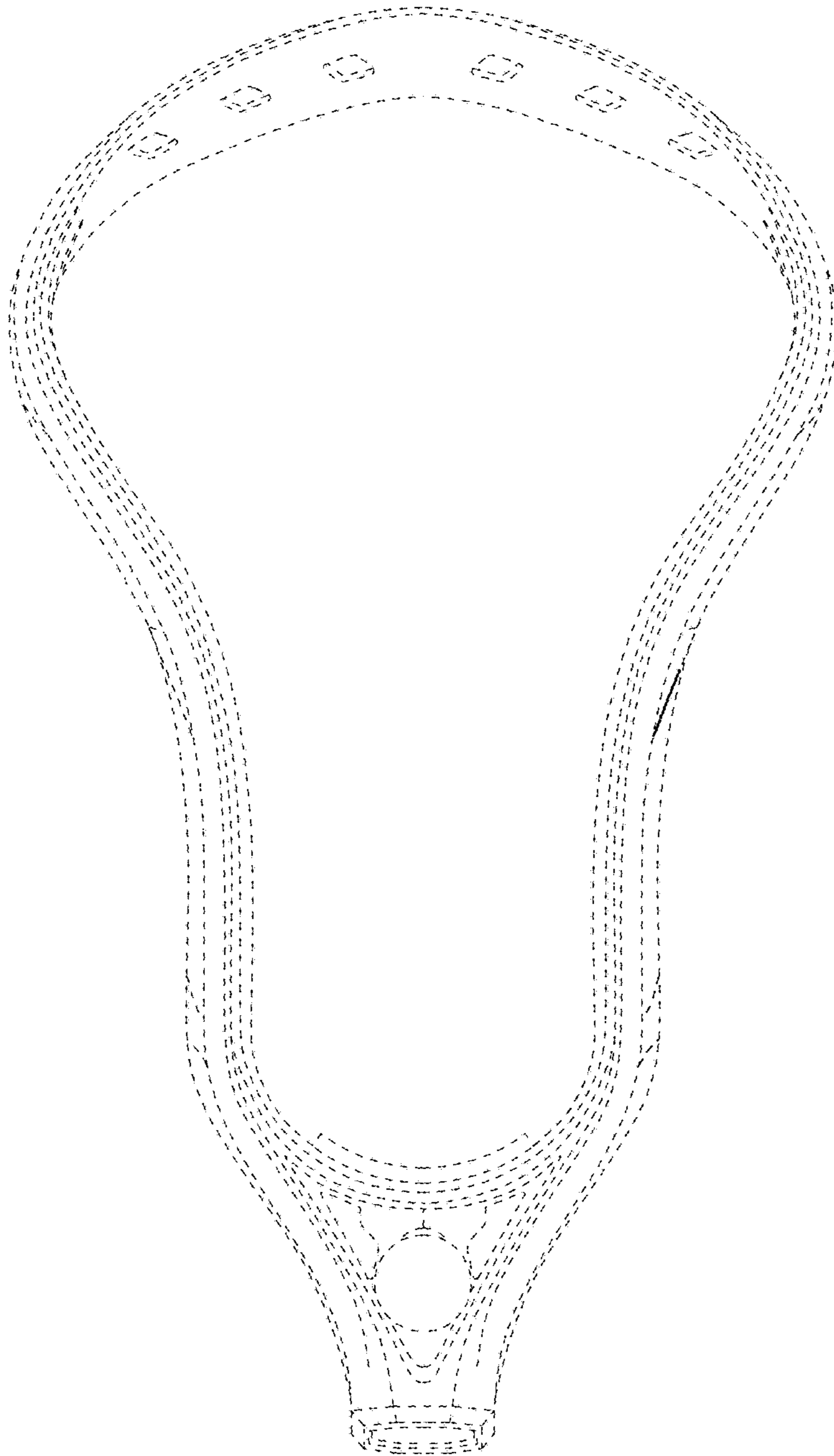

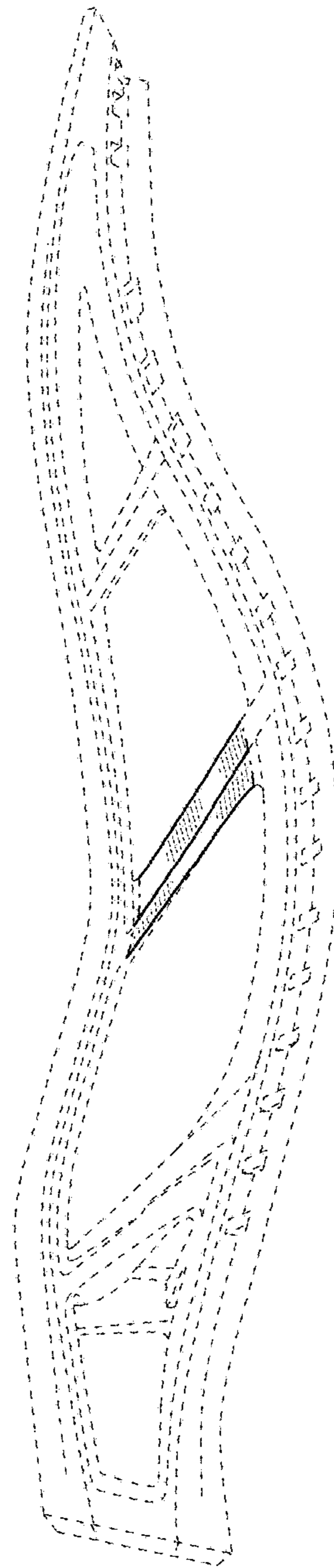

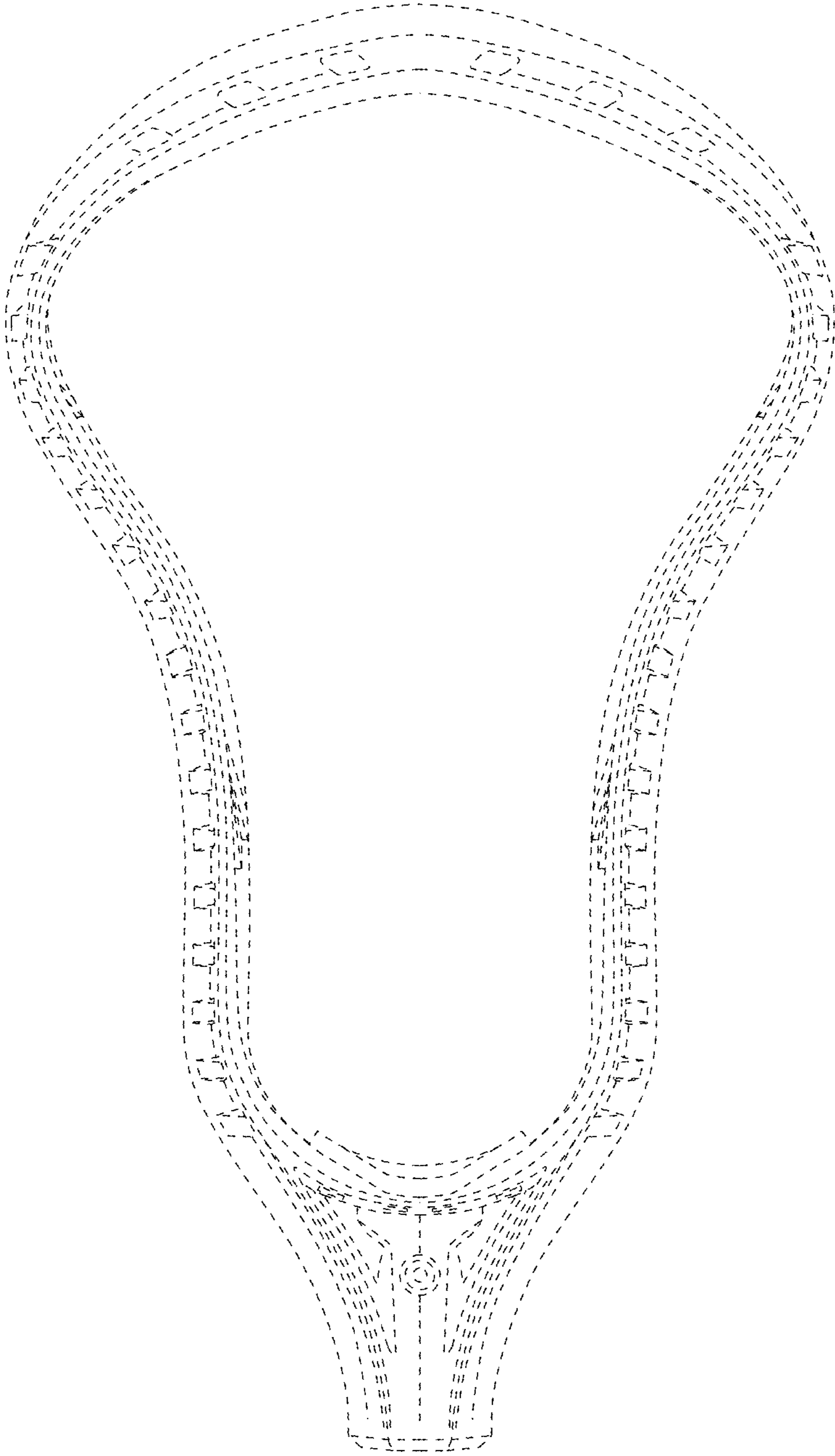

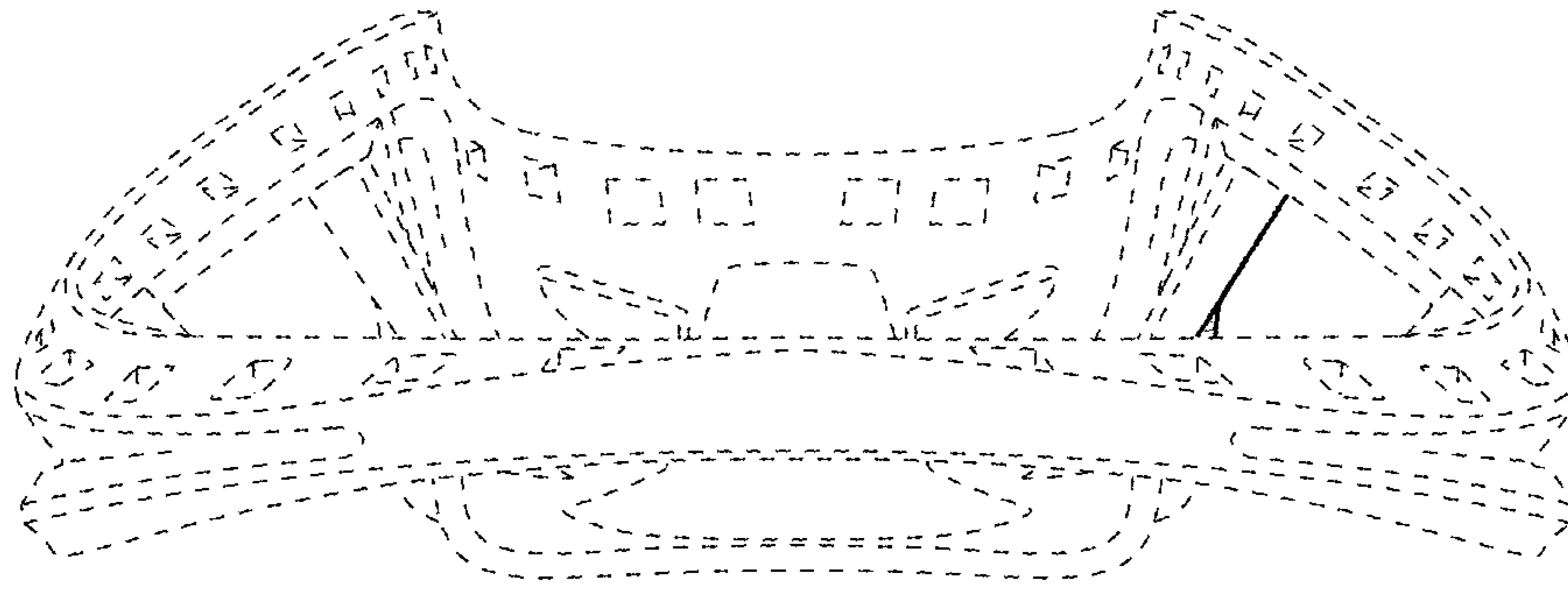

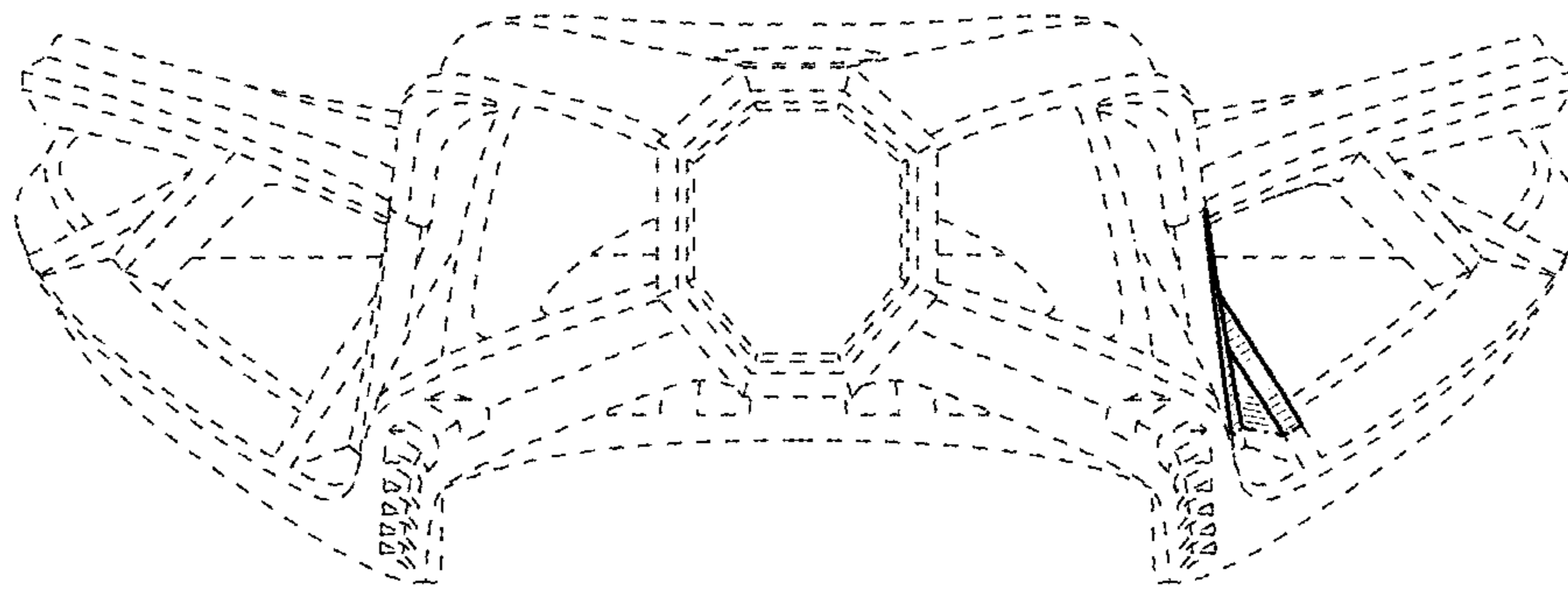

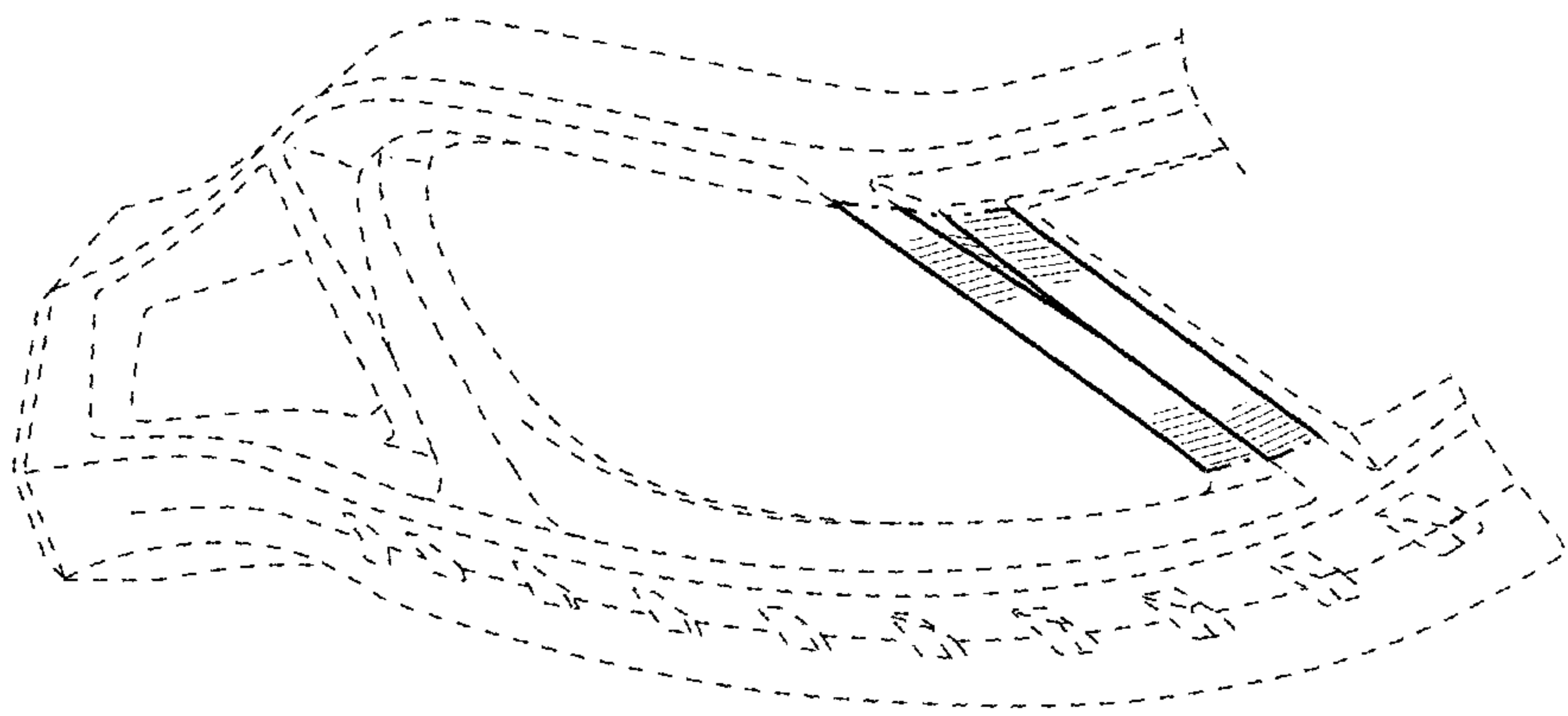

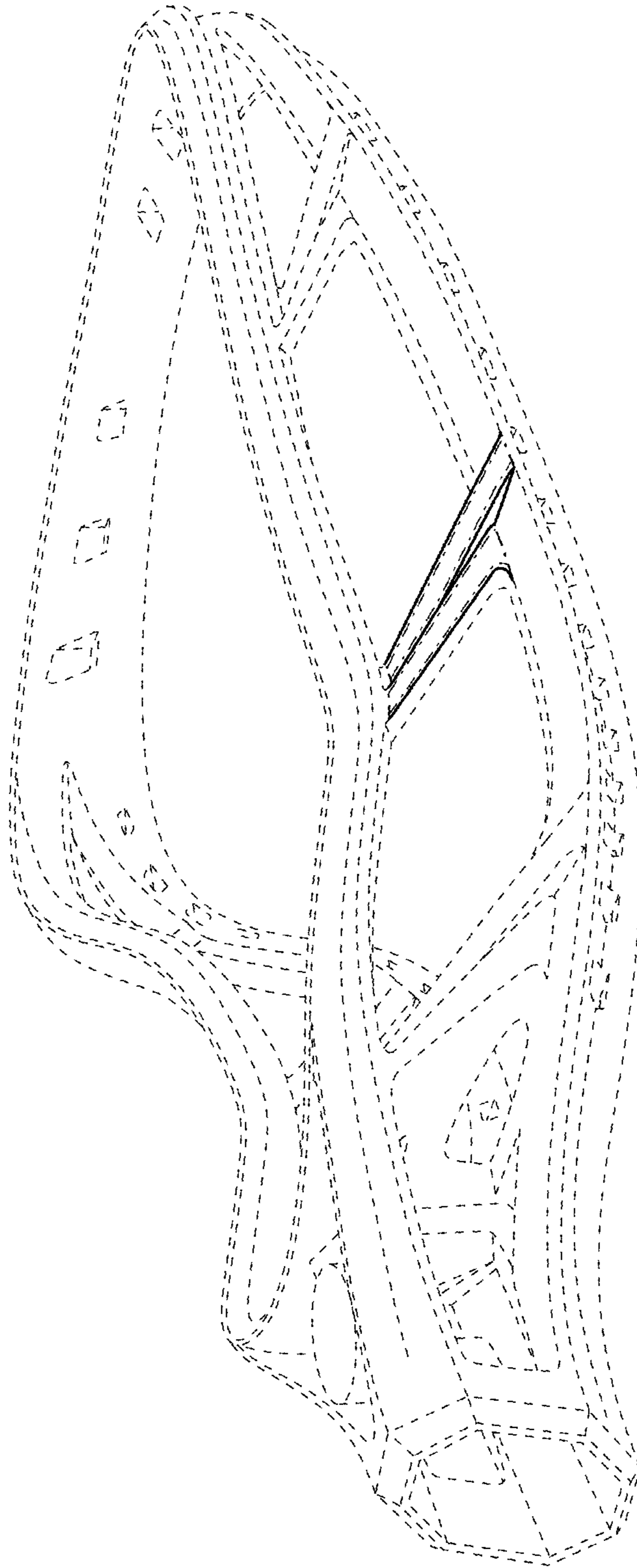

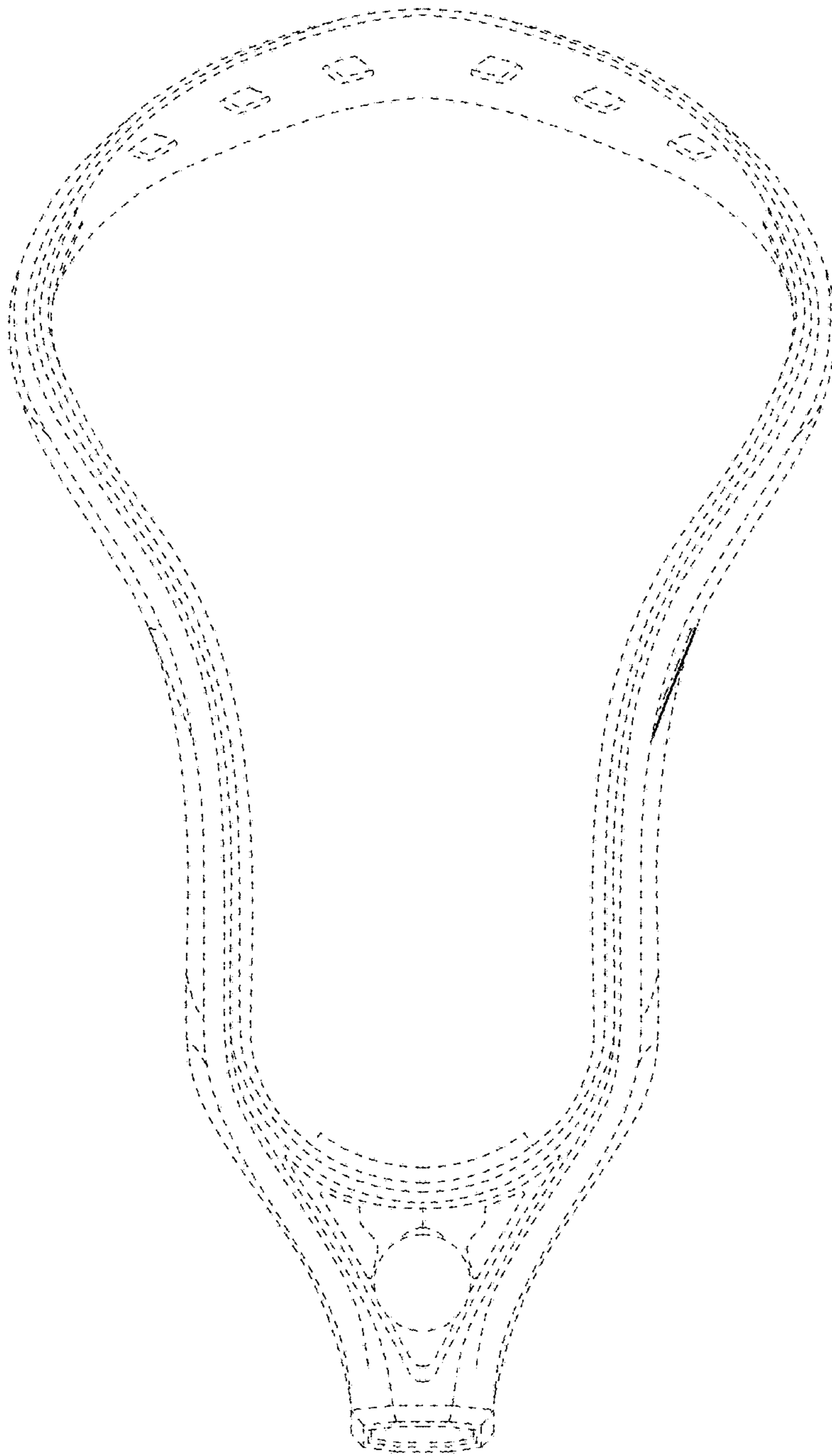

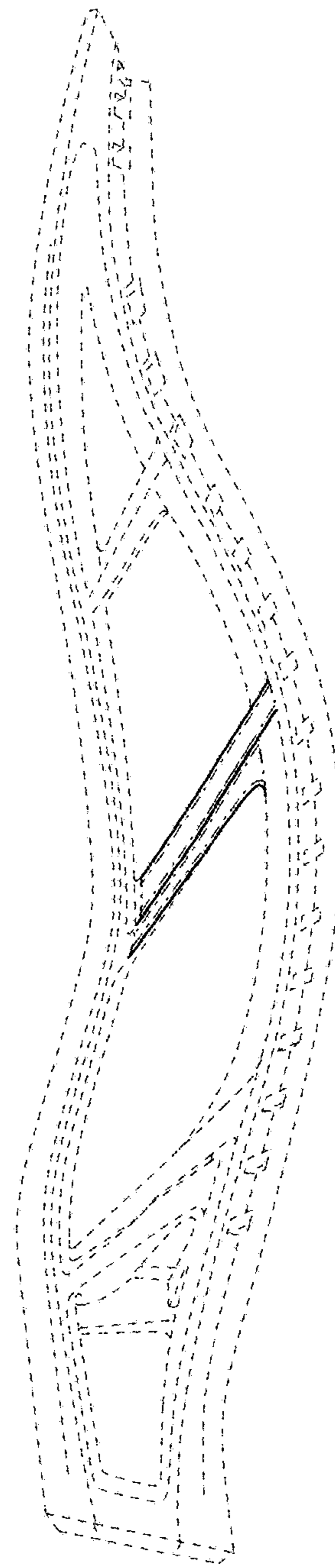

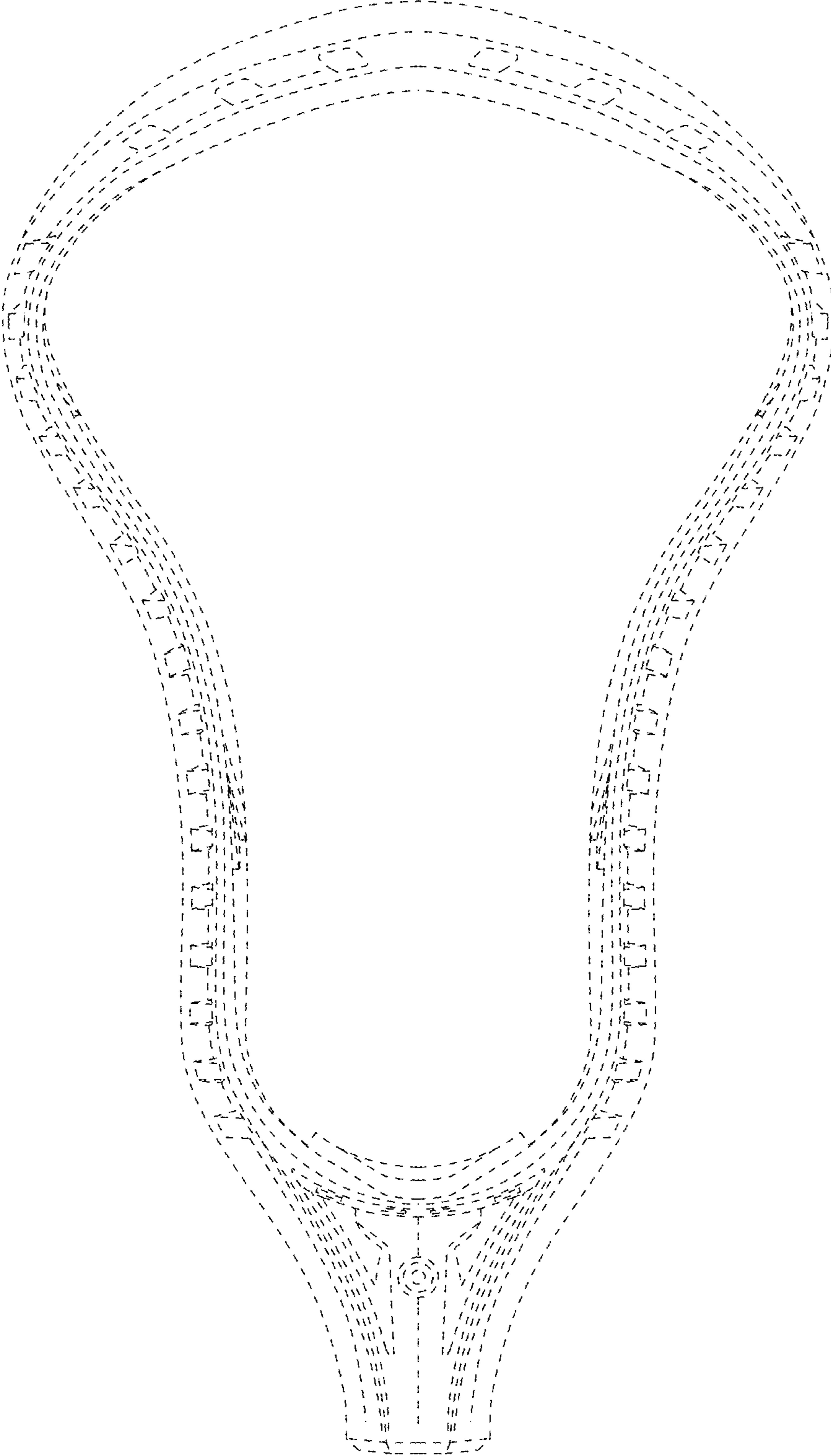

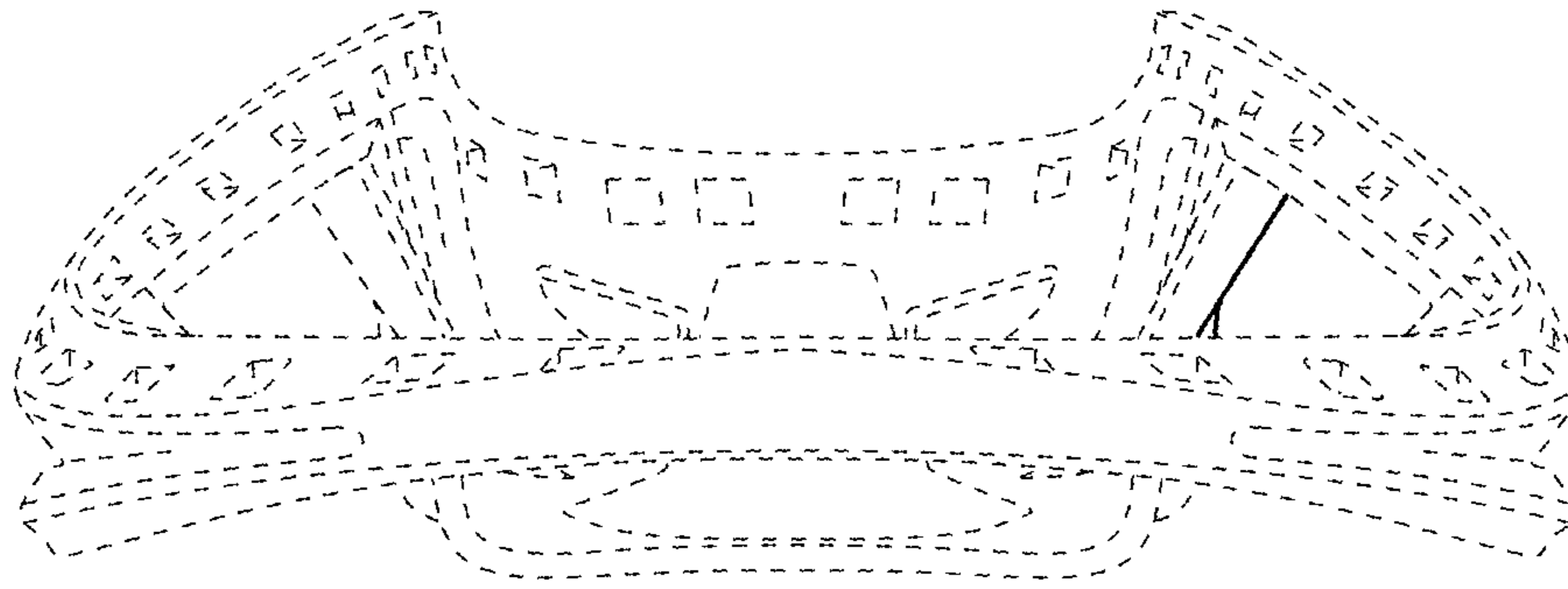

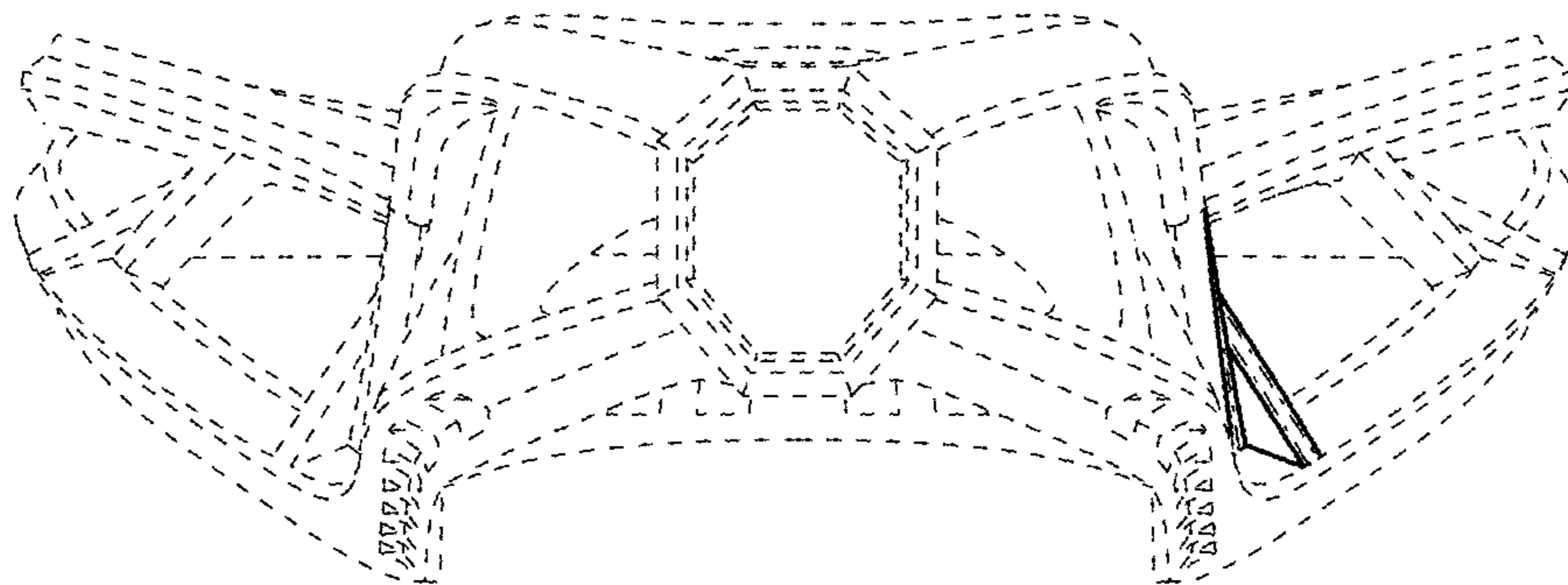

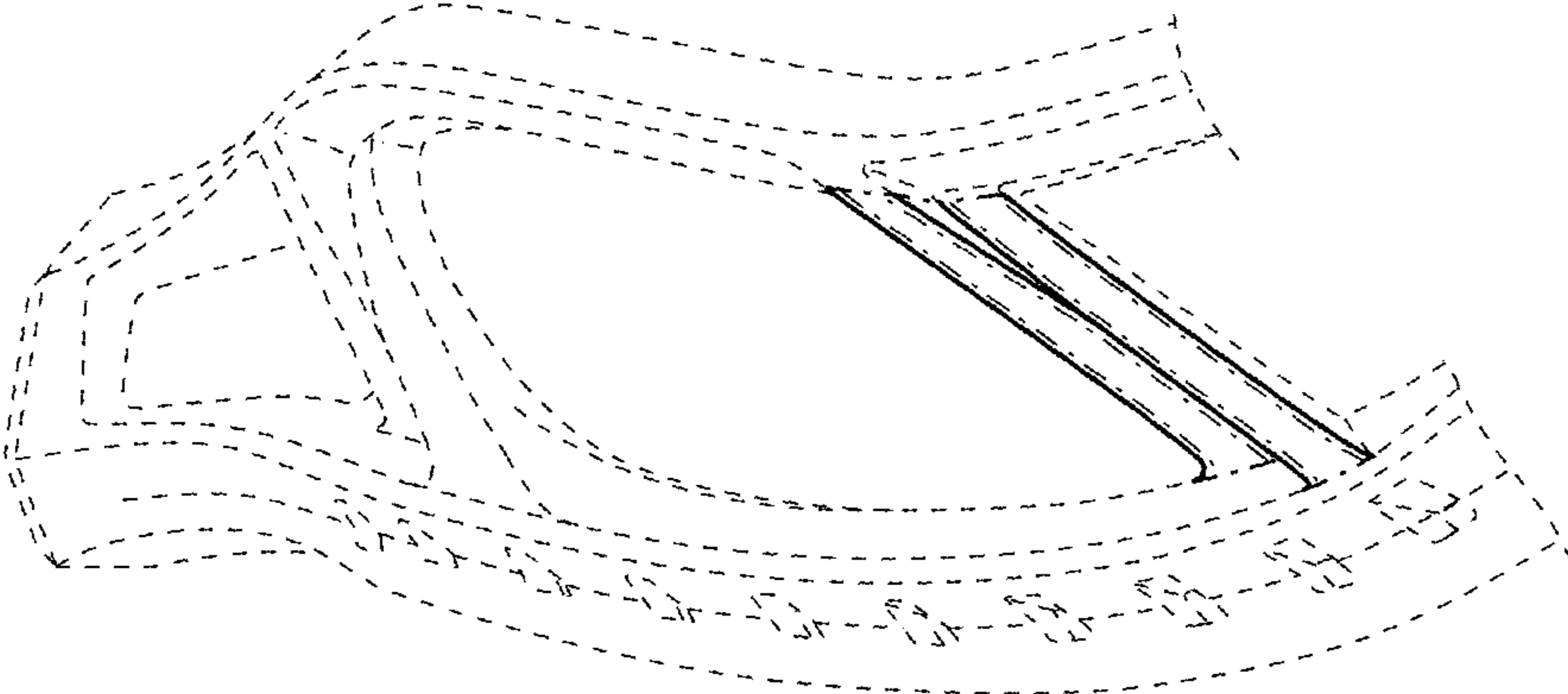
