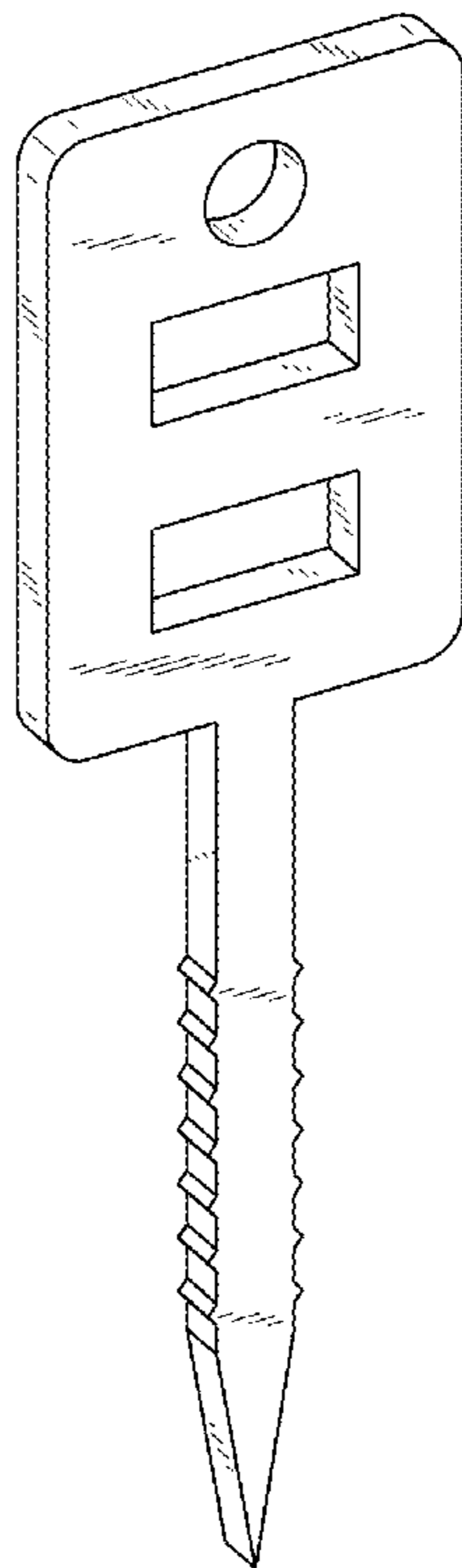
(57) **CLAIM**

The ornamental design for a key knife, as shown and described.

DESCRIPTION

FIG. 1 is a perspective front view of the key knife, showing my new design;
FIG. 2 is a front view thereof; the back view being a mirror image thereof;

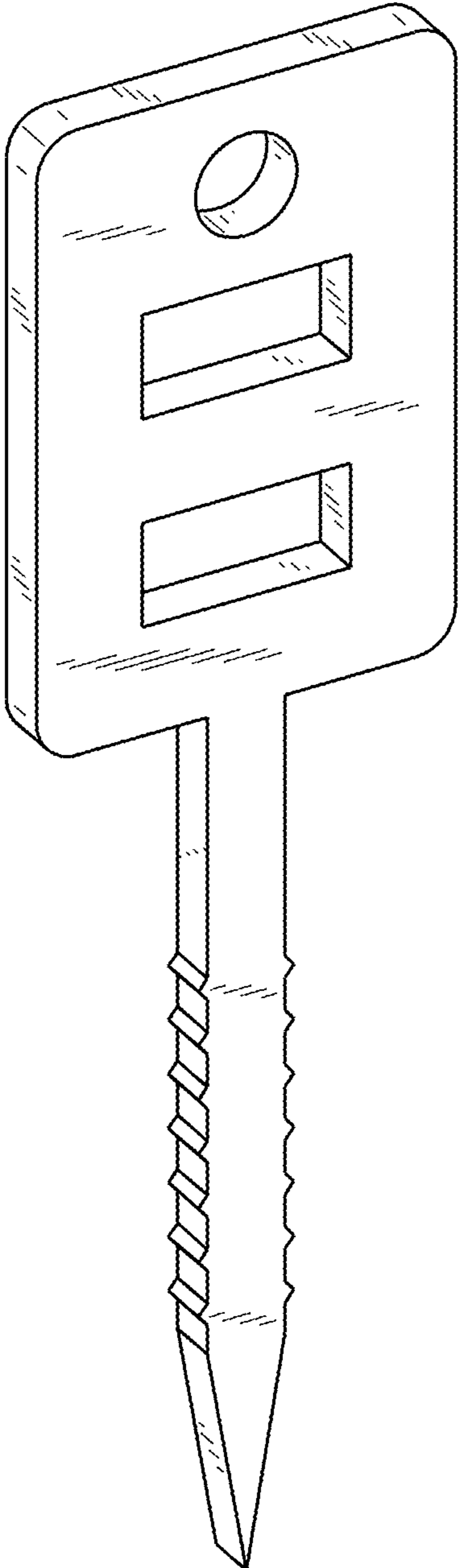

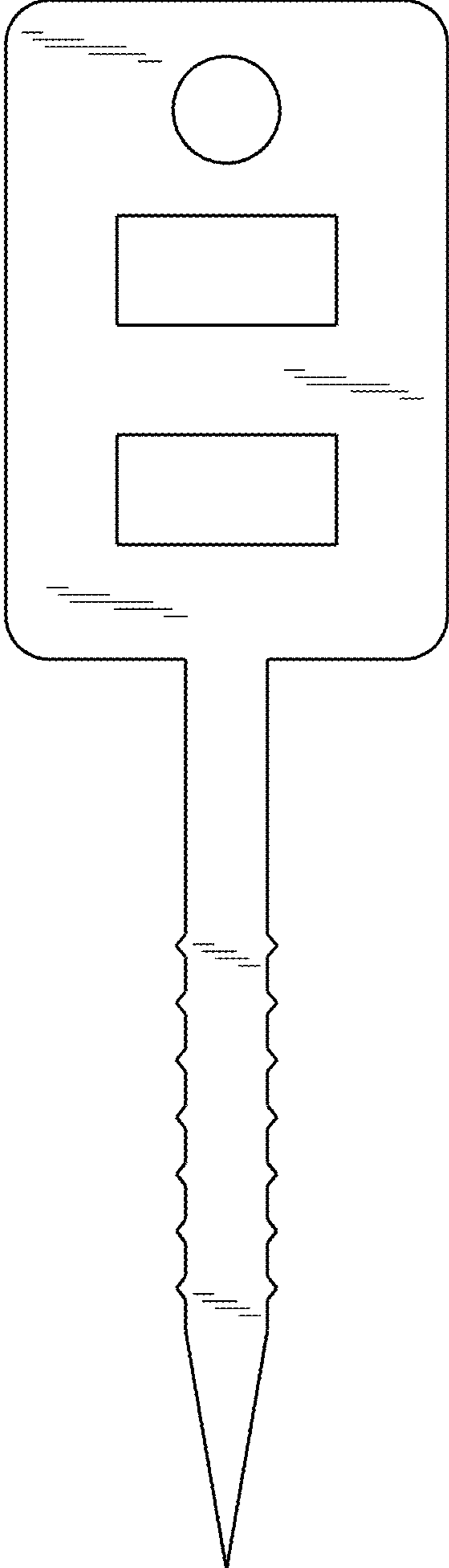
