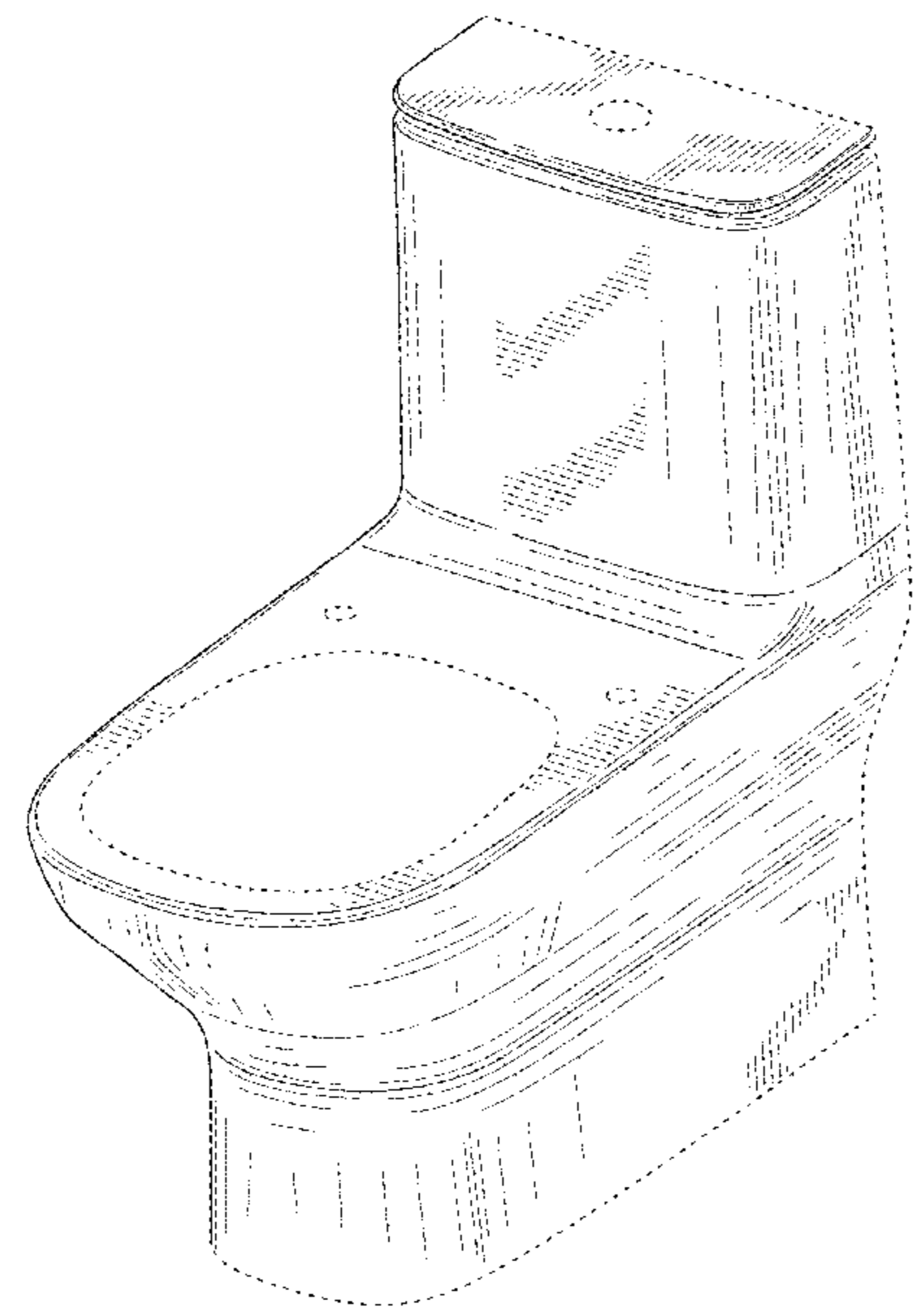
**DESCRIPTION**

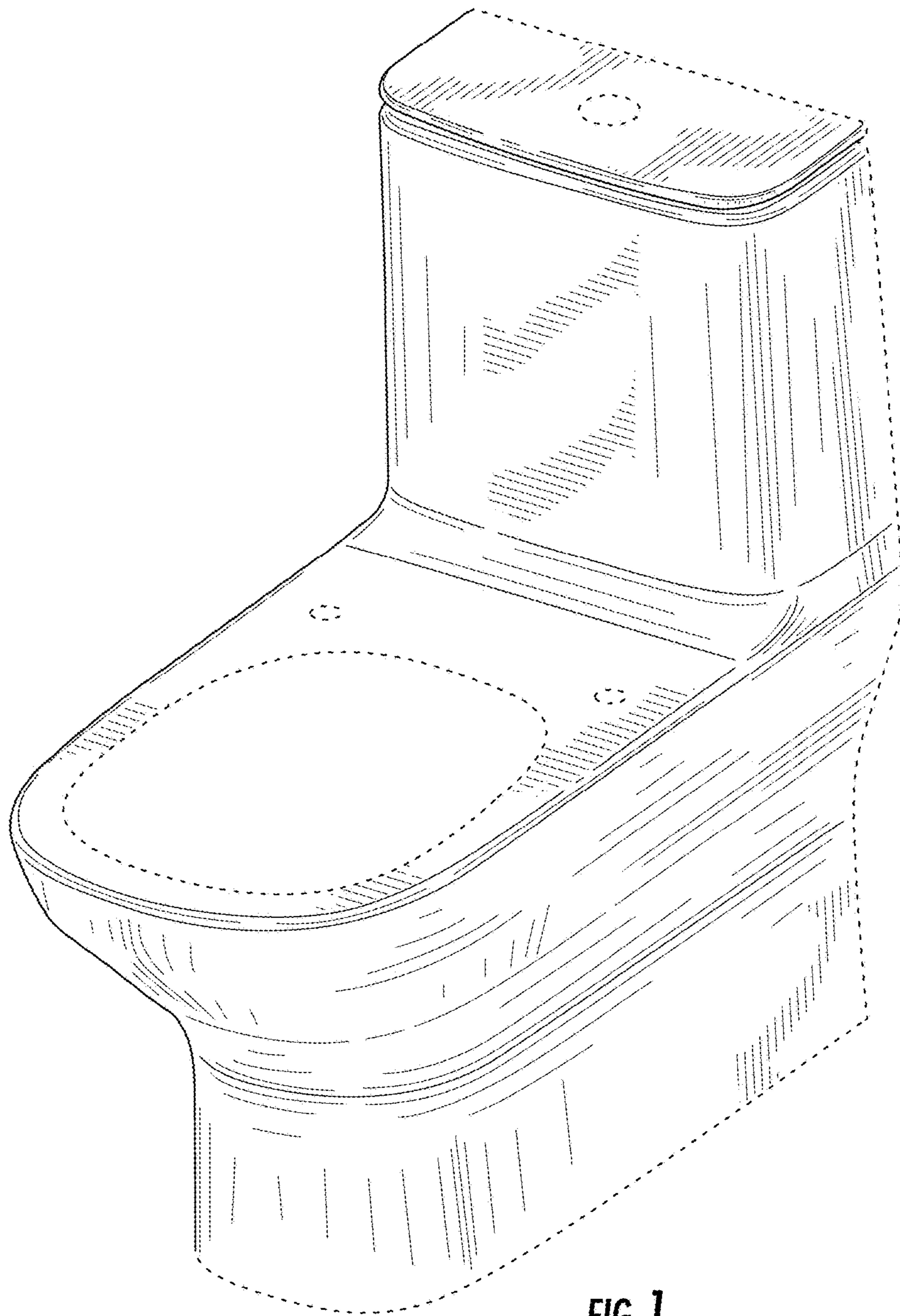

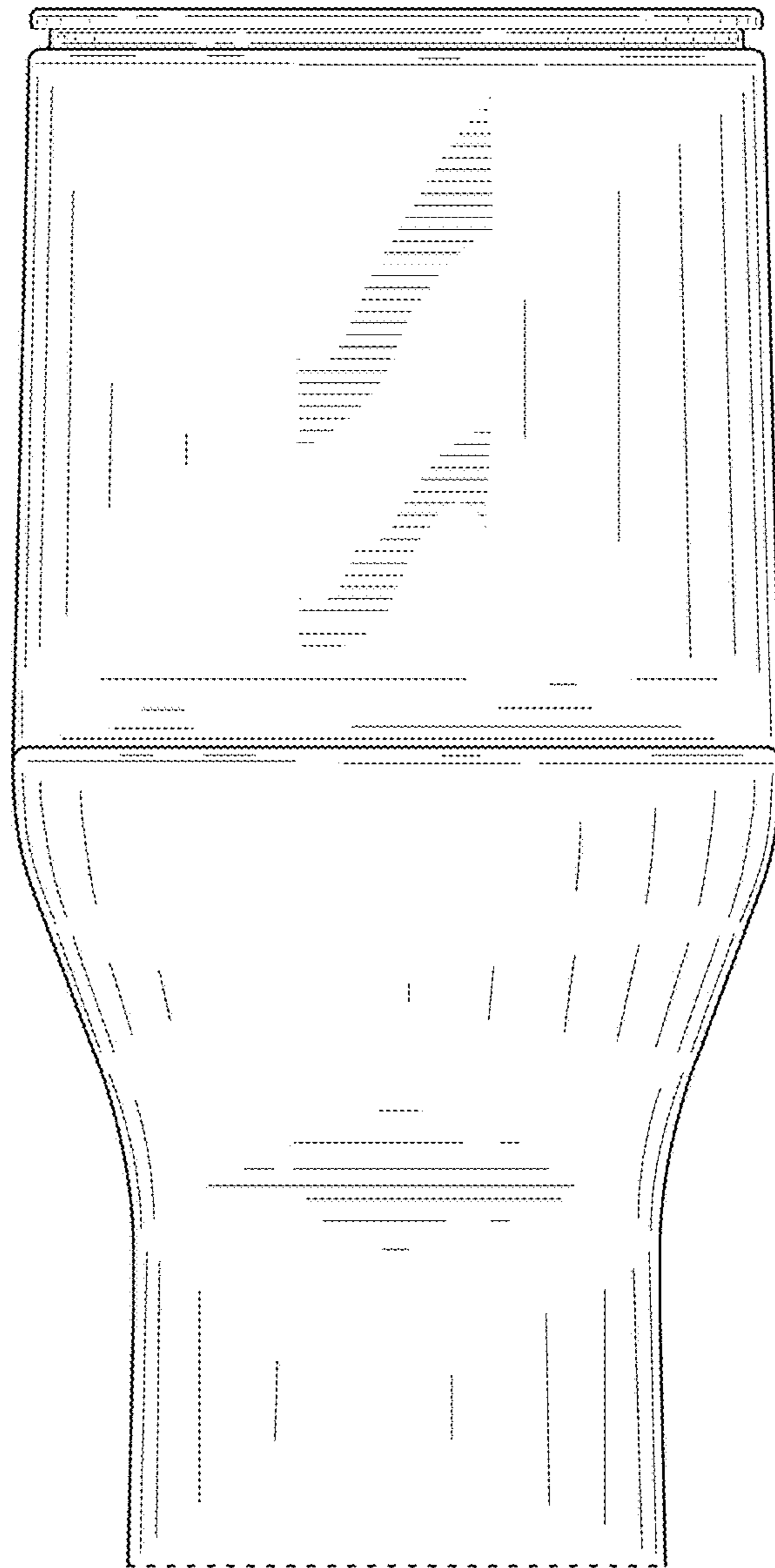
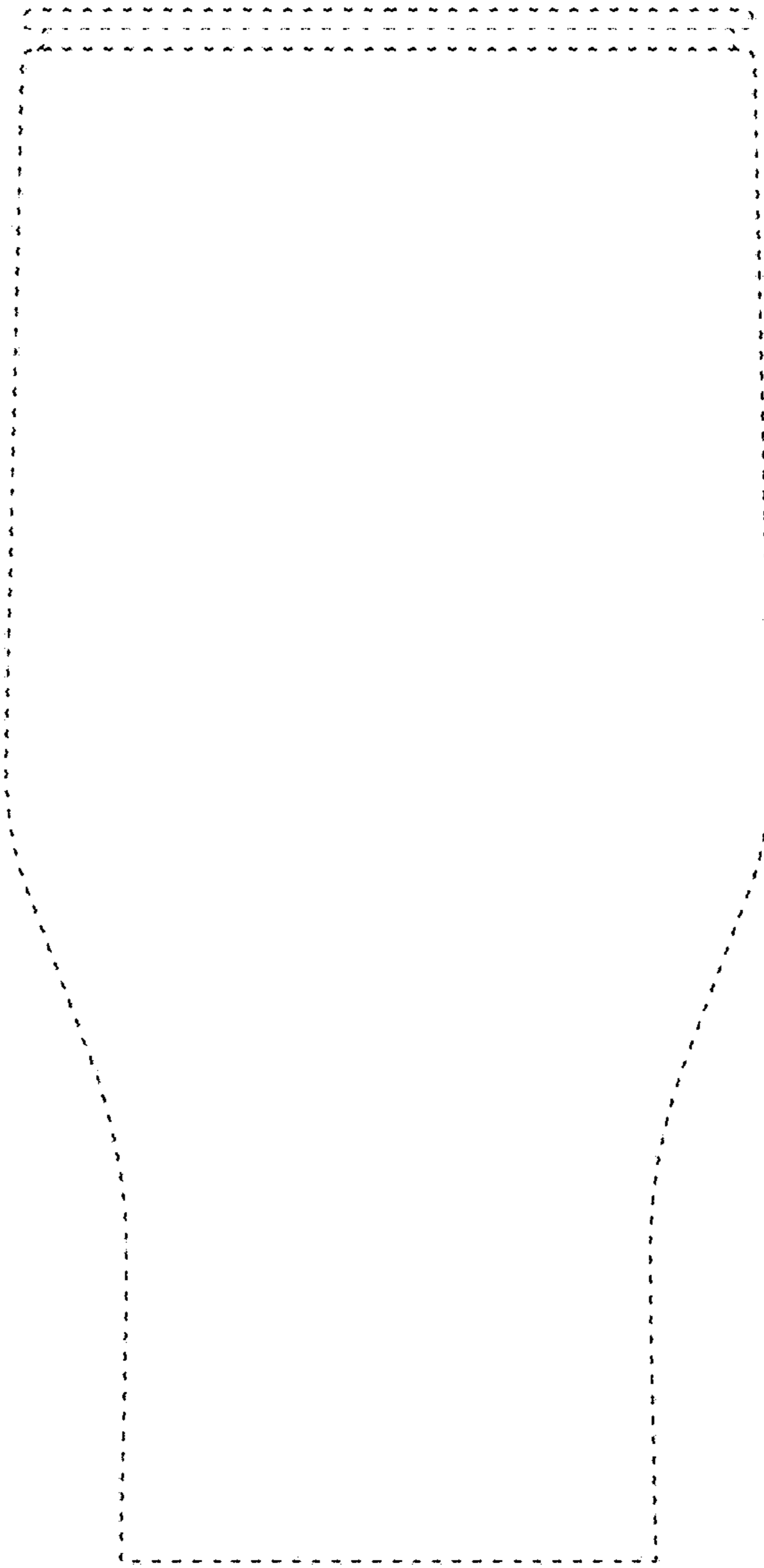

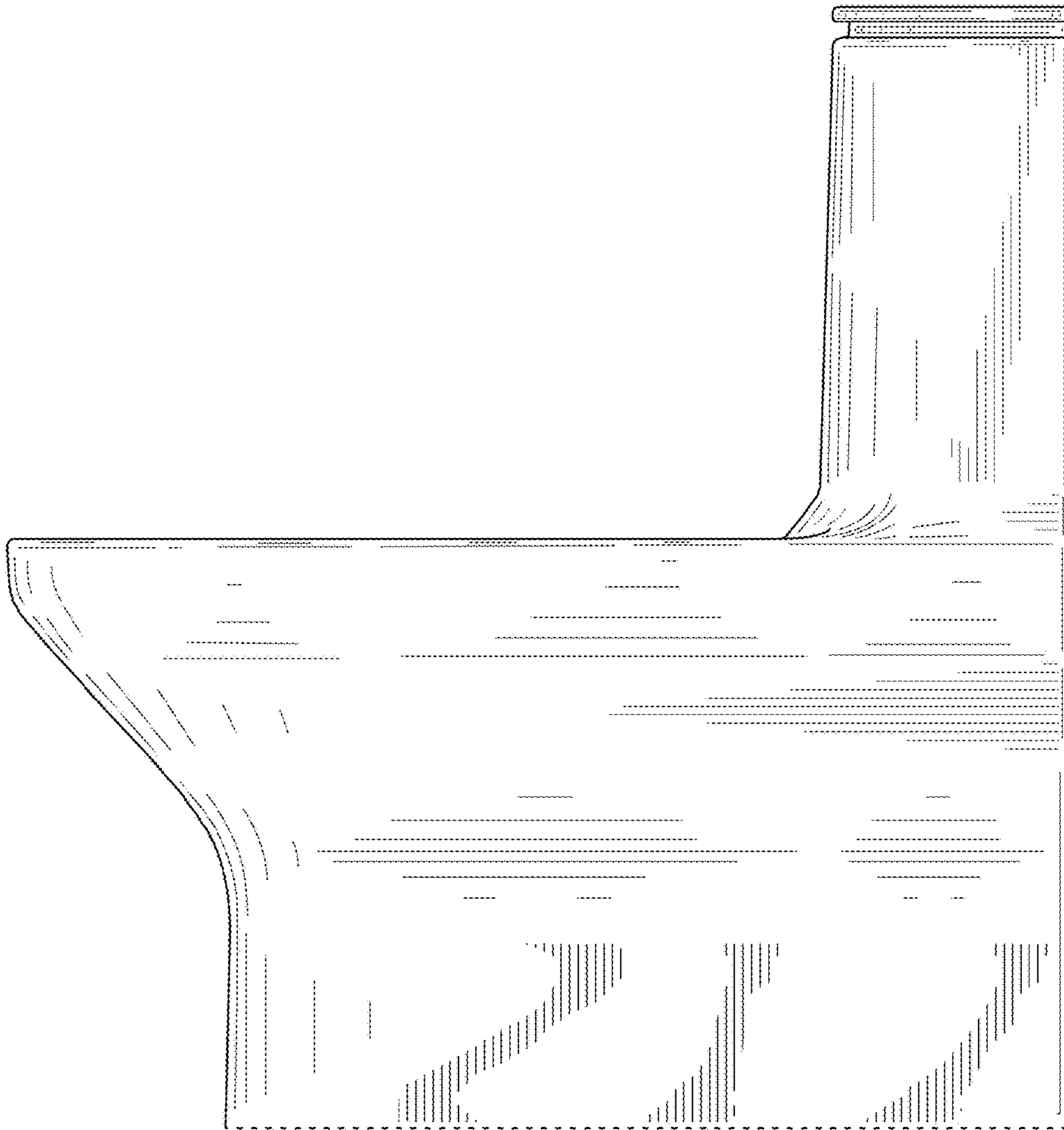

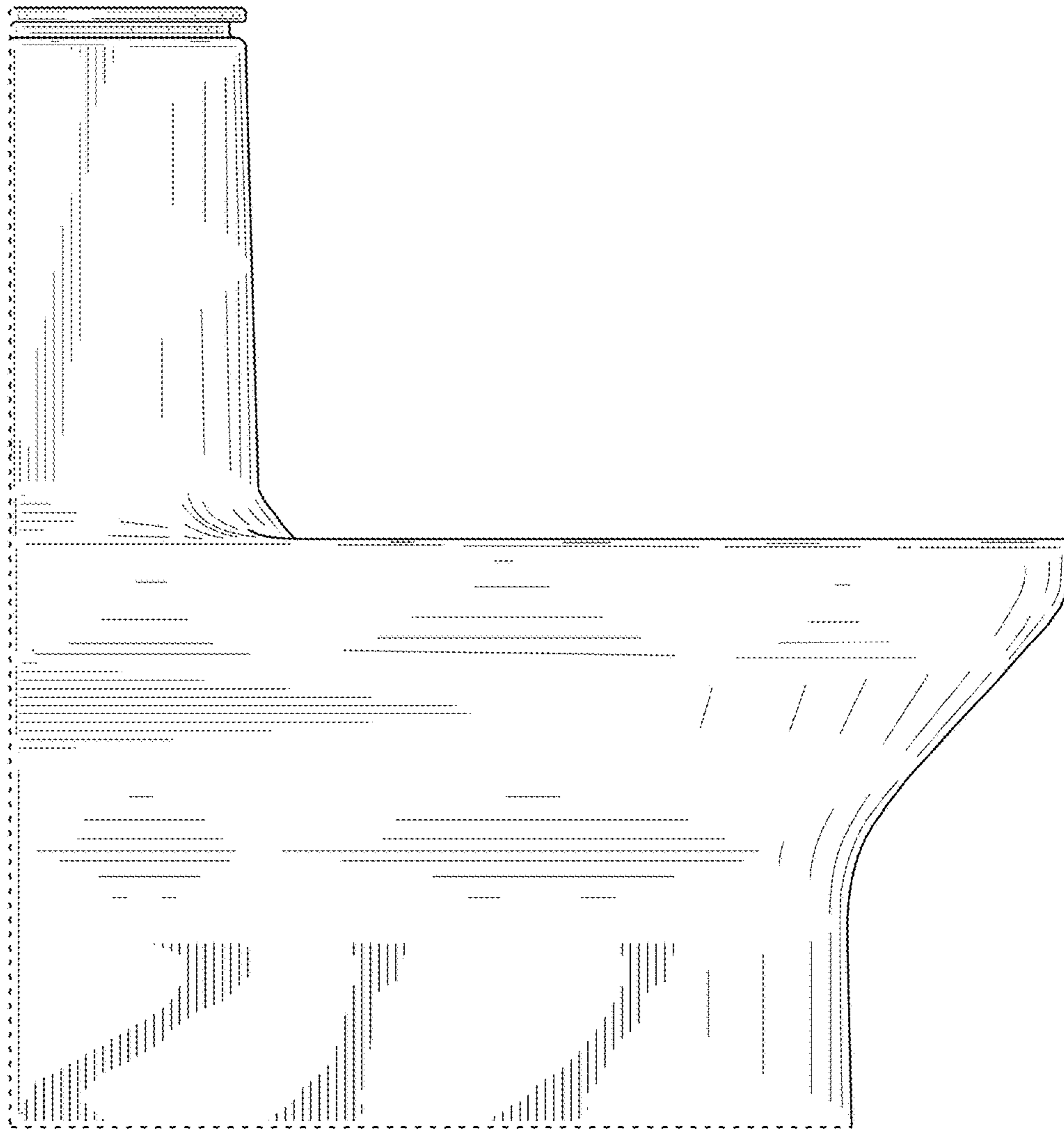

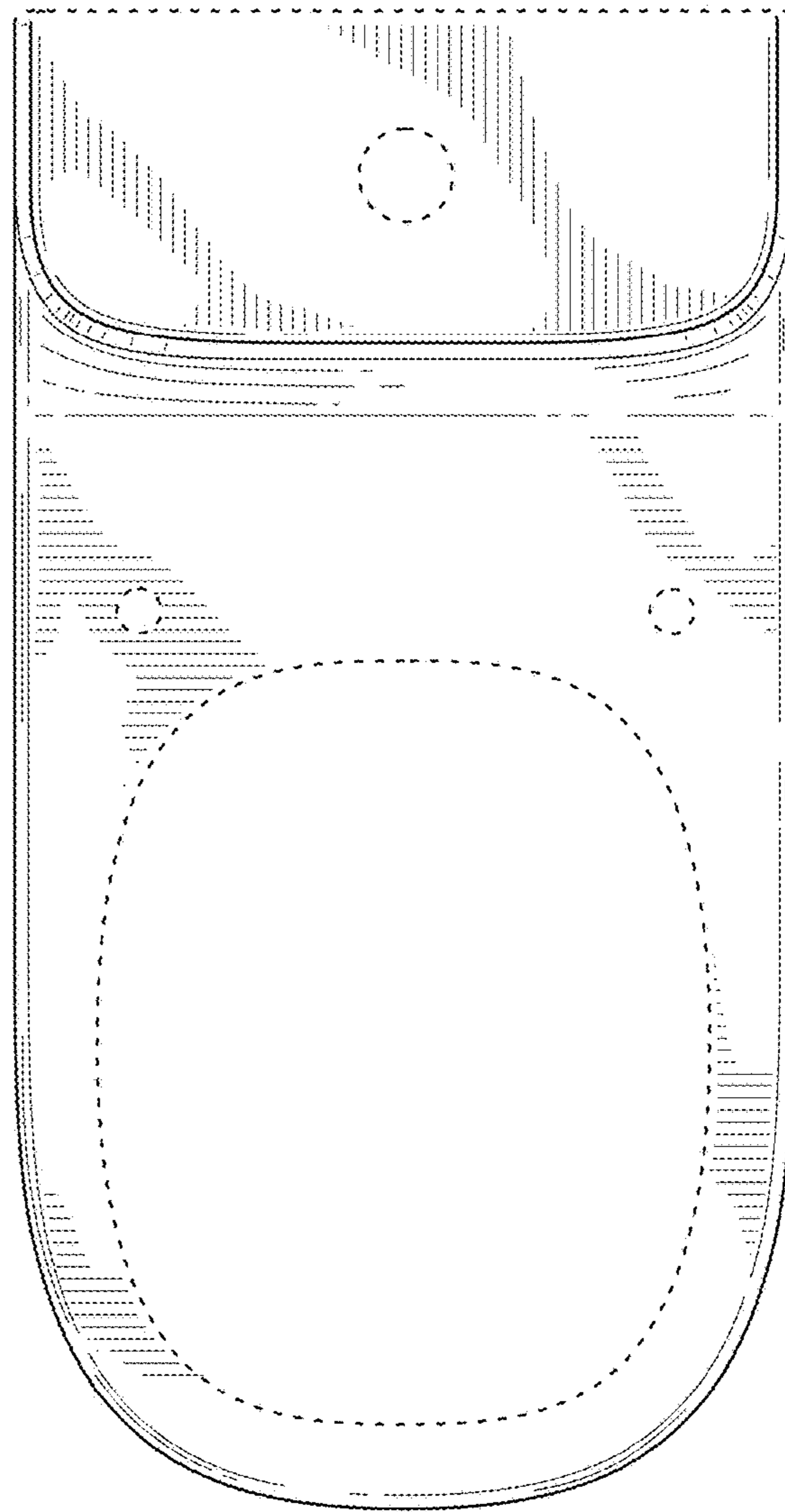

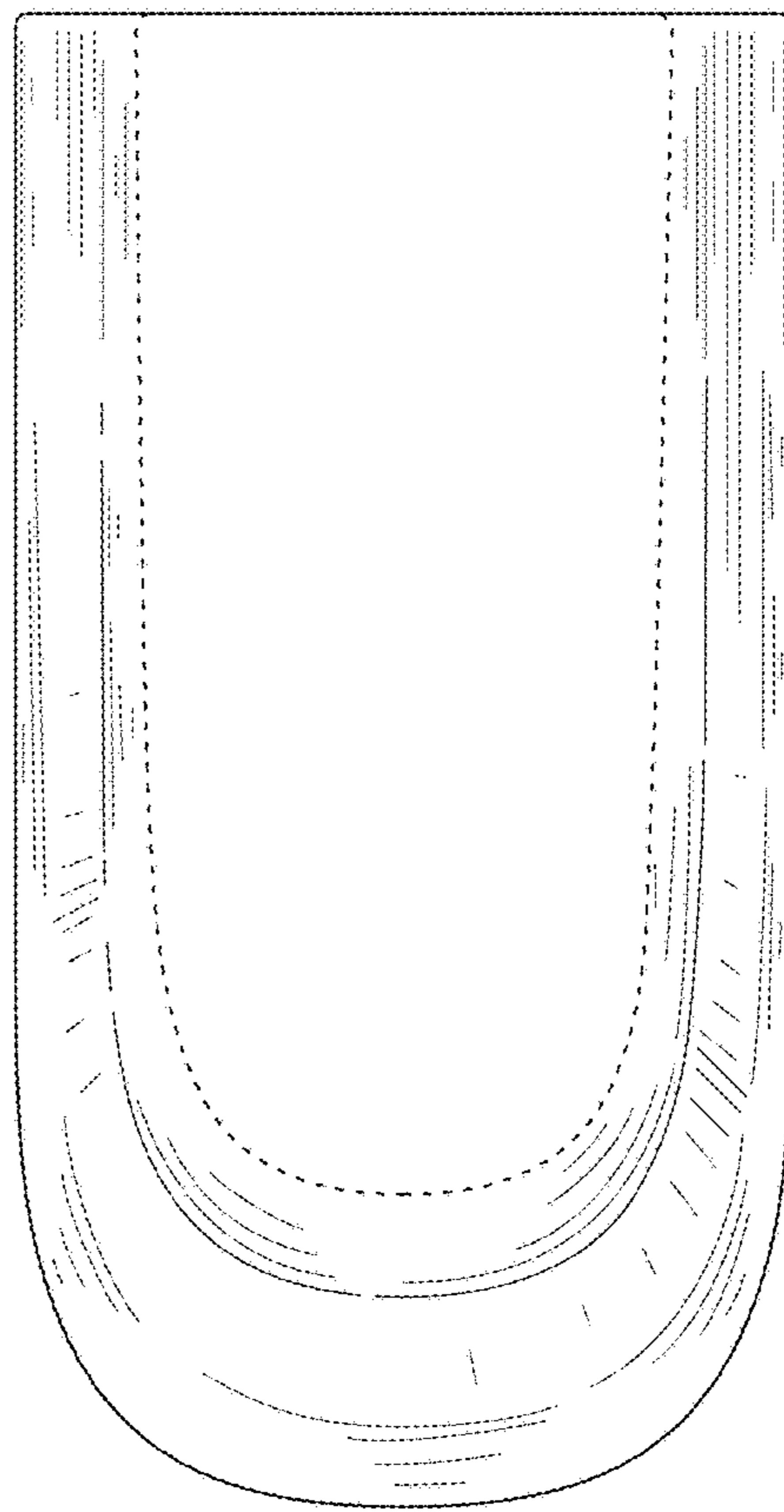
