DESCRIPTION

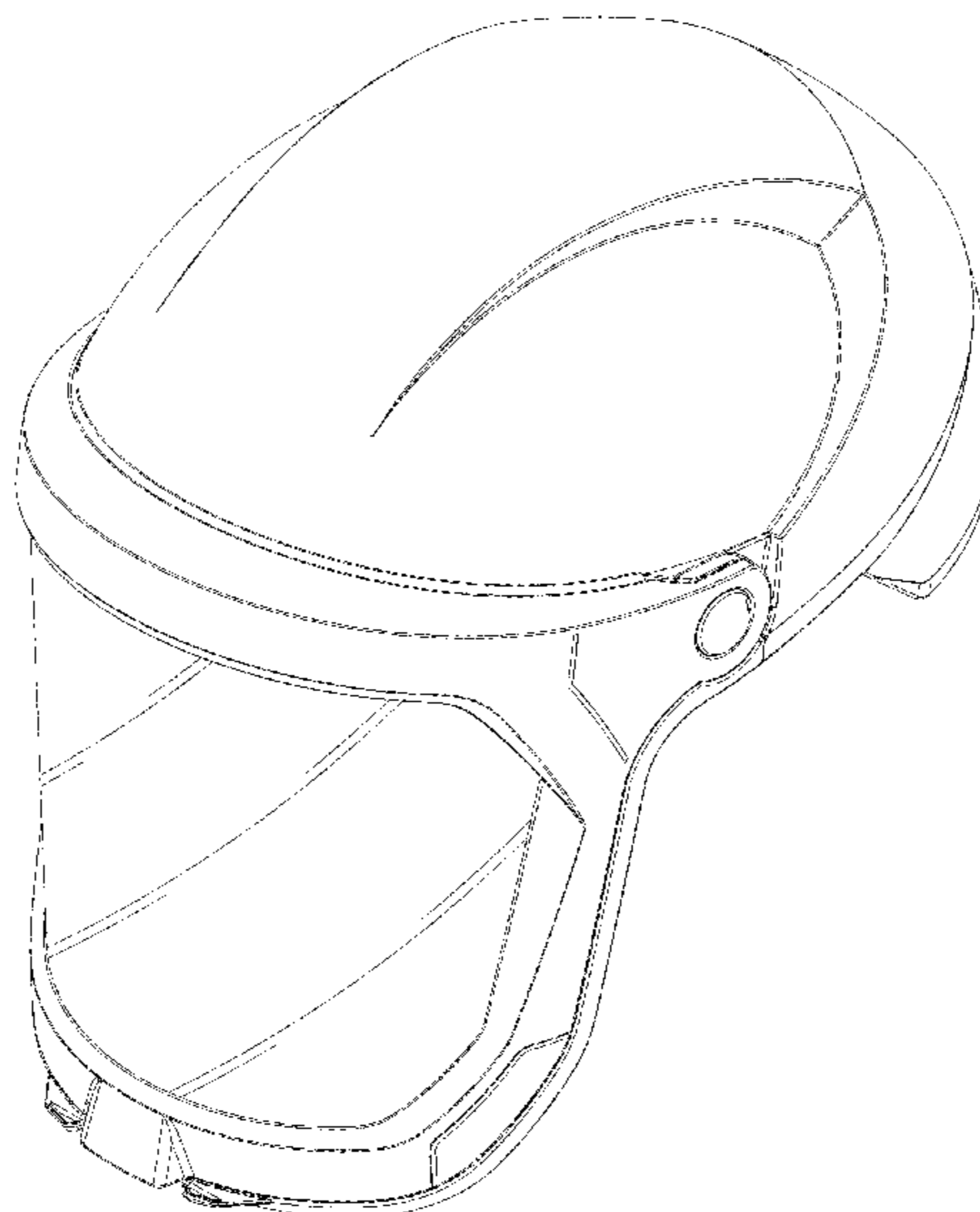
FIG. 1 is a first perspective view of a respirator helmet according to one embodiment of the invention.

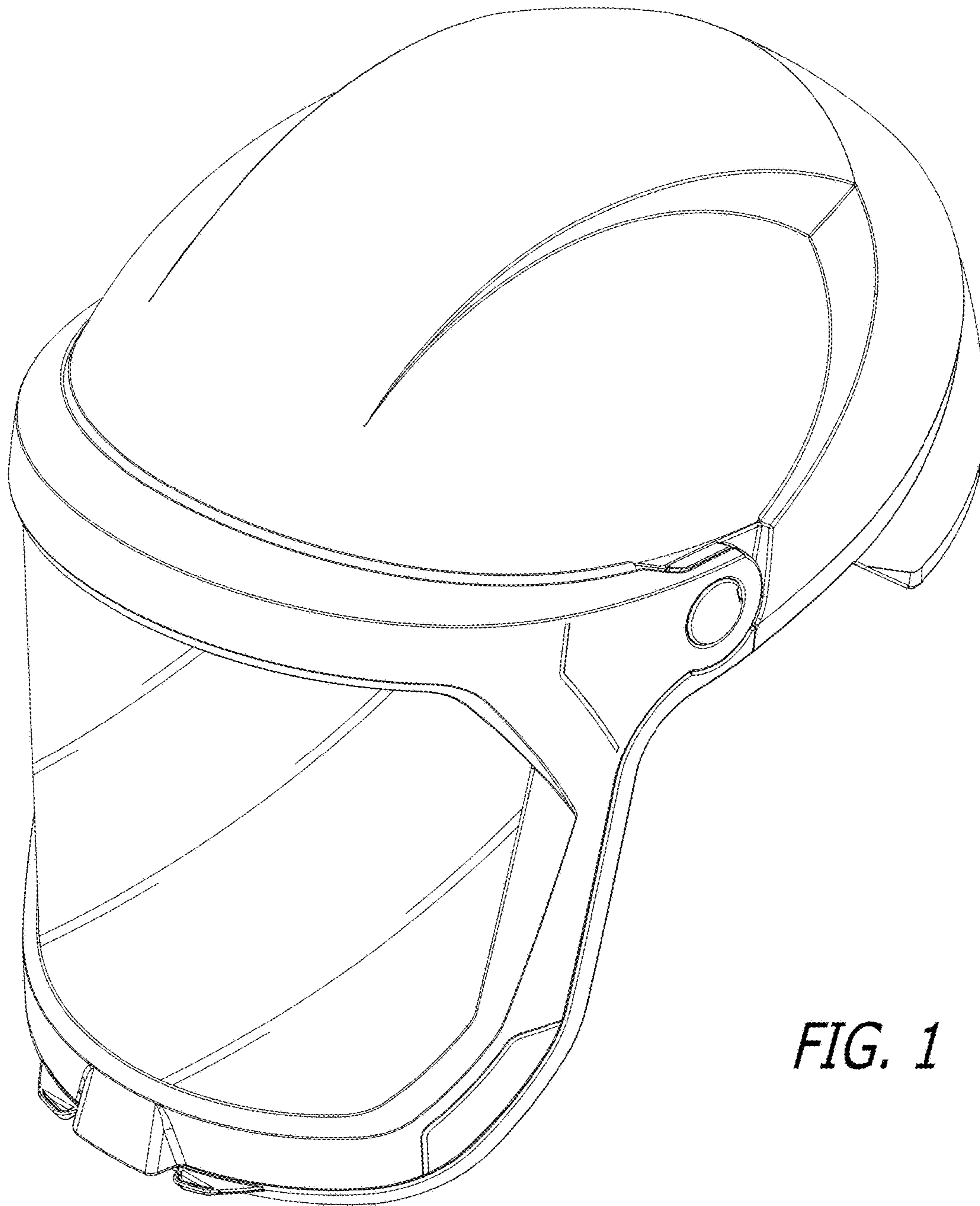

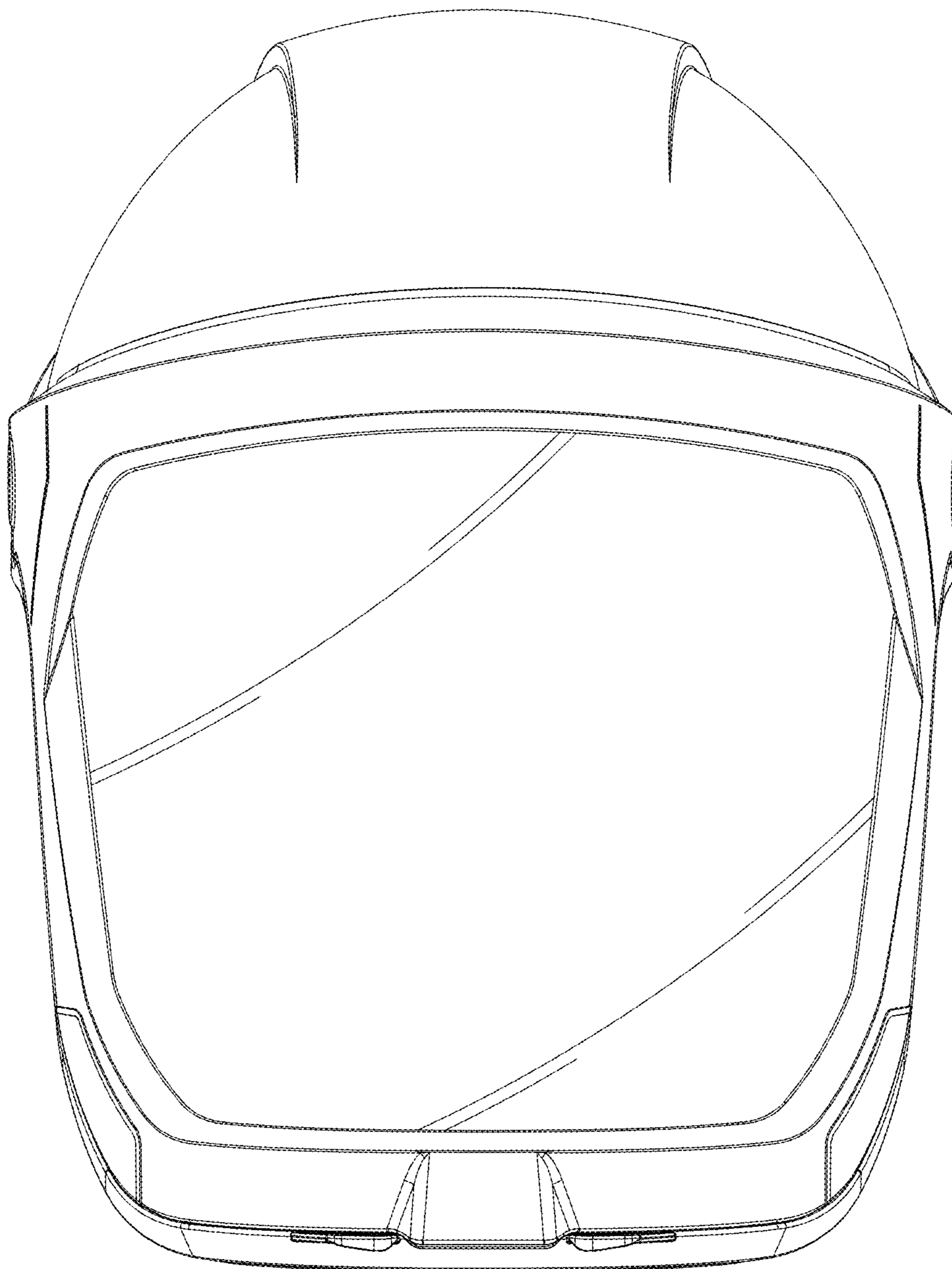

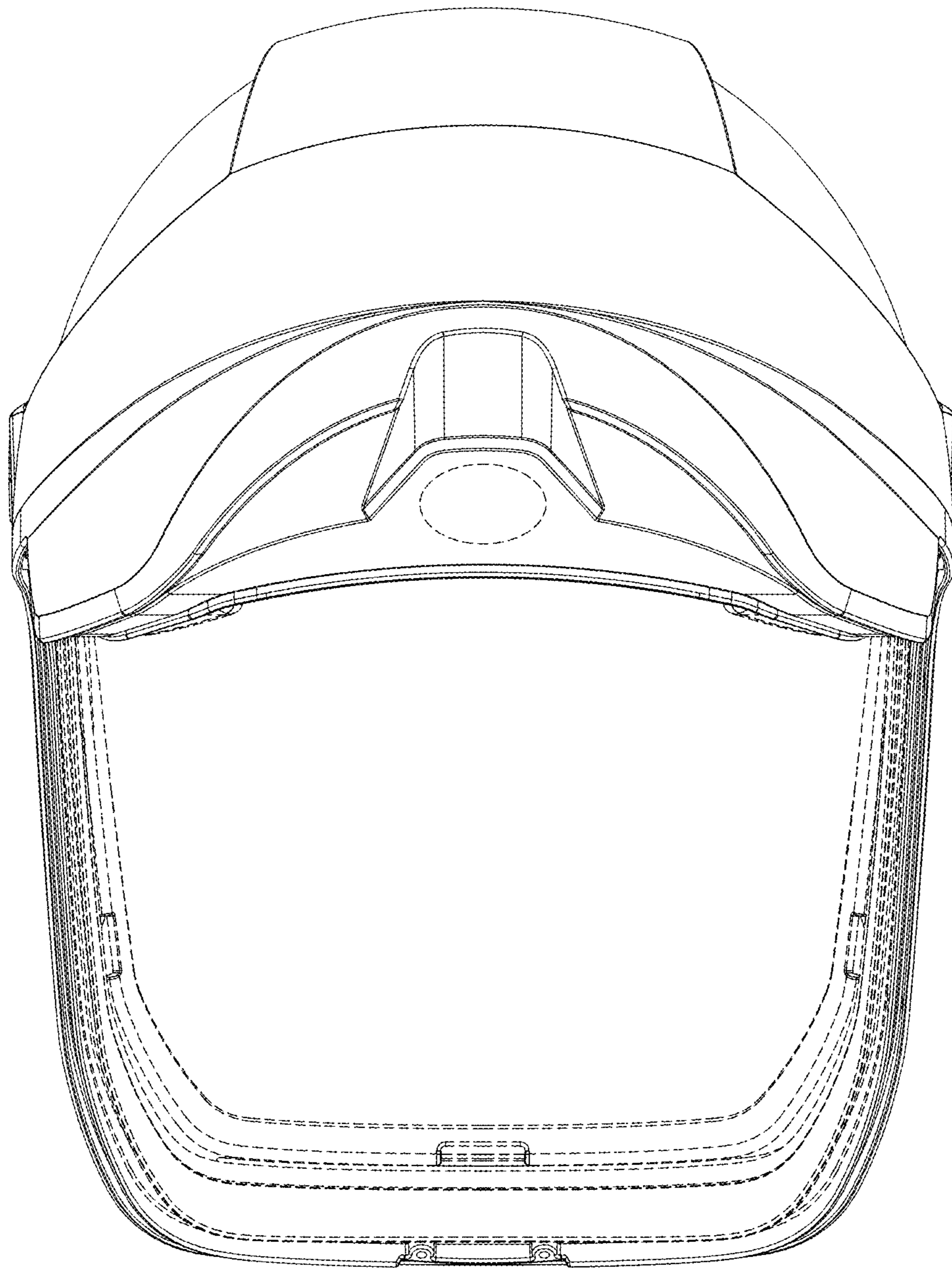

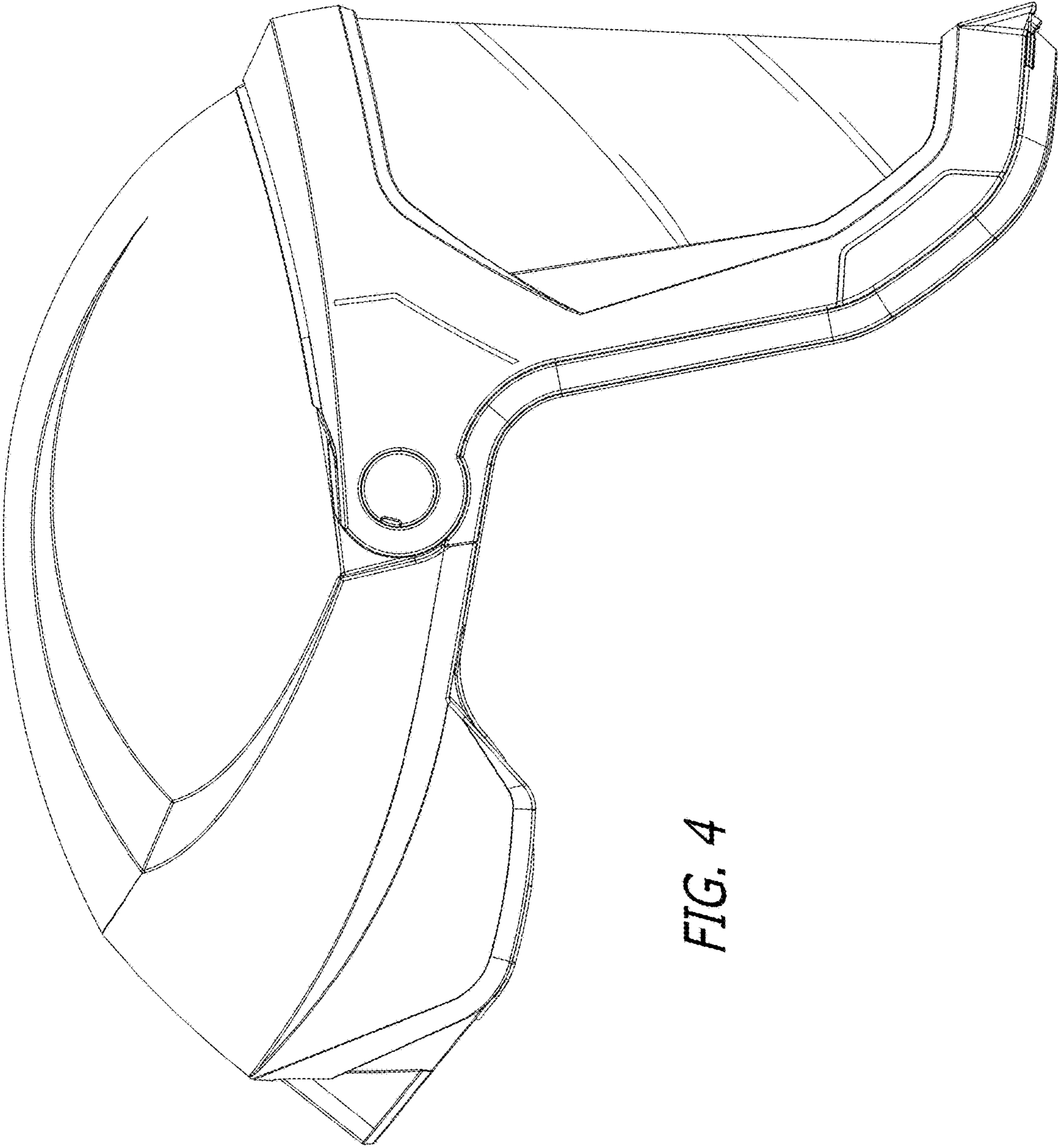

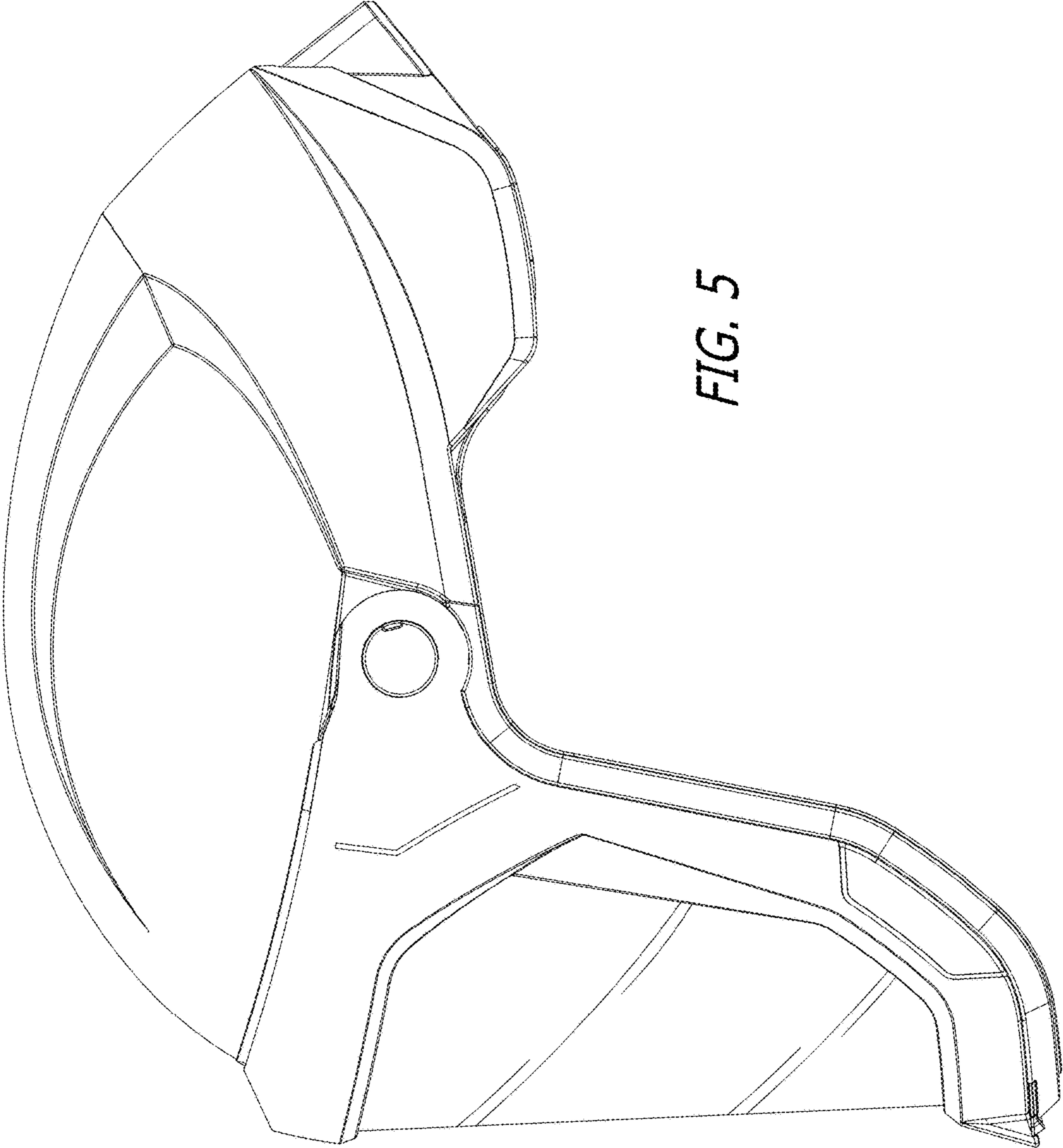

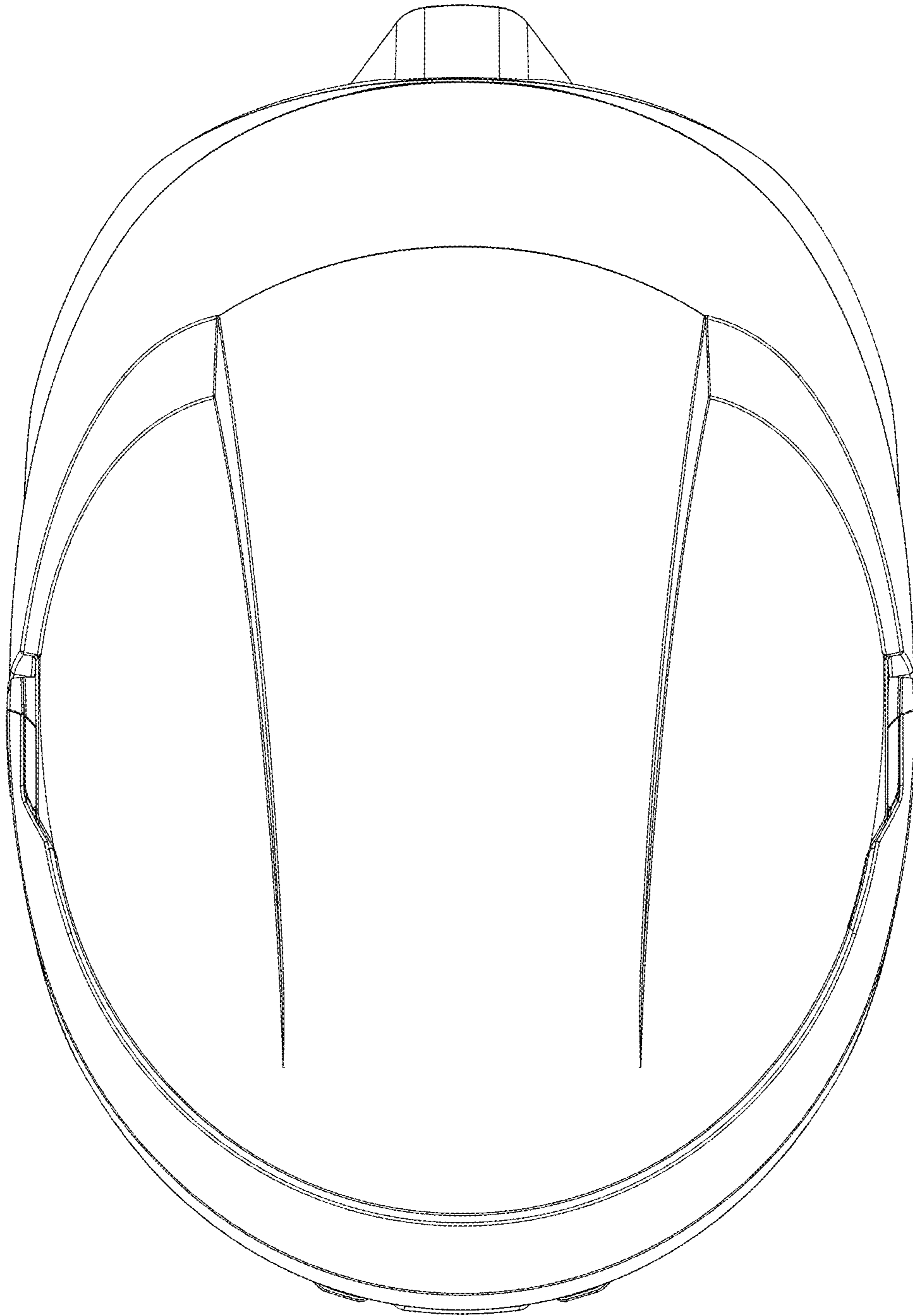

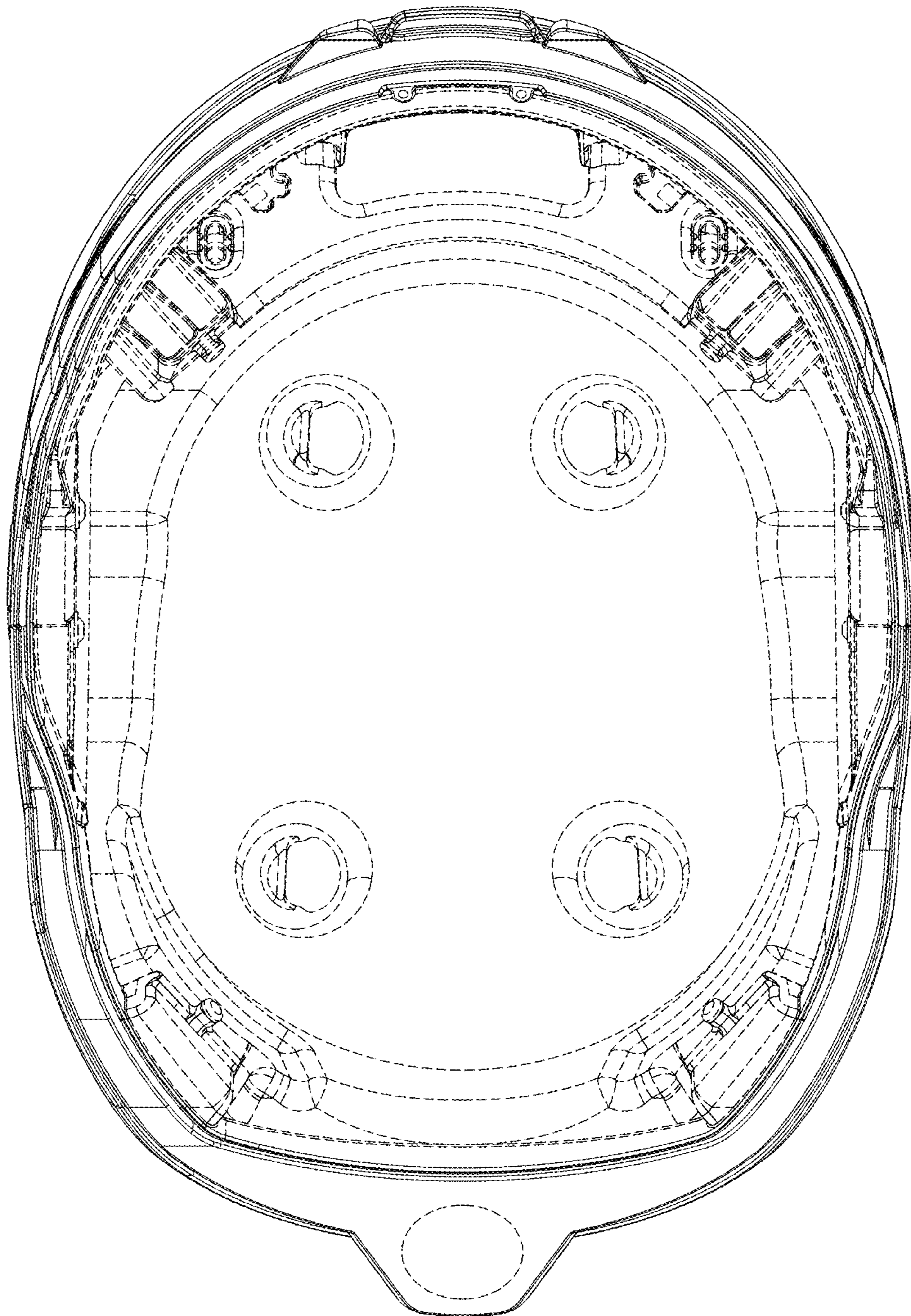
