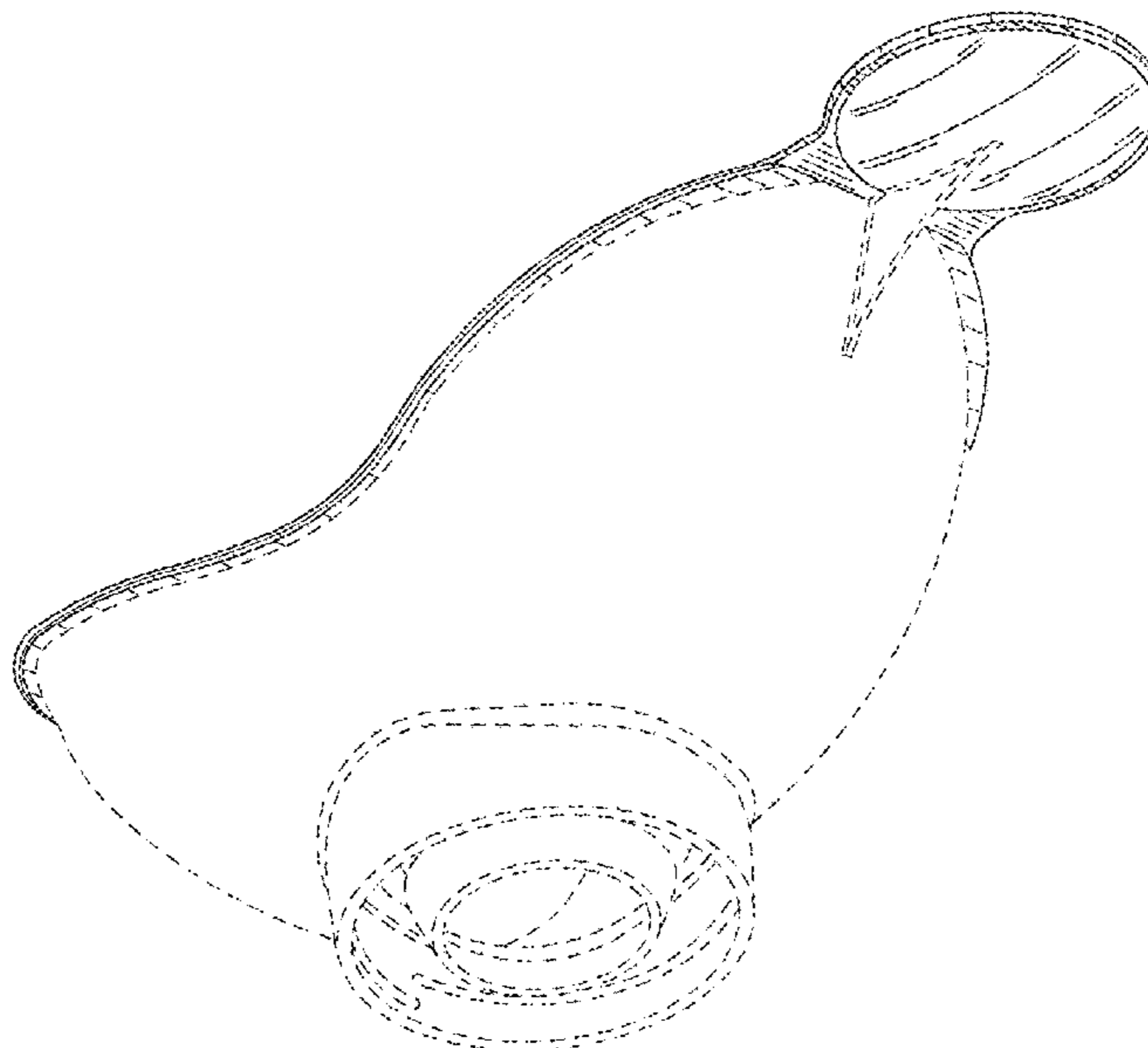
(57) **CLAIM**

The ornamental design for a specimens collector device with a handle, as shown and described.

**DESCRIPTION**

FIG. 1 is a first prospective view of an ornamental design of an exemplary embodiment of a specimens collector device with a handle showing our new design; FIG. 2 is a second prospective view thereof; FIG. 3 is a first side view thereof; FIG. 4 is a top view thereof; and, FIG. 5 is a bottom view thereof. 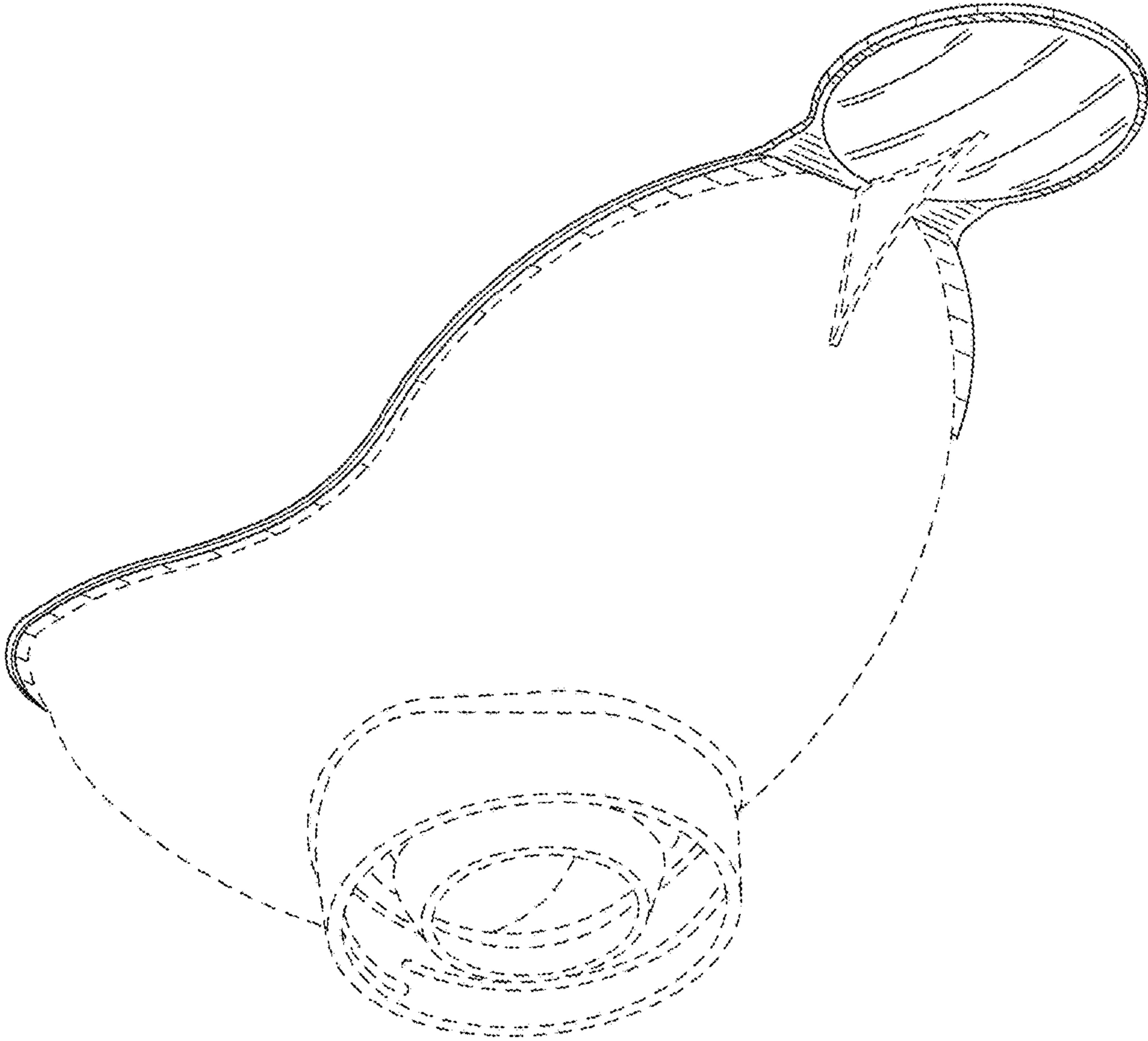

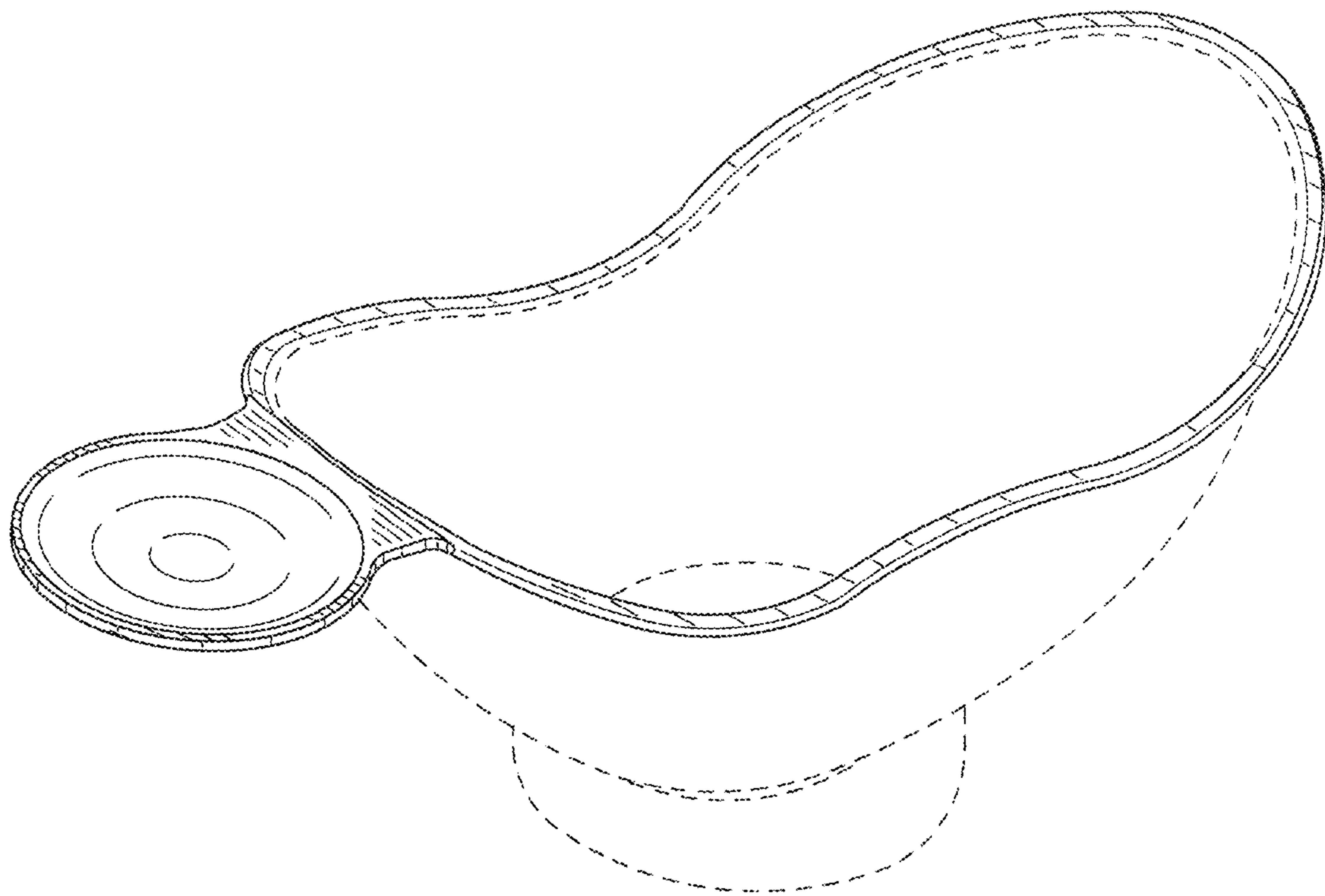

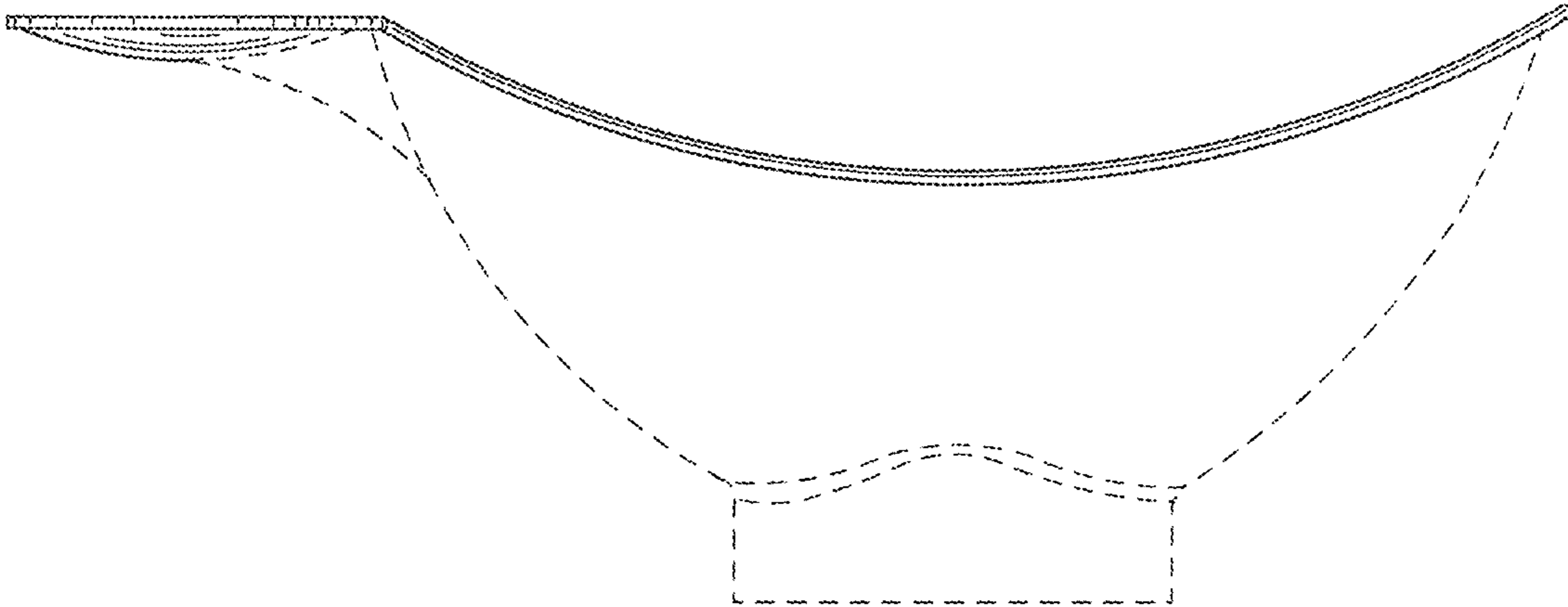

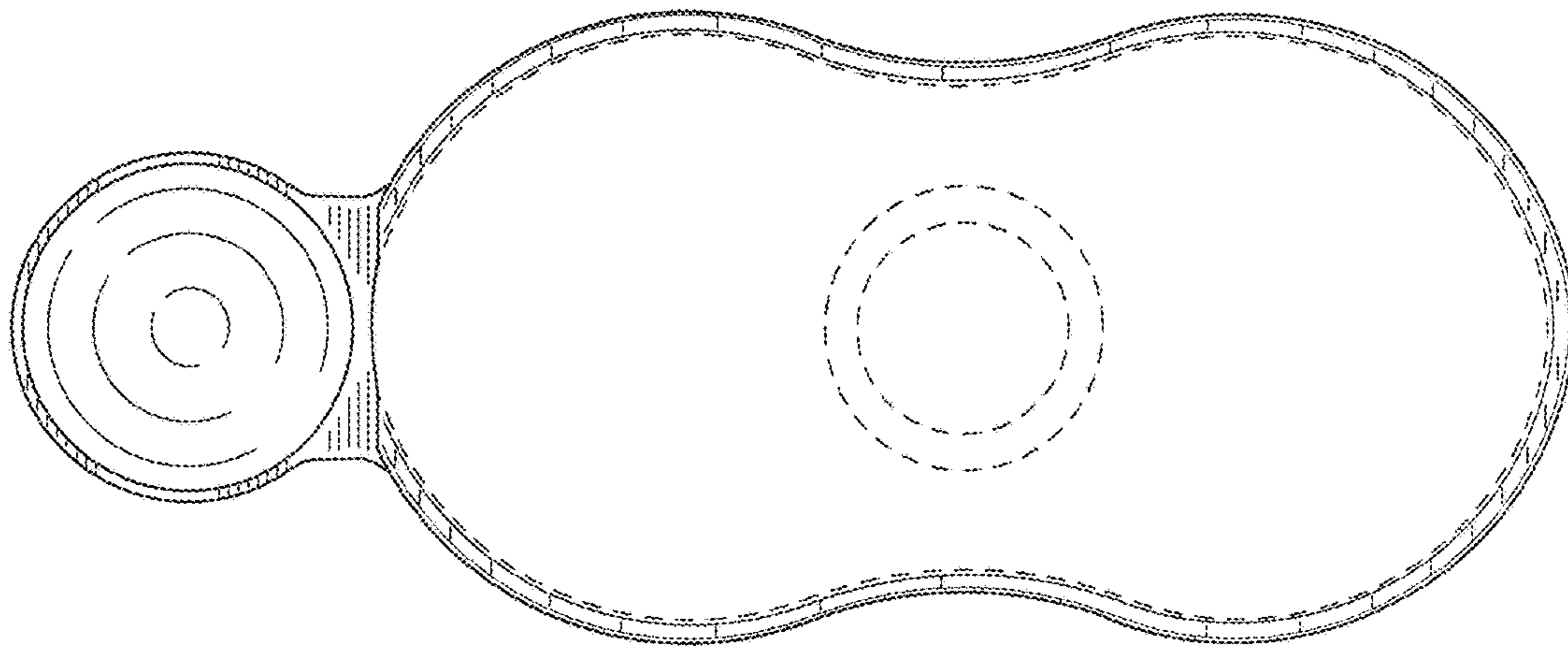

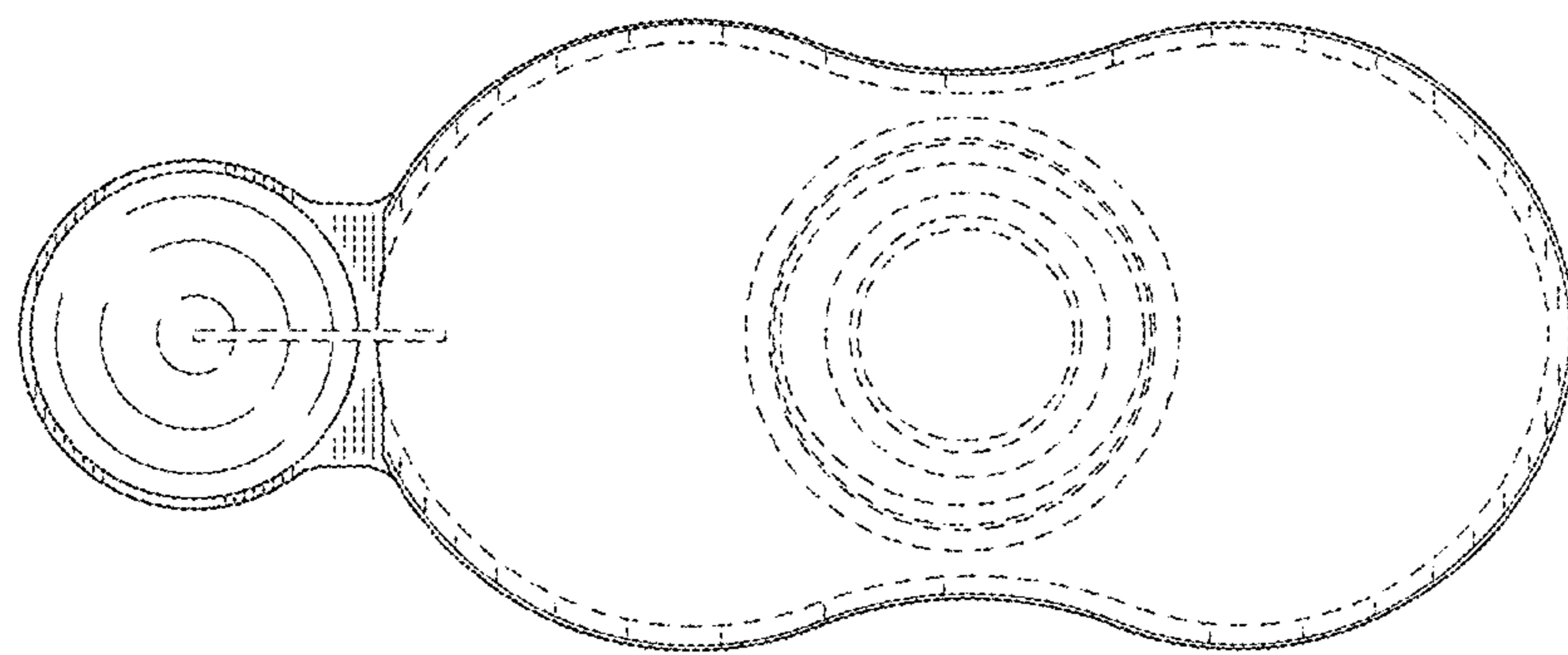
