The ornamental design for a knee wrap, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a knee wrap showing my new design;

FIG. 2 is a front elevation view thereof;

FIG. 3 is a back elevation view thereof;

FIG. 4 is a left side elevation view thereof;

FIG. 5 is a right side elevation view thereof;

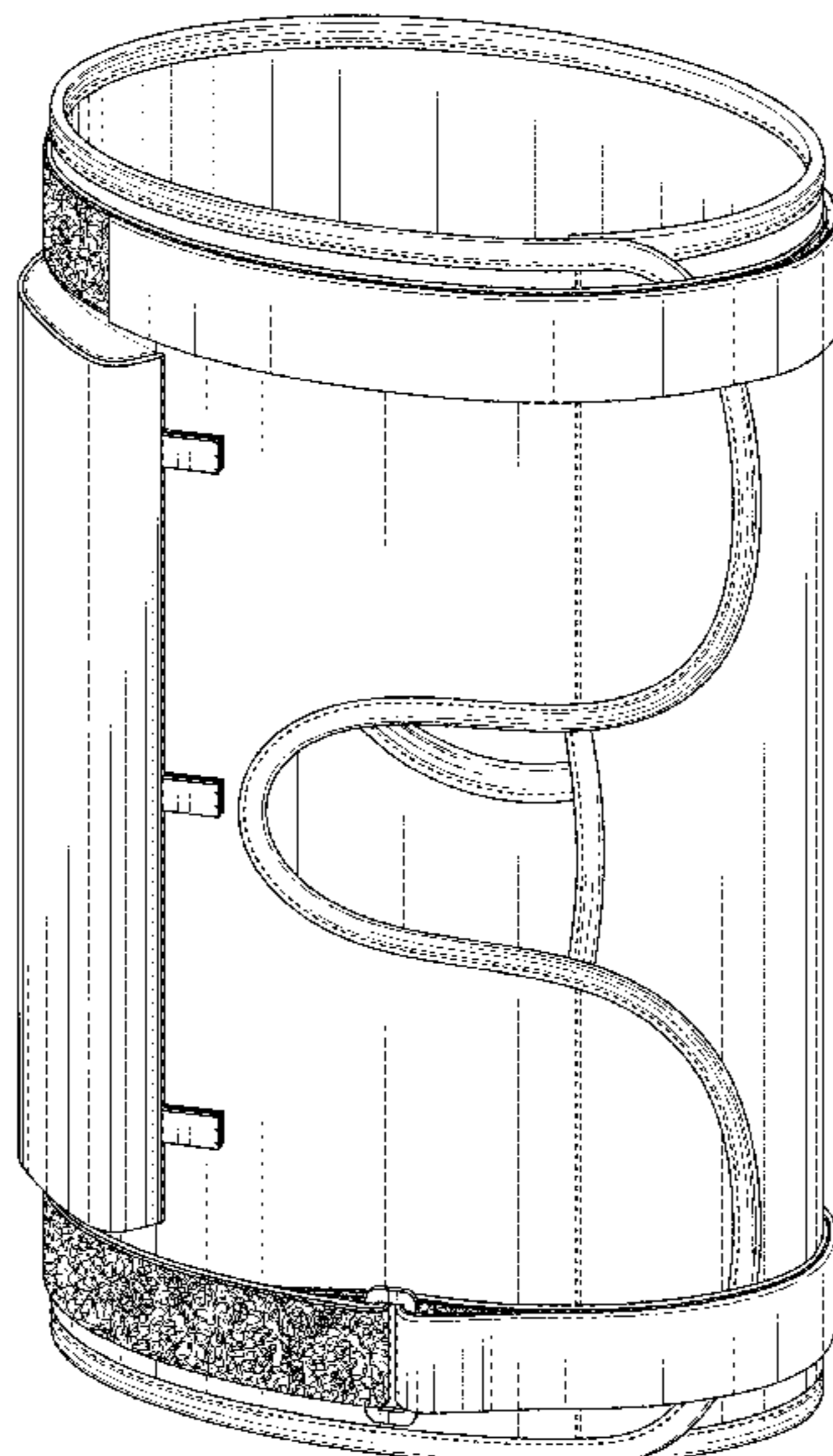

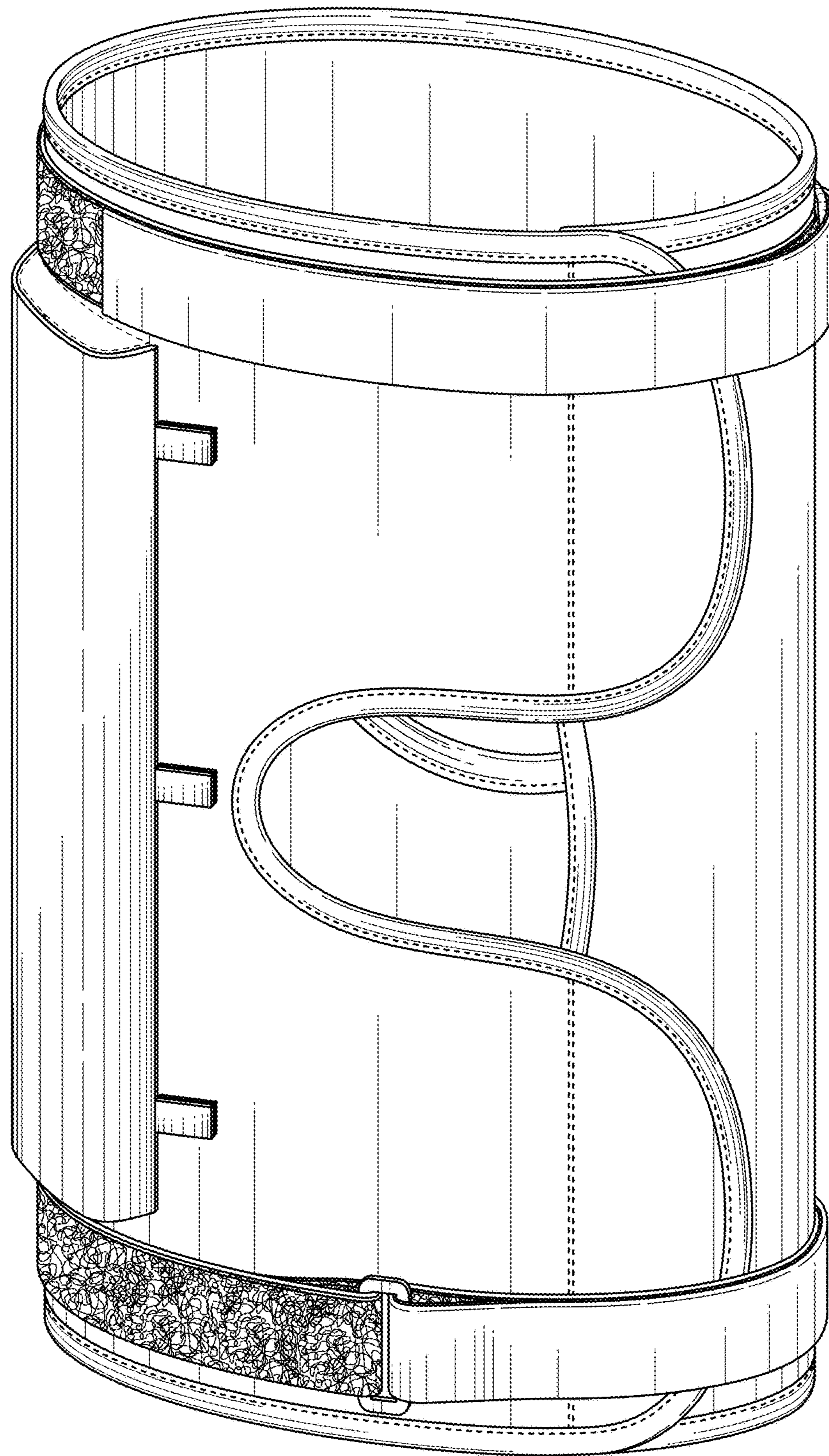

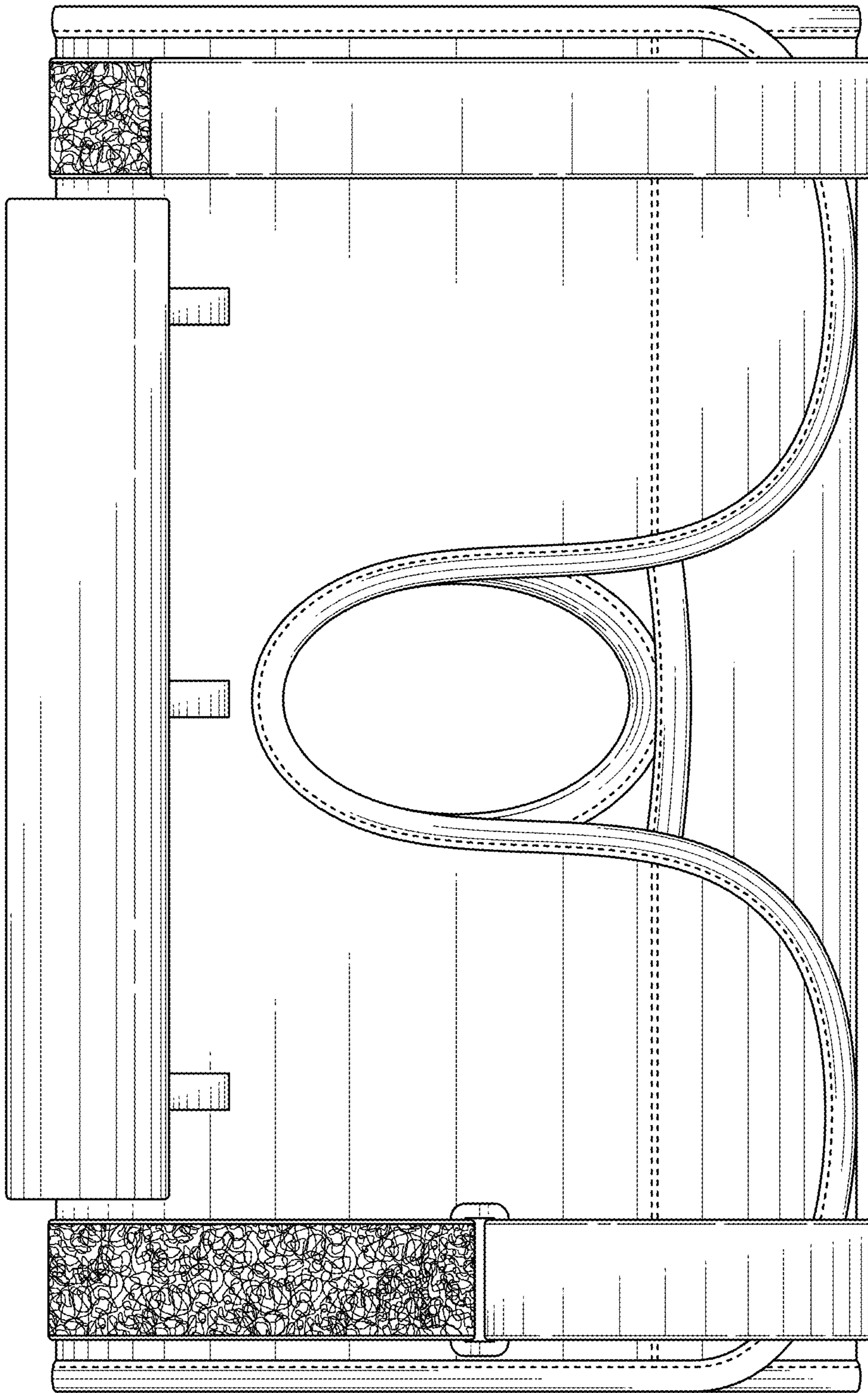

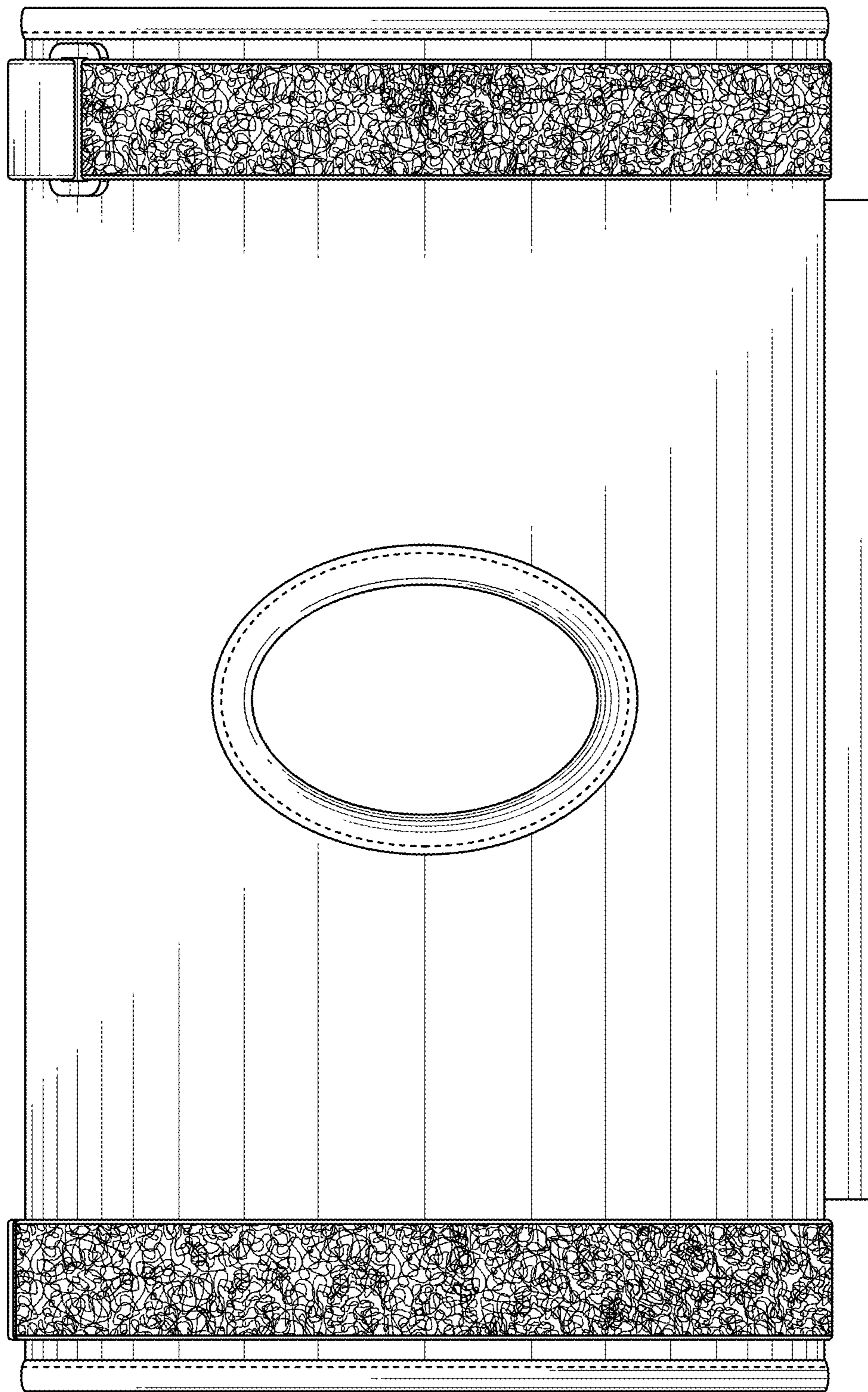

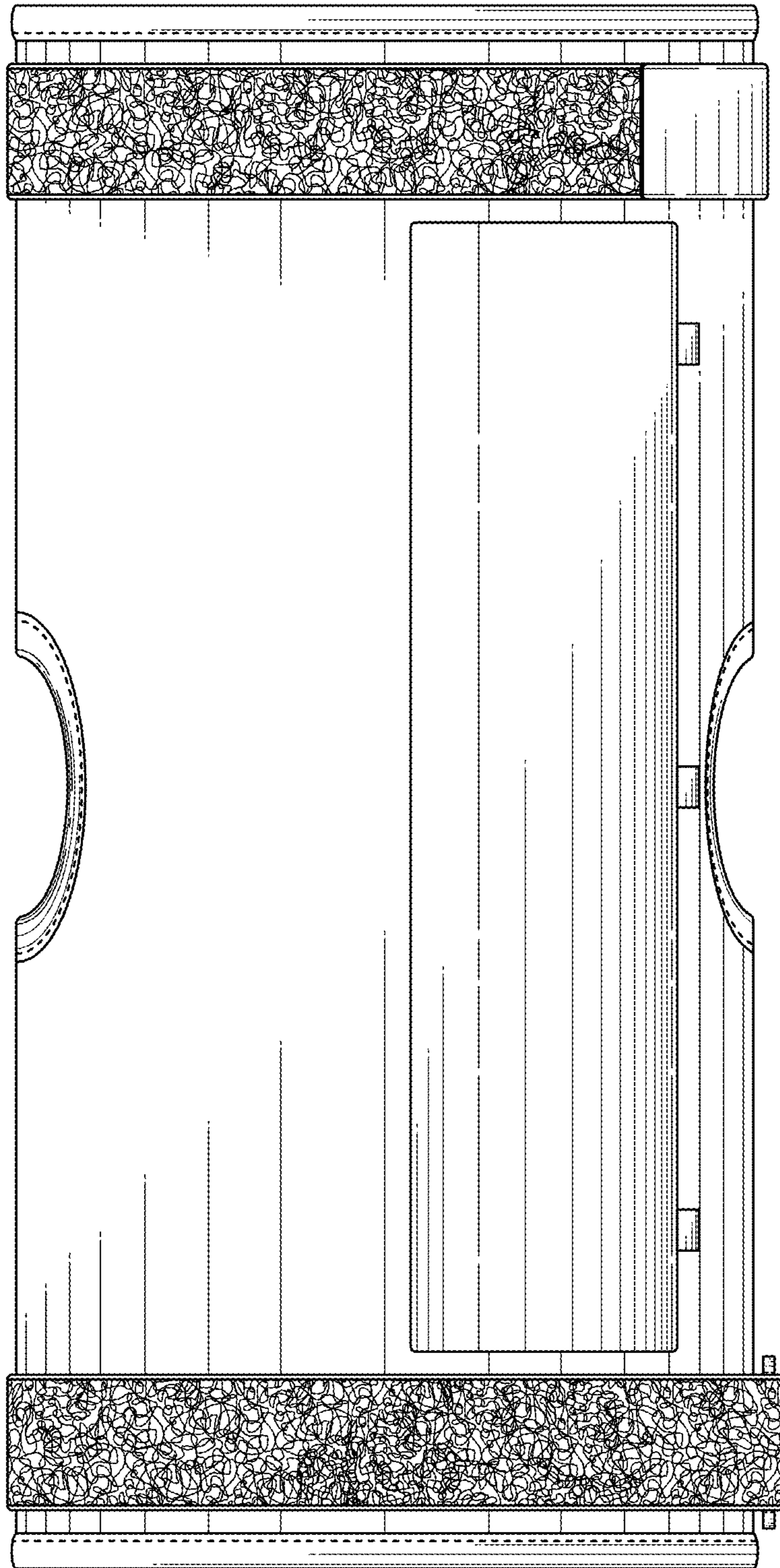

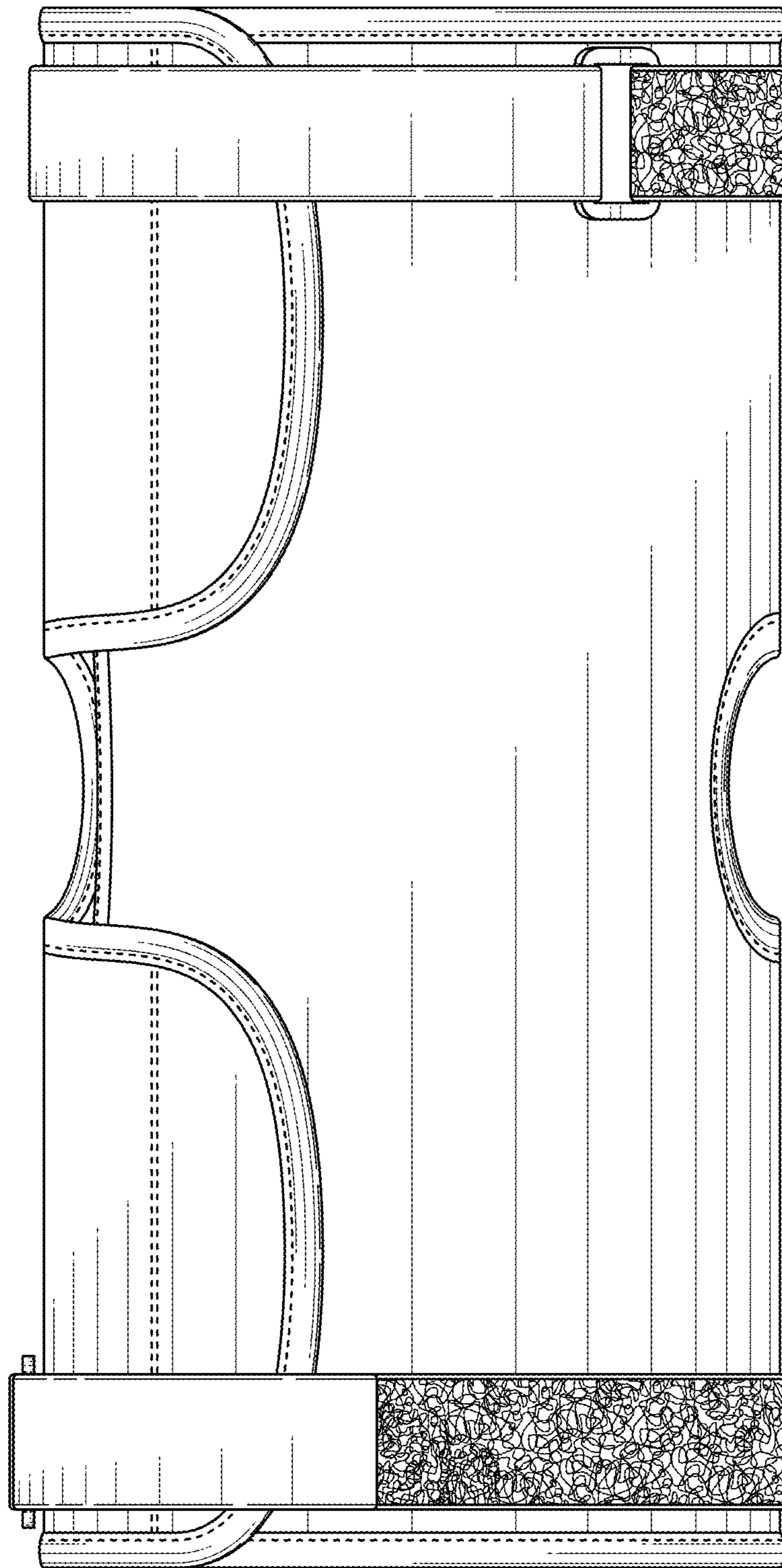

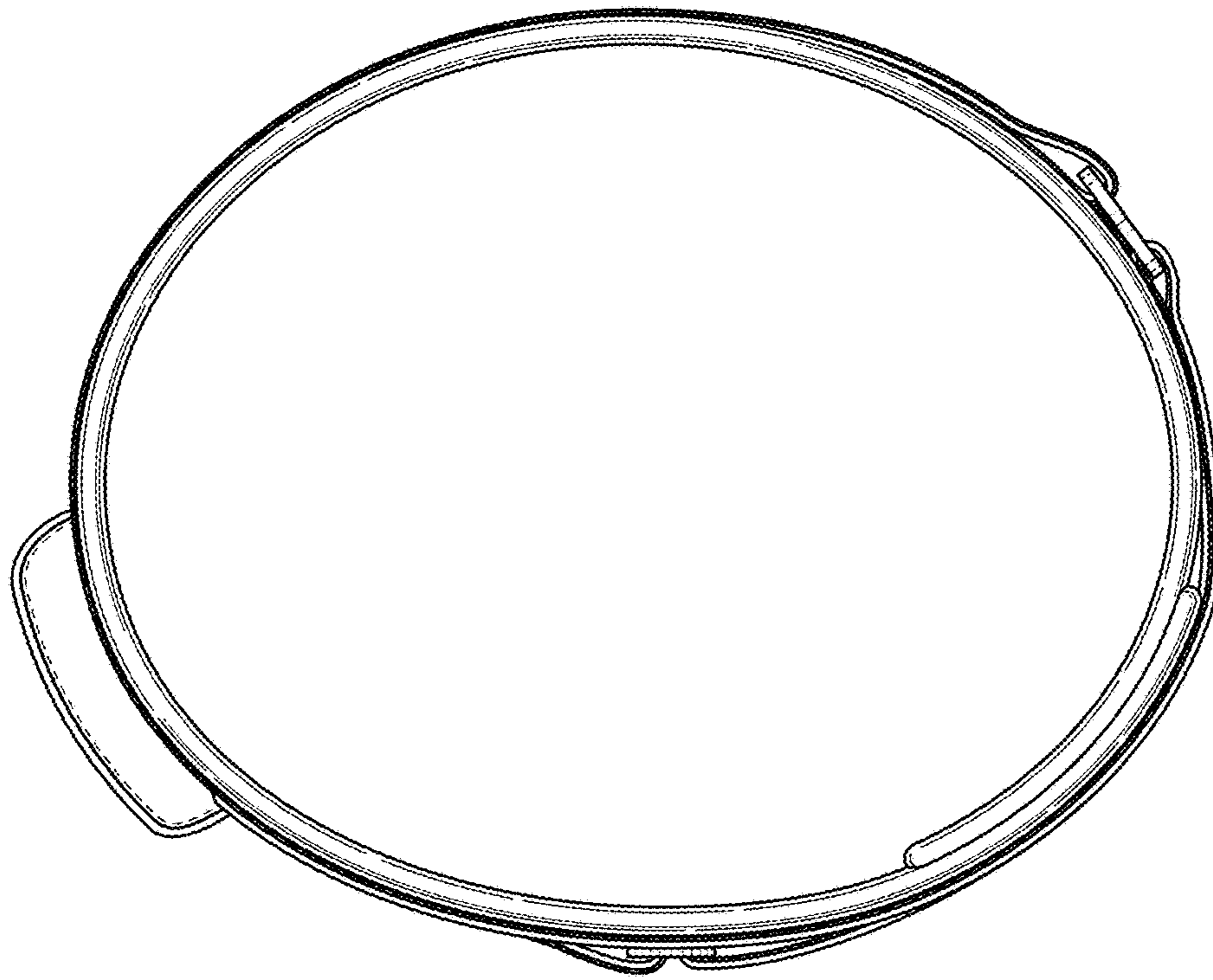

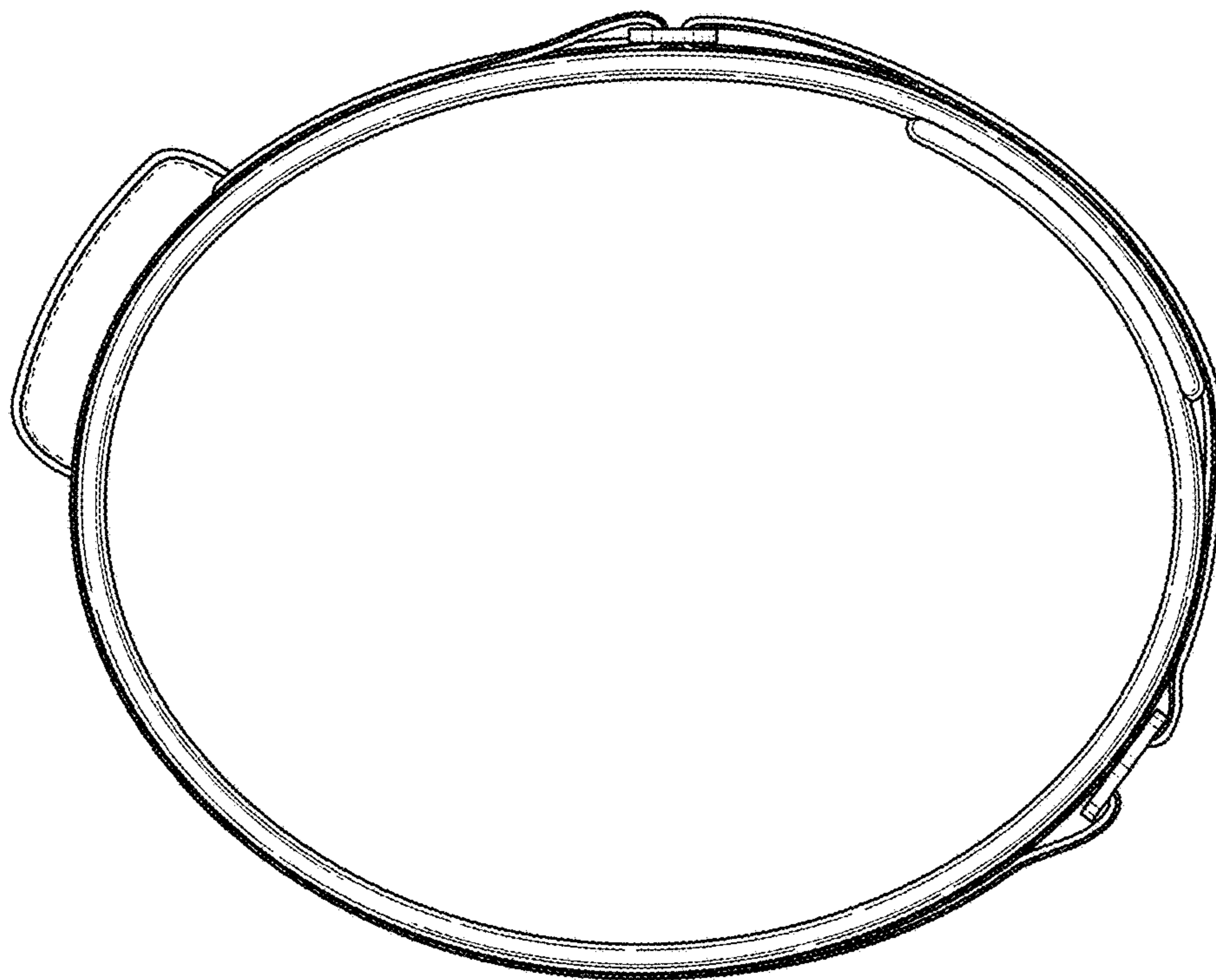

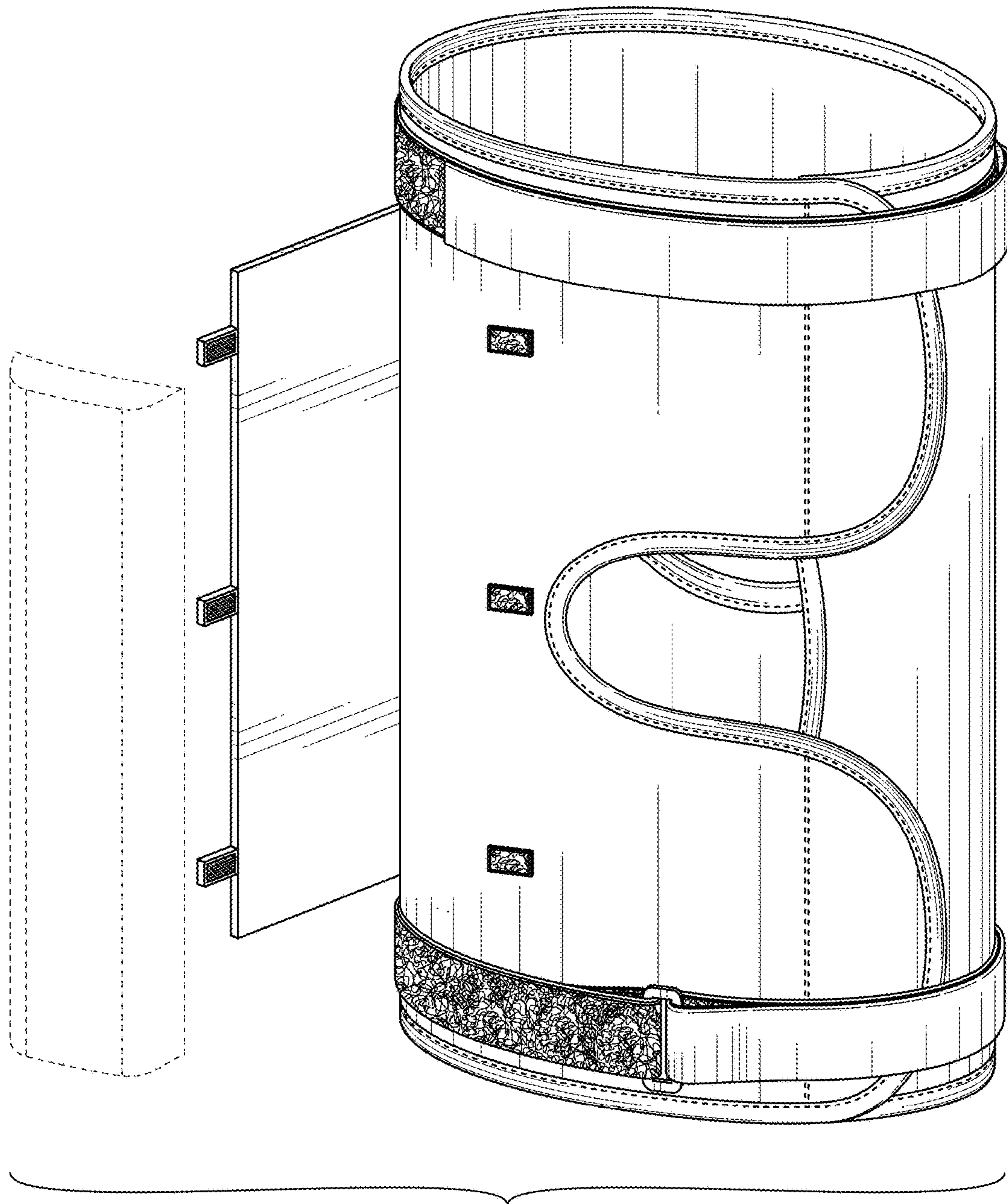
