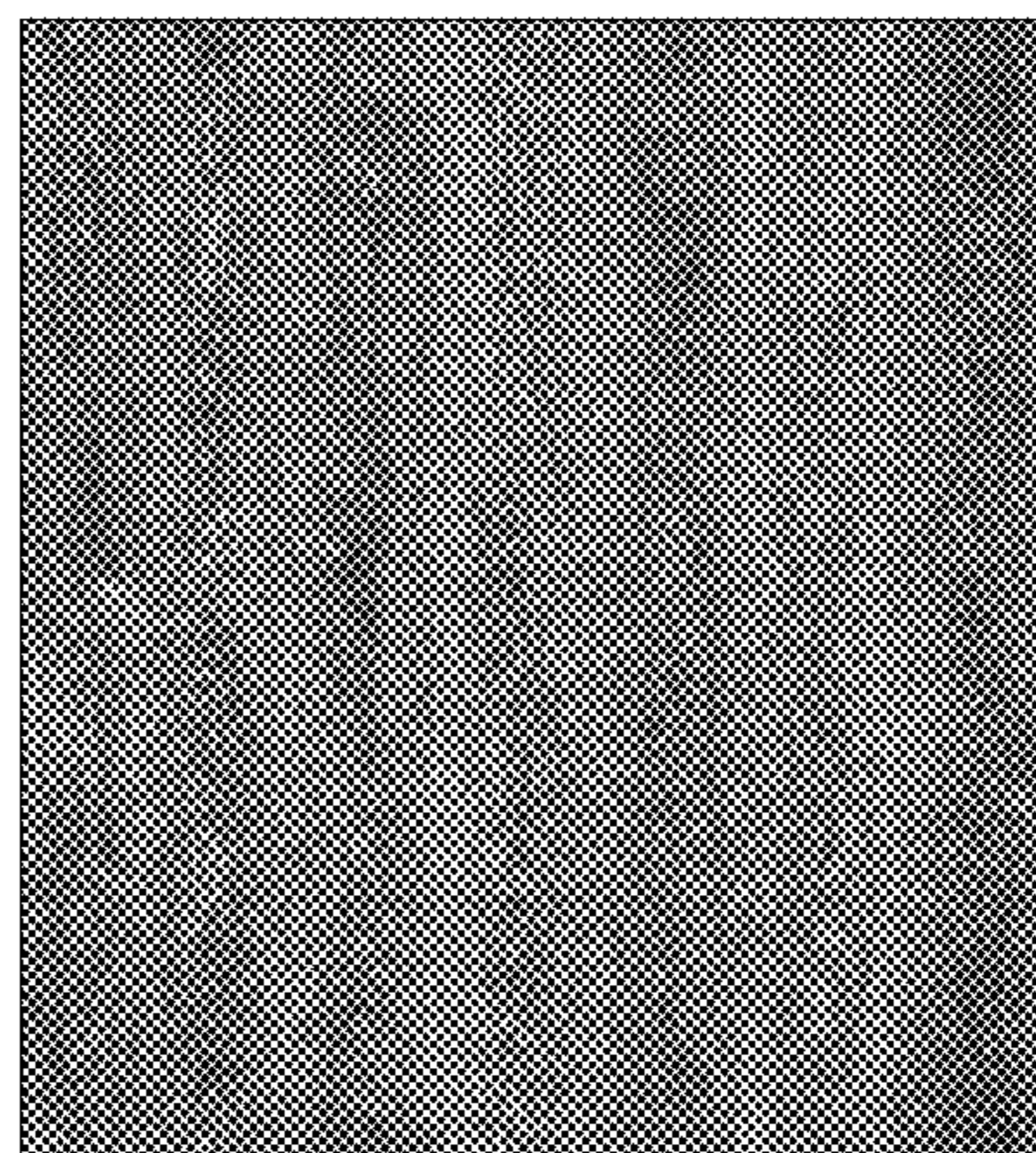
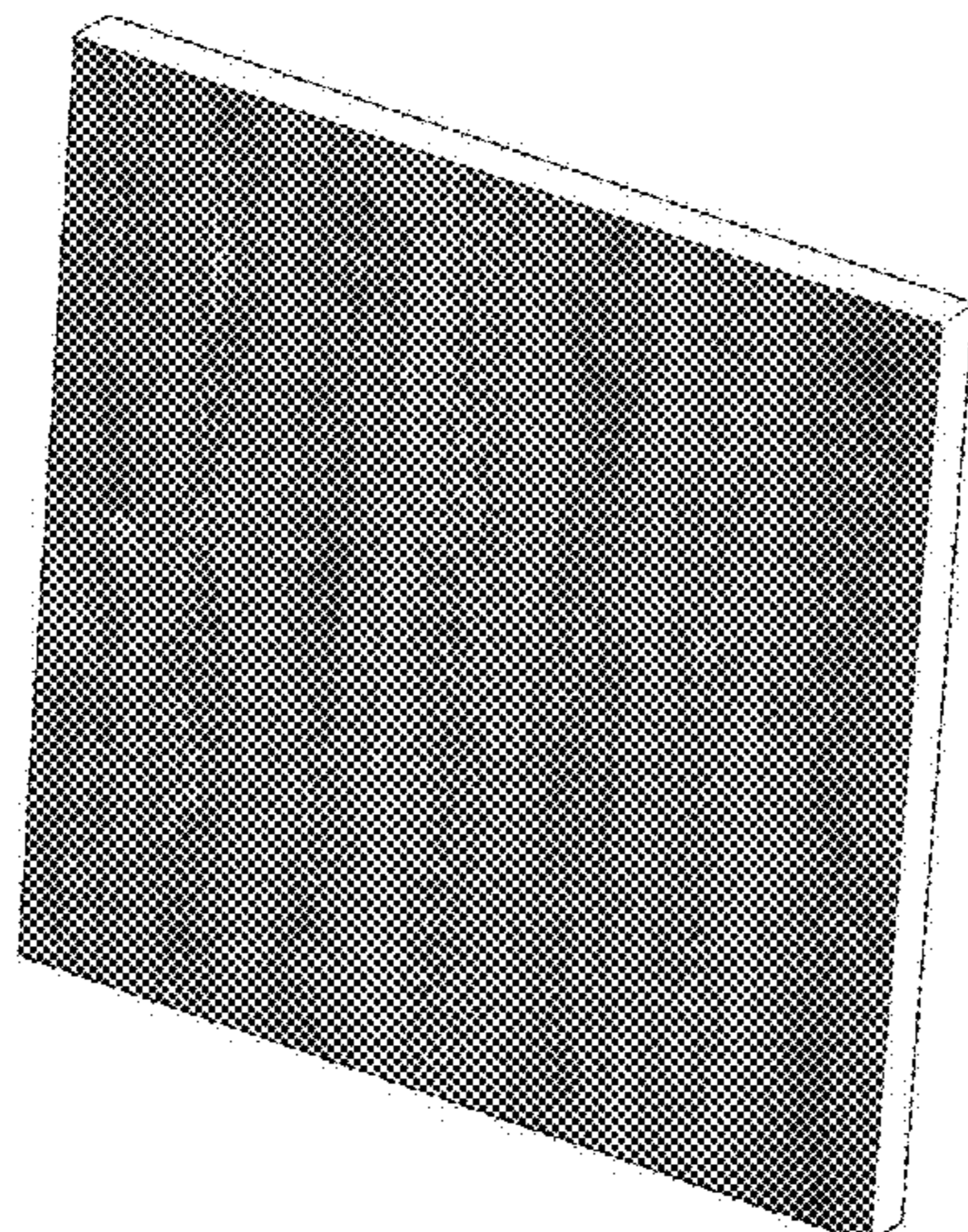
I claim the ornamental design for a tile, as shown and described.

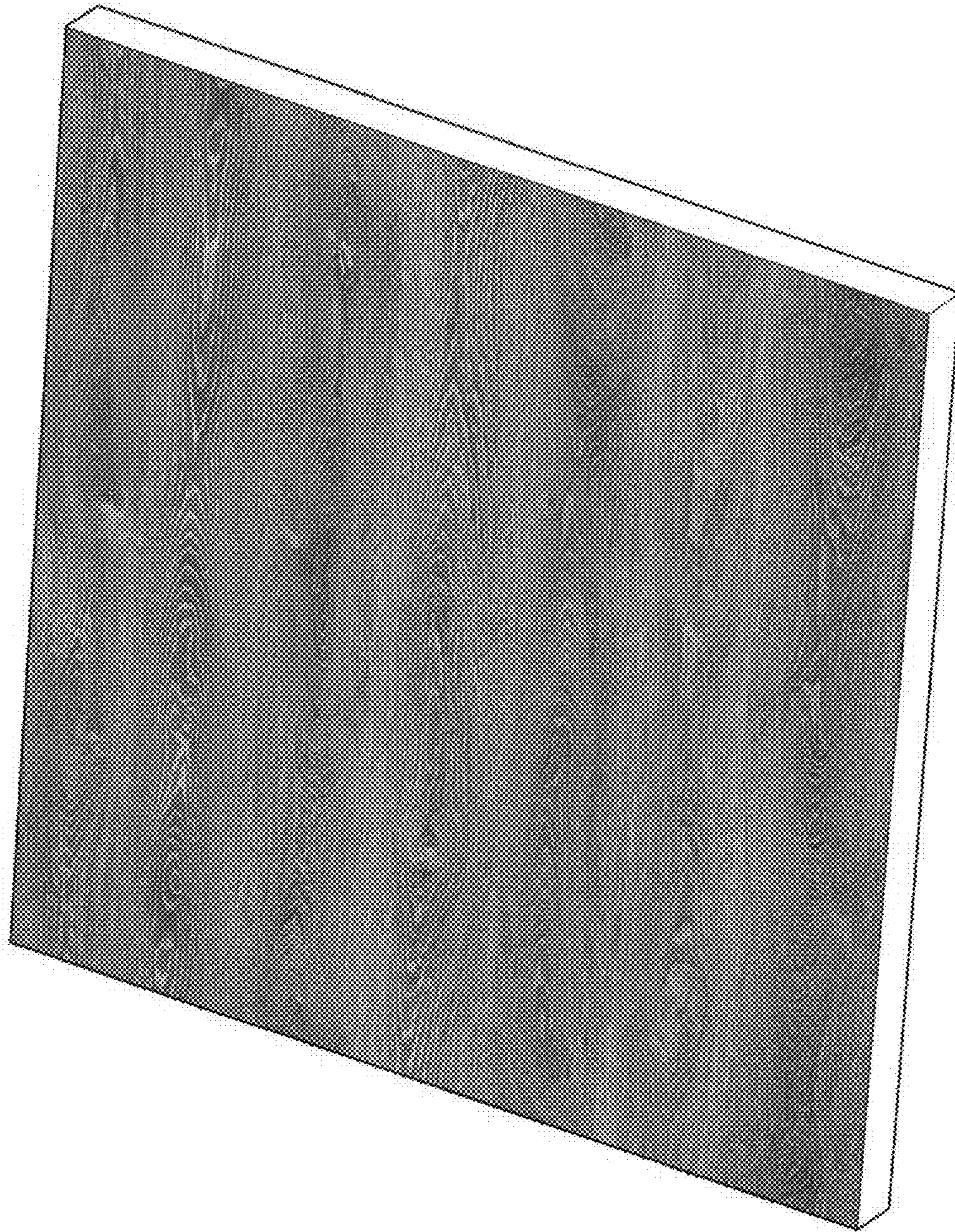

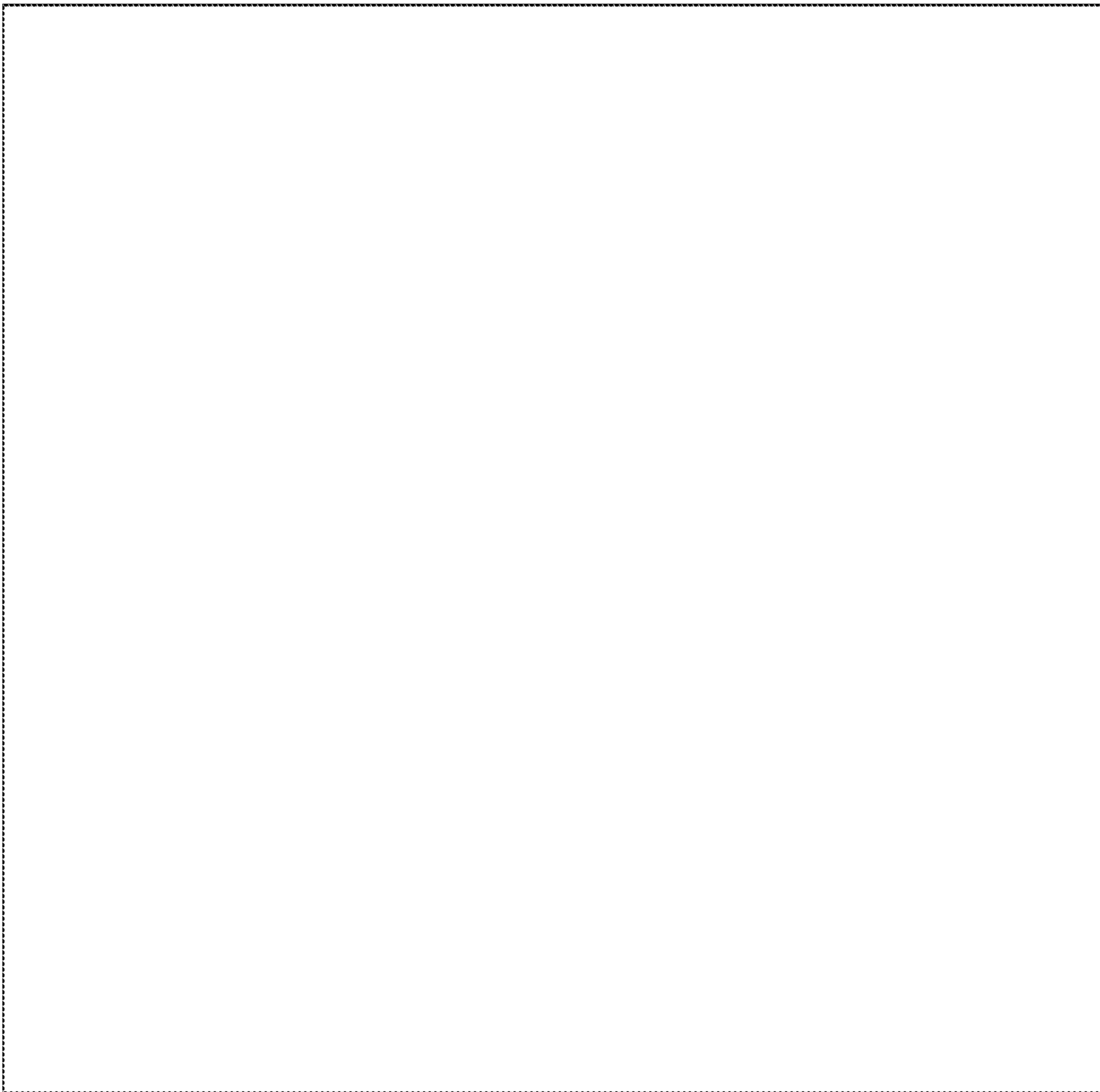
