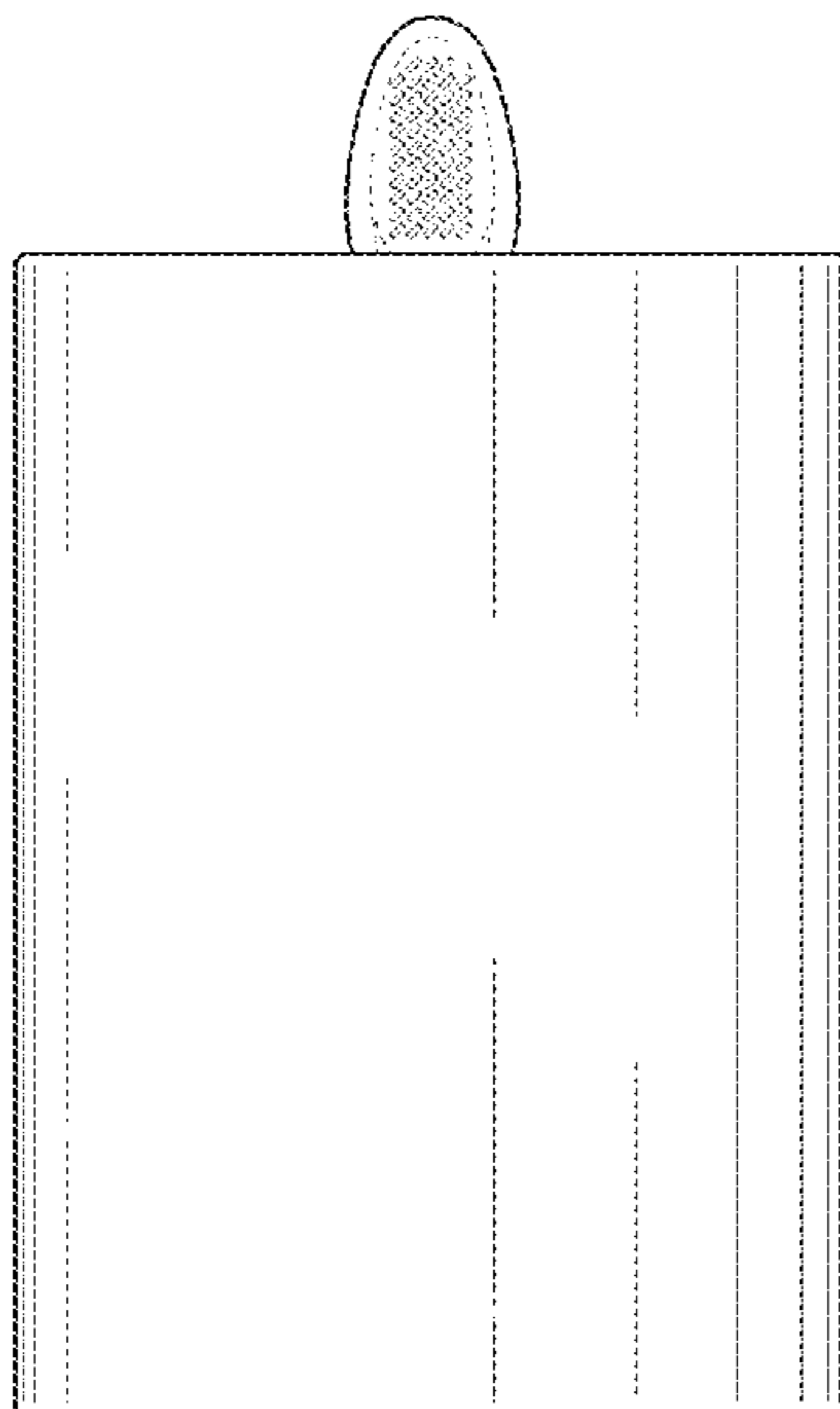
(57) **CLAIM**

The ornamental design for an electronic pillar candle with a matrix flame, as shown and described.

DESCRIPTION

FIG. 1 is a front view of the electronic pillar candle with a matrix flame;
FIG. 2 is rear view of the electronic pillar candle of FIG. 1;
FIG. 3 is a side view of the electronic pillar candle of FIG. 1;
FIG. 4 is a top view of the electronic pillar candle of FIG. 1;
FIG. 5 is a bottom view of the electronic pillar candle of FIG. 1;
FIG. 6 is a perspective view of the top of the electronic pillar candle of FIG. 1; and,
FIG. 7 is a perspective view of the bottom of the electronic pillar candle of FIG. 1.
The broken-line disclosure represents portions of the electronic candle which form no part of the claimed design.

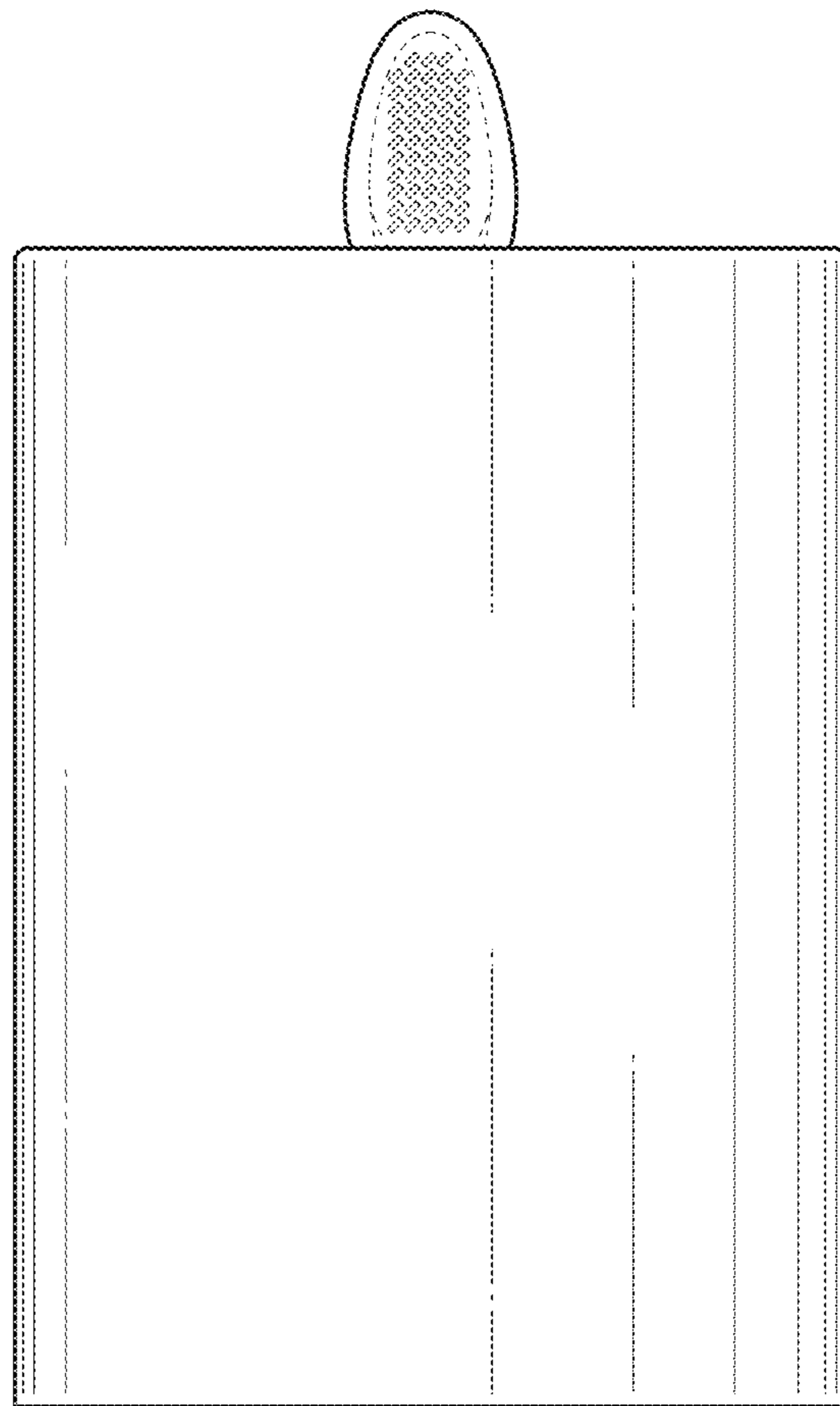

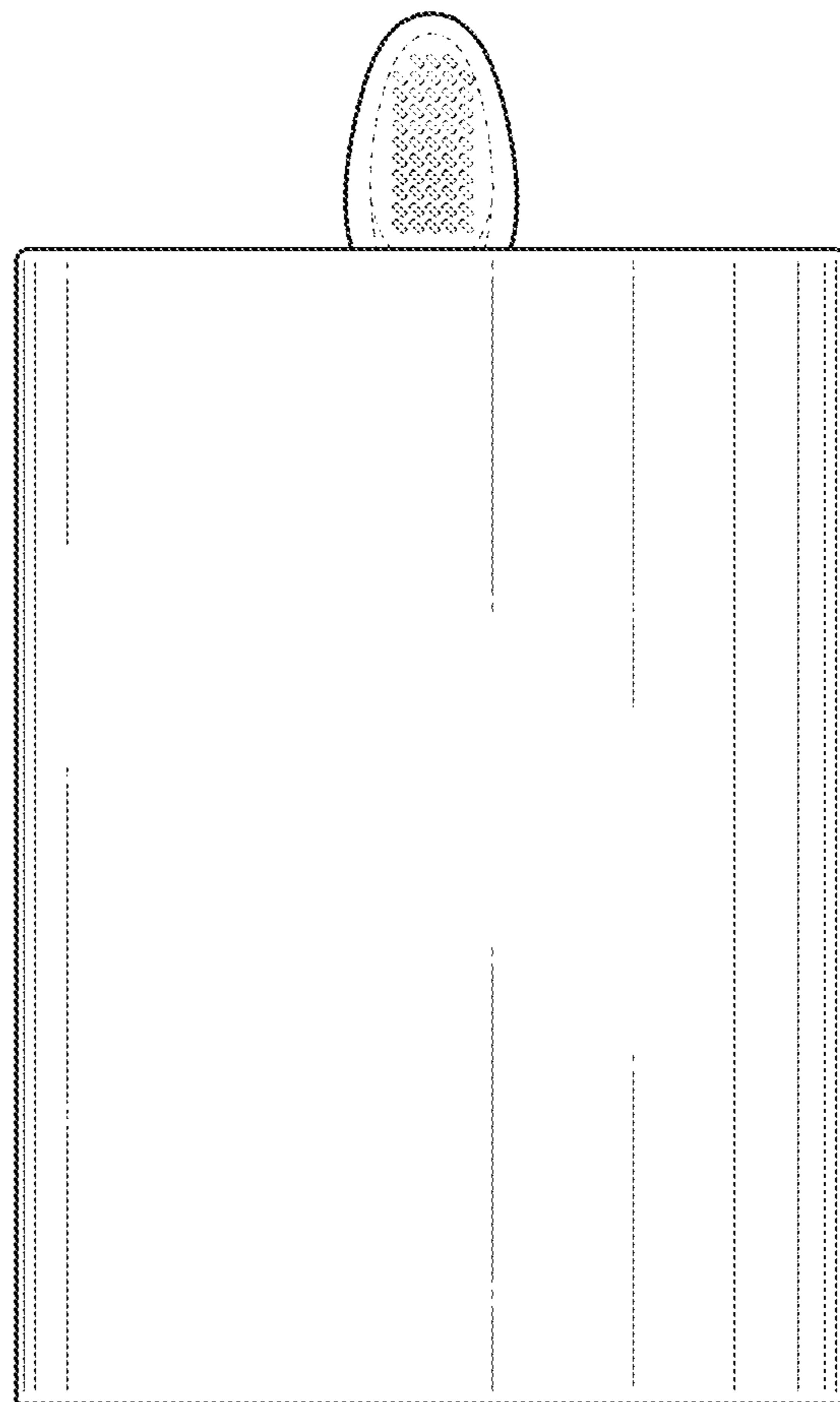

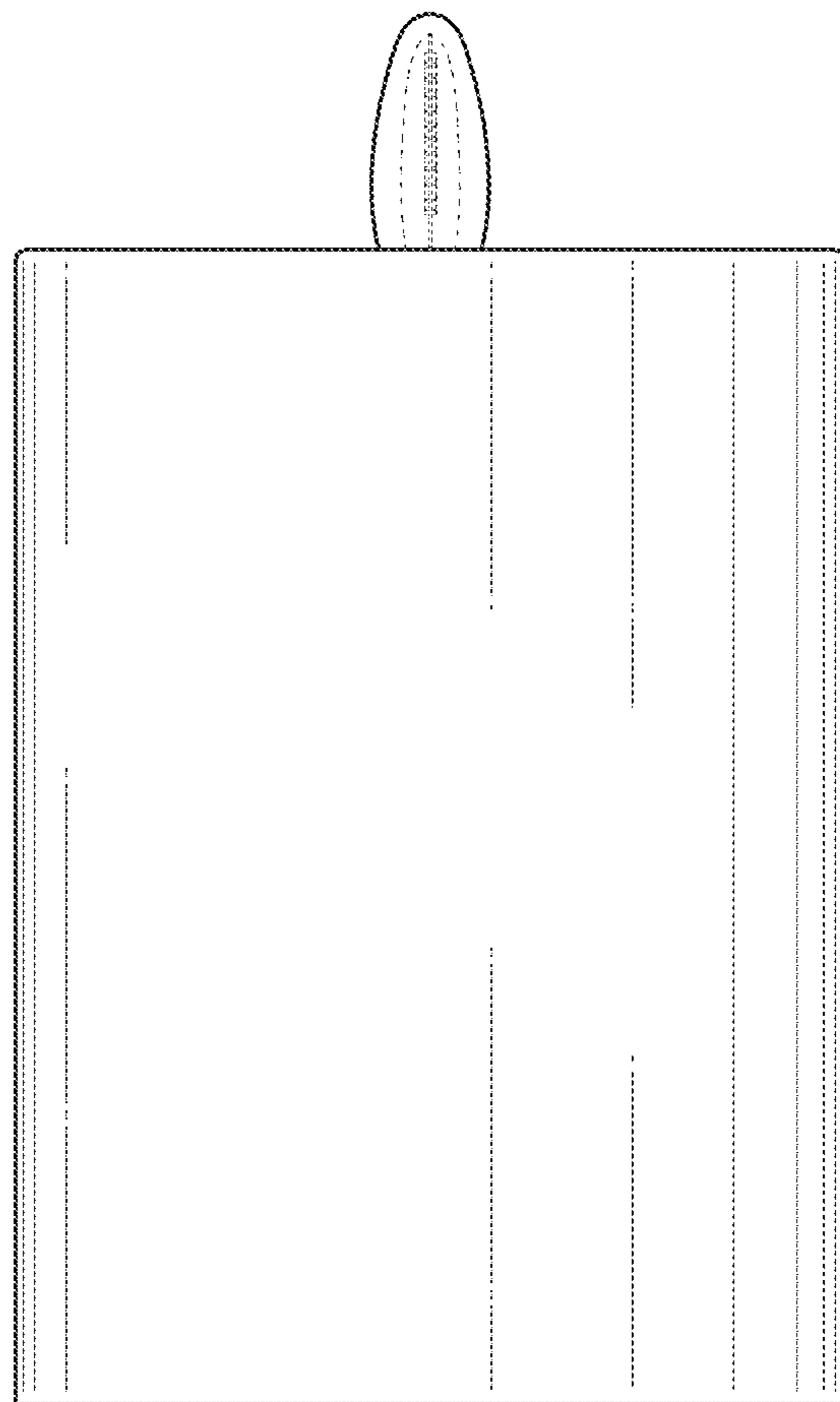

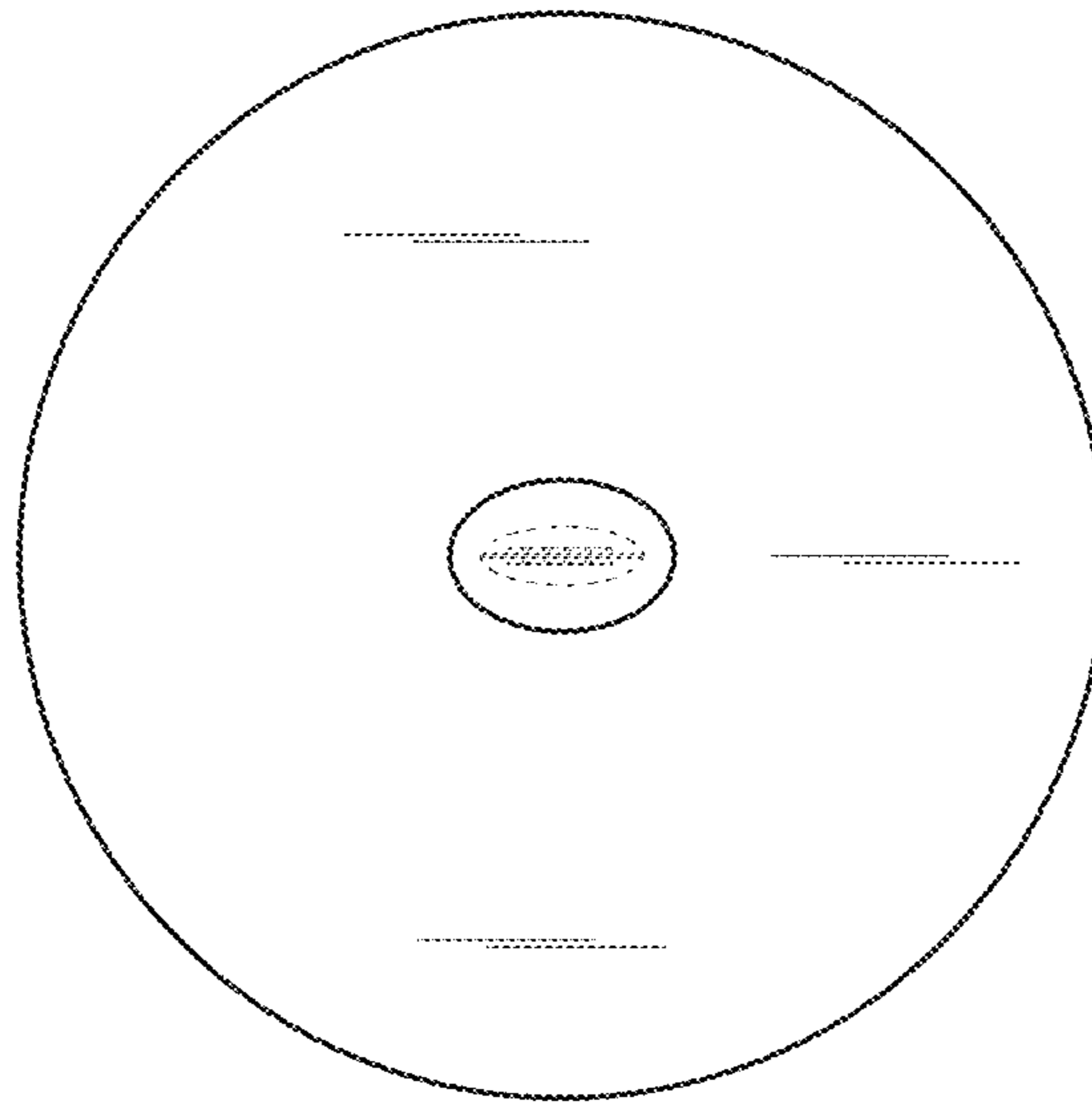

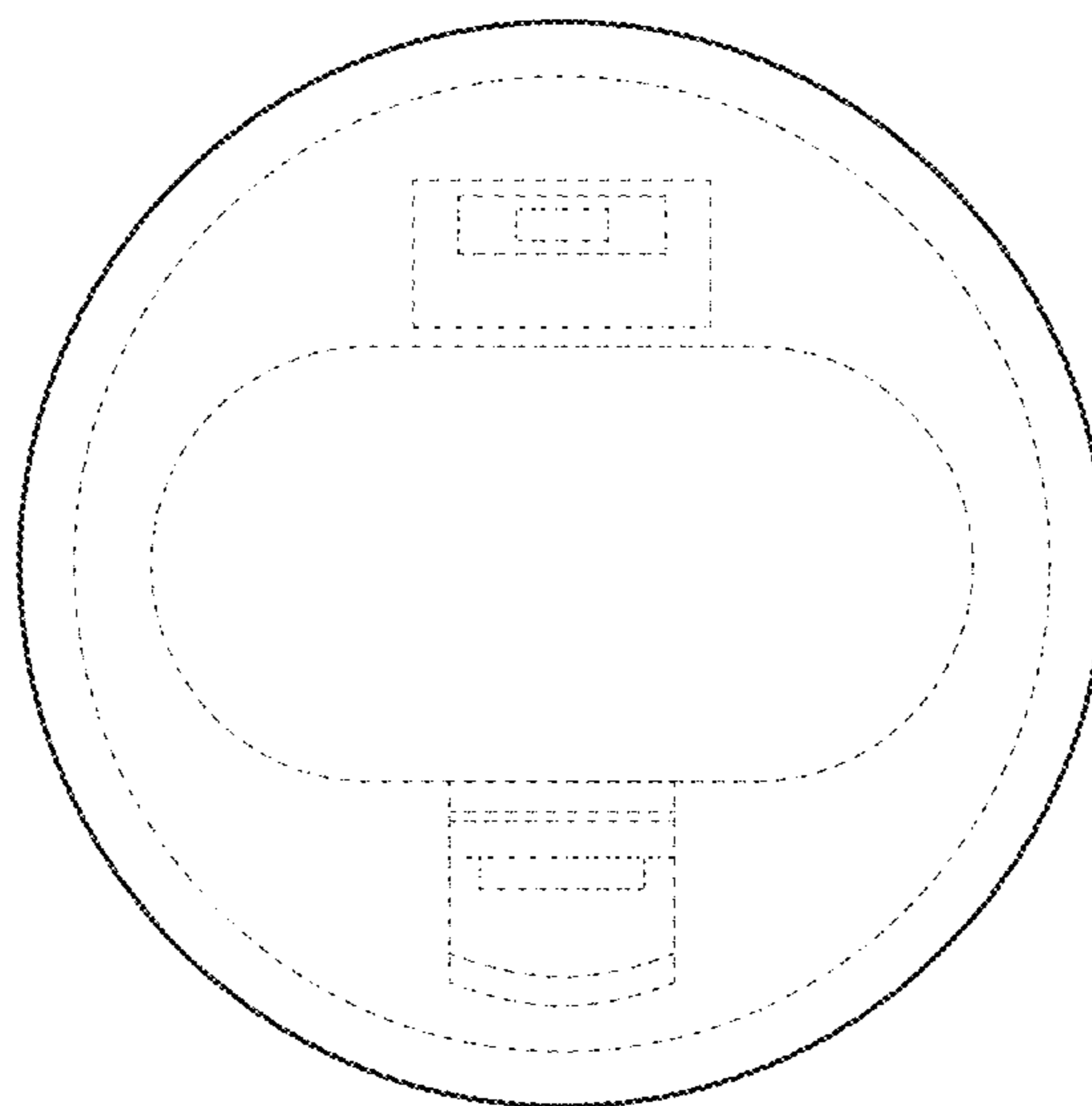

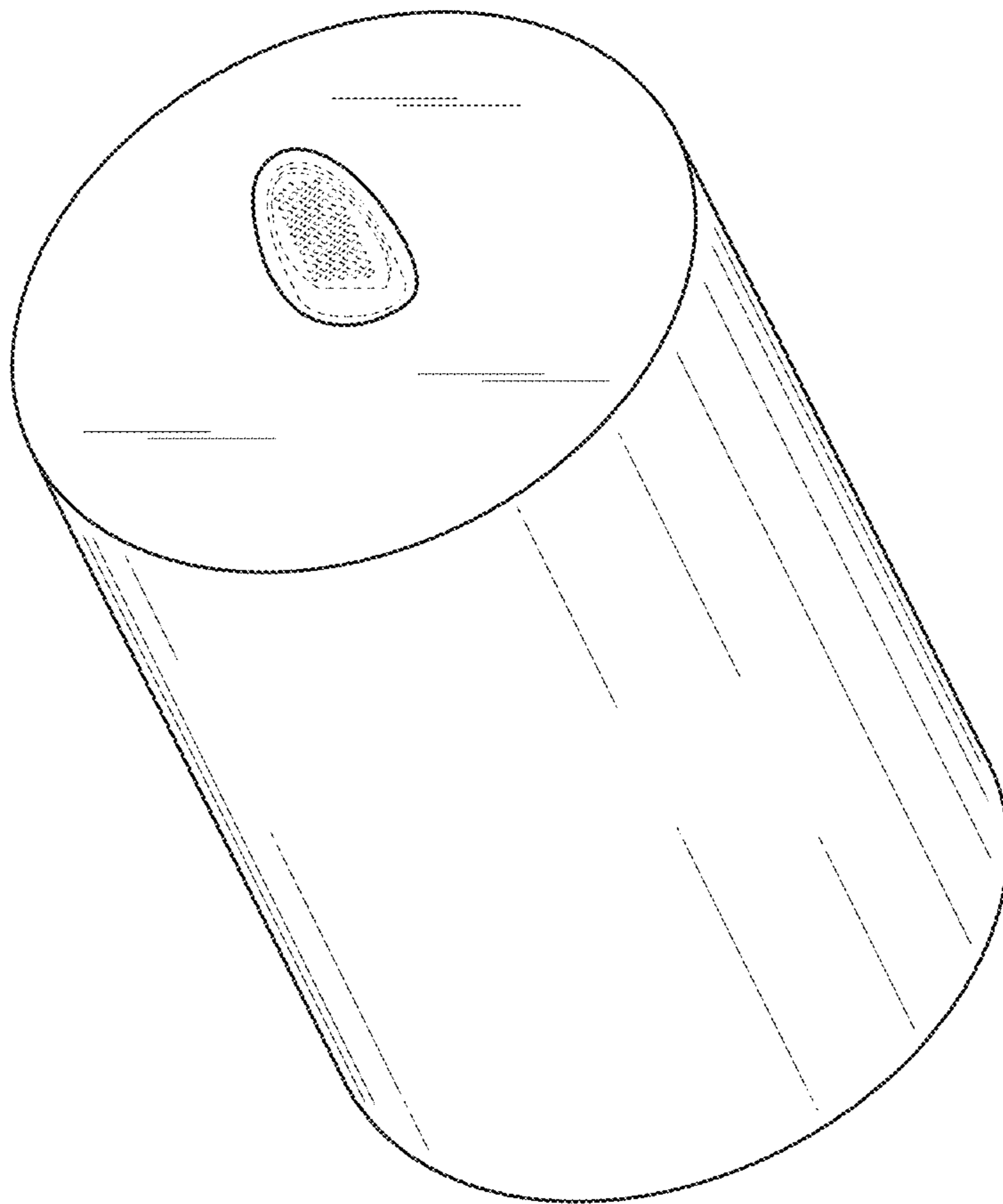

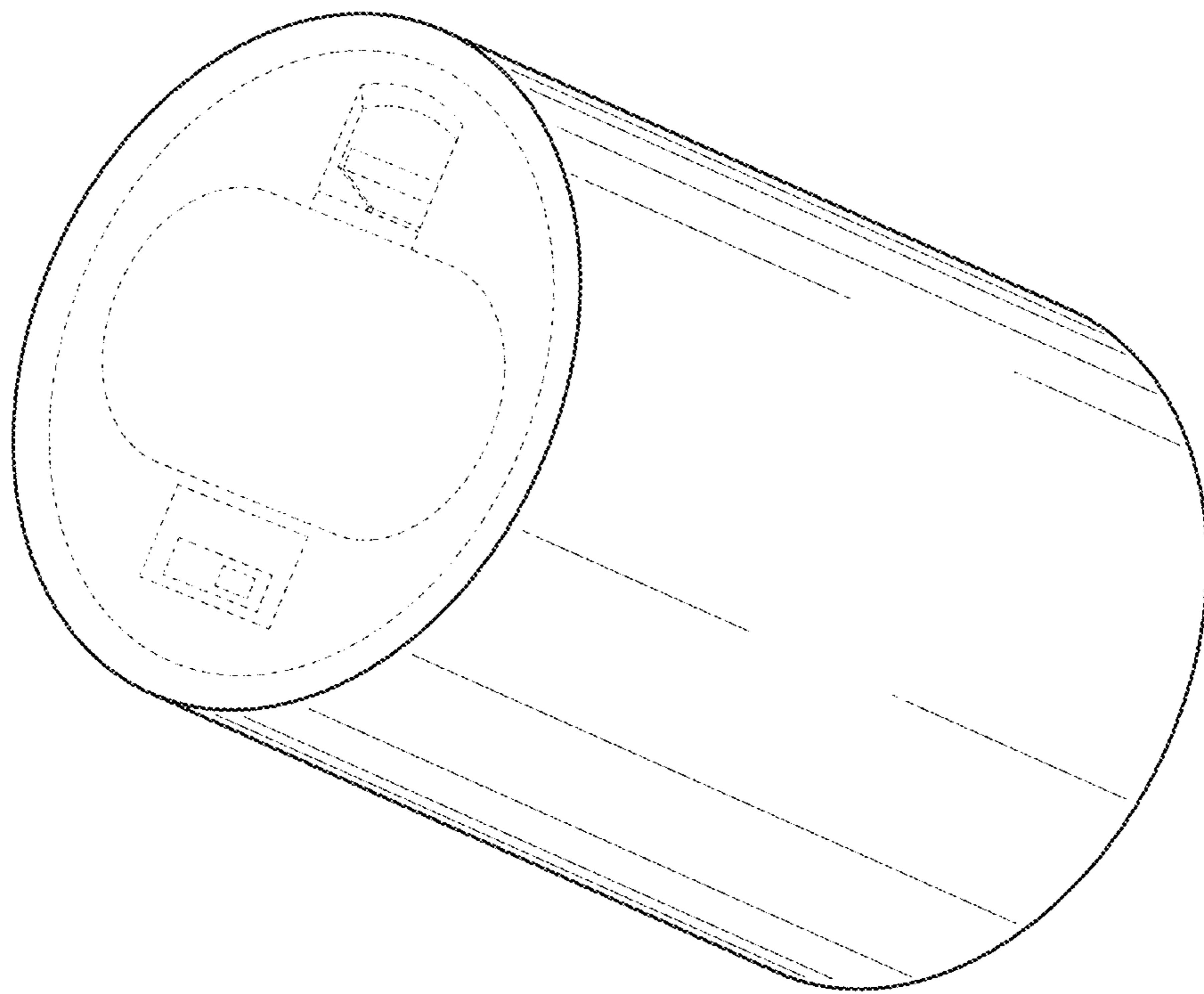
