The ornamental design for a rear combination lamp for an automobile, as shown and described.

DESCRIPTION

FIG. 1: a front view of a rear combination lamp for an automobile;
FIG. 2: a plan view of the rear combination lamp for an automobile;
FIG. 3: a left side view of the rear combination lamp for an automobile; and,
FIG. 4: a front perspective view of the rear combination lamp for an automobile as seen from the left side.

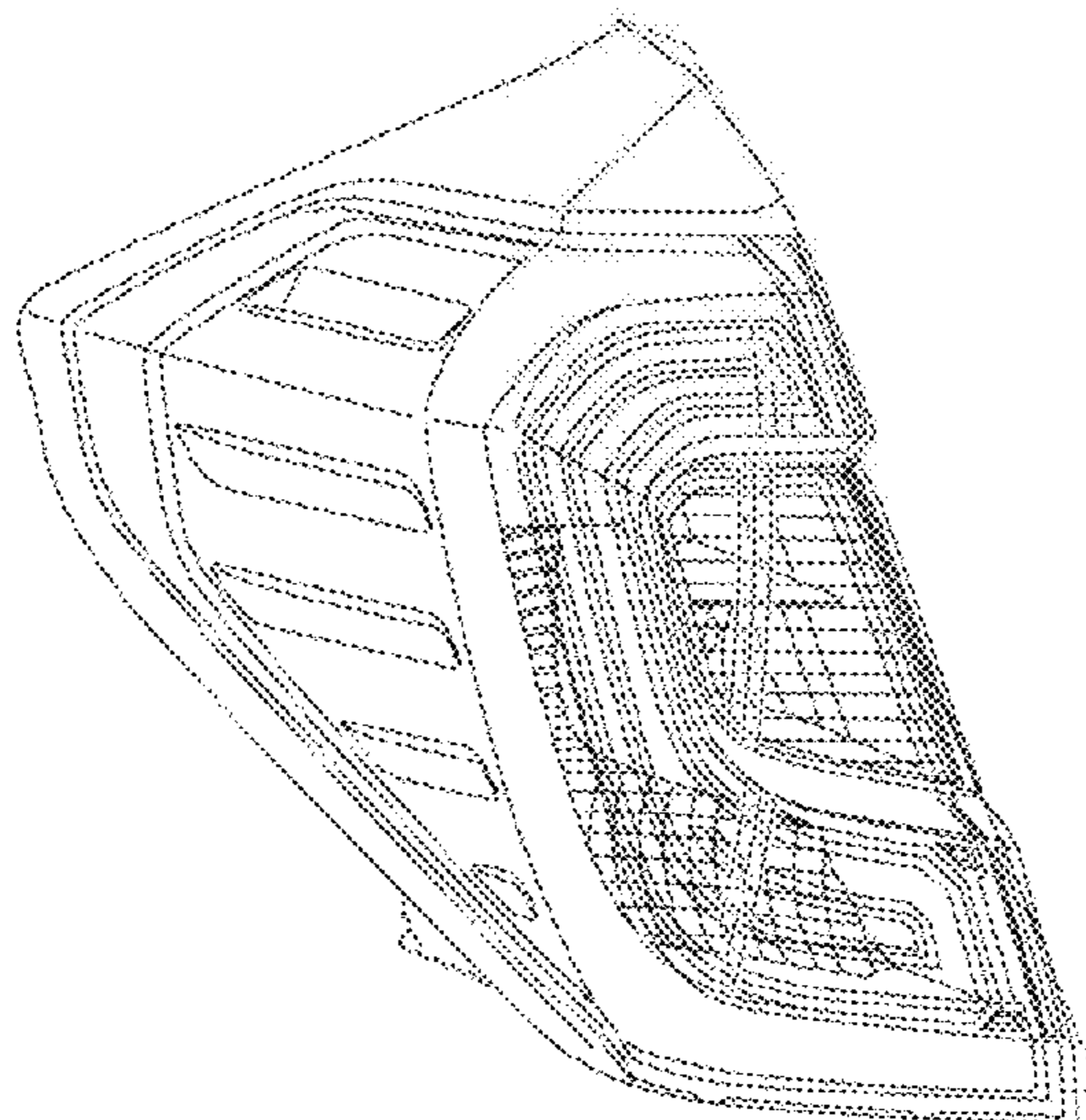

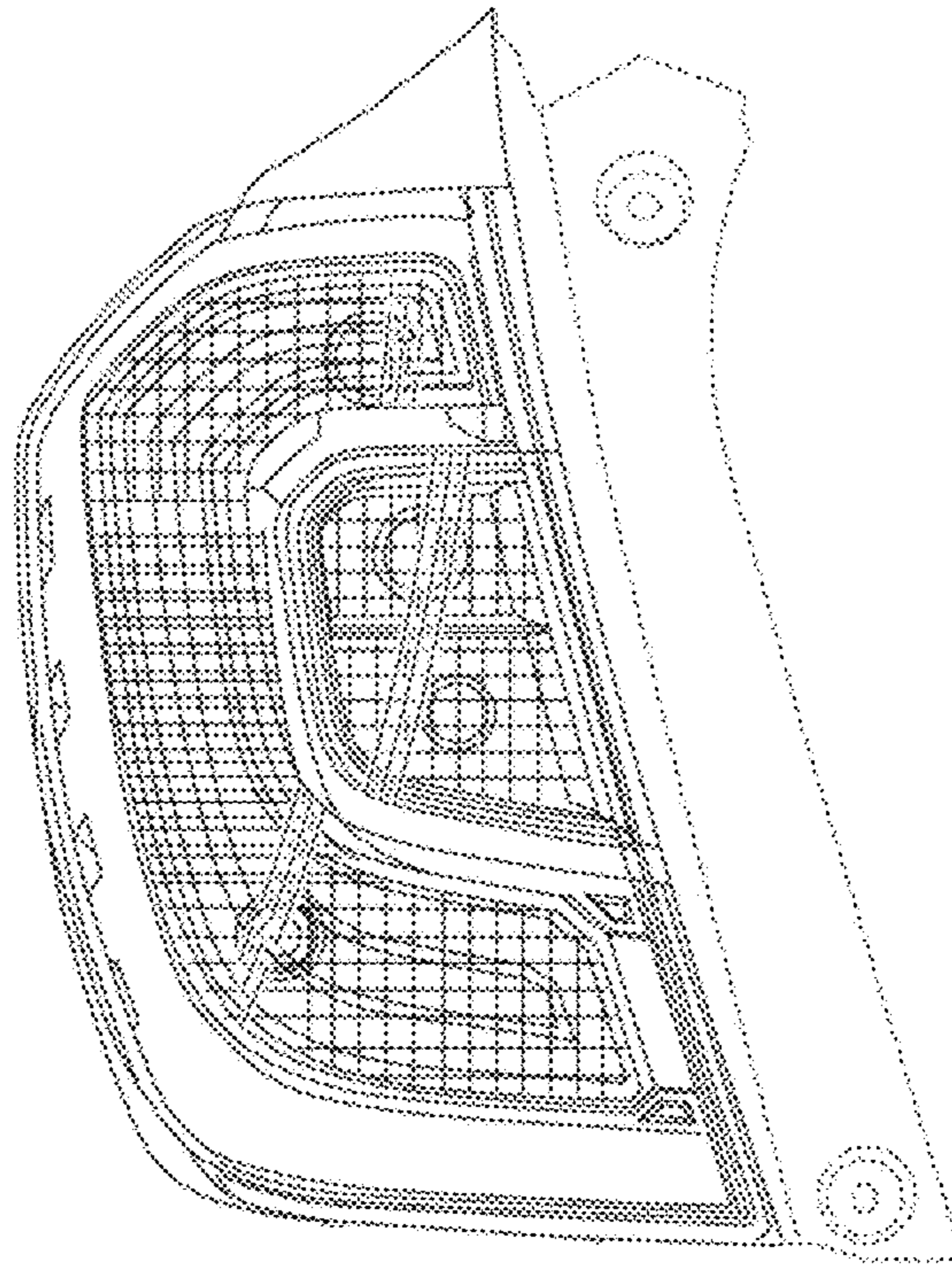

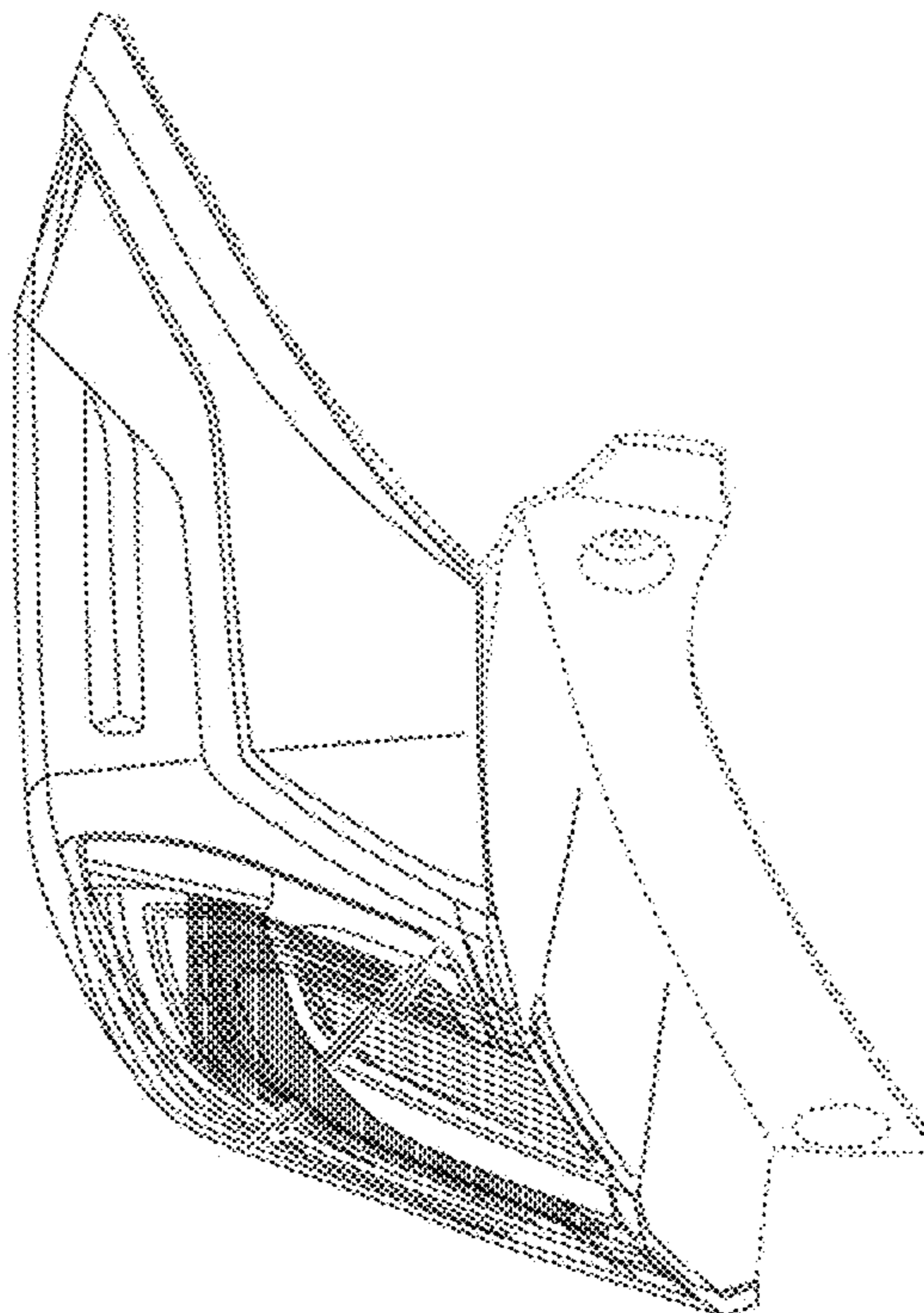

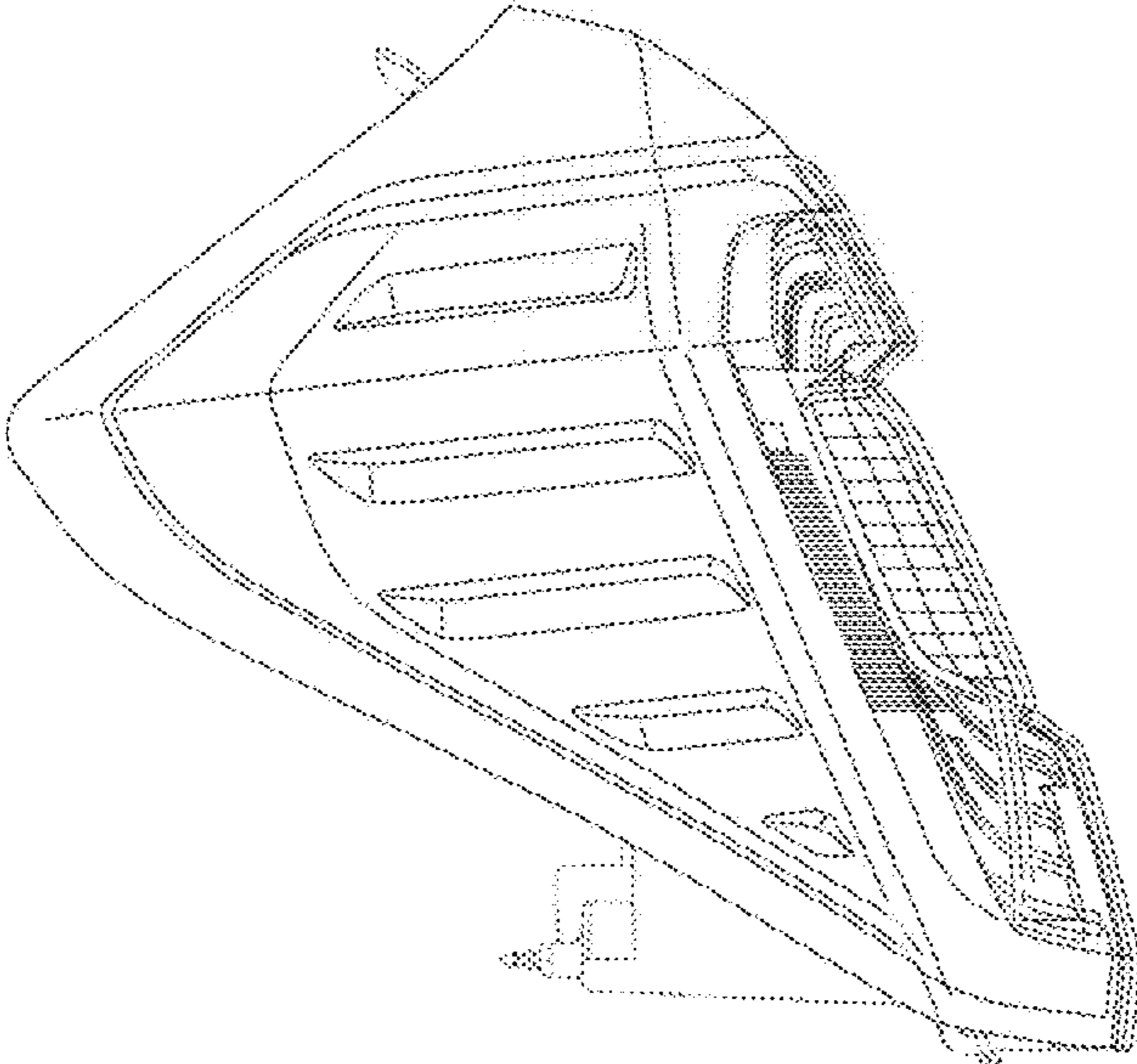
