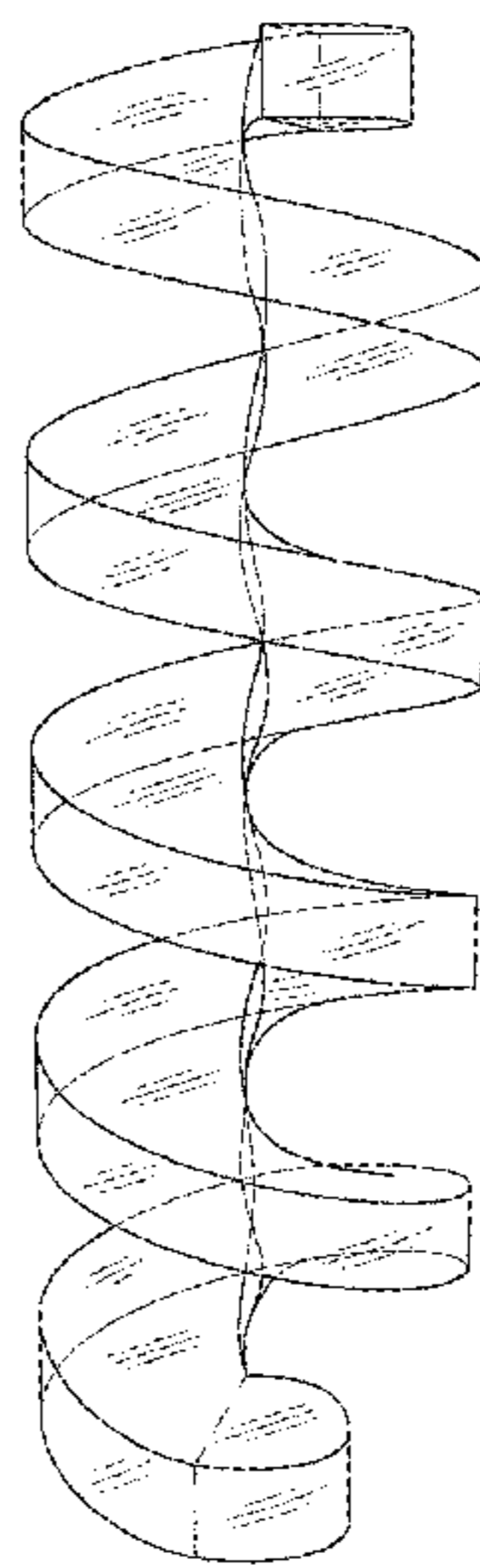
(57) **CLAIM**

The ornamental design for a spiral shaped tip for use in rolled smoking articles, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a spiral shaped tip for use in rolled smoking articles;

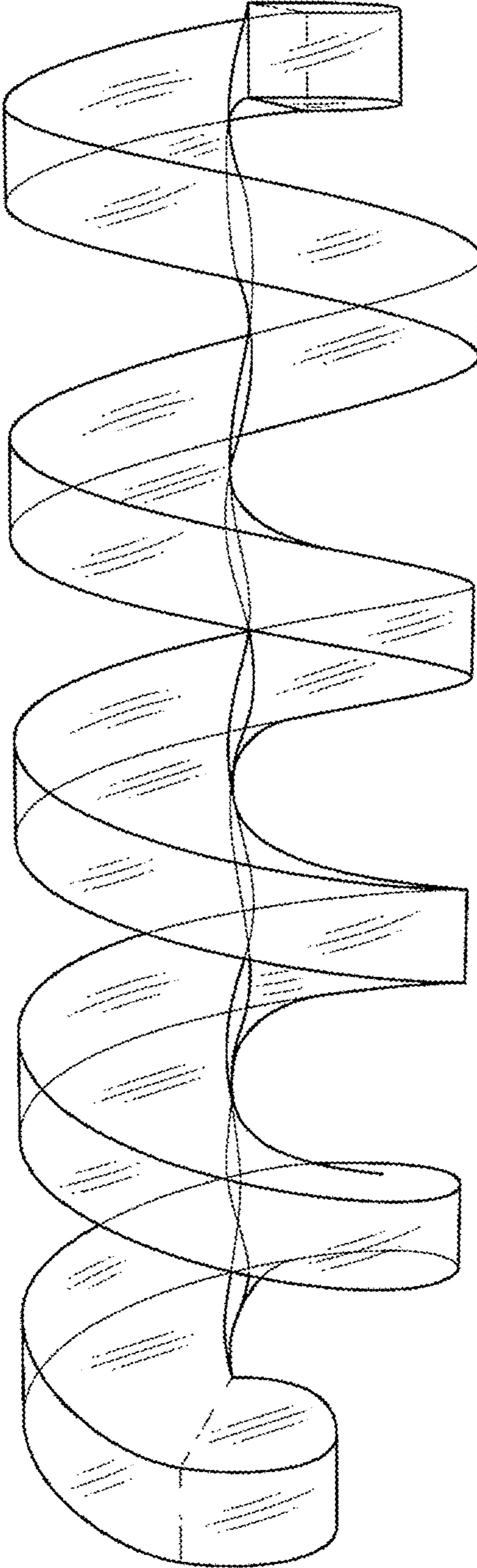

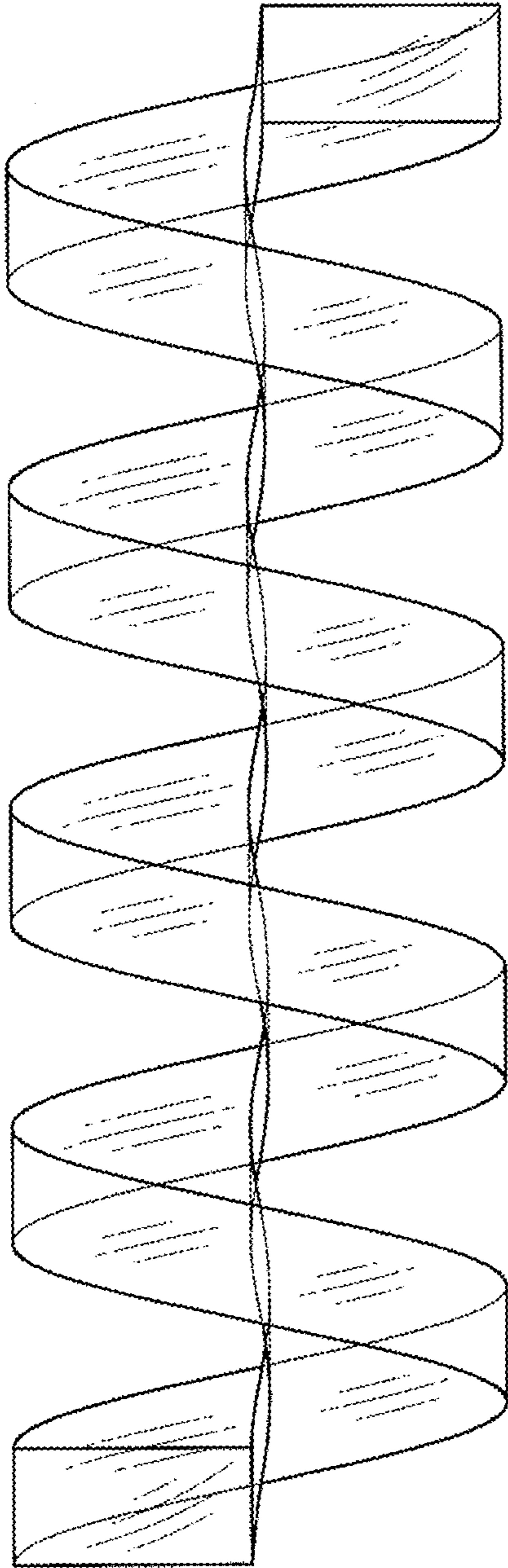

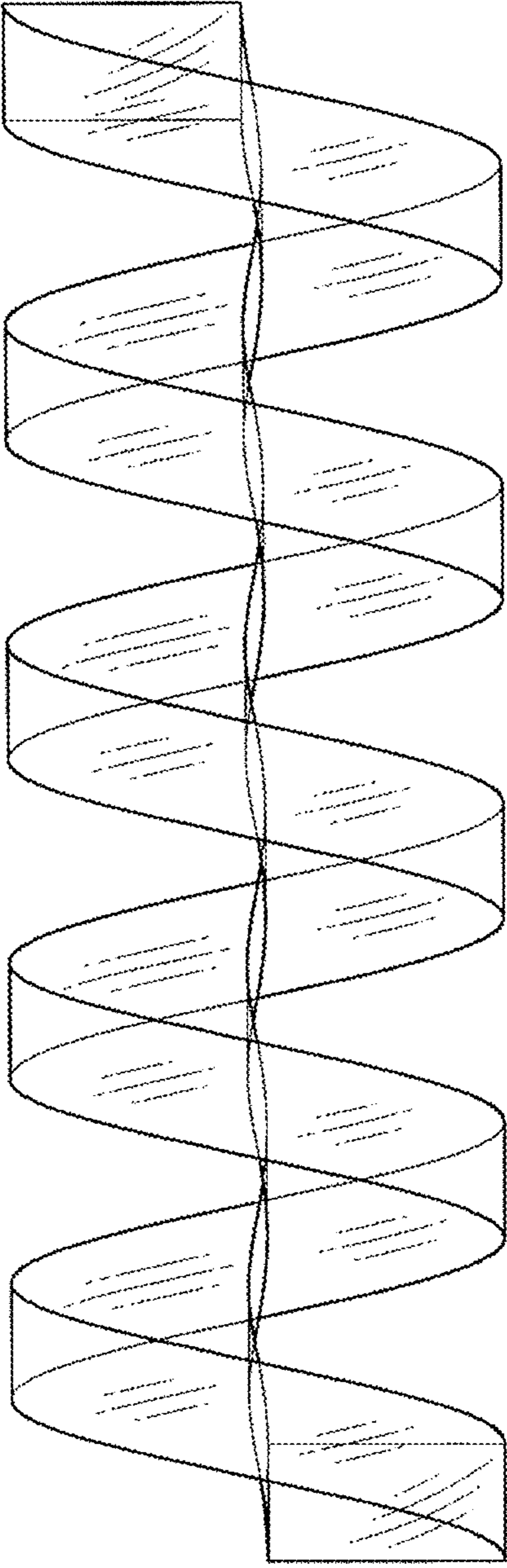

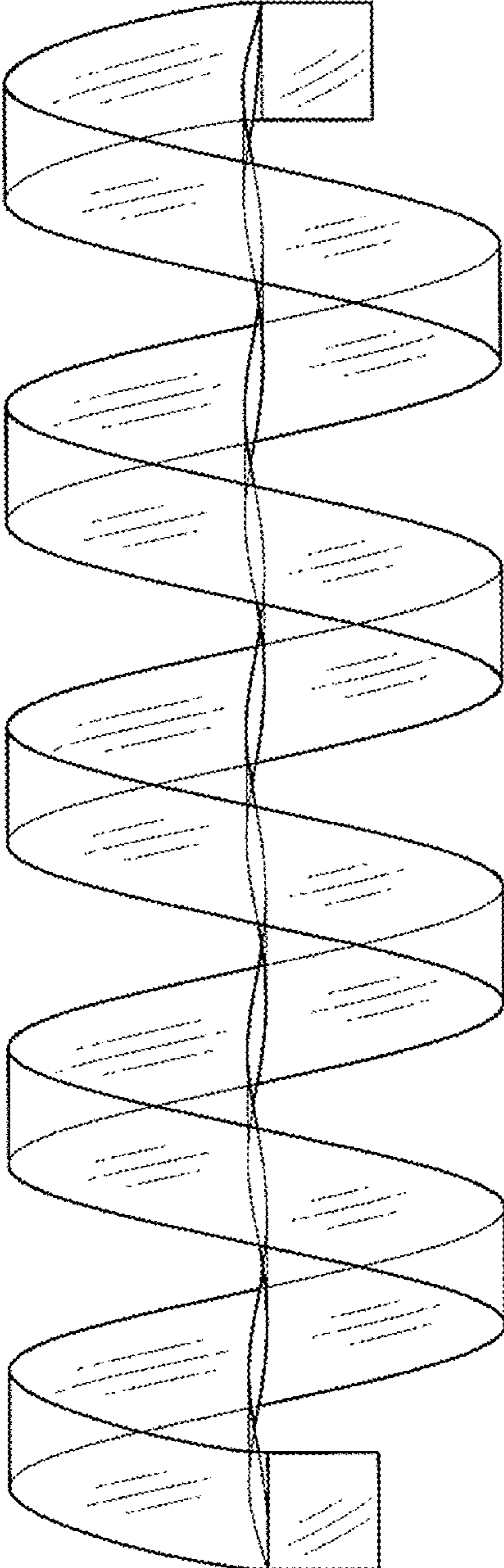

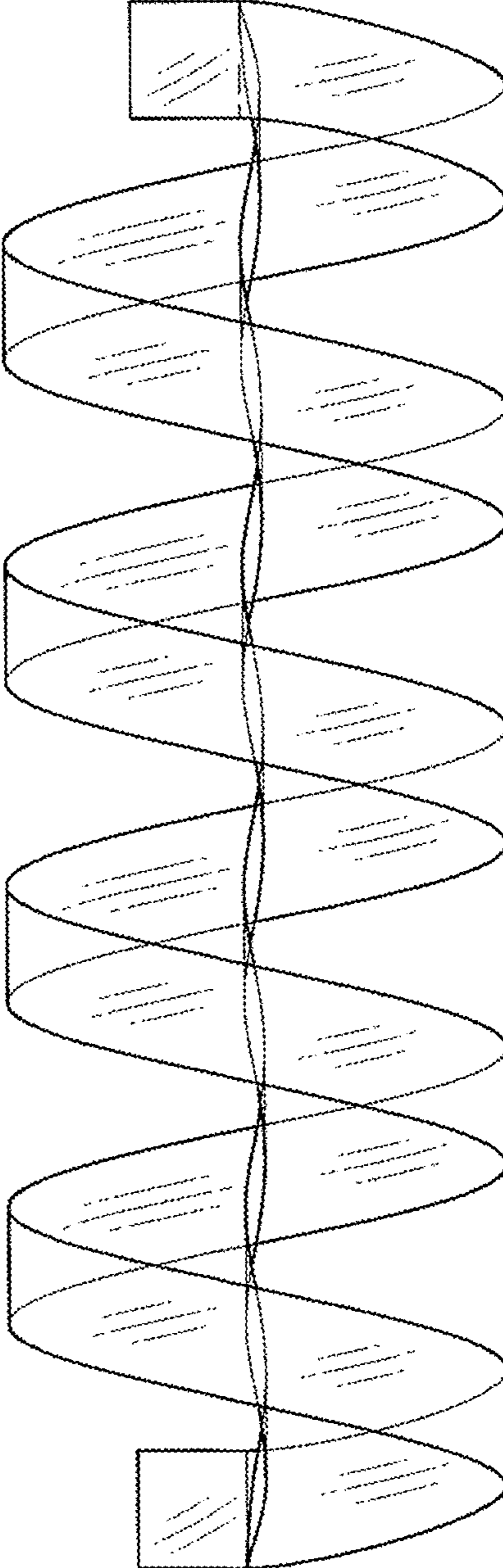

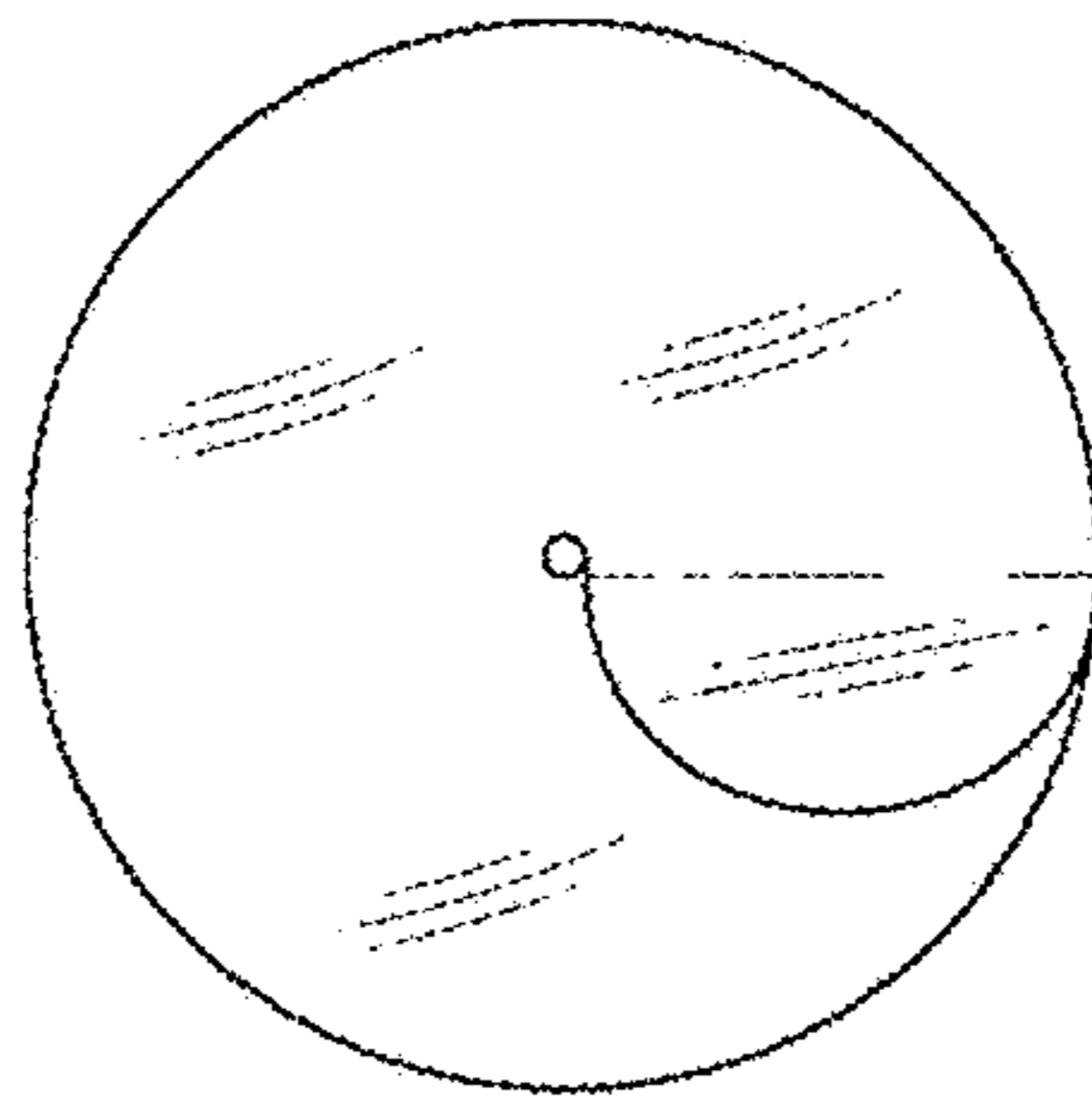

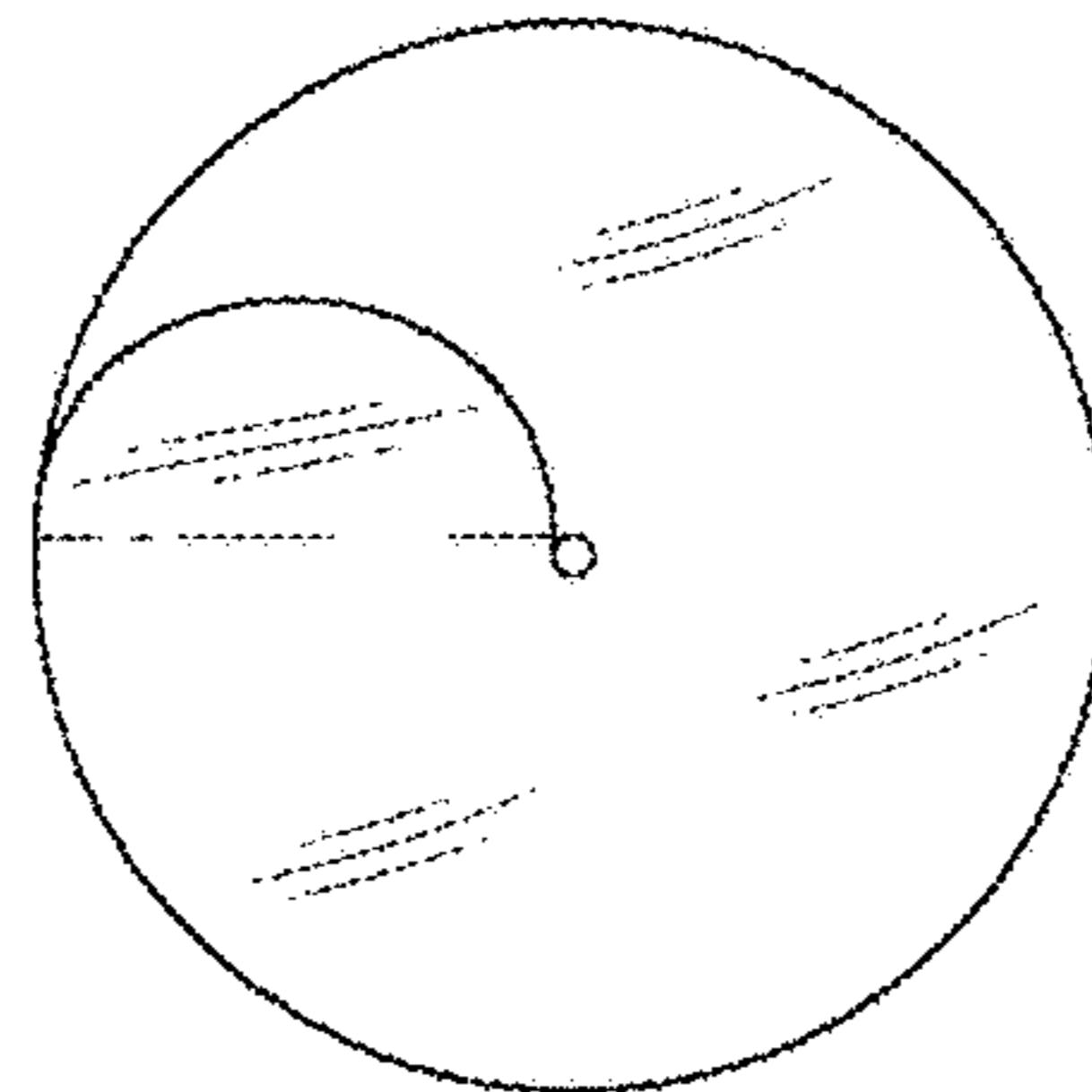
