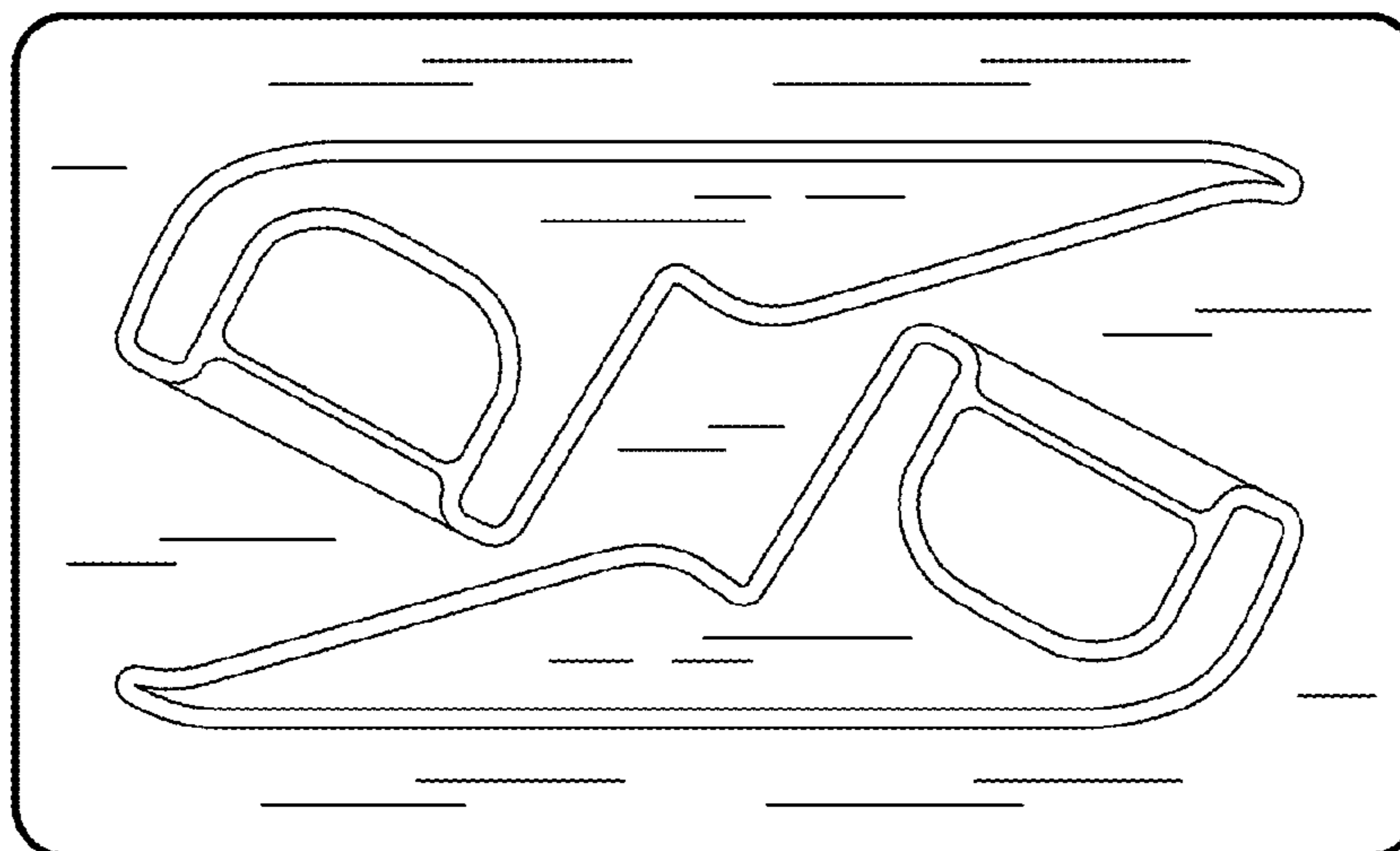
(57) **CLAIM**

The ornamental design for a card holder for teeth cleaning devices, as shown and described.

**DESCRIPTION**

FIG. 1 is a front view of a card holder for teeth cleaning devices showing the new design;  
FIG. 2 is a rear view thereof;  
FIG. 3 is a top view thereof, the bottom view being a mirror image;  
FIG. 4 is a side view thereof; the opposite side view being a mirror image; and,  
FIG. 5 is a front view thereof with an outer layer removed. The broken lines indicate unclaimed portions of the article and form no part of the claimed design.

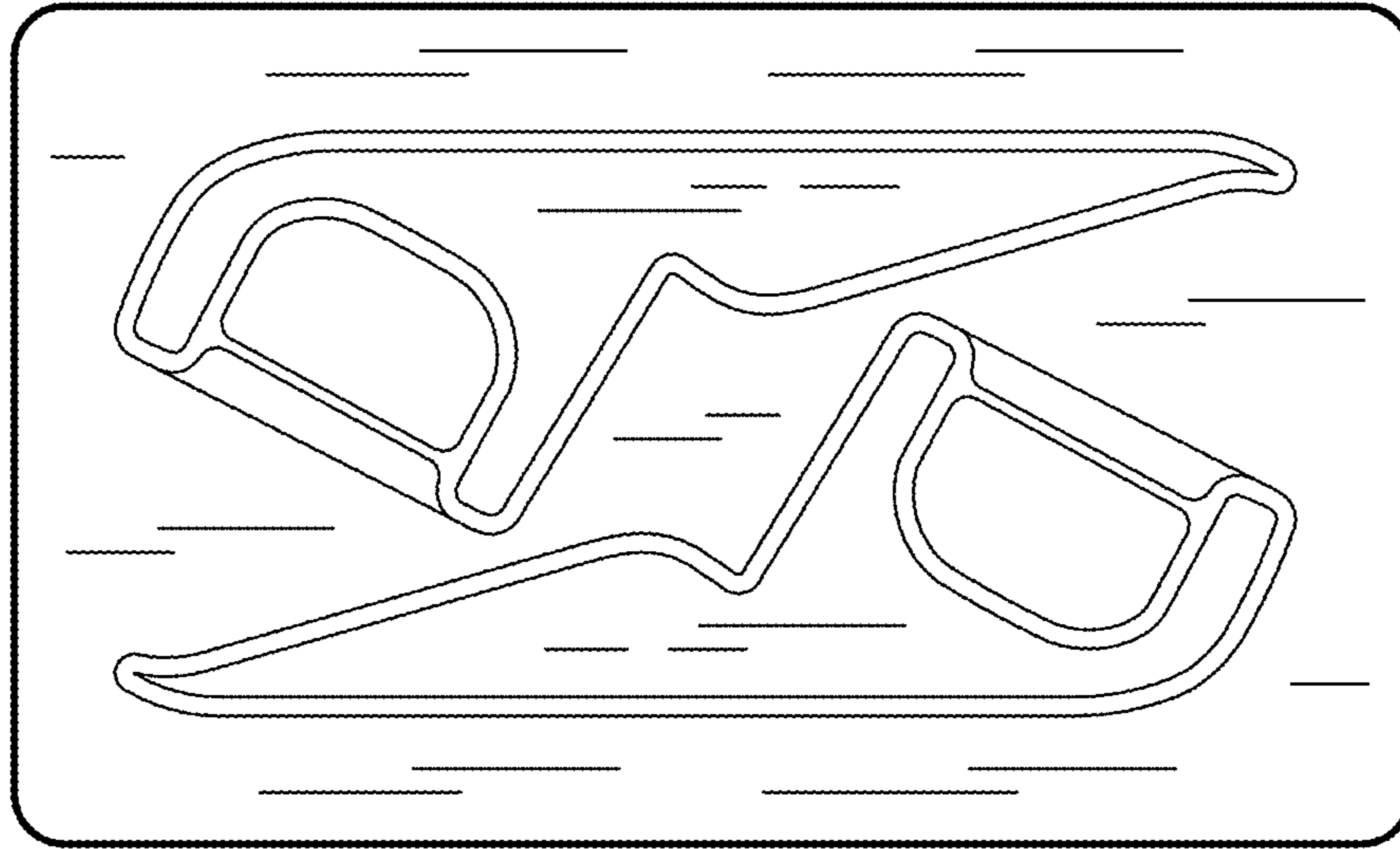

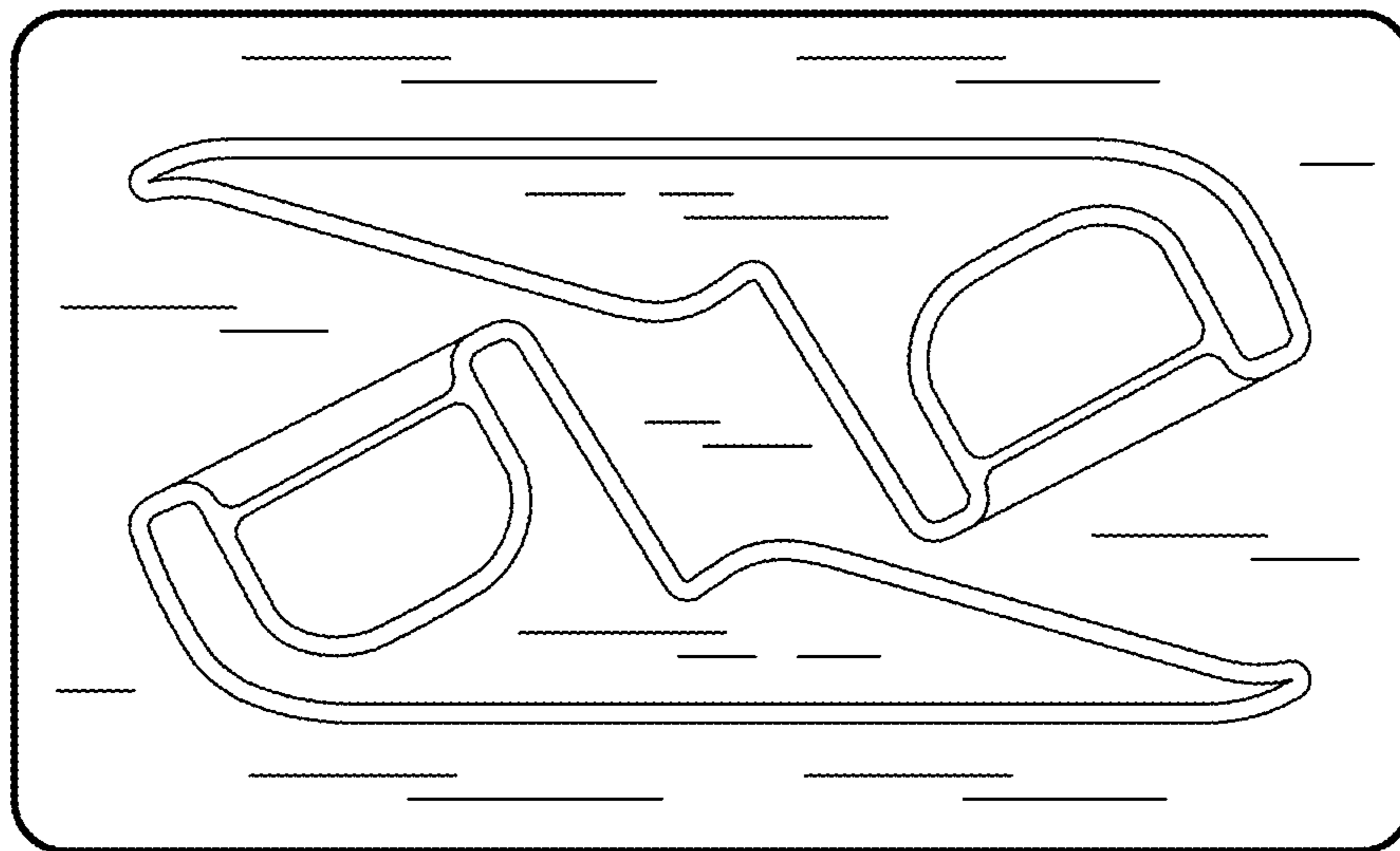

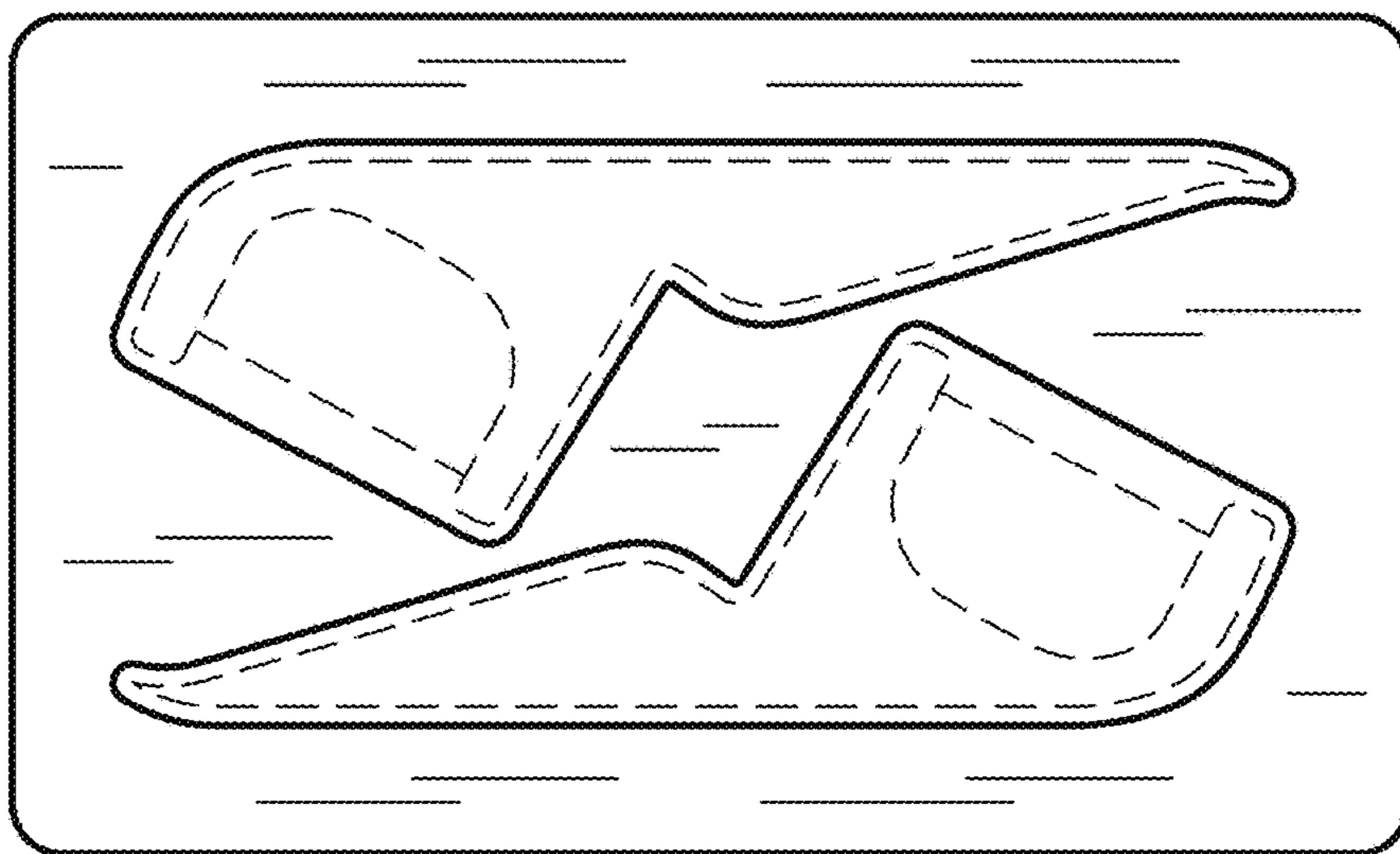
