(57) **CLAIM**

The ornamental design for an insertable small item basket for a shopping cart, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the insertable small item basket for a shopping cart showing my new design; FIG. 2 is another perspective view thereof; FIG. 3 is a front elevation view thereof; FIG. 4 is a rear elevation view thereof; FIG. 5 is a right elevation view thereof; FIG. 6 is a left elevation view thereof; FIG. 7 is a top plan view thereof; and, FIG. 8 is a bottom plan view thereof. Broken lines are included for depicting environmental subject matter and form no part of the claimed design.

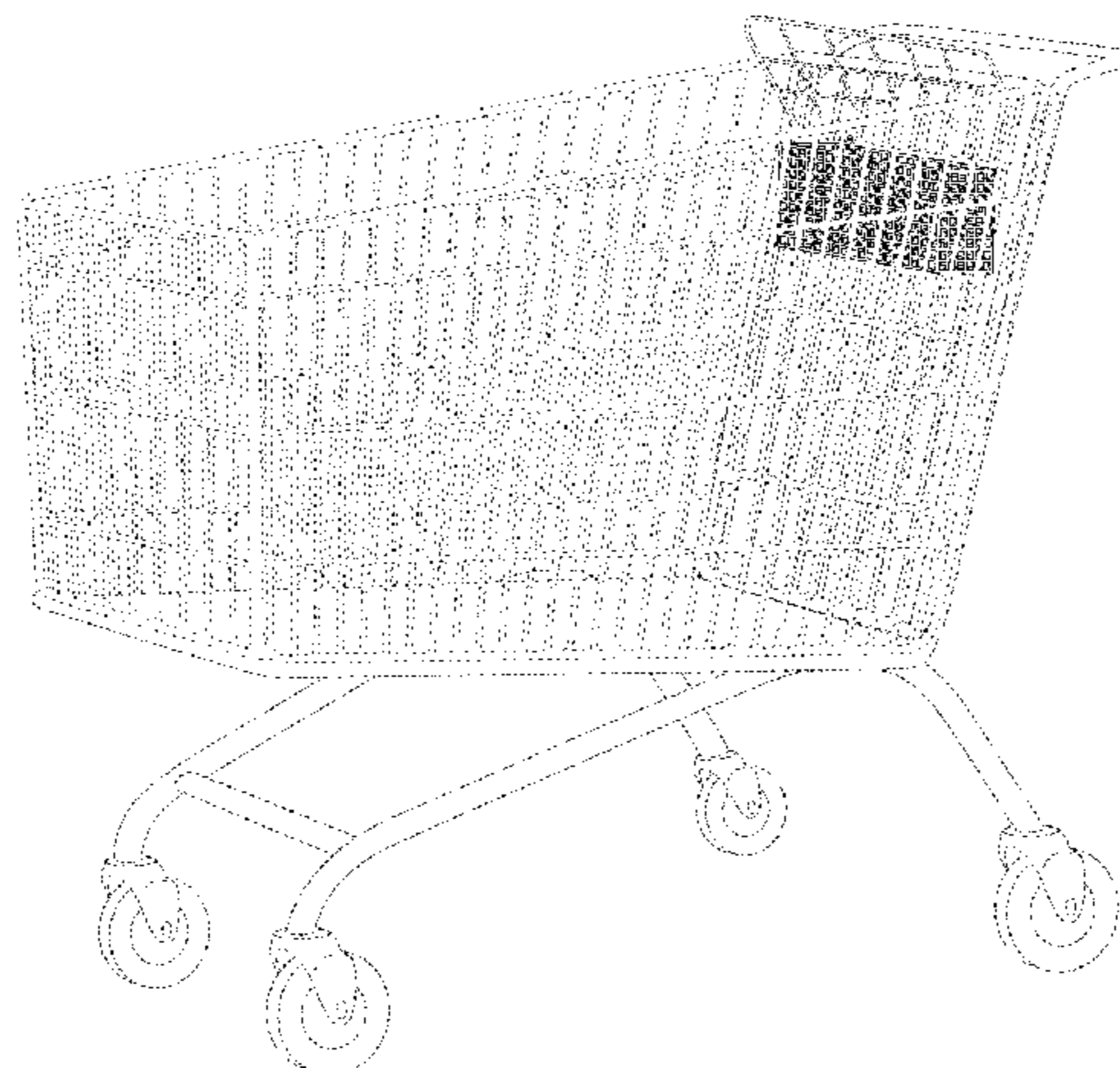

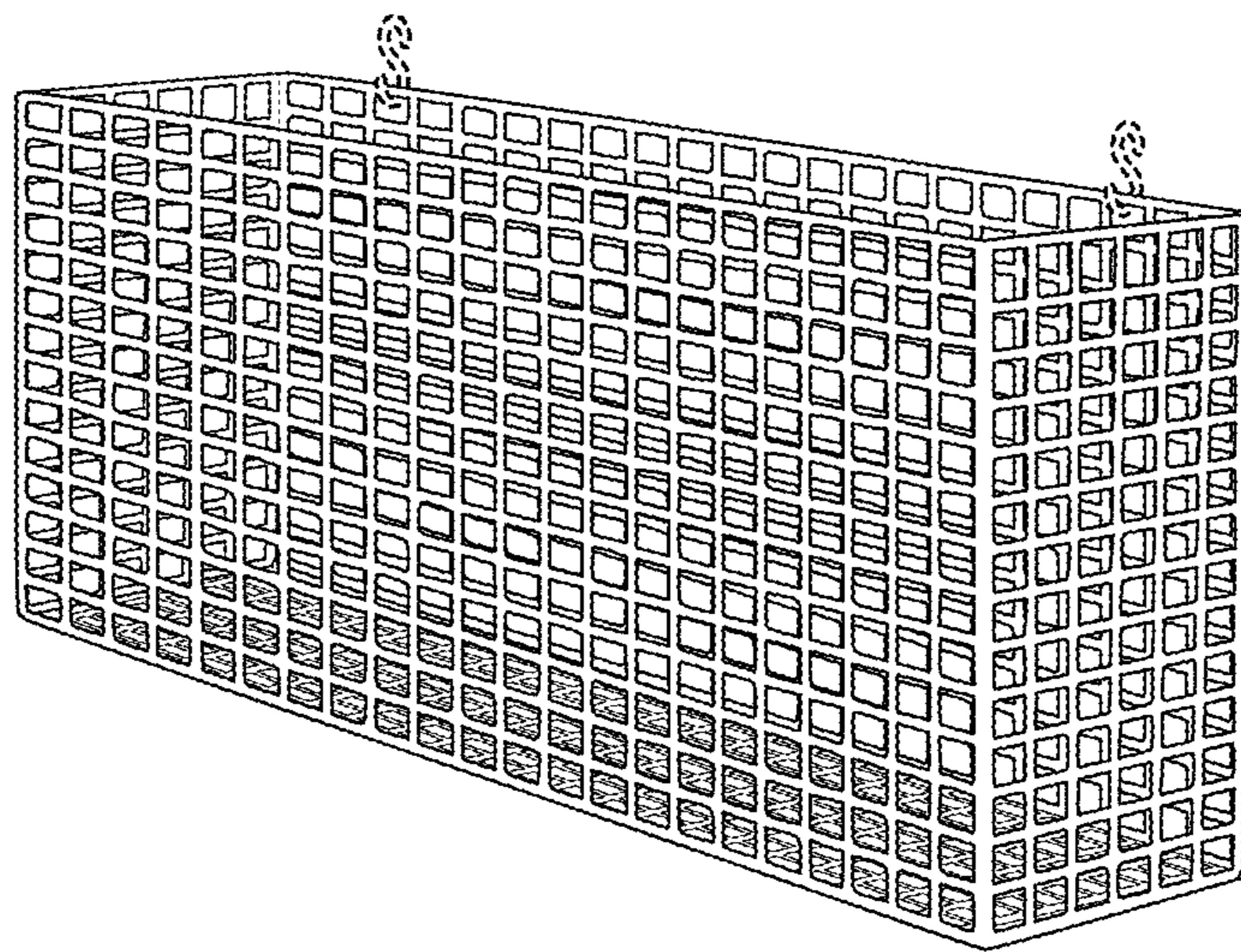

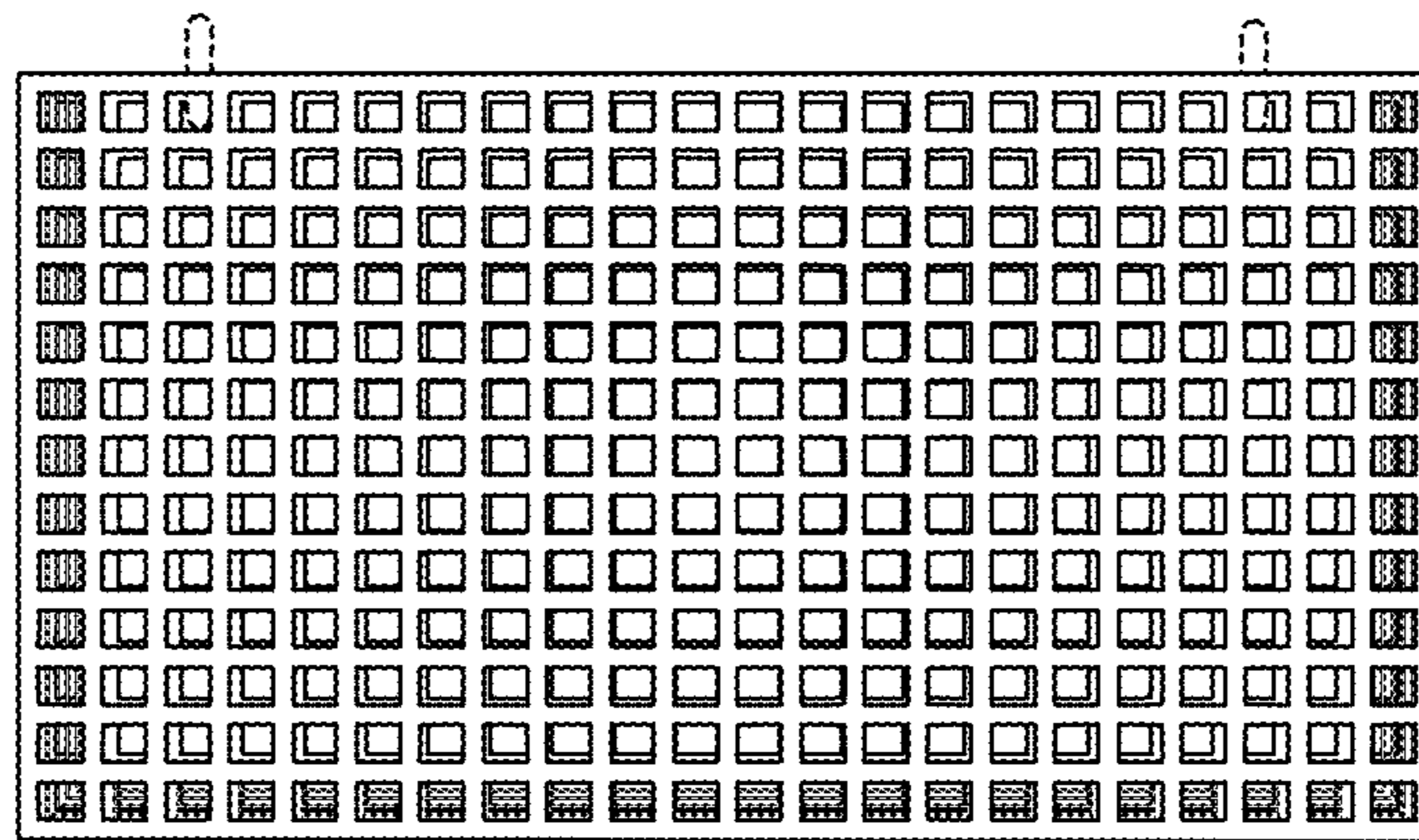

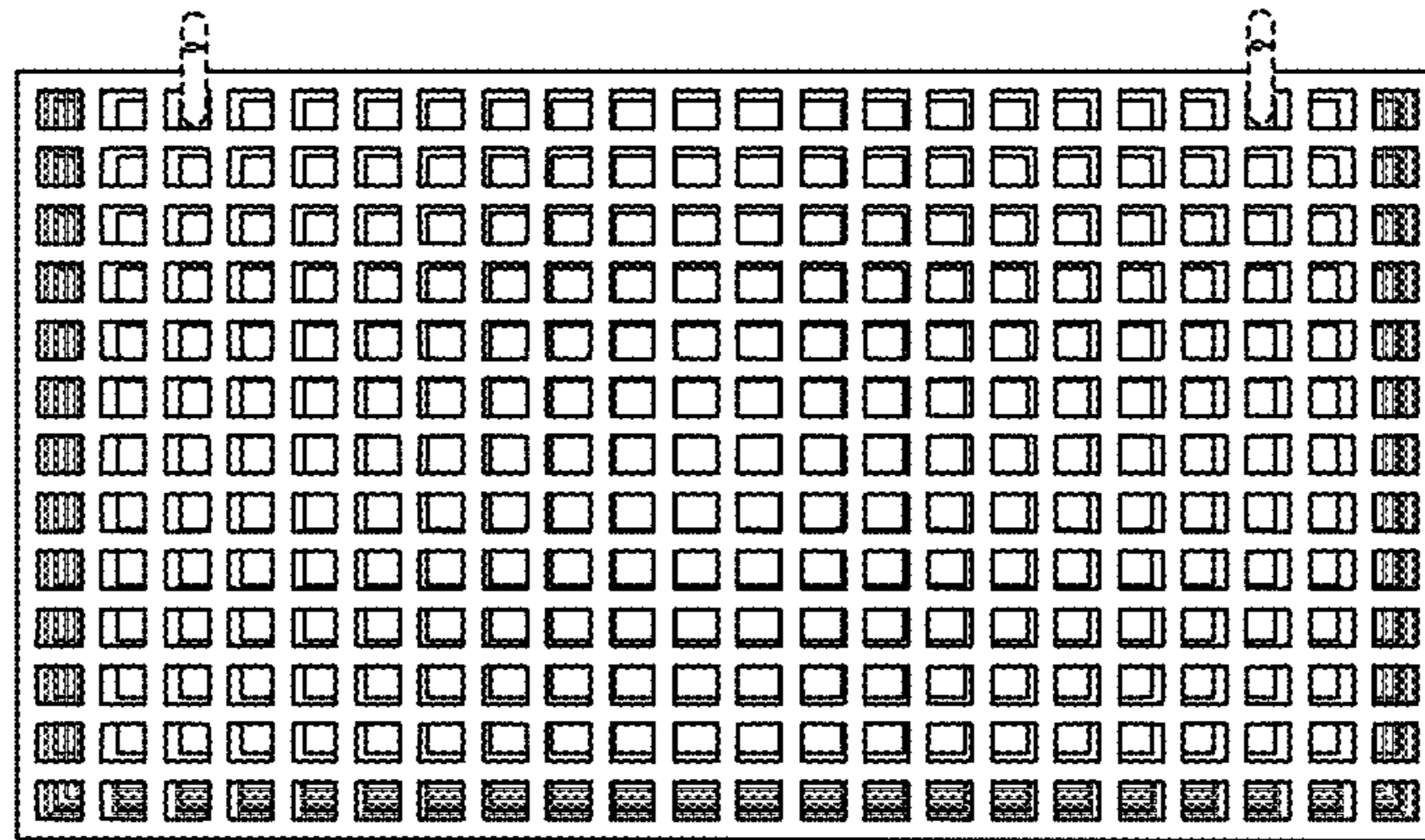

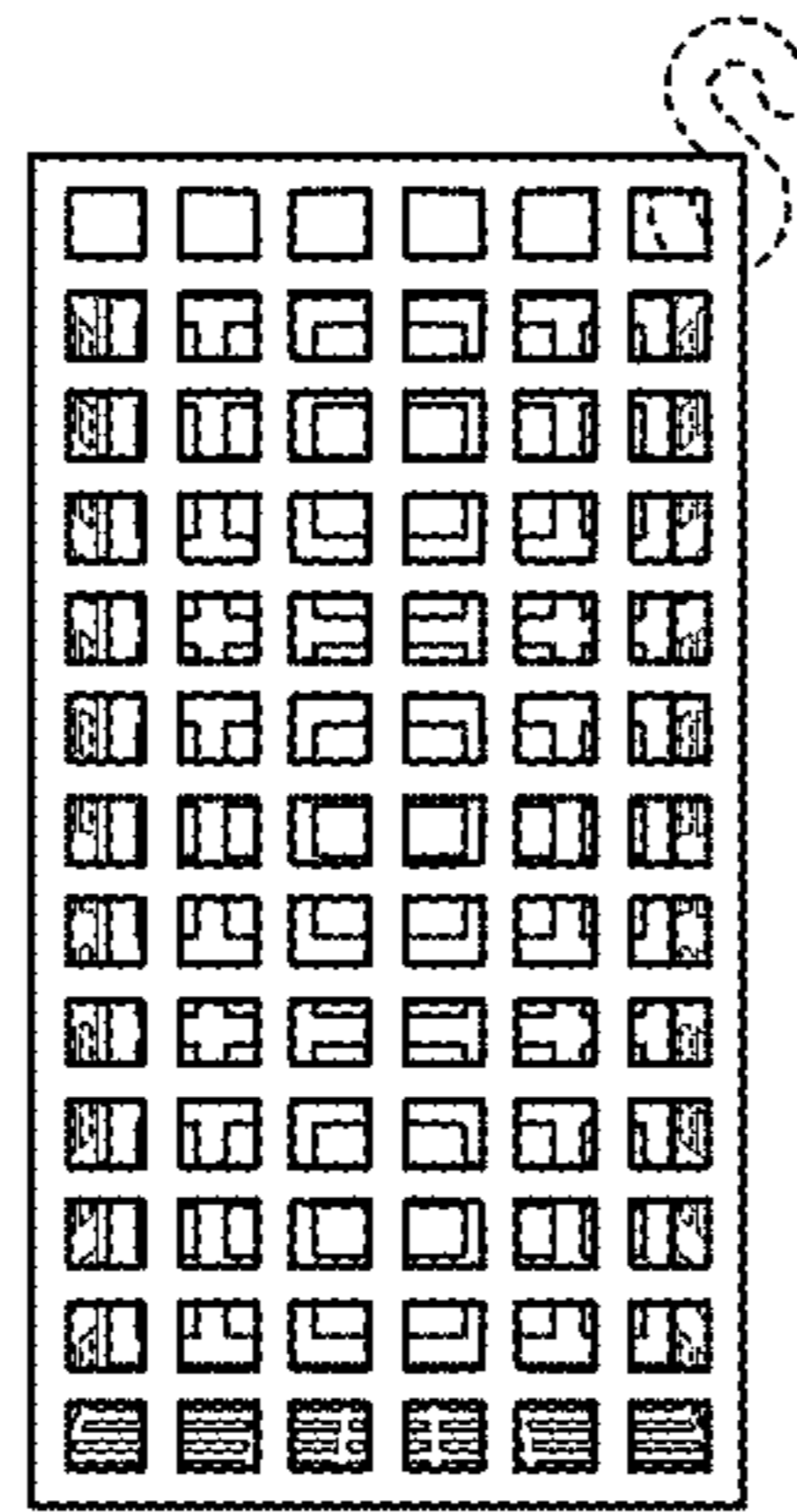

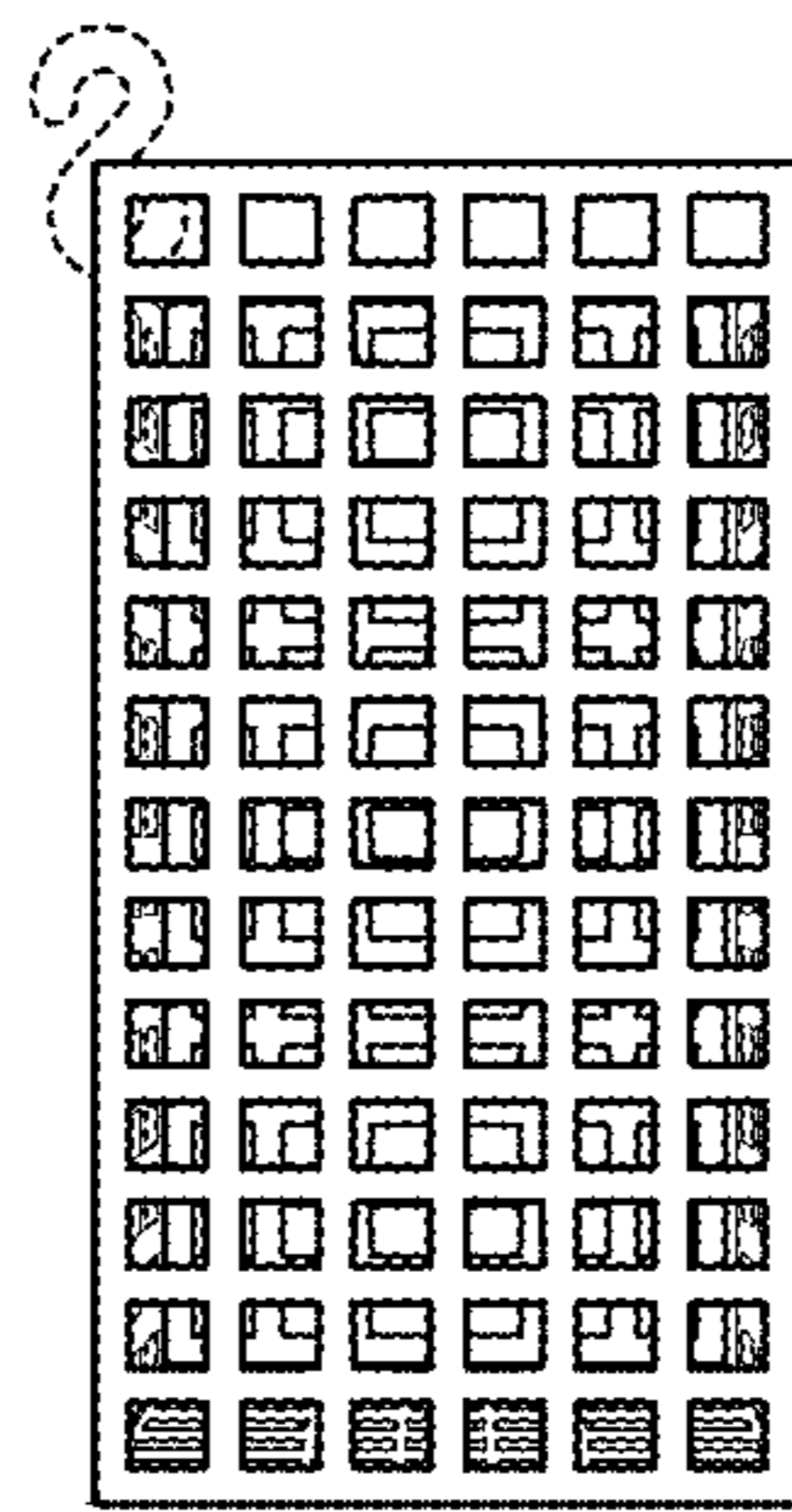

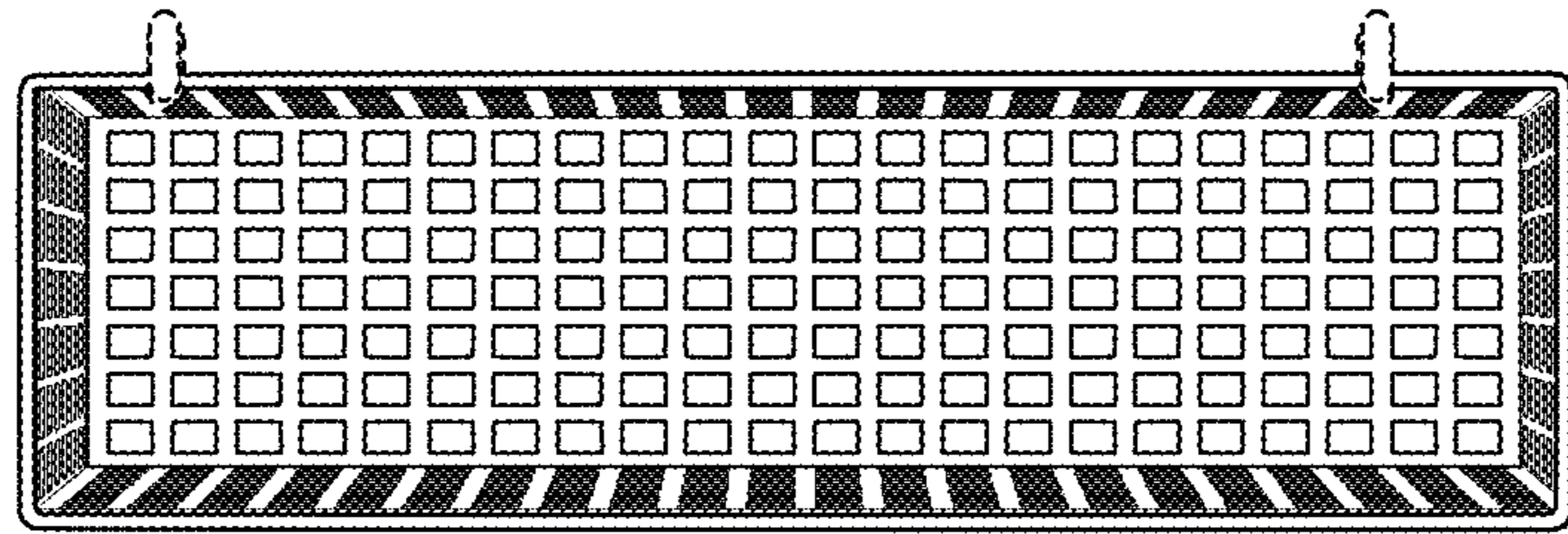

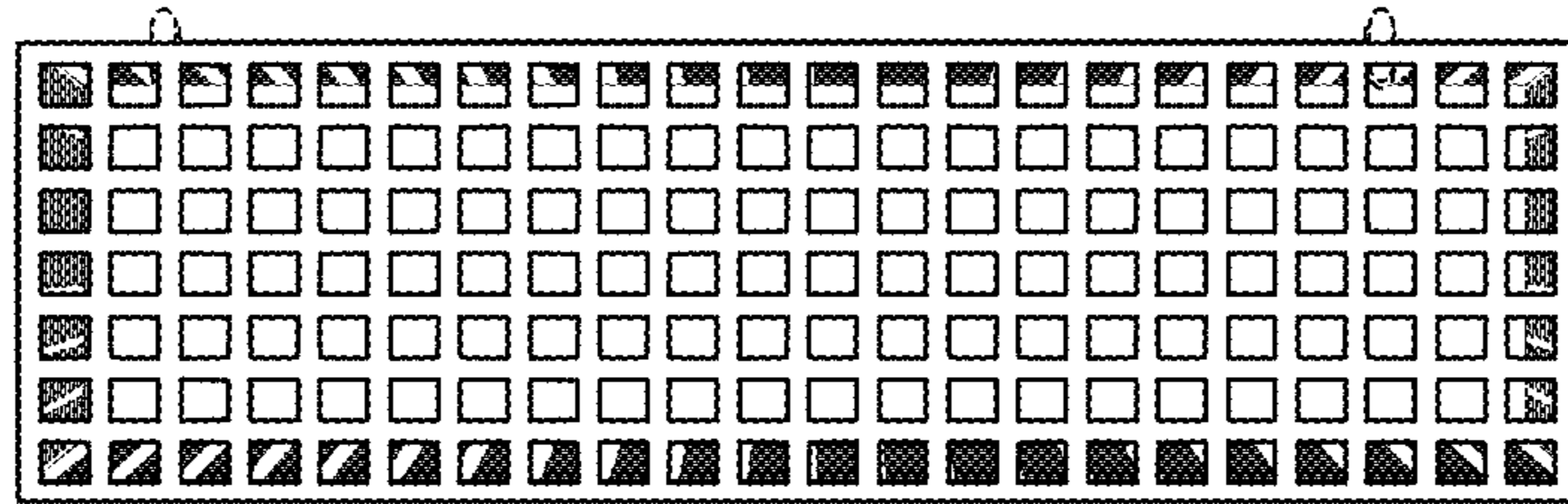
