(57) **CLAIM**

The ornamental design for easy-open hospital apparel, as shown and described.

DESCRIPTION

FIG. 1 is a front view of easy-open hospital apparel comprising long pants comprising snaps in the crotch and the inner seams of the legs to maintain them in a closed condition;

FIG. 2 is a rear view of the easy-open hospital apparel comprising long pants comprising snaps in the crotch and the inner seams of the legs to maintain them in a closed condition;

FIG. 3 is a left side view of the easy-open hospital apparel comprising long pants comprising snaps in the crotch and the inner seams of the legs to maintain them in a closed condition;

FIG. 4 is a right side view of the easy-open hospital apparel comprising long pants comprising snaps in the crotch and the inner seams of the legs to maintain them in a closed condition;

FIG. 5 is a front view of the easy-open hospital apparel comprising long pants showing the crotch and one leg in an open condition;

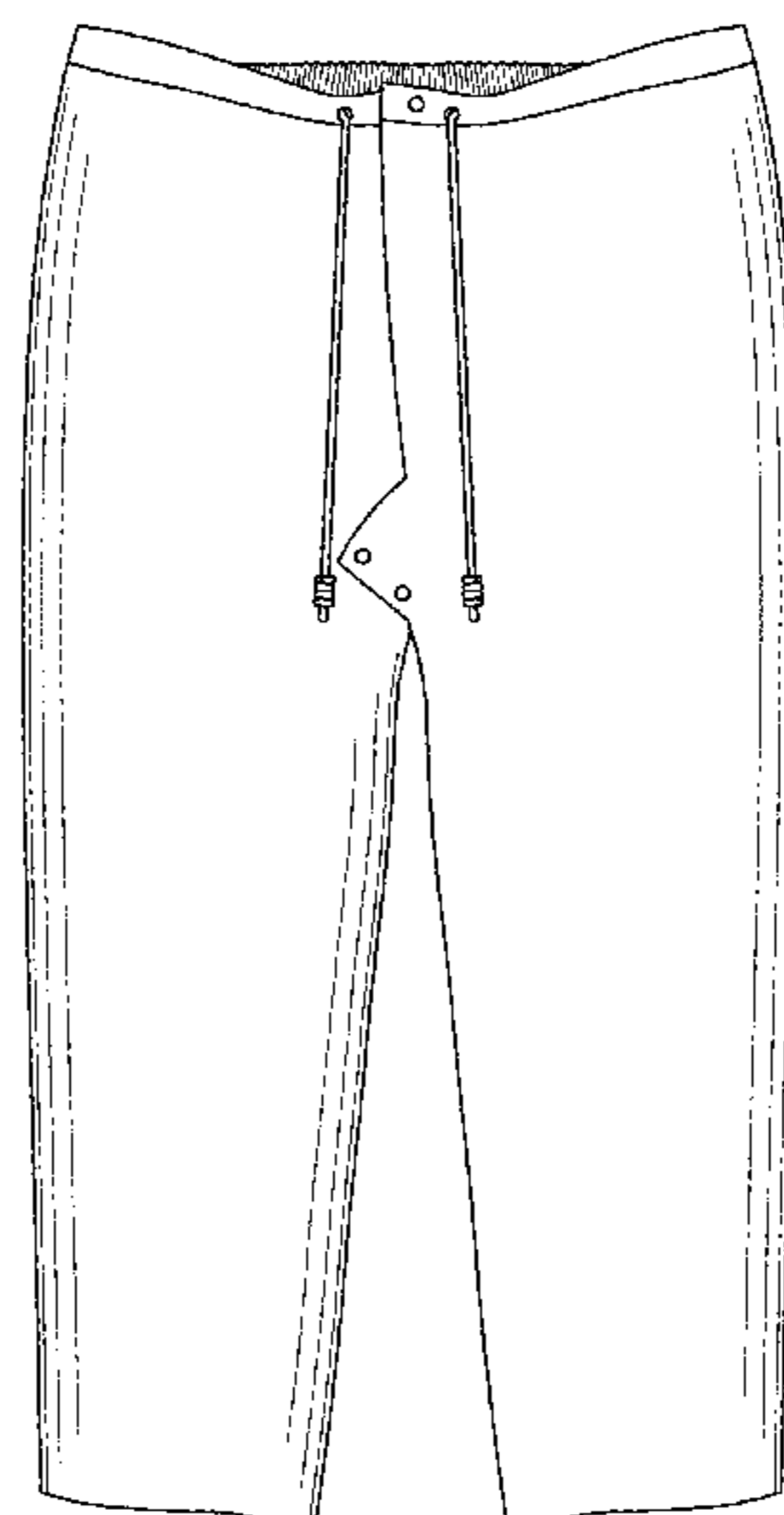
FIG. 6 is a rear view of the easy-open hospital apparel comprising long pants showing the crotch and one leg in an open condition;

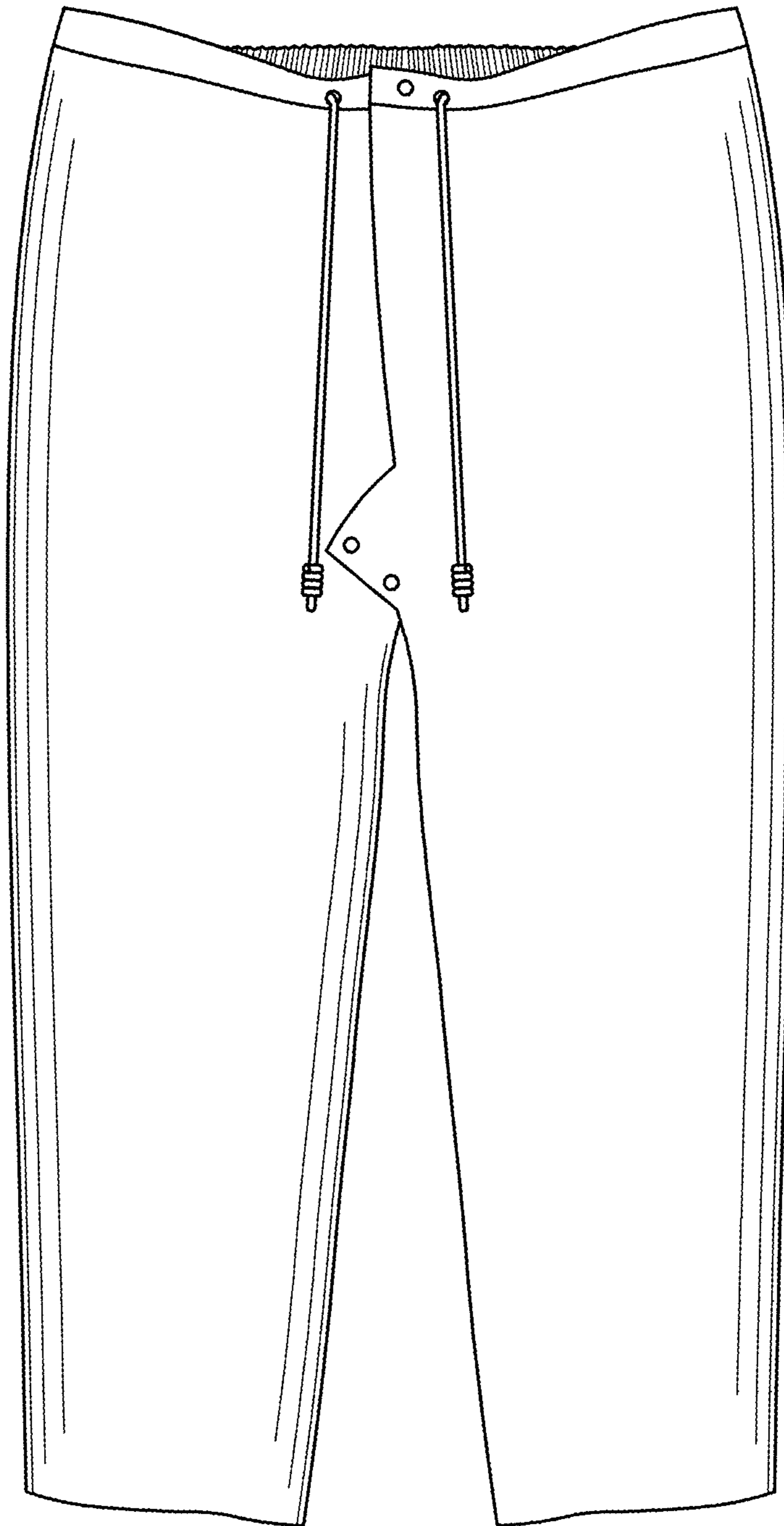

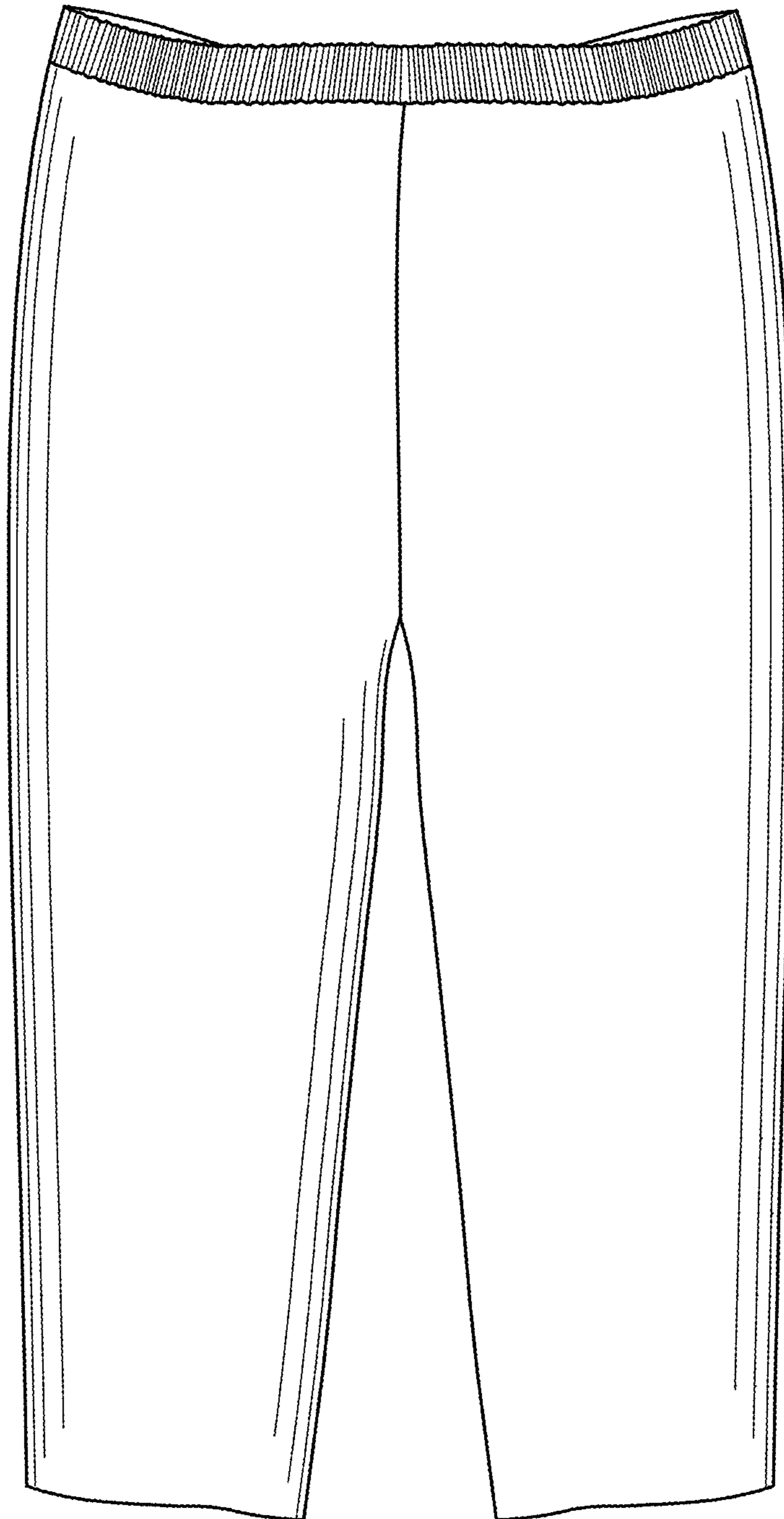

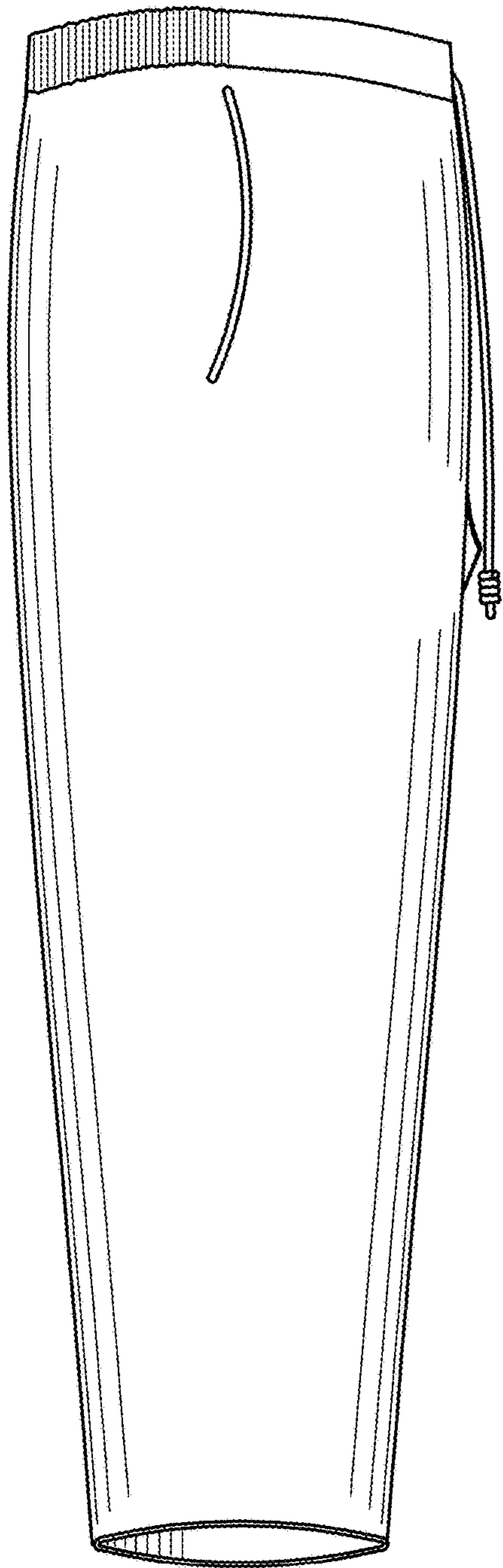

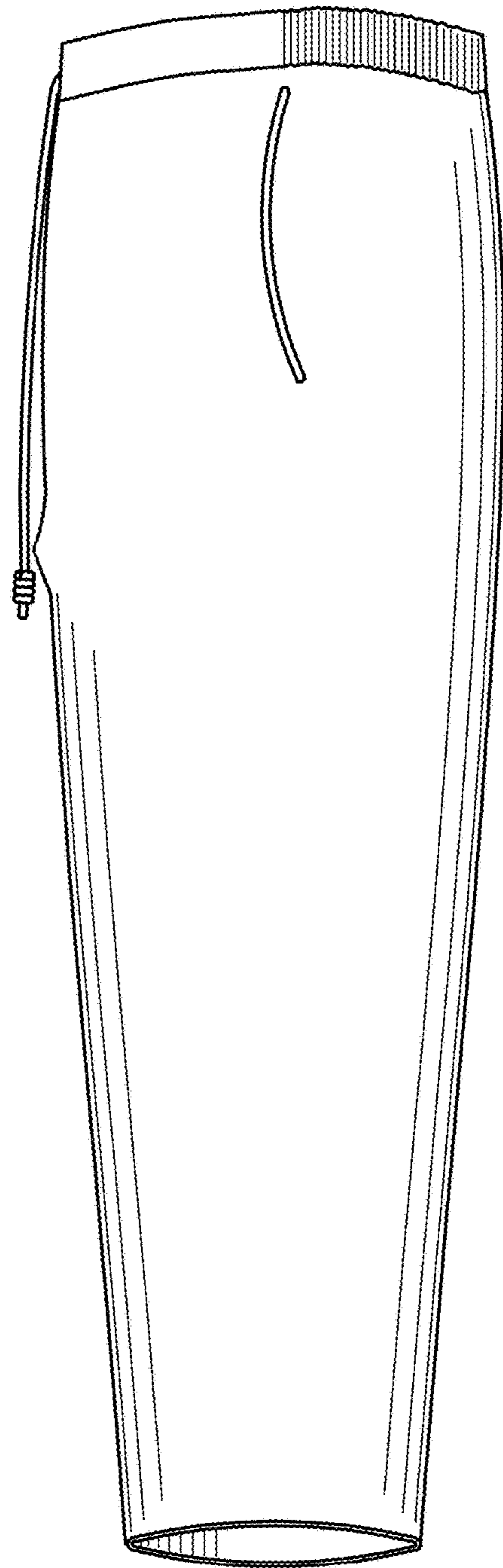

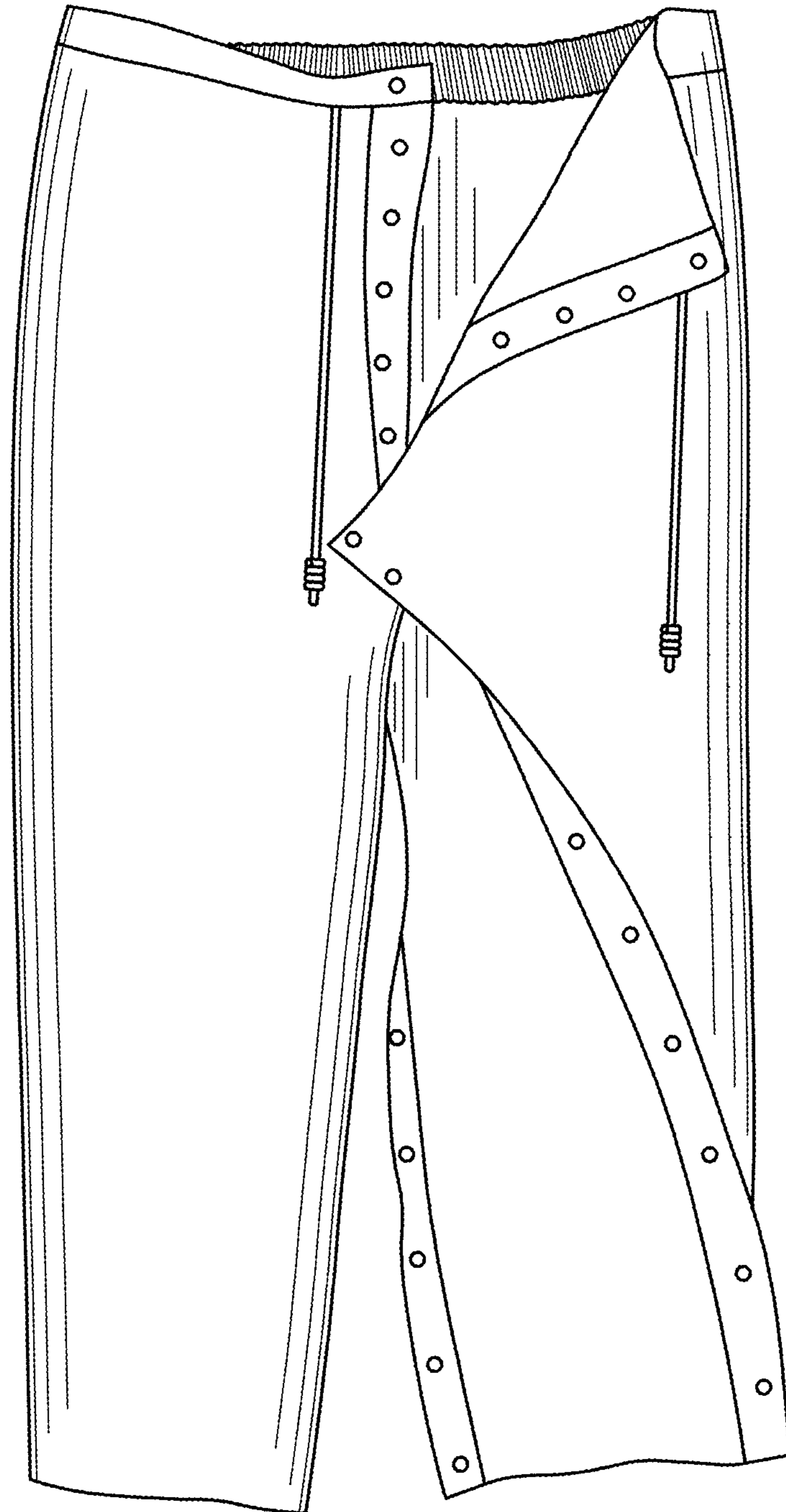

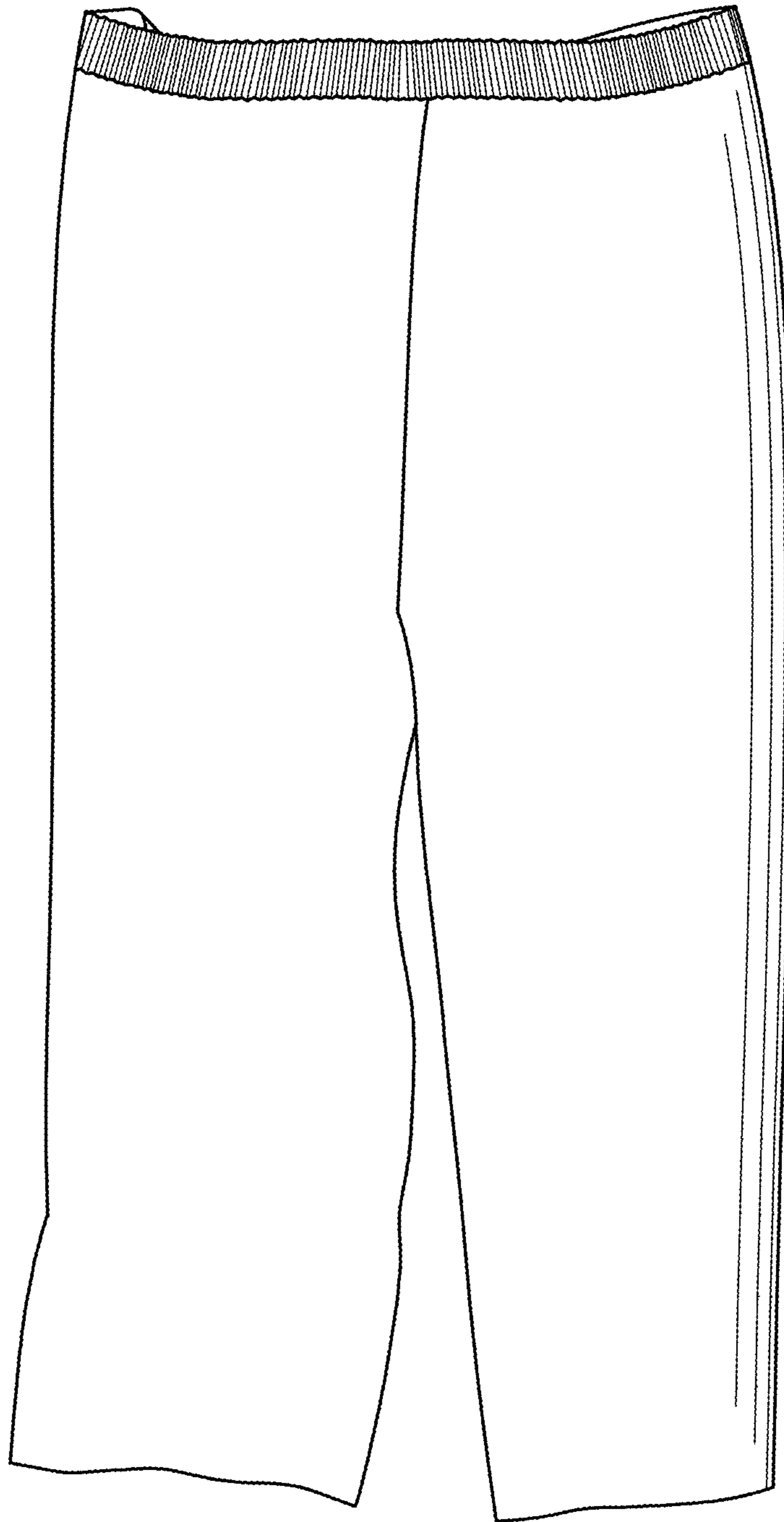

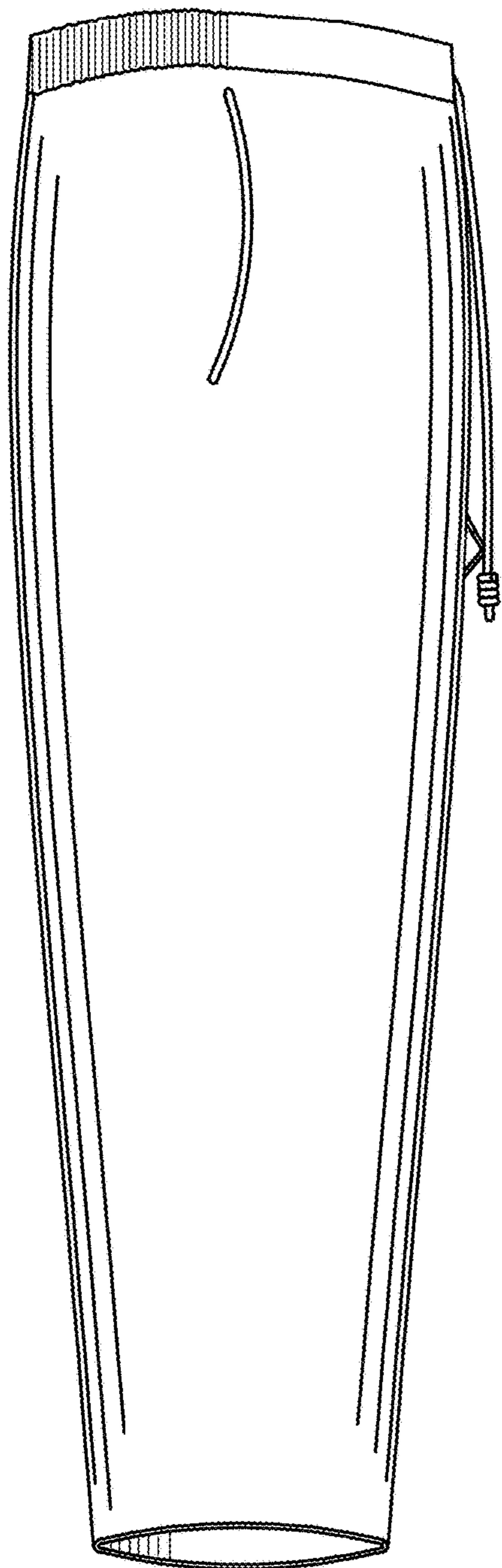

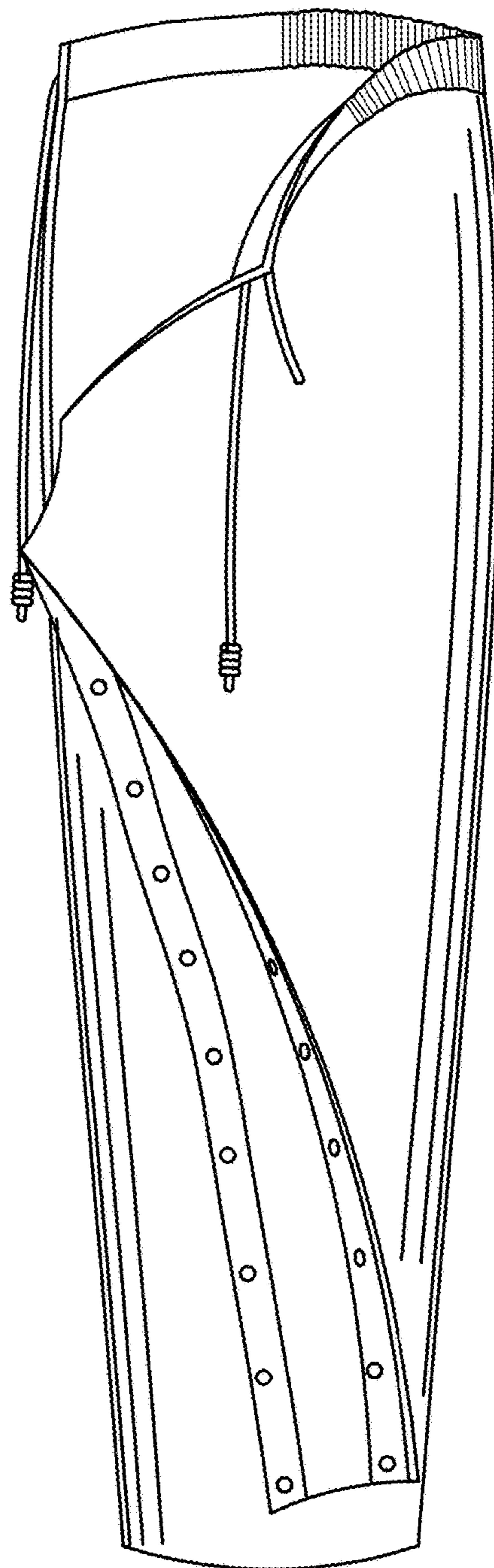
