DESCRIPTION

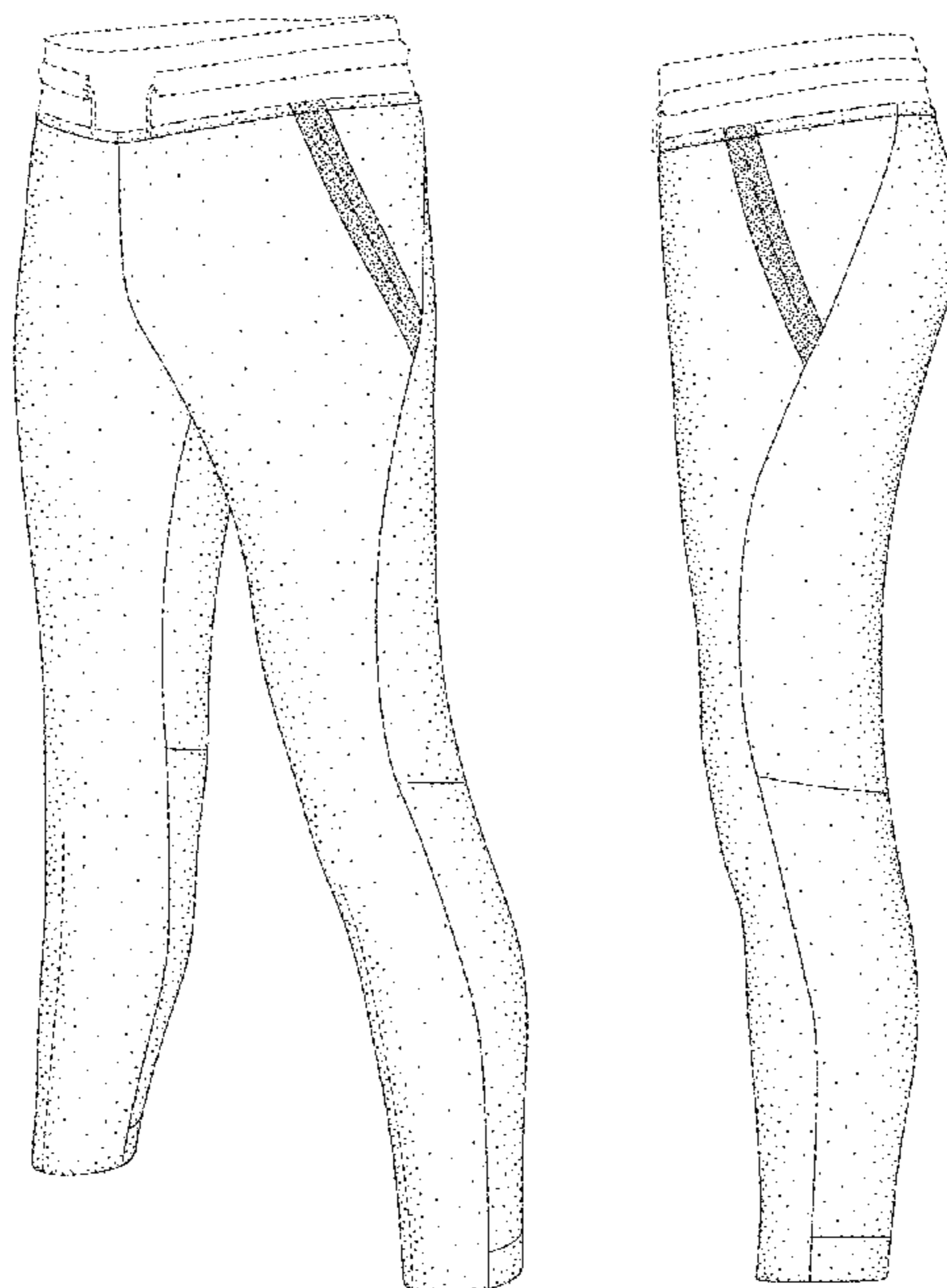
FIG. 1 is a front right perspective view of a garment showing our new design in an in-use configuration;

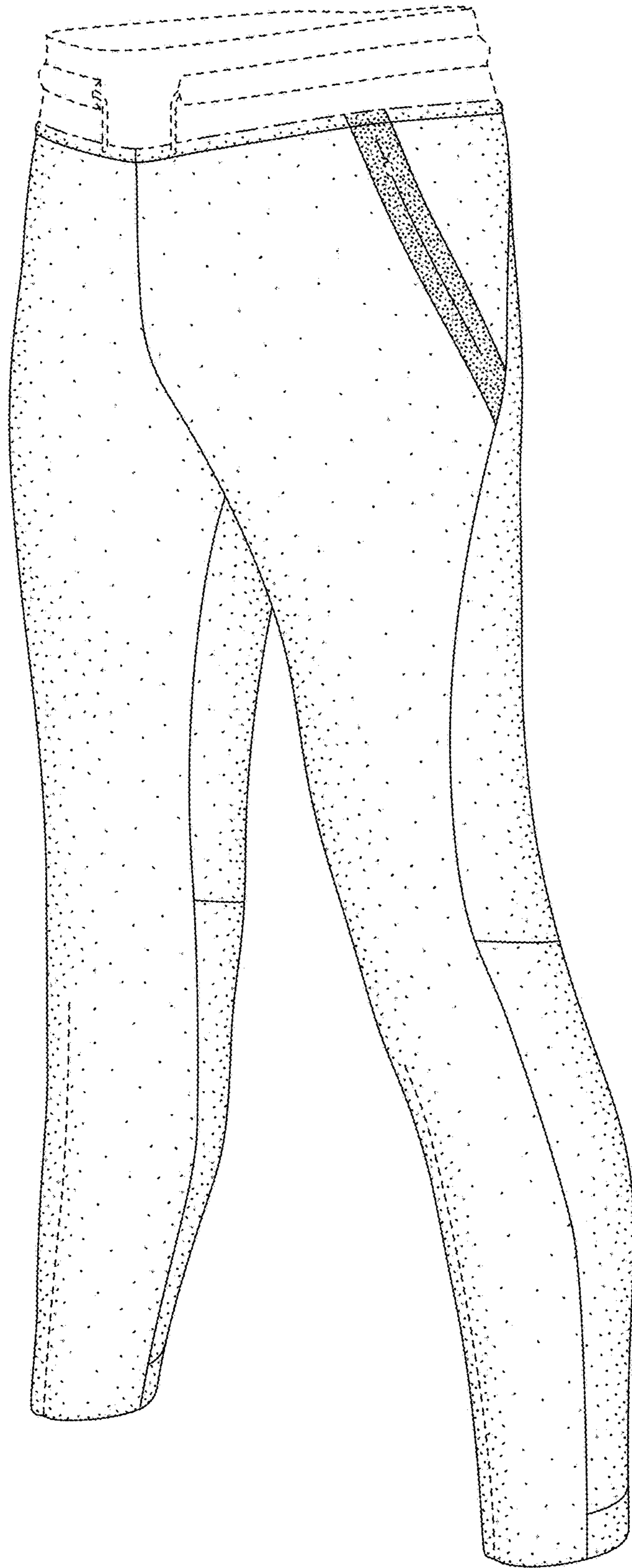

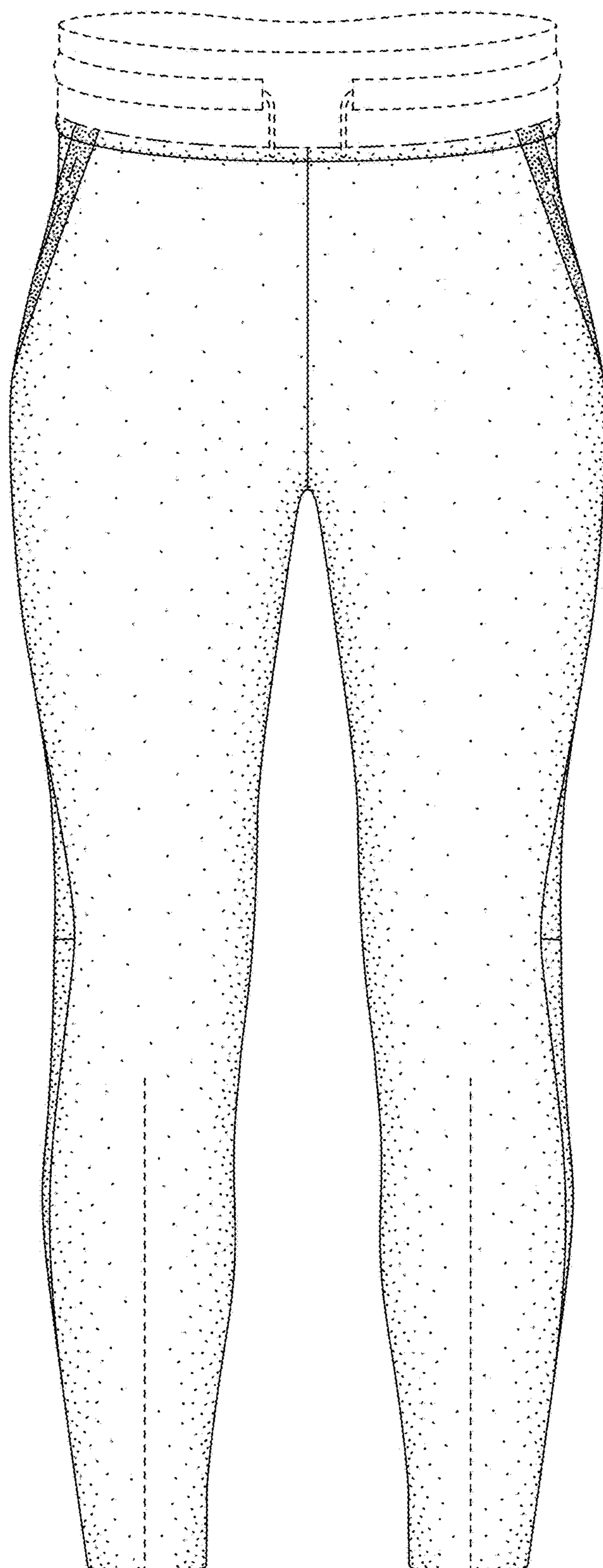

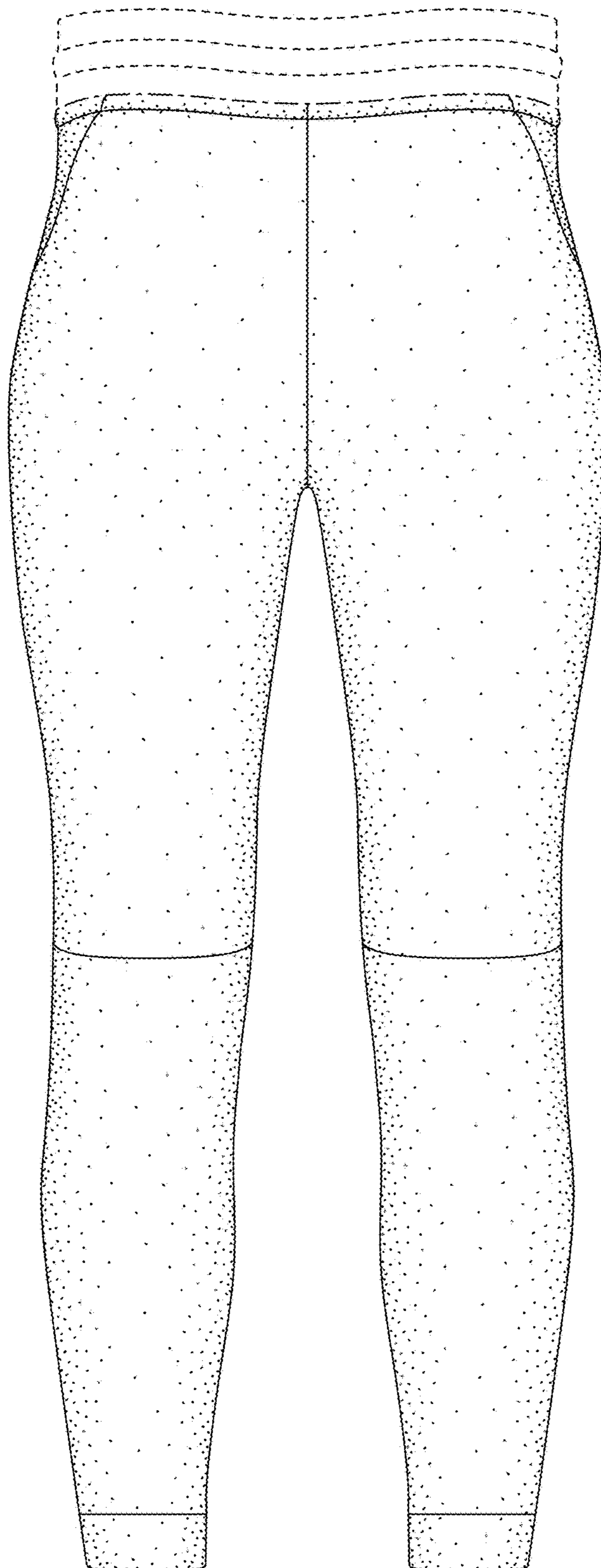

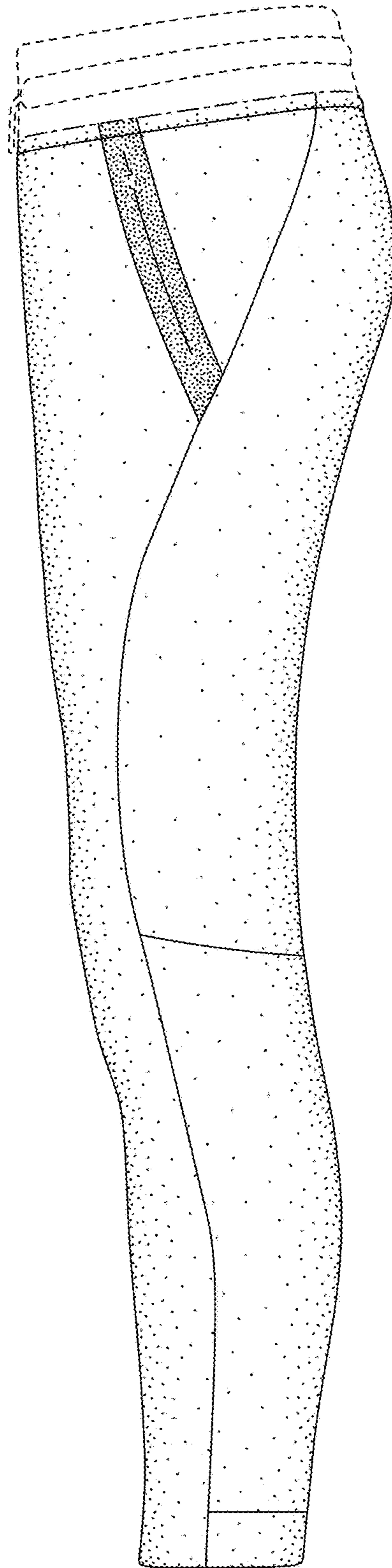

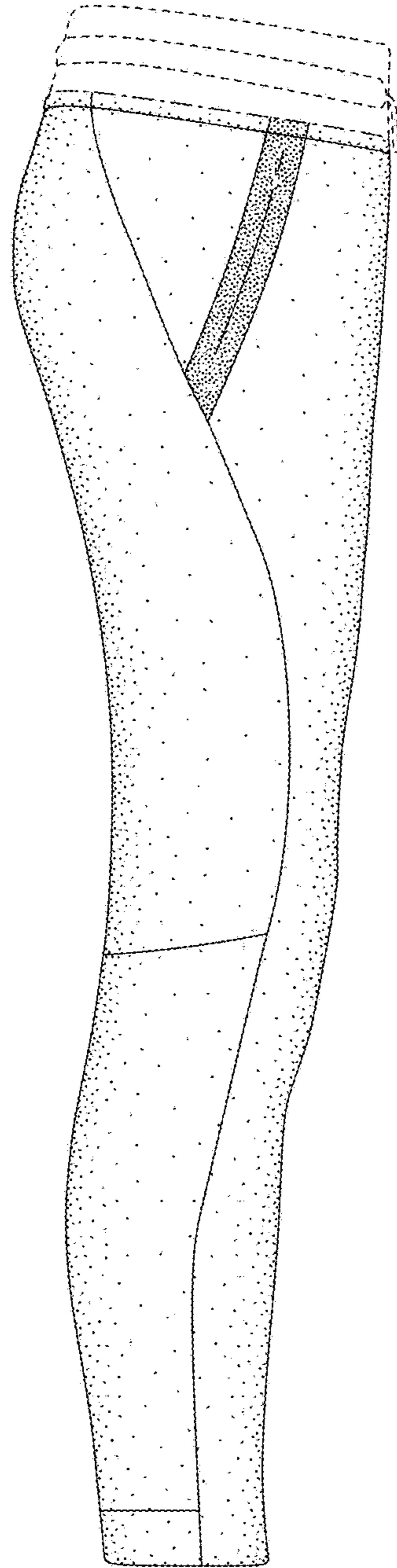
