DESCRIPTION

The evenly-spaced broken lines shown in the drawings are directed to environment and form no part of the claimed design.

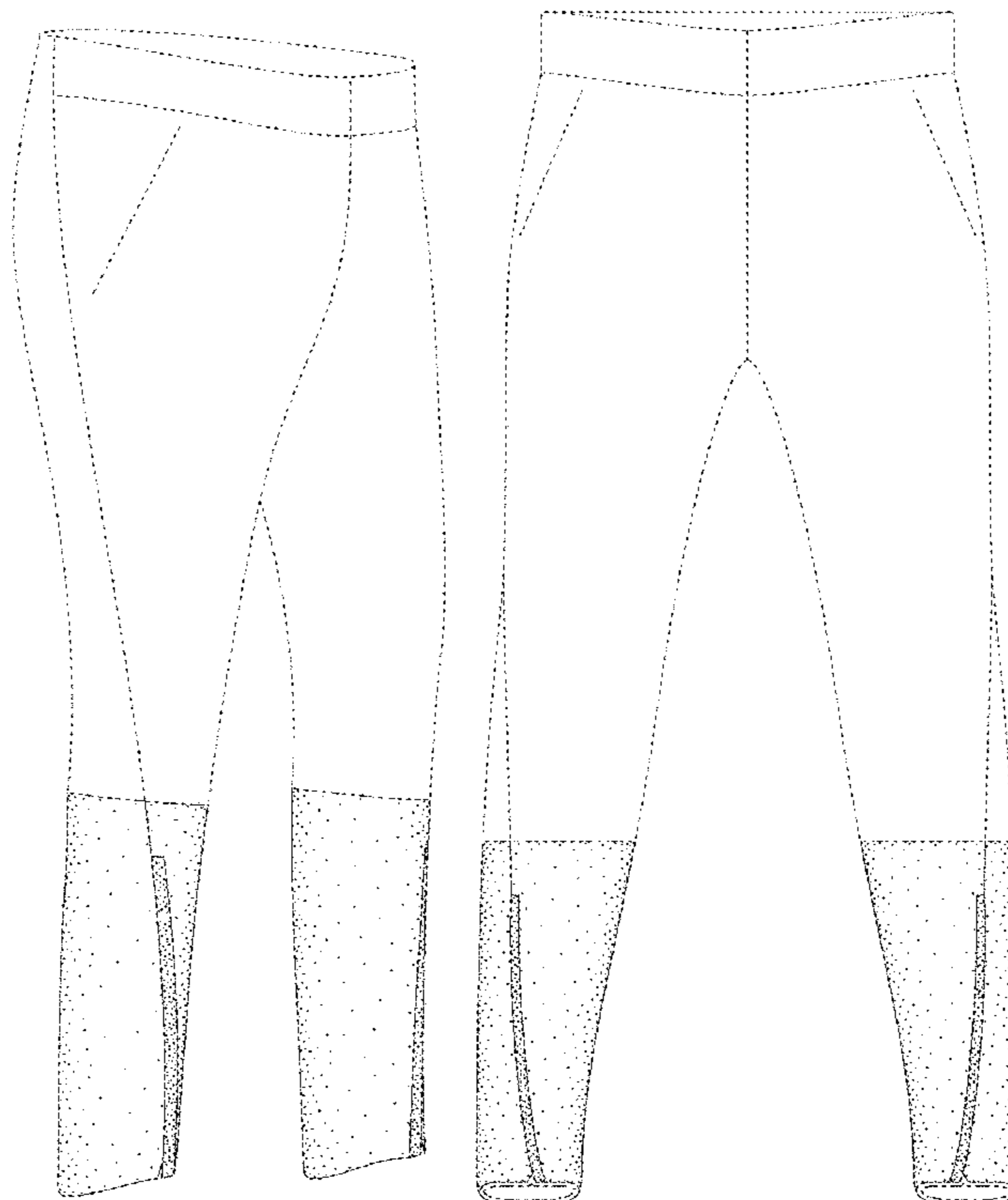
The dash dot broken lines depict boundaries of the claim that form no part of the claim.

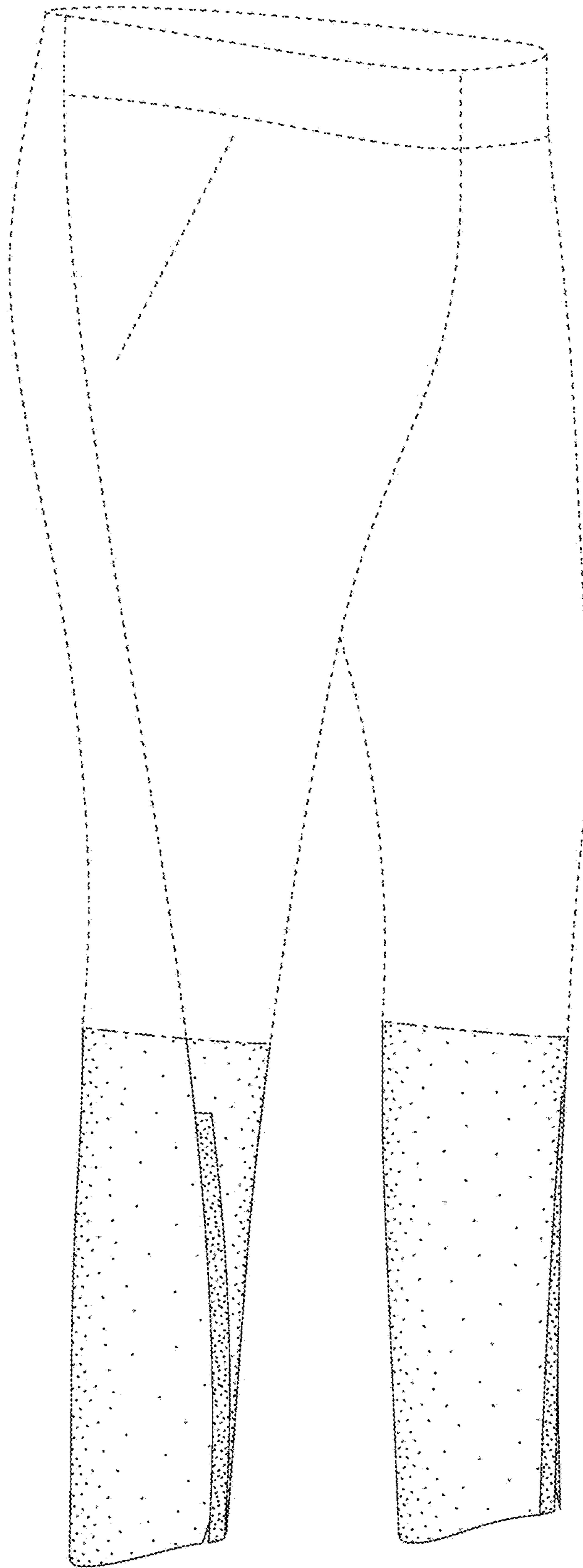

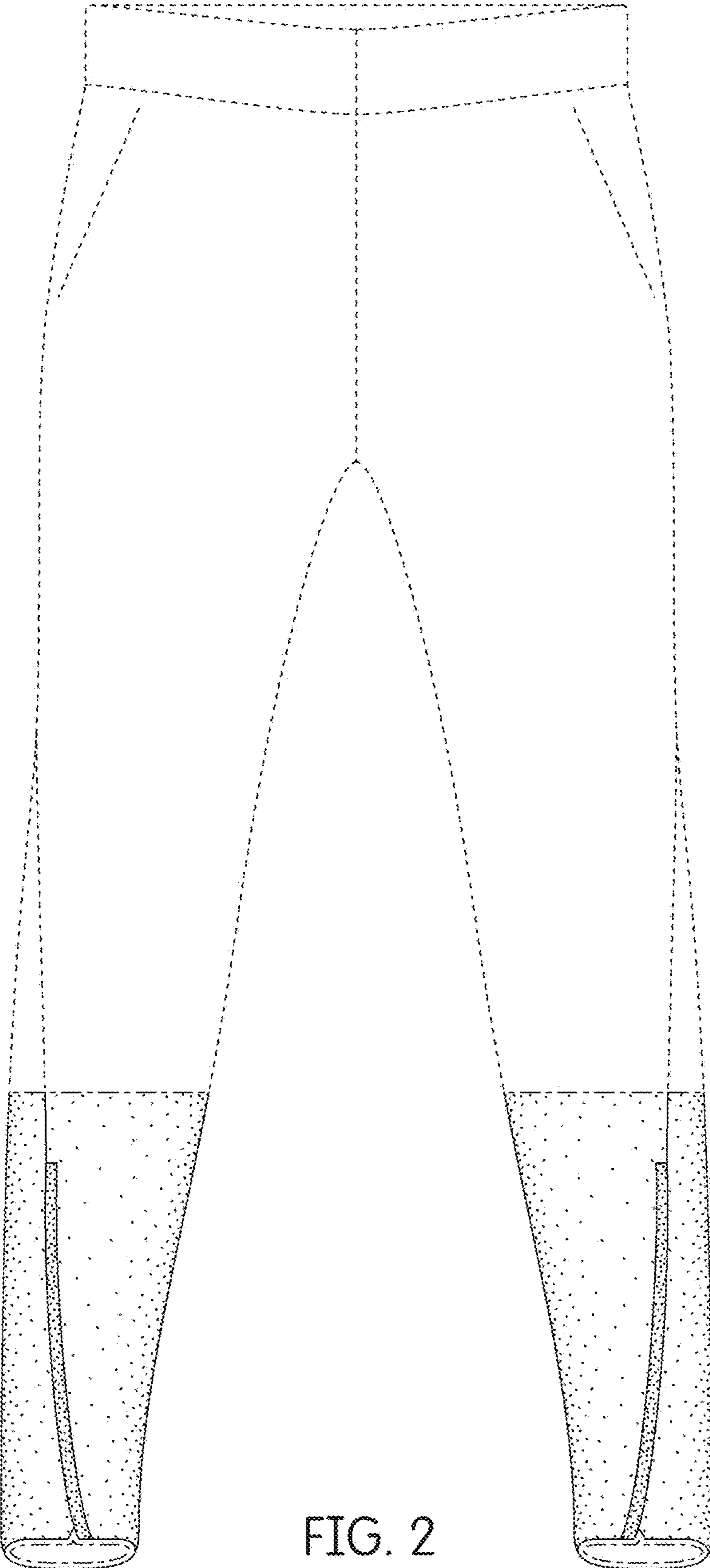

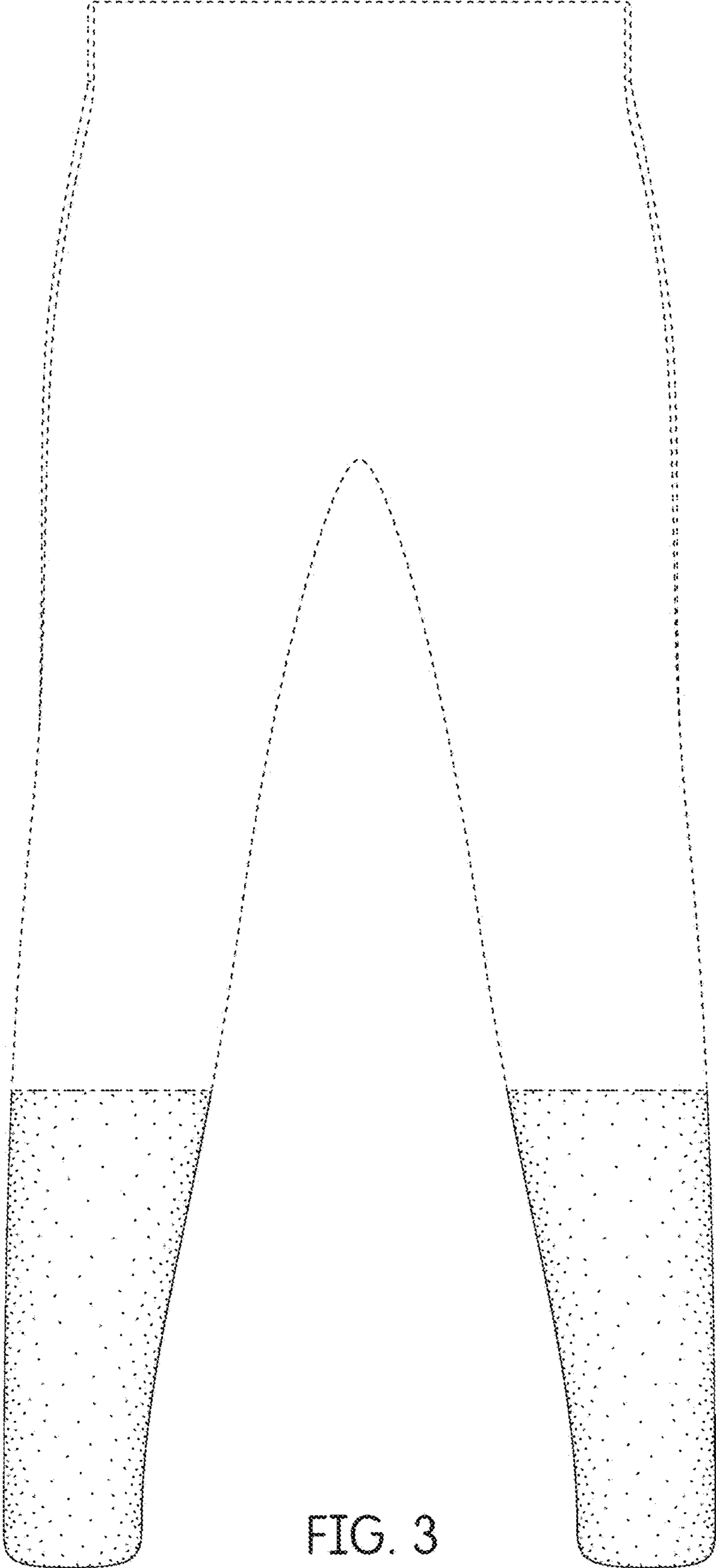

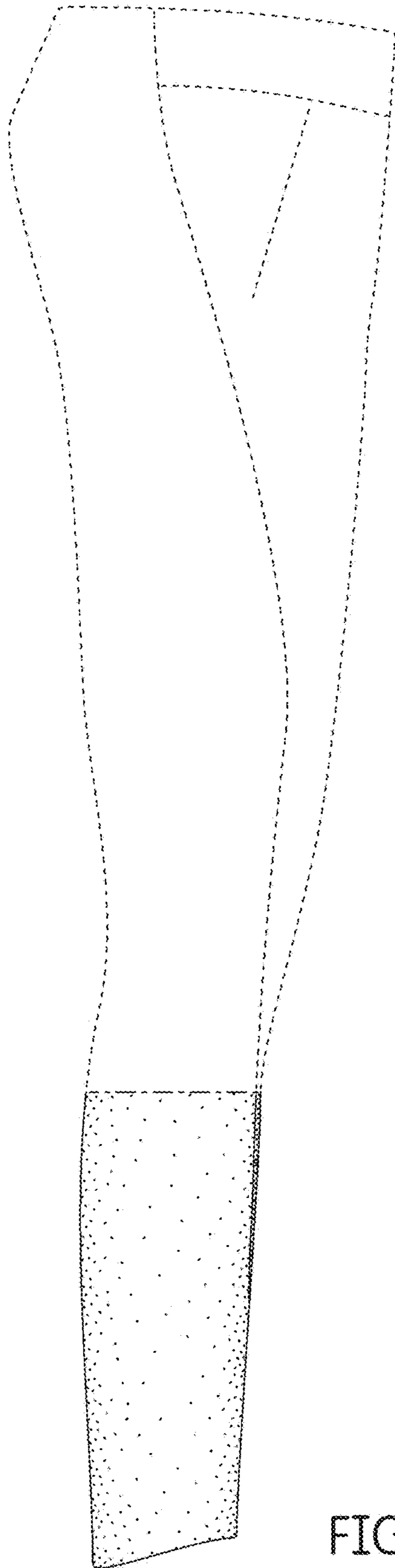

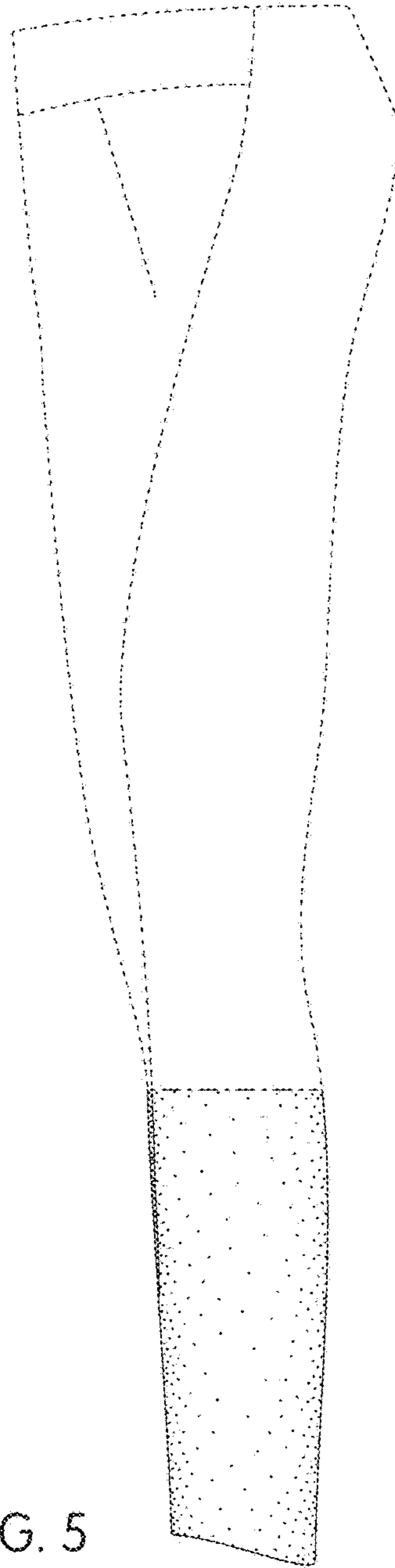
