(57) **CLAIM**

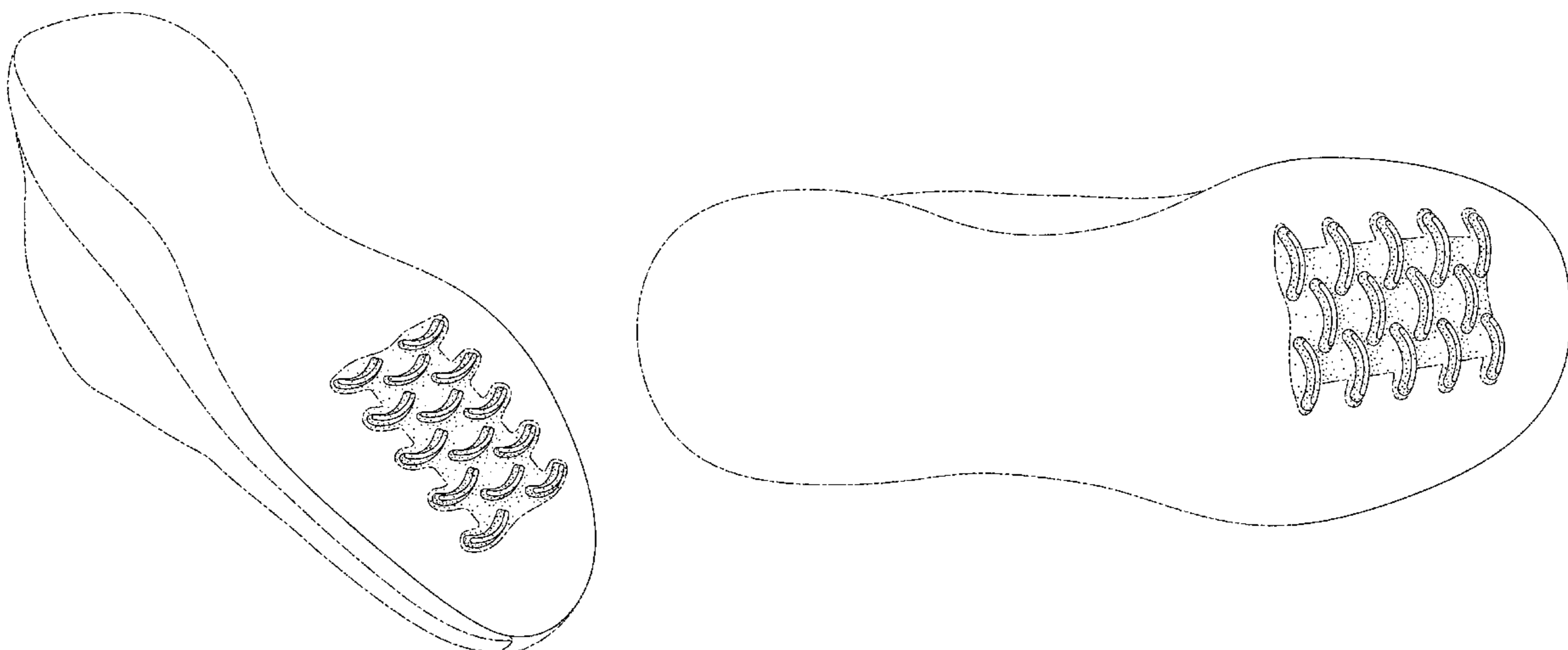
The ornamental design for a shoe outsole, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a shoe outsole showing my new design;
FIG. 2 is a bottom view thereof;
FIG. 3 is a rear perspective view thereof; and,
FIG. 4 is an enlargement of FIG. 1 with the claimed solid line outside of the shaded area and unclaimed subject matter omitted for purposes of enlargement.
The solid line outside of the shaded area is claimed. The broken lines immediately adjacent to the shaded area represent unclaimed boundaries of the design. The broken lines showing the remainder of the shoe represent unclaimed subject matter and form no part of the claimed design.

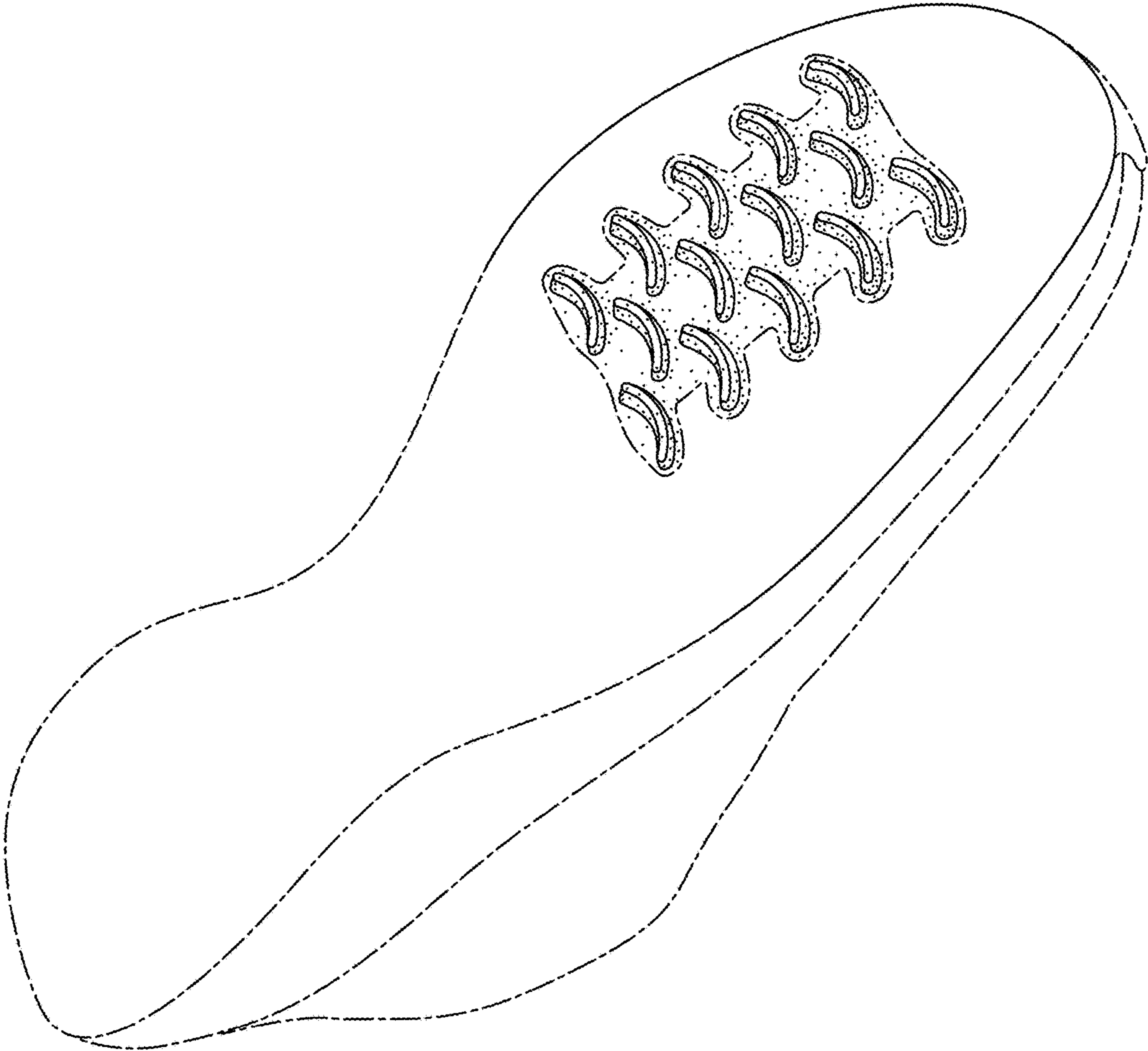

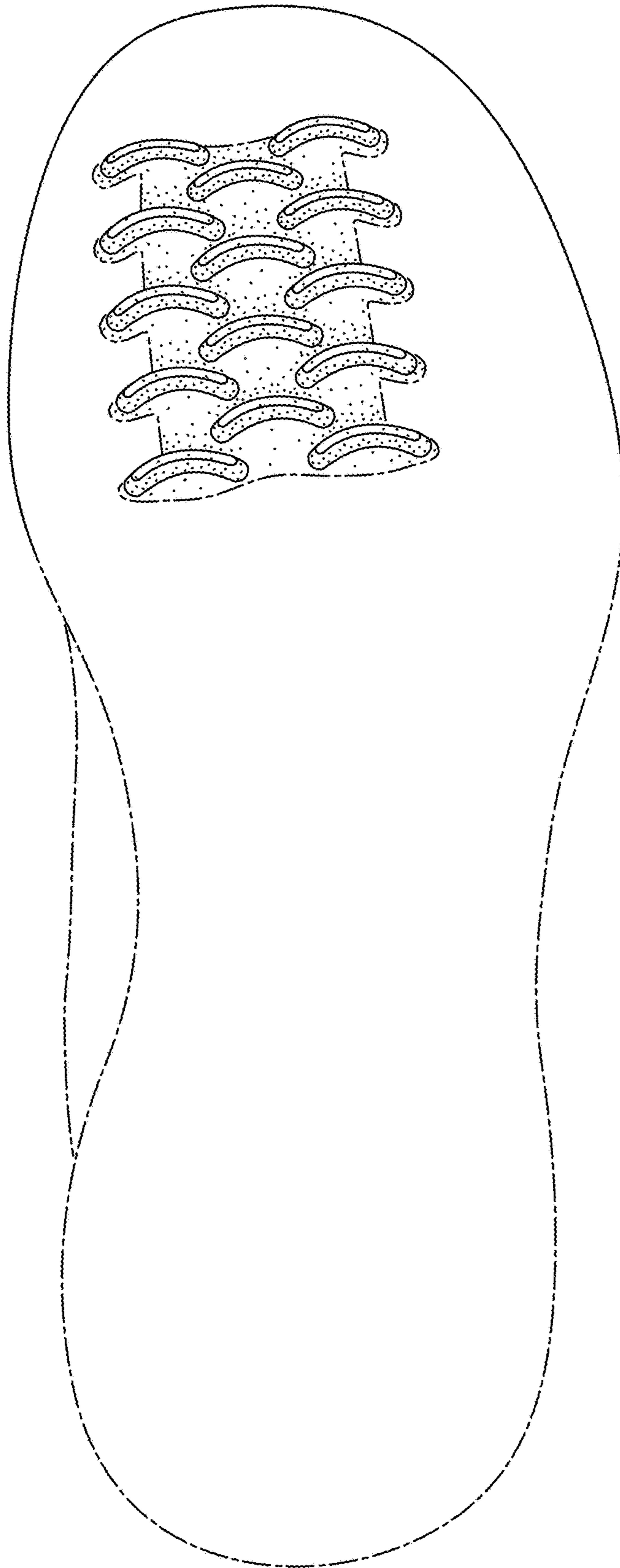

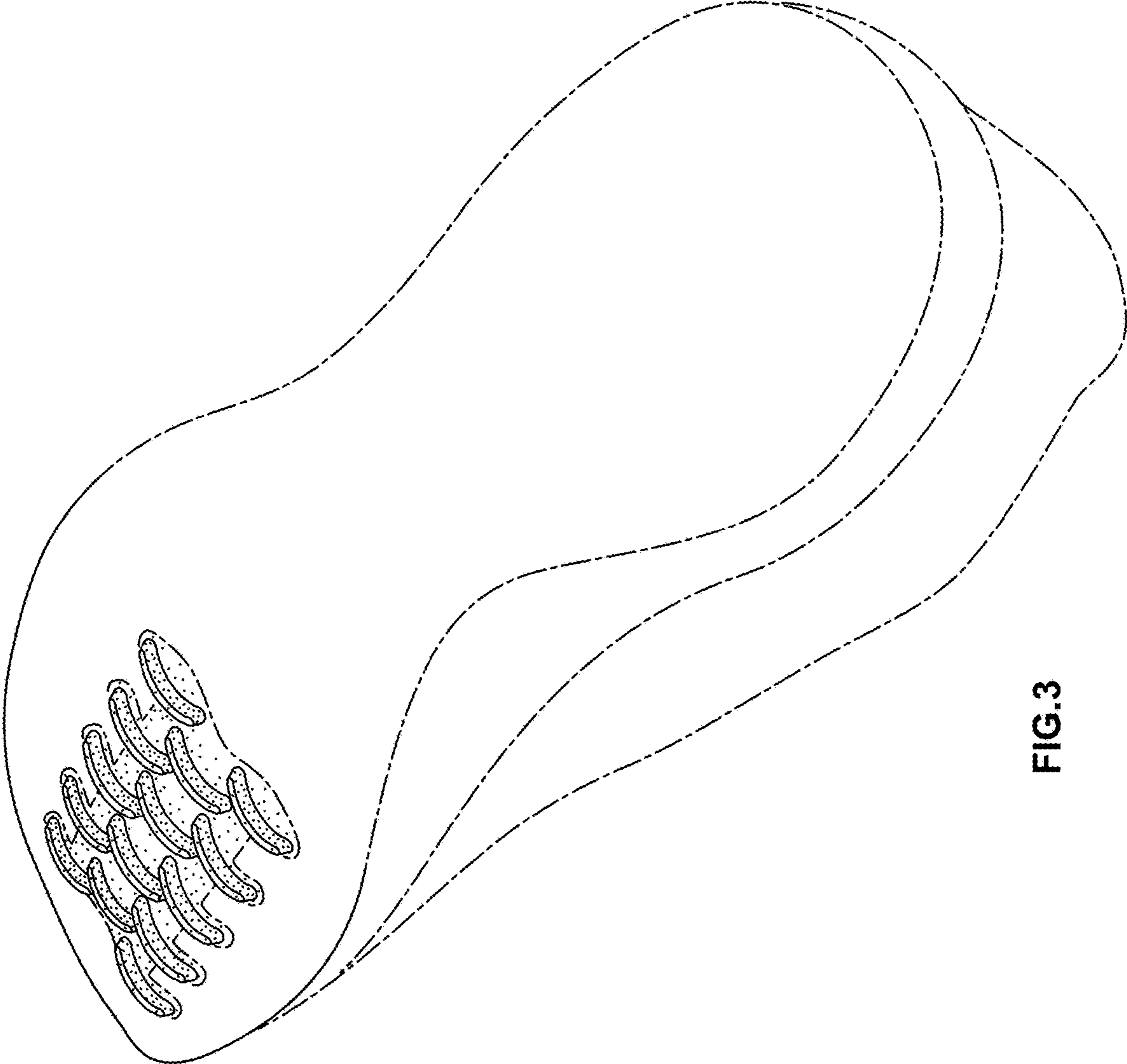

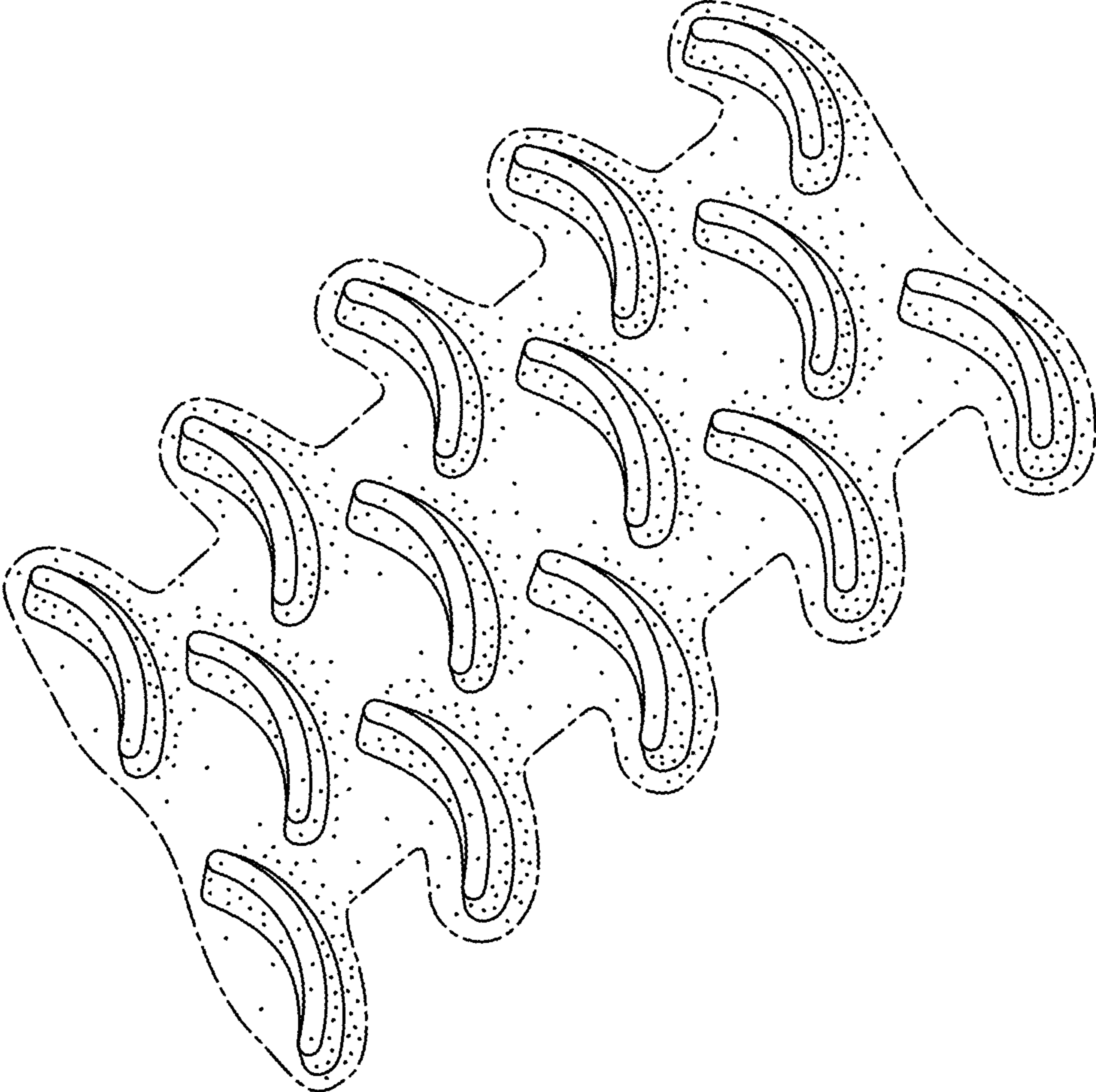
