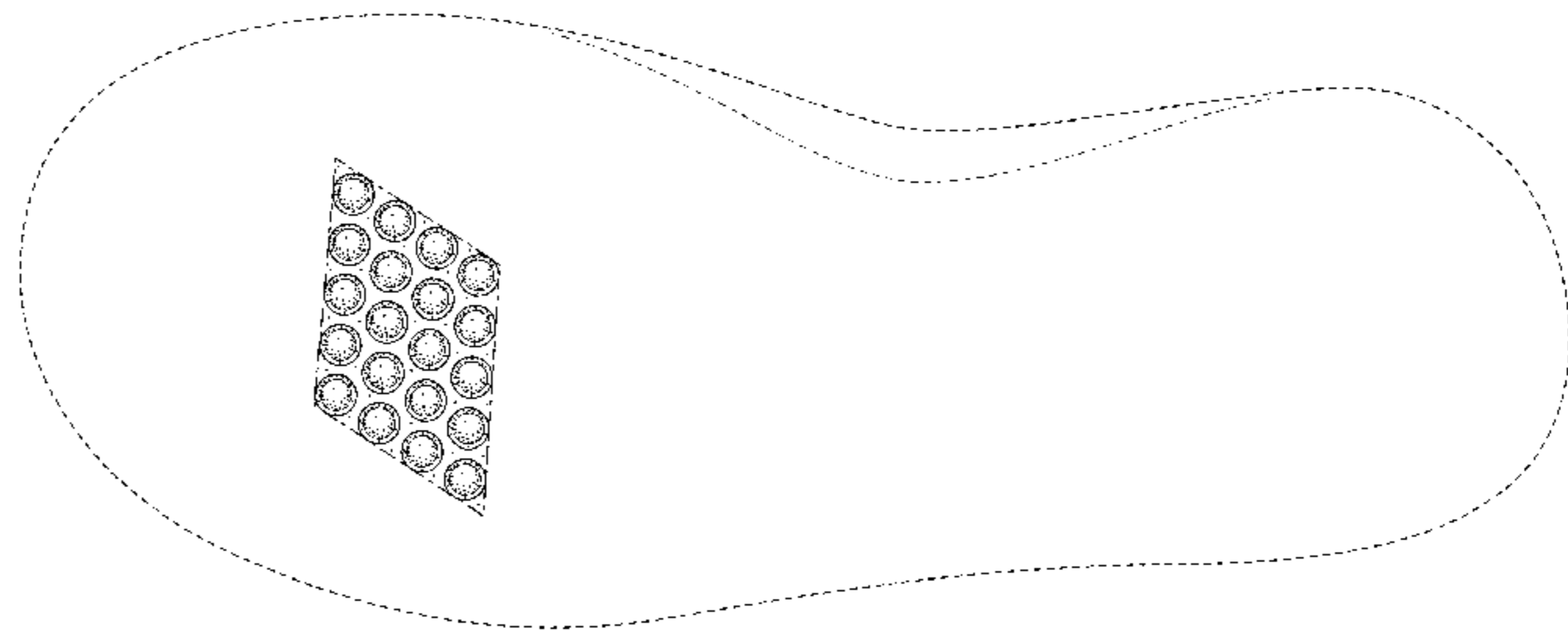
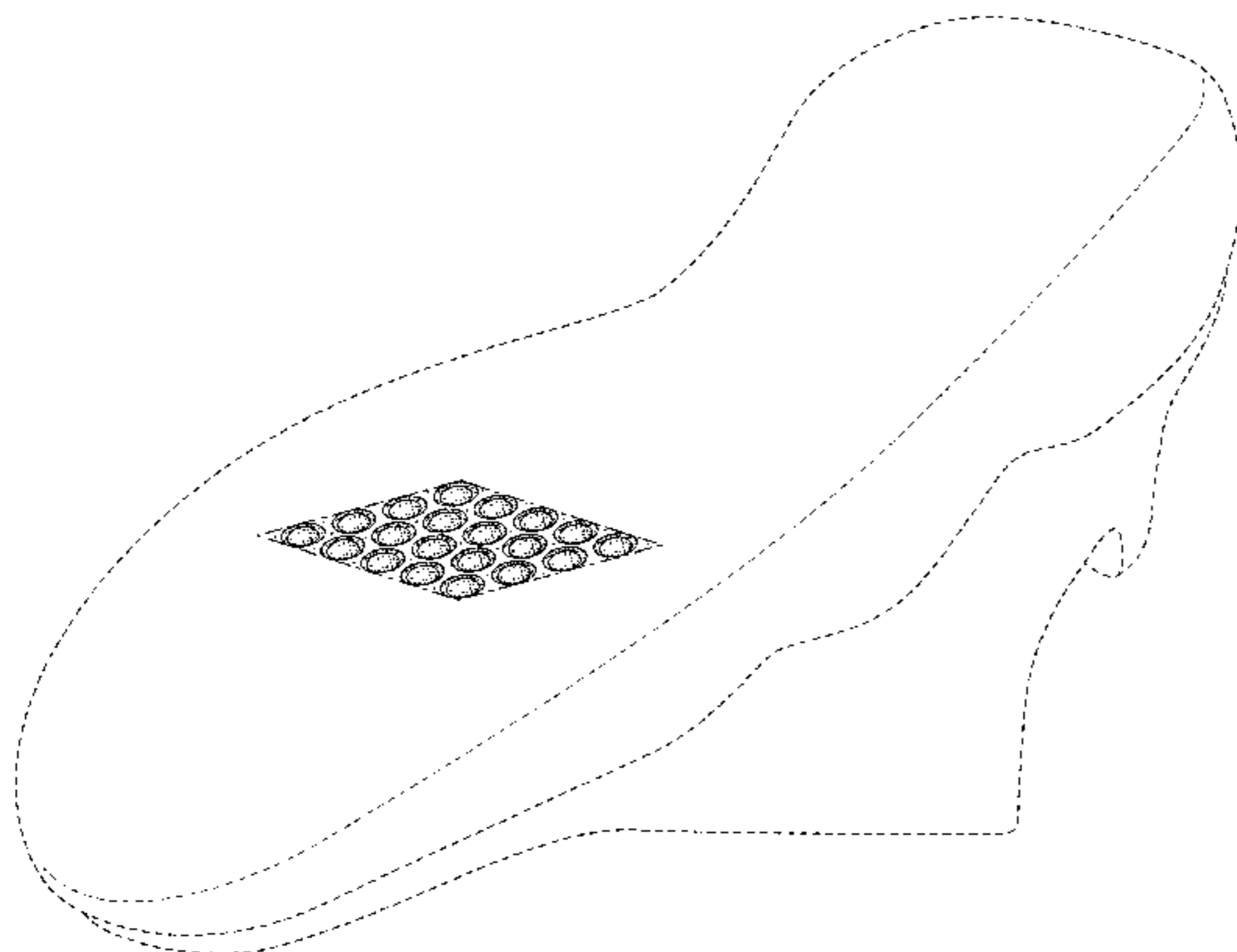
(57) **CLAIM**

The ornamental design for a shoe outsole, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a shoe outsole showing my new design;
 FIG. 2 is a bottom view thereof; and,
 FIG. 3 is a rear perspective view thereof.
 The broken line immediately surrounding the perimeter of the shaded area represents an unclaimed peripheral boundary of the design. The broken line showing of the remainder of the shoe represents unclaimed subject matter and forms no part of the claimed design.

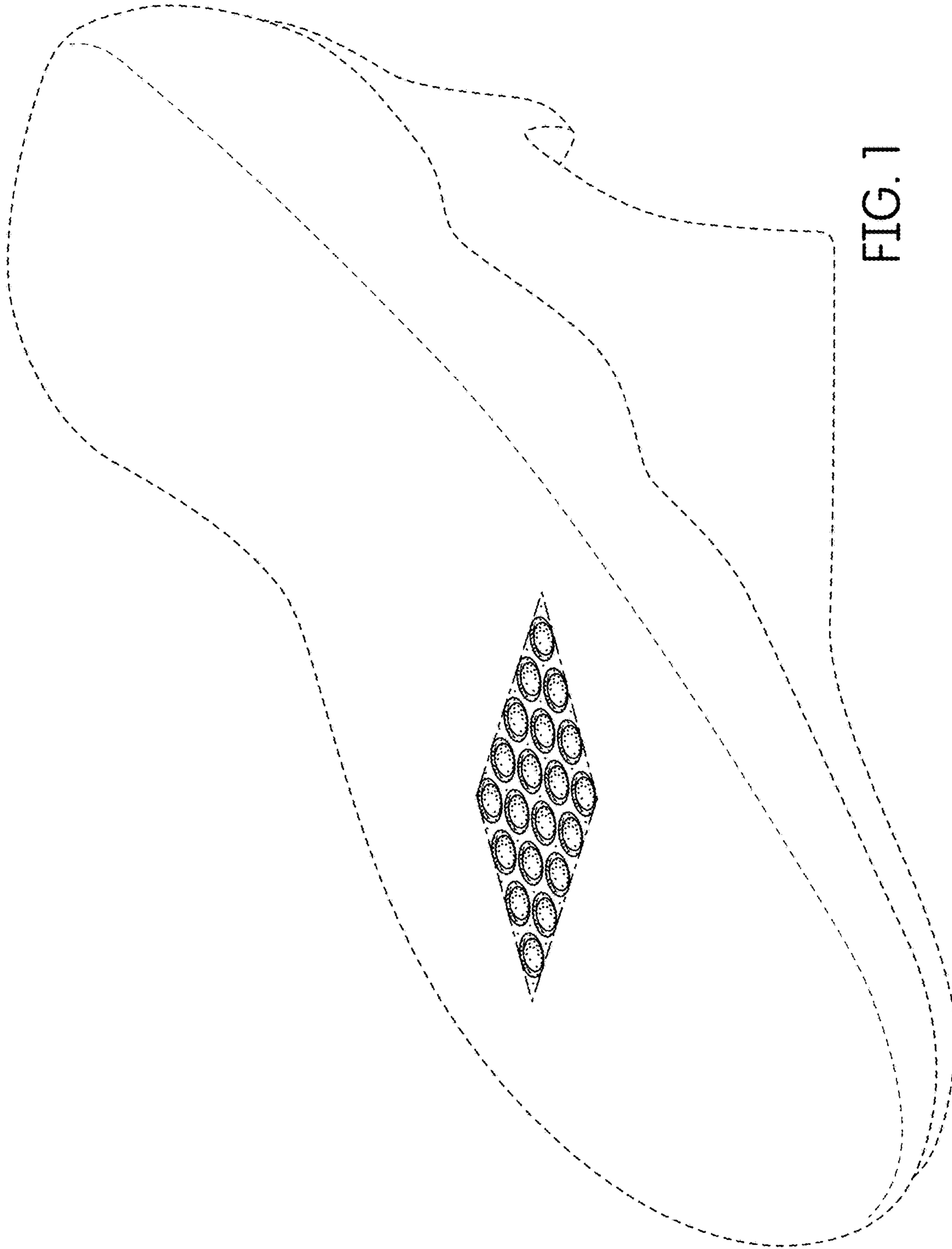

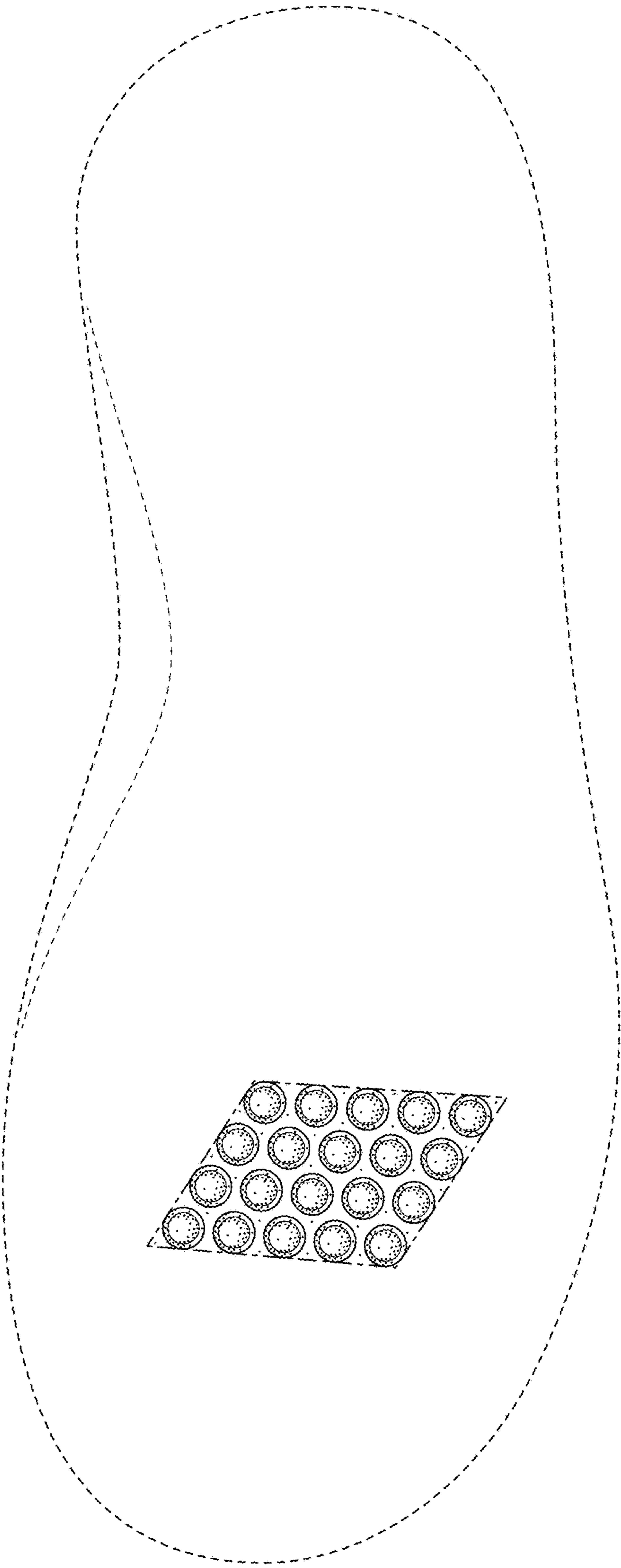

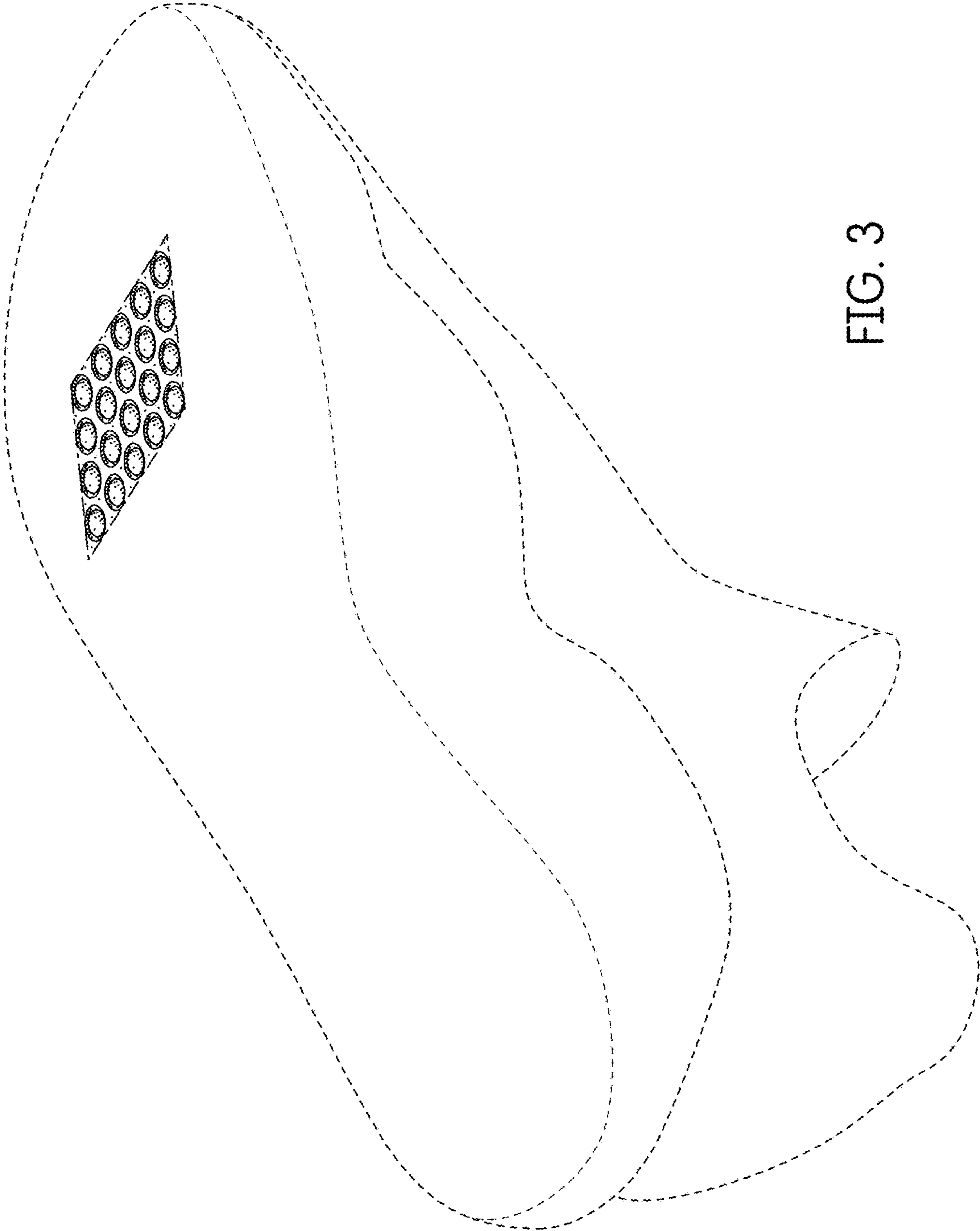
