The ornamental design for a shoe, as shown and described.

DESCRIPTION

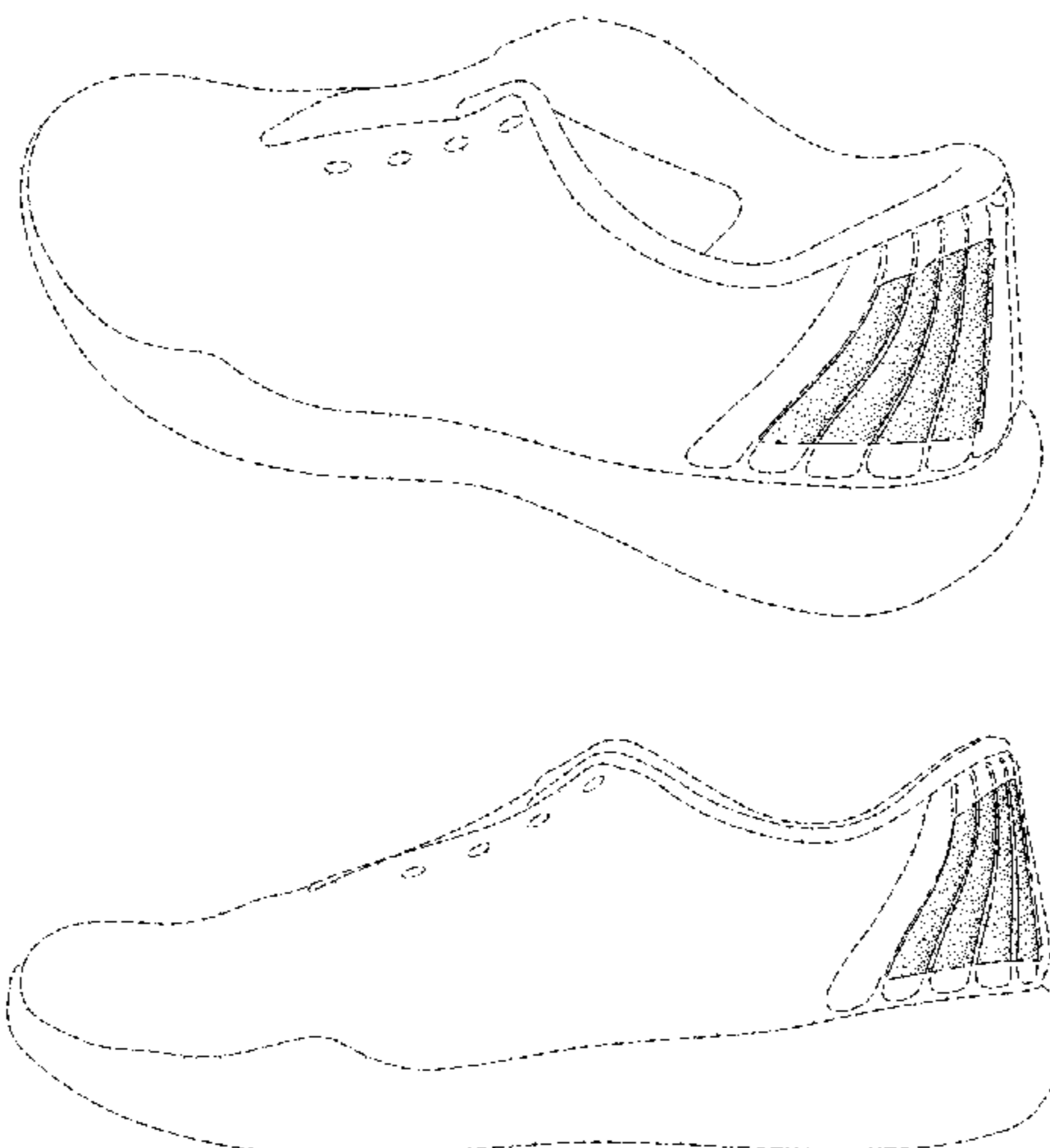
FIG. 1 is a rear, lateral-side perspective view of a shoe showing the present design;
FIG. 2 is a lateral side view thereof;
FIG. 3 is a rear view thereof; and,
FIG. 4 is a top view thereof.

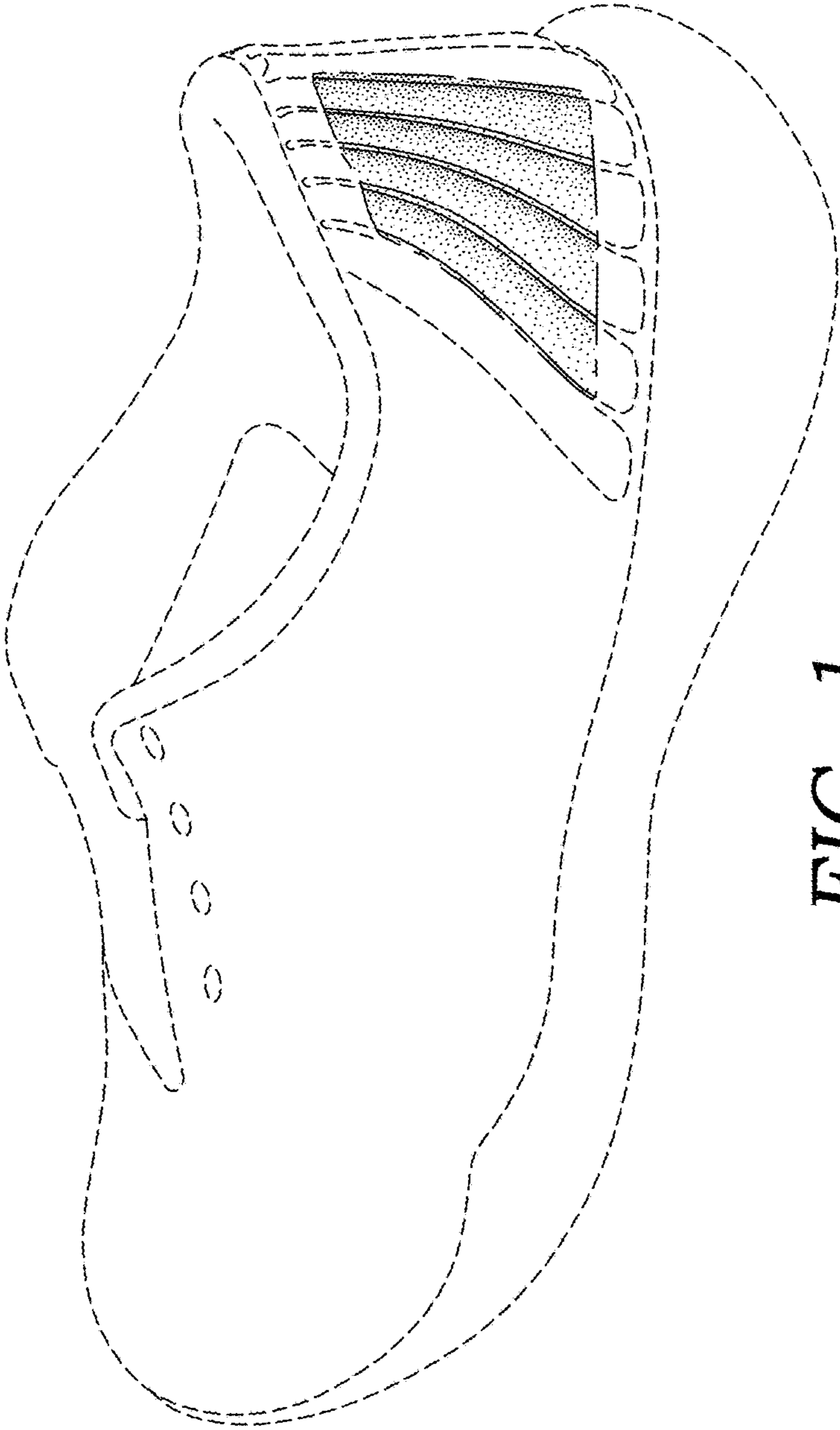

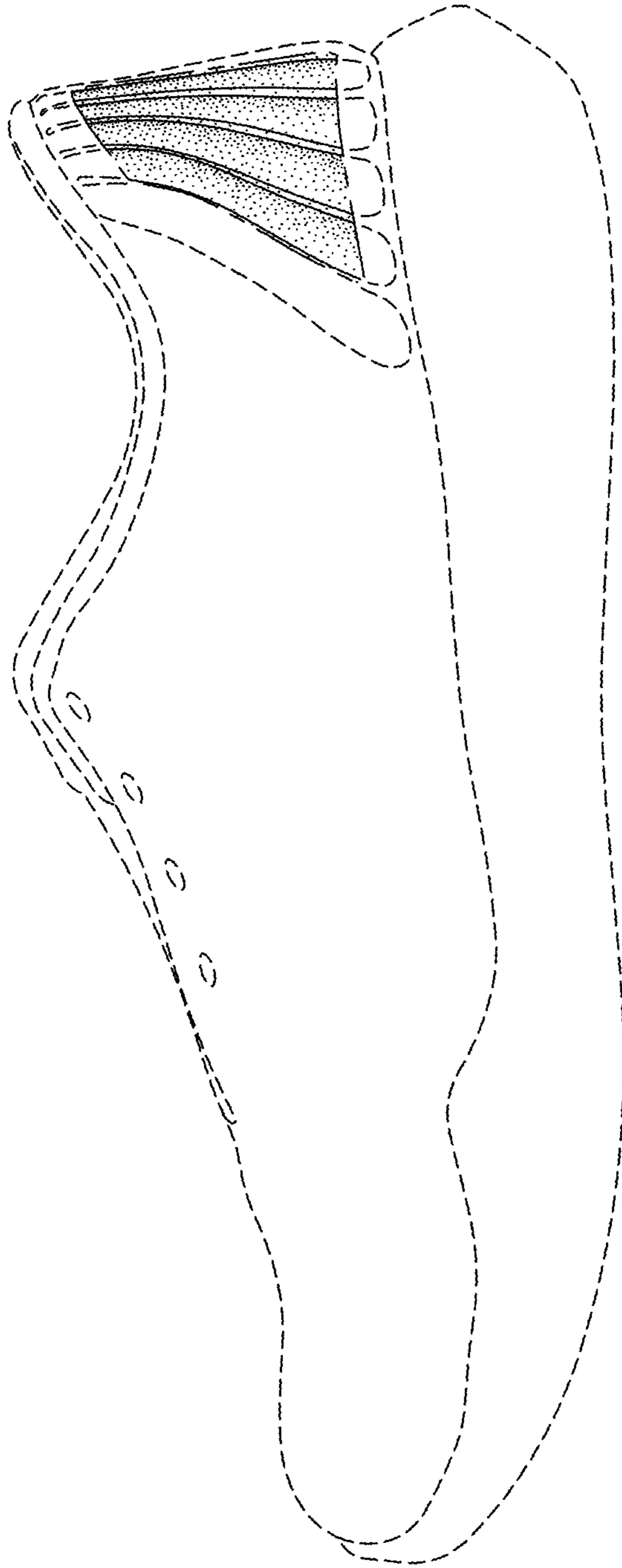

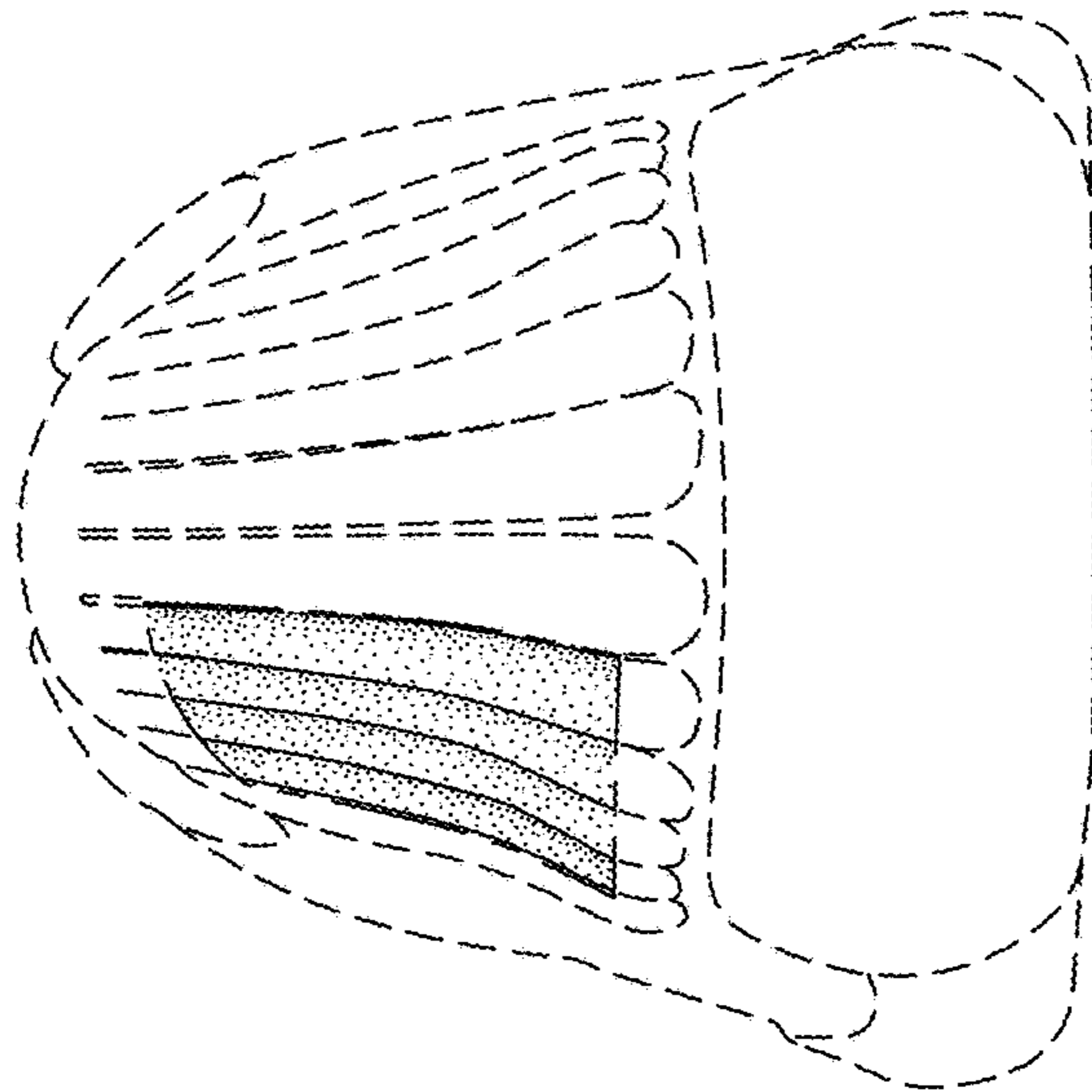

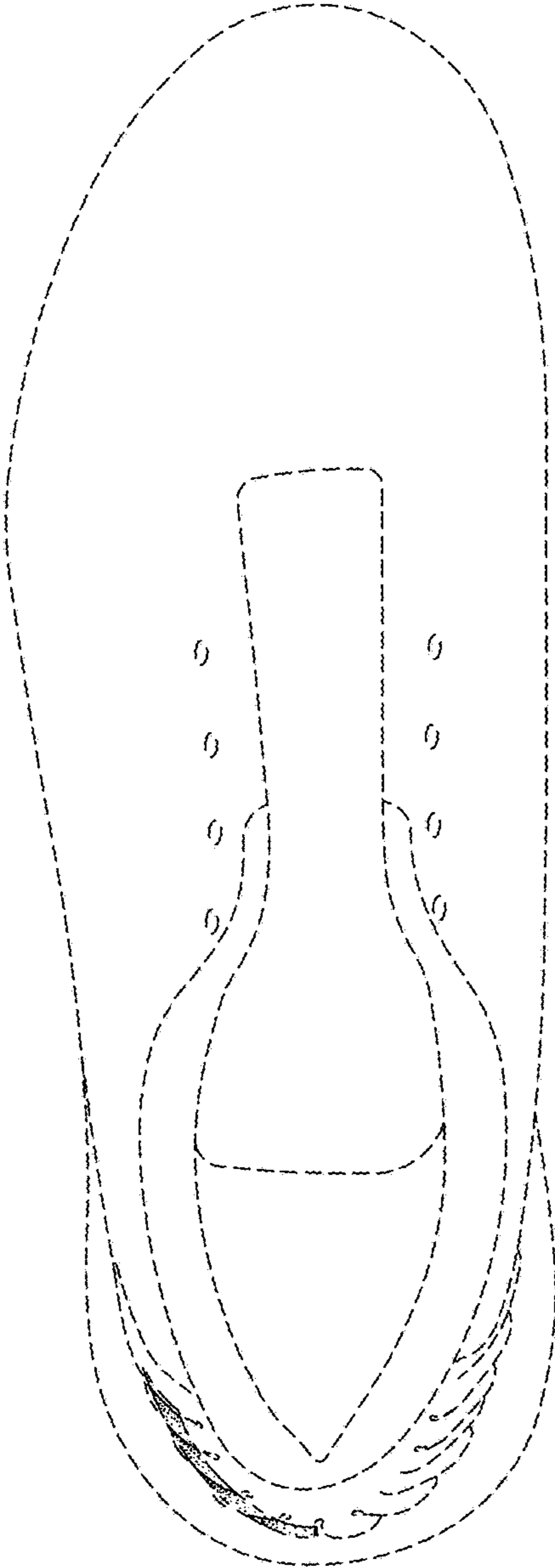
