DESCRIPTION

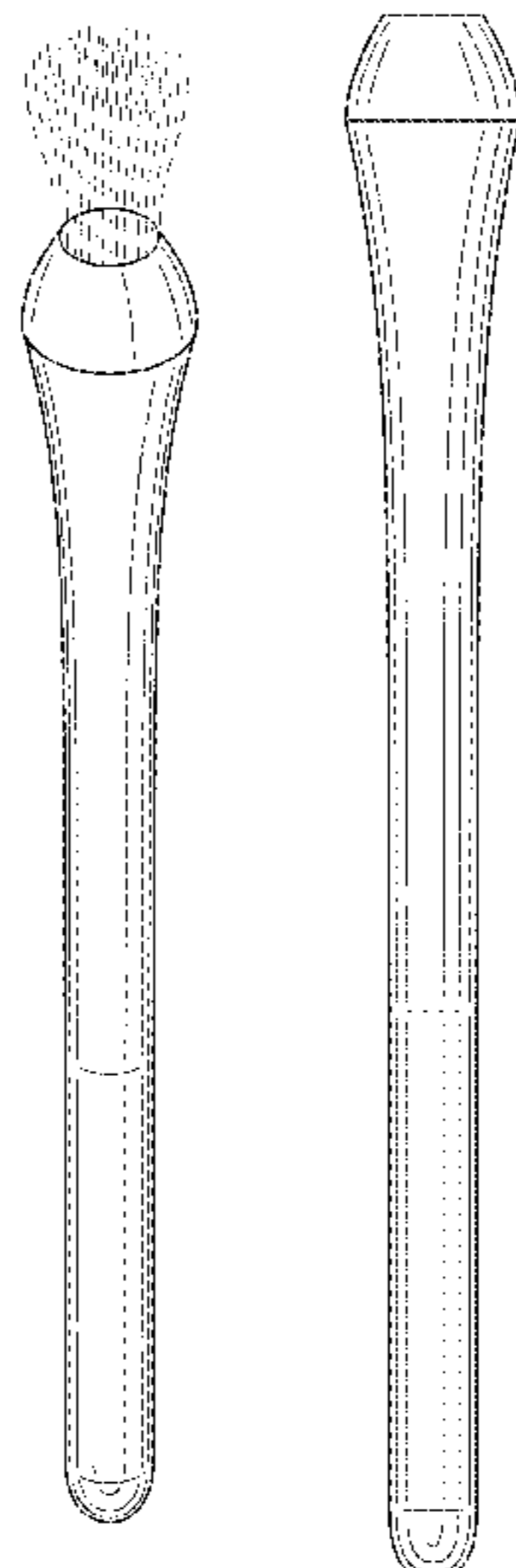
FIG. 1 is a perspective view of a cosmetics brush showing our new design;
 FIG. 2 is a front elevation view thereof, the rear being a mirror image;
 FIG. 3 is a right side elevation view thereof, the left side being a mirror image;

 FIG. 5 is a bottom plan view thereof.

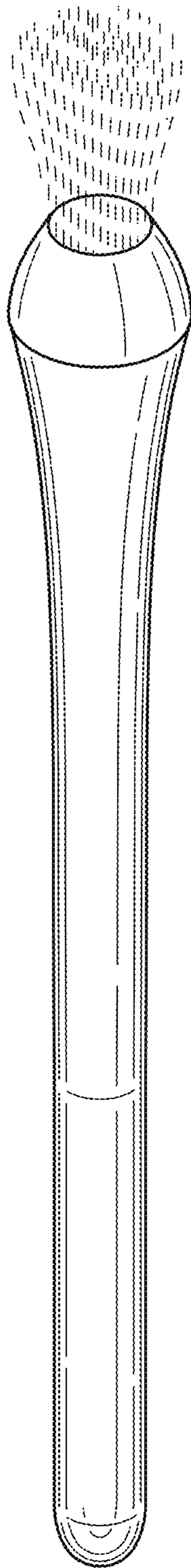

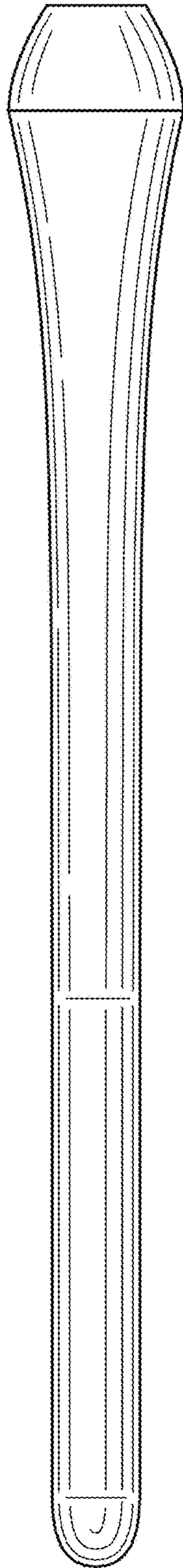

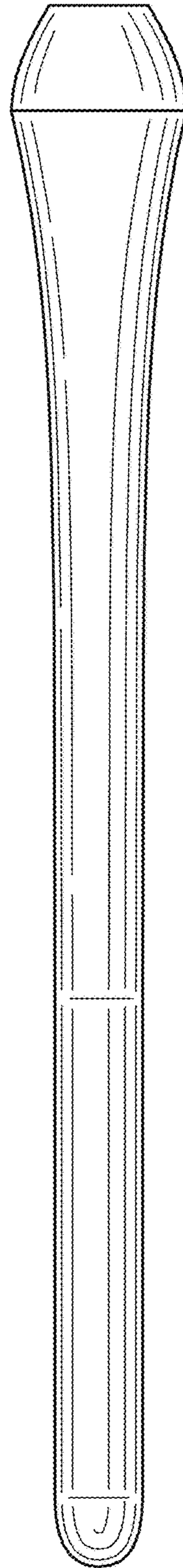

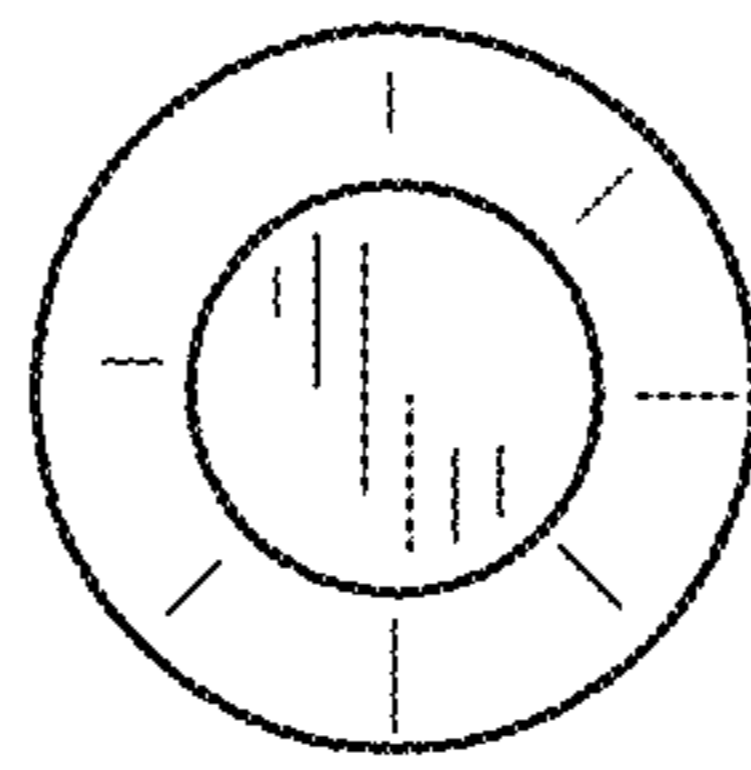

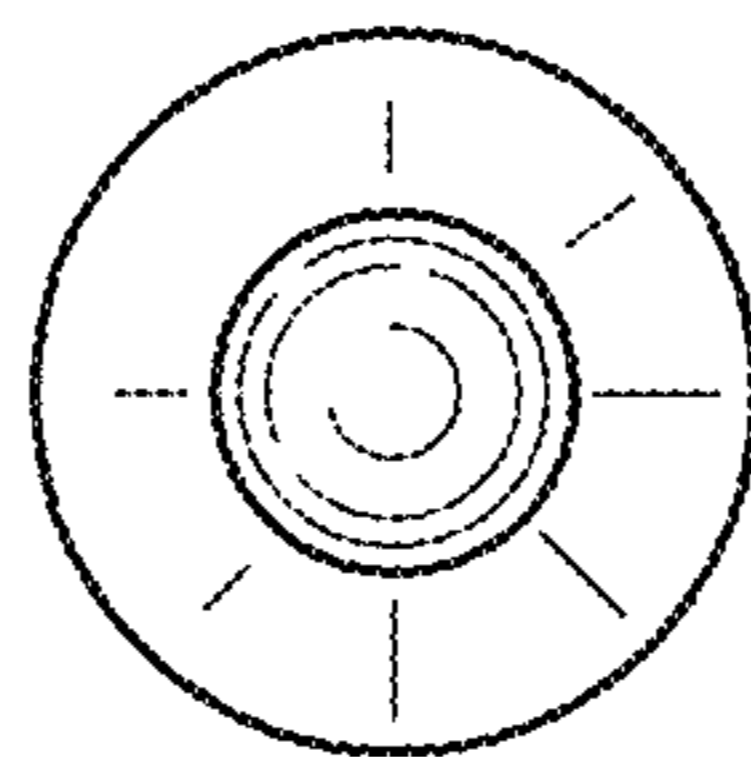
