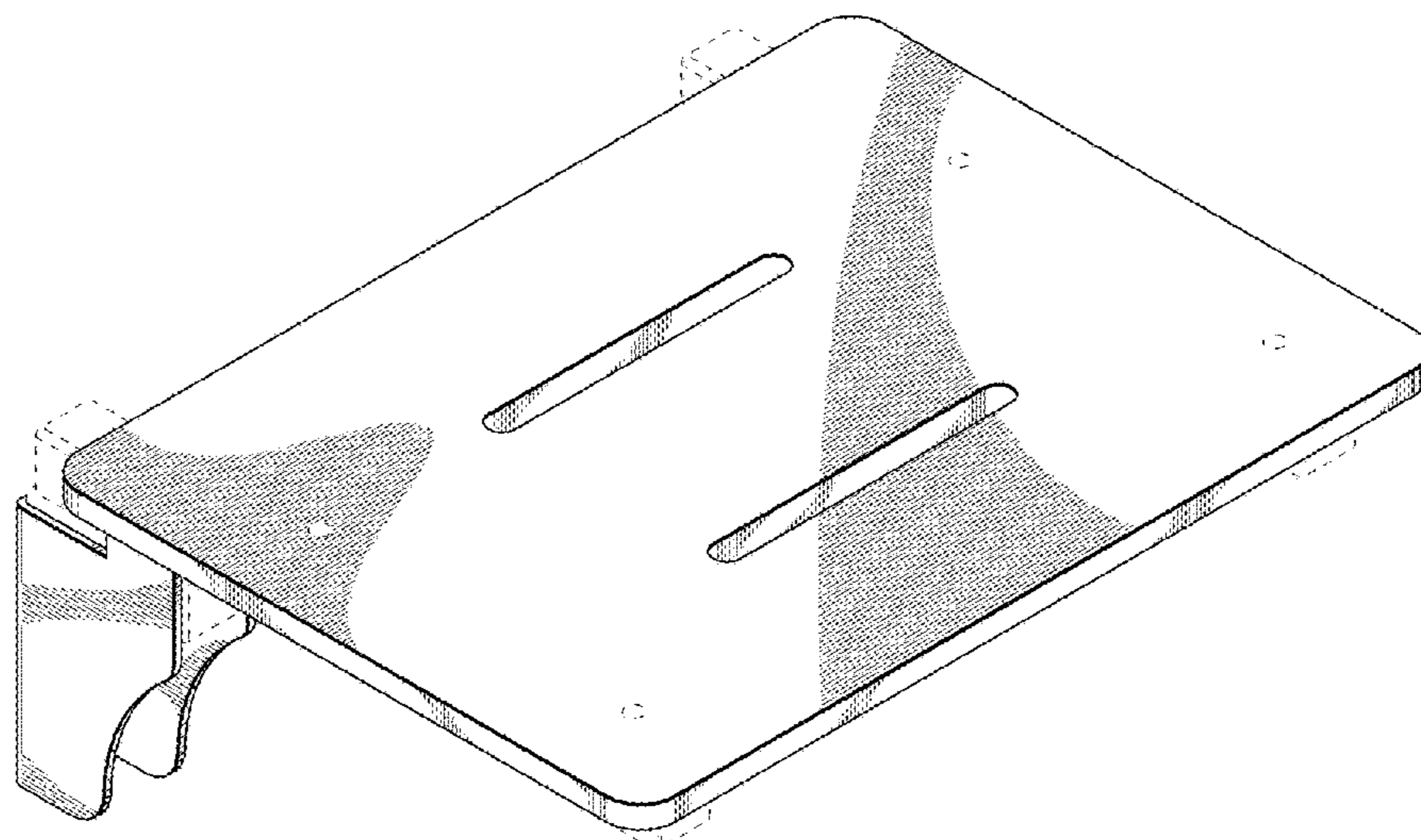
(57) **CLAIM**

The ornamental design of a wave bracket and eclipse seat, as shown and described.

DESCRIPTION

FIG. 1 is a top, front, left side perspective view of a wave bracket and eclipse seat of the new design.
FIG. 2 is a front elevation view thereof.
FIG. 3 is a rear elevation view thereof.
FIG. 4 is a left side elevation view thereof.
FIG. 5 is a right side elevation view thereof.

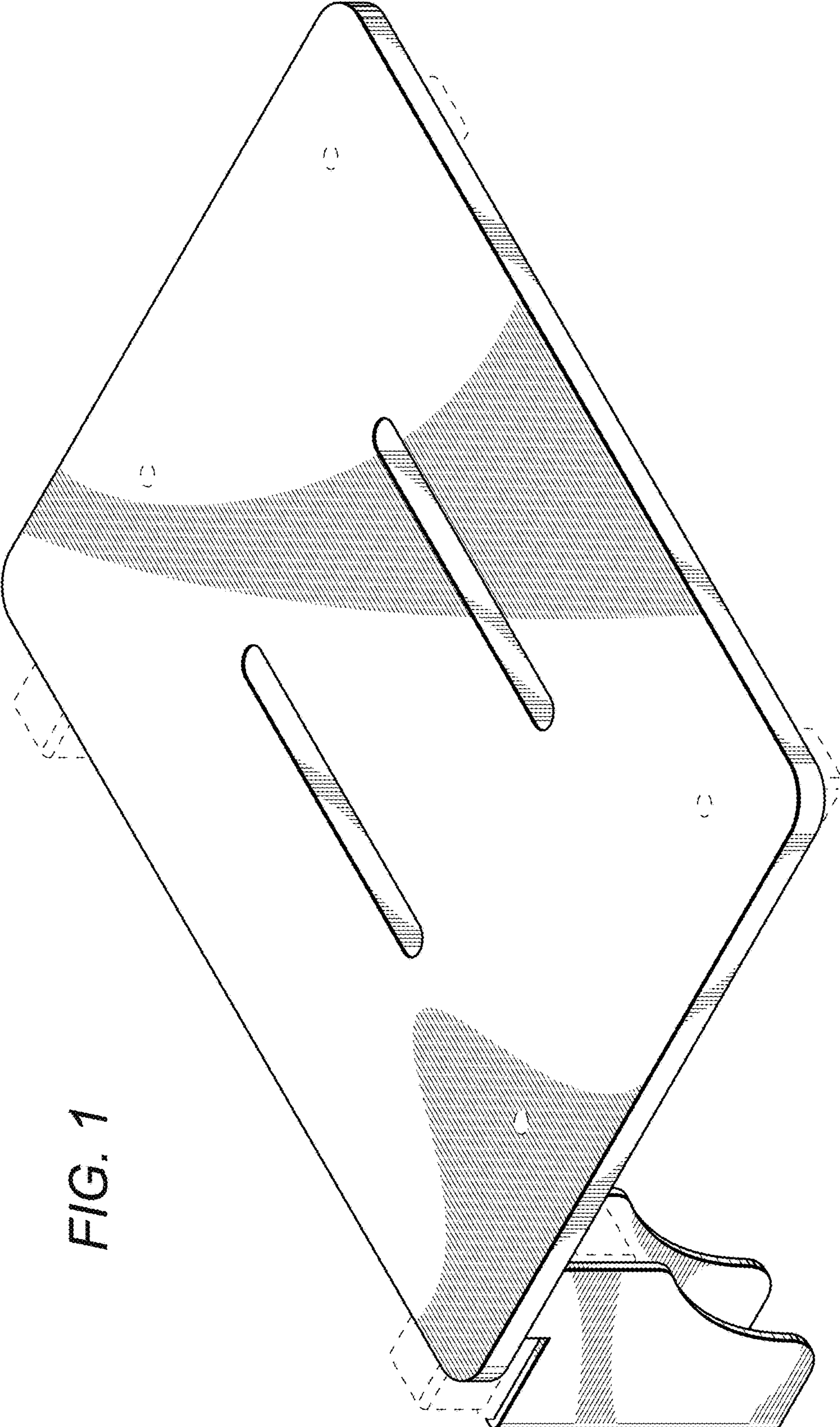

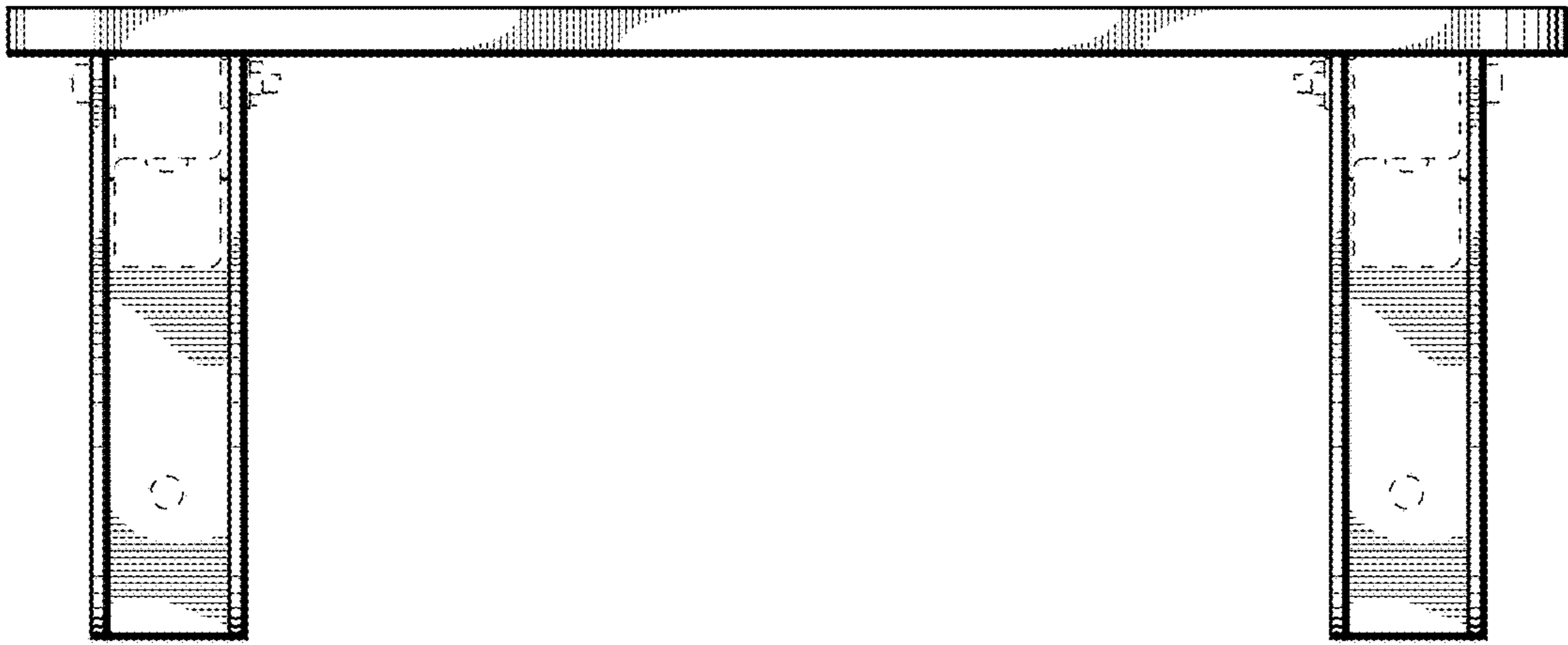
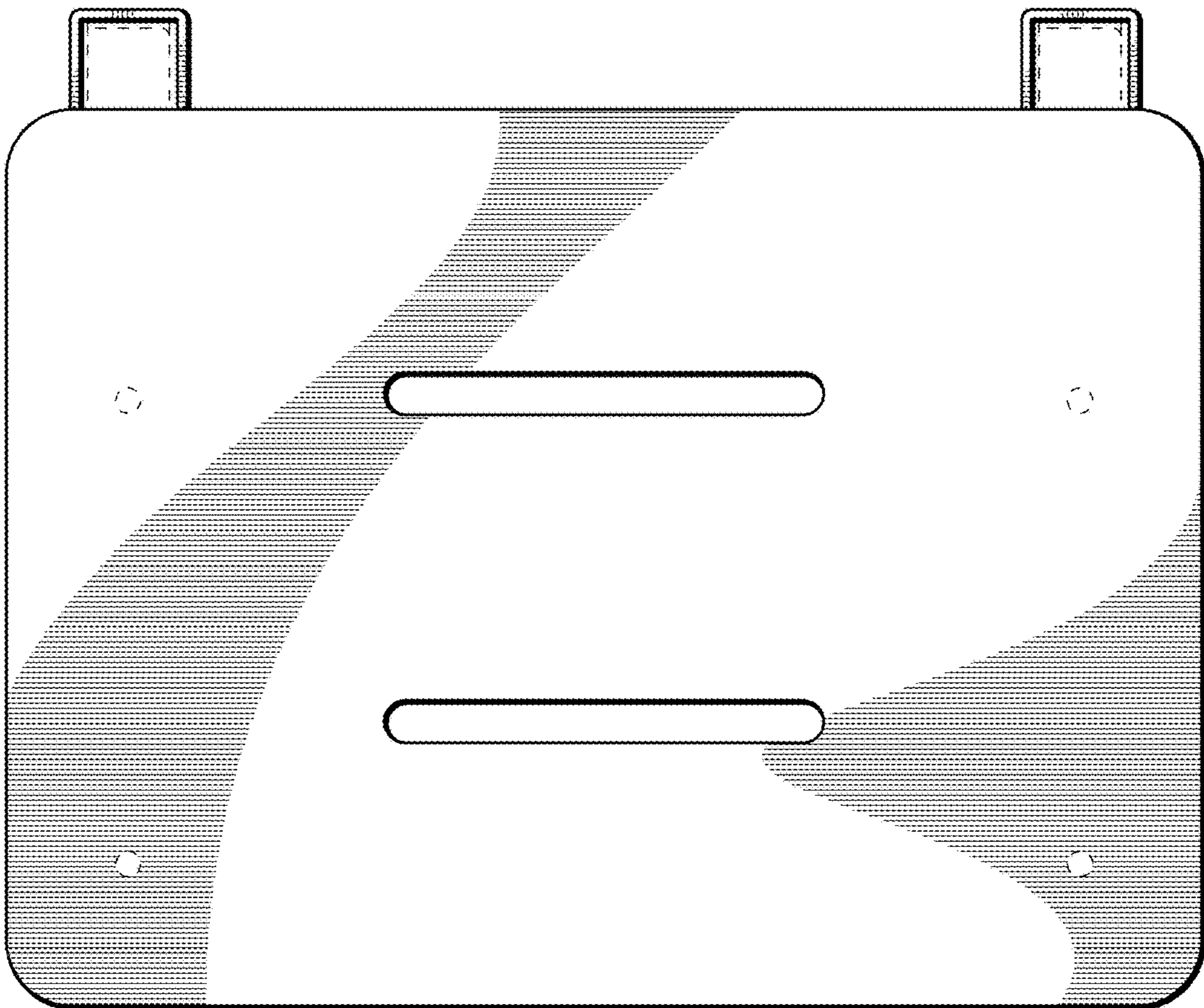

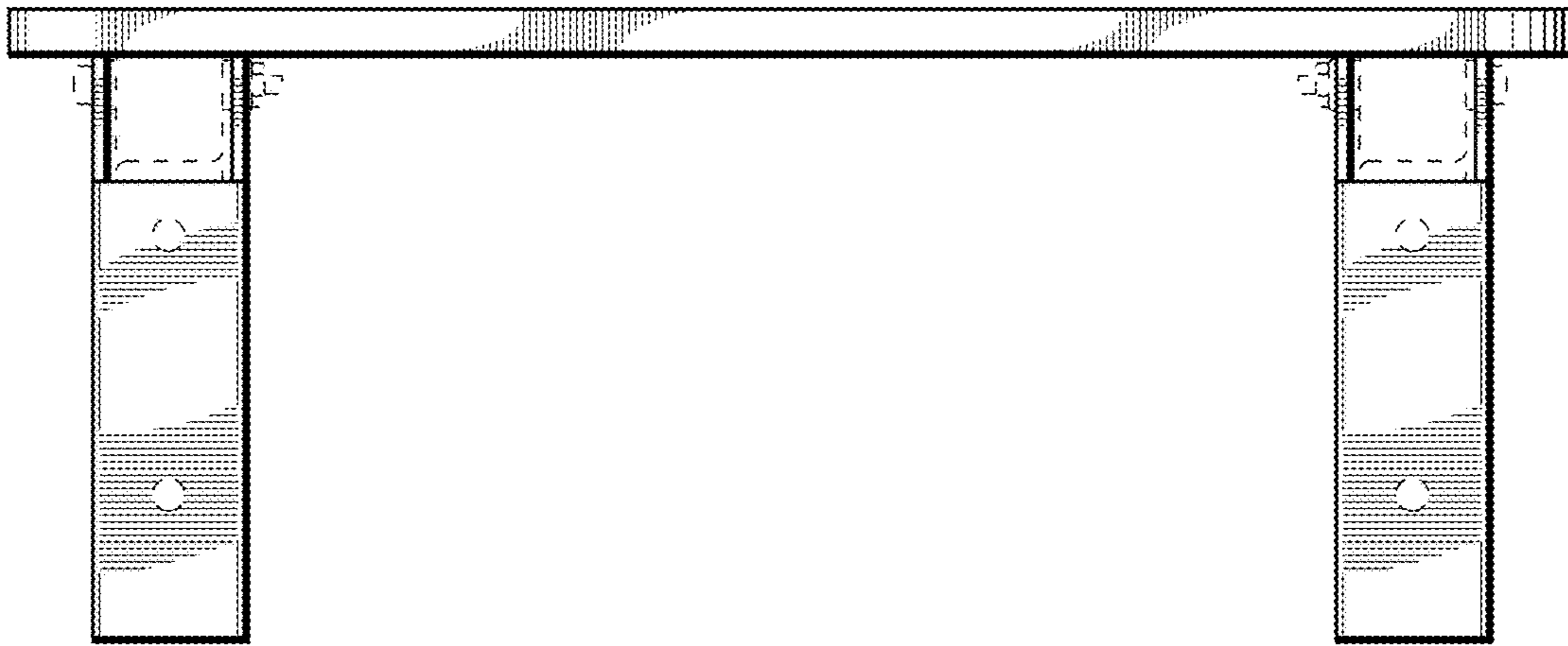
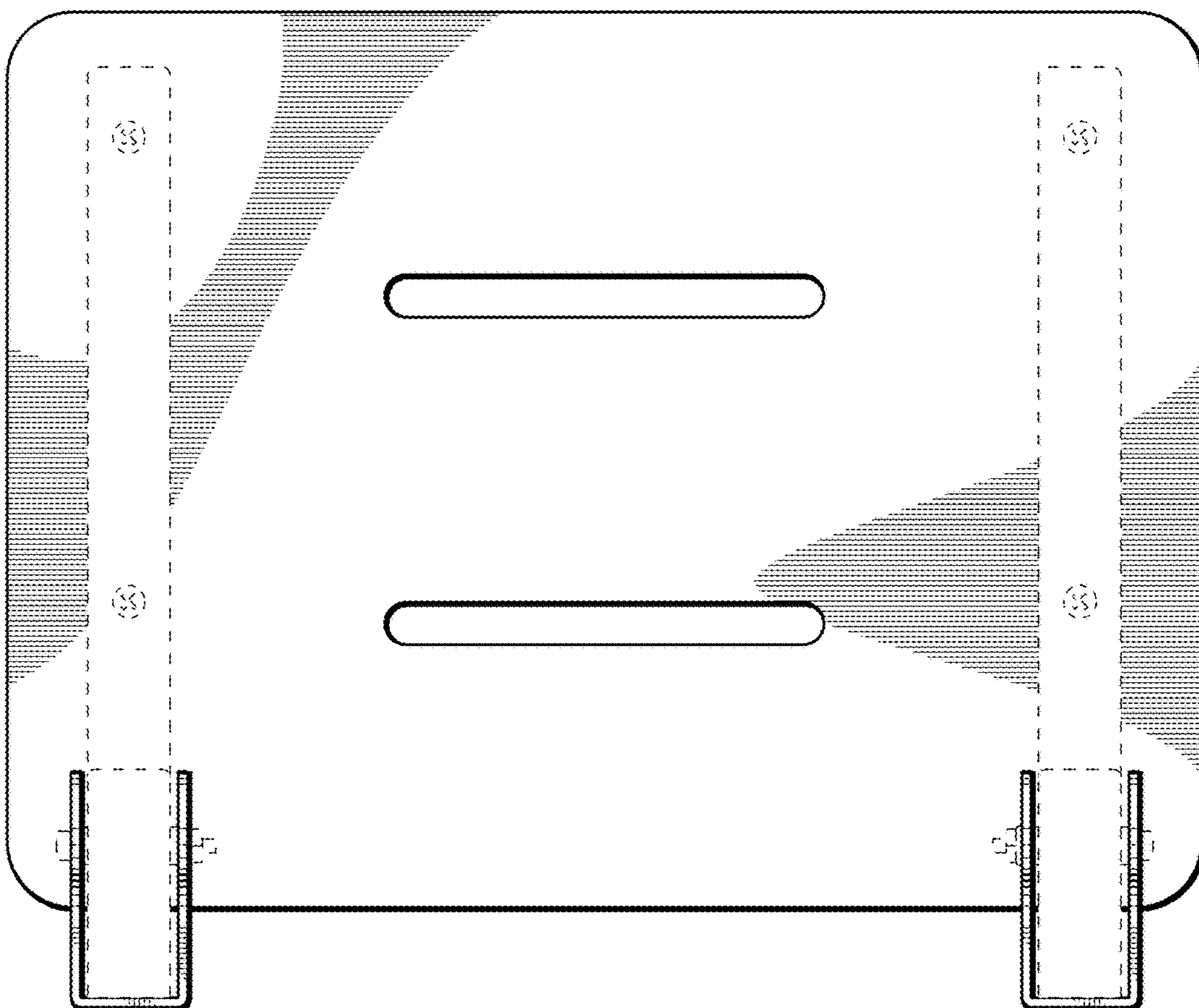

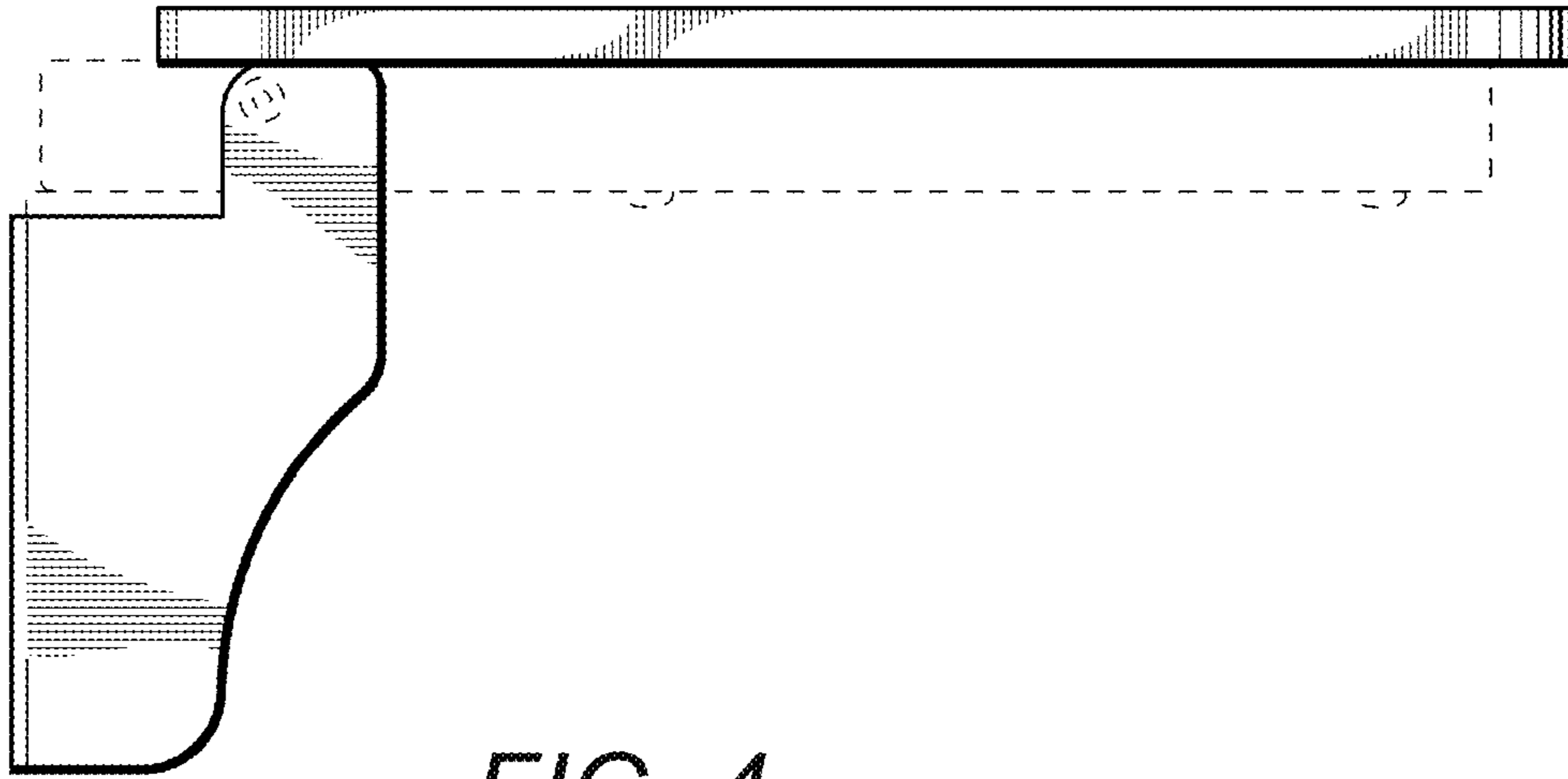
