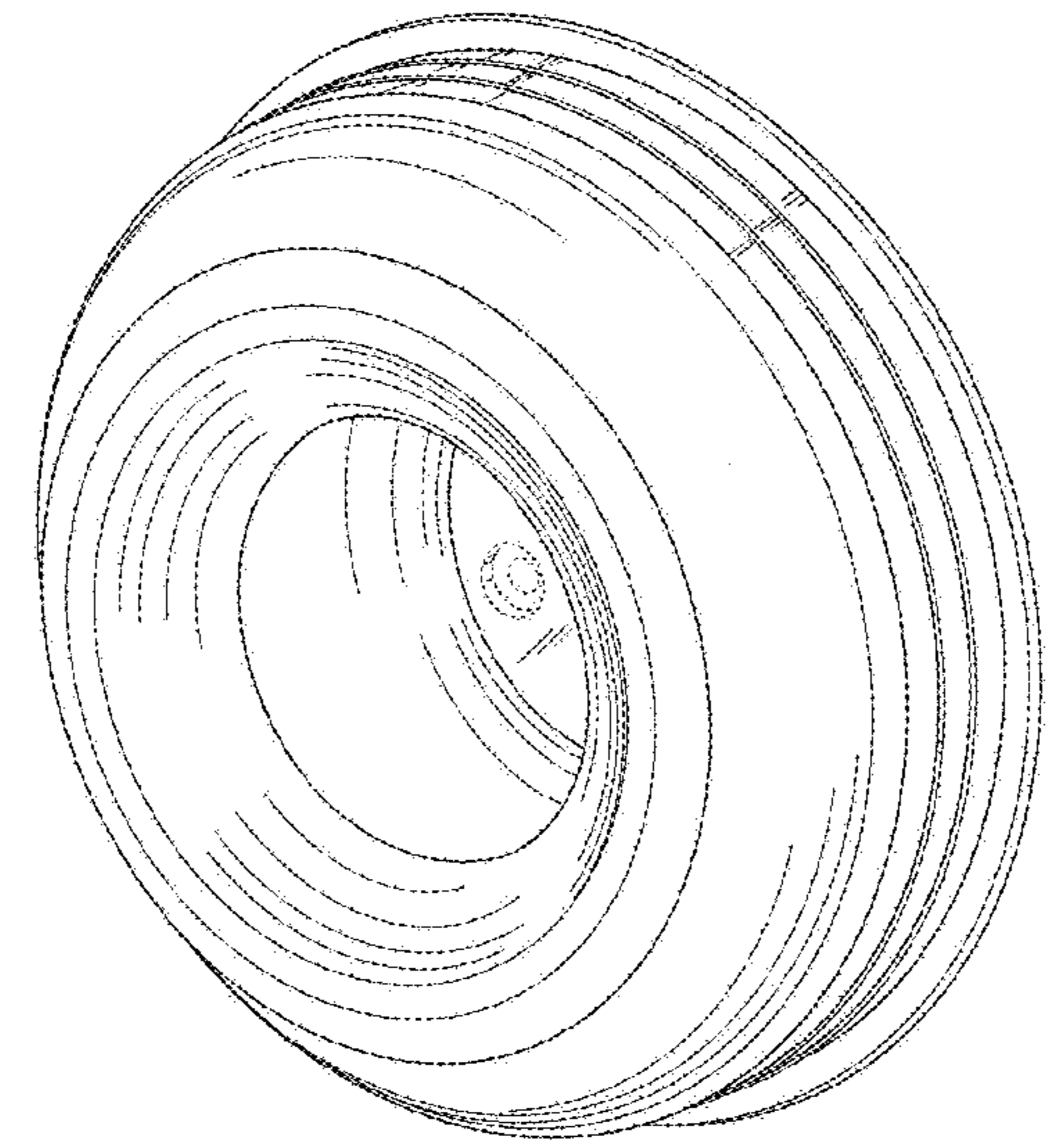
(57) **CLAIM**

DESCRIPTION

FIG. 1 is an isometric view of an insert for a web material dispenser, embodying my new design;
FIG. 2 is a front elevation view thereof;
FIG. 3 is a side elevation view thereof, wherein the opposing side elevation view is a mirror image thereof;
FIG. 4 is a top plan view thereof; and,
FIG. 5 is a bottom plan view thereof.

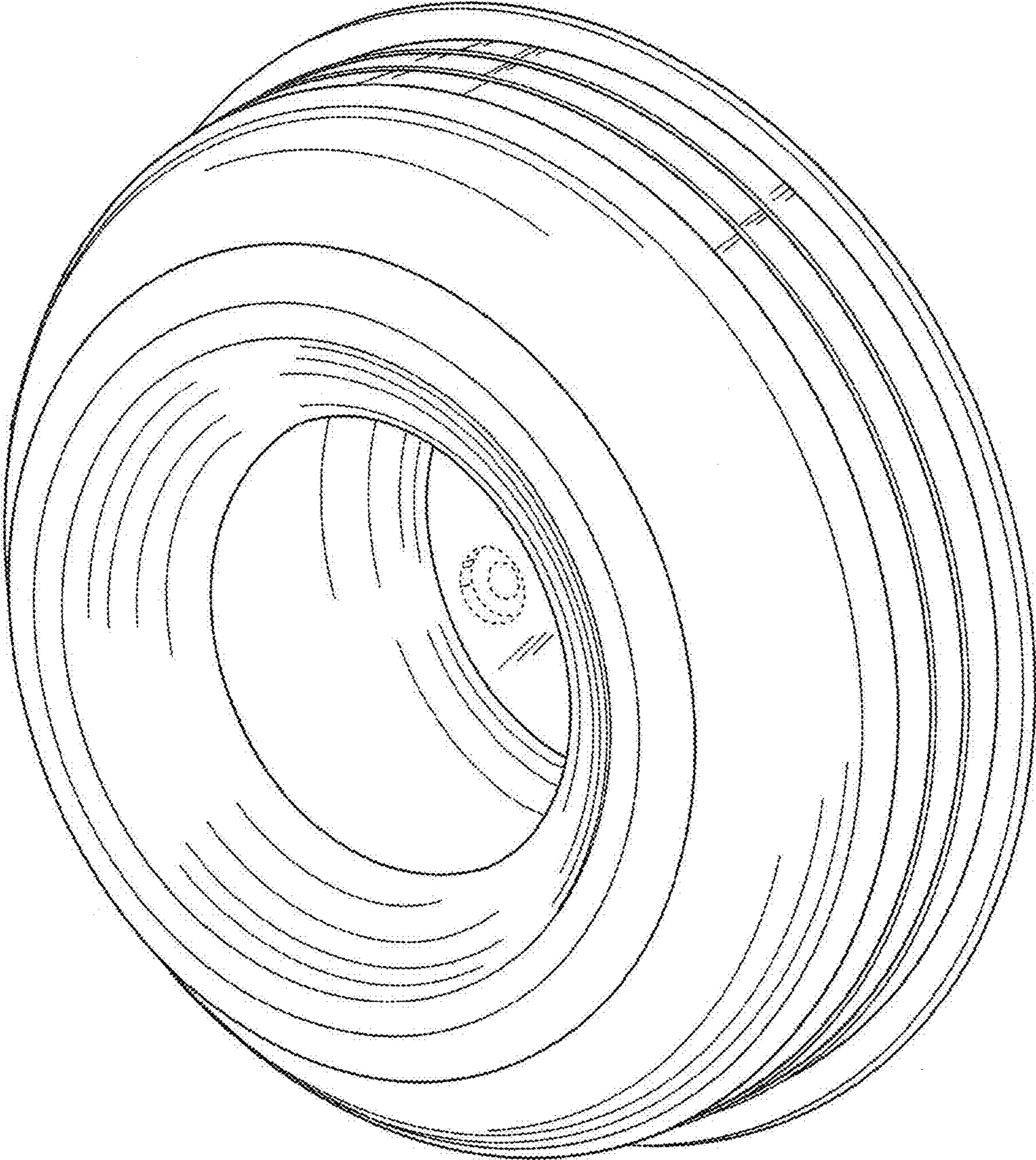

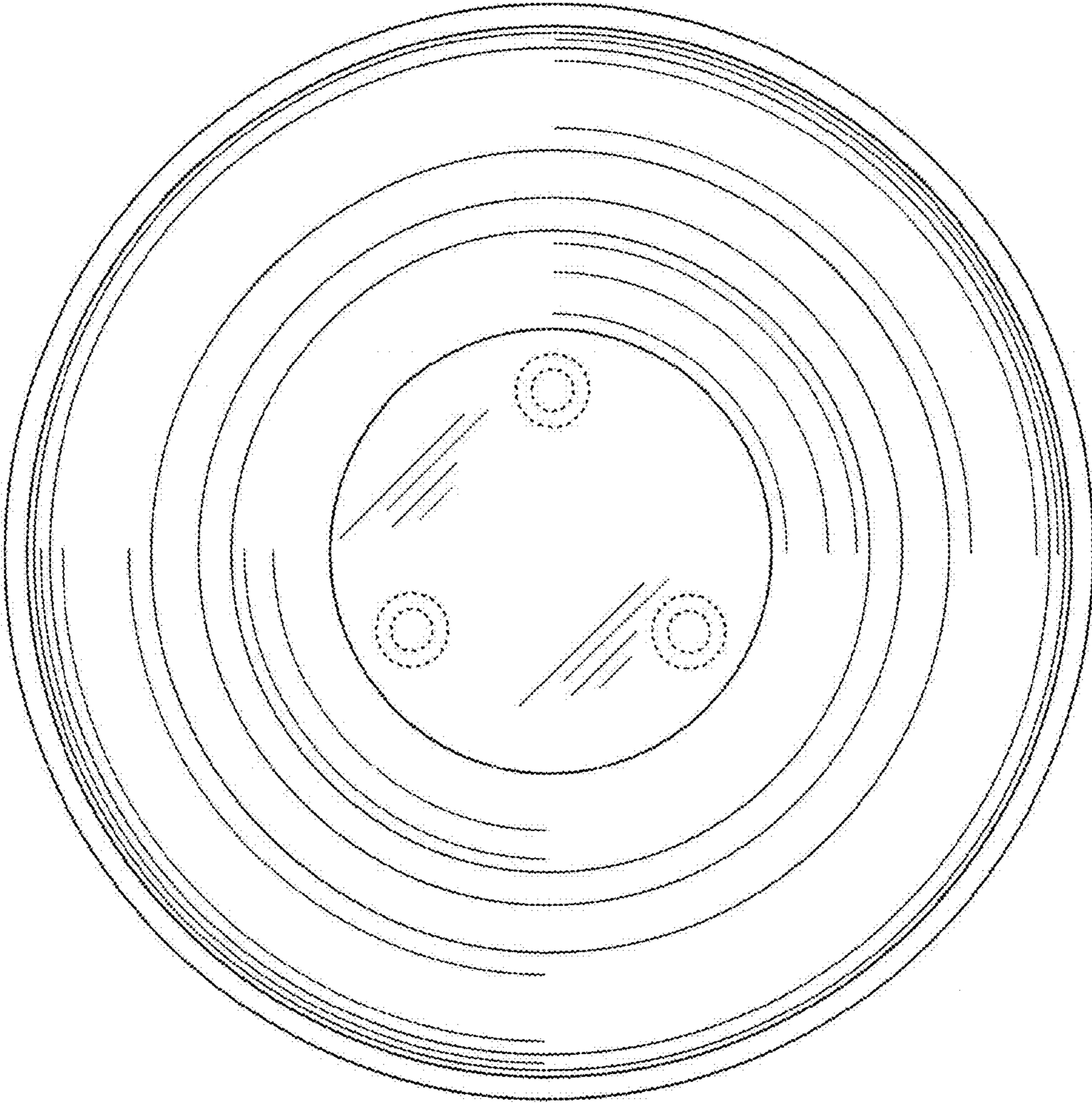

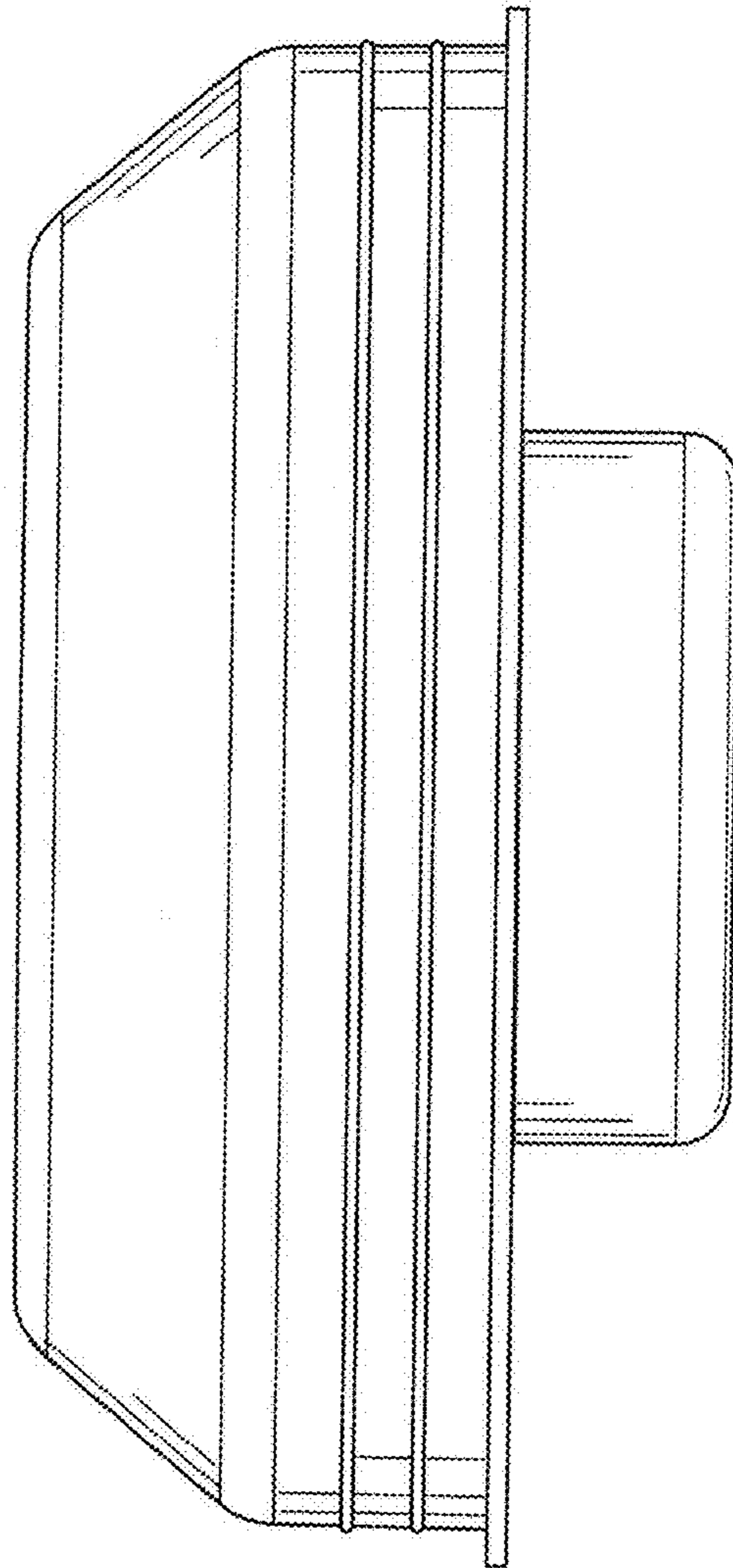

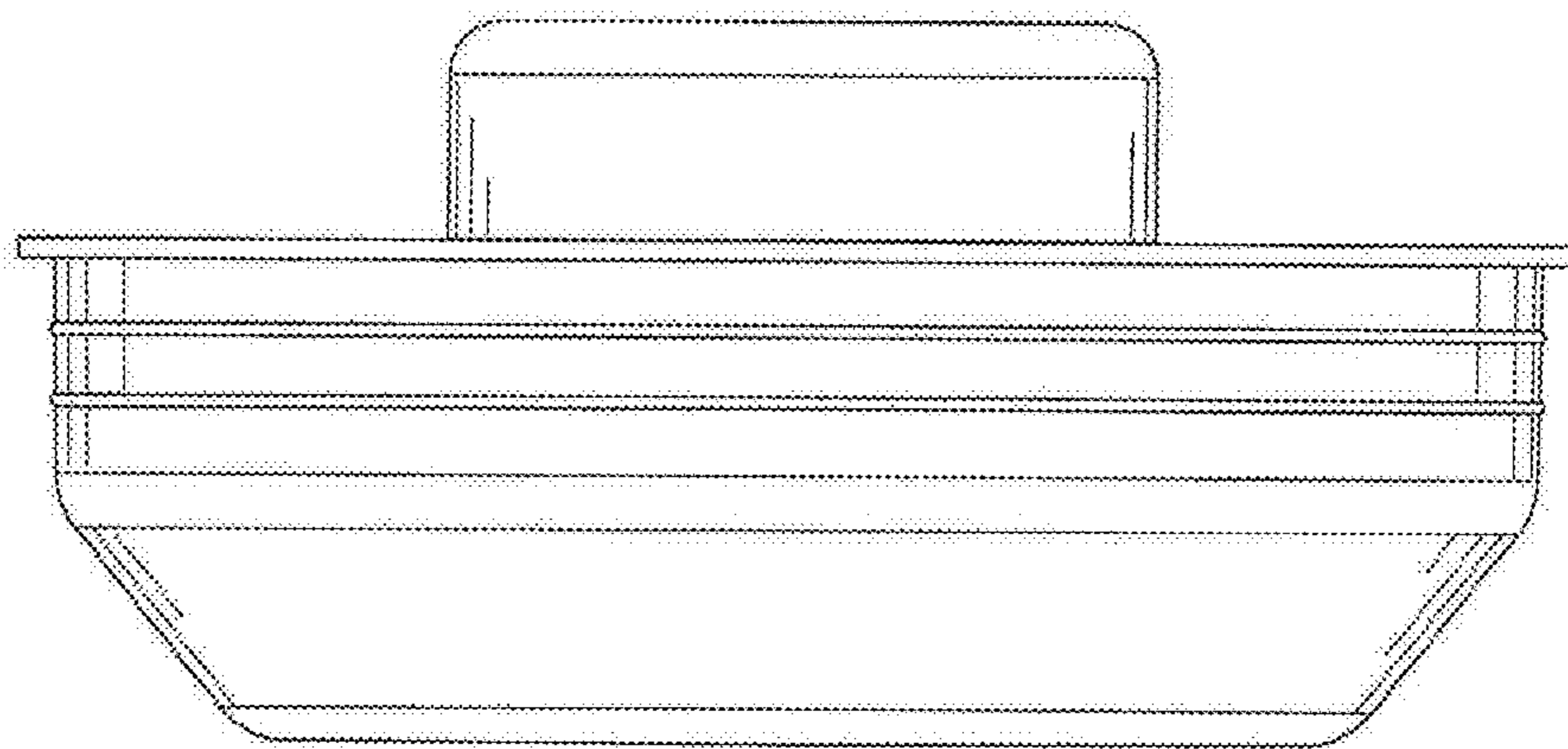

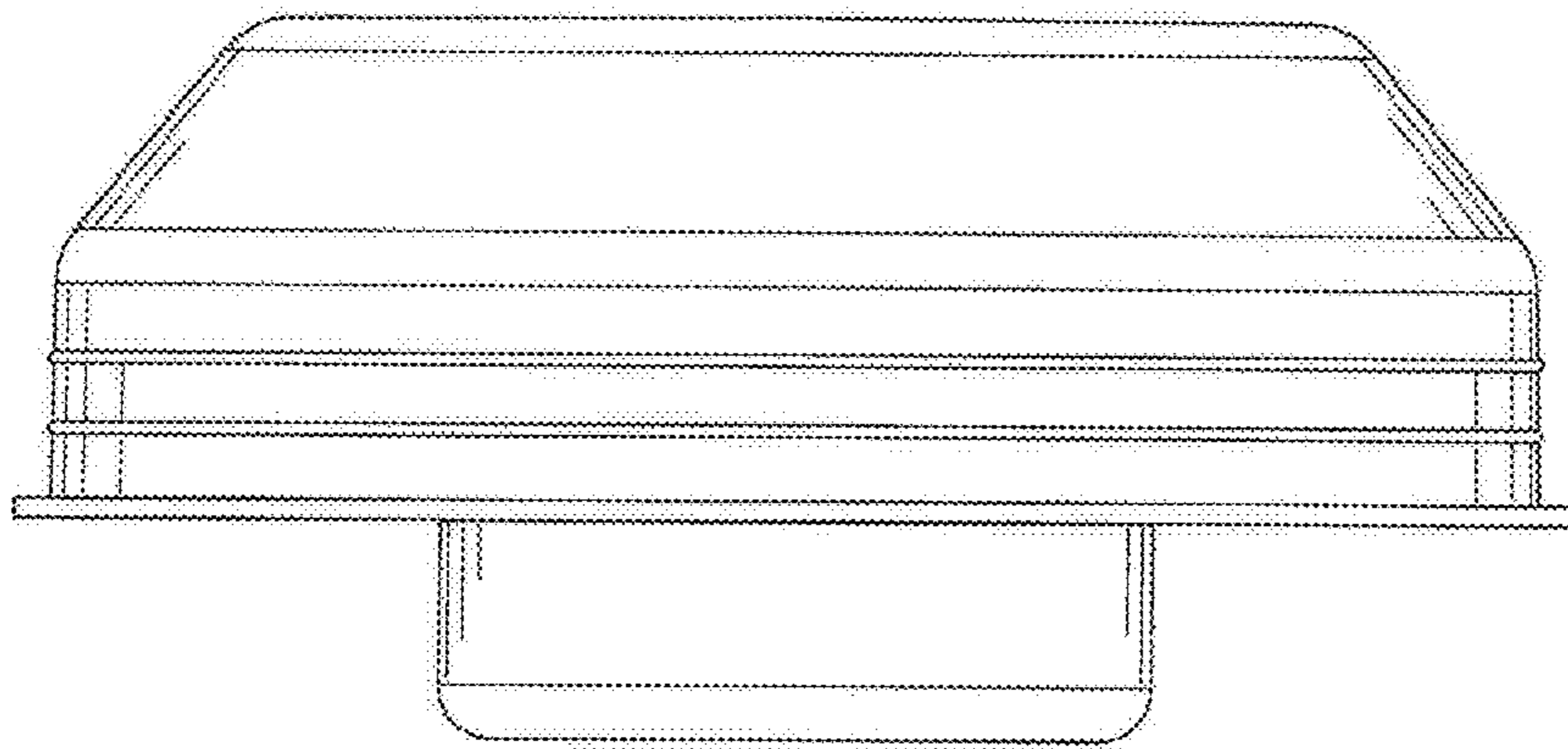
