(57) **CLAIM**

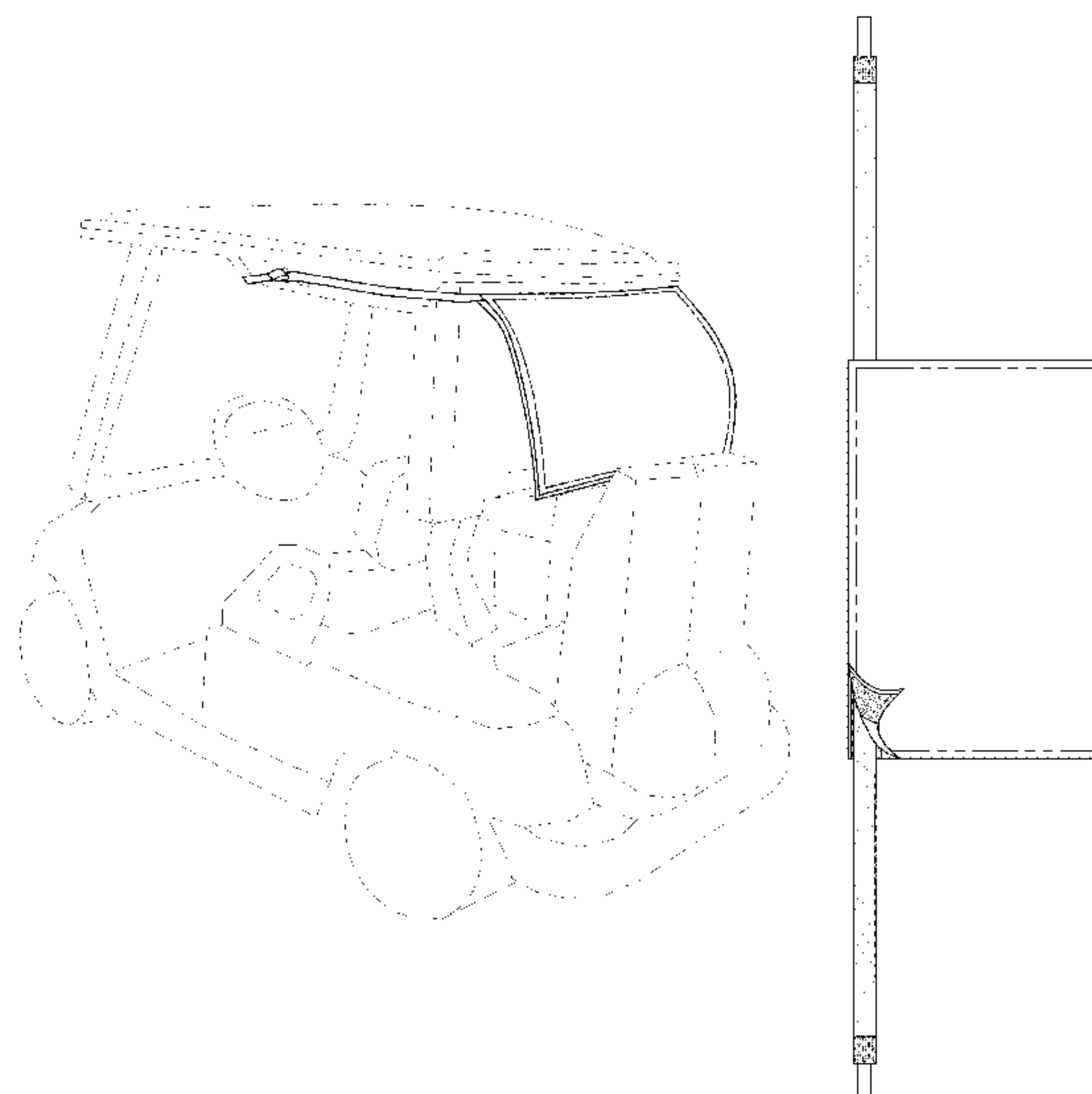
The ornamental design for a protective shade, as shown and
described.

DESCRIPTION

FIG. 1 is a perspective view showing my new design;
FIG. 2 is a front view of FIG. 1;
FIG. 3 is an exploded view of FIG. 1;
FIG. 4 is a side view of FIG. 1;
FIG. 5 is an opposite side view of FIG. 4;
FIG. 6 is a top view of FIG. 1; and,
FIG. 7 is a bottom view of FIG. 1.
The broken line showing of parts of the FIG. 1 drawings is
included for the purpose of illustrating background environ-
ment and forms no part of the claimed design. The dot-dot-
dash broken lines shown along the edges on the surface of
the rectangle in FIGS. 2 and 3 represent stitching that forms
no part of the claimed design. The stippling in FIGS. 2, 3,
6, and 7 represents texture.

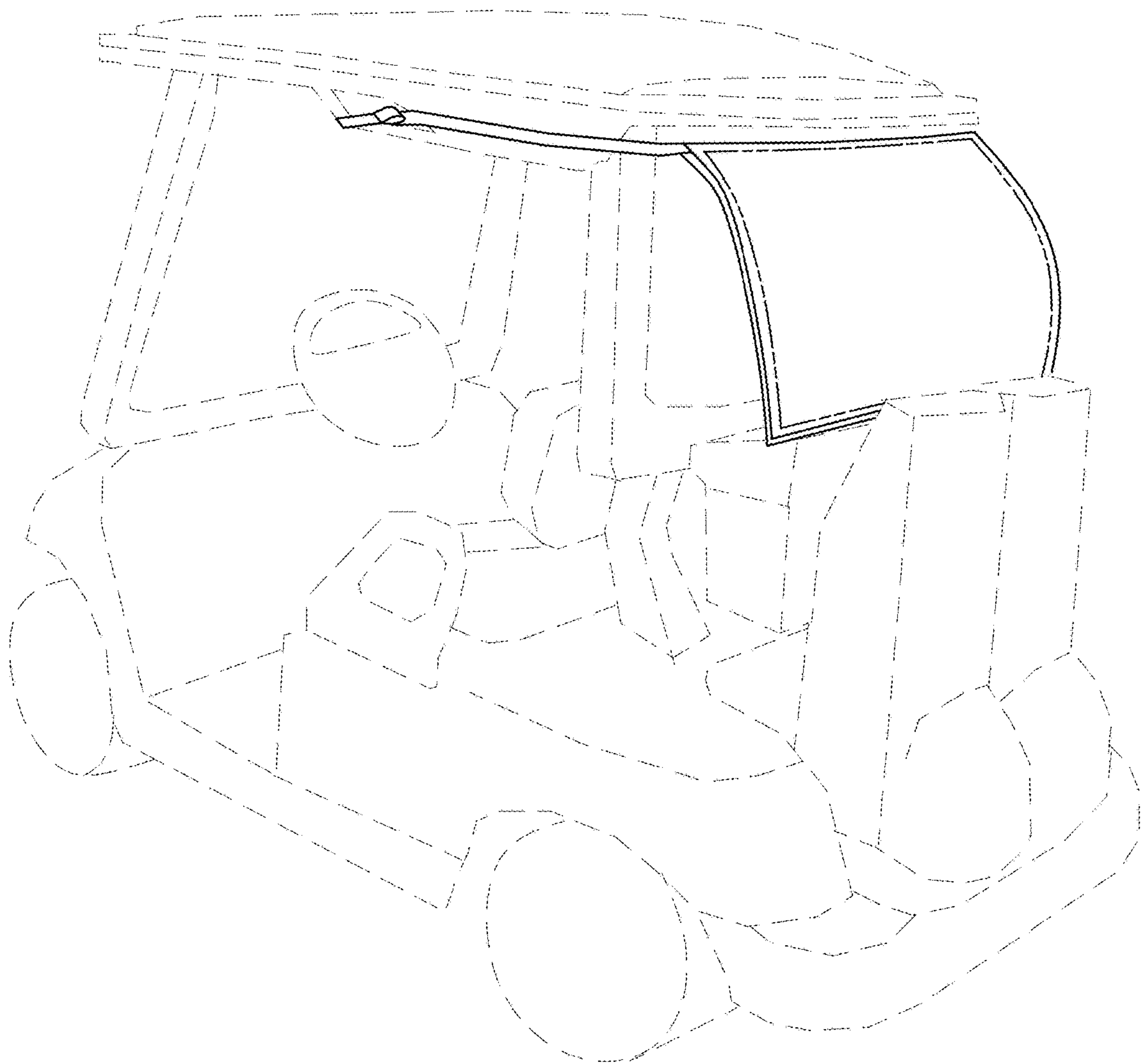

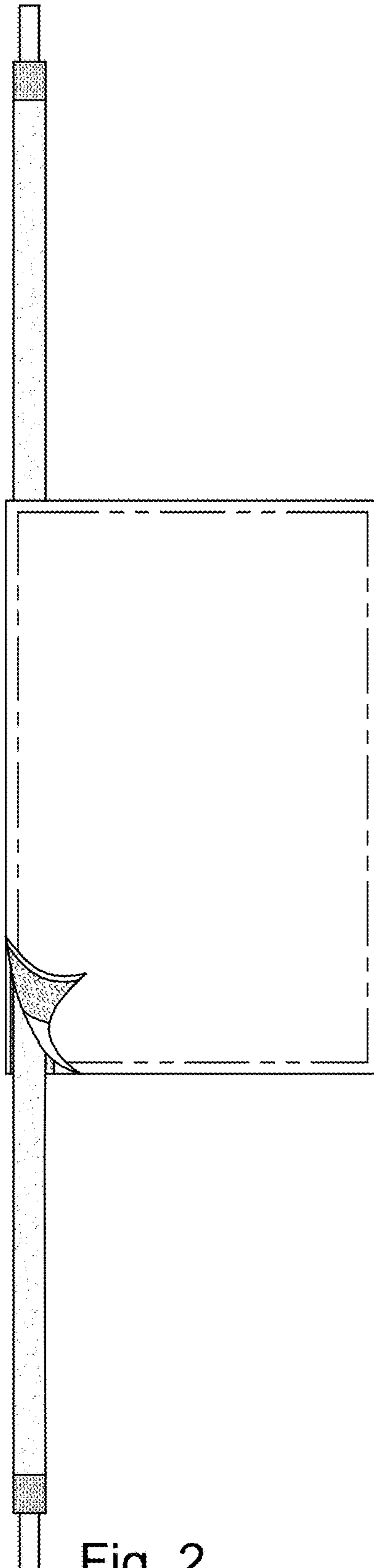
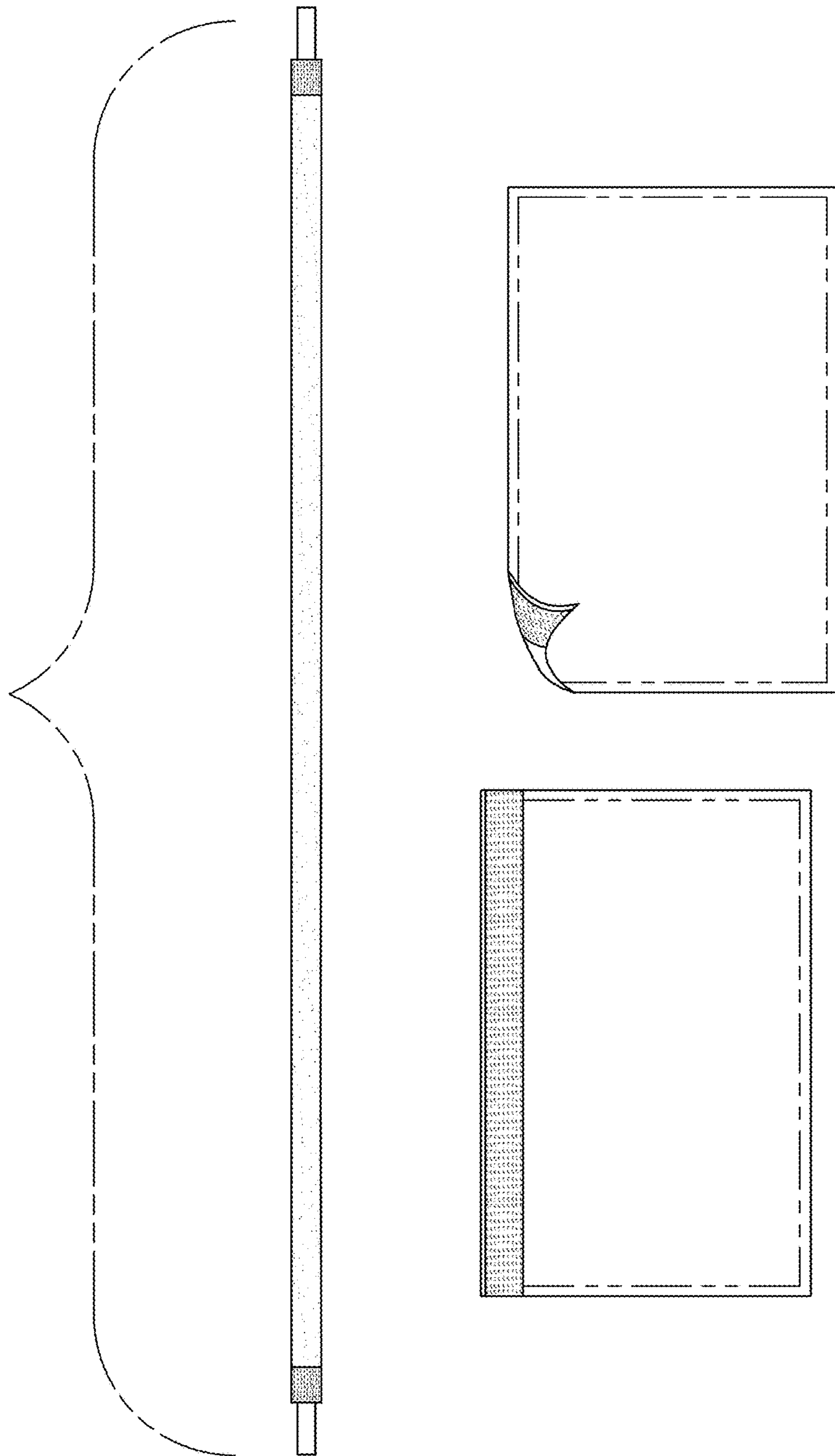

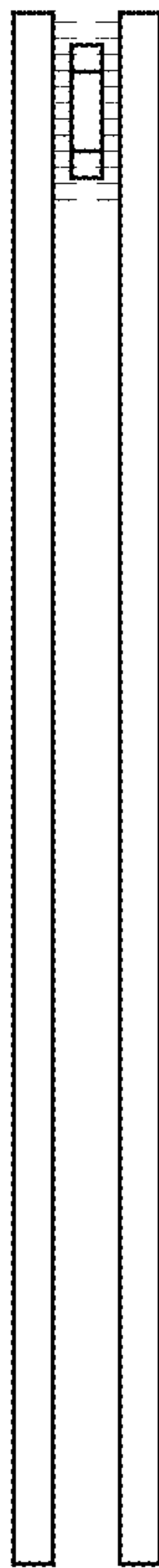

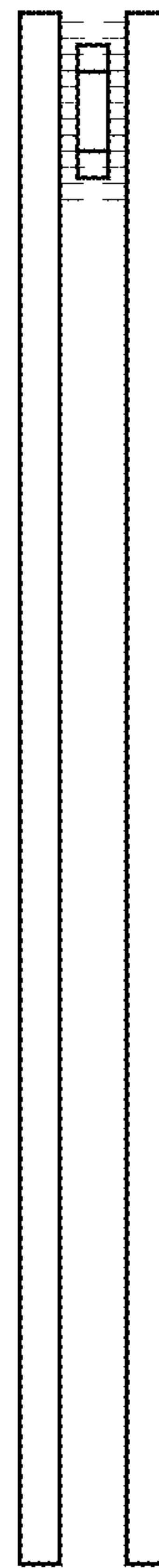

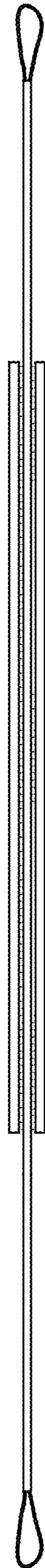
